The ornamental design for a sole for footwear with insert, as shown and described.

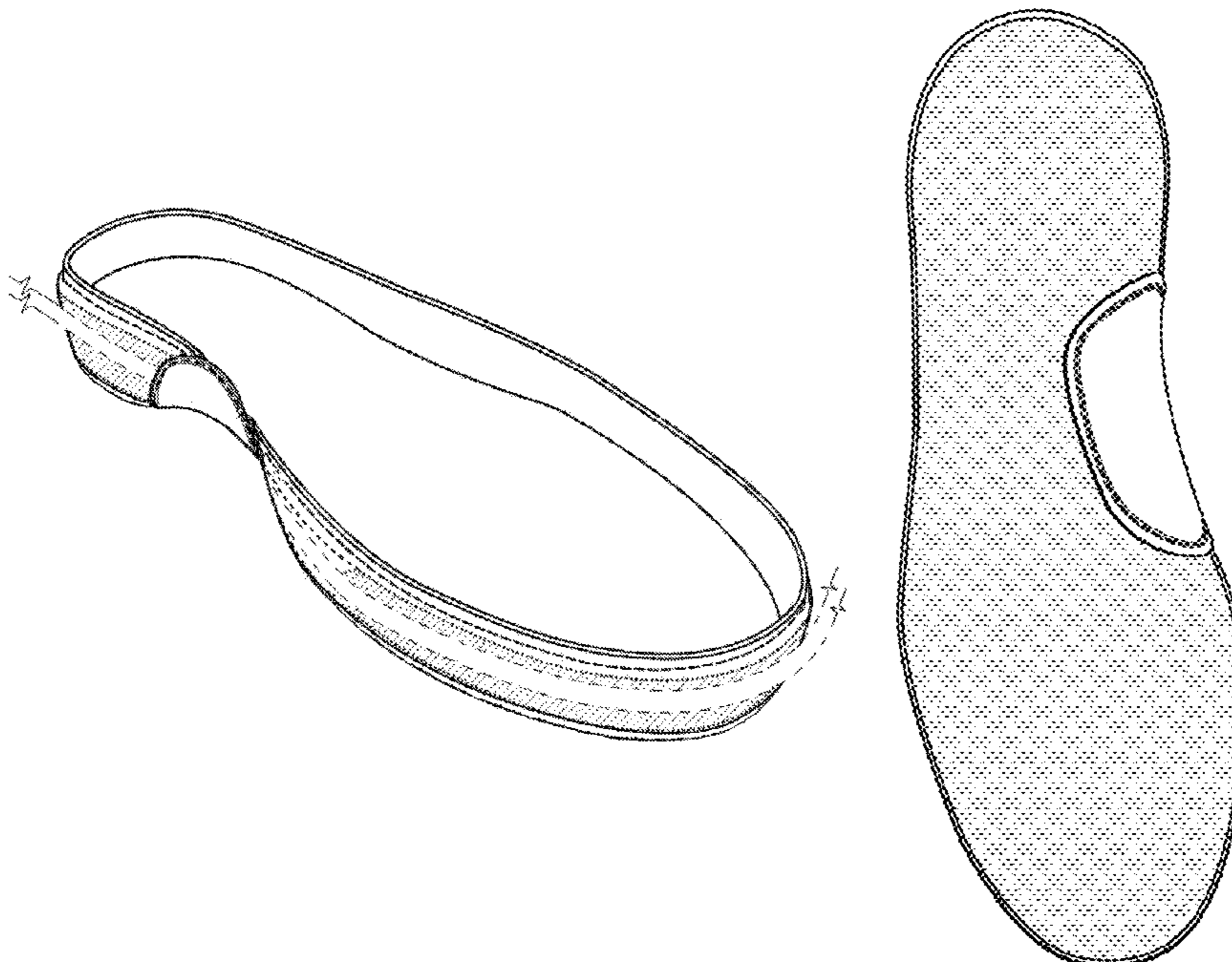
DESCRIPTION

1. Sole for footwear with insert

- 1.2 : Left
- 1.3 : Right
- 1.4 : Back
- 1.5 : Front
- 1.6 : Bottom
- 1.7 : Top

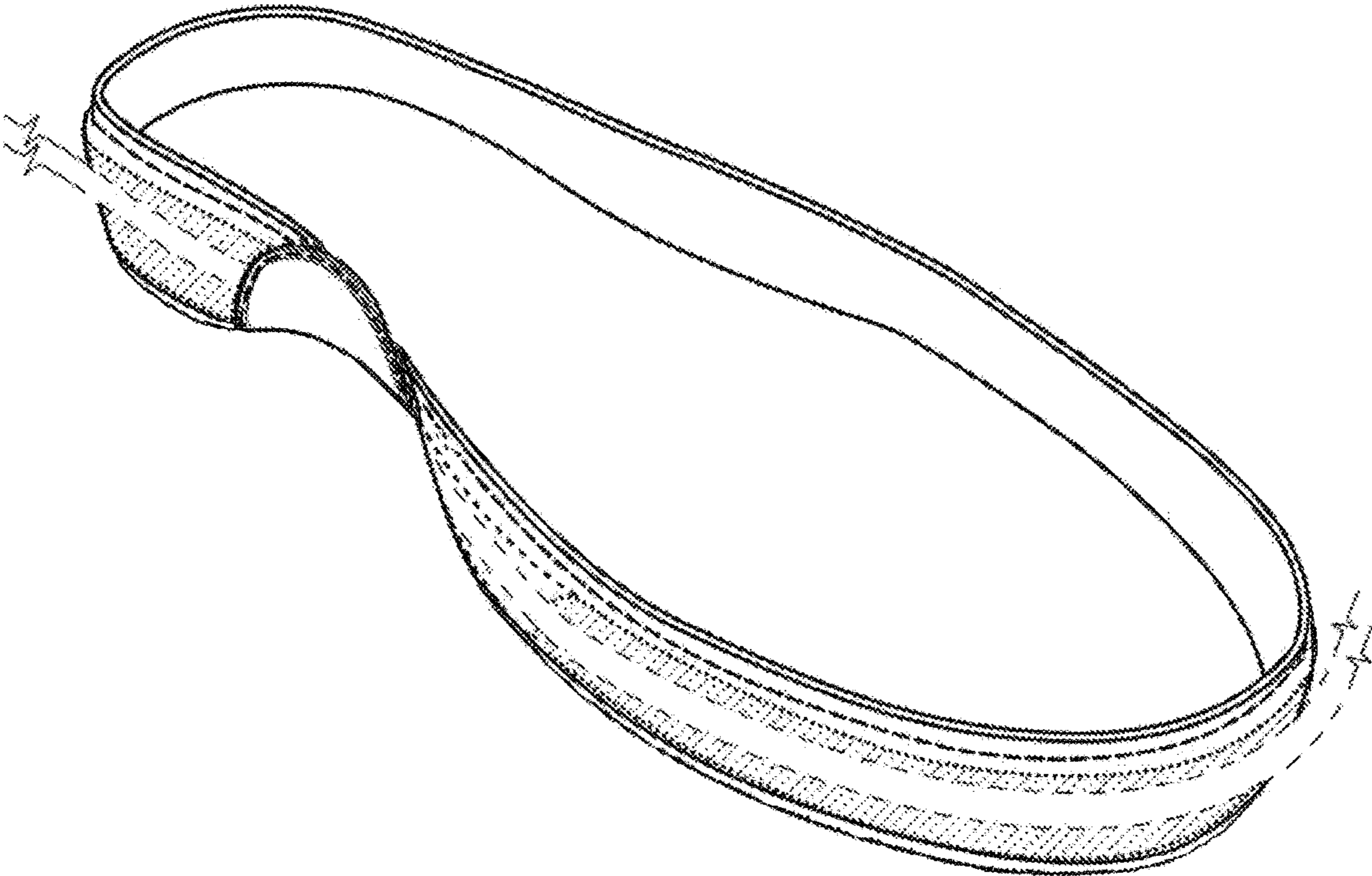
The long, dark, evenly dashed broken lines adjacent solid lines are for the purpose of illustrating claimed stitching. All other broken lines on the bottom and sides of the article are made of shorter dashes and are for the purpose of illustrating surface ornamentation and form no part of the claim.

The sole for footwear with insert is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claim.

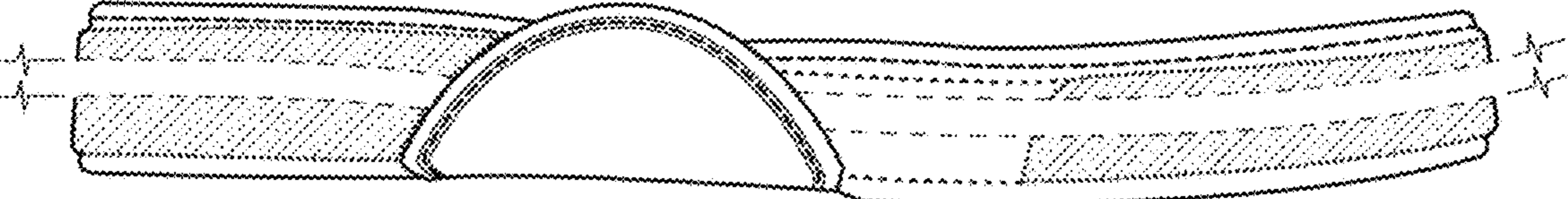

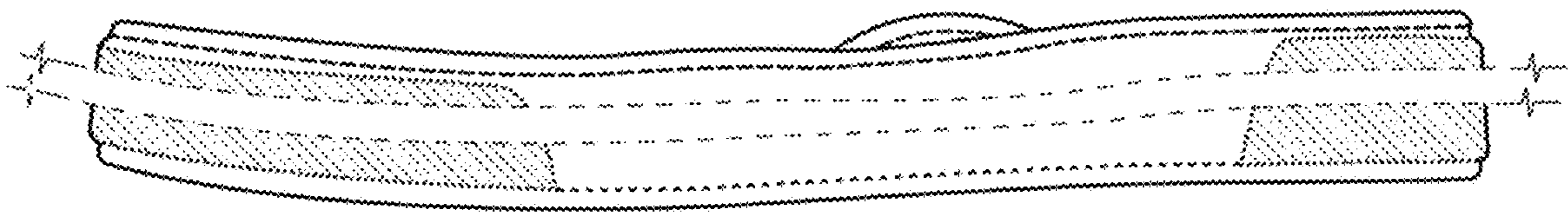

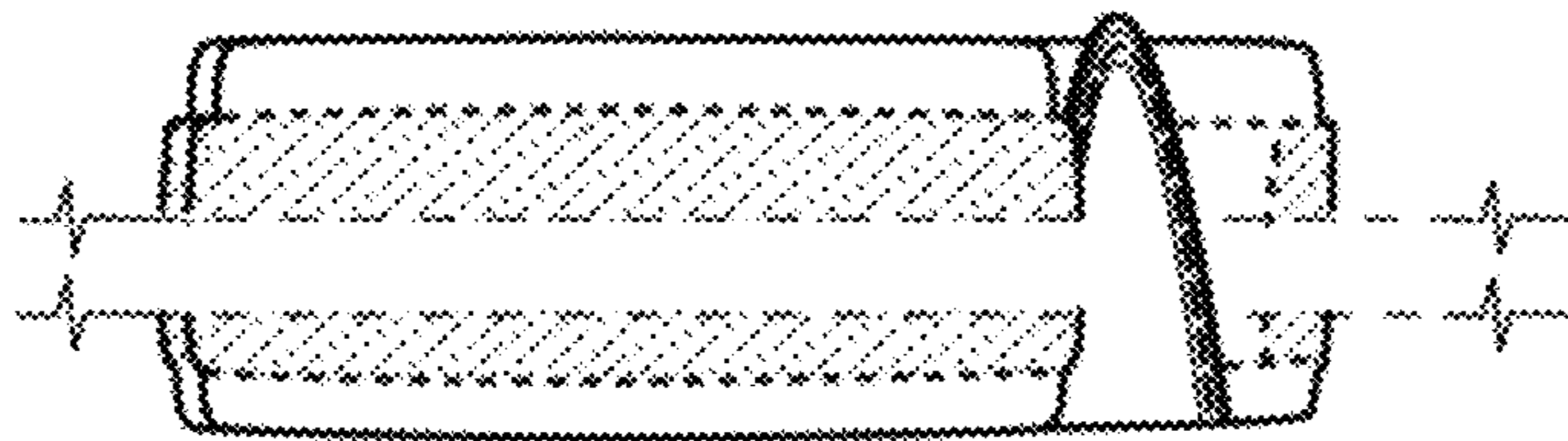

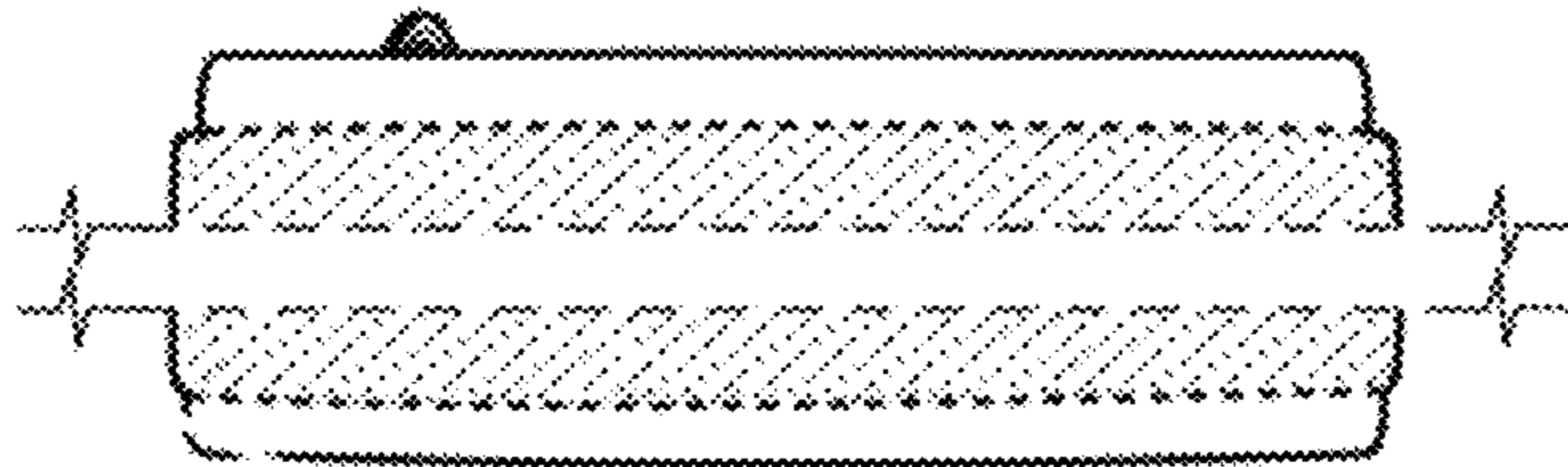

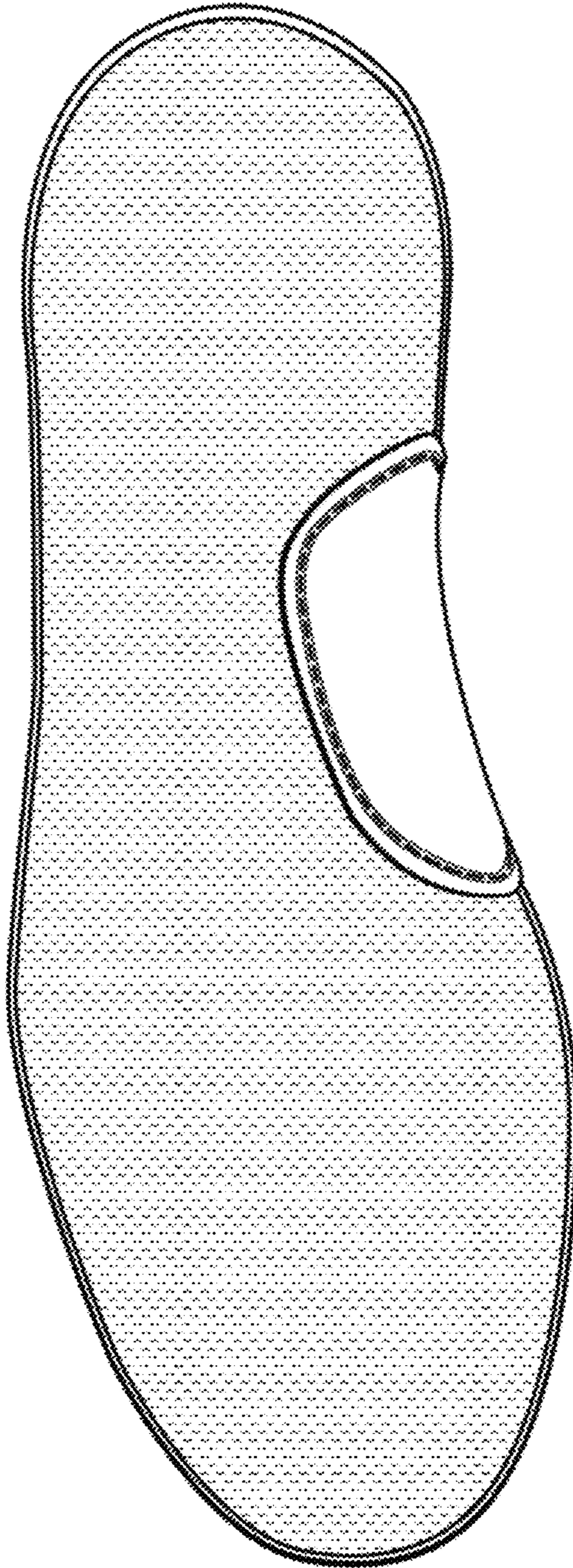
