(57) **CLAIM**

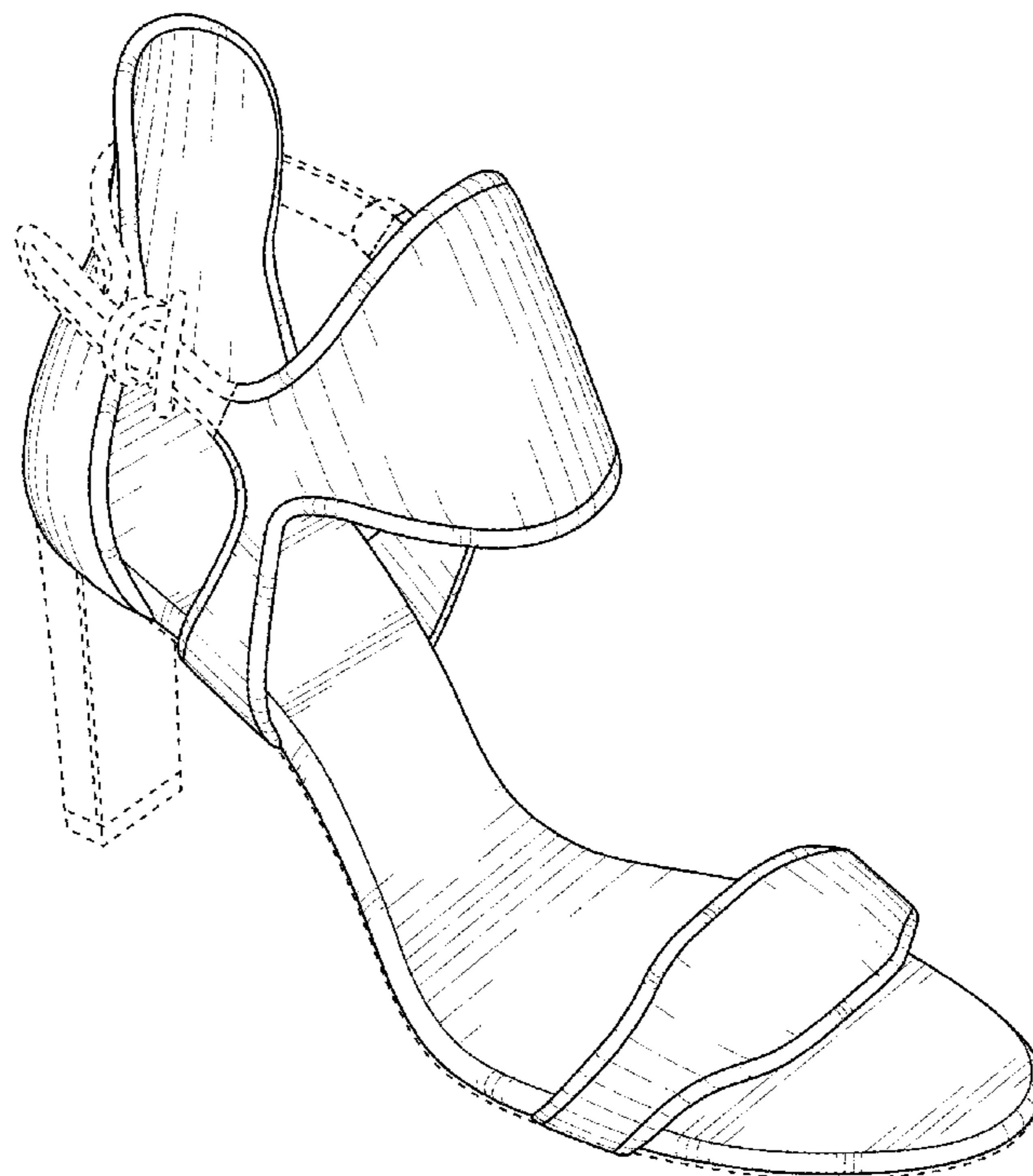
The ornamental design for footwear, as shown and described.

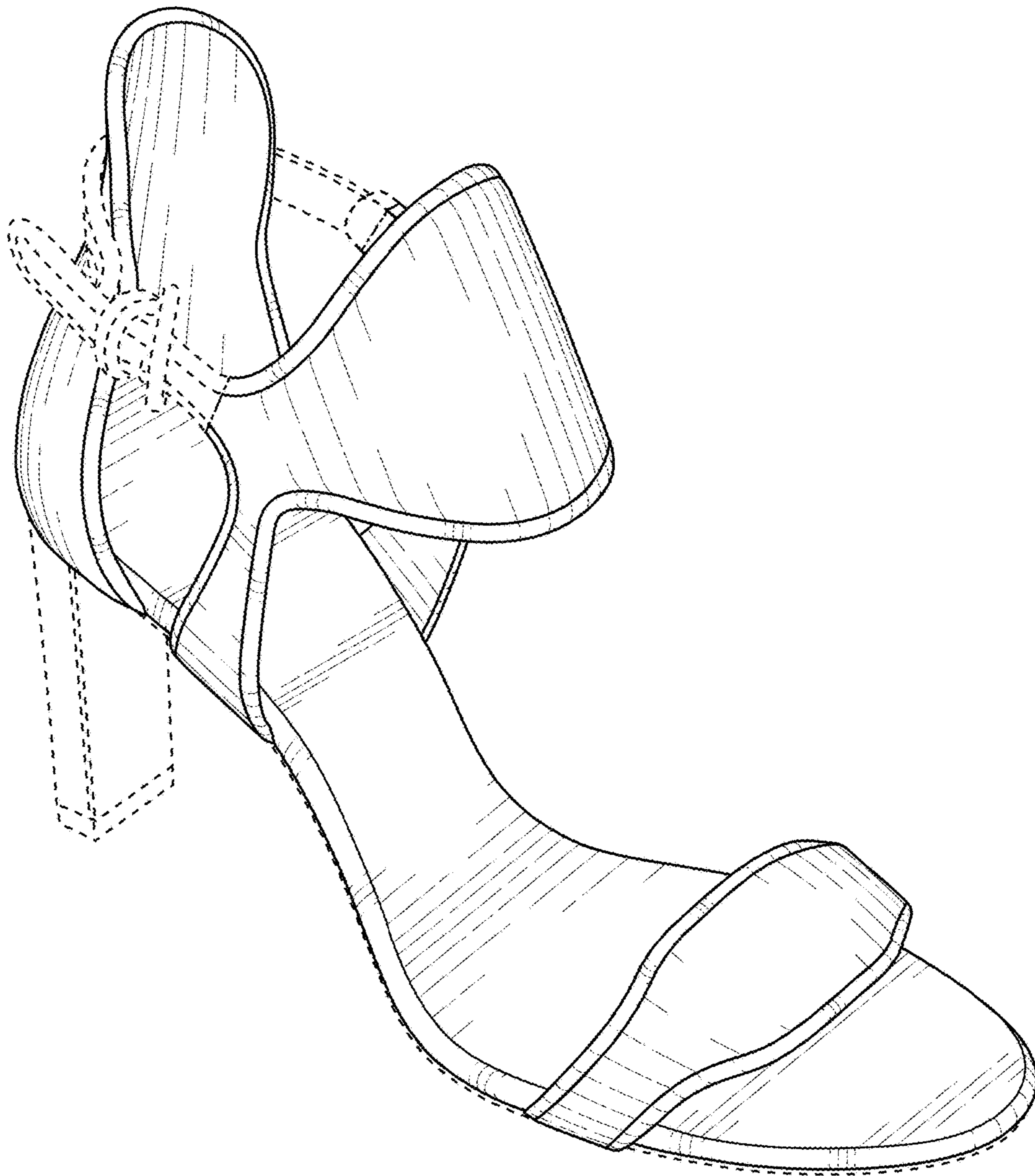

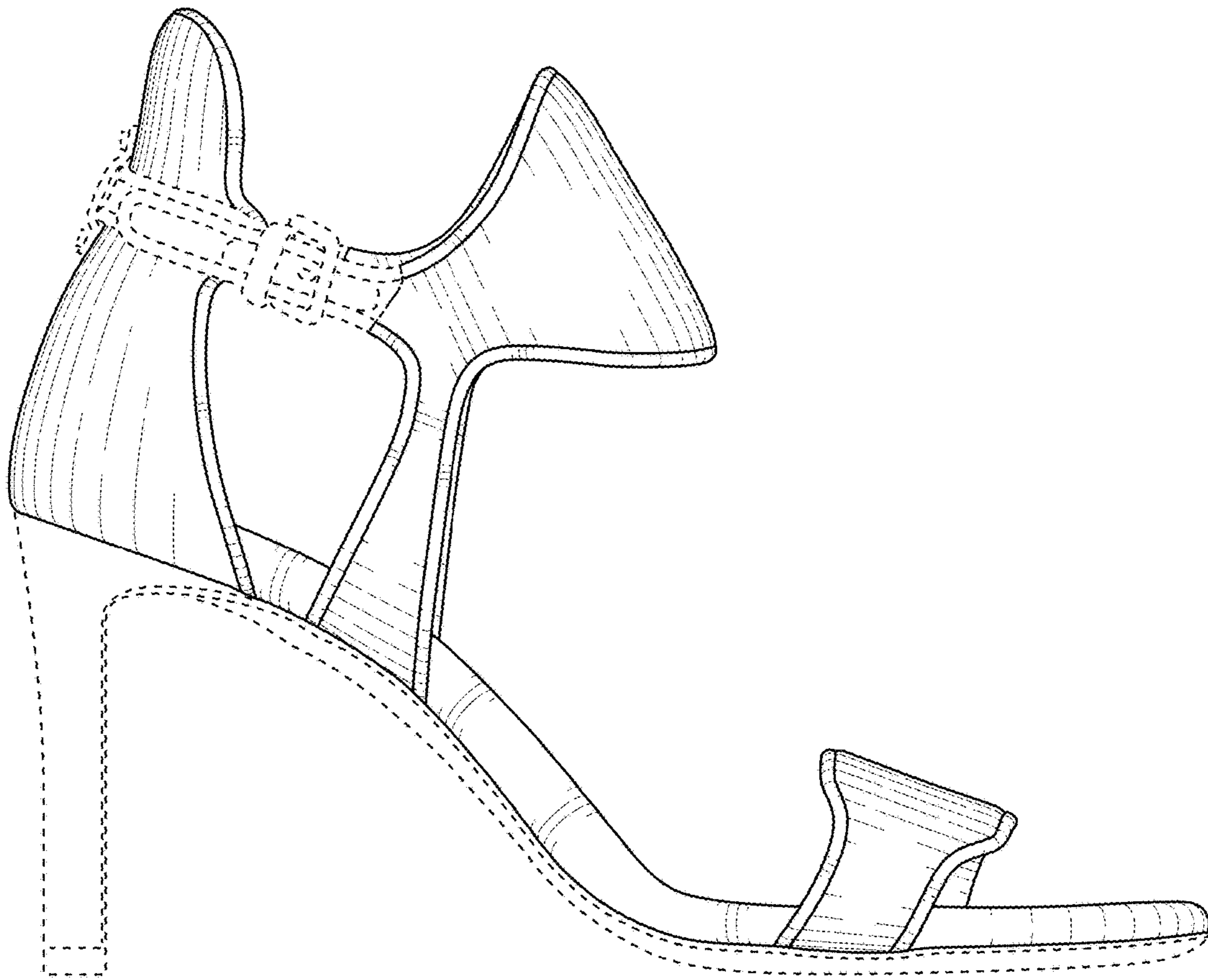

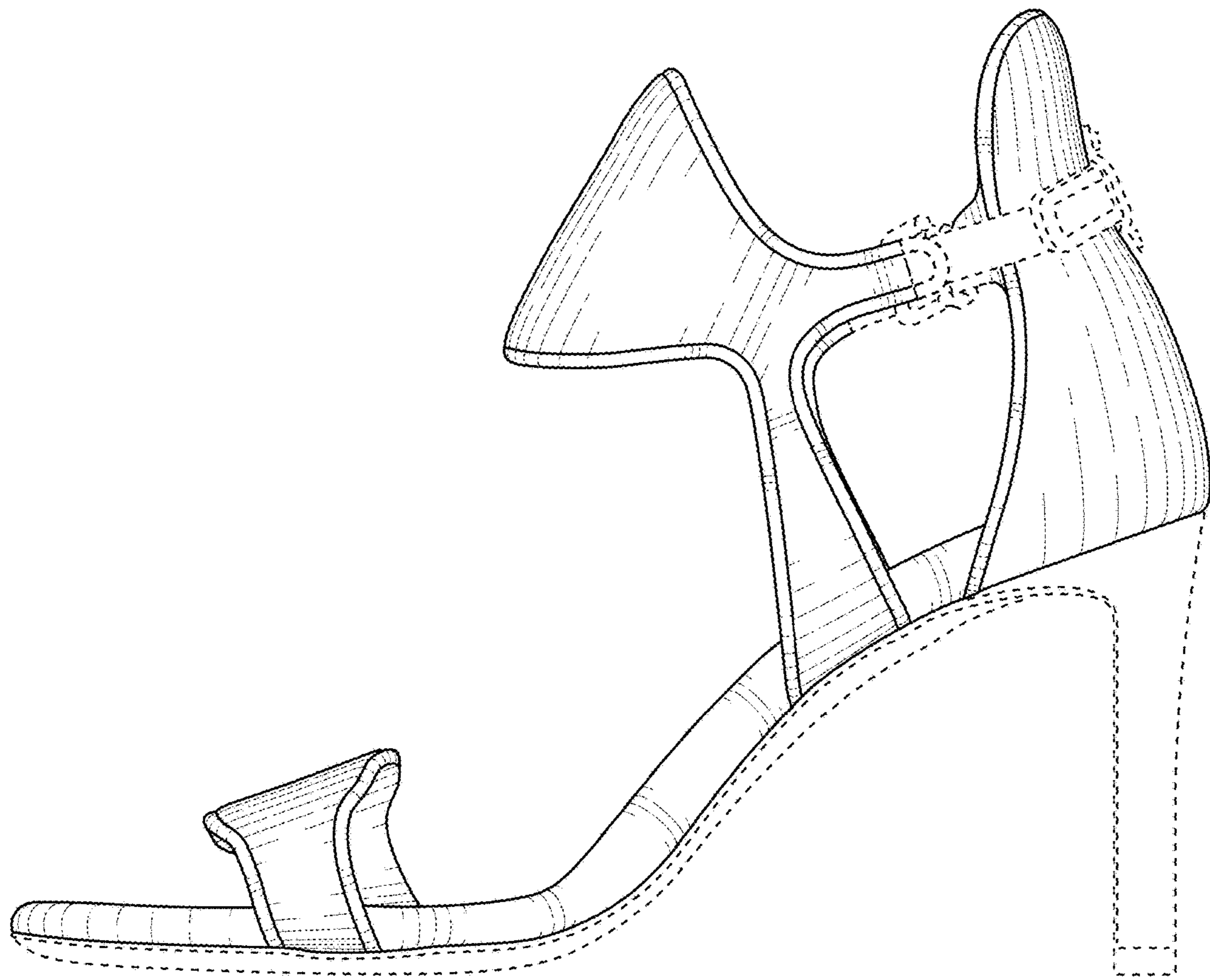

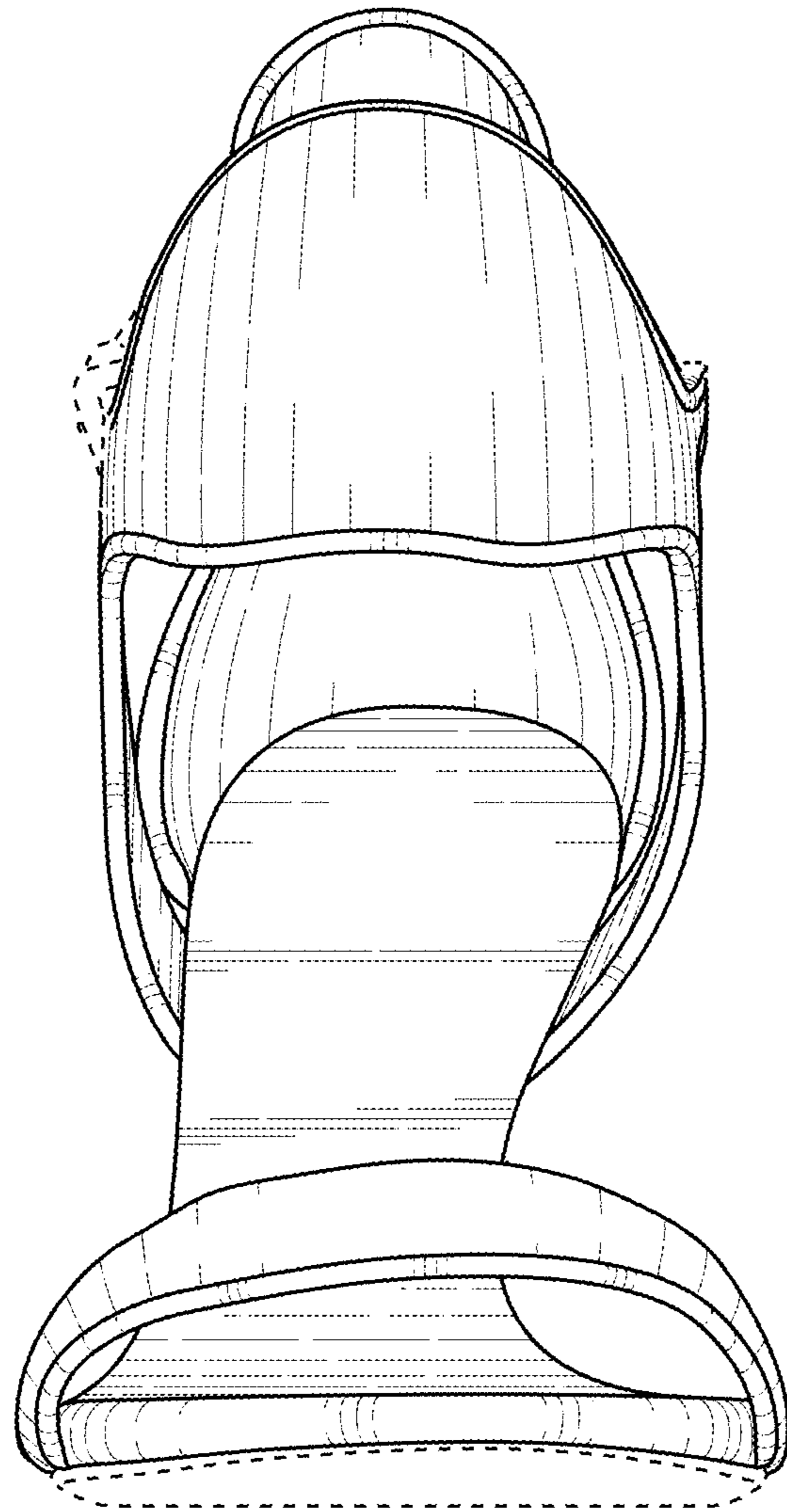

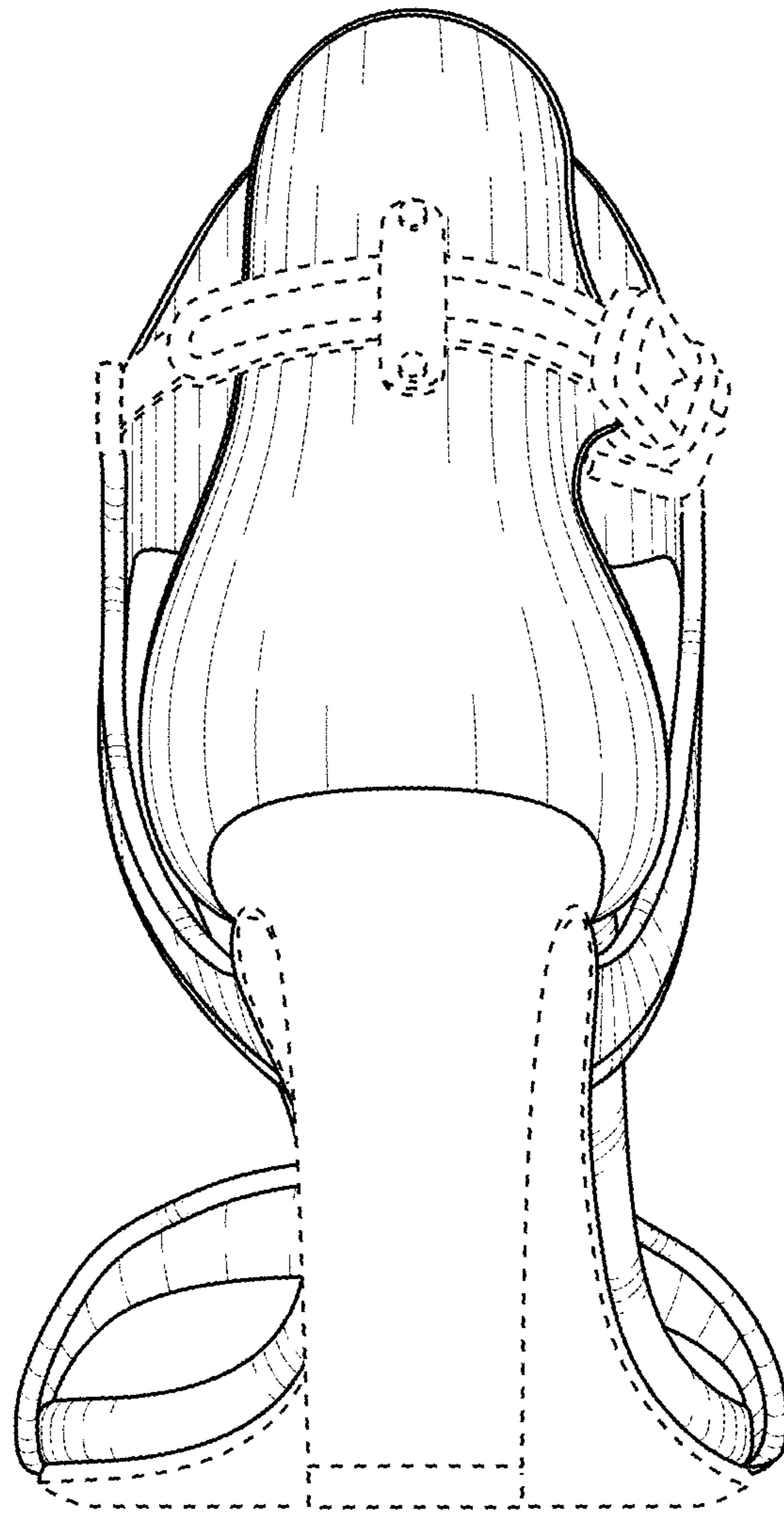

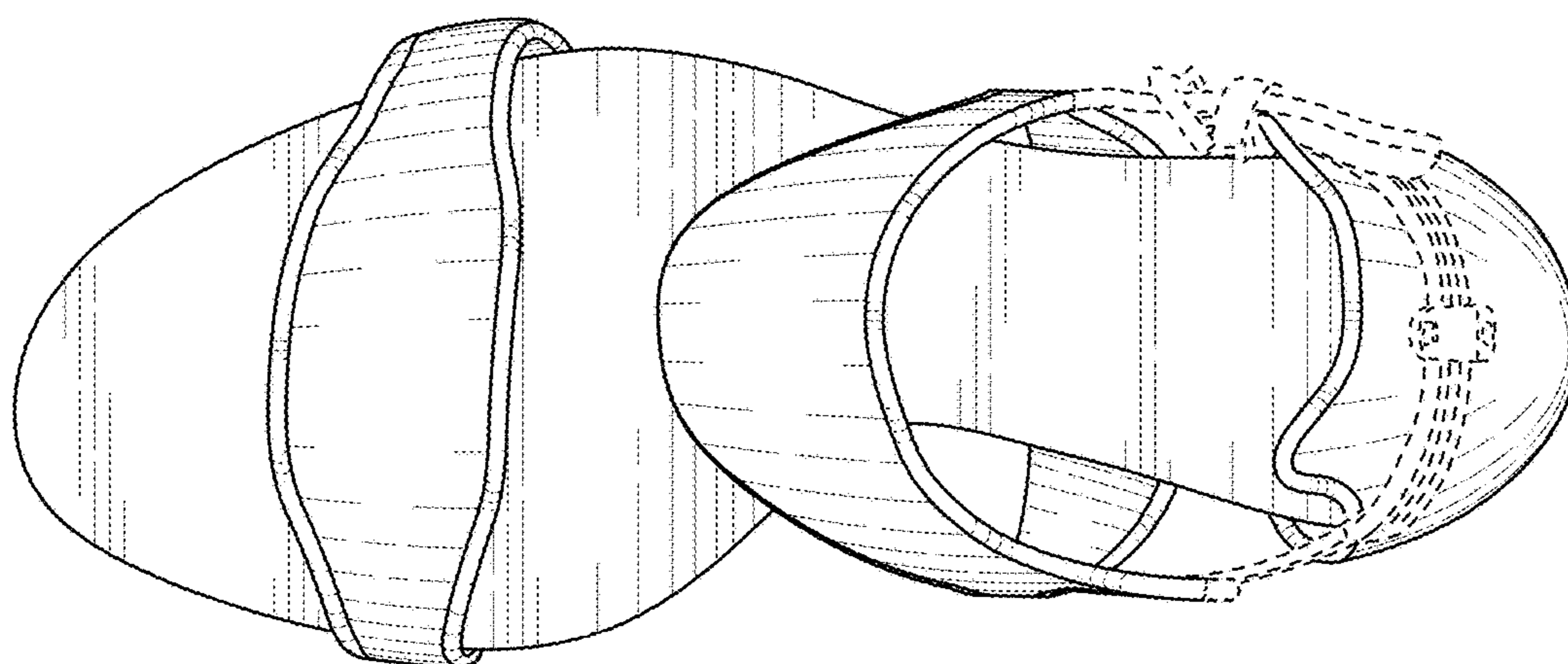
