DESCRIPTION

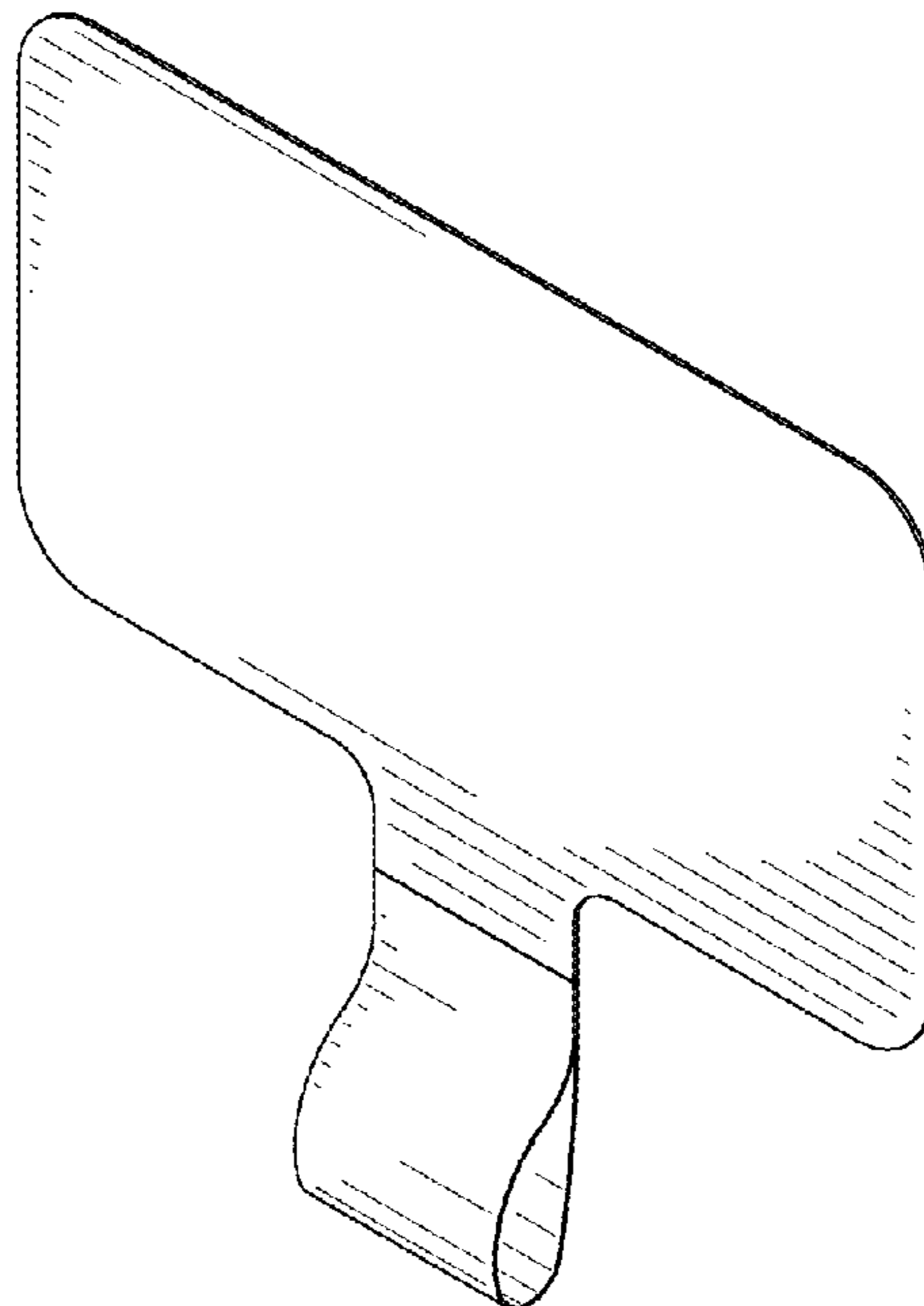
FIG. 1 is a top front perspective view of a phone carrier showing my new design.

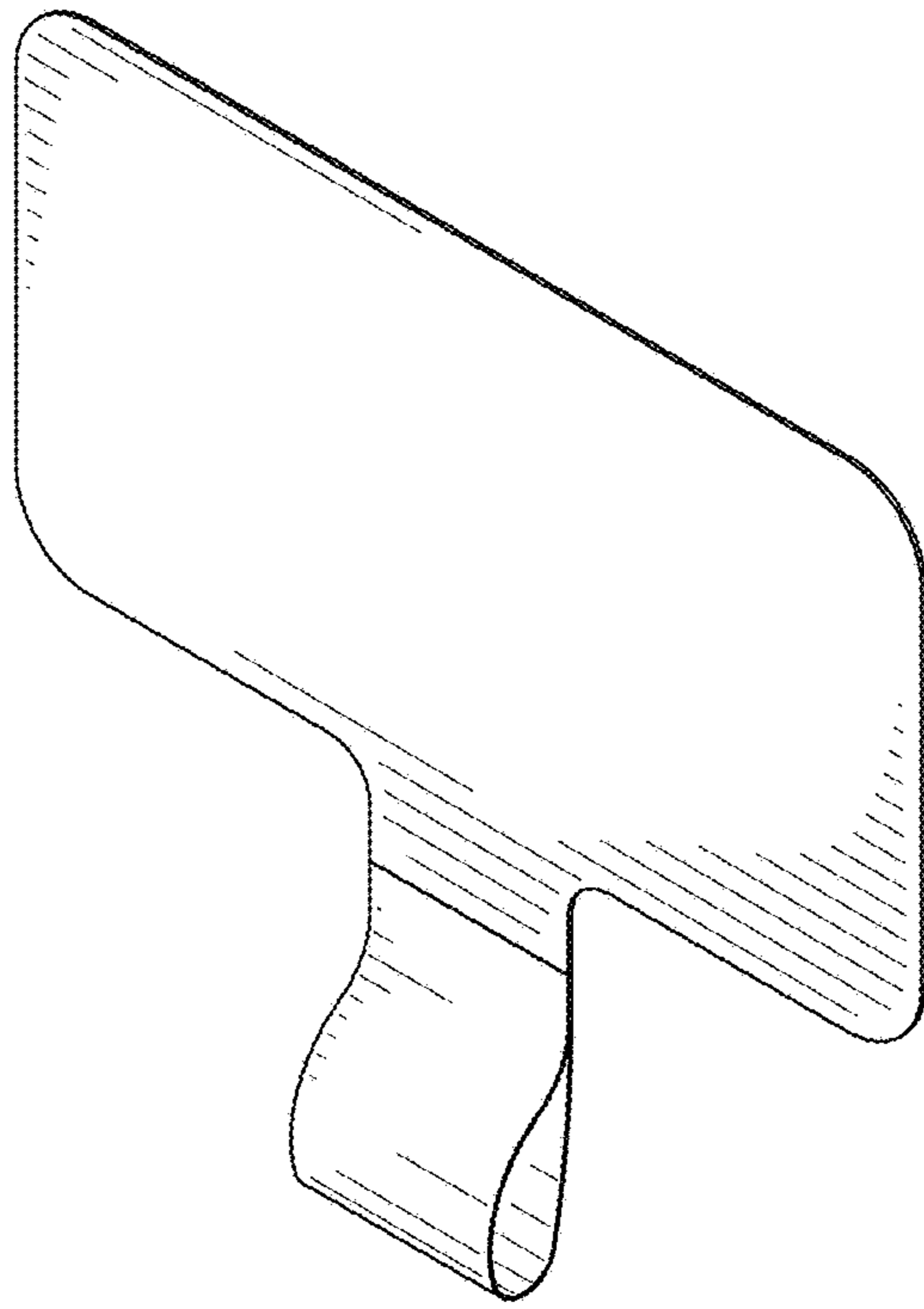

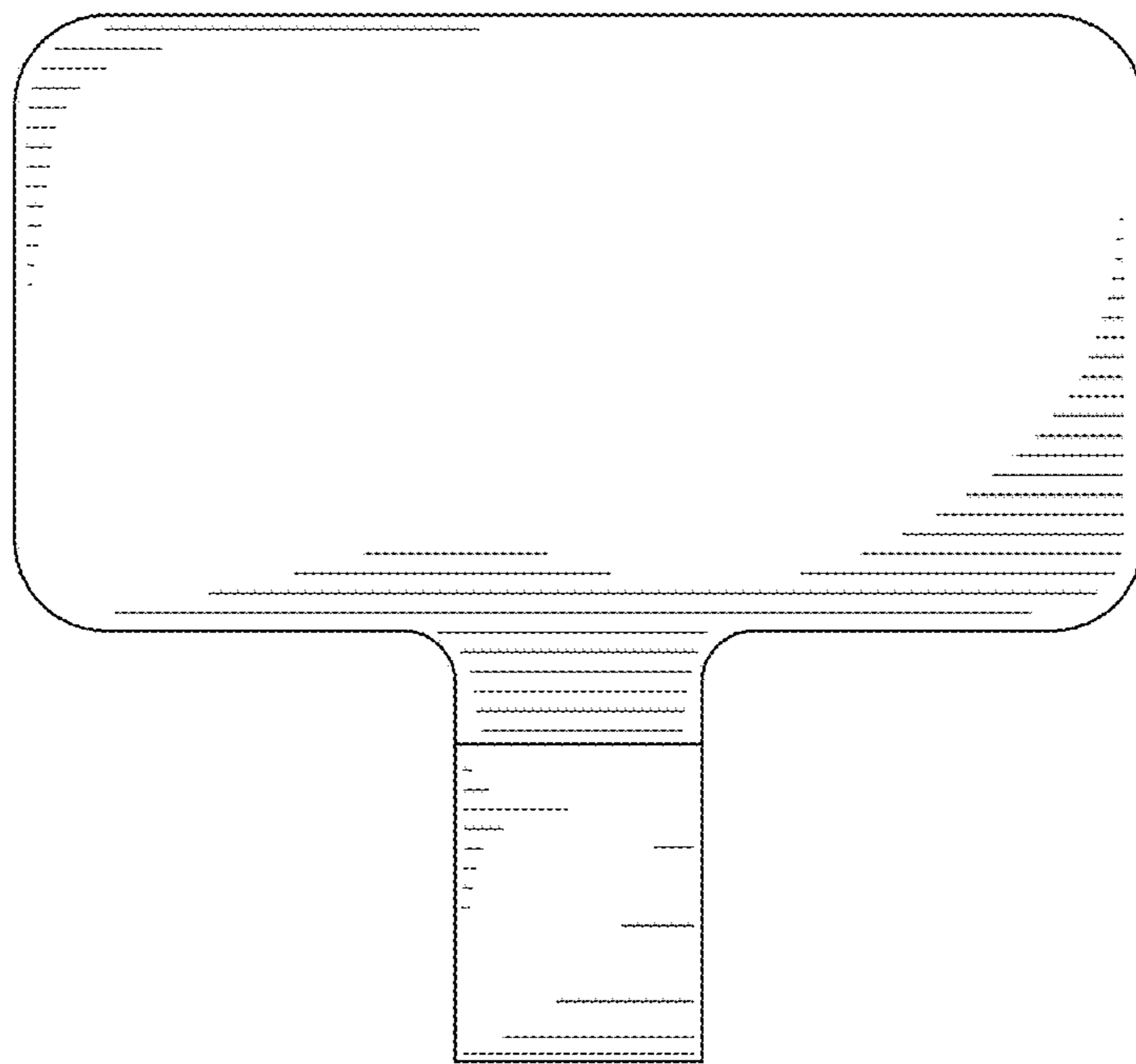

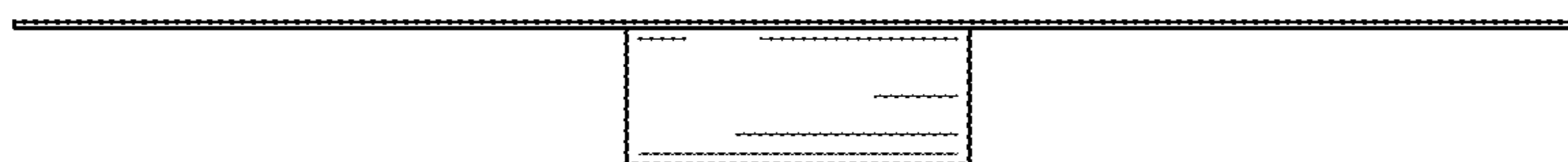

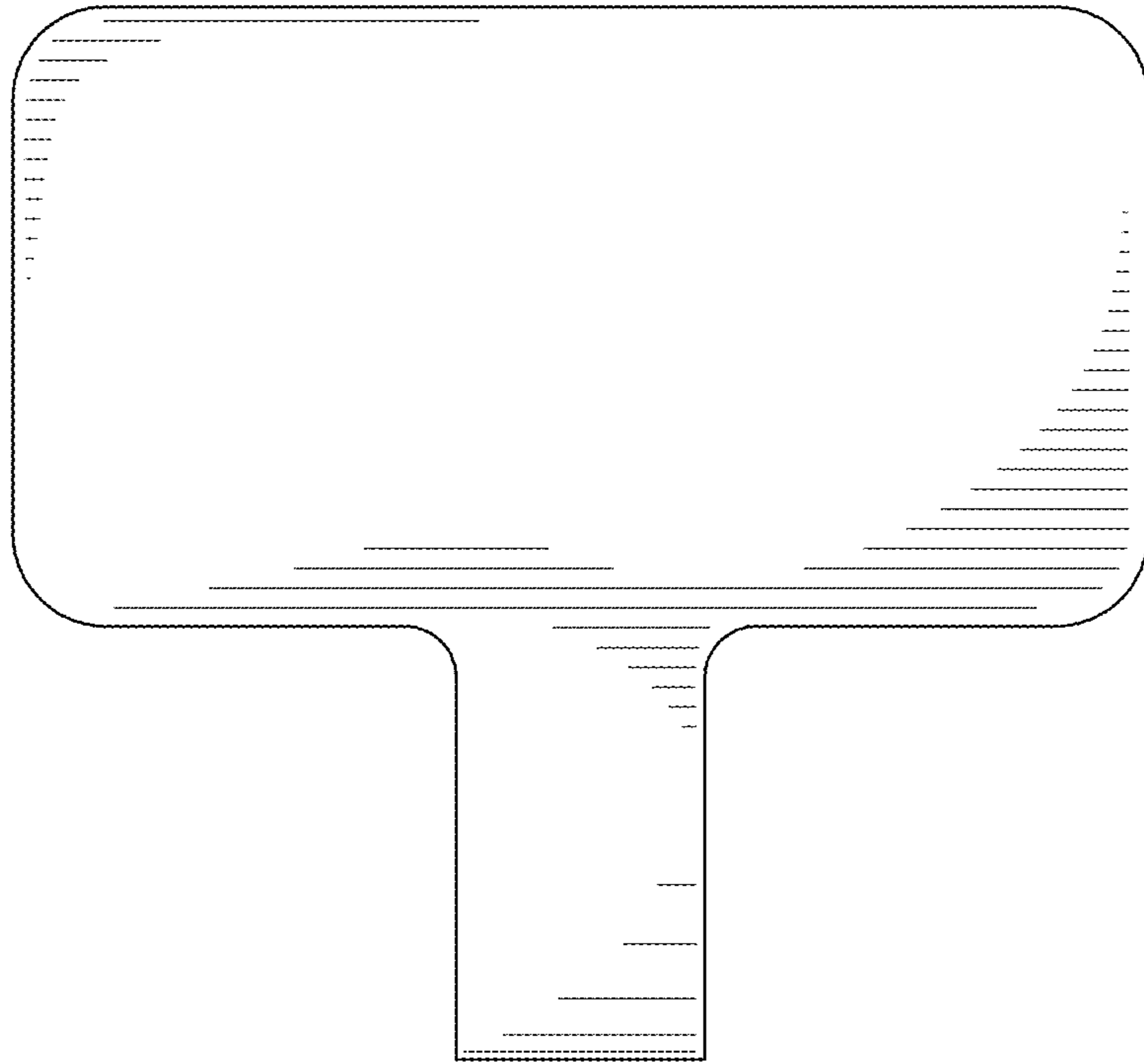

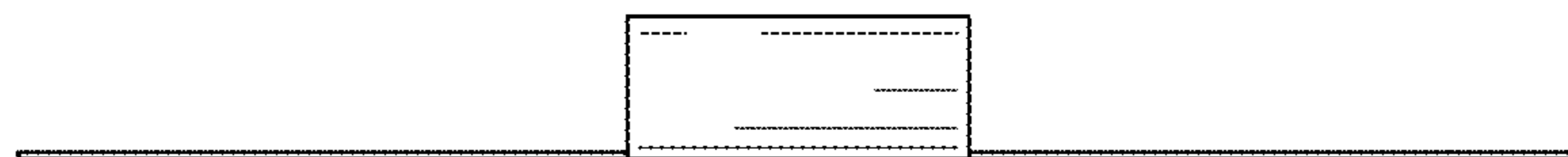

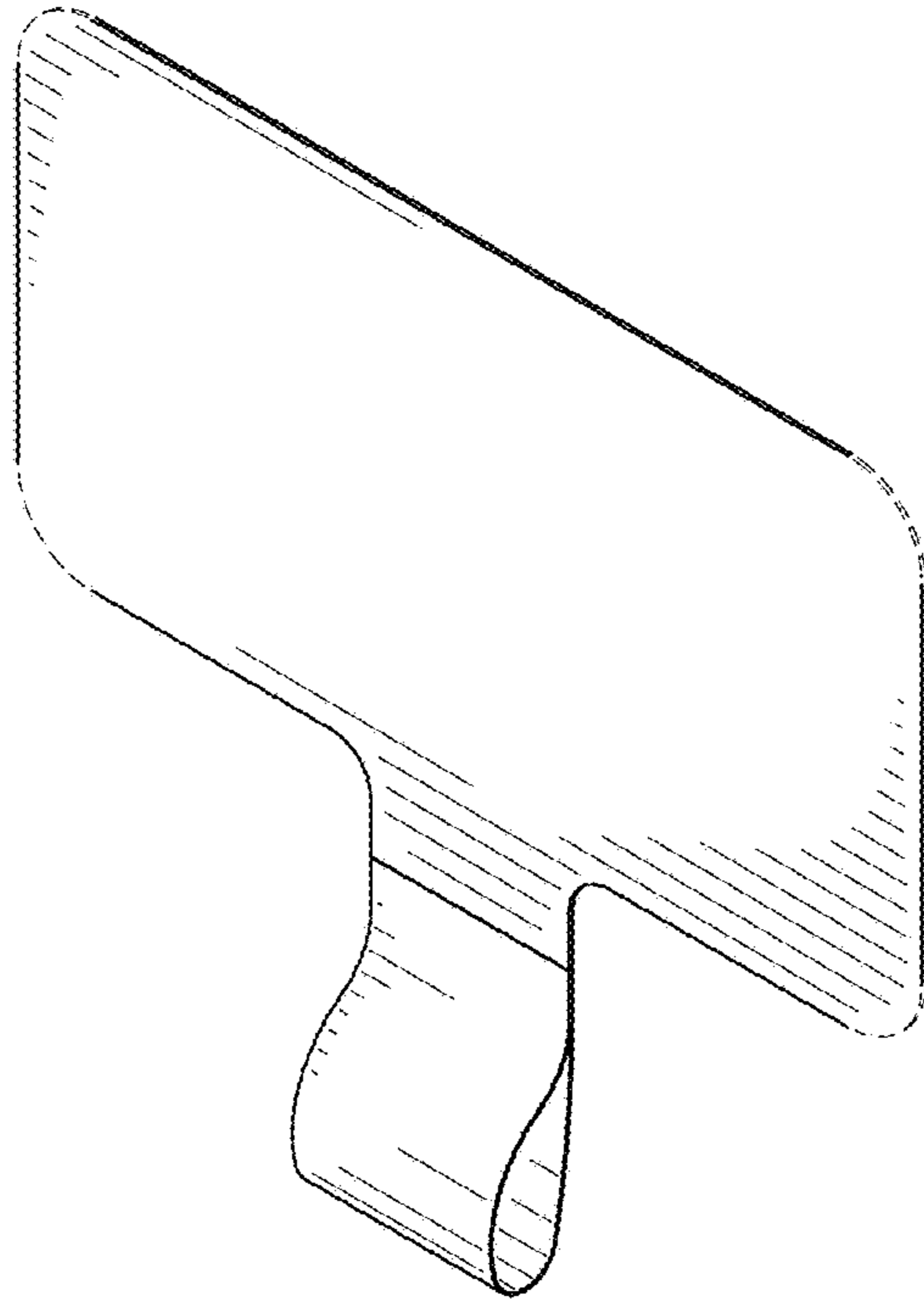

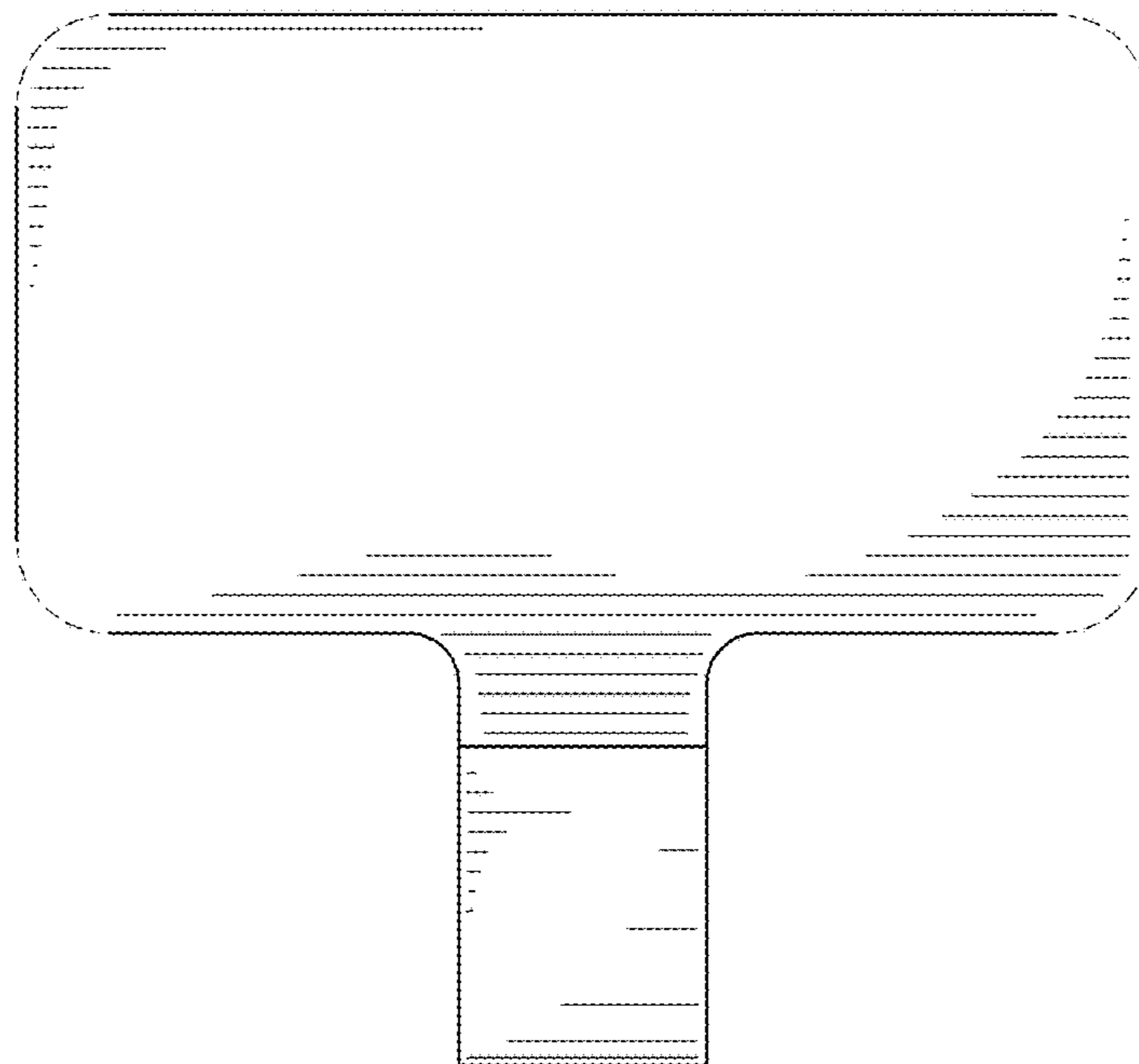

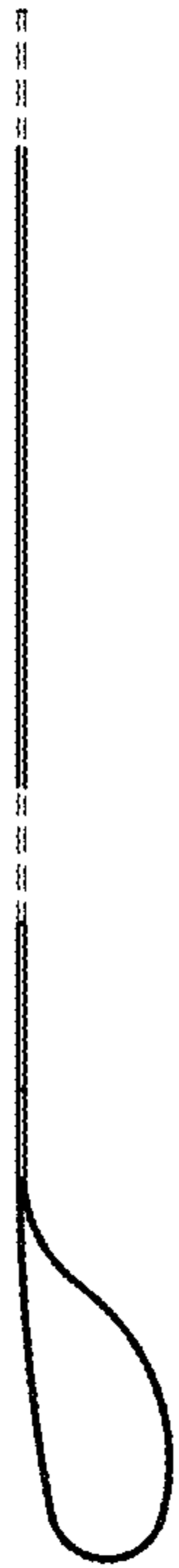

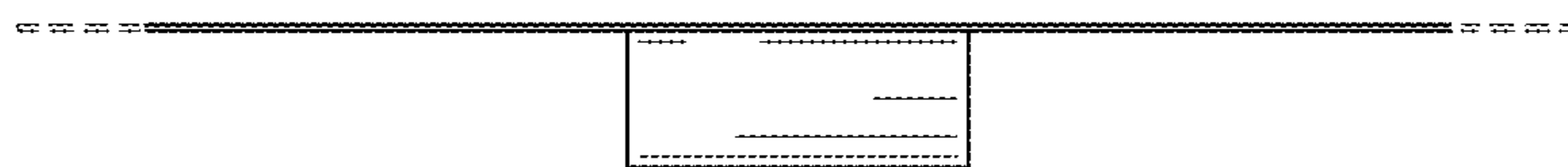

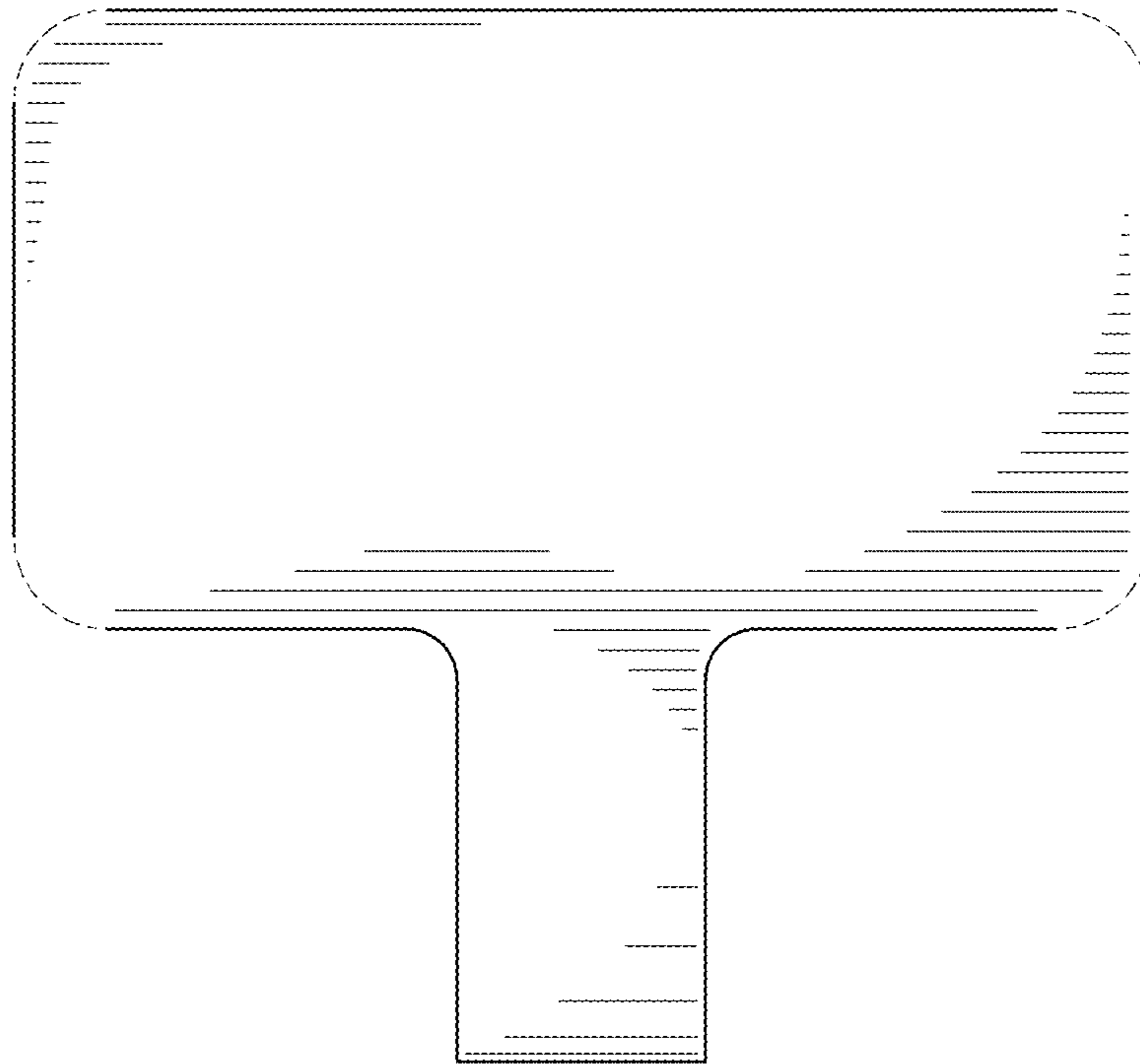

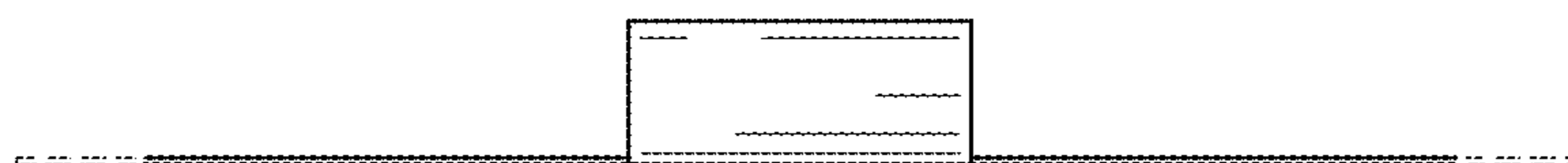
