(57) **CLAIM**

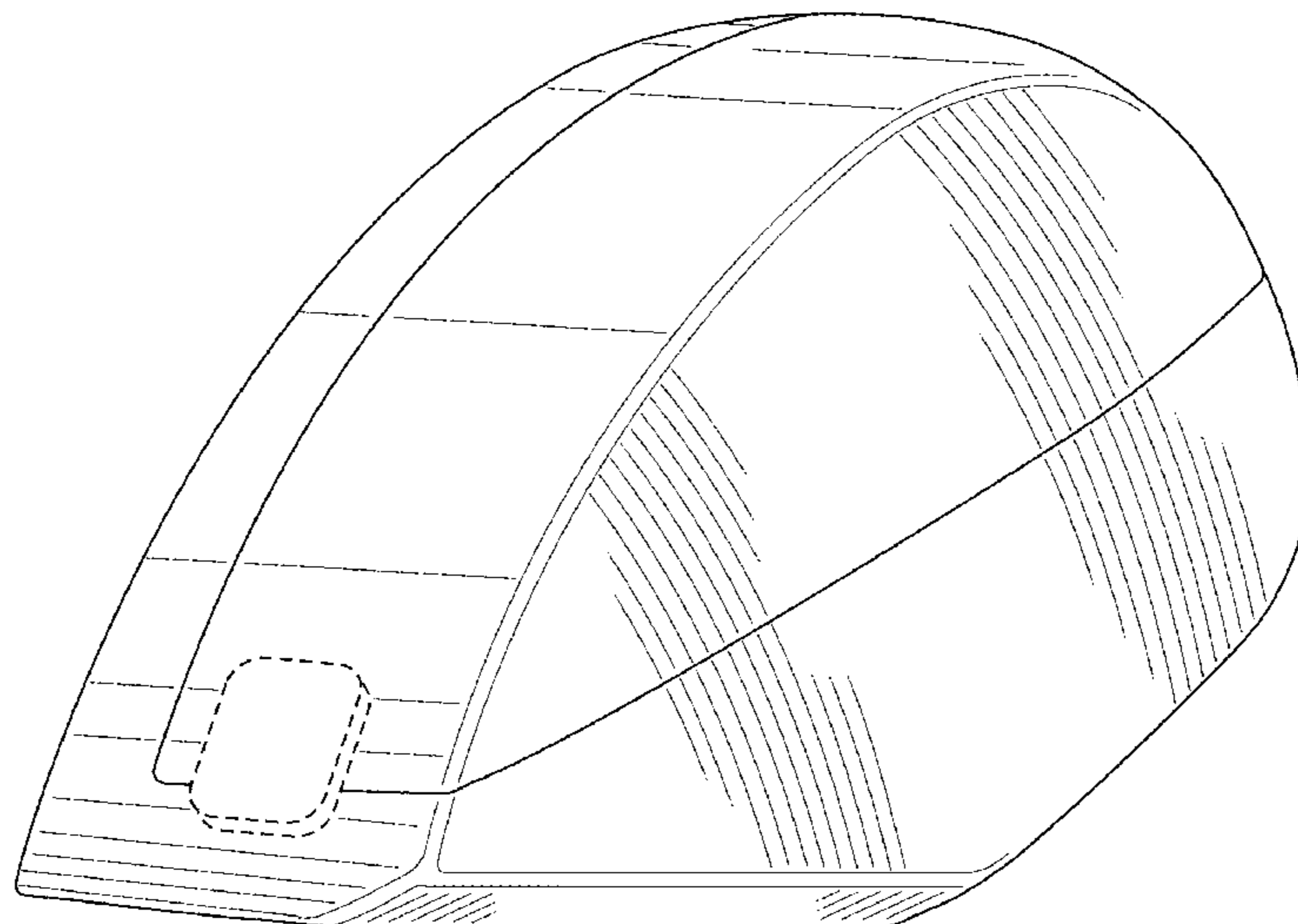
The ornamental design for a side hardbag for a motorcycle, as shown and described.

DESCRIPTION

FIG. 1, is a perspective view of a left side hardbag for a motorcycle according to the invention; FIG. 2, is a side view thereof; FIG. 3, is a reverse side view thereof; FIG. 4, is a top view thereof; FIG. 5, is a bottom view thereof; FIG. 6 is a front view thereof; FIG. 7 is a back view thereof; and FIG. 8 is an isometric view of the side hardbag for a motorcycle as it would appear in an exemplary environment. FIG. 9 is a perspective view of a right side hardbag for a motorcycle according to the invention; FIG. 10 is a side view thereof; FIG. 11 is a reverse side view thereof; FIG. 12 is a top view thereof; FIG. 13 is a bottom view thereof; FIG. 14 is a front view thereof; and, FIG. 15 is a back view thereof.

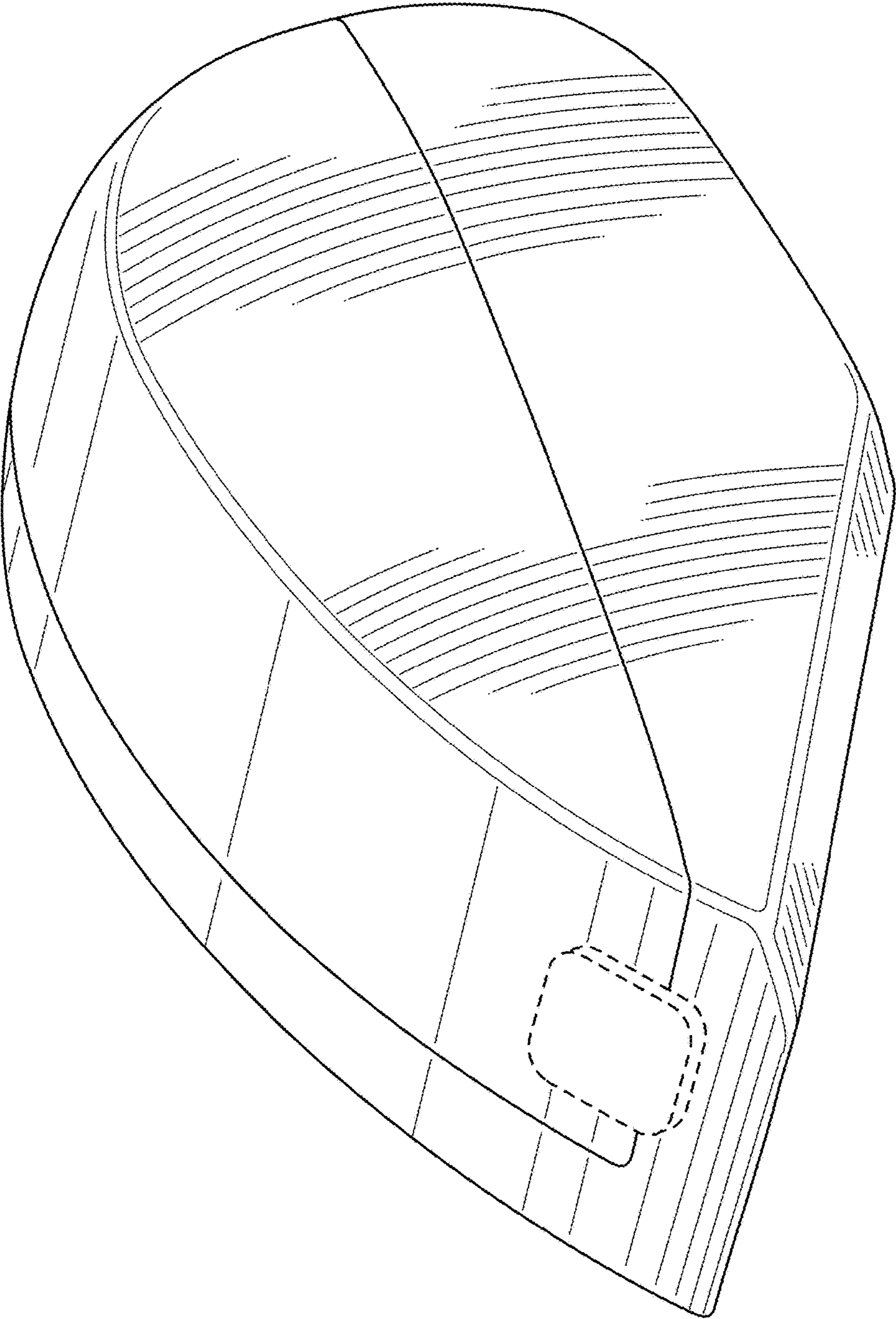

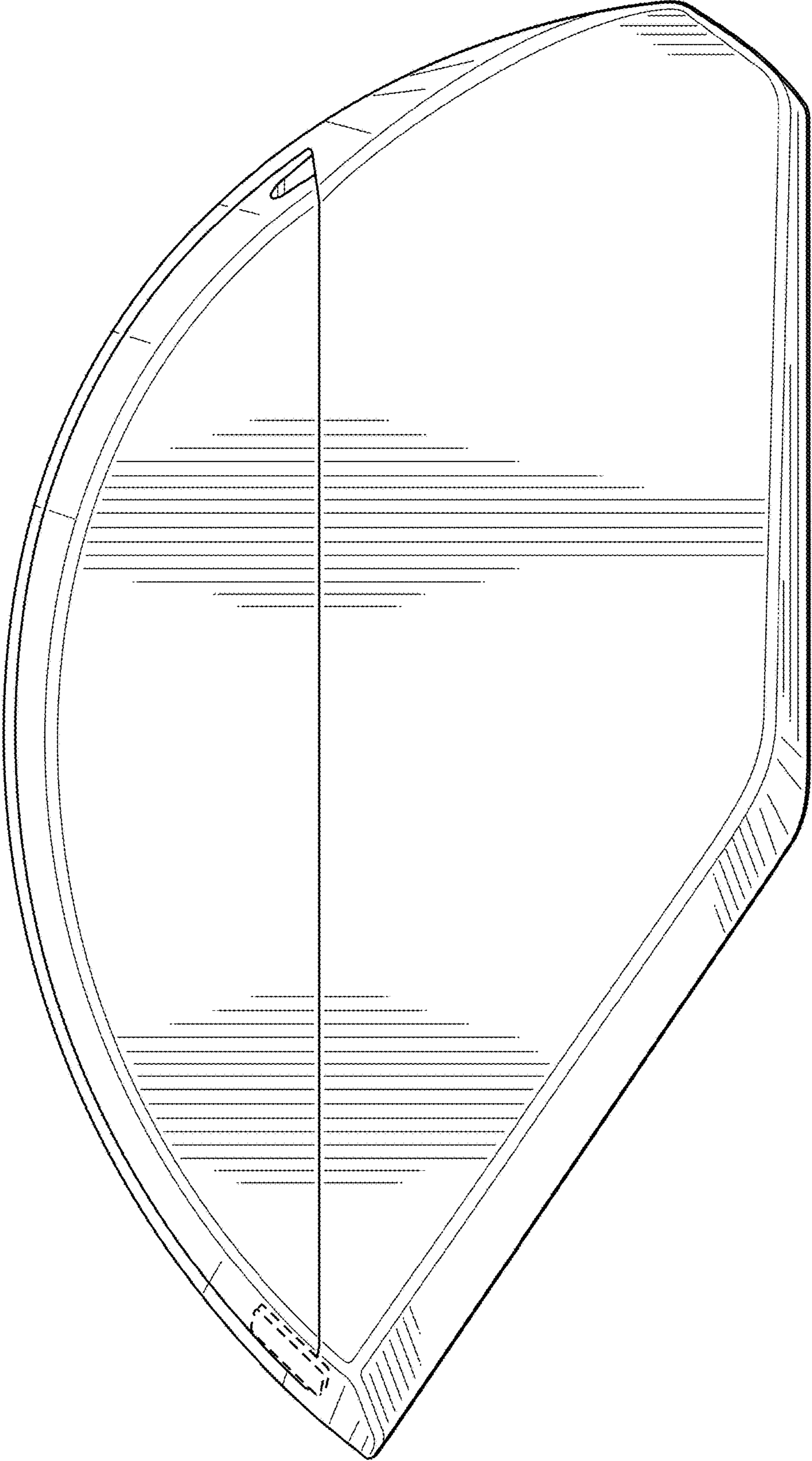

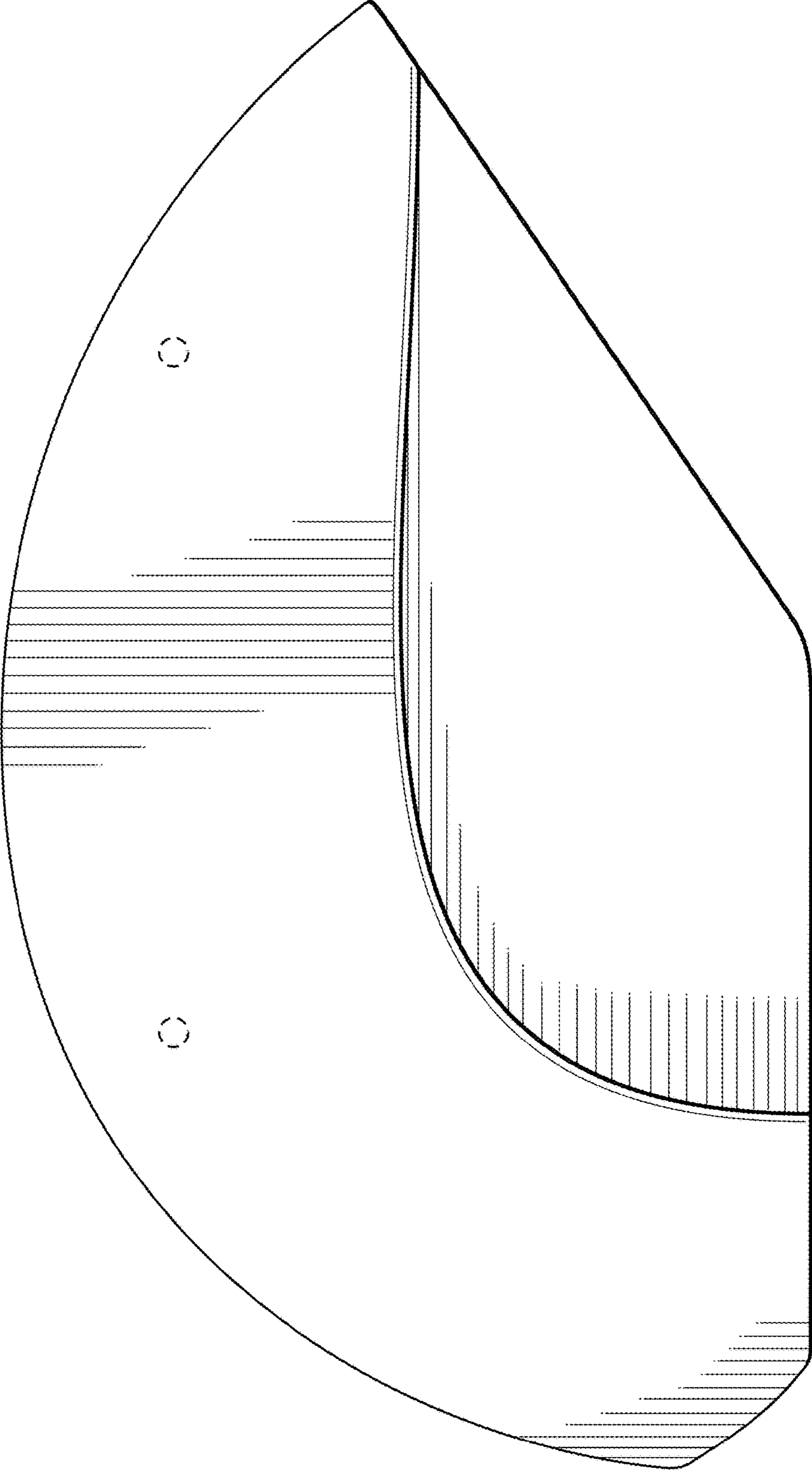

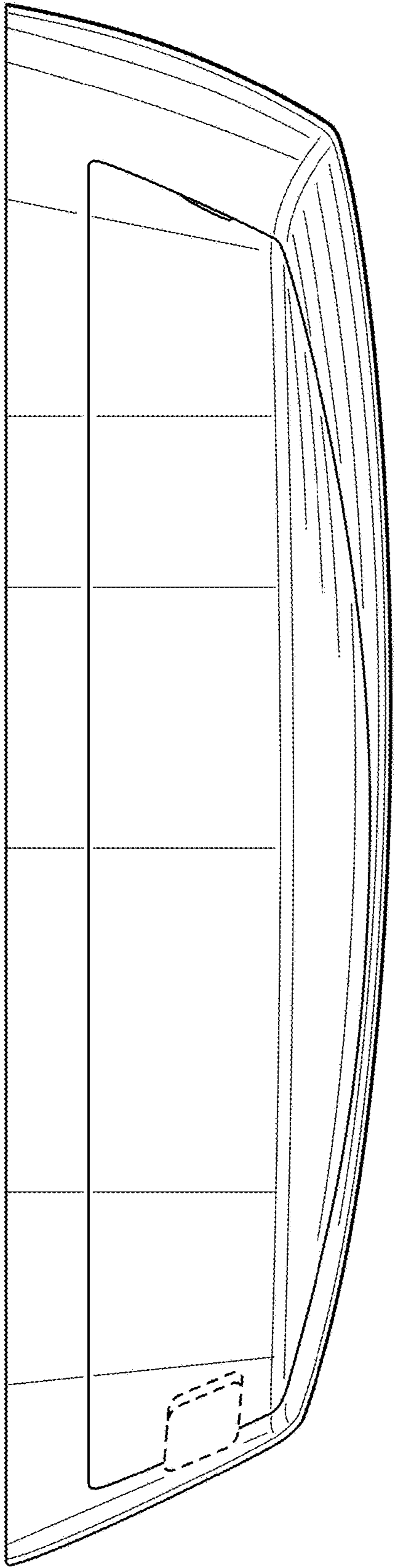

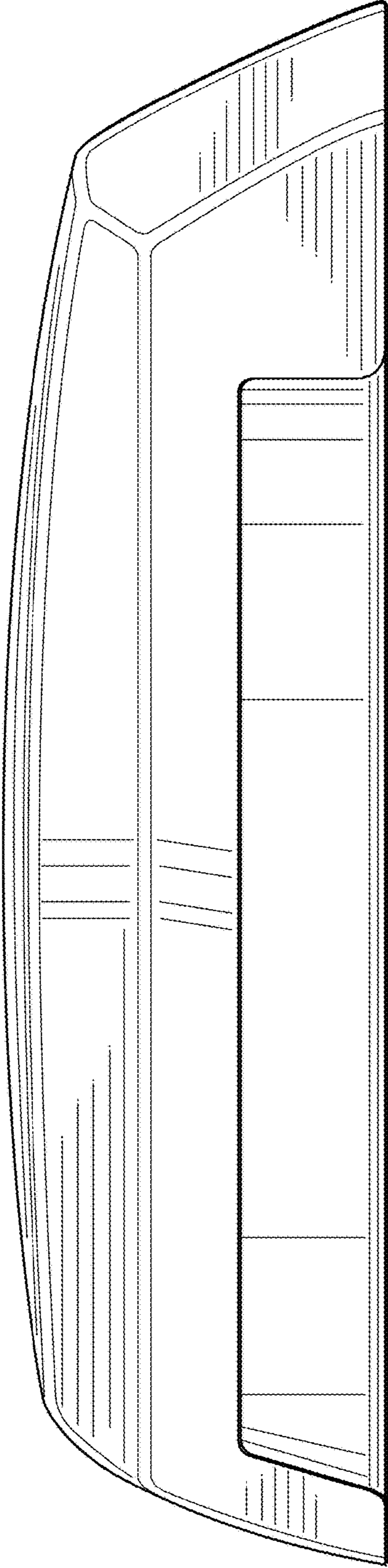

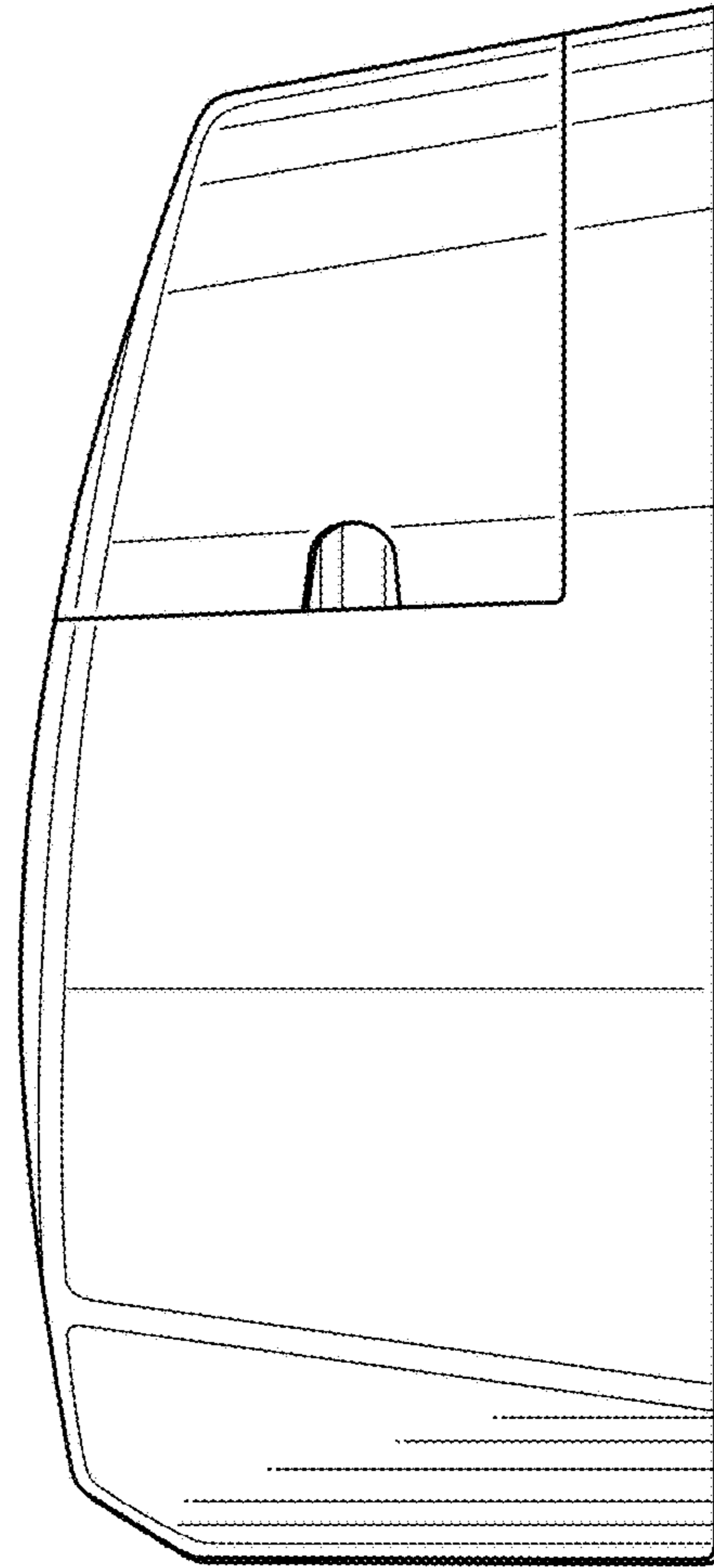
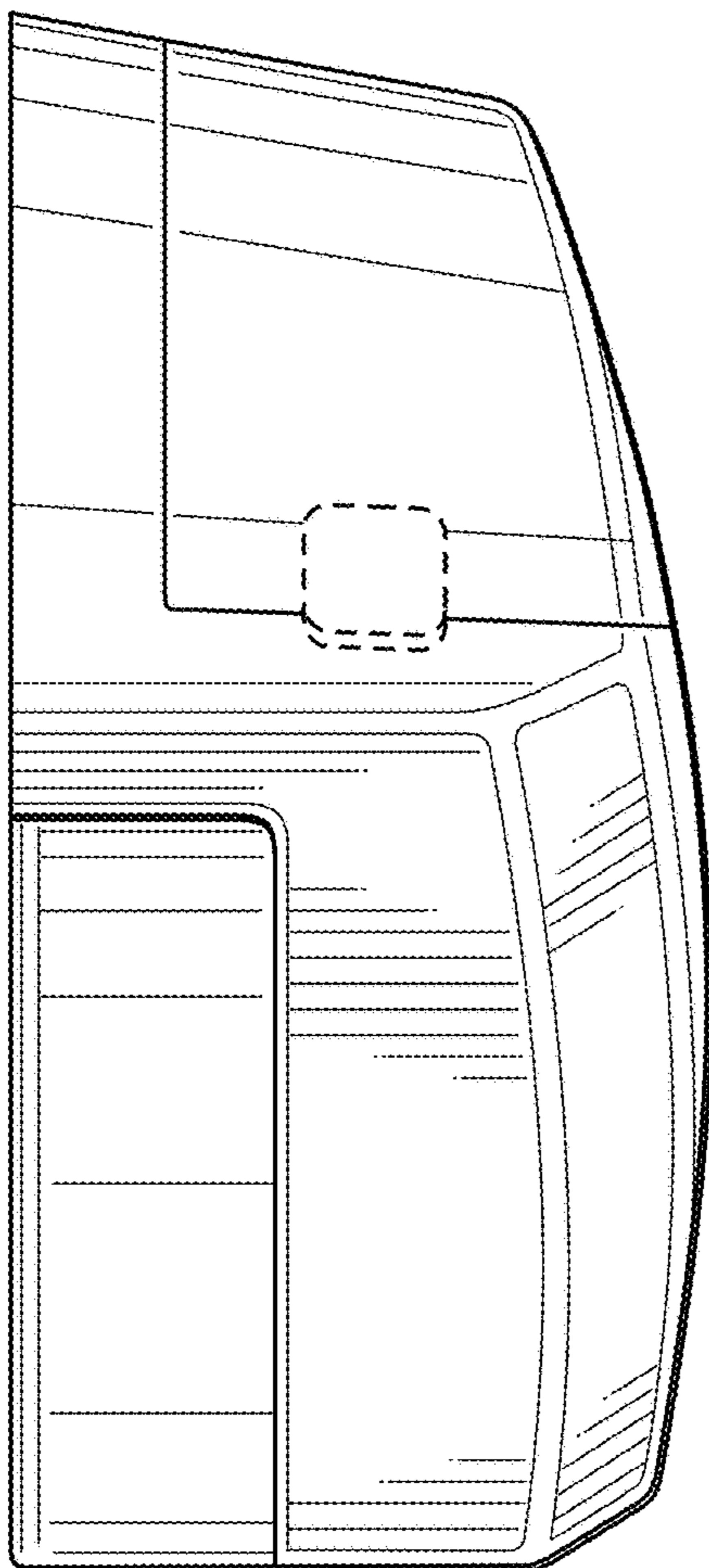

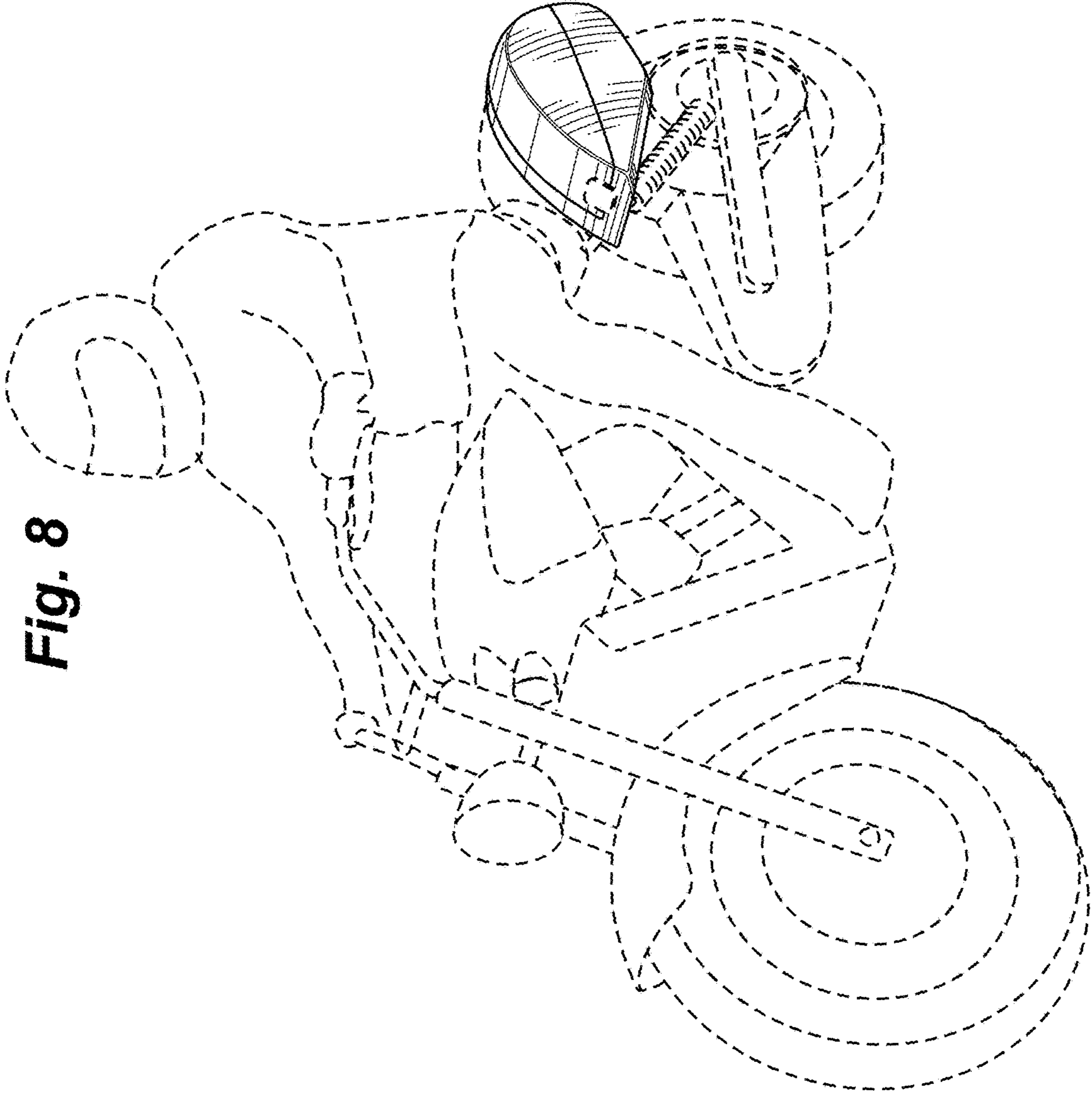

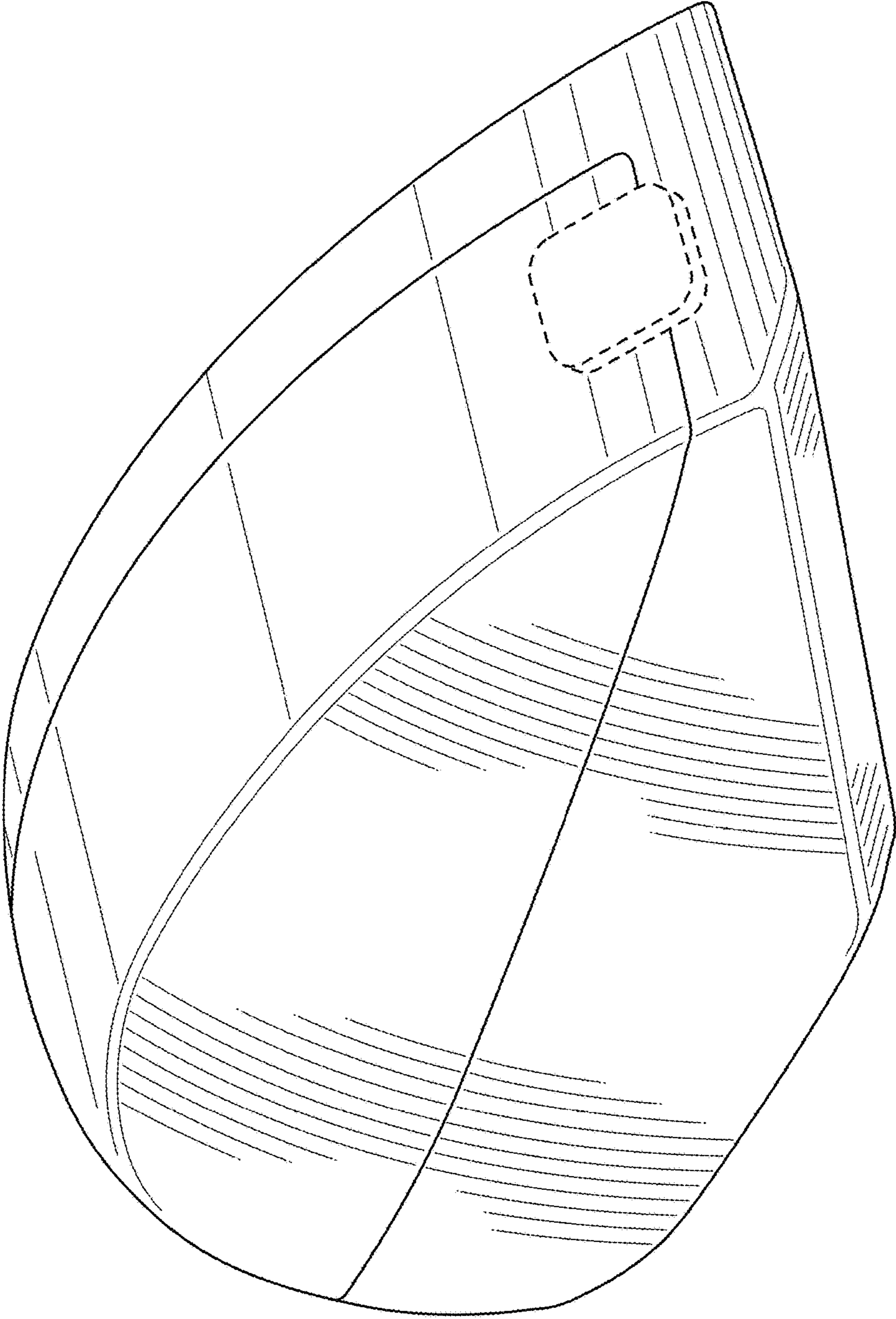

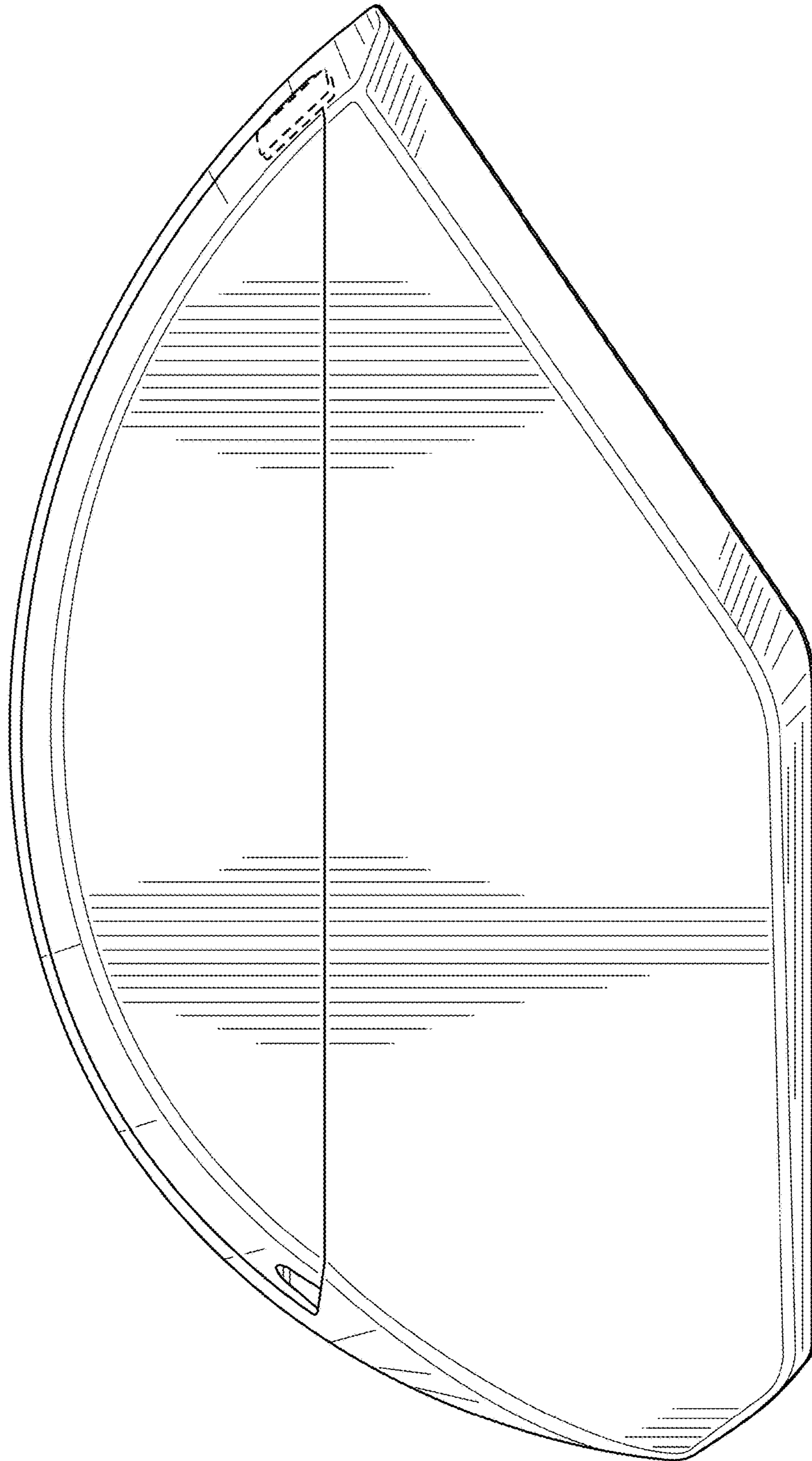

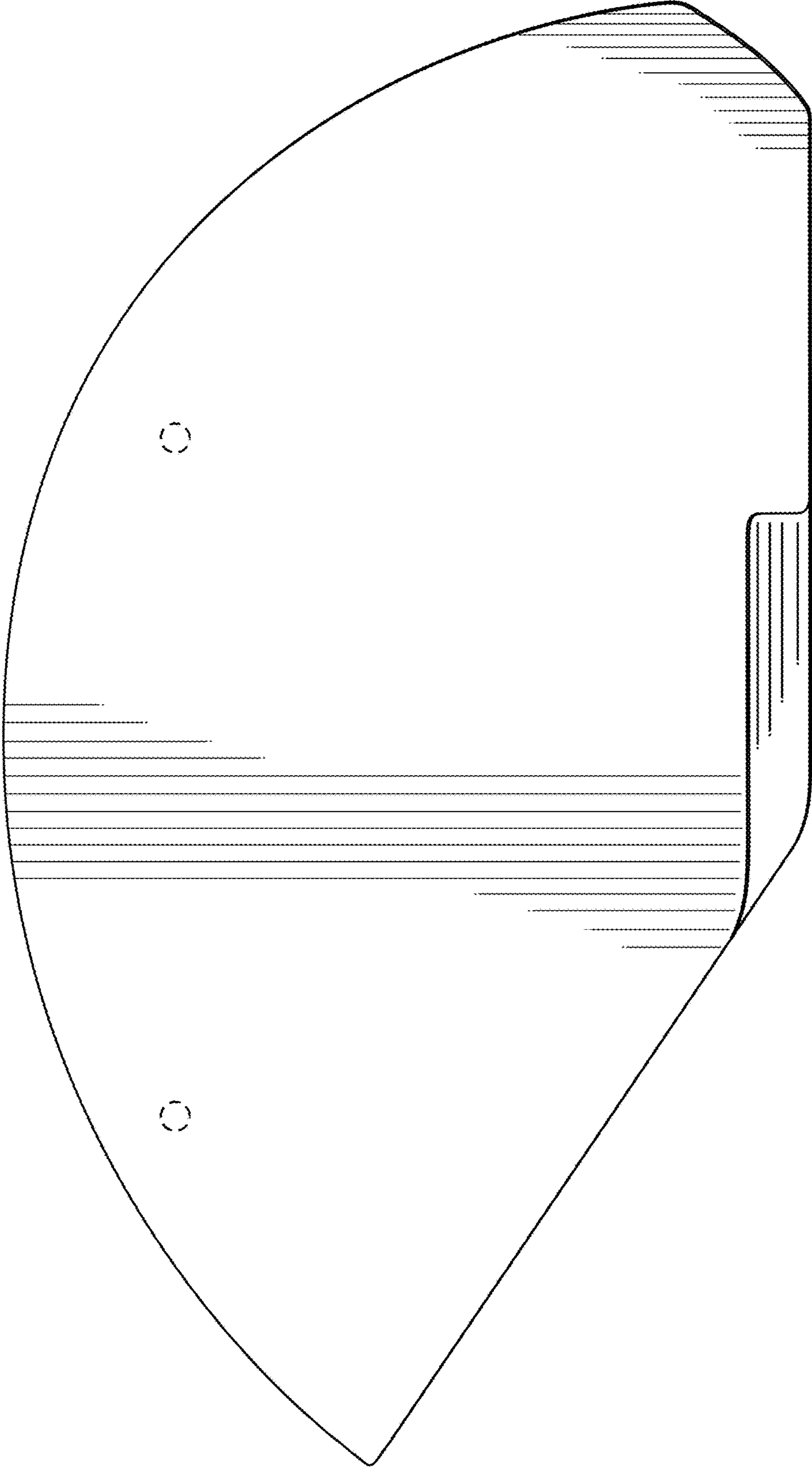

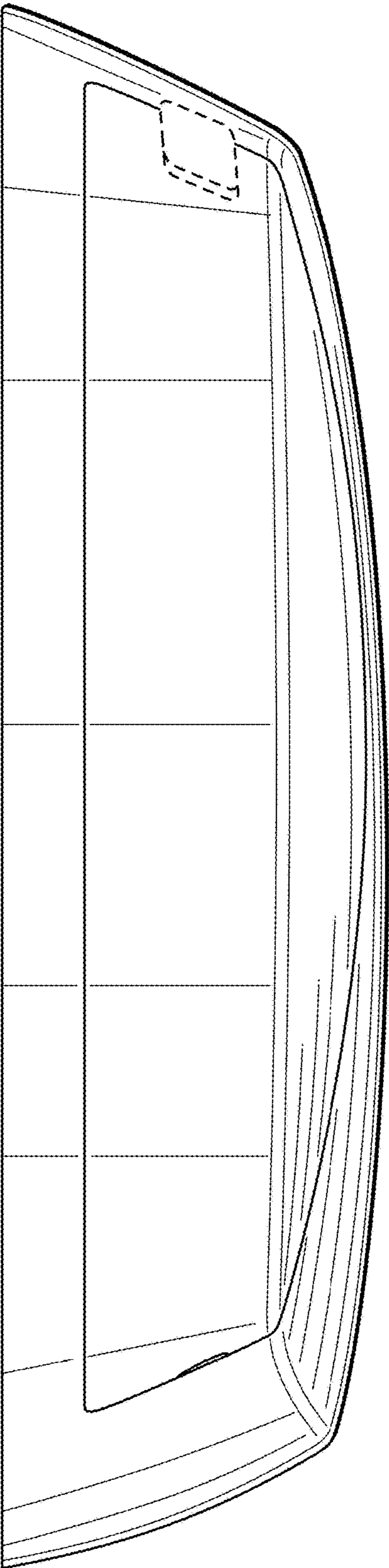

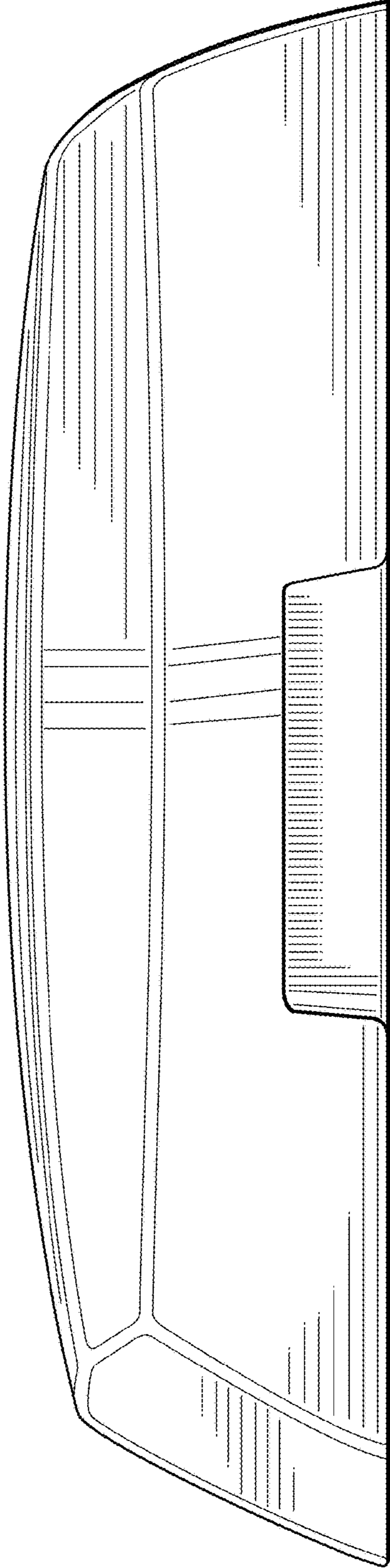

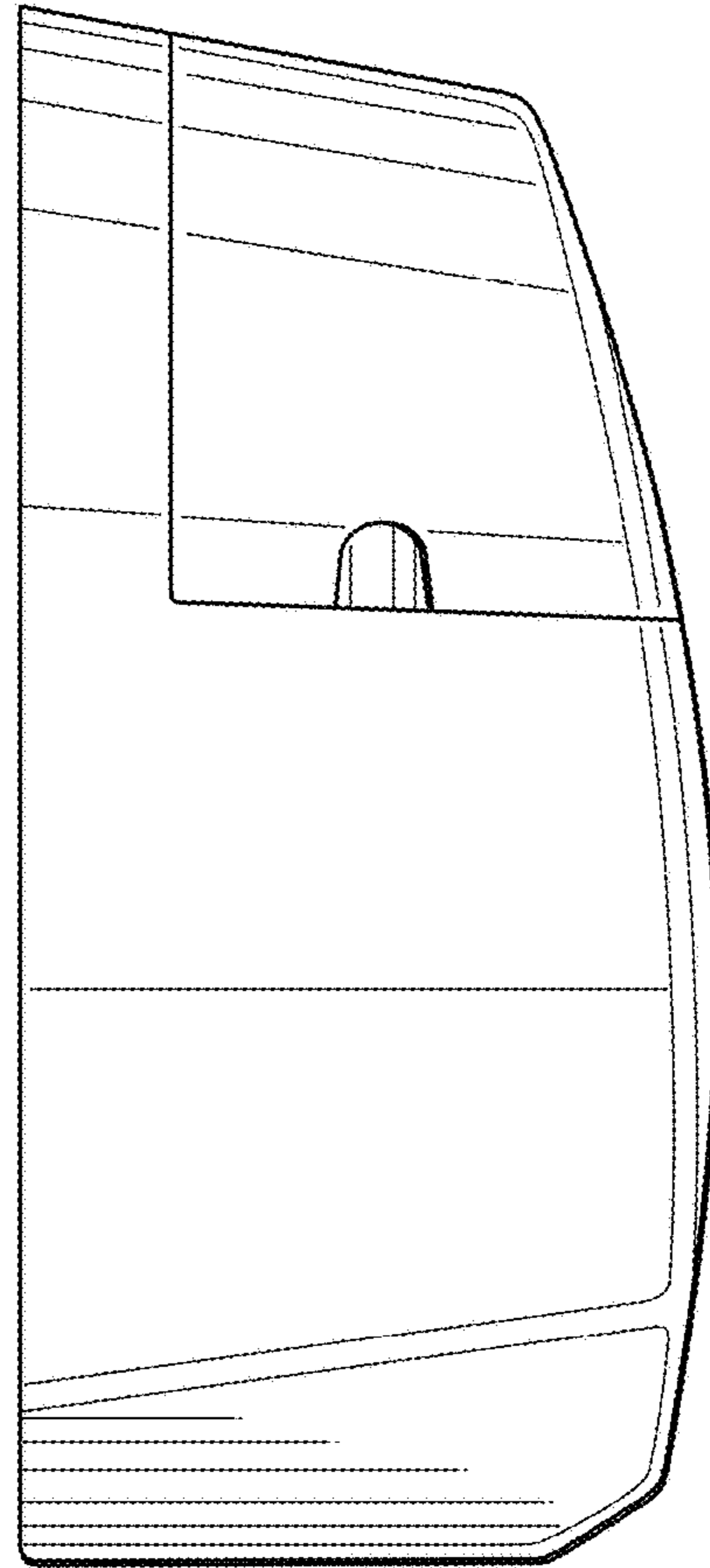
