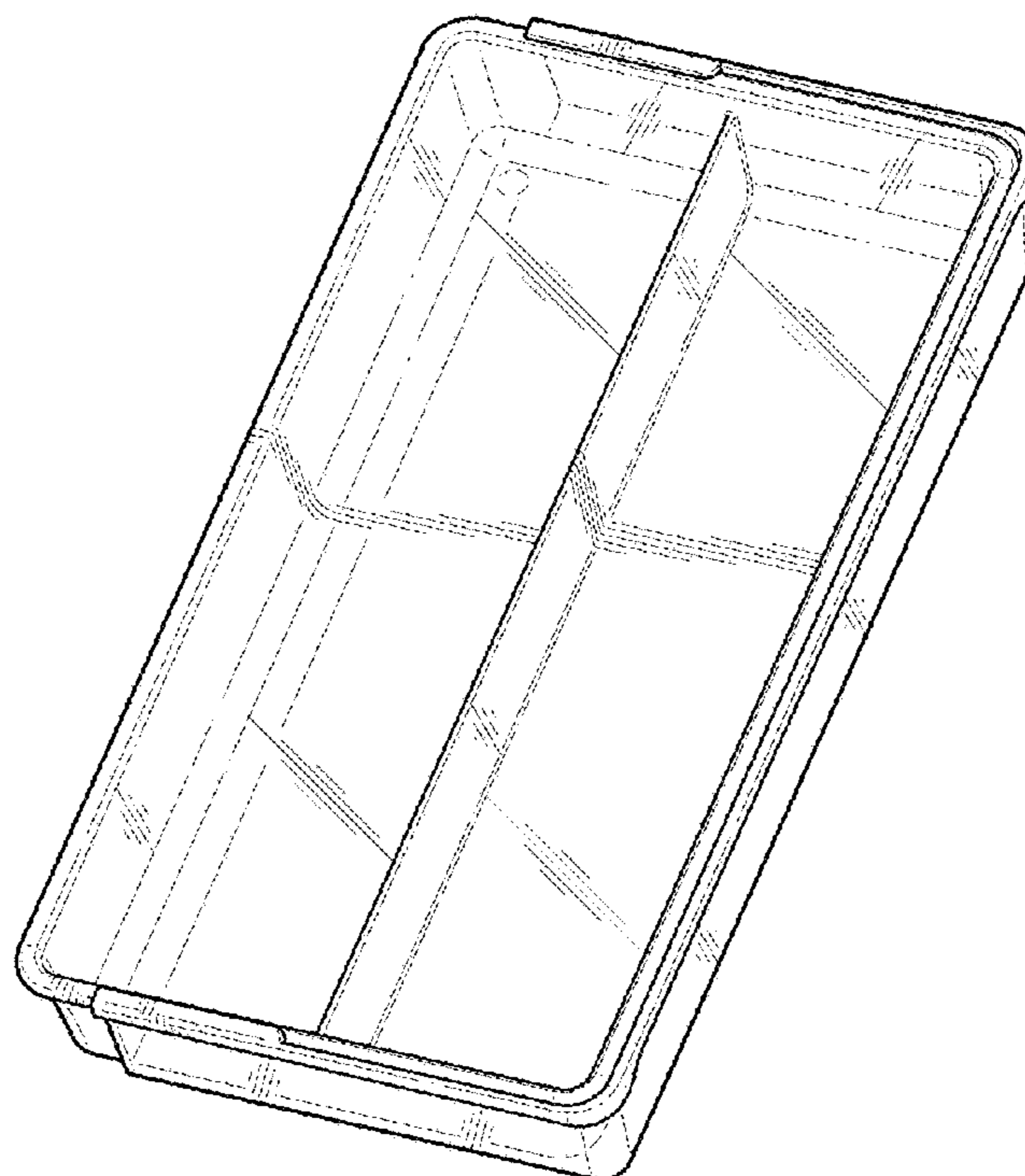
(57) **CLAIM**

I claim the ornamental design for an organizer, as shown and described.

DESCRIPTION

FIG. 1 is a front/left/top perspective view of an organizer; FIG. 2 is front/right/bottom perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a top plan view thereof; FIG. 5 is a right side elevation view thereof; and, FIG. 6 is a bottom plan view thereof. The broken lines depict portions of the article that form no part of the claimed design.

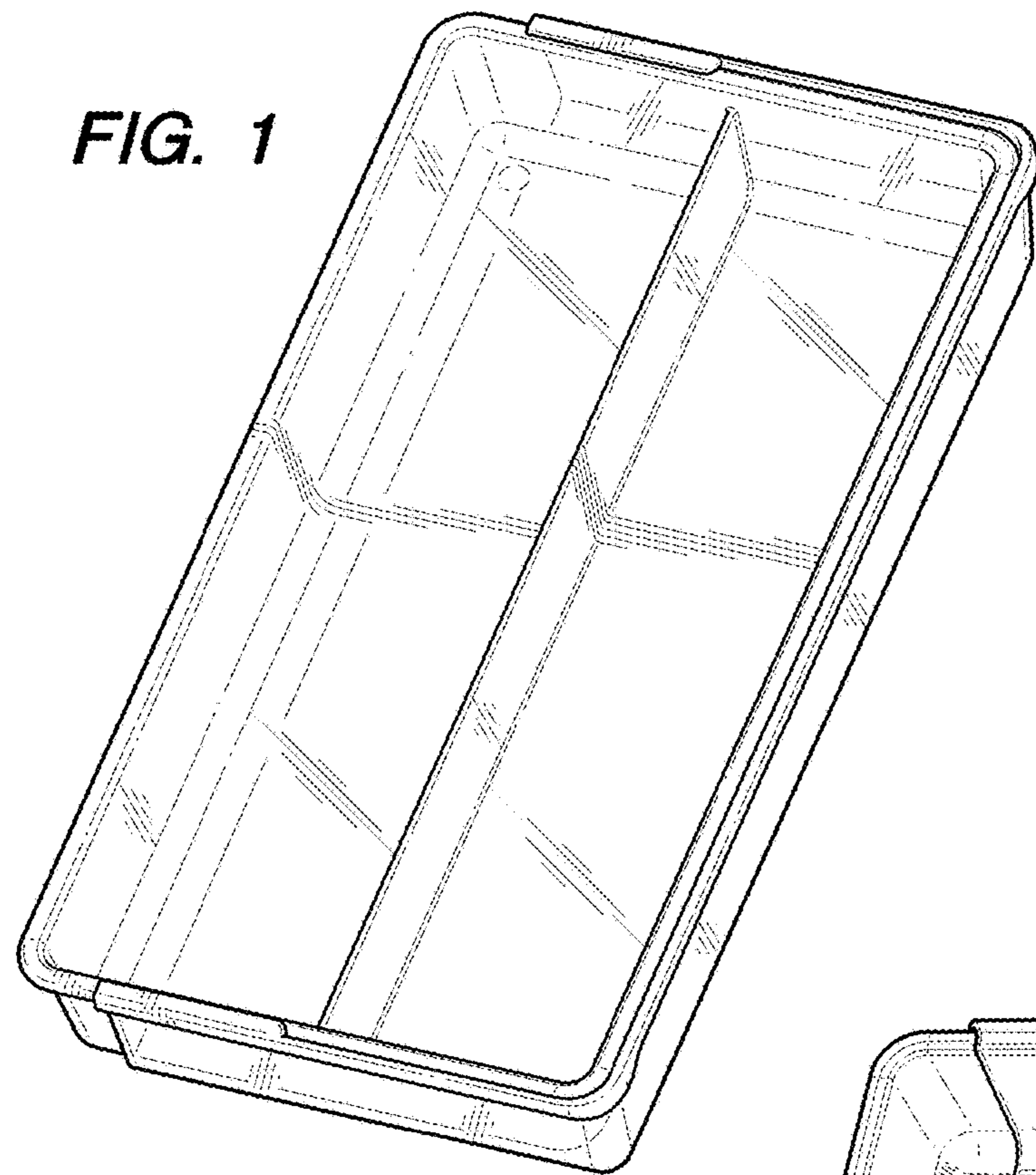

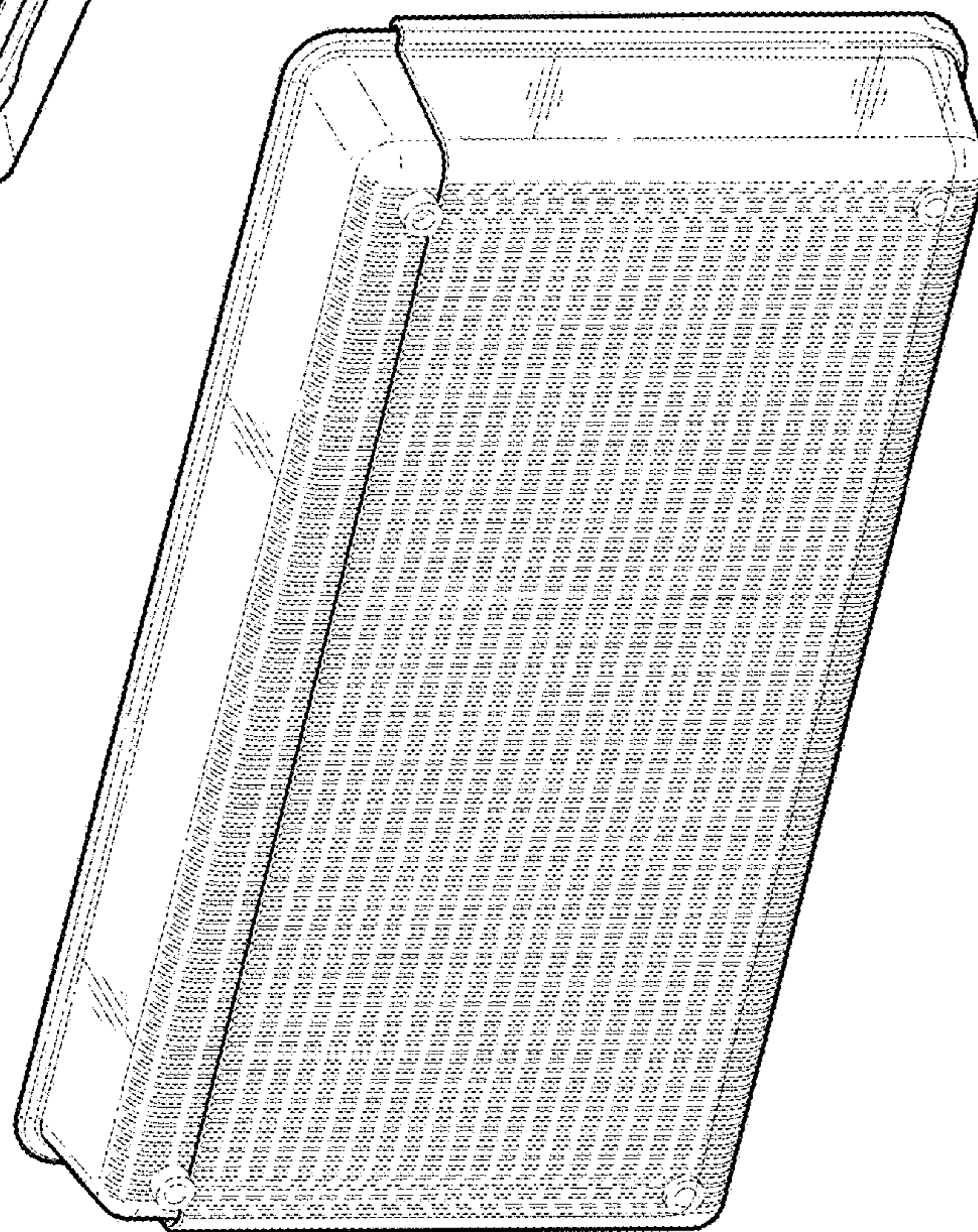

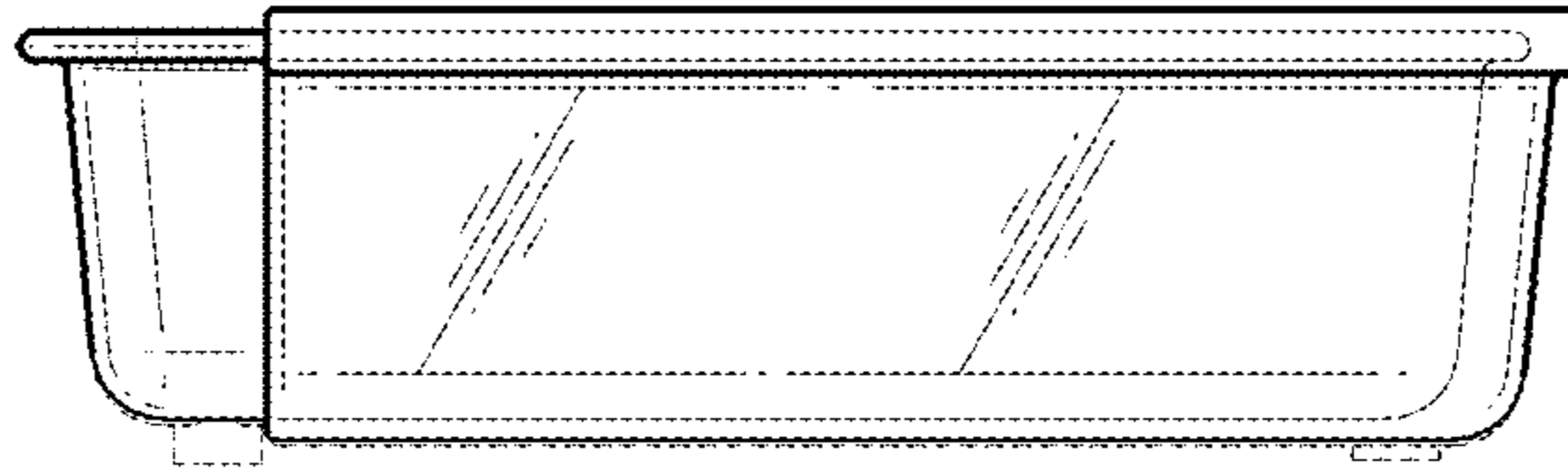

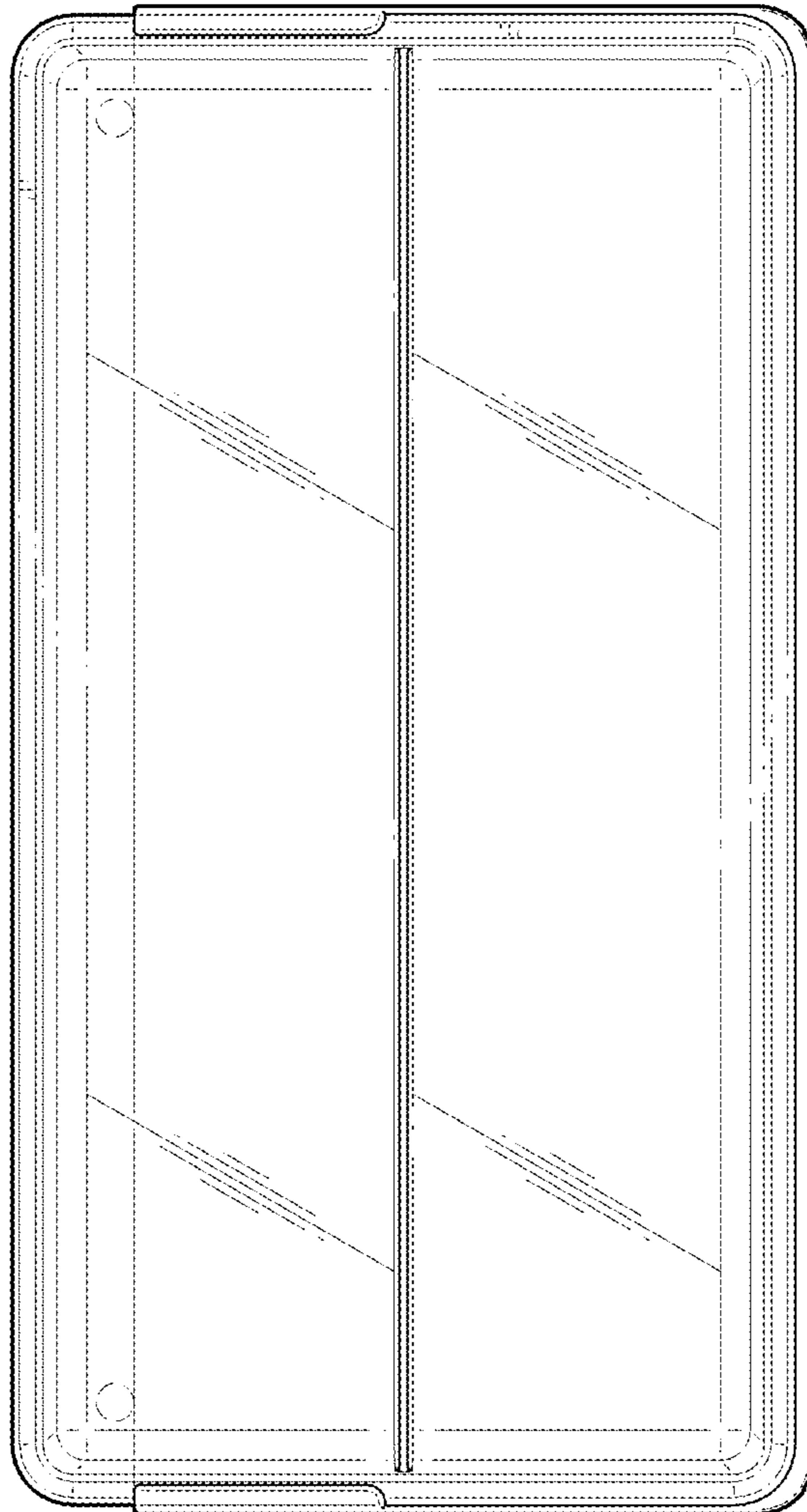

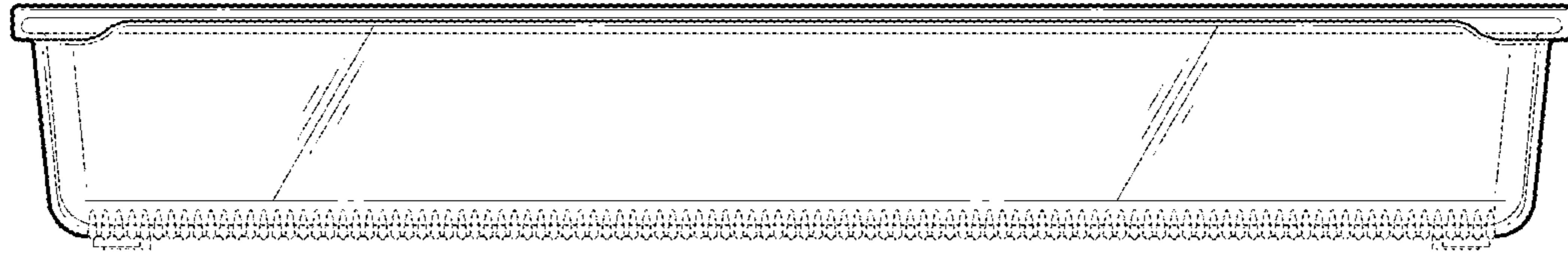
