FIG. 5 is a rear view of the cooking apparatus of FIG. 1.

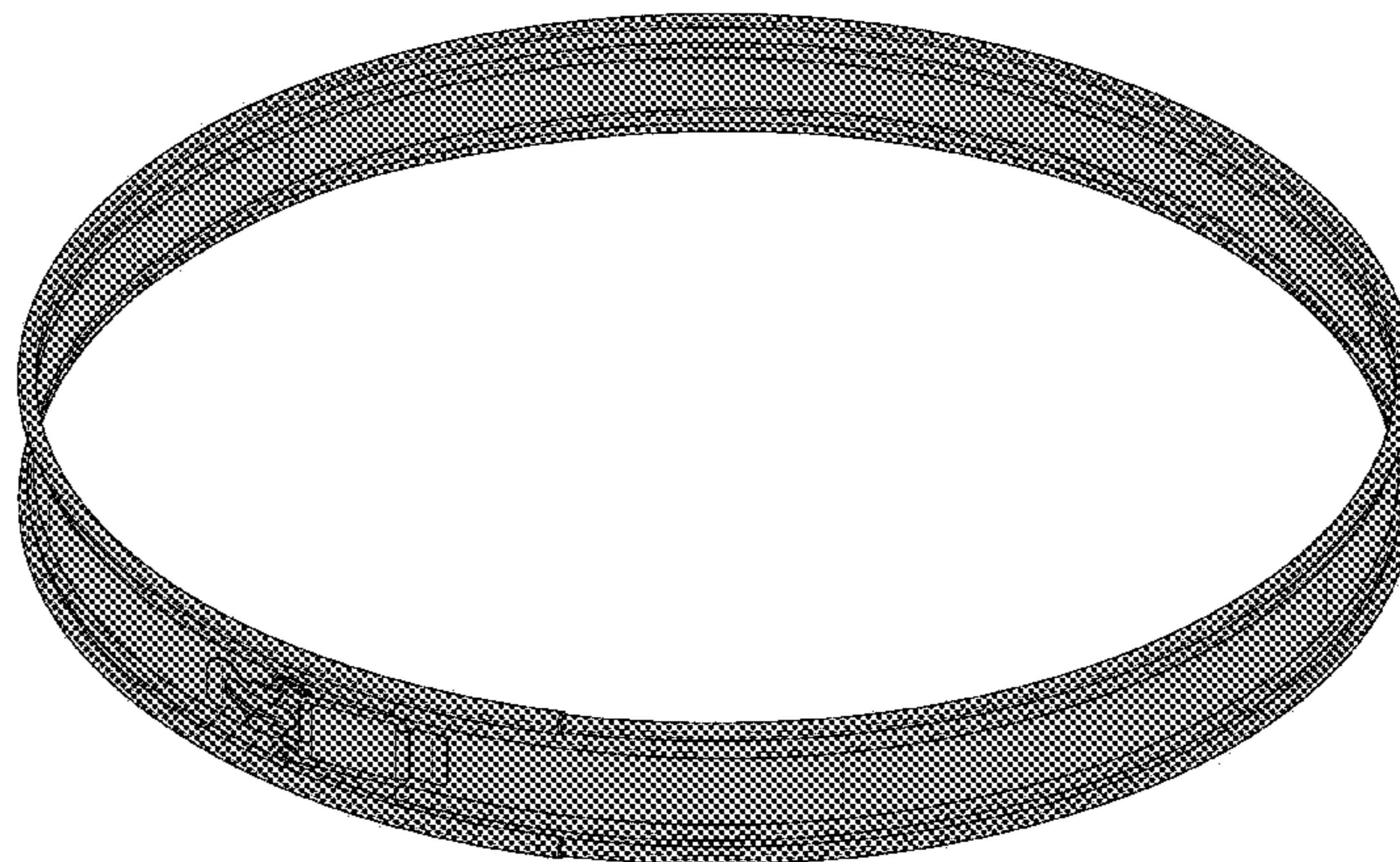
FIG. 6 is a top perspective view of the cooking apparatus of FIG. 1.

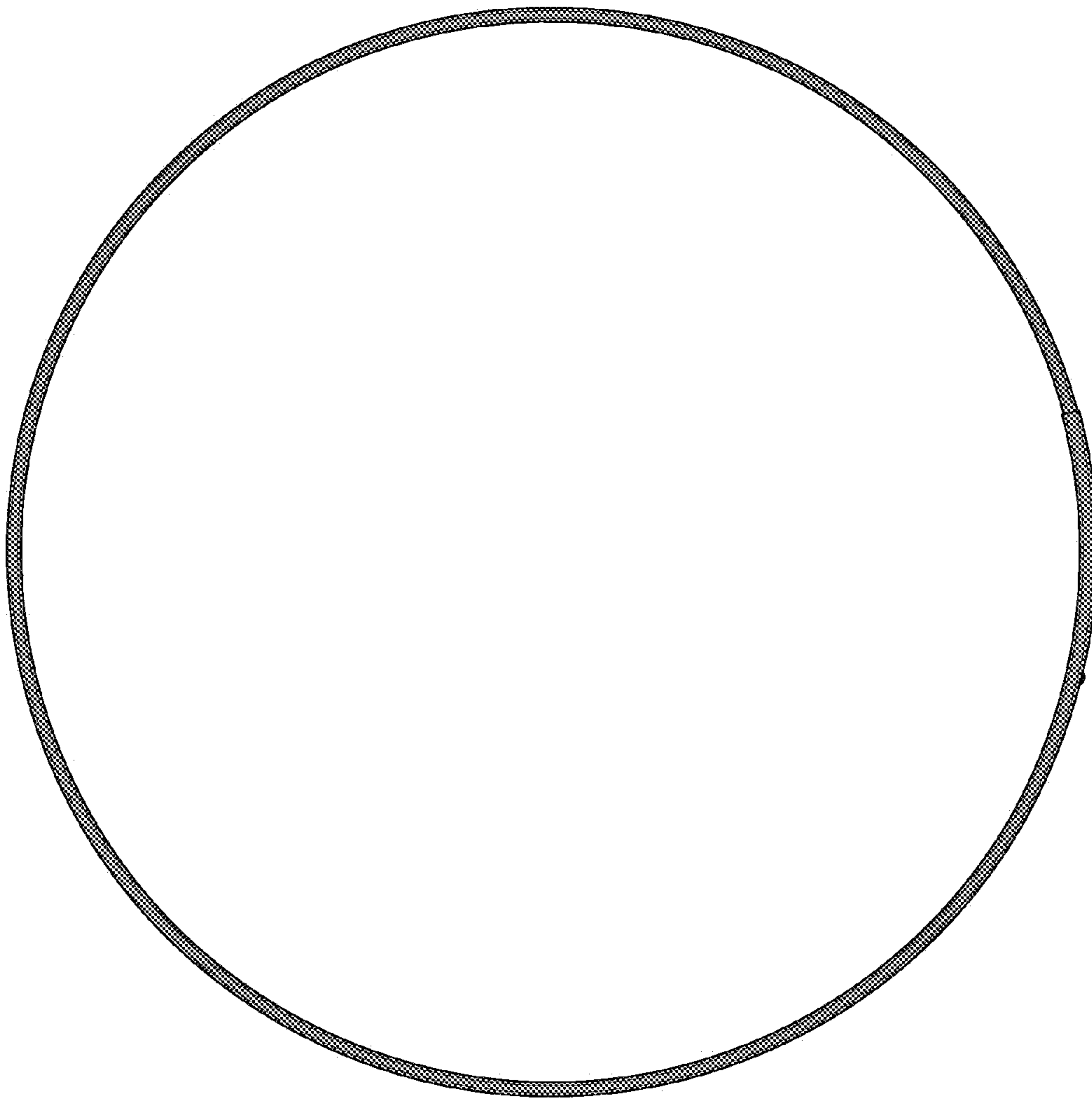

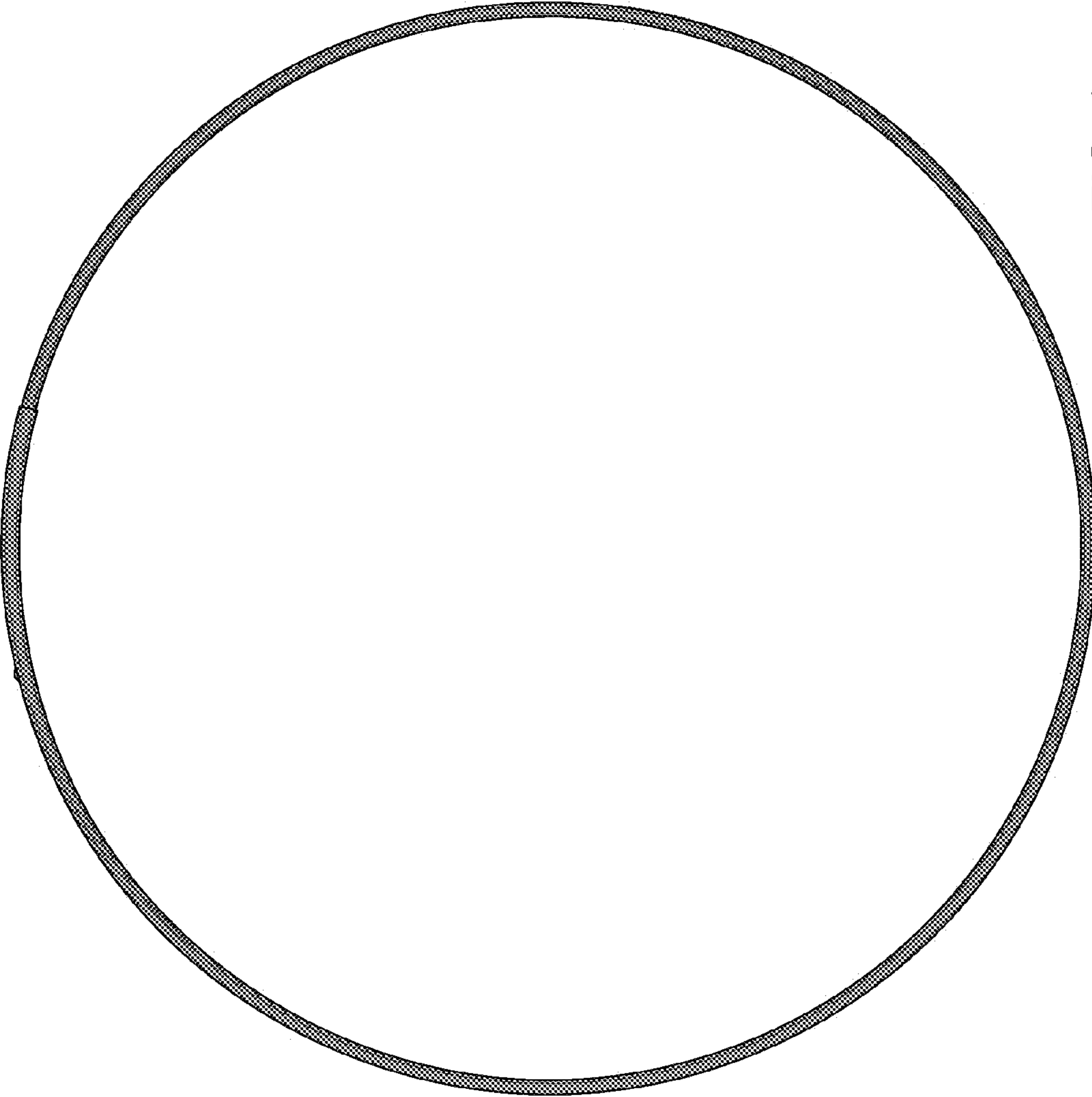

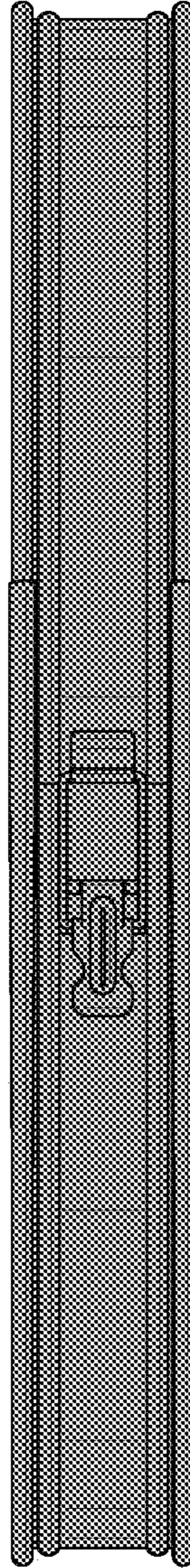

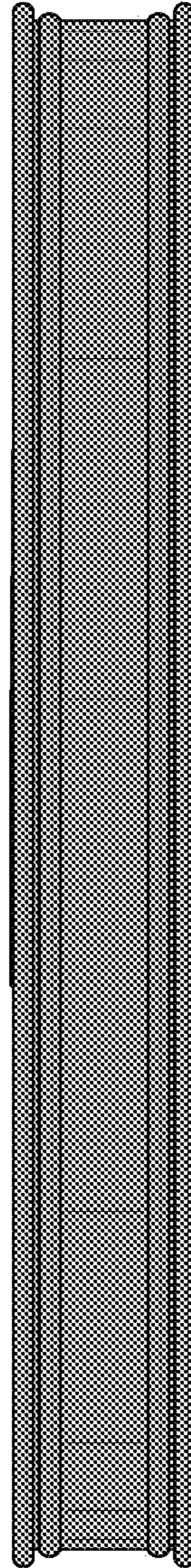

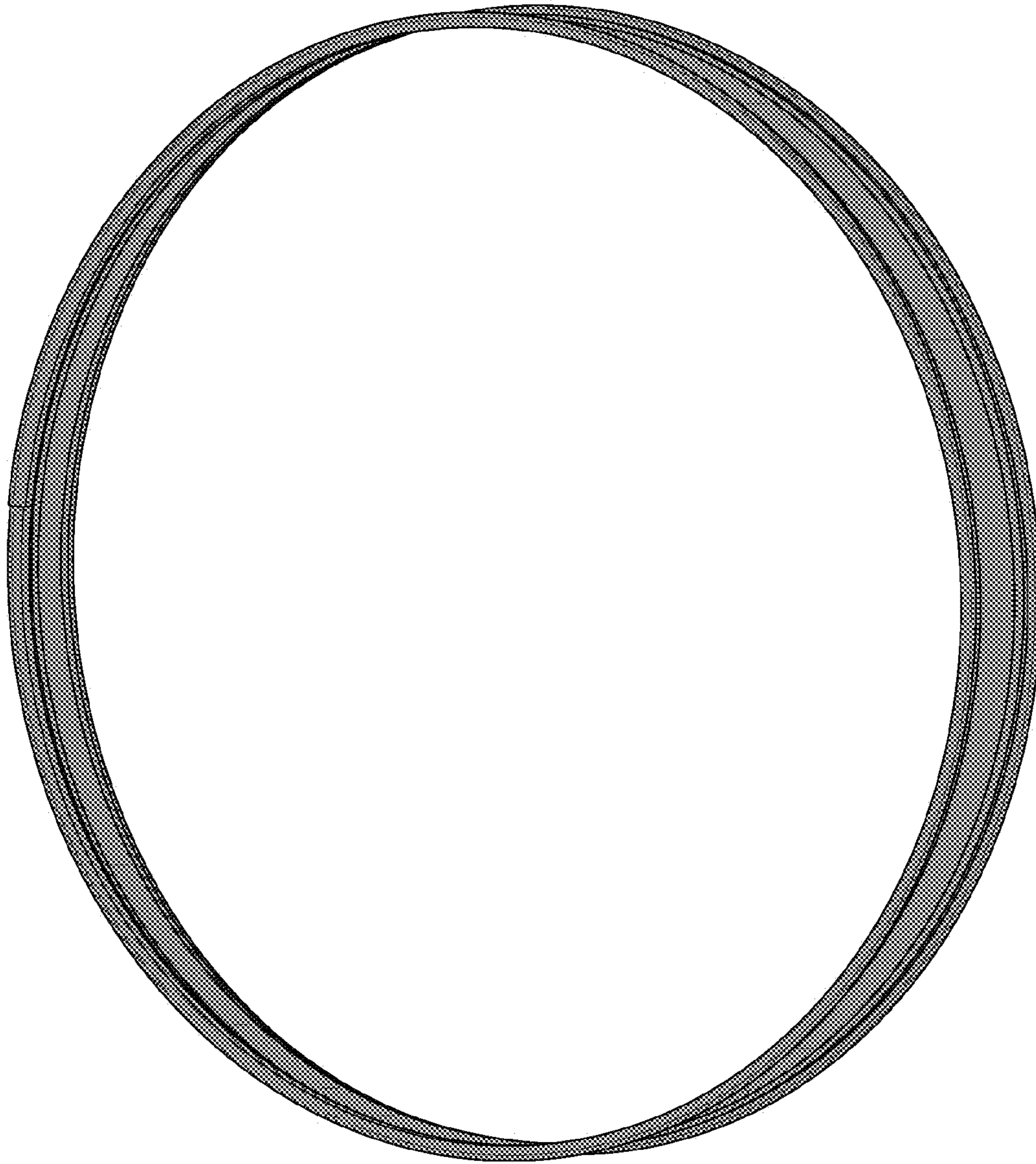

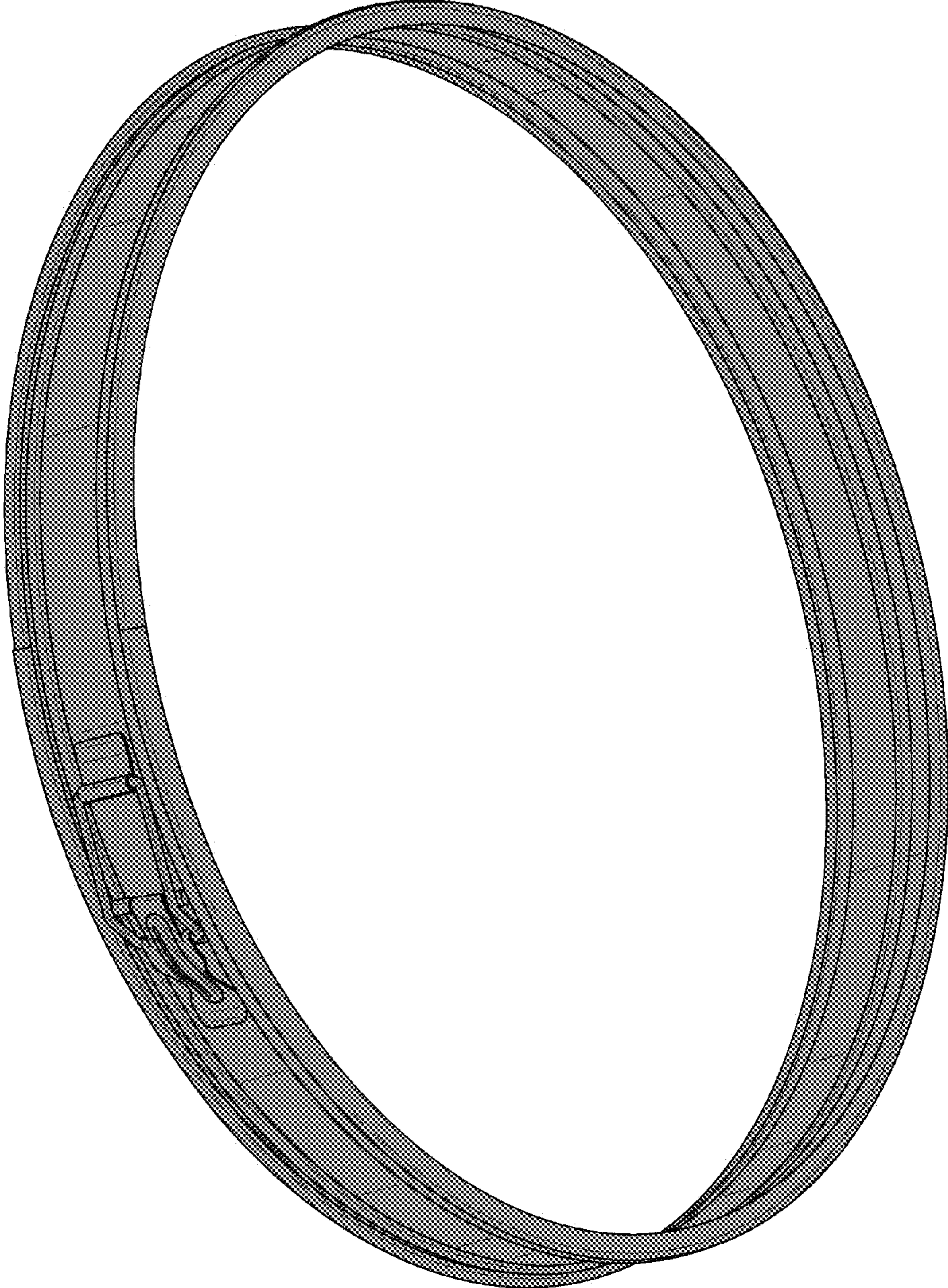

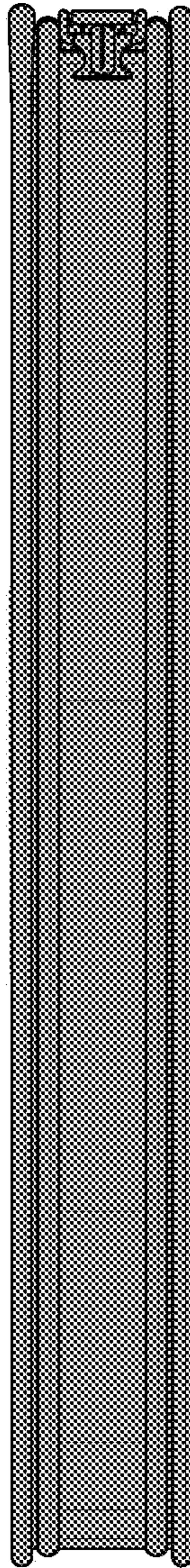

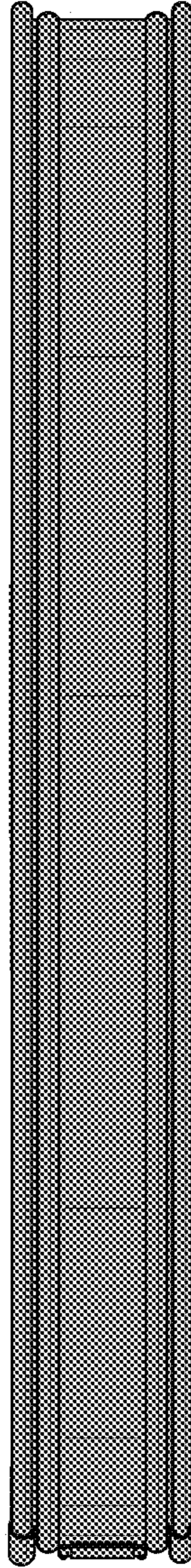
