**DESCRIPTION**

1. Perfume bottle

FIG. 1.2 is a front elevational view of the perfume bottle shown in FIG. 1.1;

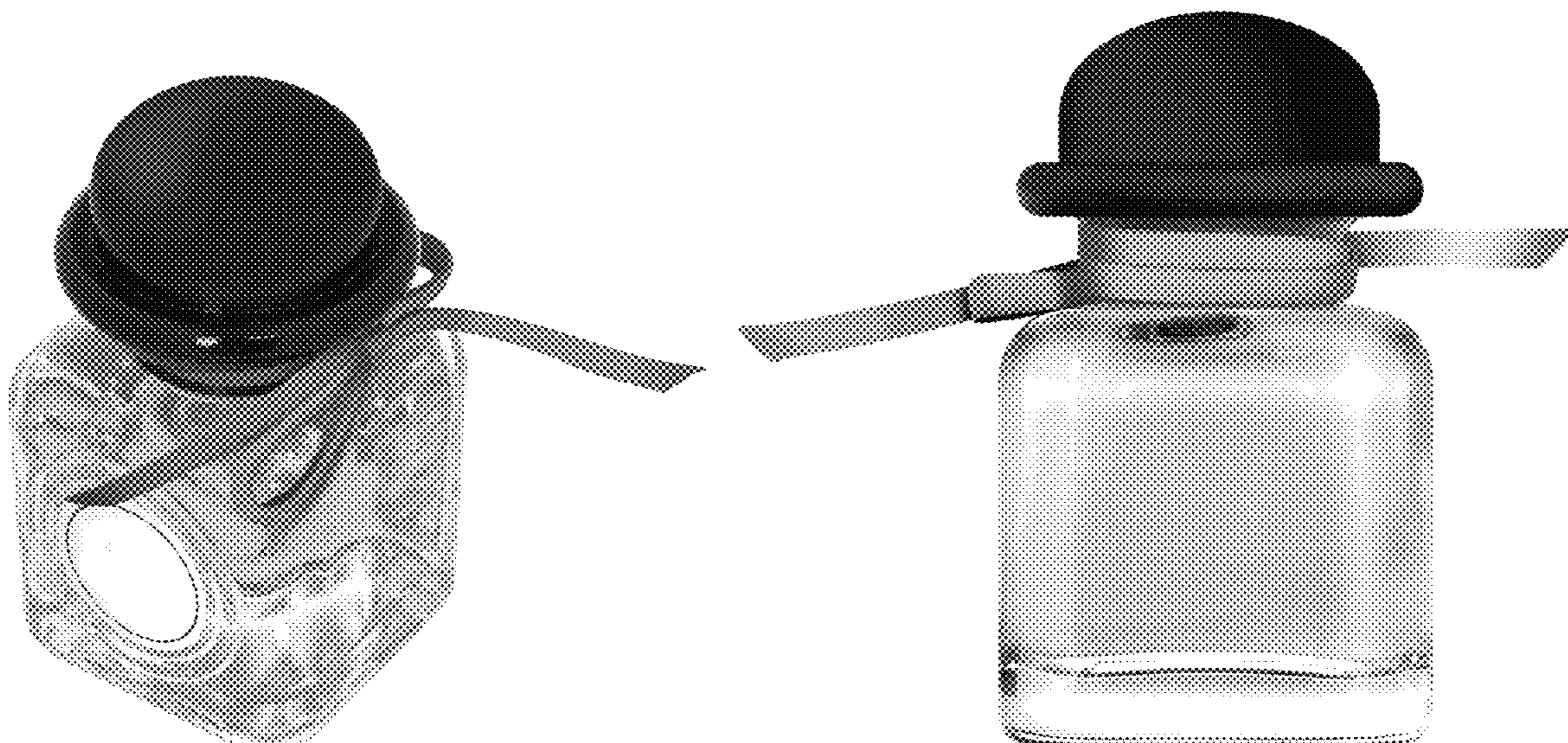
FIG. 1.3 is a back elevational view of the perfume bottle shown in FIG. 1.1;
