(57) **CLAIM**

The ornamental design for a Christmas tree ornament, as shown and described.

**DESCRIPTION**

FIG. 1 is a right, top perspective view of a first embodiment of a Christmas tree ornament showing my new design;

FIG. 2 is a front view of the Christmas tree ornament of FIG. 1;

FIG. 3 is a right side view of the Christmas tree ornament of FIG. 1;

FIG. 4 is a left side view of the Christmas tree ornament of FIG. 1;

FIG. 5 is a top view of the Christmas tree ornament of FIG. 1;

FIG. 6 is a bottom view of the Christmas tree ornament of FIG. 1;

FIG. 7 is a back view of the Christmas tree ornament of FIG. 1;

FIG. 8 is a cross sectional view taken along line 8-8 in FIG. 3;

FIG. 9 is a left side view of a second embodiment of a Christmas tree ornament showing my new design, the right side view is the same as FIG. 3, except for the lengthened bottom protrusions;

FIG. 10 is a back view of the Christmas tree ornament of FIG. 9, the front view is the same as FIG. 2, except for the lengthened bottom protrusion;

FIG. 11 is a bottom view of the Christmas tree ornament of FIG. 9, the top view is the same as FIG. 5;

FIG. 12 is the same cross sectional view shown in FIG. 8, except for the lengthened bottom protrusion;

FIG. 13 is a left side view of a third embodiment of a Christmas tree ornament showing my new design;

FIG. 14 is a rear view of the Christmas tree ornament of FIG. 13;

FIG. 15 is a right side view of the Christmas tree ornament of FIG. 13;

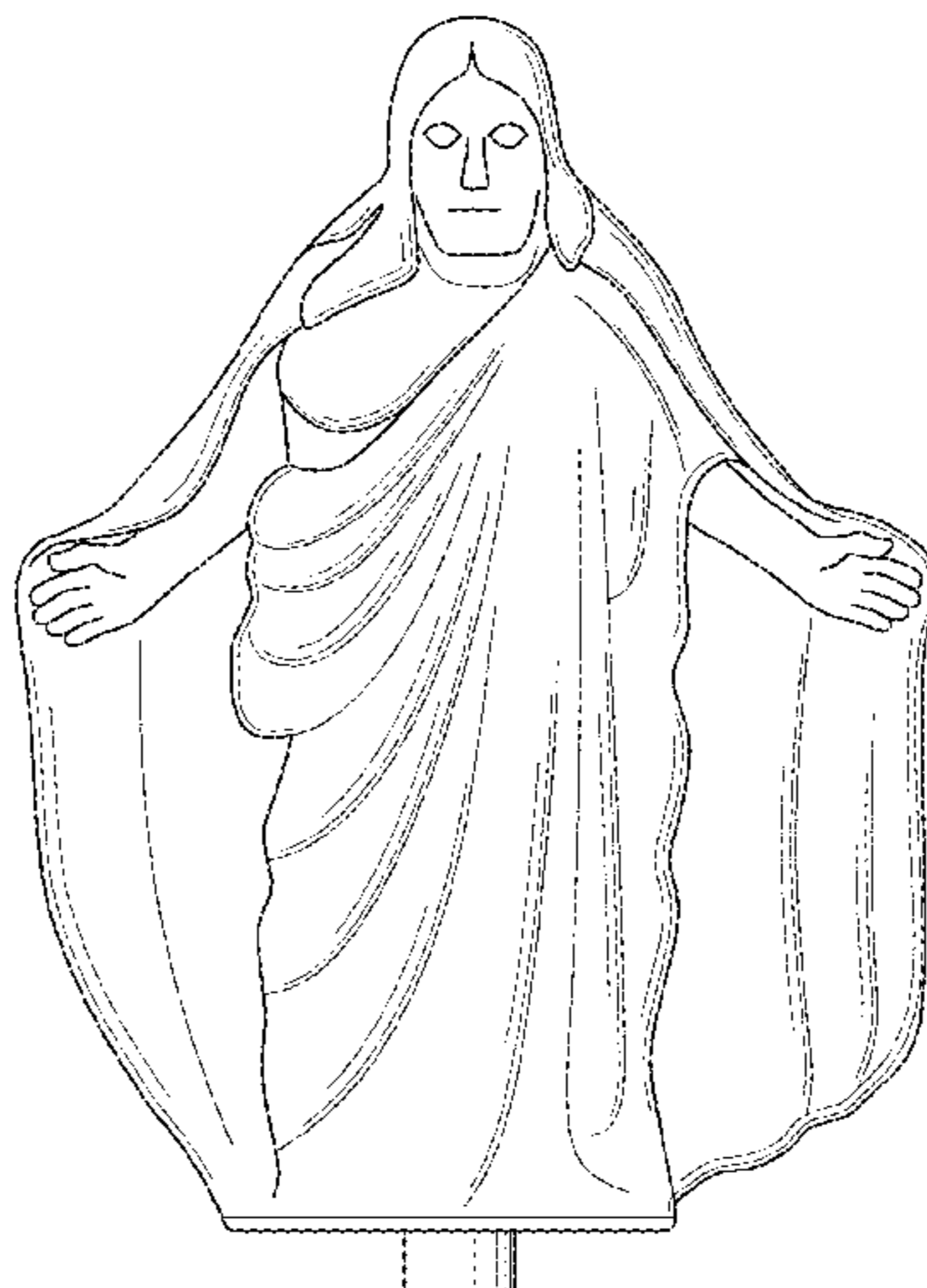
FIG. 16 is a top view of the Christmas tree ornament of FIG. 13;

FIG. 17 is a bottom view of the Christmas tree ornament of FIG. 13; and,

FIG. 18 is the same rear view as shown in FIG. 14, shown in a used condition with a tree shown in broken lines.

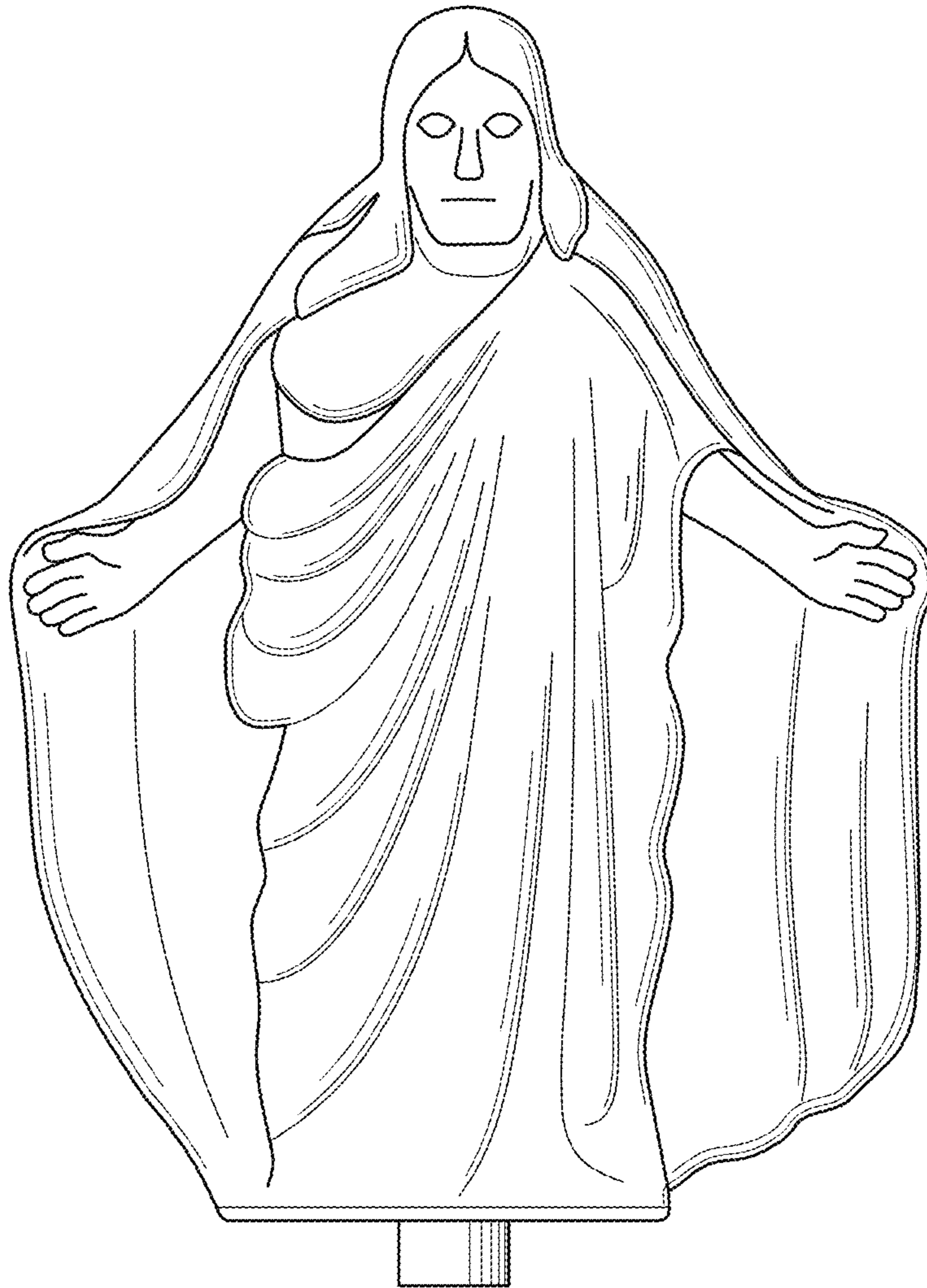

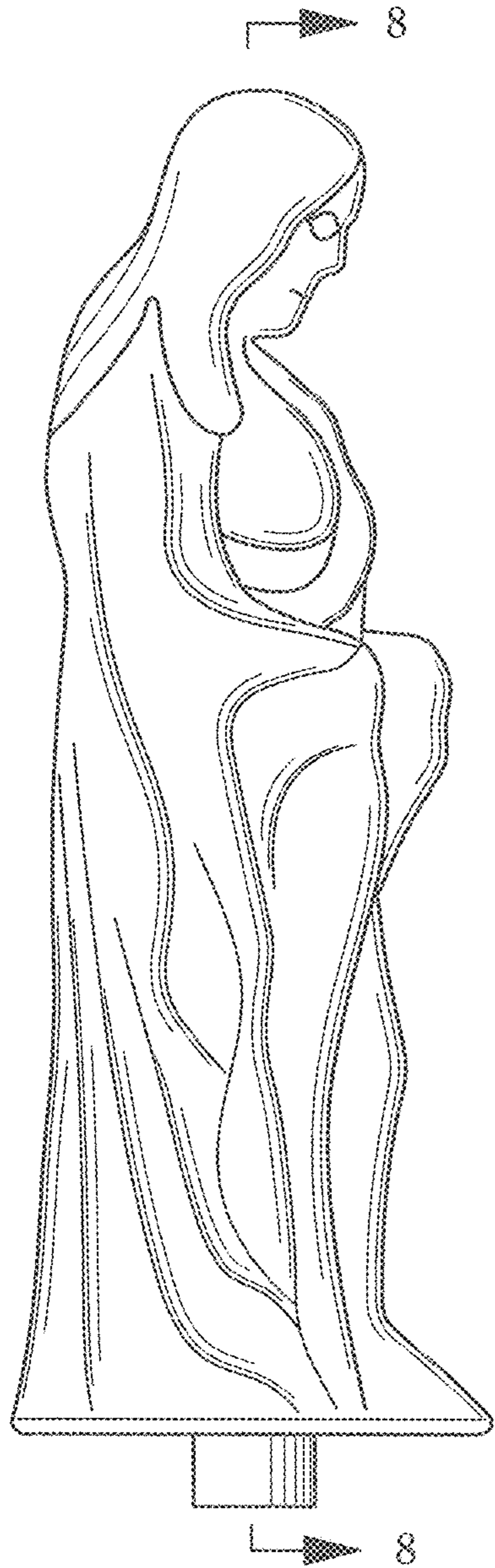

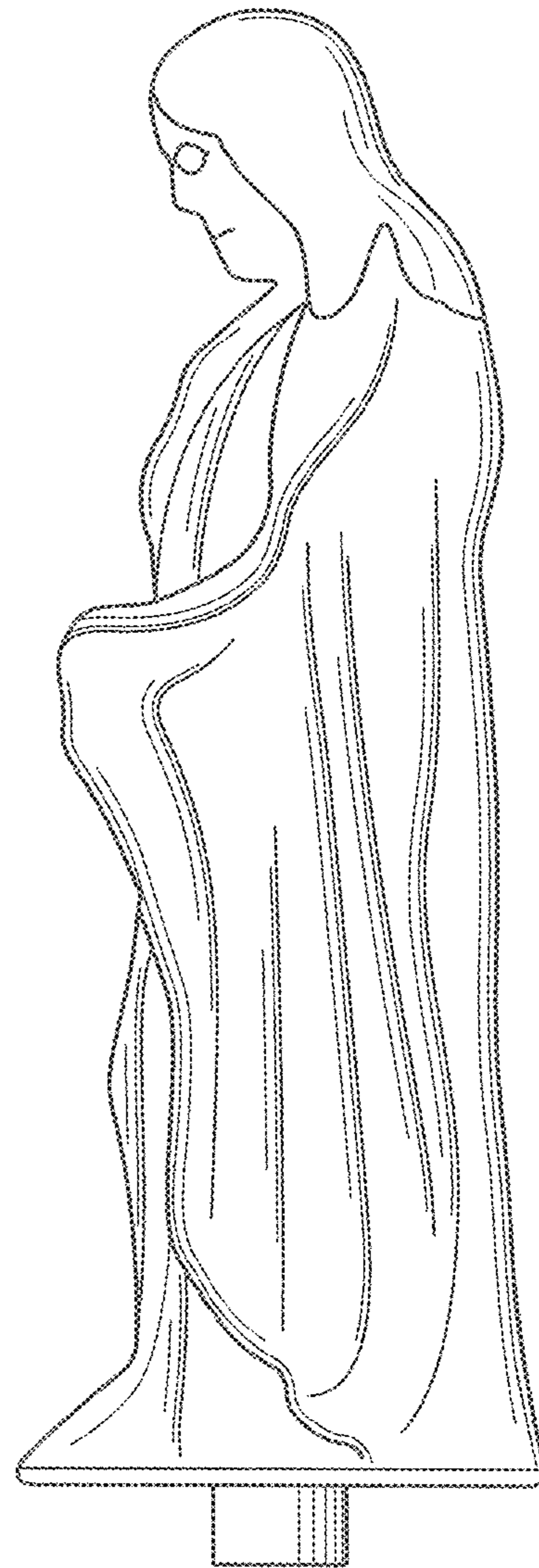

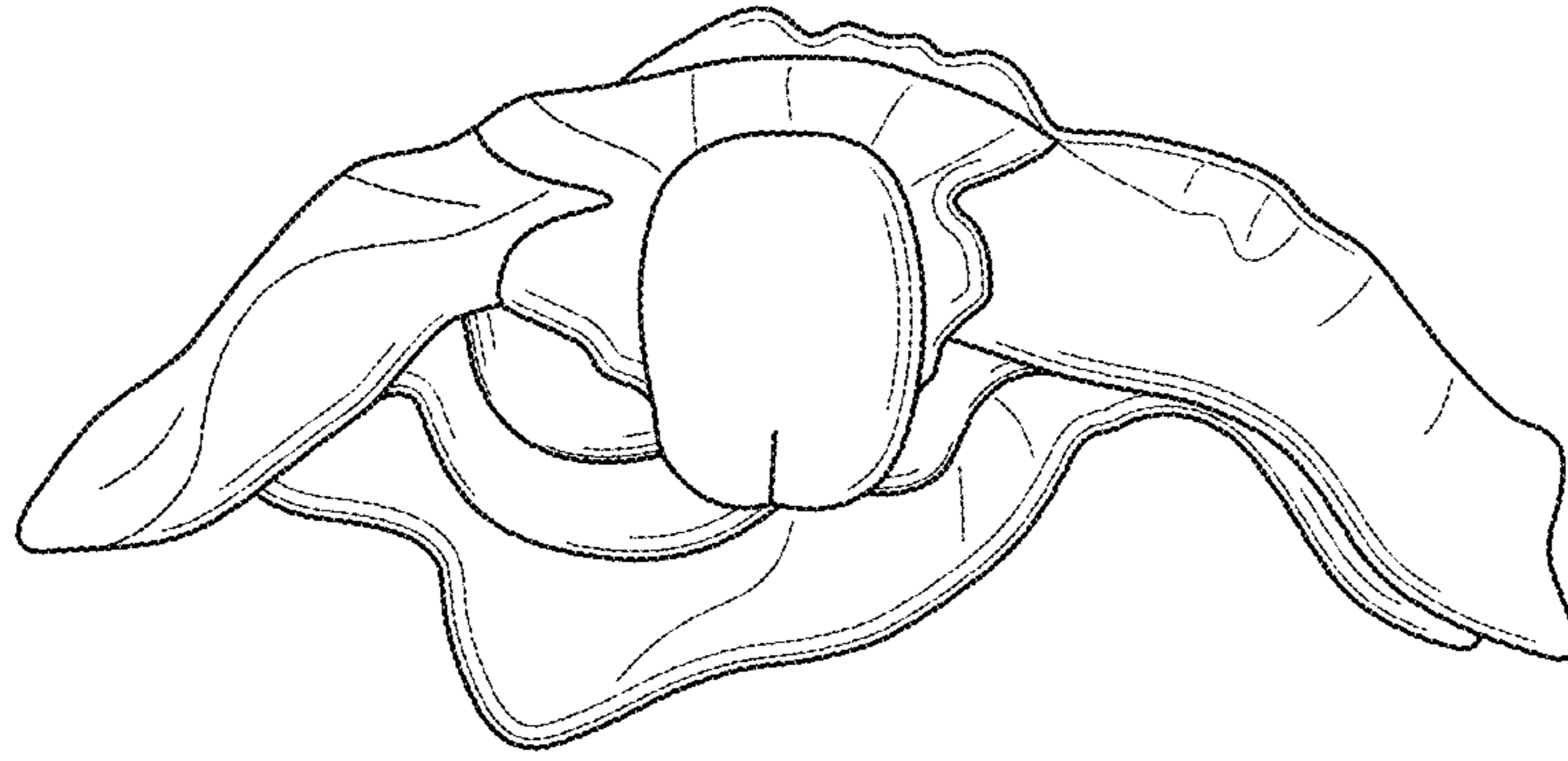

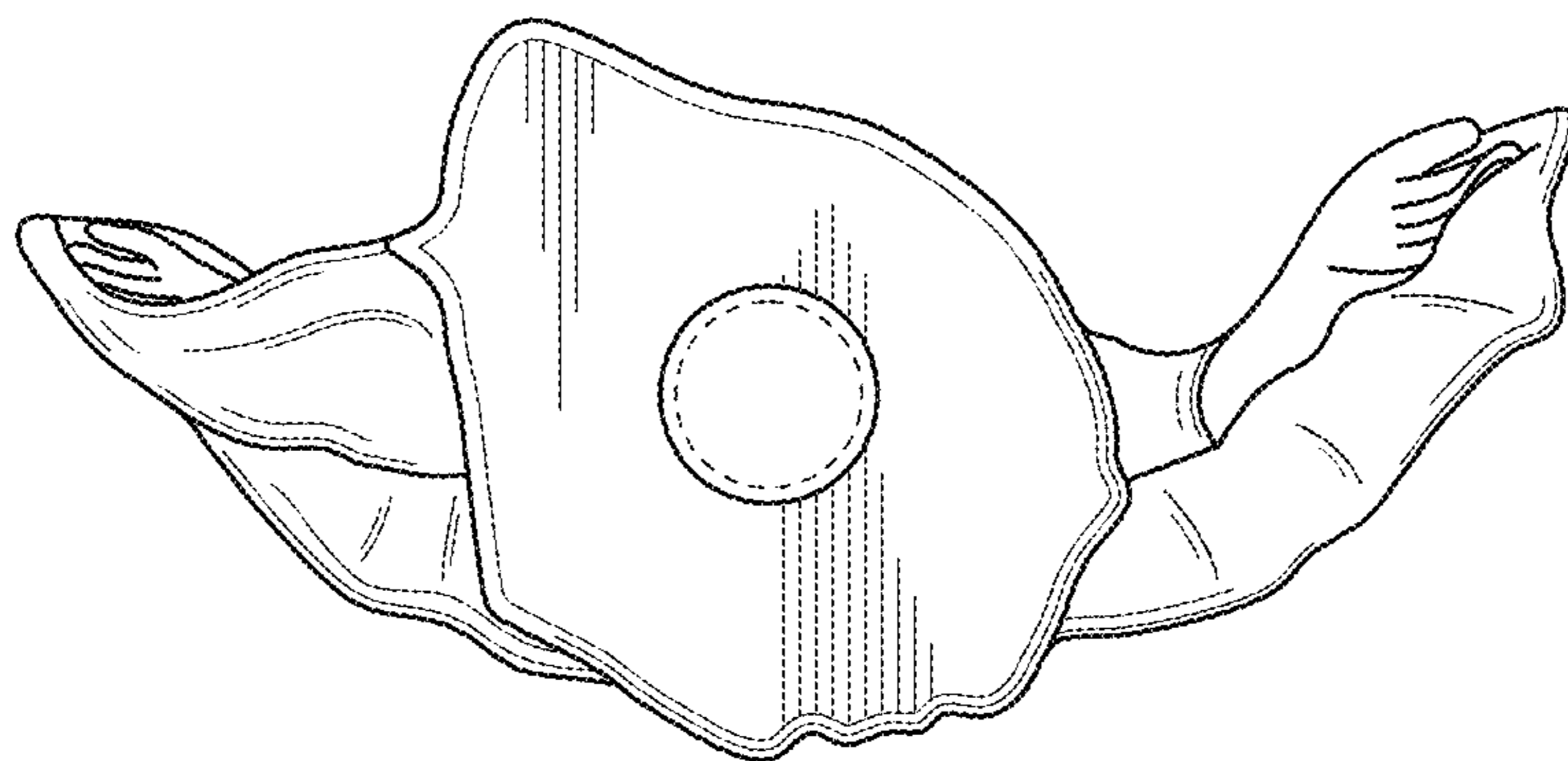

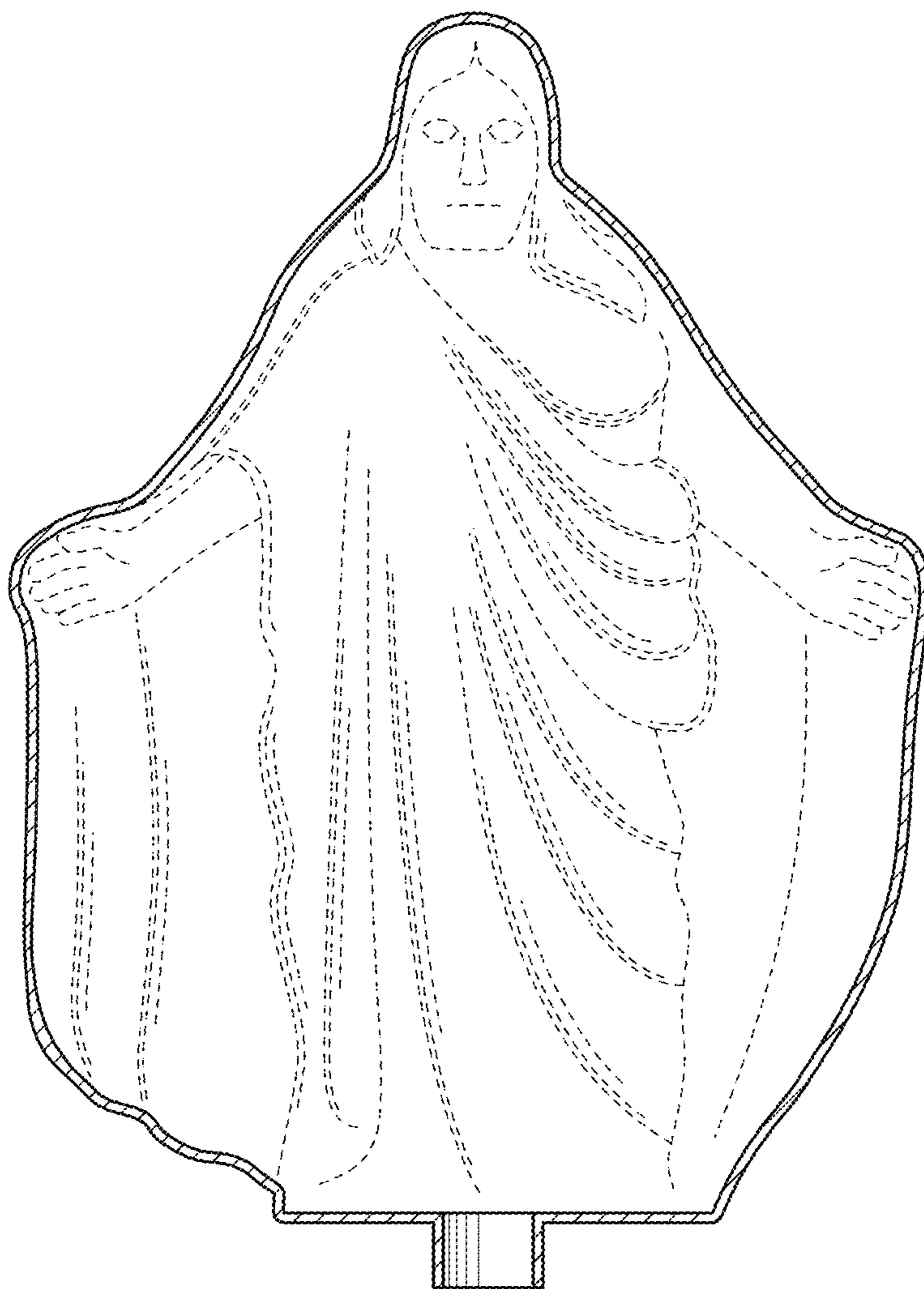

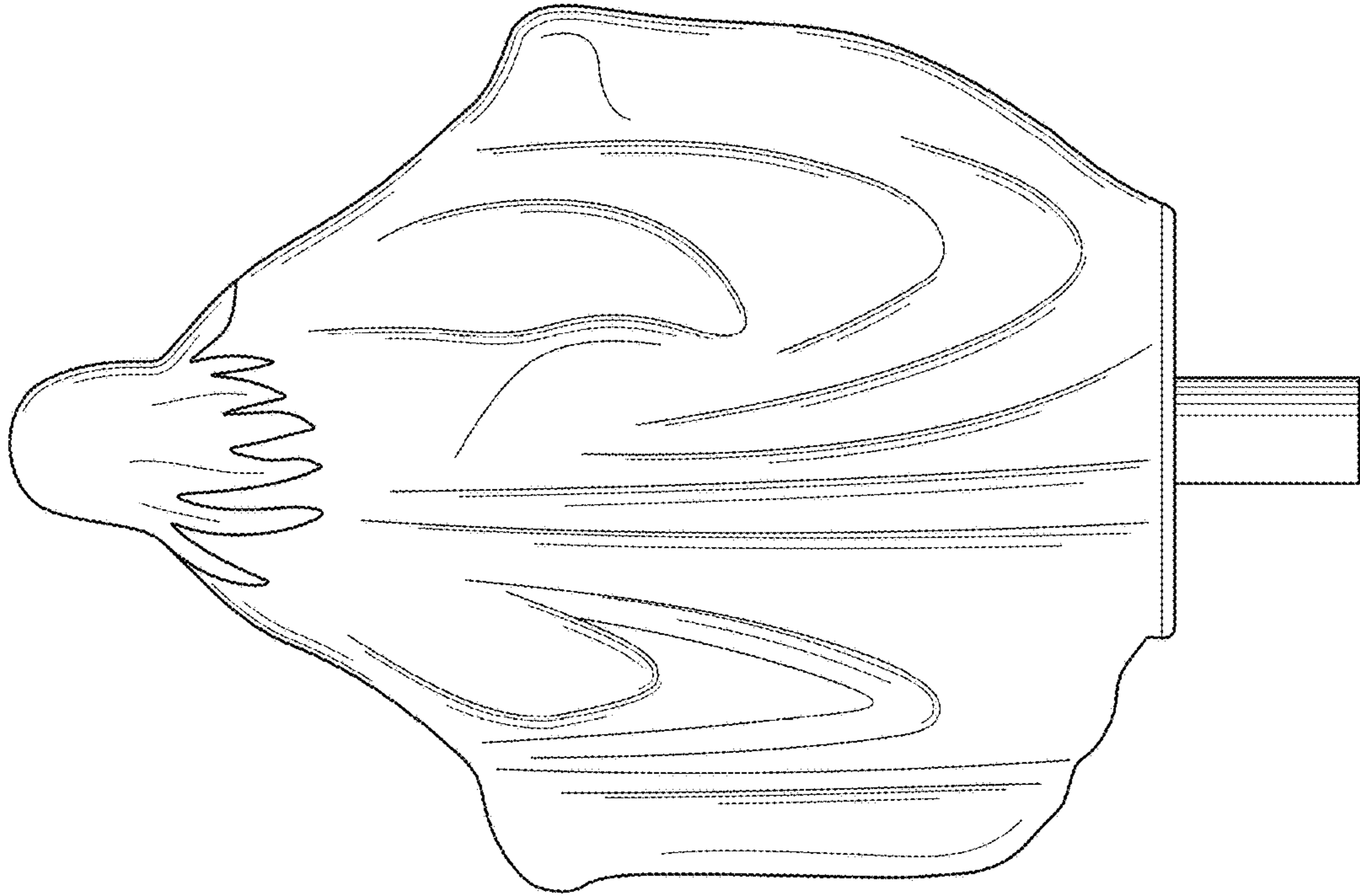

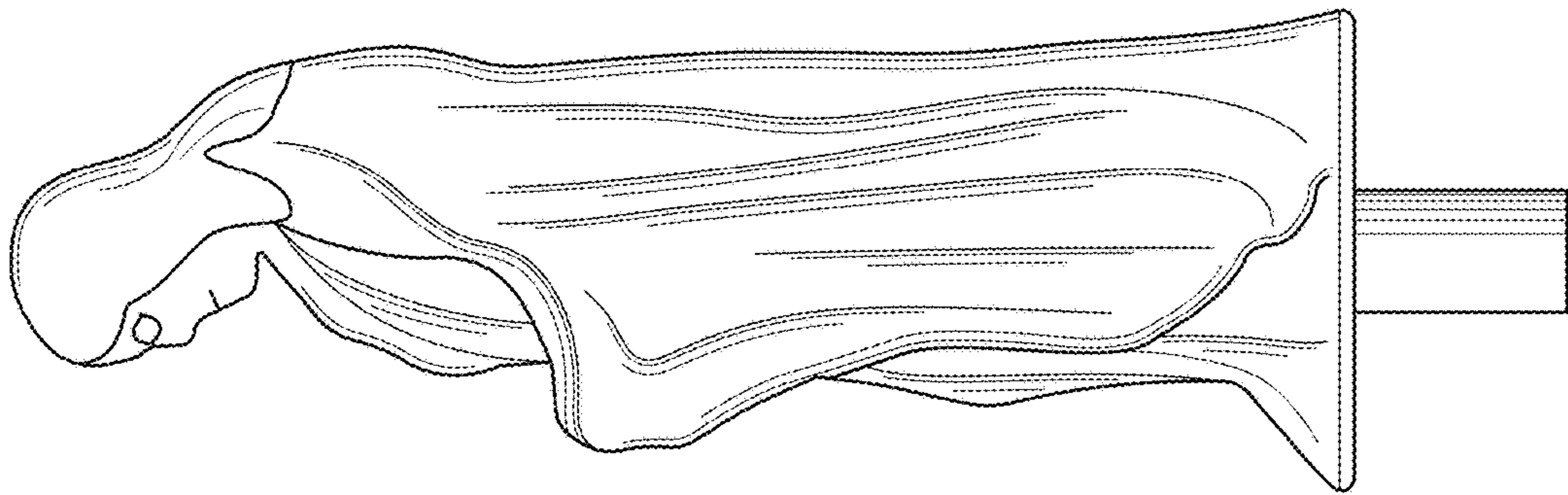

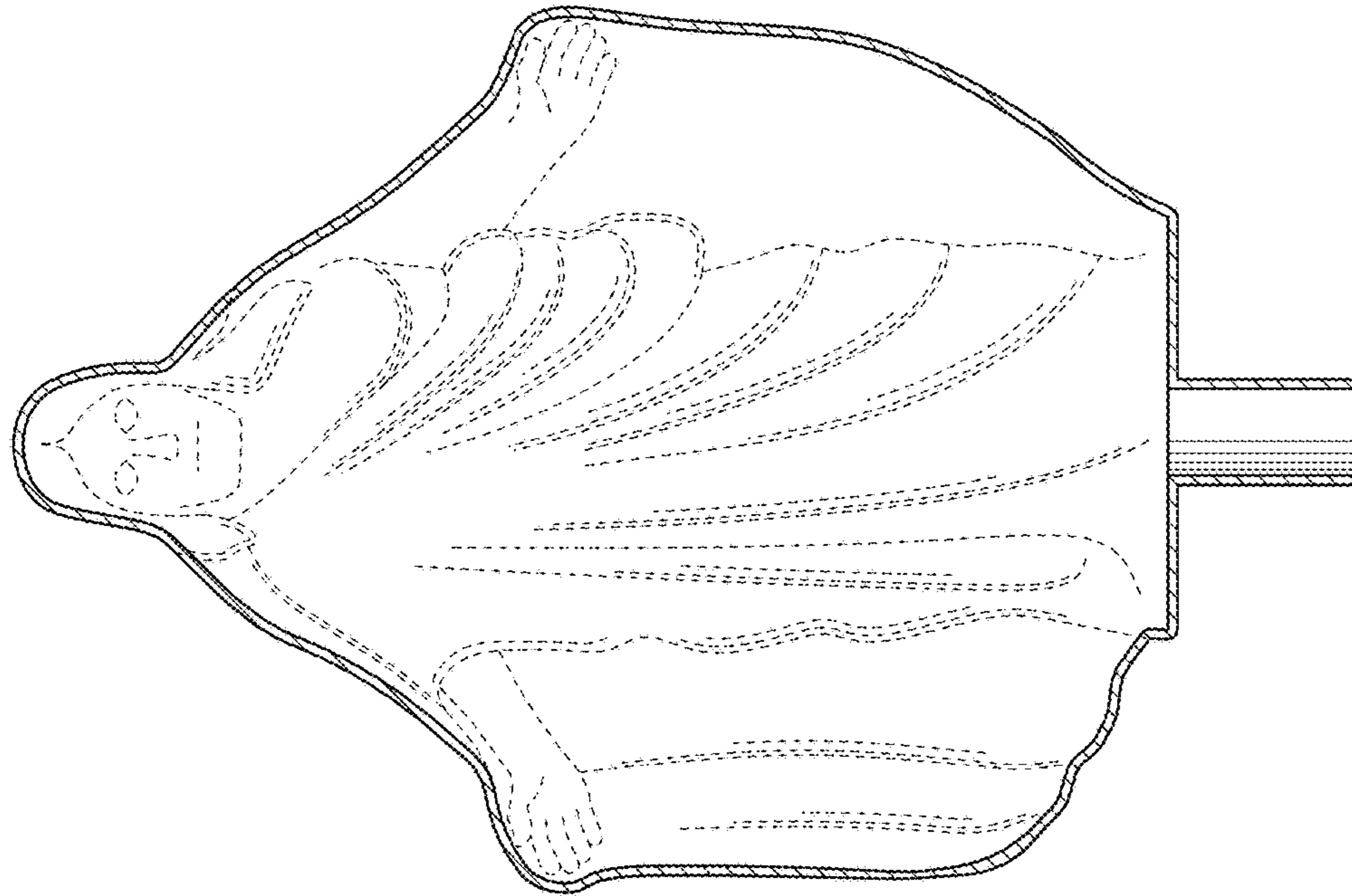

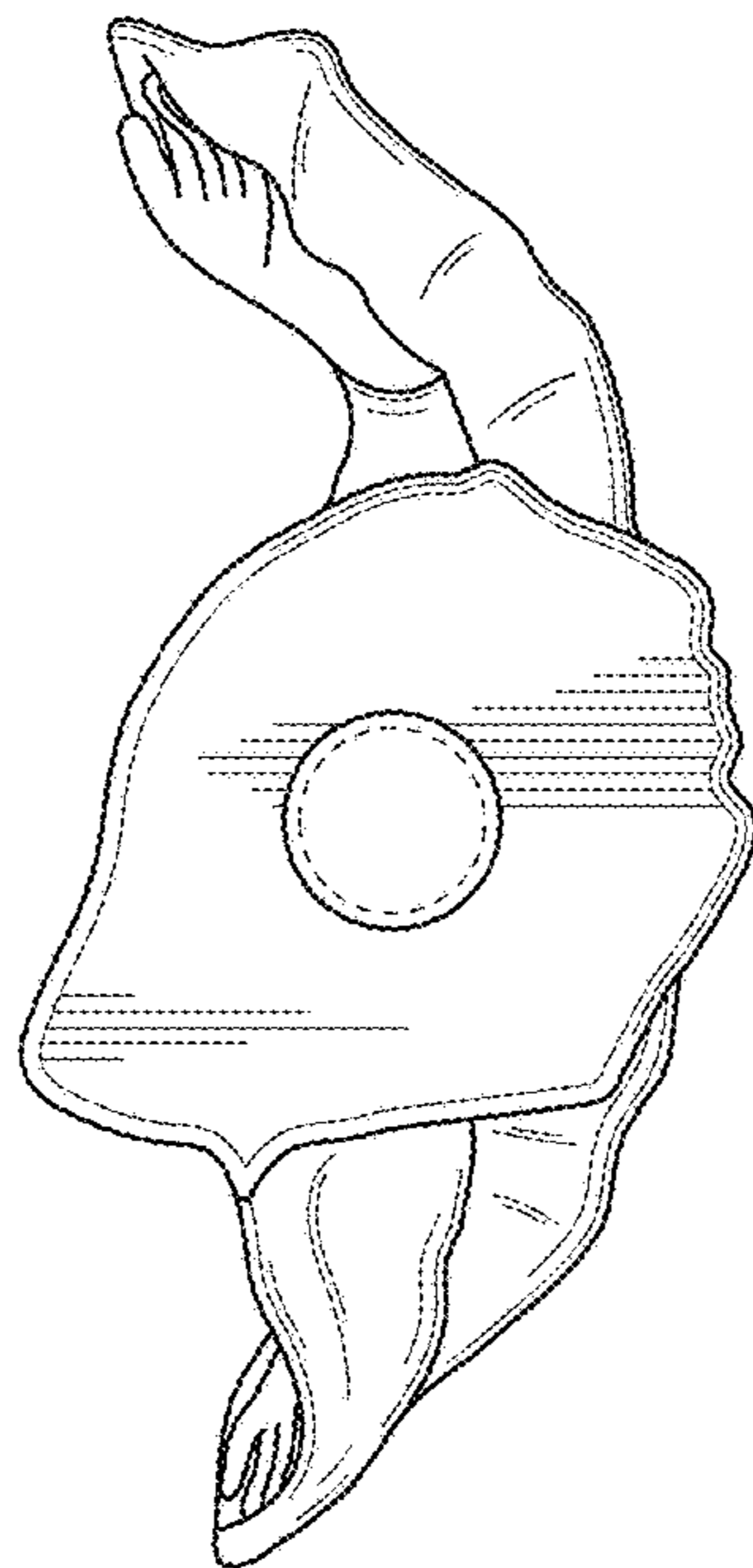

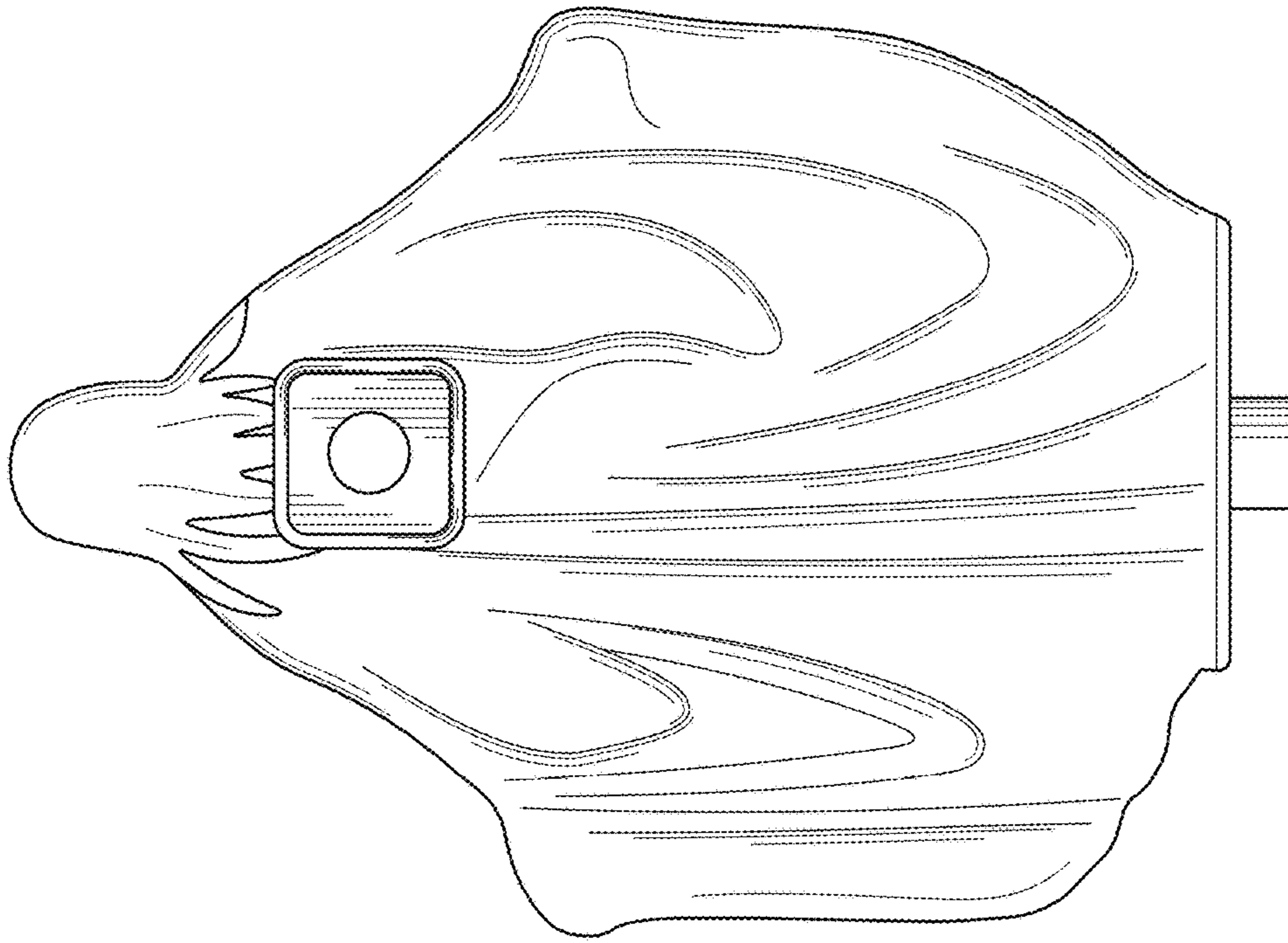

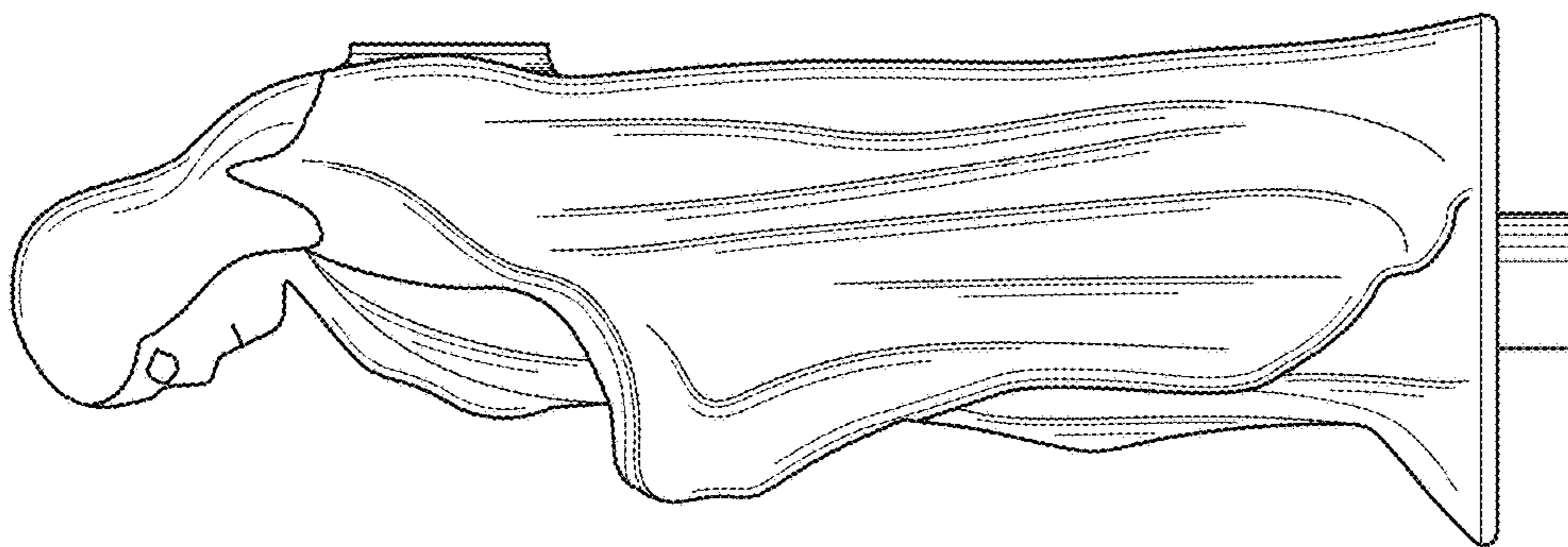

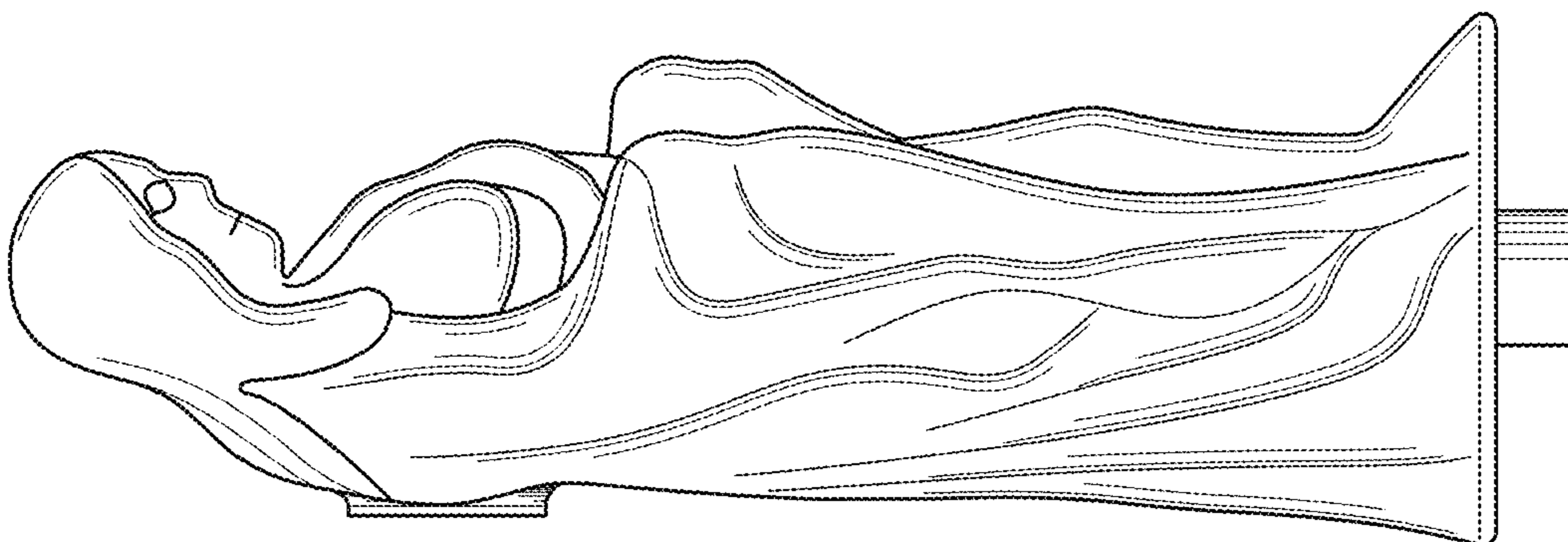

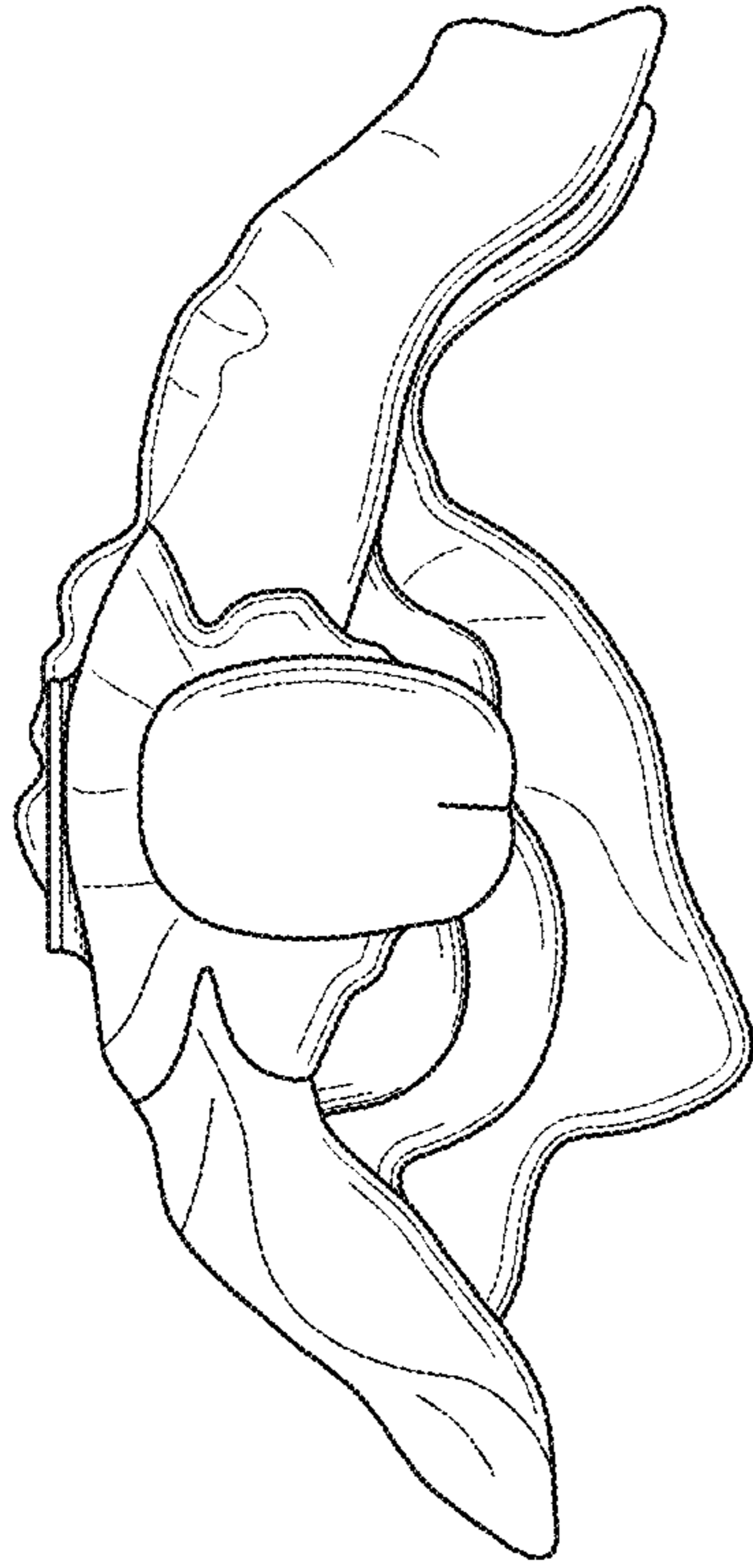

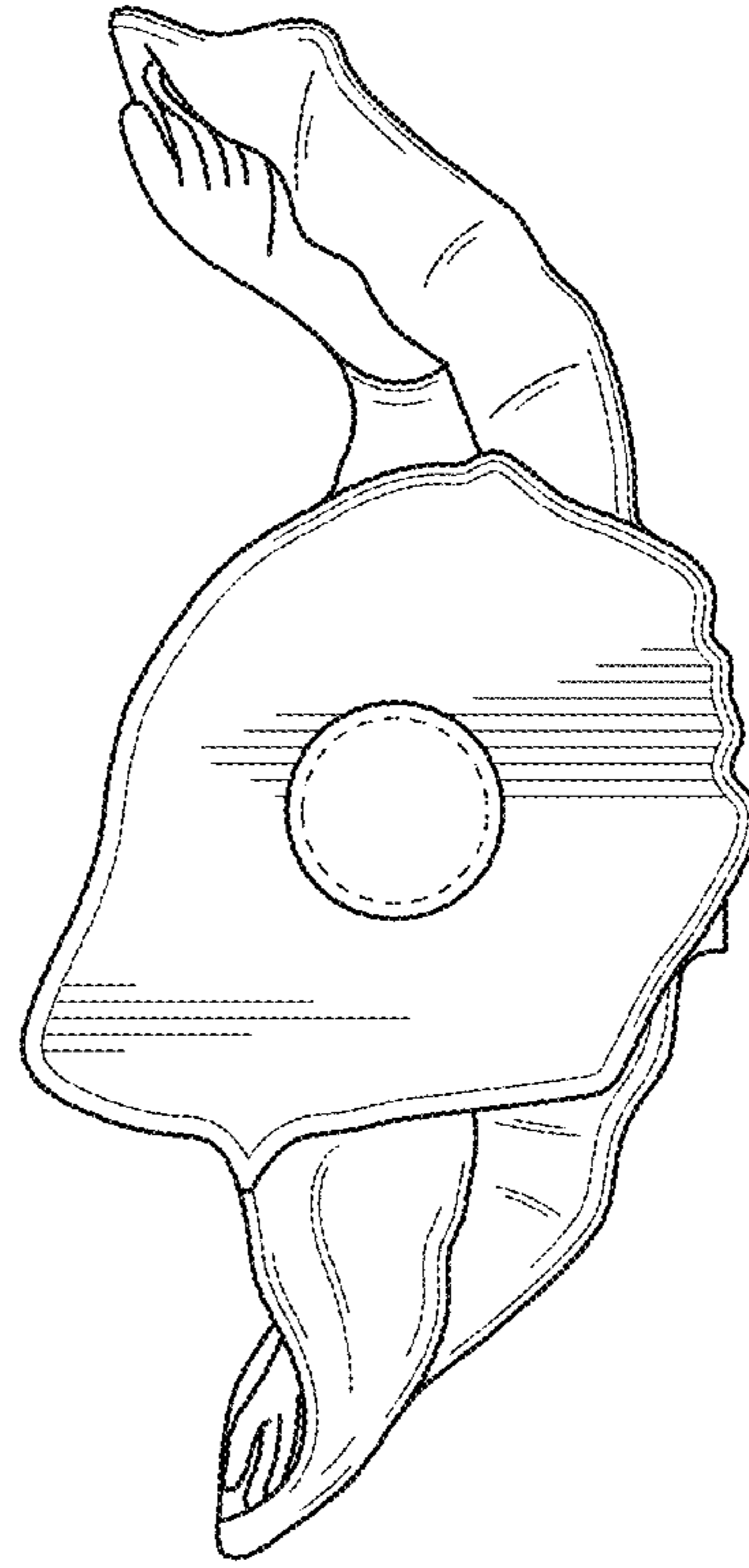

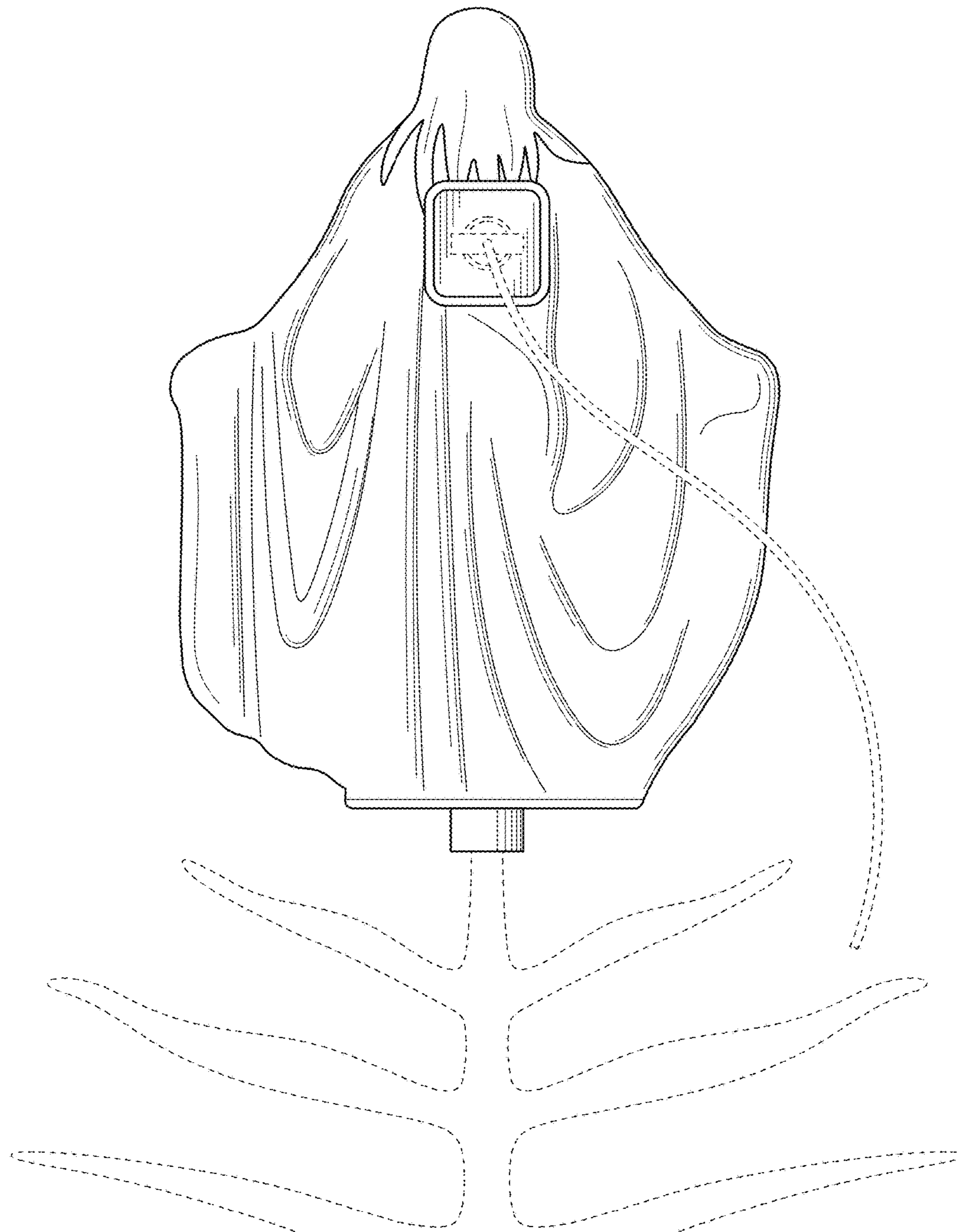
