DESCRIPTION

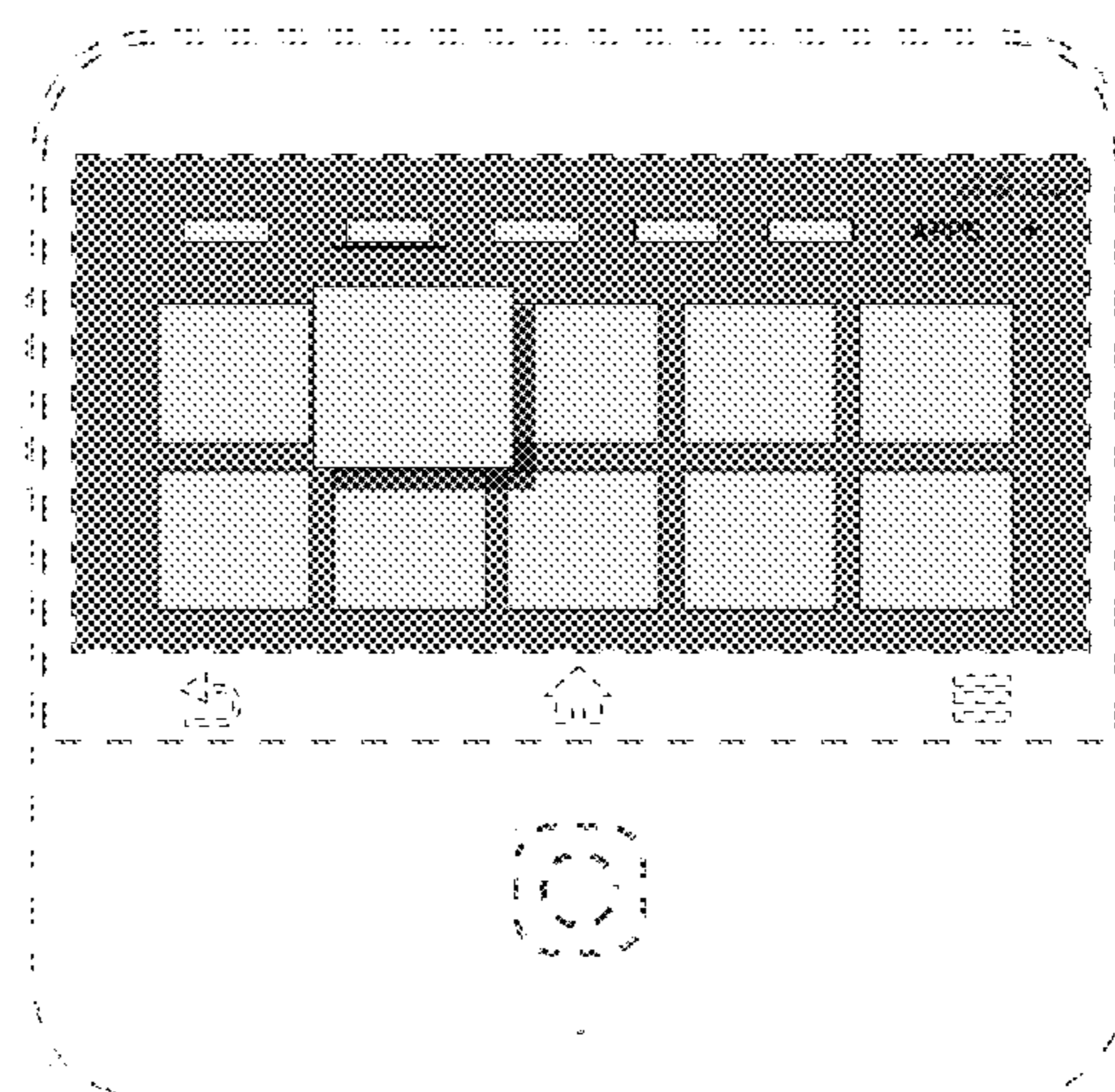
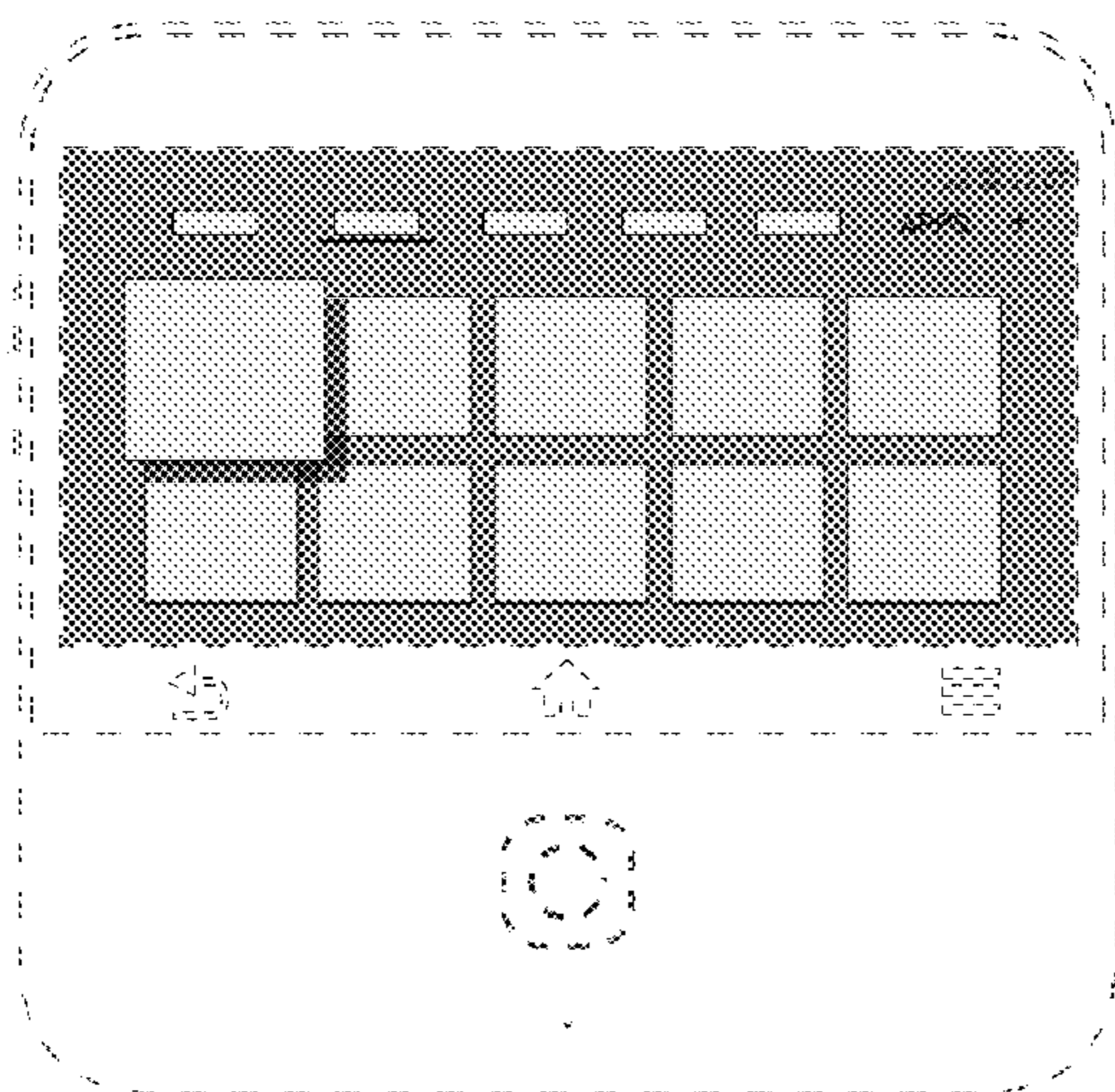
FIG. 1 is a front view of the first image of our new design for a consumer electronic device with animated graphical user interface; and,

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-2. The process or period that one image transitions to another image forms no part of the claimed design.

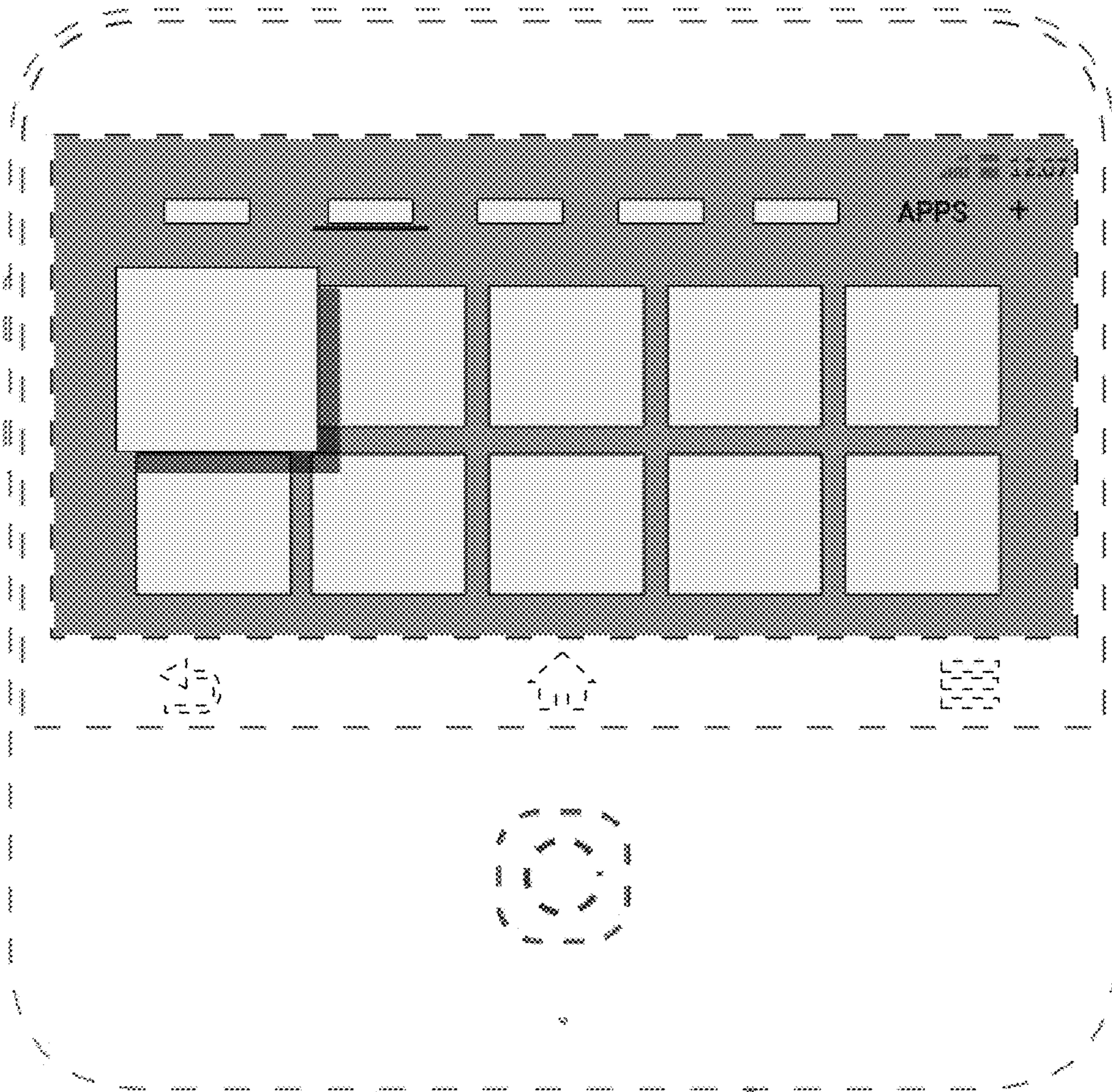

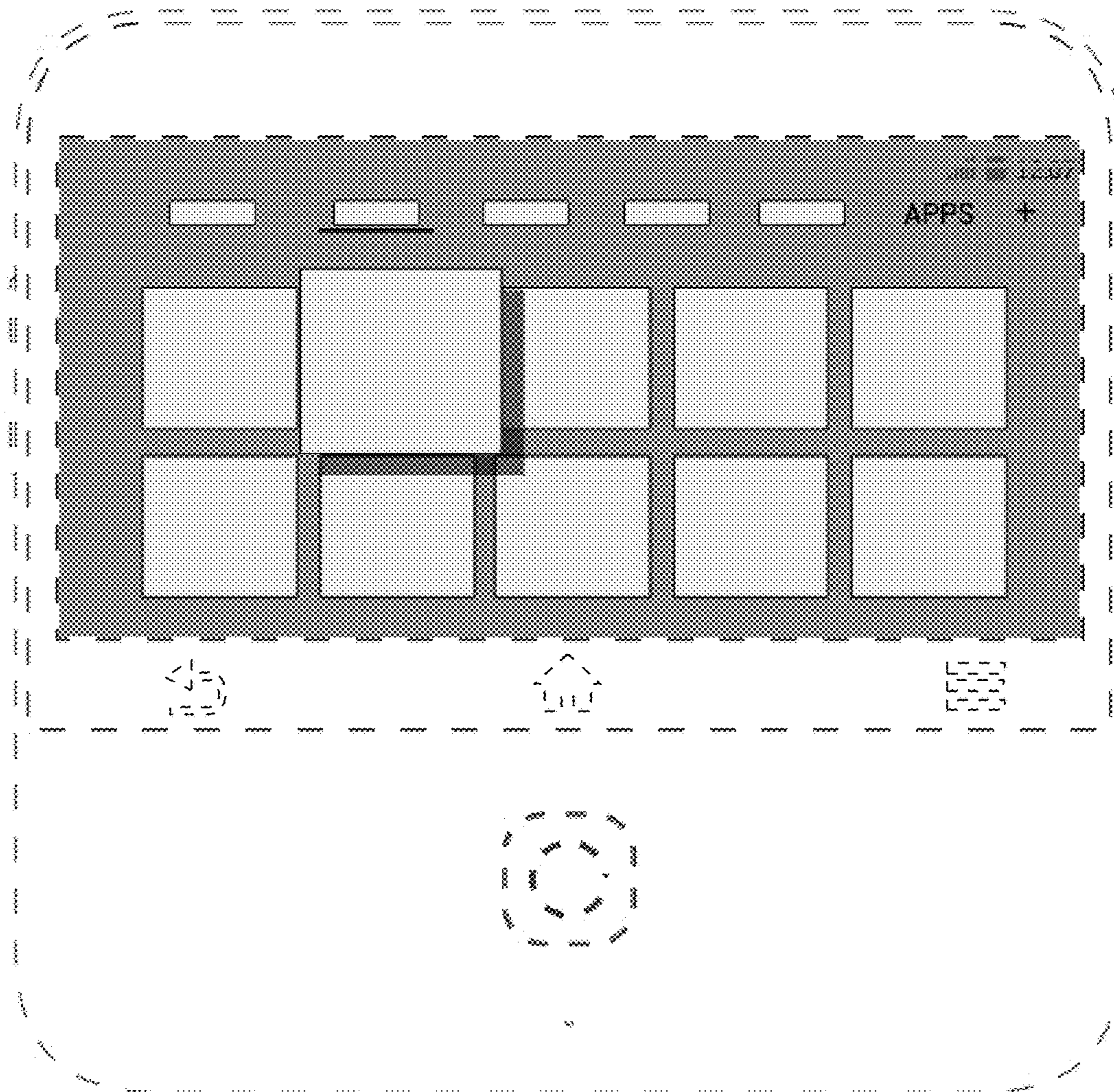
