(57) **CLAIM**

The ornamental design for a head cover for a golf club, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a head cover for a golf club showing the claimed design;

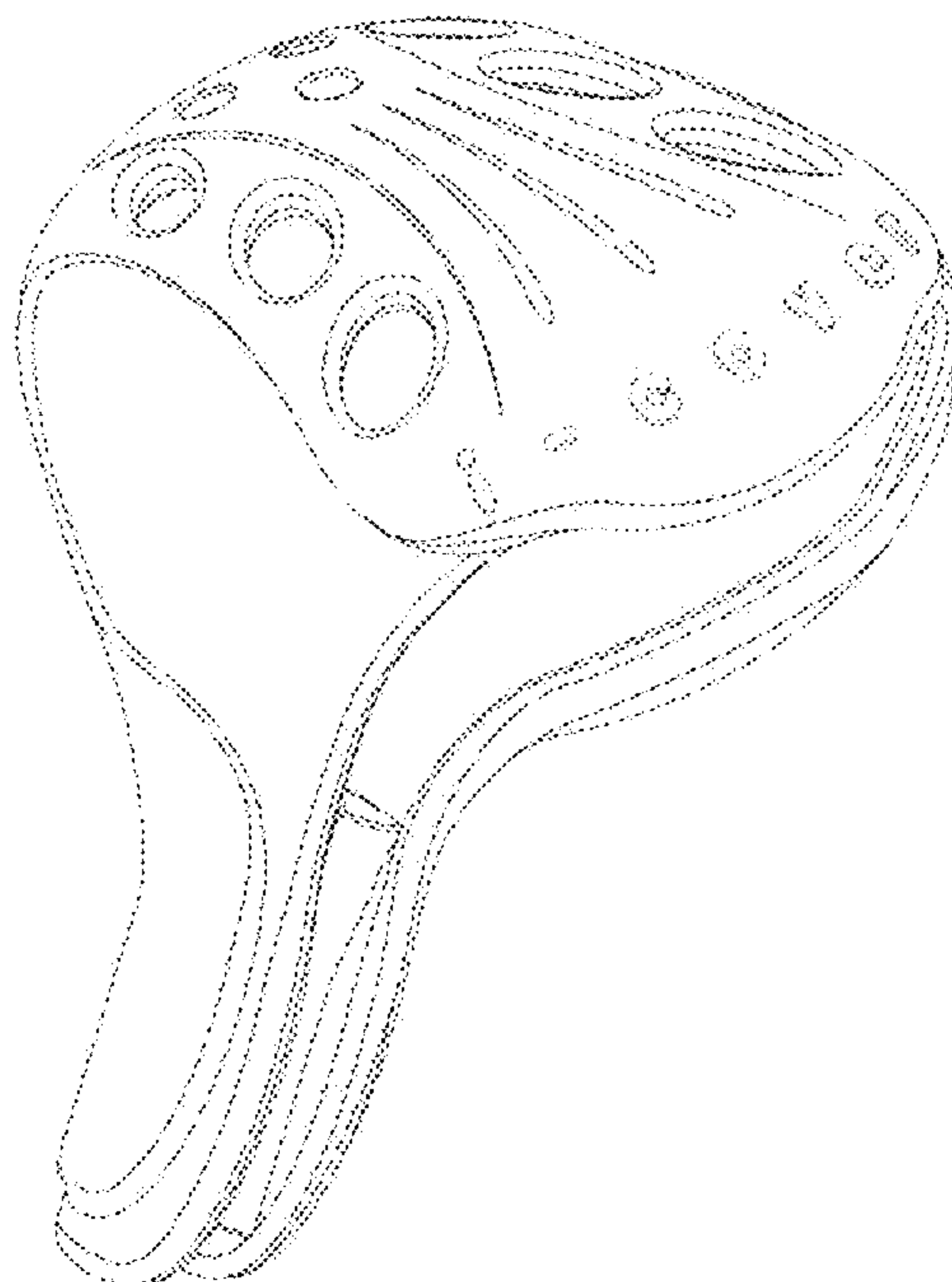

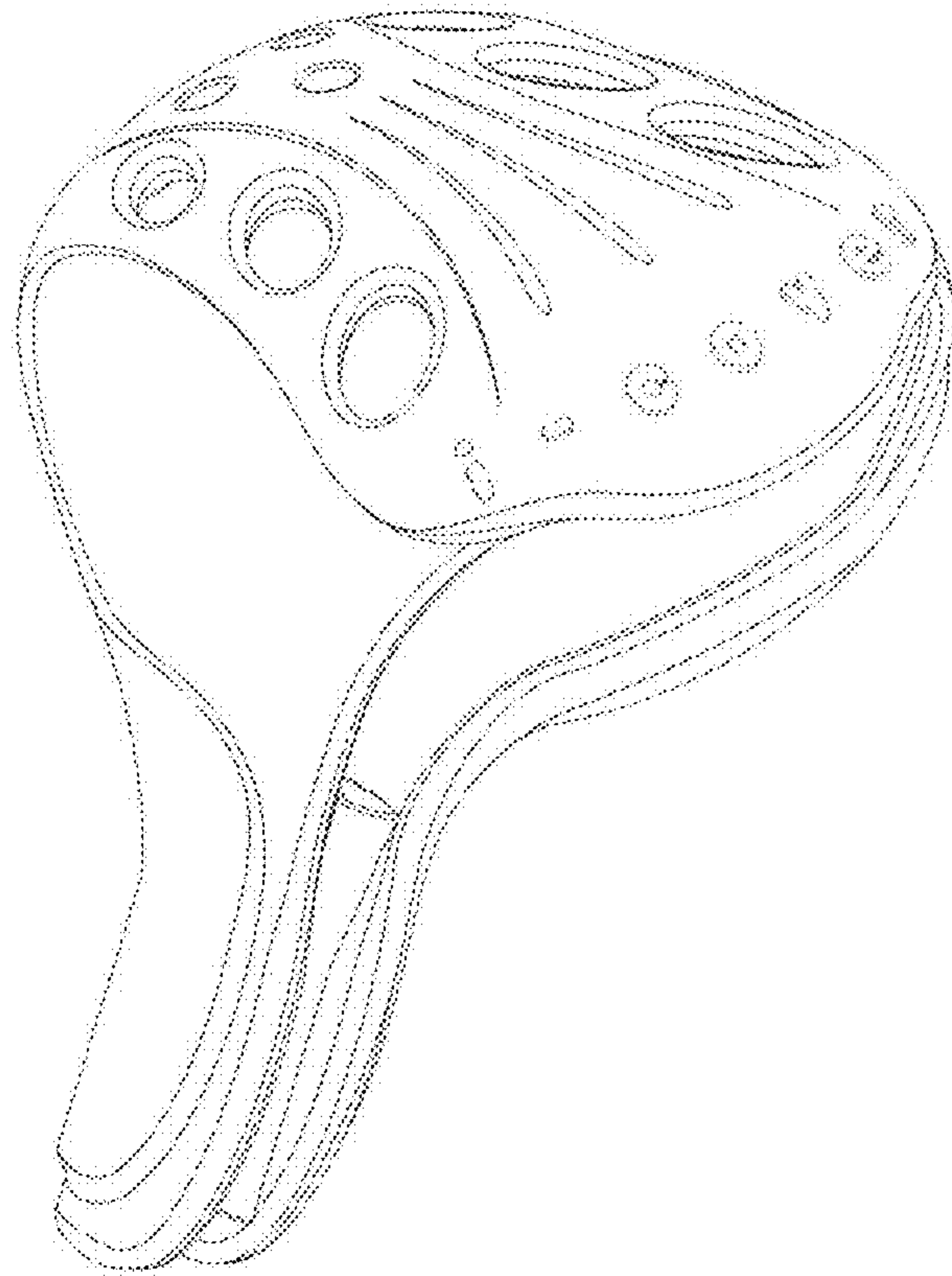

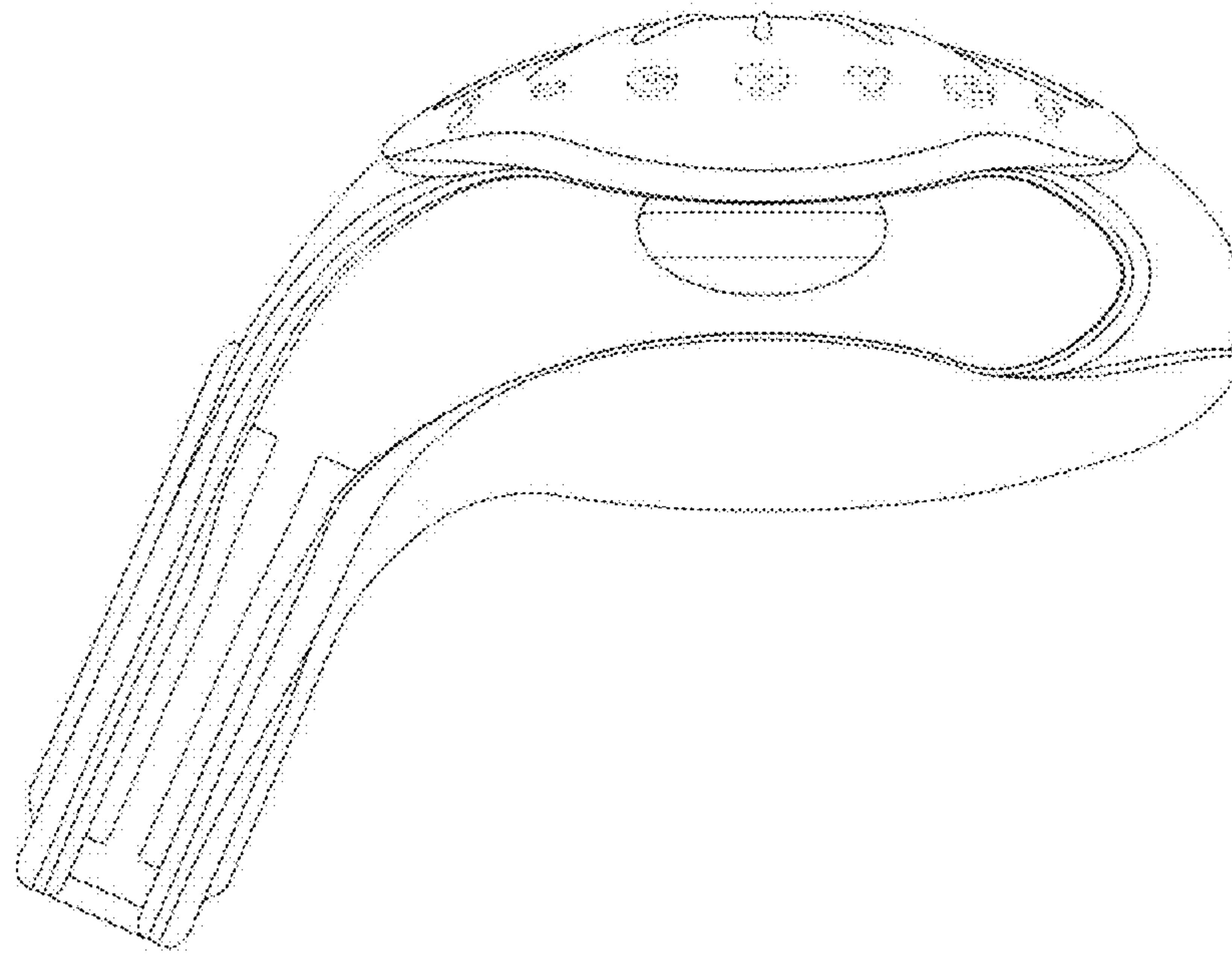

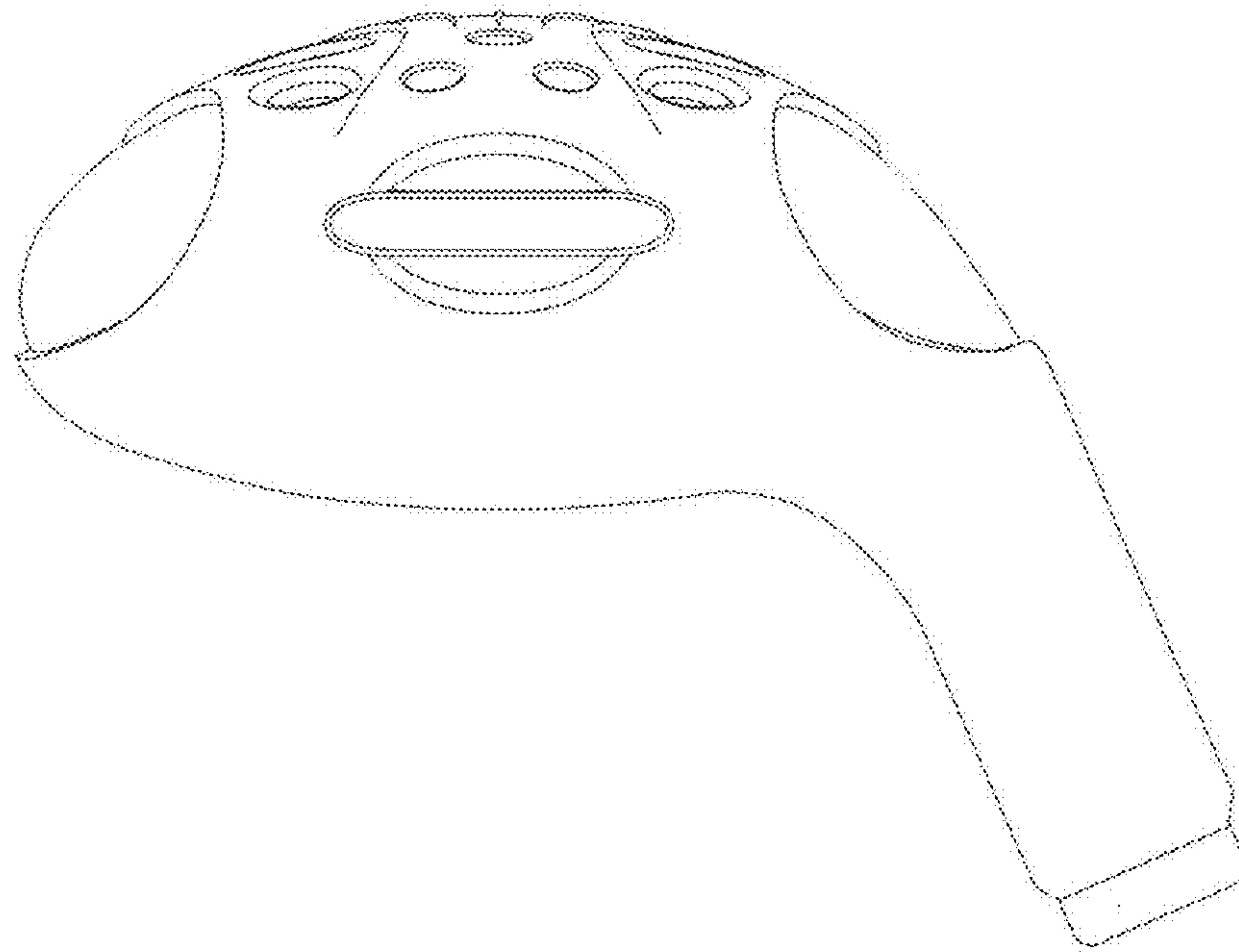

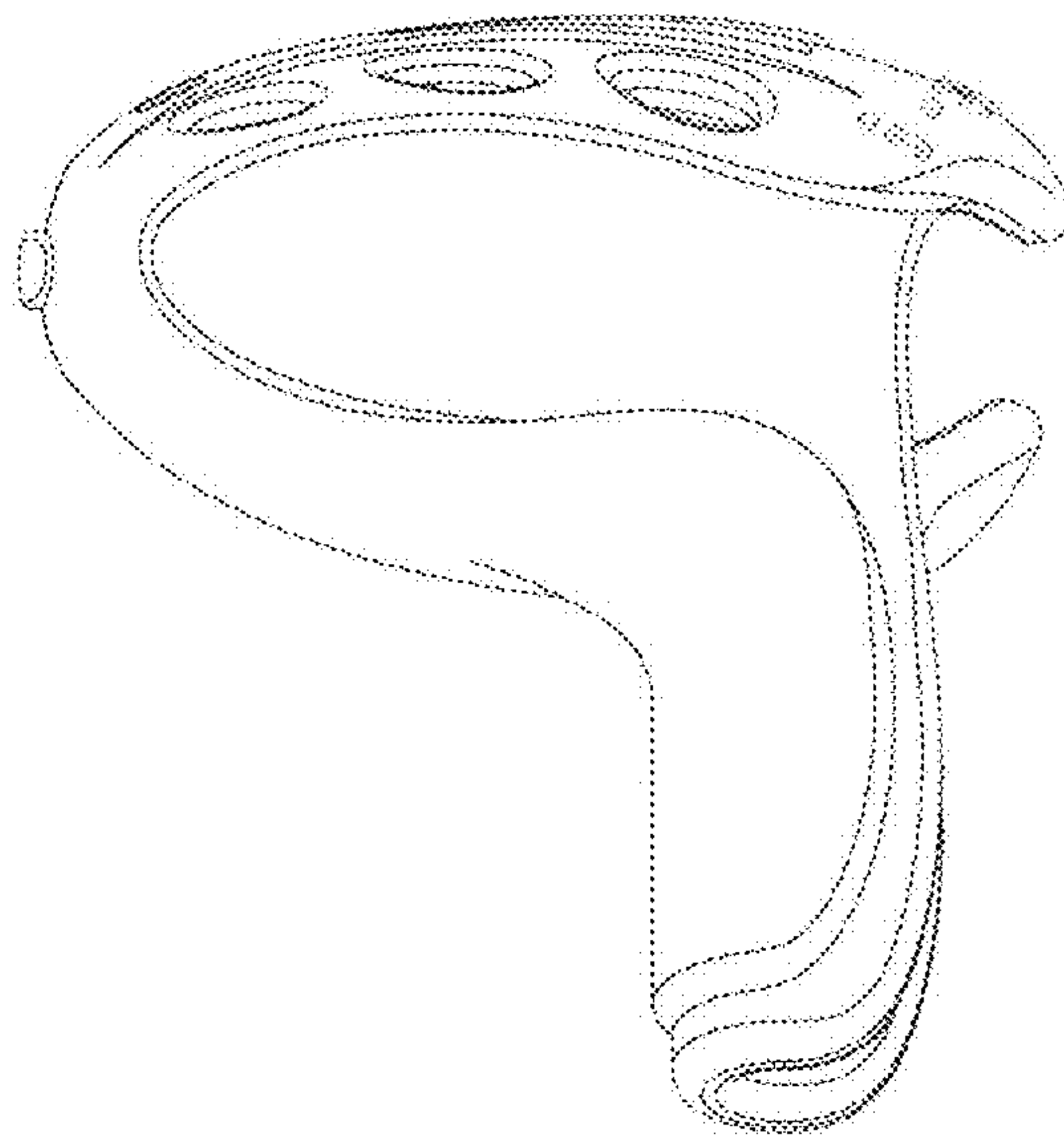

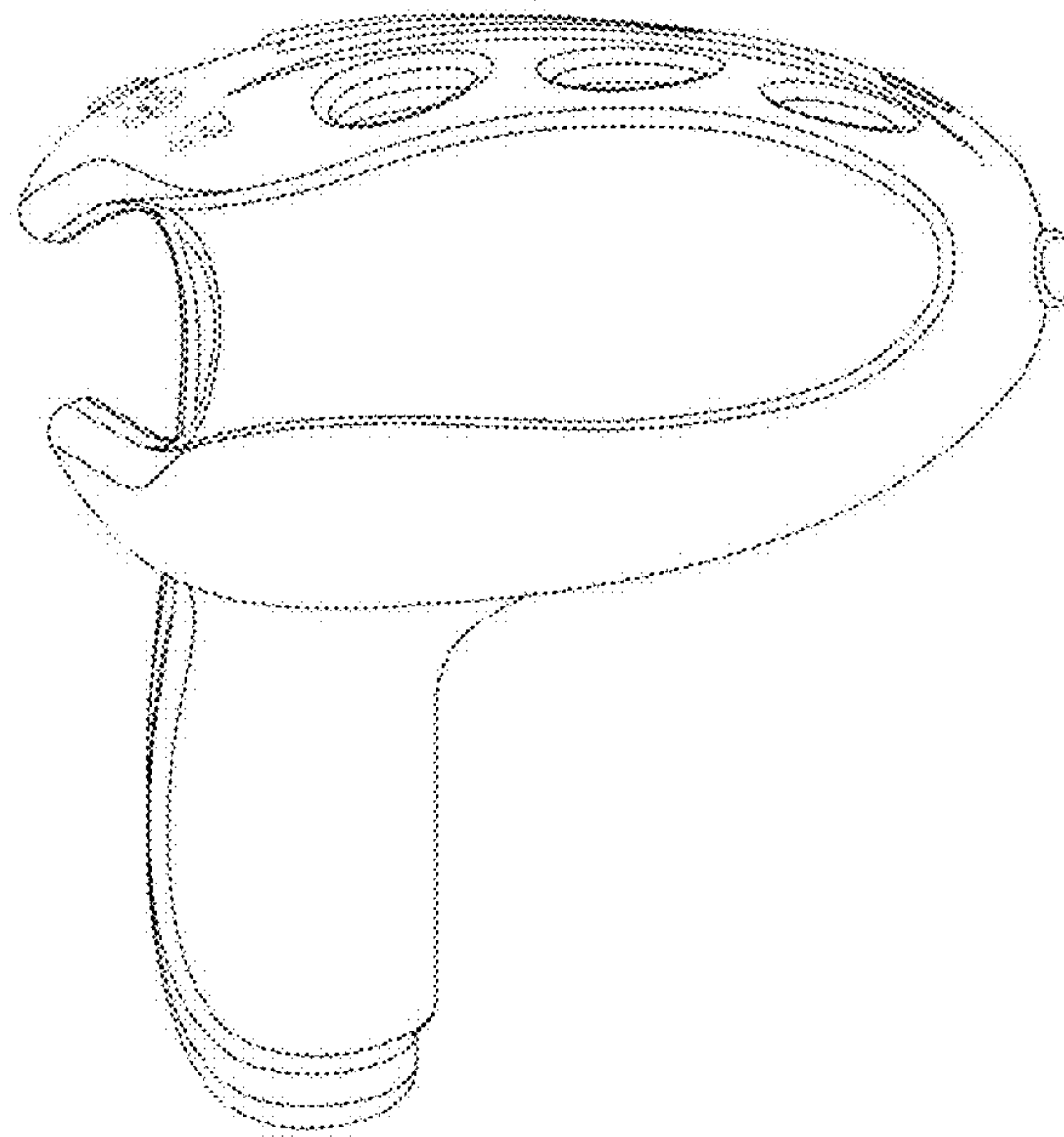

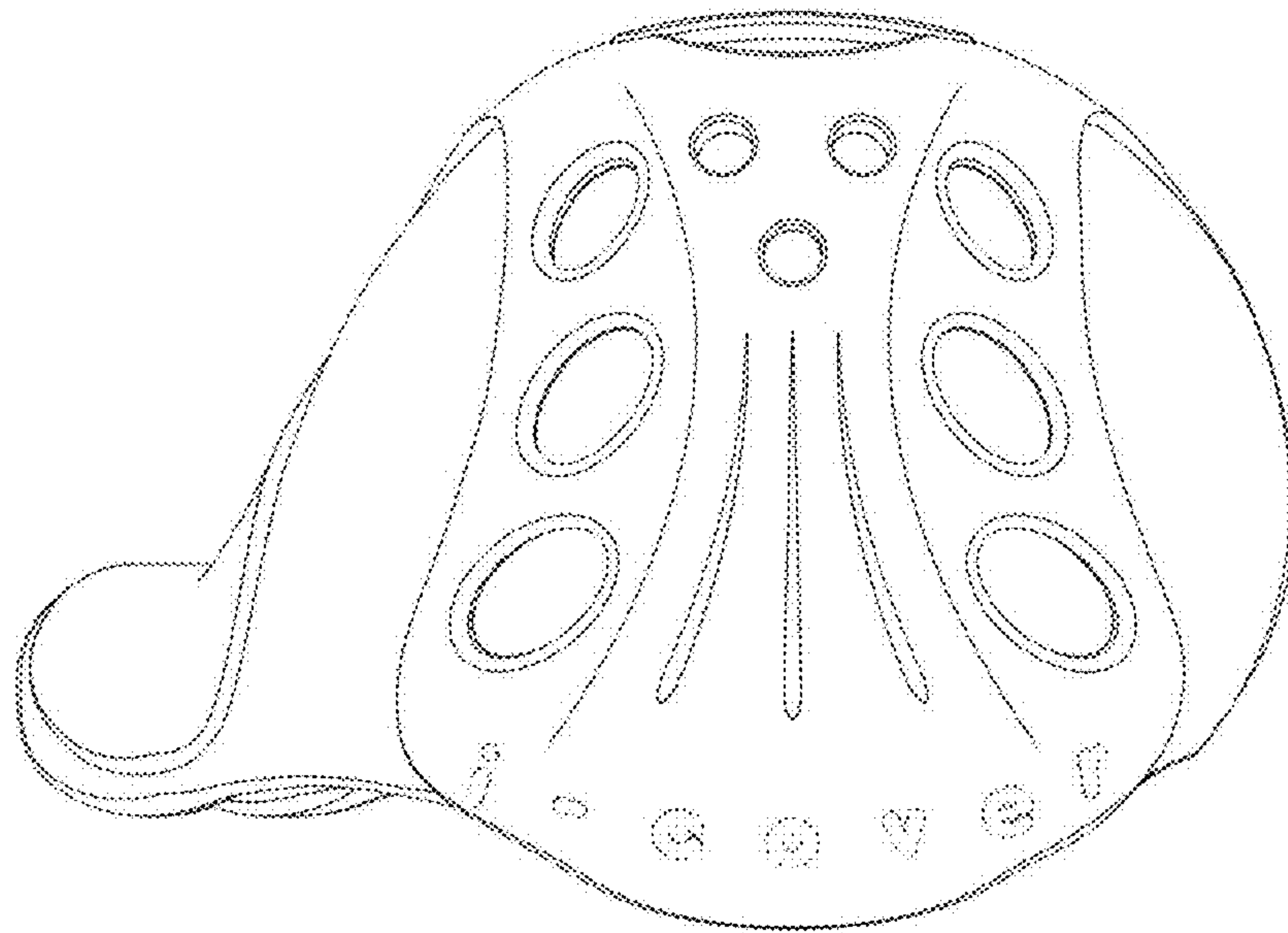

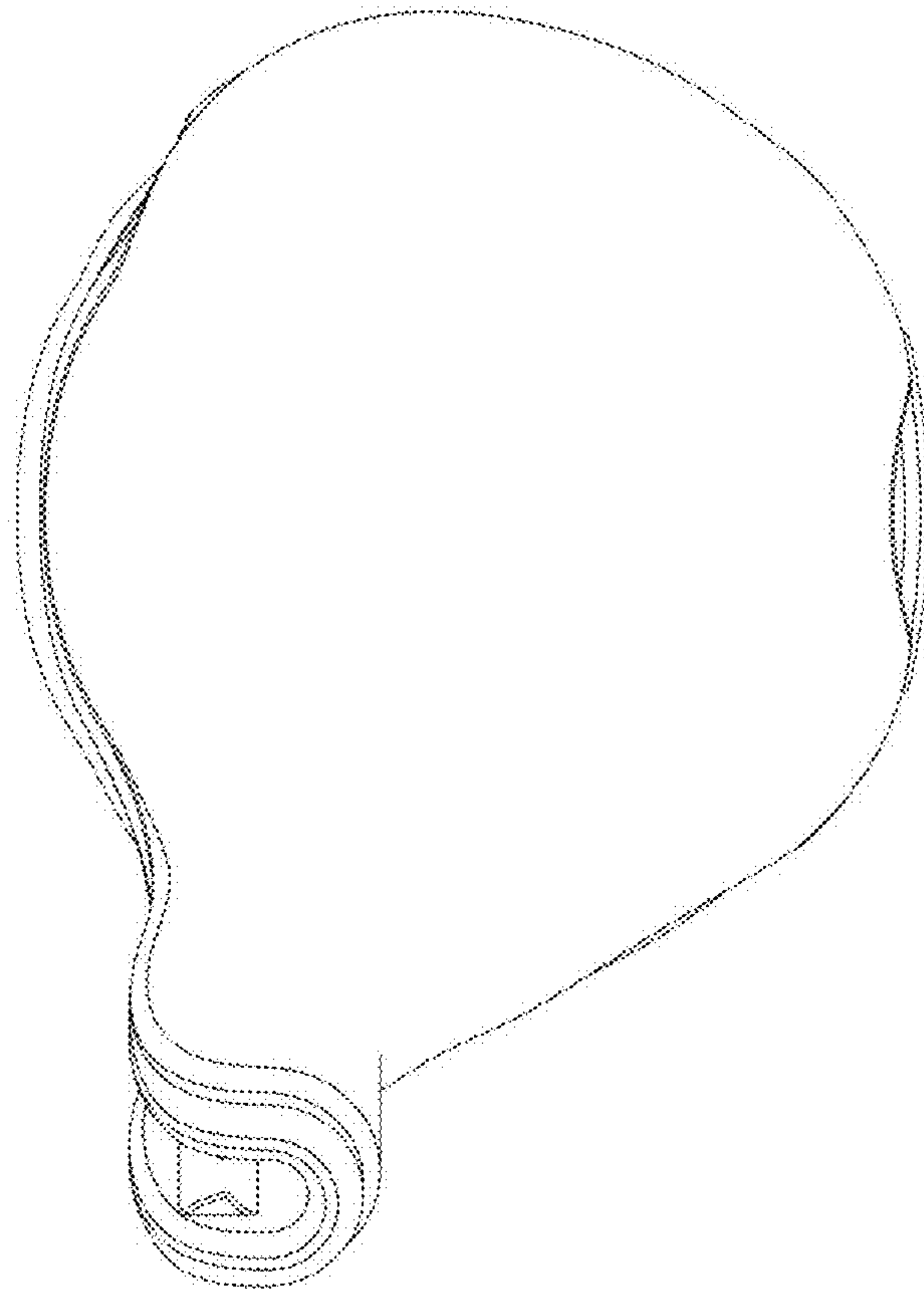
