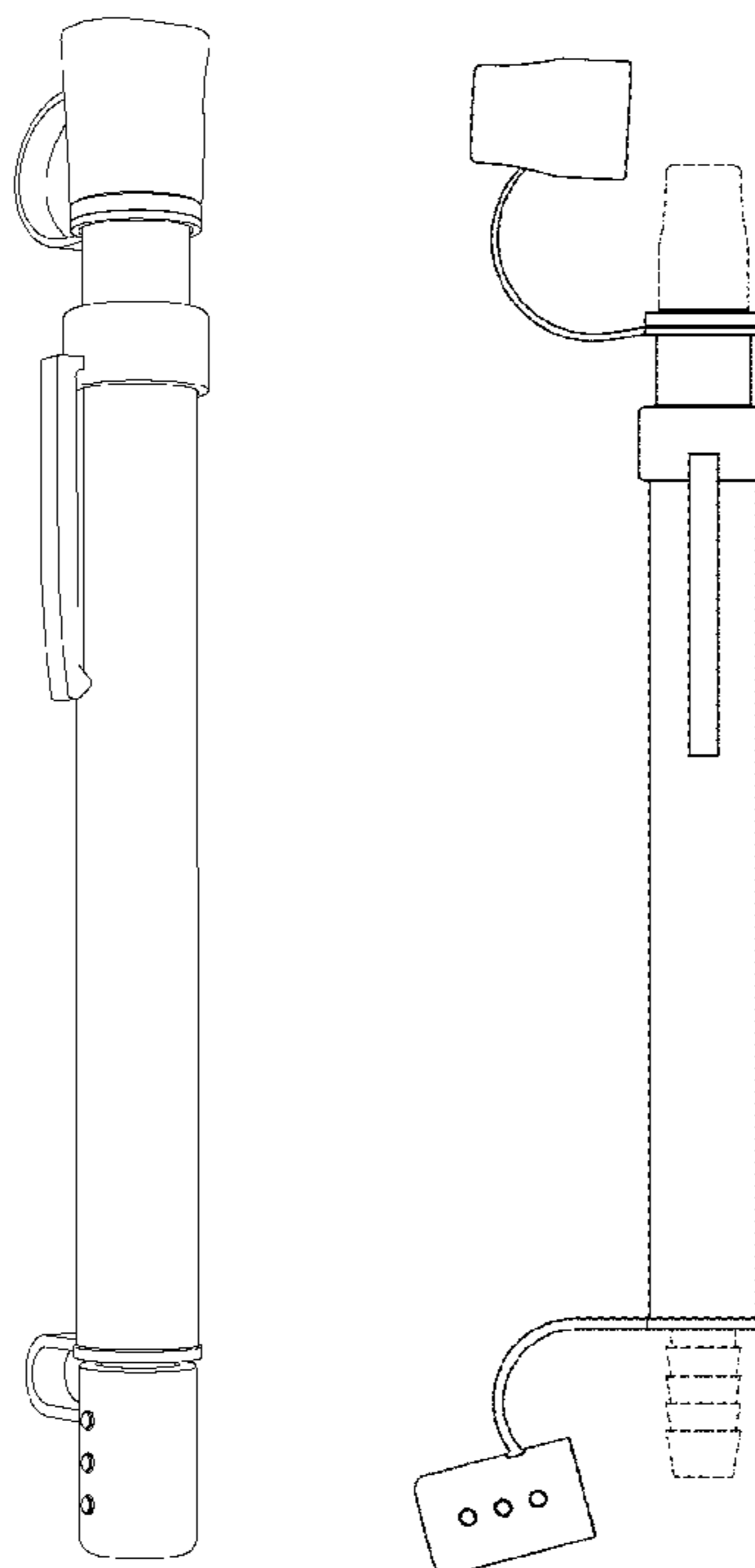
(57) **CLAIM**

The ornamental design for a portable water purifying filter, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portable water purifying filter showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top view thereof;
FIG. 7 is a bottom view thereof;
FIG. 8 is a reference view thereof in a state that caps are open; and,
FIG. 9 is a reference view thereof in use in a state that caps are open.

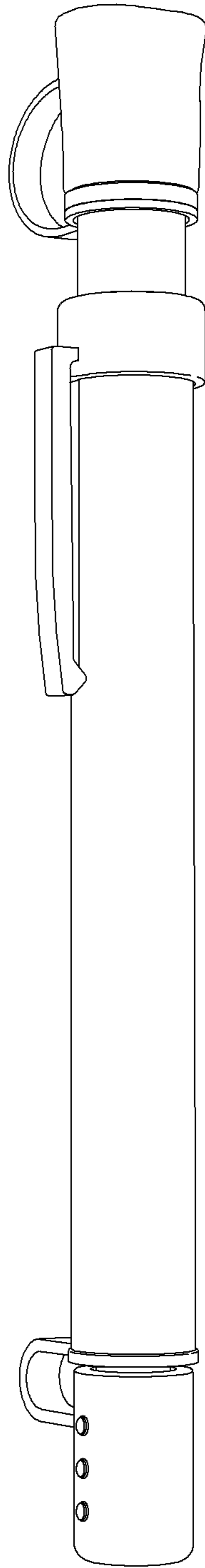

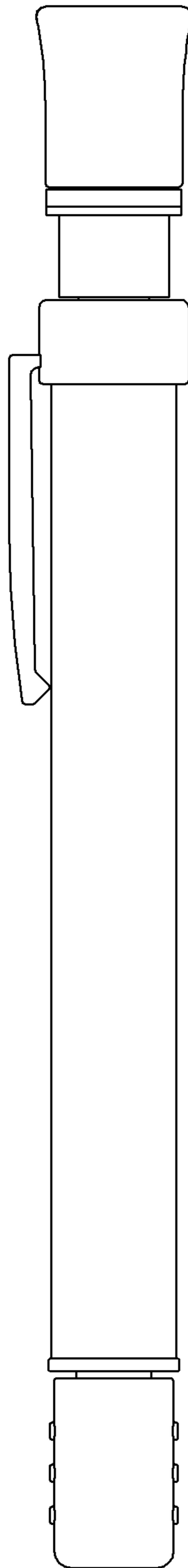

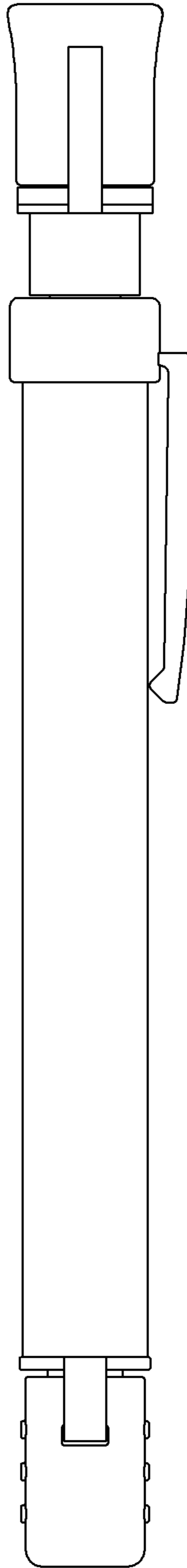

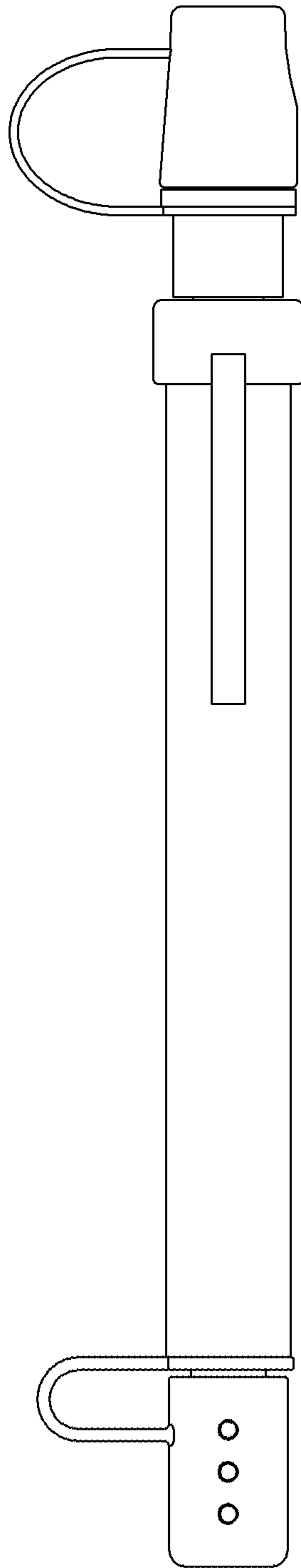

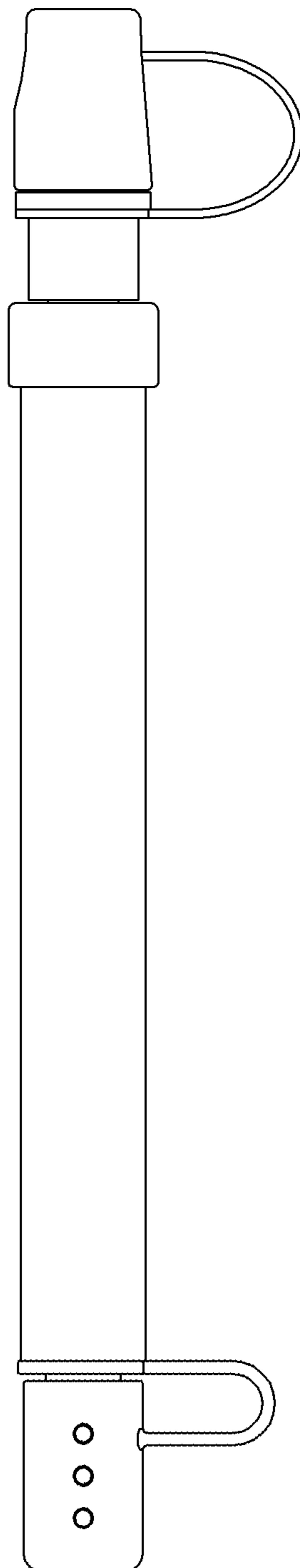

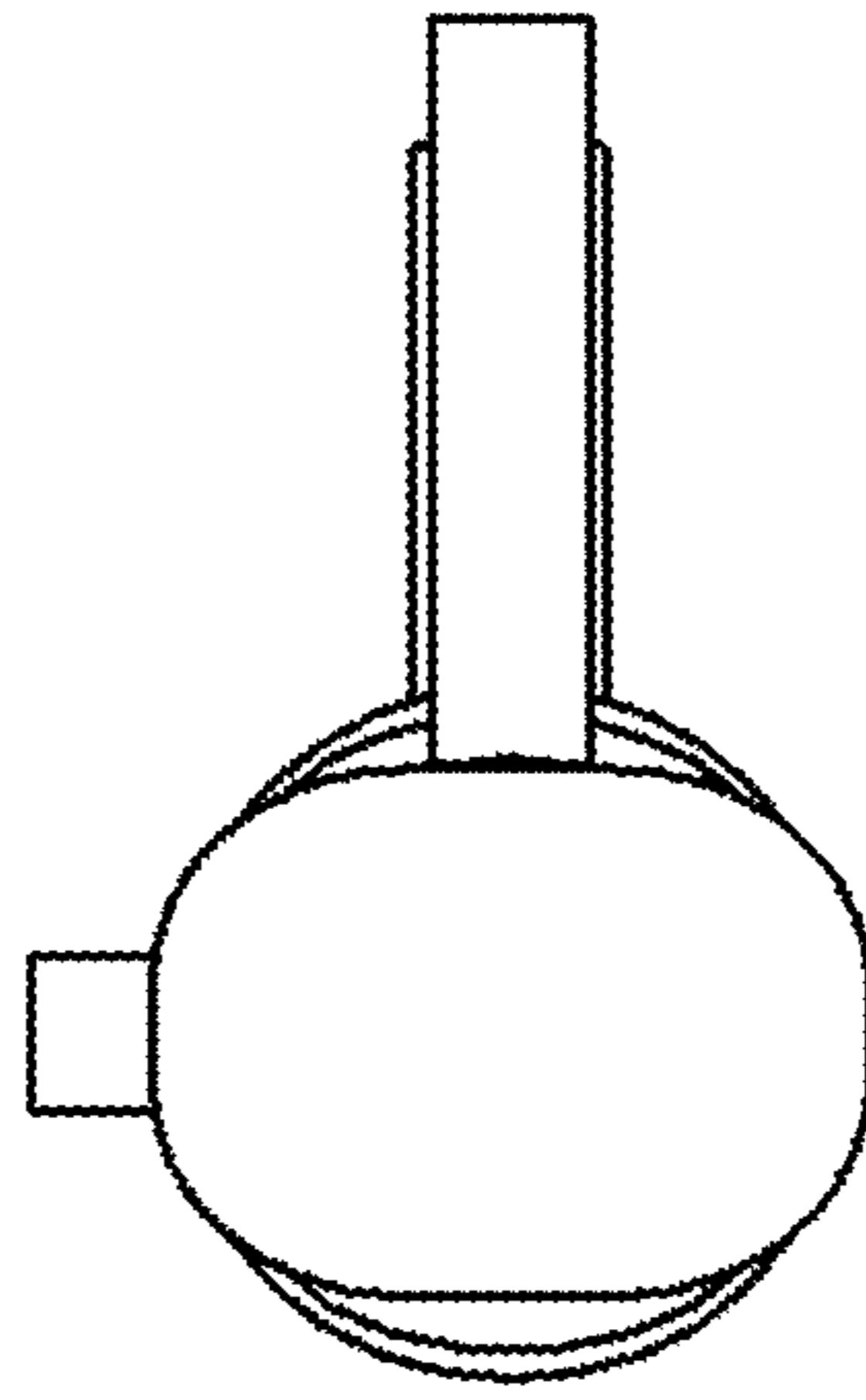

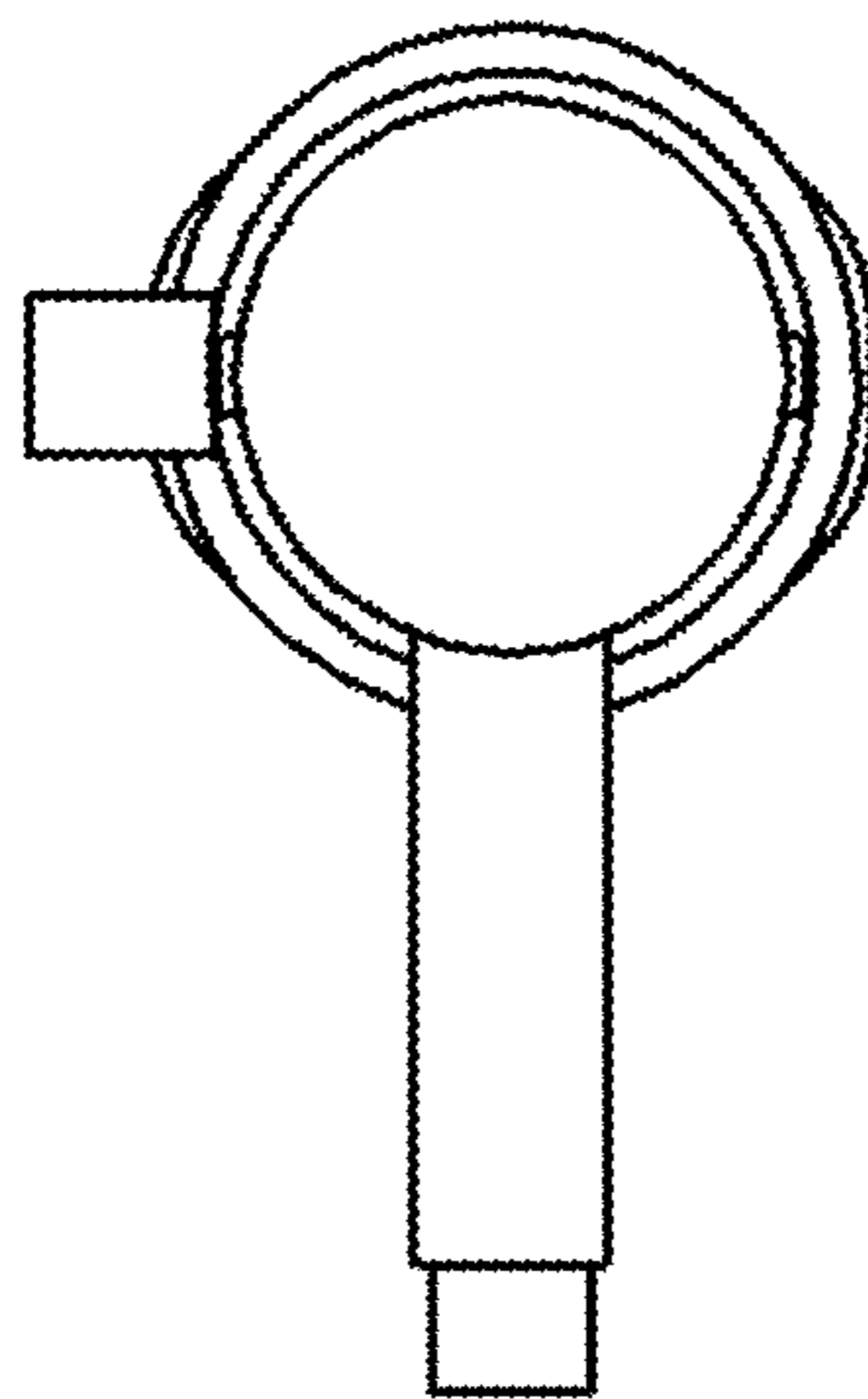

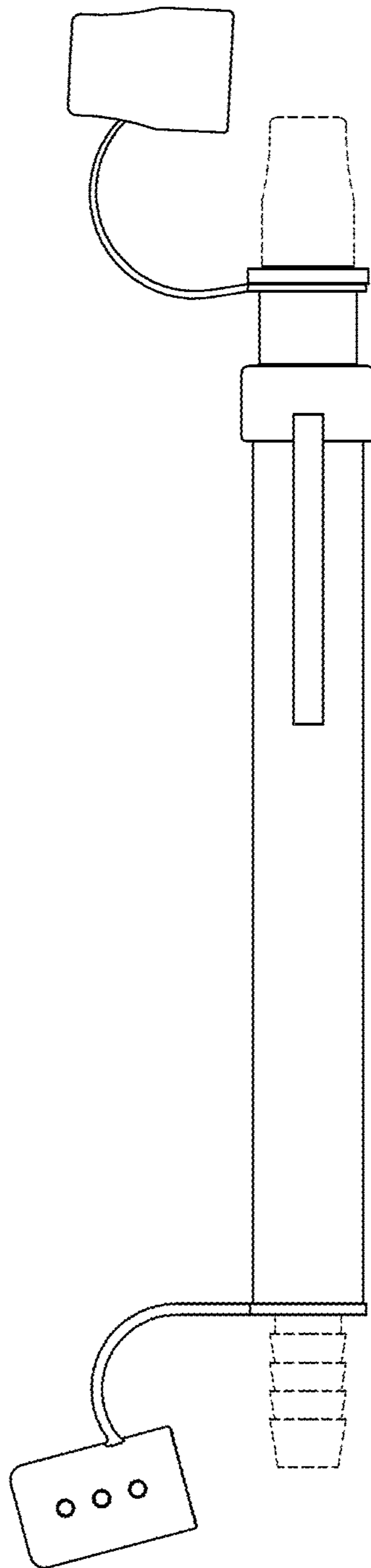

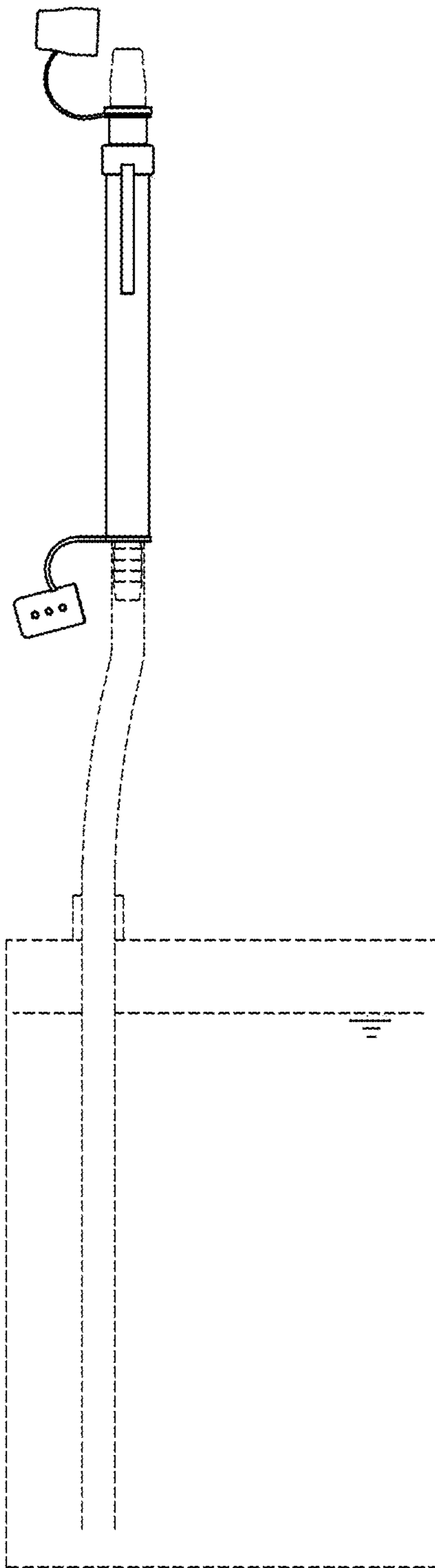
