The ornamental design for a hose connector, as shown and described.

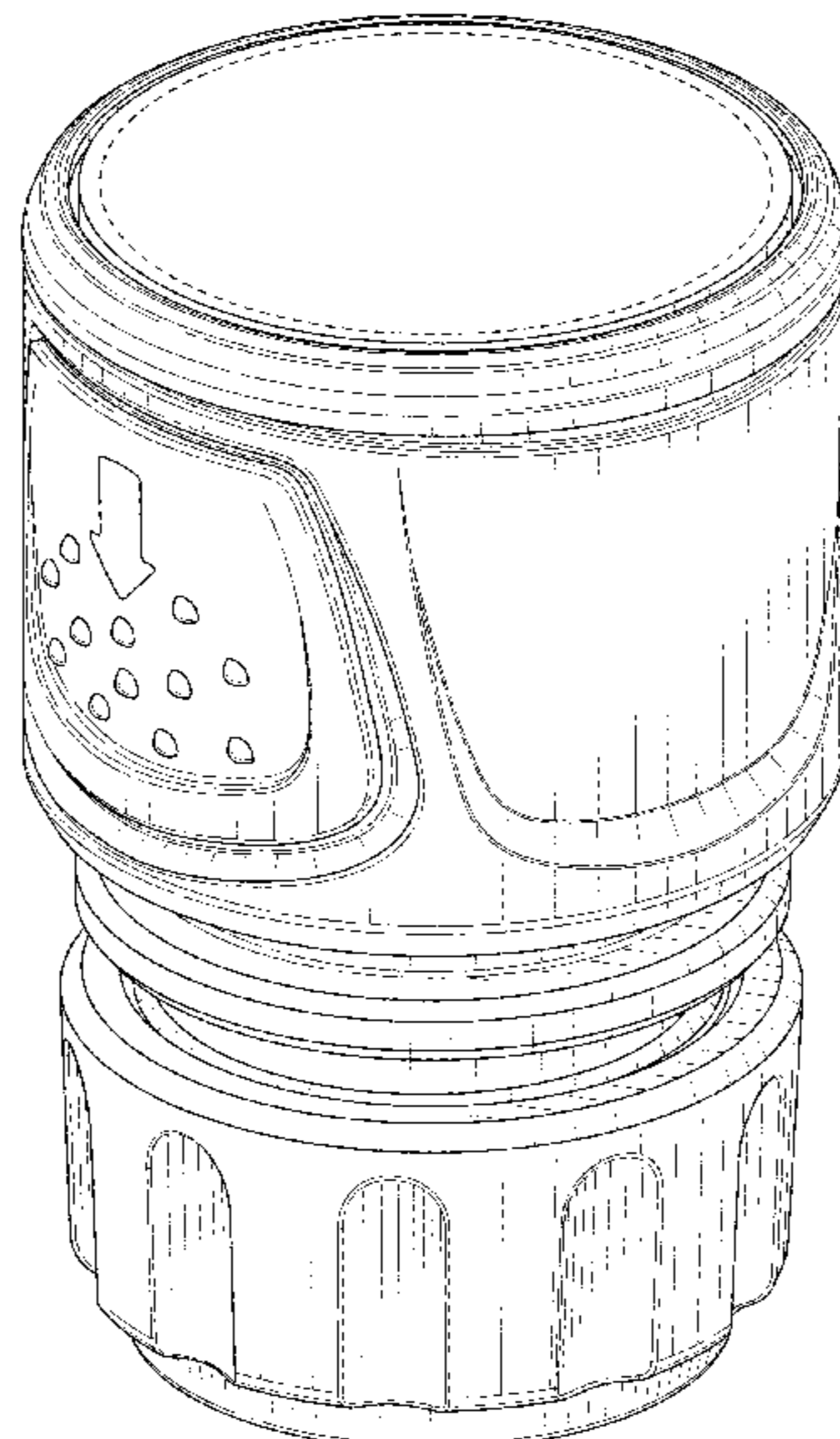
DESCRIPTION

FIG. 1 is a front, top and right perspective view of the hose connector showing the new design;

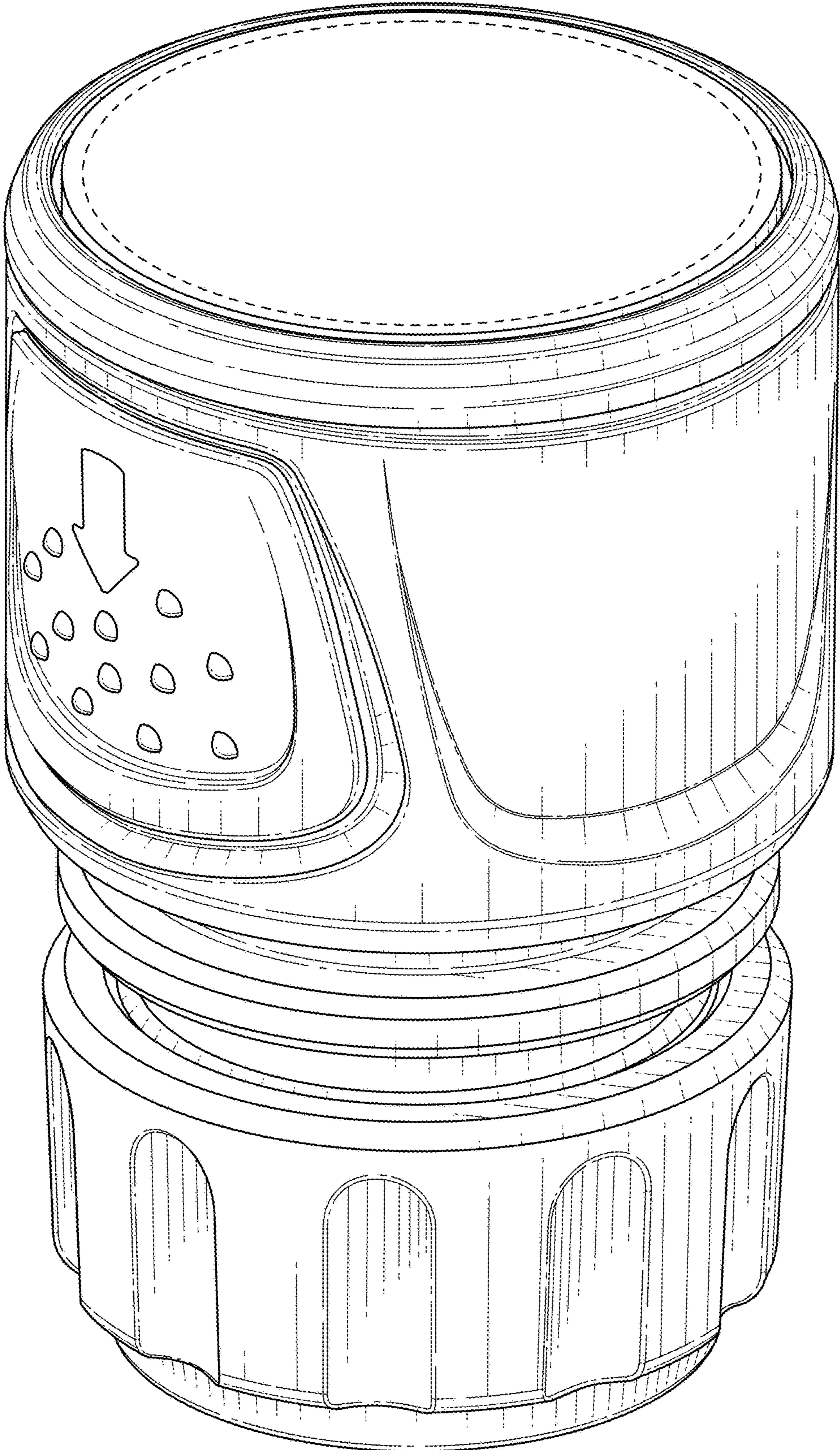

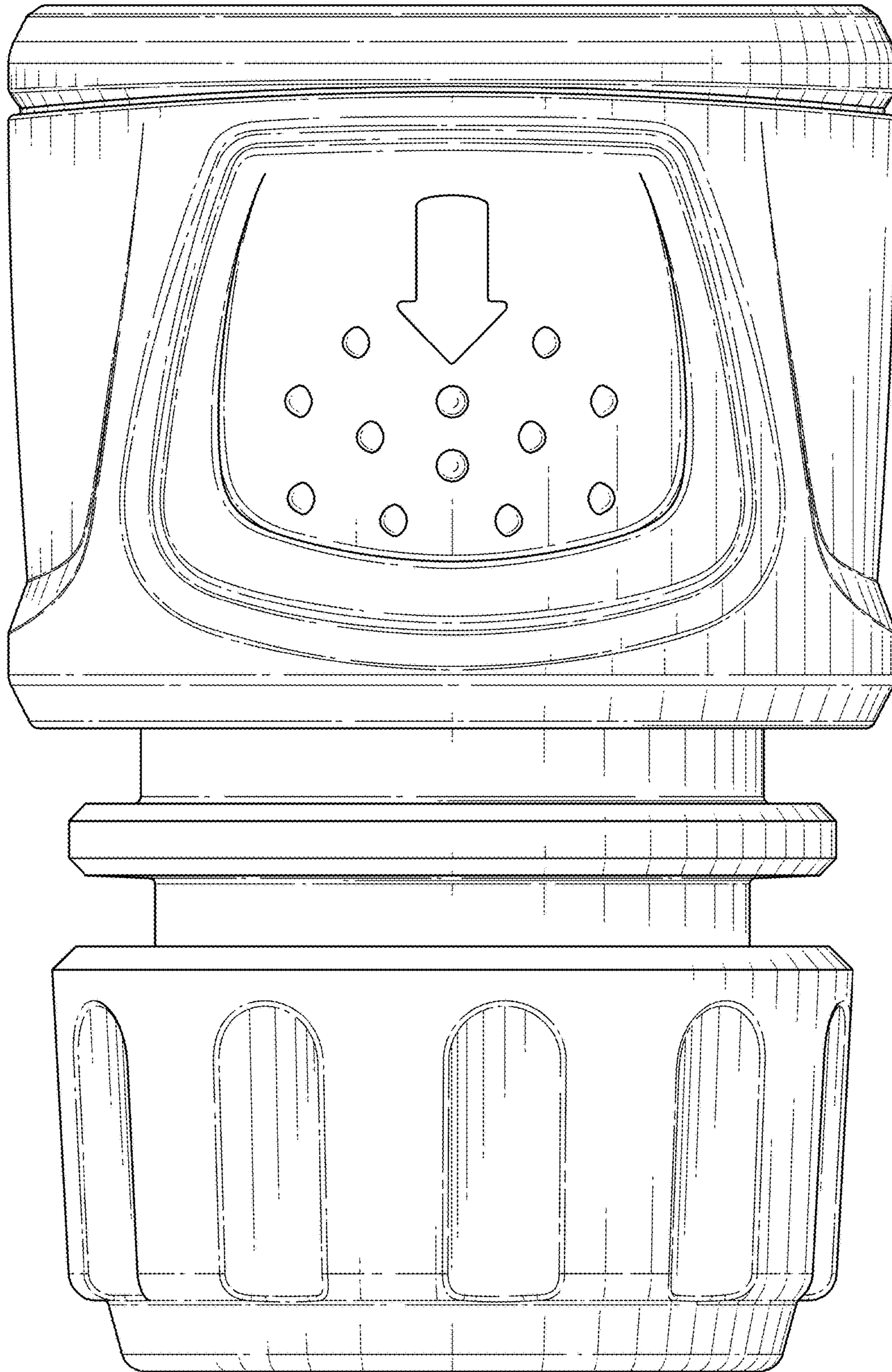

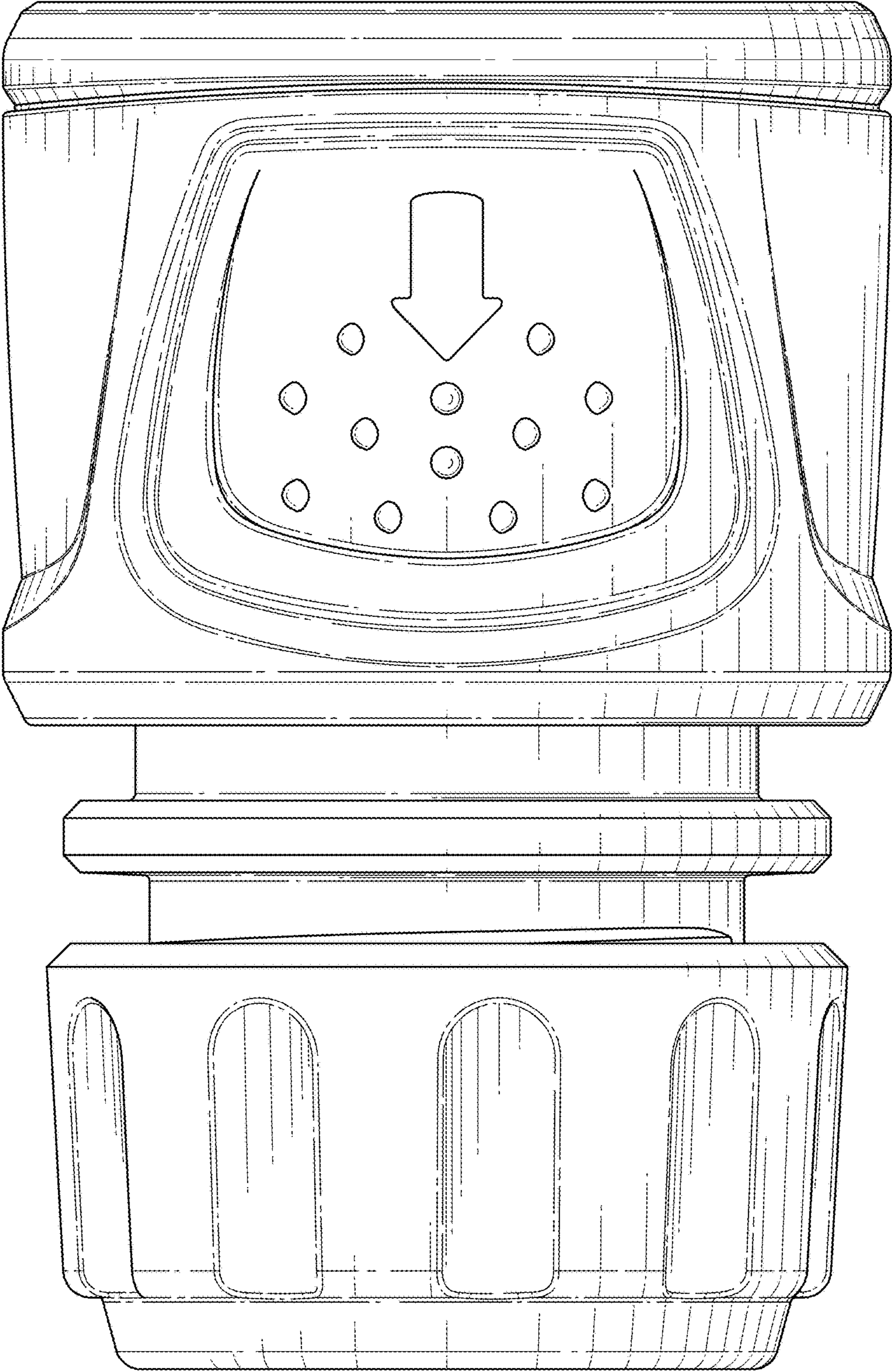

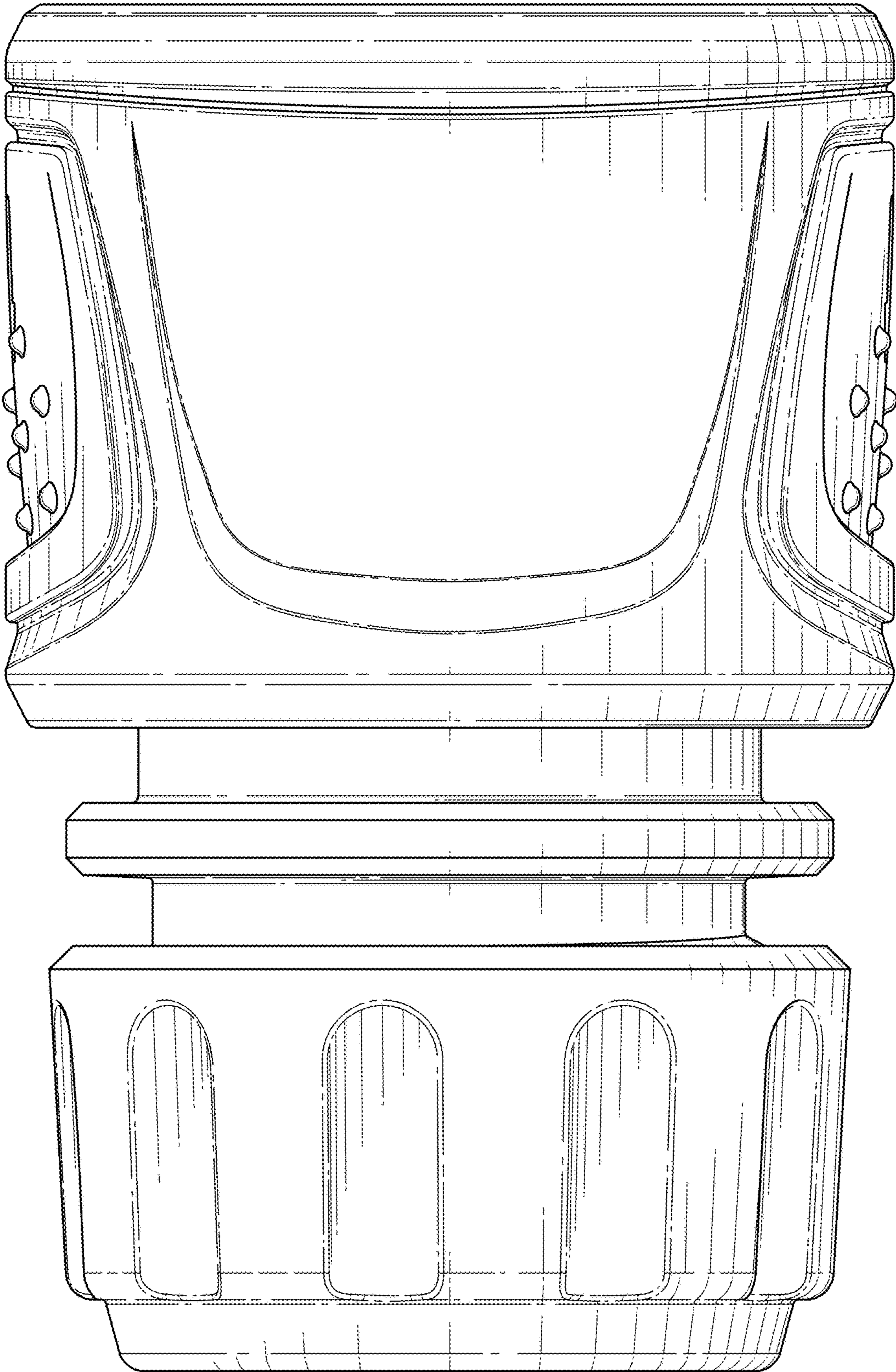

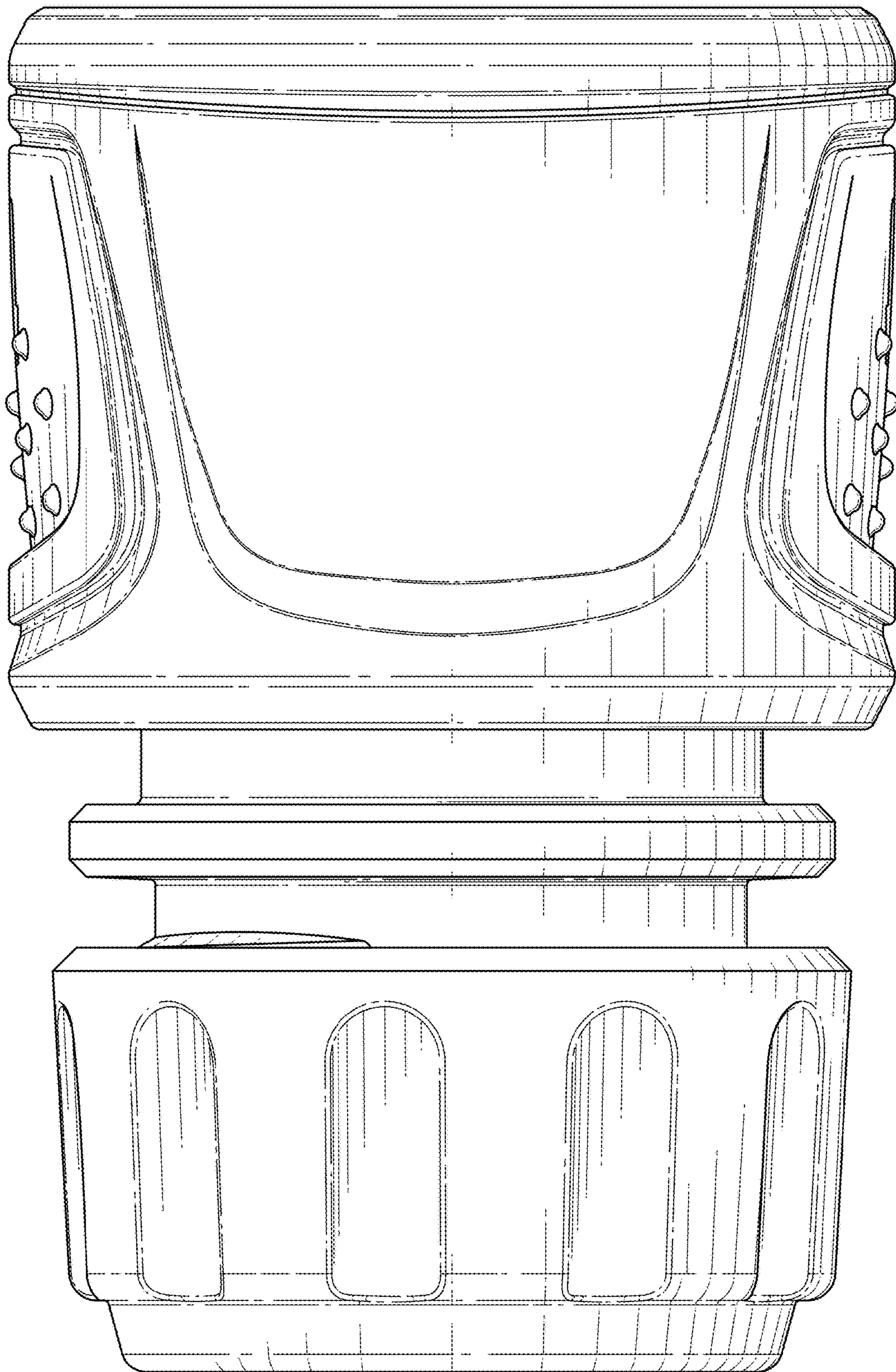

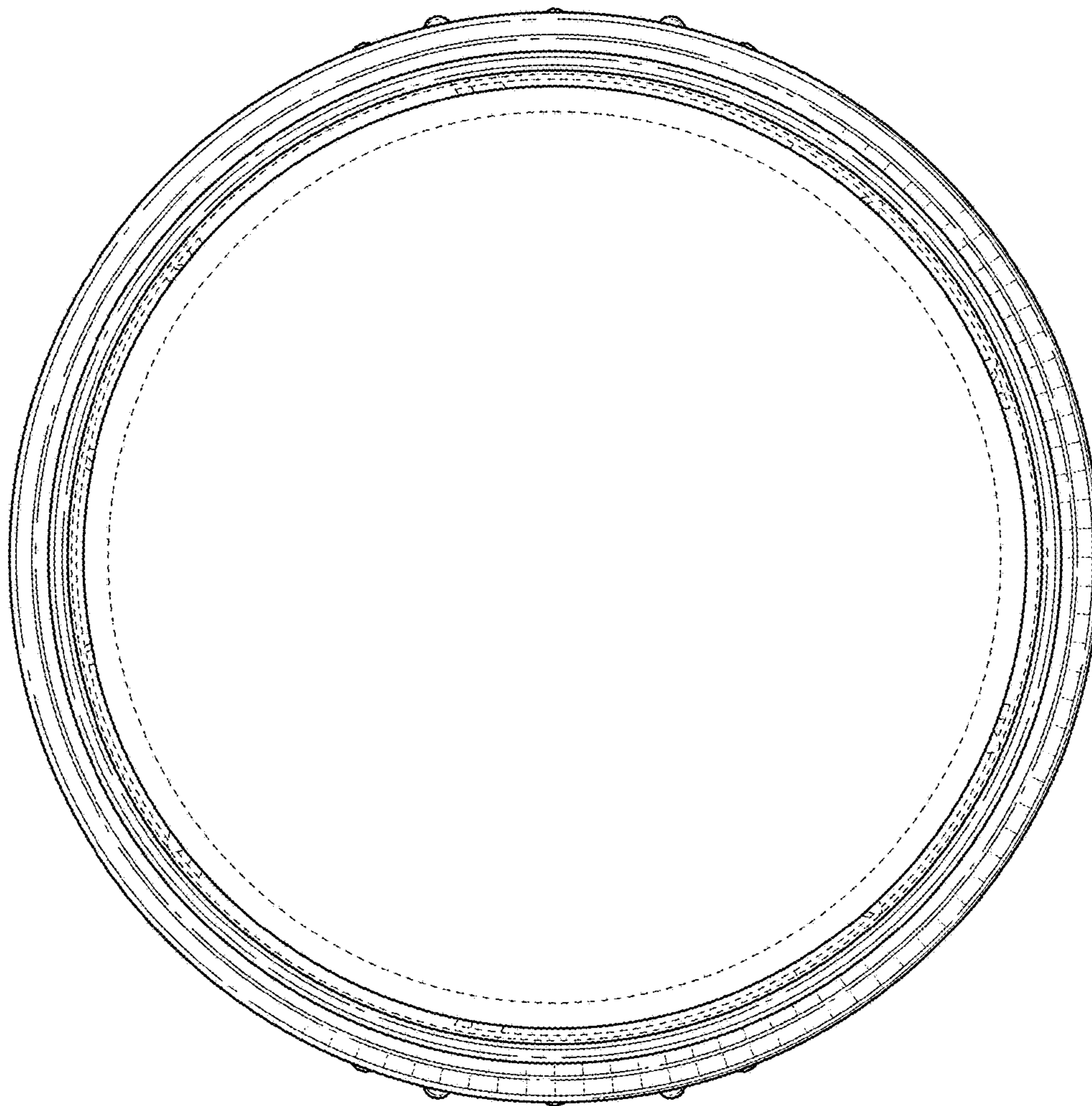

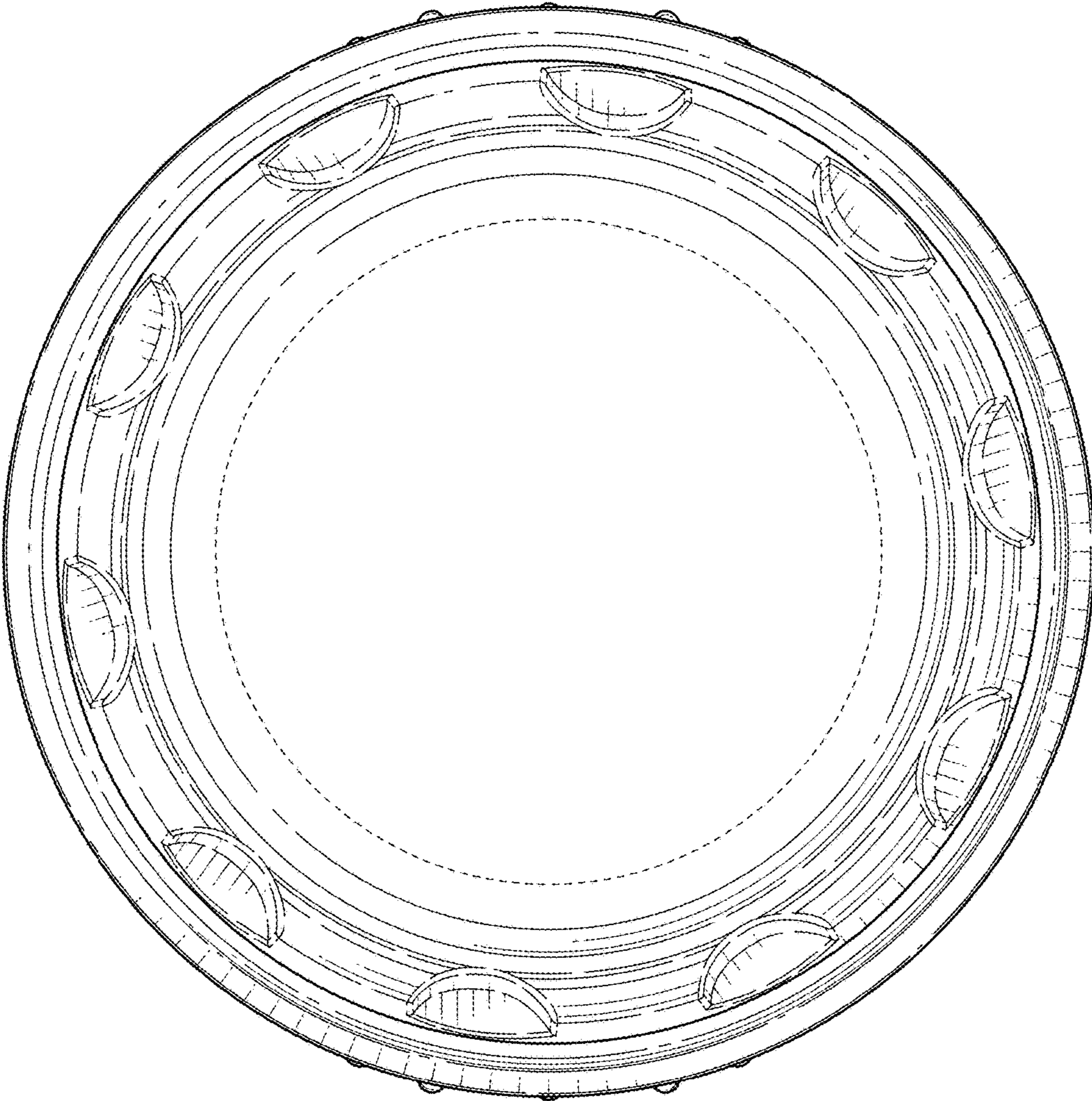
