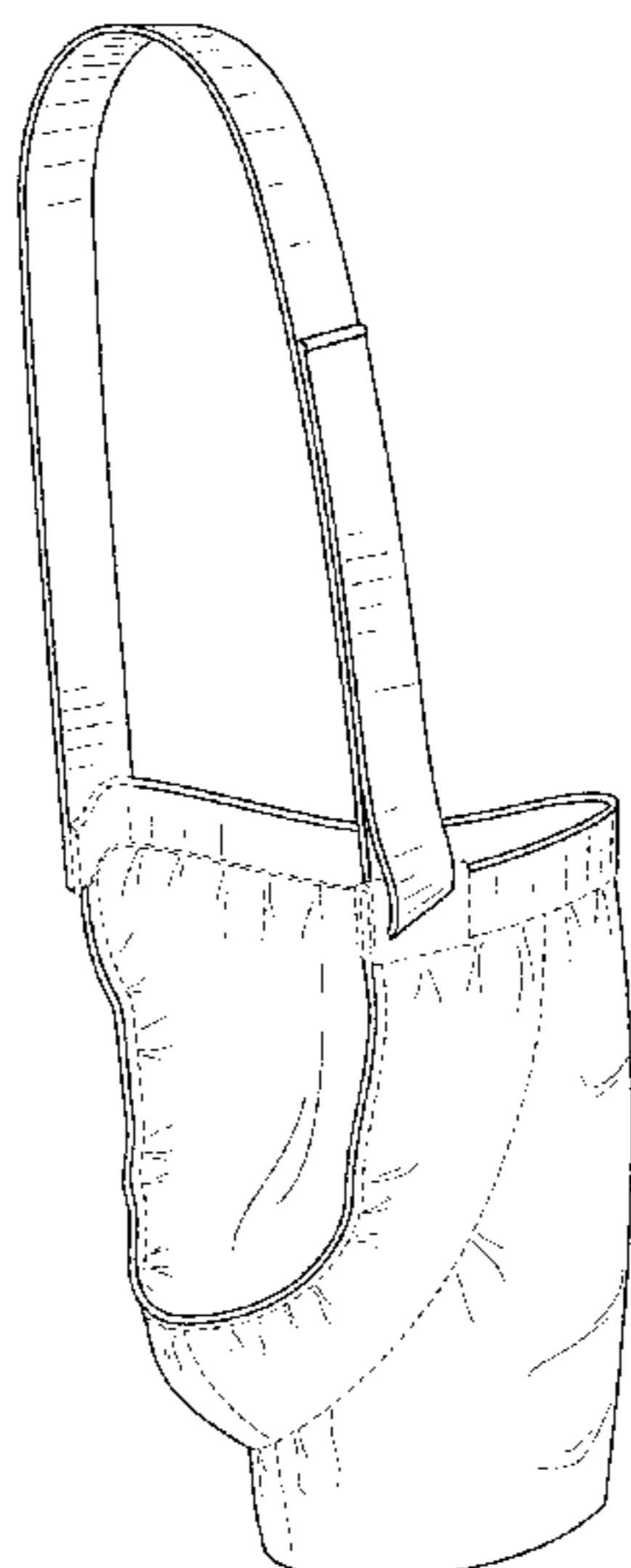
DESCRIPTION

FIG. 1 is a perspective view of a unilateral medical garment. FIG. 2 is a front view of the unilateral medical garment of FIG. 1. FIG. 3 is a back view of the unilateral medical garment of FIG. 1. FIG. 4 is a left side view of the unilateral medical garment of FIG. 1. FIG. 5 is a right side view of the unilateral medical garment of FIG. 1. FIG. 6 is a top view of the unilateral medical garment of FIG. 1. FIG. 7 is a bottom view of the unilateral medical garment of FIG. 1. FIG. 8 is a front perspective view of the unilateral medical garment of FIG. 1 on a human model; and, FIG. 9 is a rear perspective view of the unilateral medical garment of FIG. 1 on a human model. The broken lines on the garment represent seam lines and are for illustrative purposes only. All other broken lines are directed to the environment (i.e., the human model in FIGS. 8 and 9). 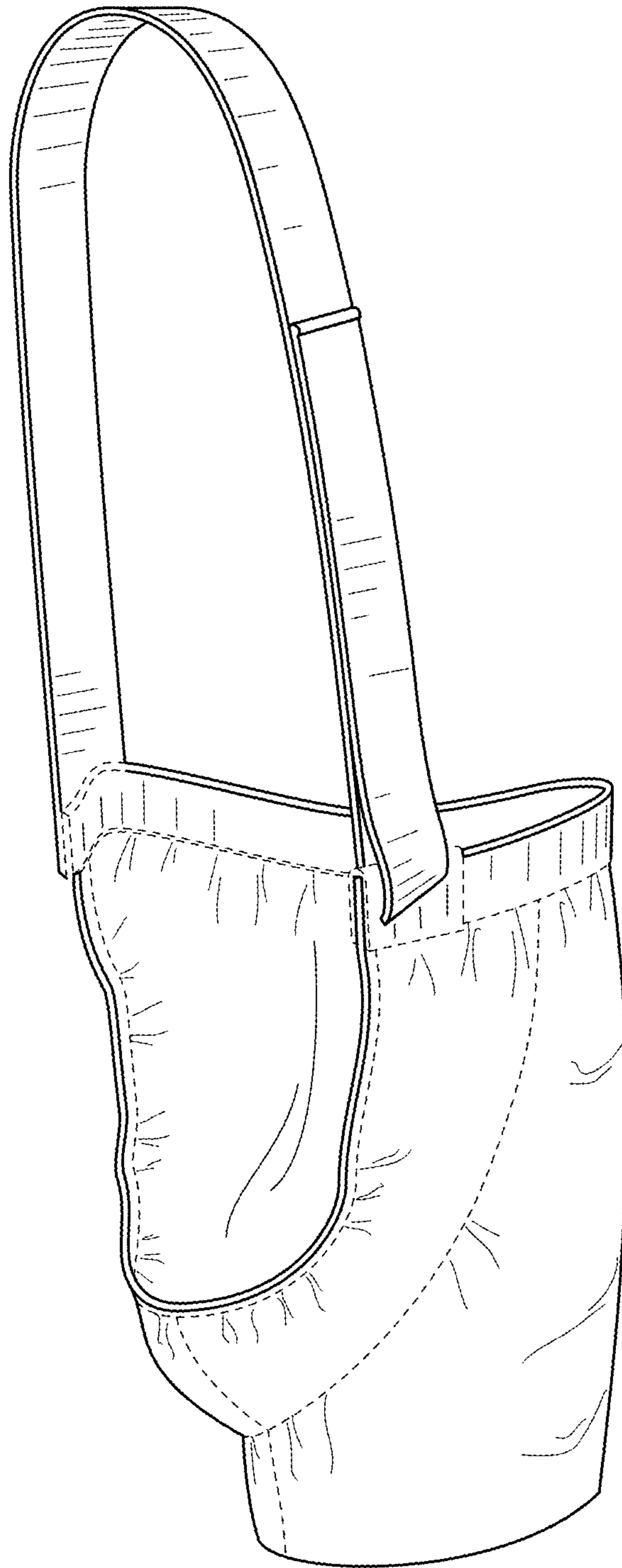

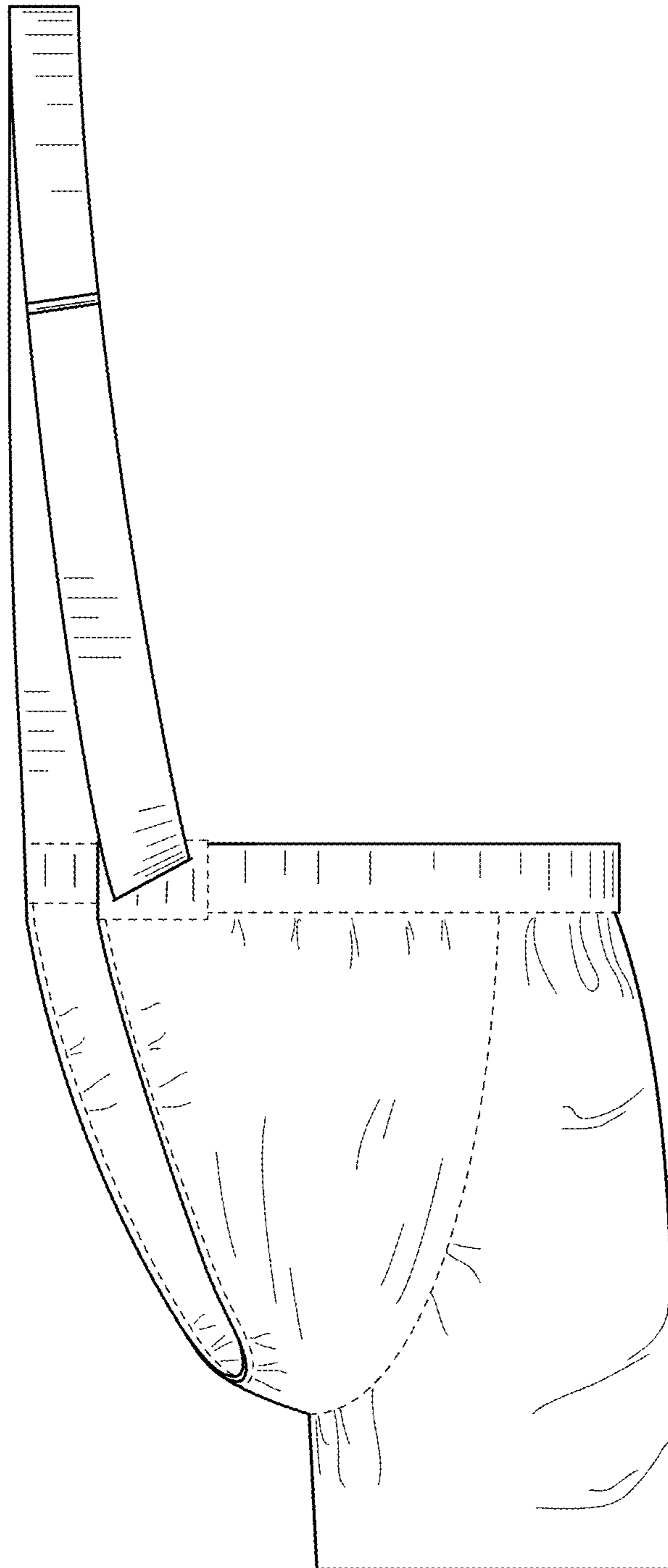

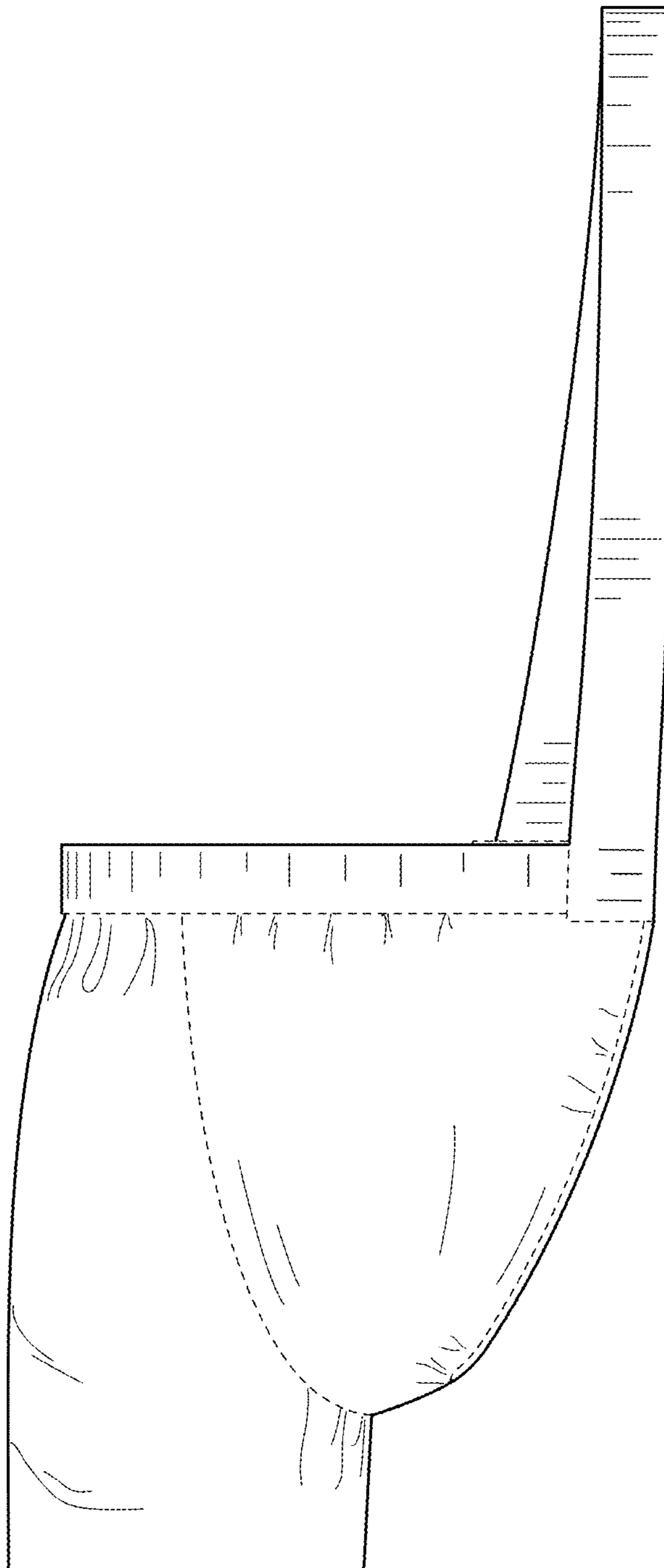

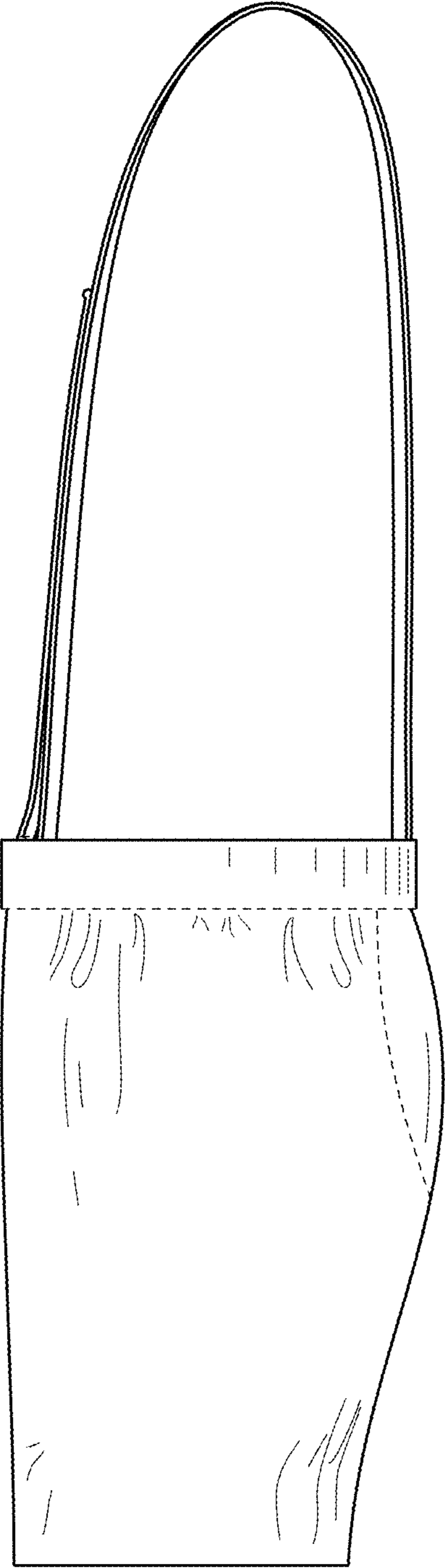

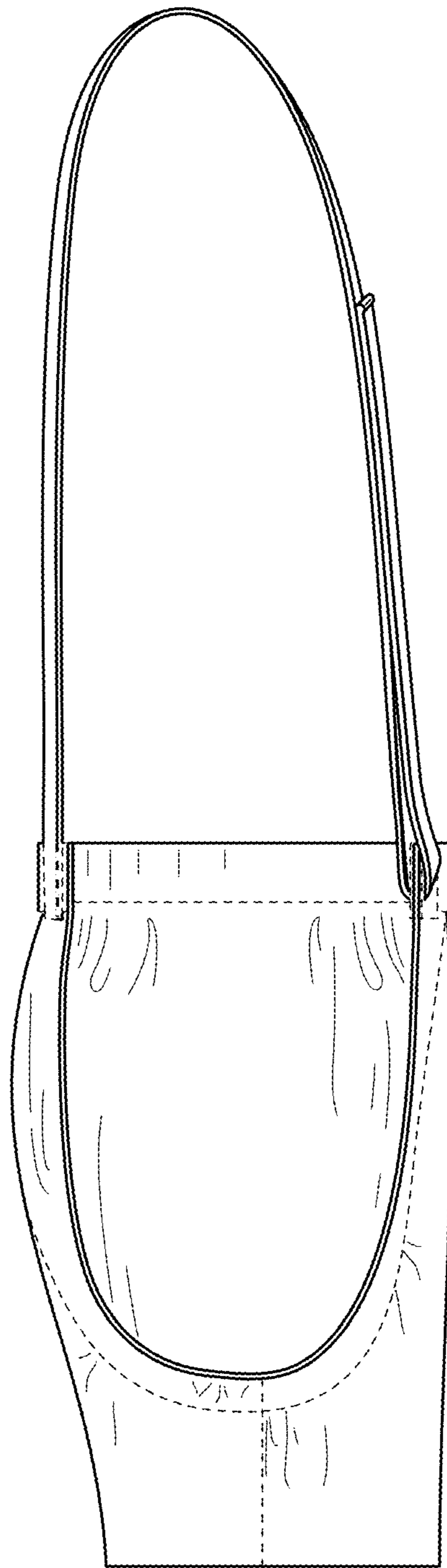

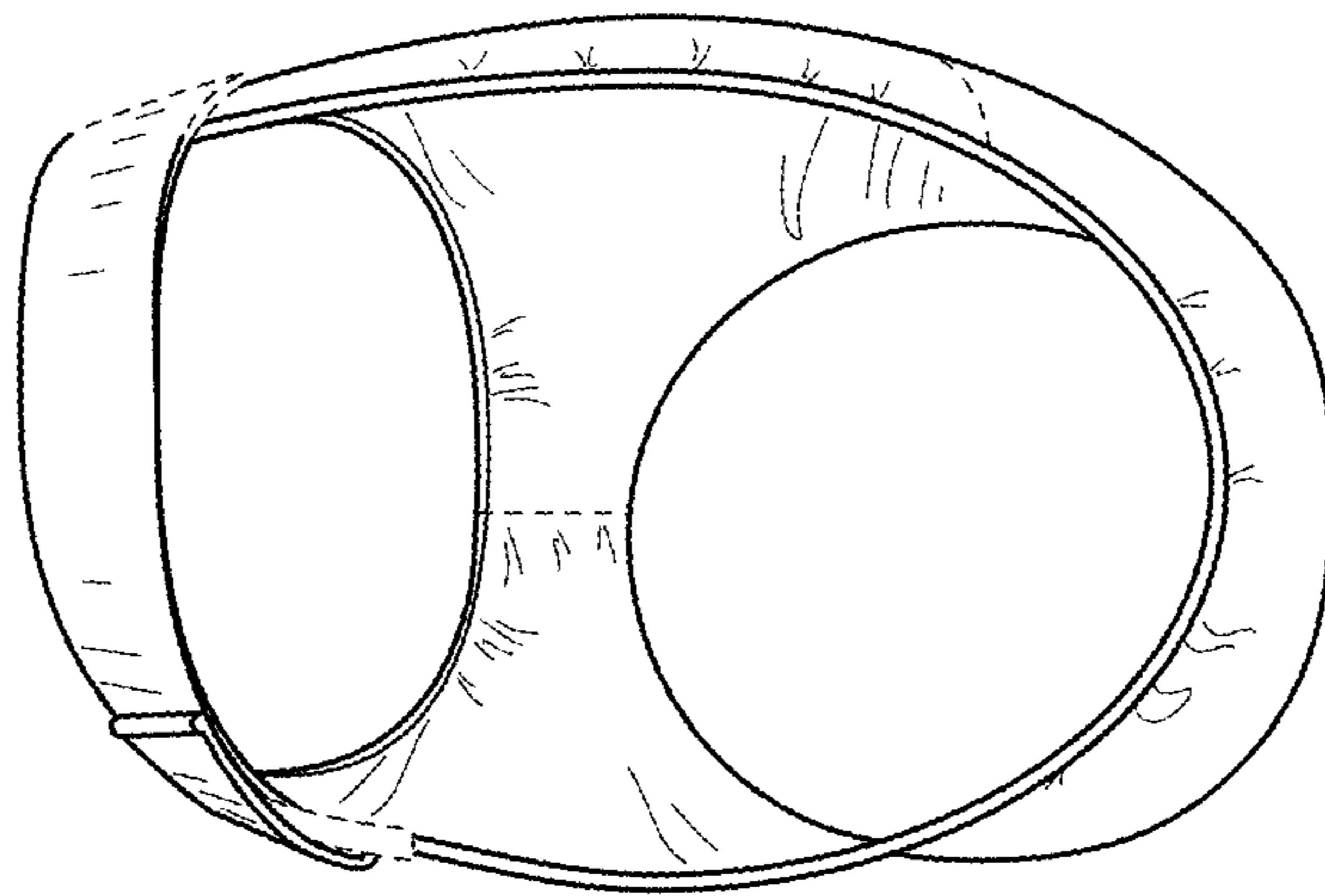

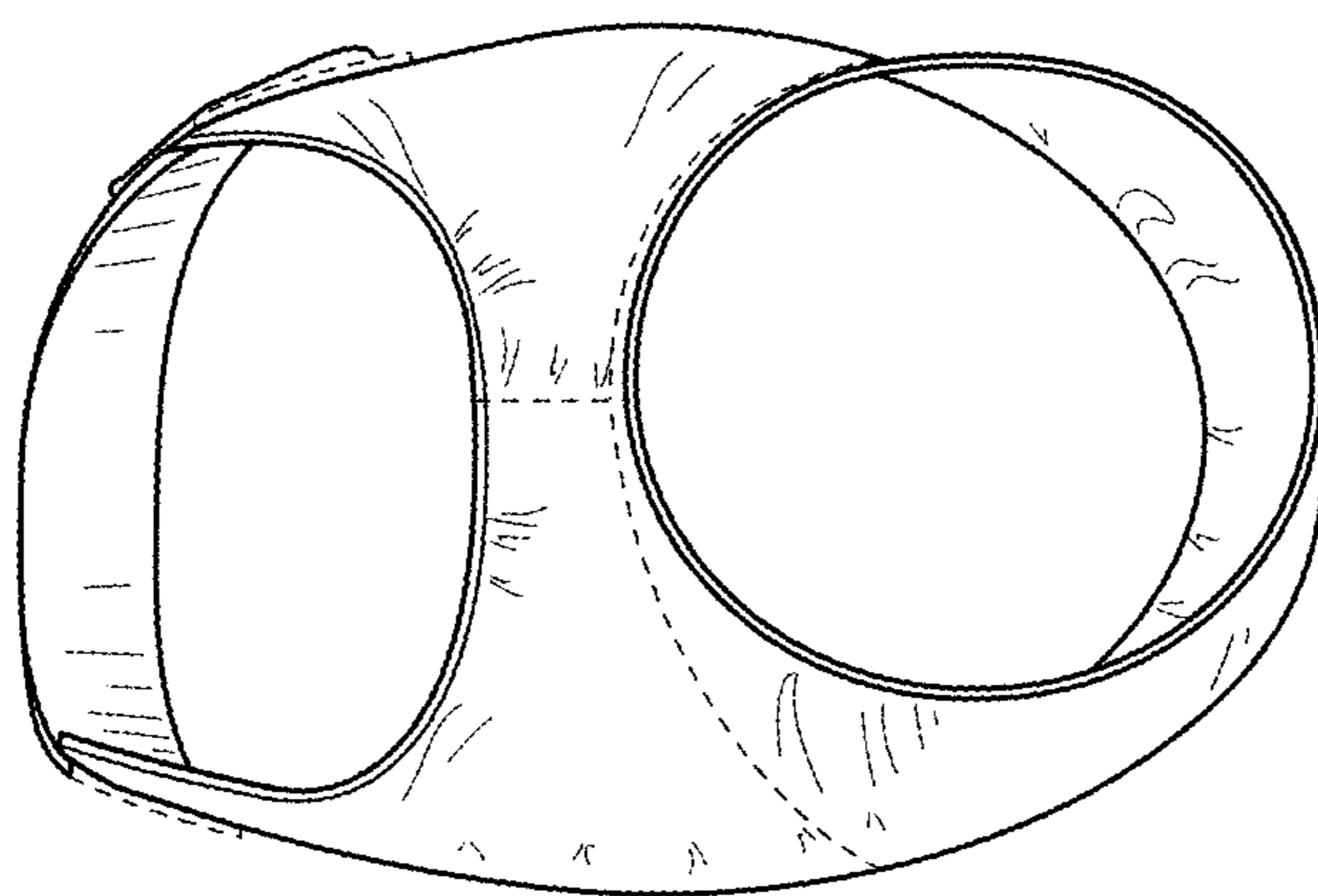

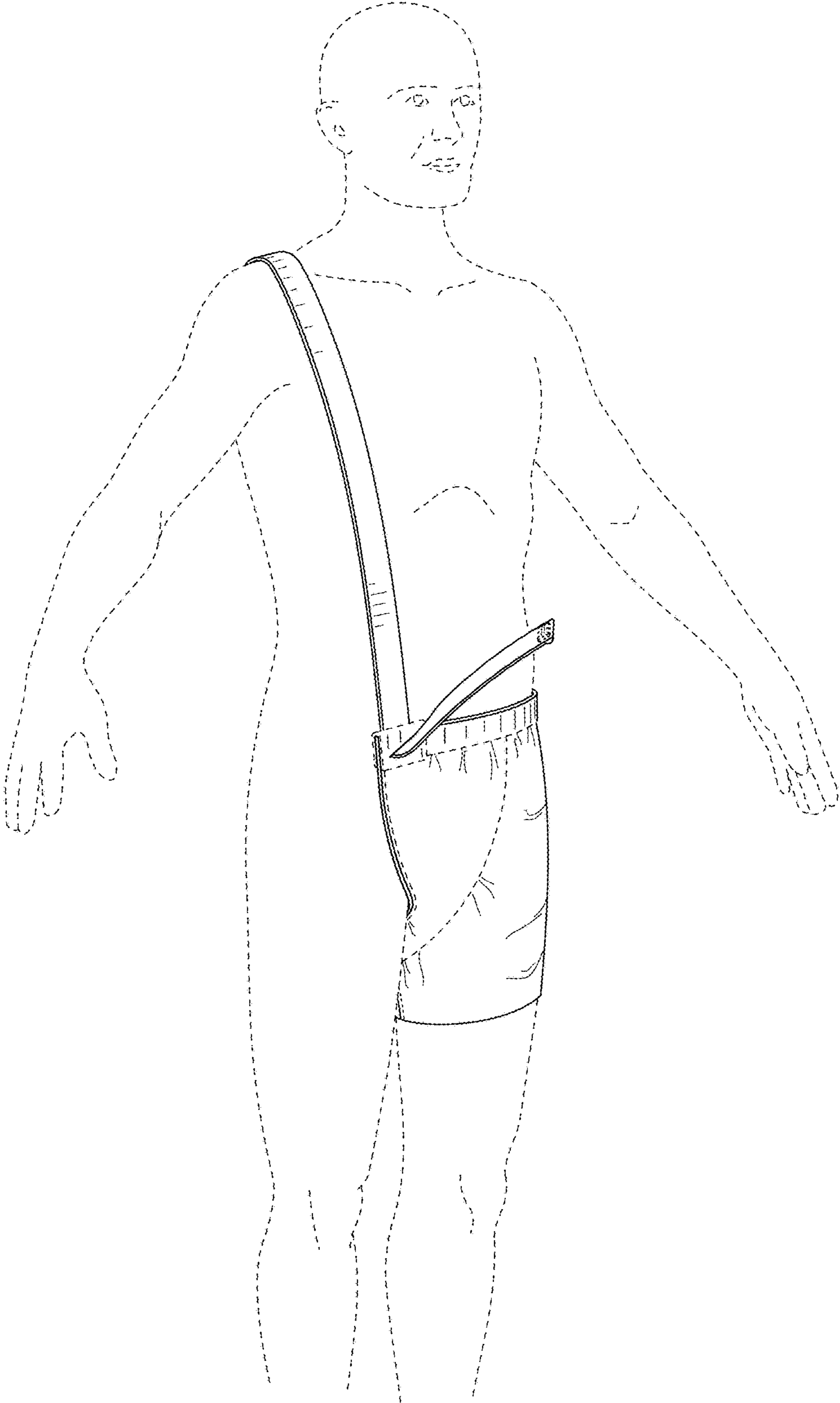

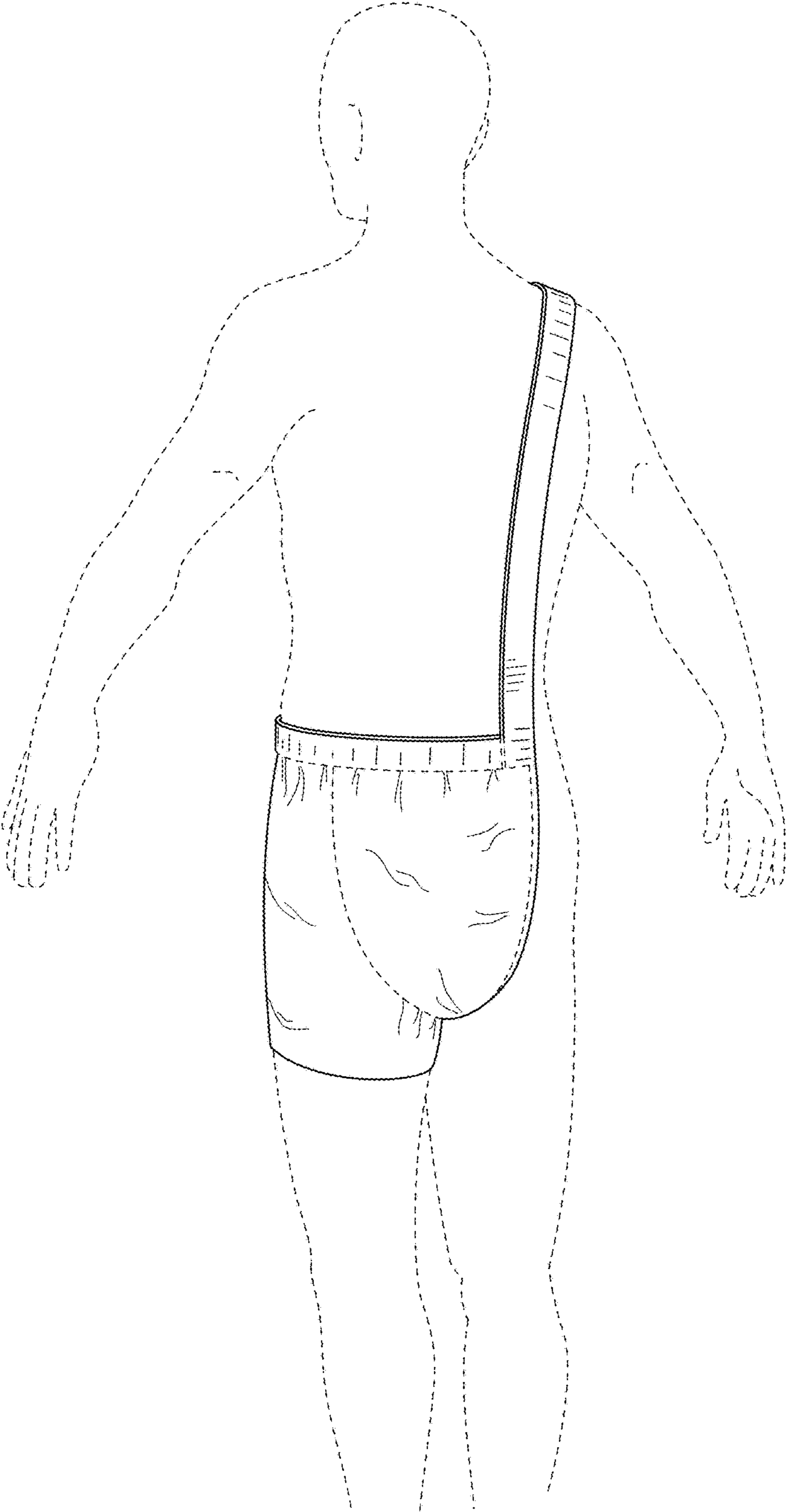
