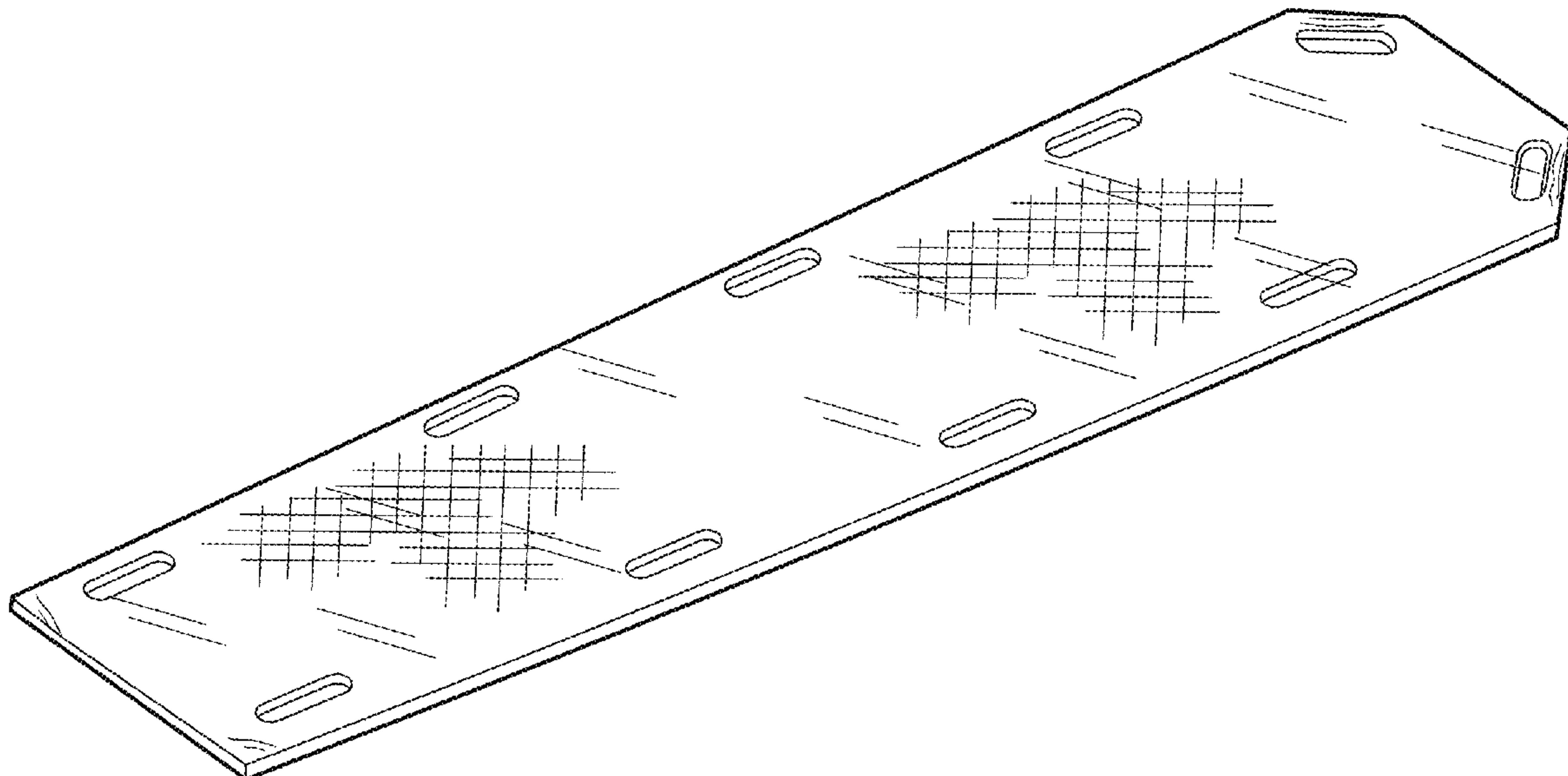
The ornamental design for a spineboard with cover, as shown and described.

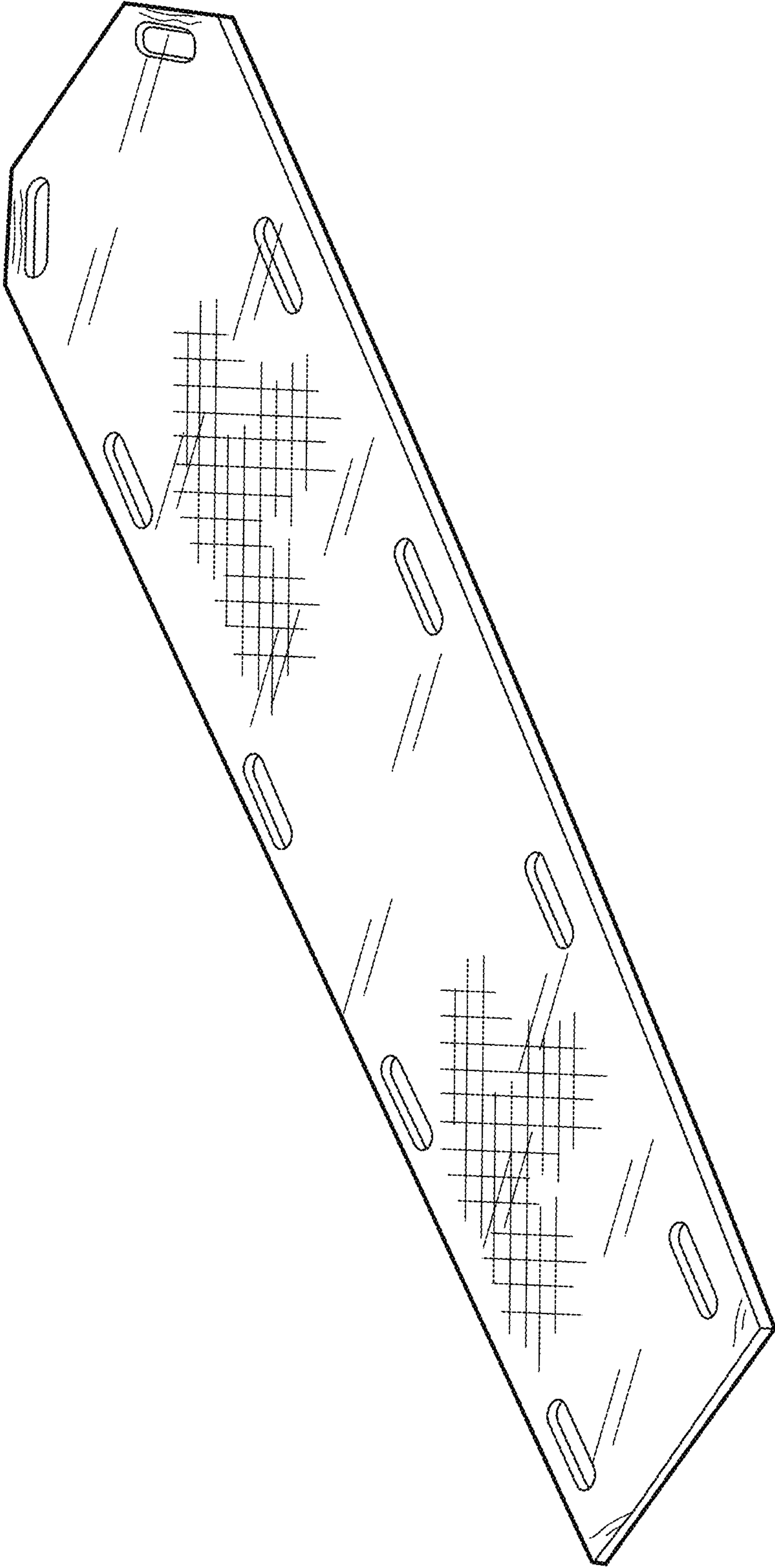

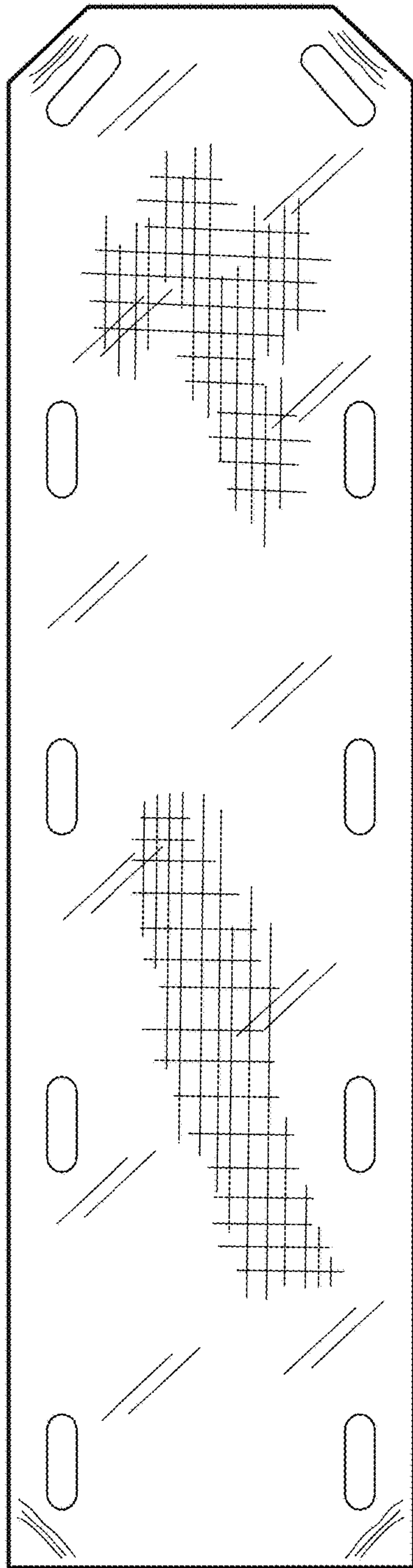

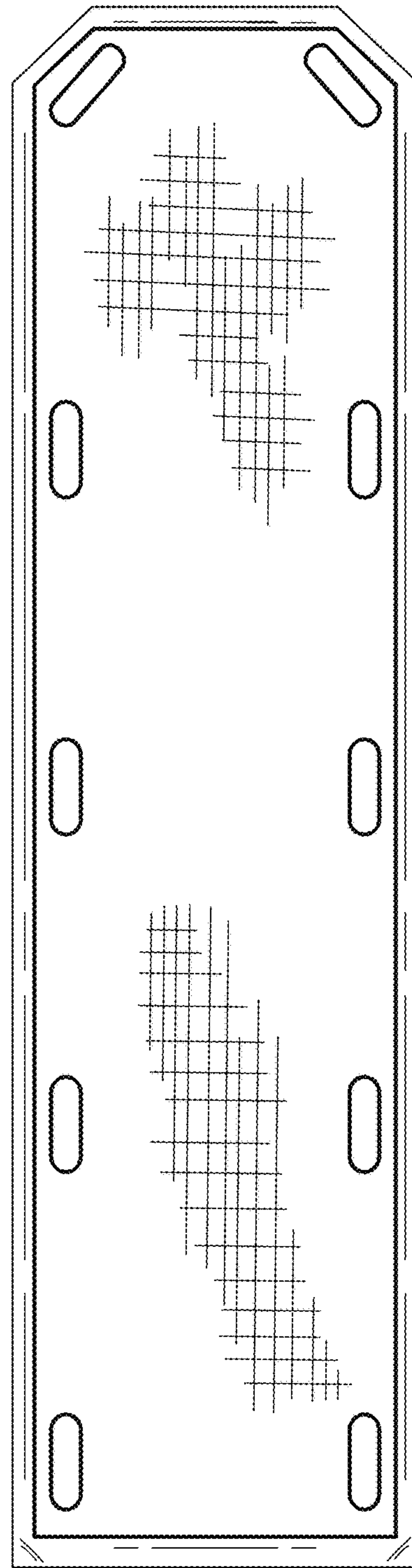

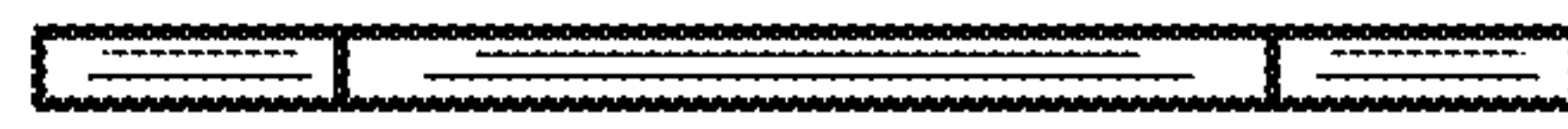

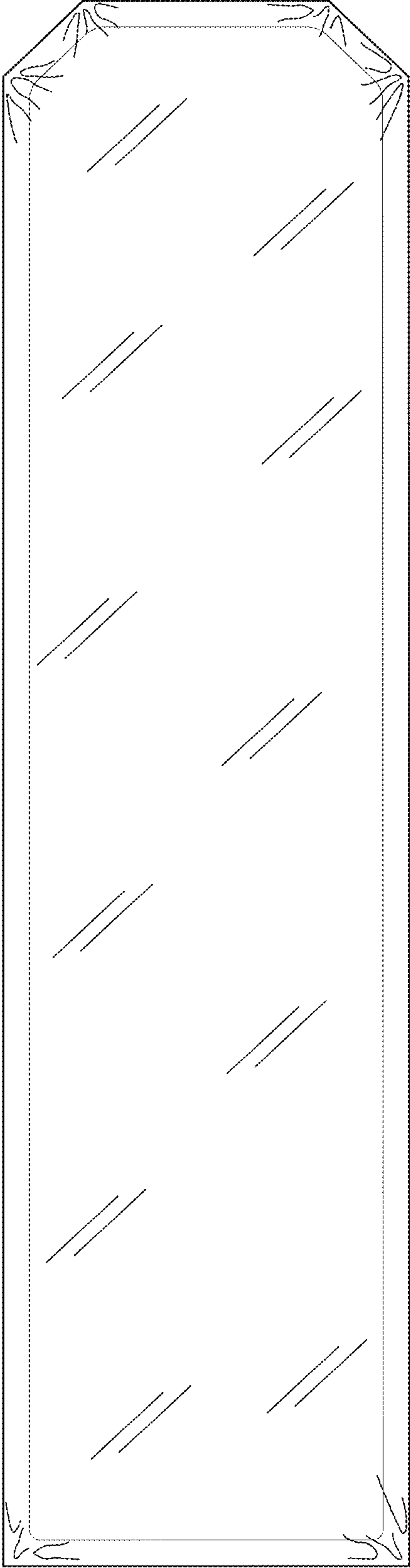
