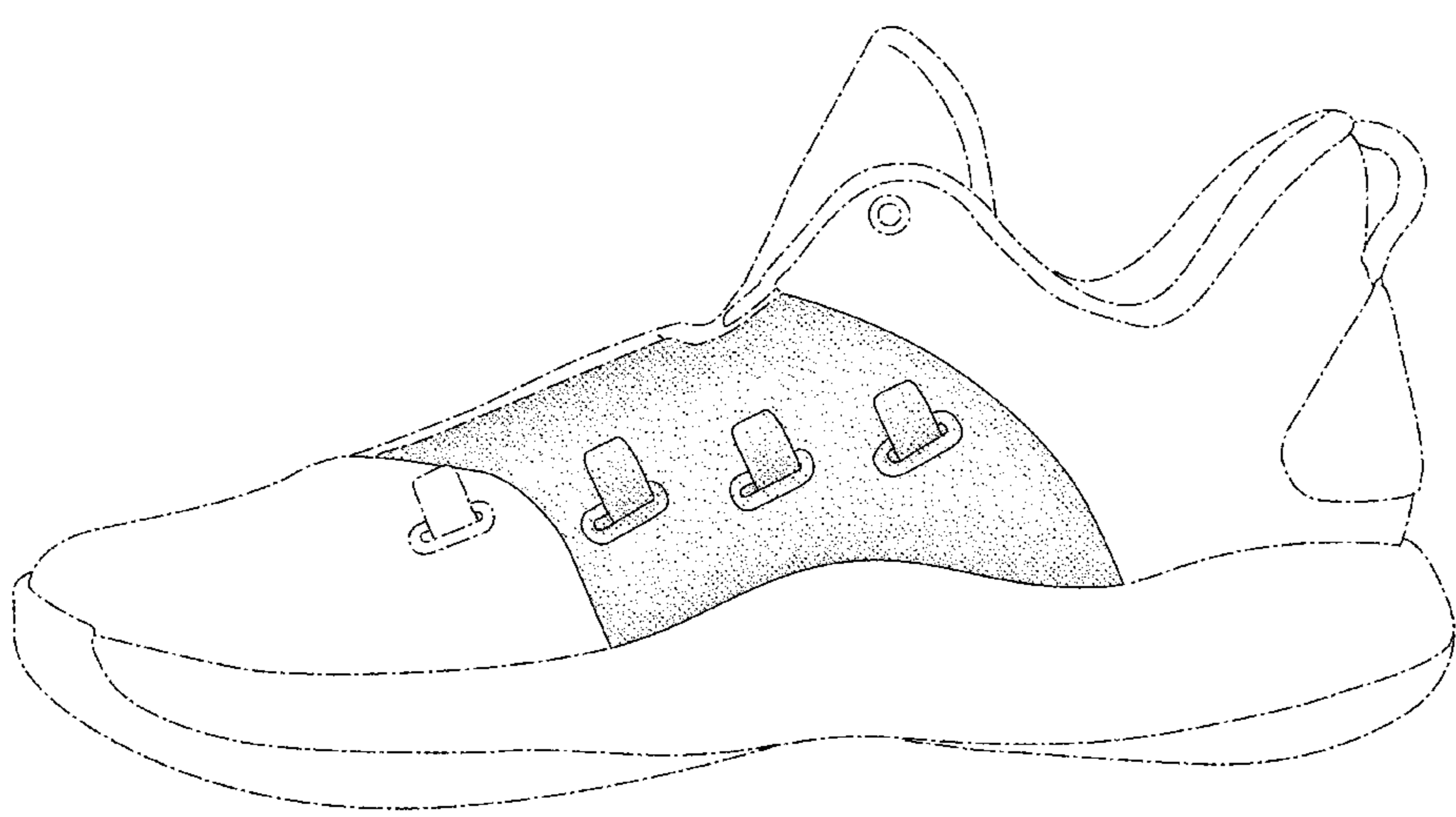

DESCRIPTION

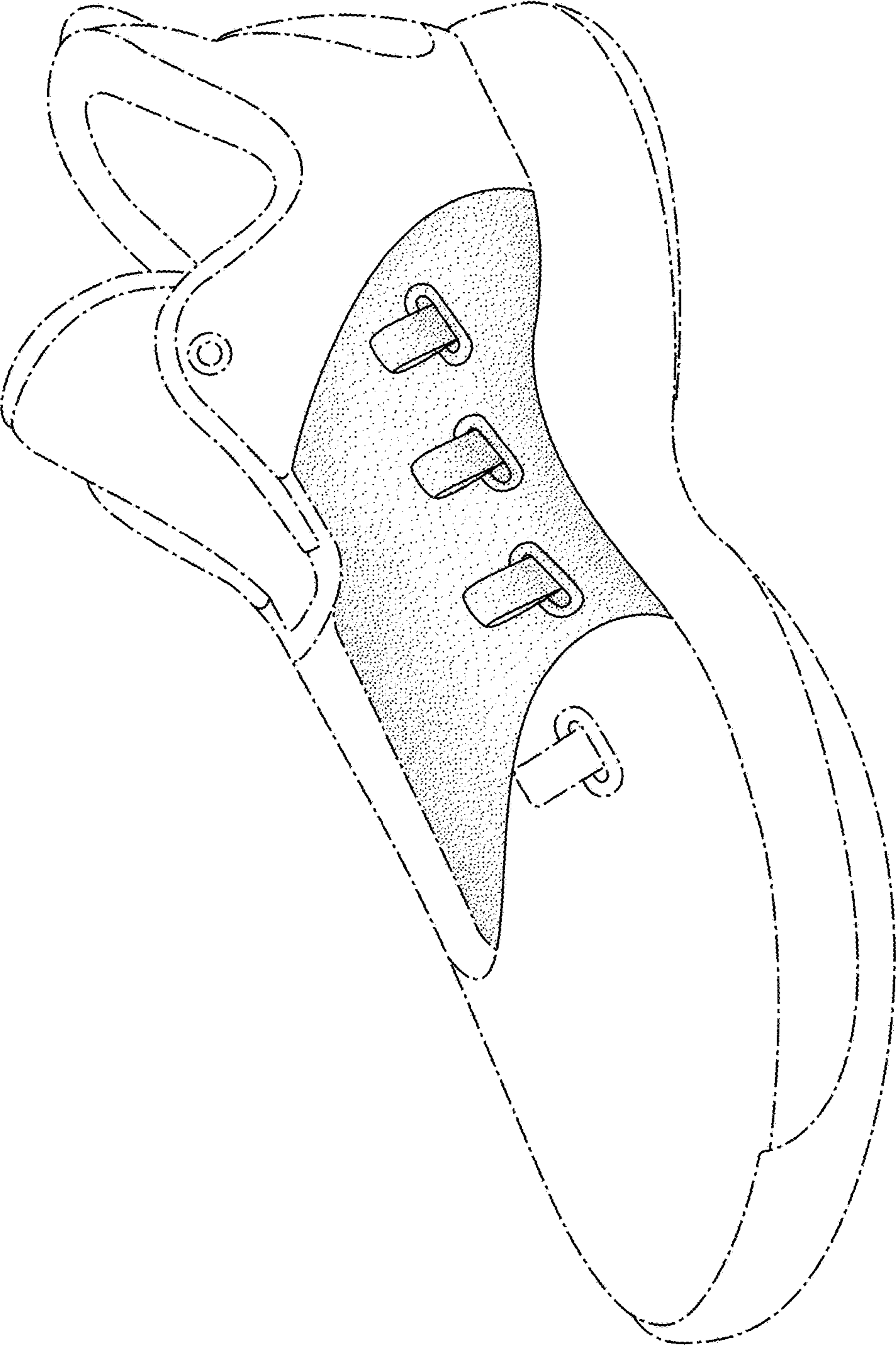

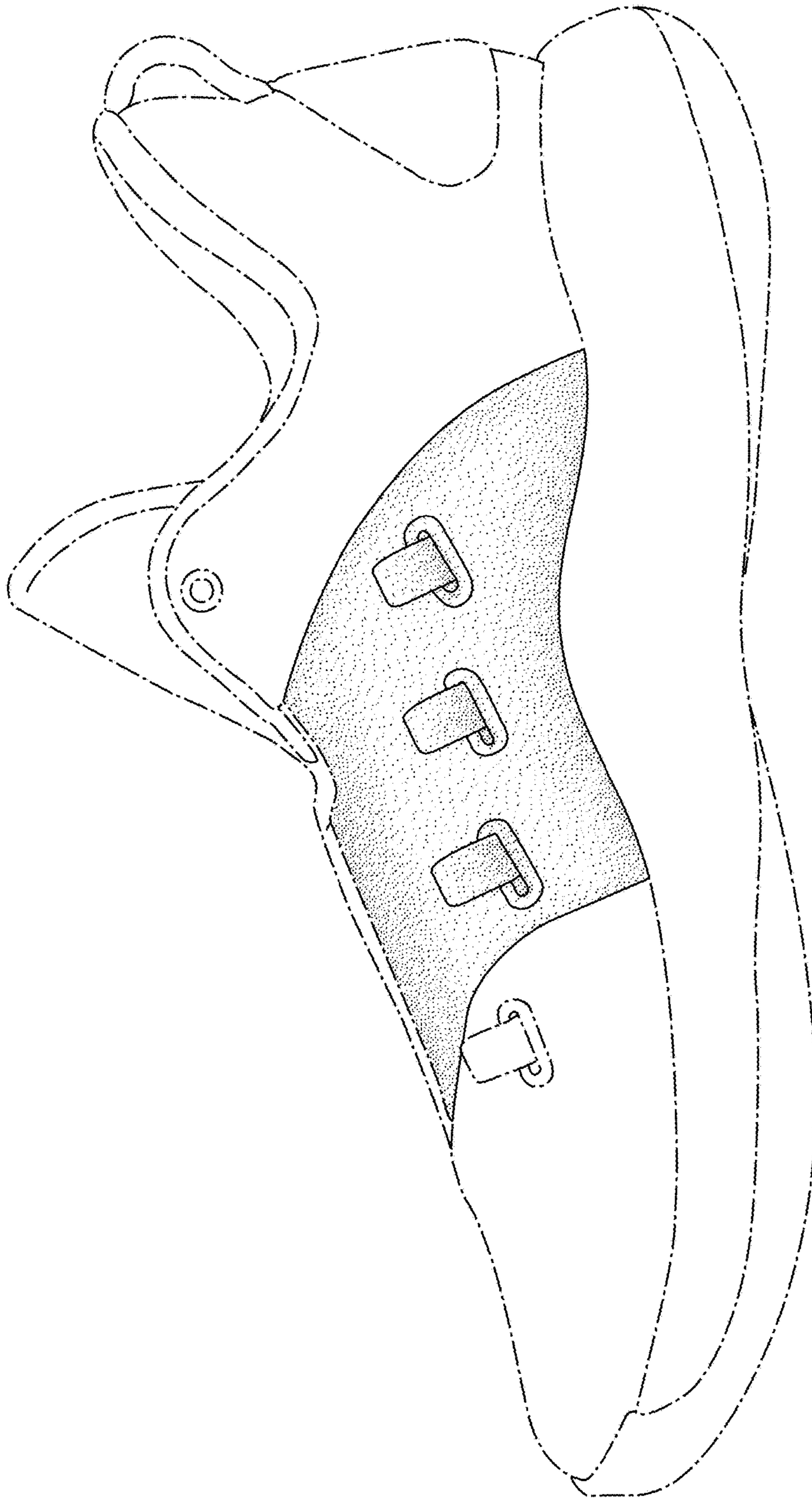

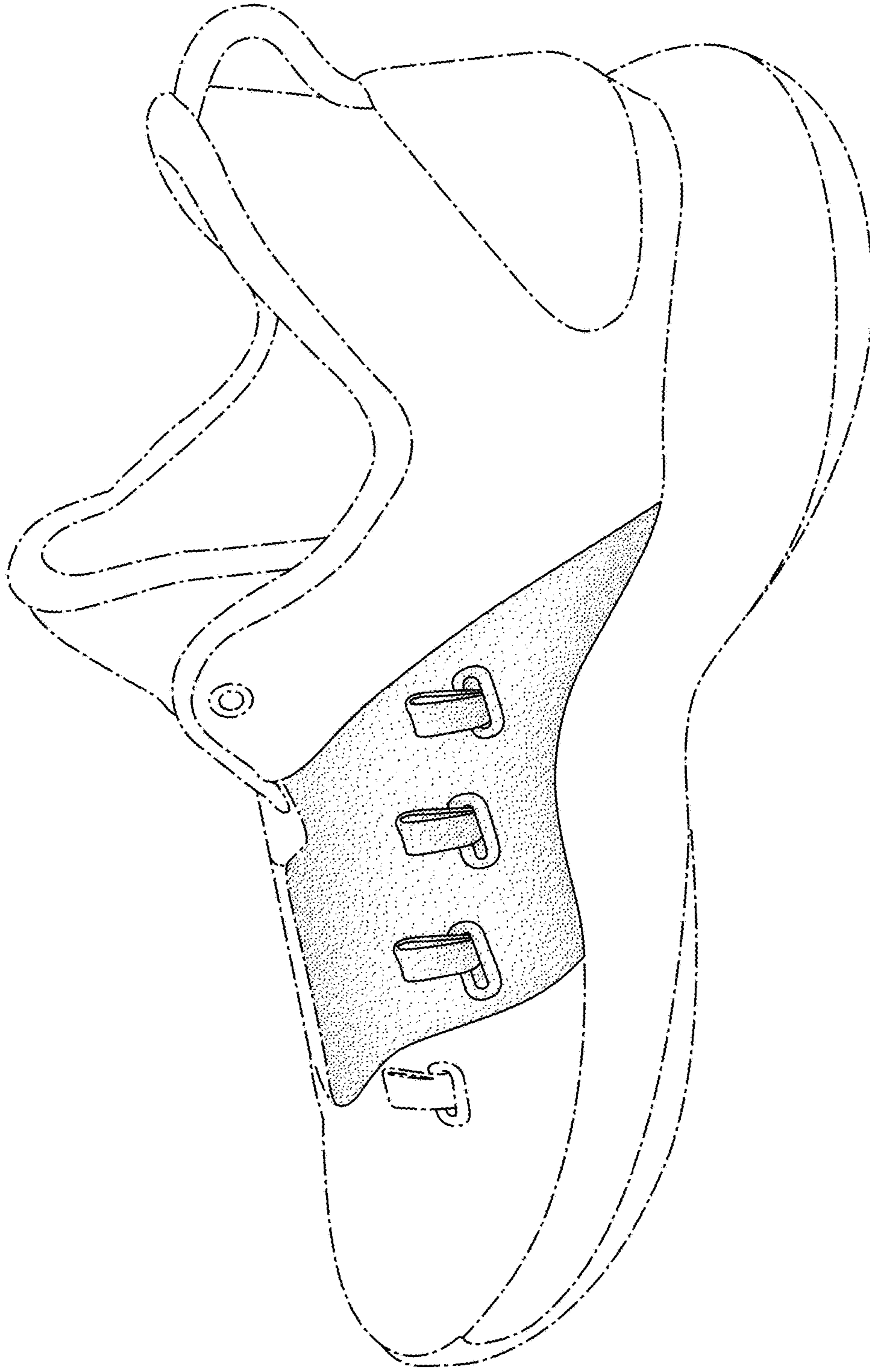
