1.6 is a top view thereof; and

1.7 is a bottom view thereof.

The dotted lines represent stitching, and form part of the claimed design. The two dot-dash-dot lines in view **1.7** between the front and the back of the bag extending perpendicularly across from the front side to the back side of the bag represent the environment and form no part of the claimed design.

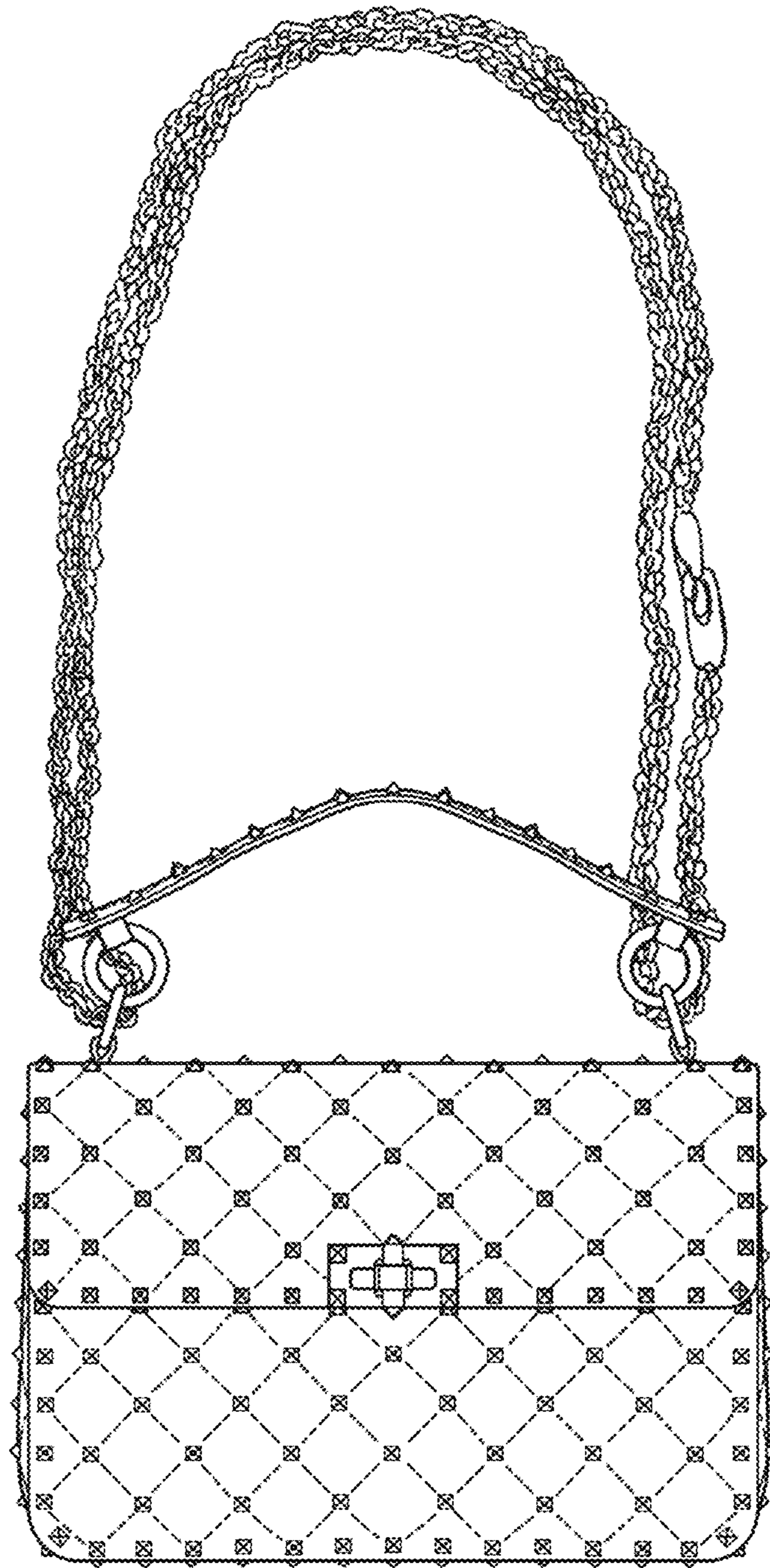

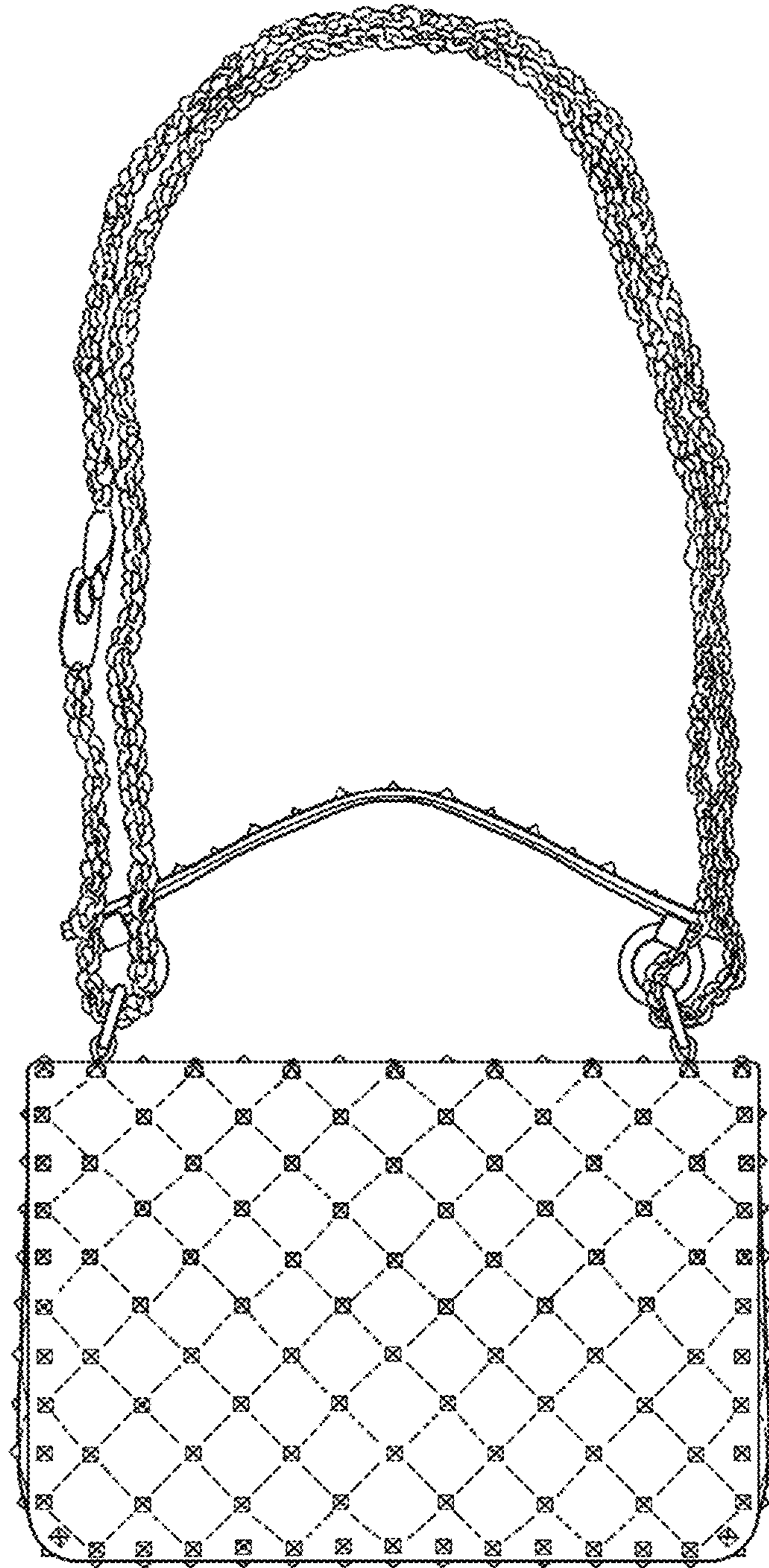

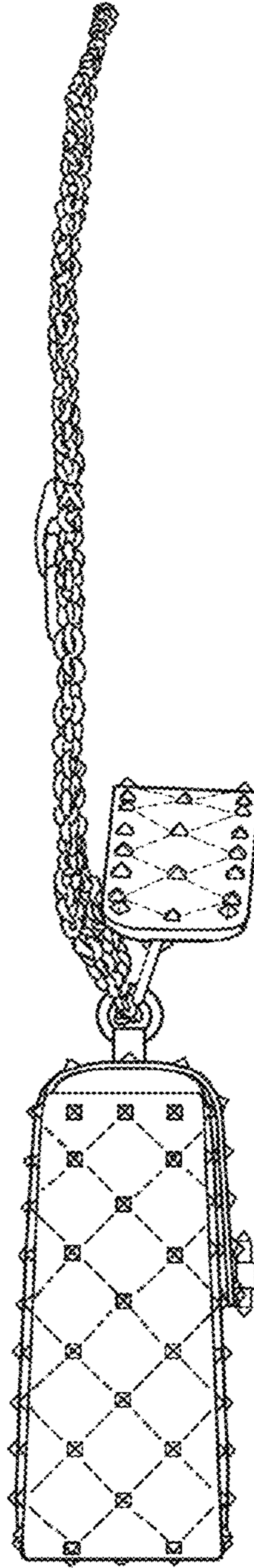

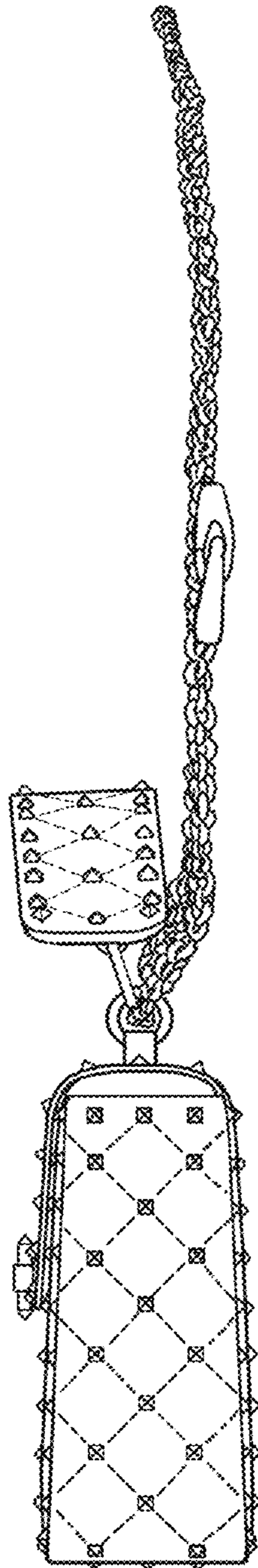

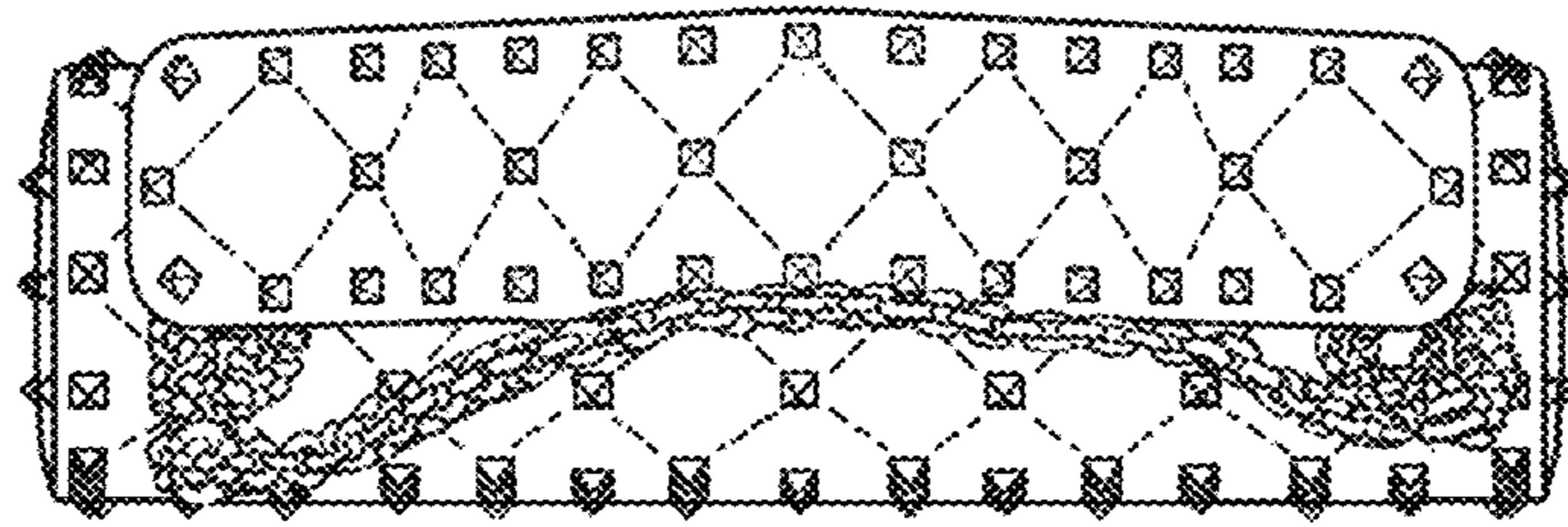
