(57) **CLAIM**

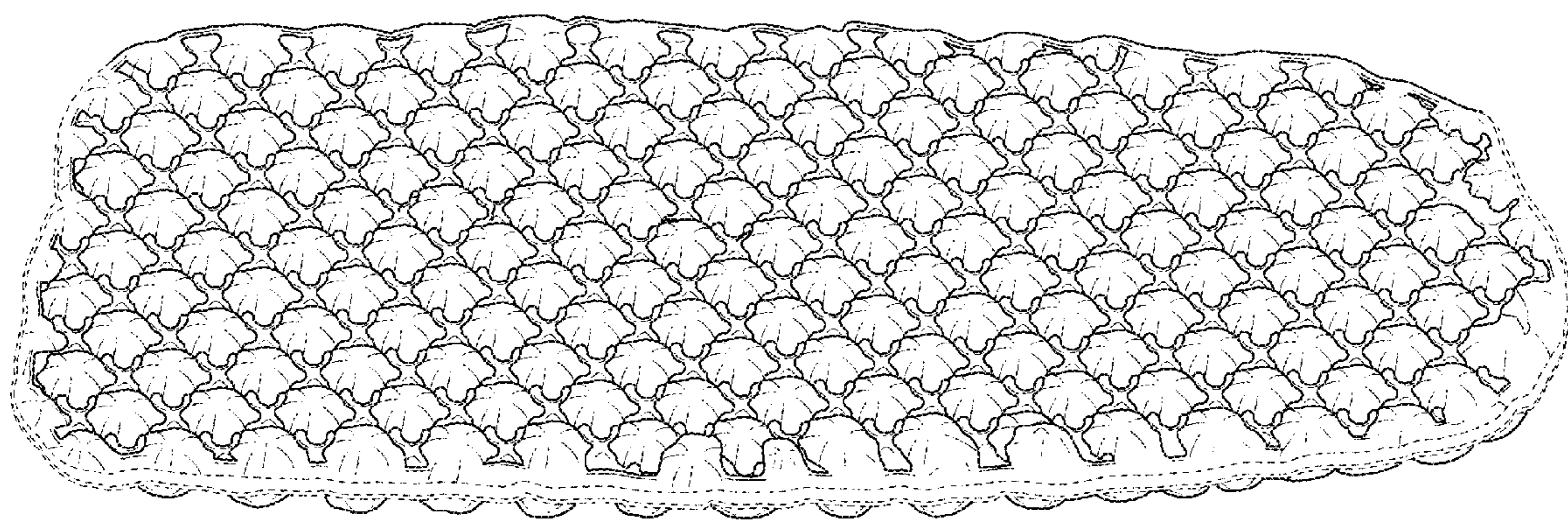
The ornamental design for an air sleeping pad, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of the air sleeping pad;  
FIG. 2 is a front view thereof;  
FIG. 3 is a back view thereof;  
FIG. 4 is a left-side view thereof;  
FIG. 5 is a right-side view thereof;  
FIG. 6 is a top view thereof; and,  
FIG. 7 is a bottom view thereof.  
Shade lines of varying lengths are used in the figures. Each shade line is a solid line terminating with a white space followed by a dot or a short dash. The shade lines are only for the illustrative purpose of showing shading and form no part of the claimed design.  
The dash-only broken lines used in the figures depicting the sidewall of the air sleeping pad are included for the purpose of illustrating unclaimed subject matter and form no part of the claimed design.

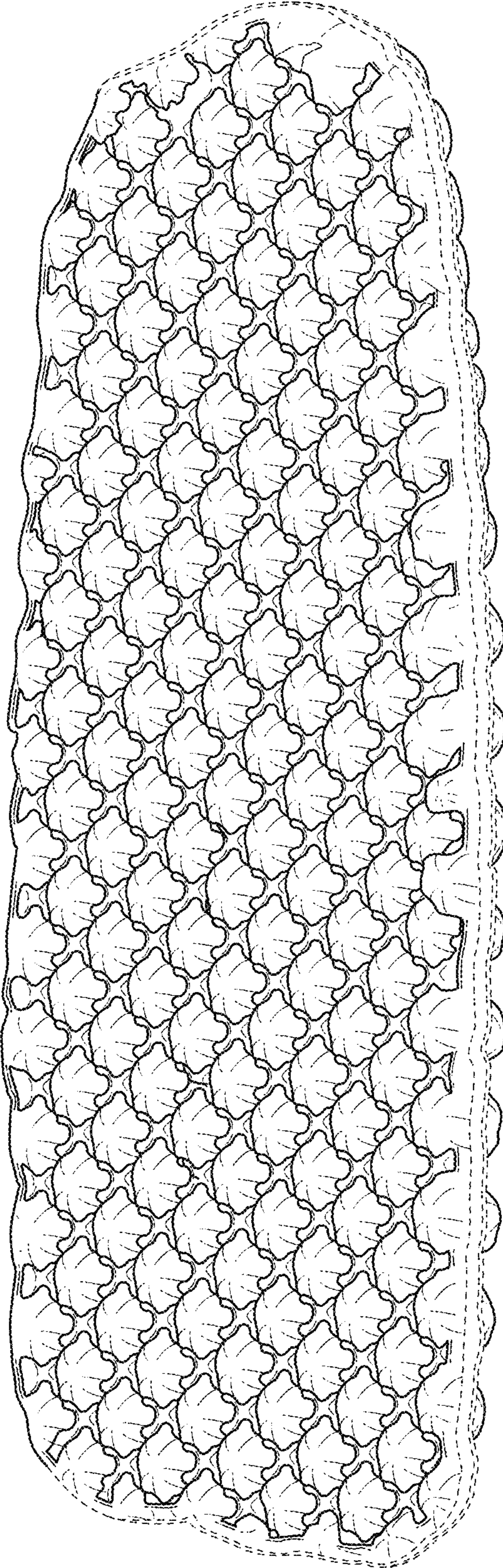

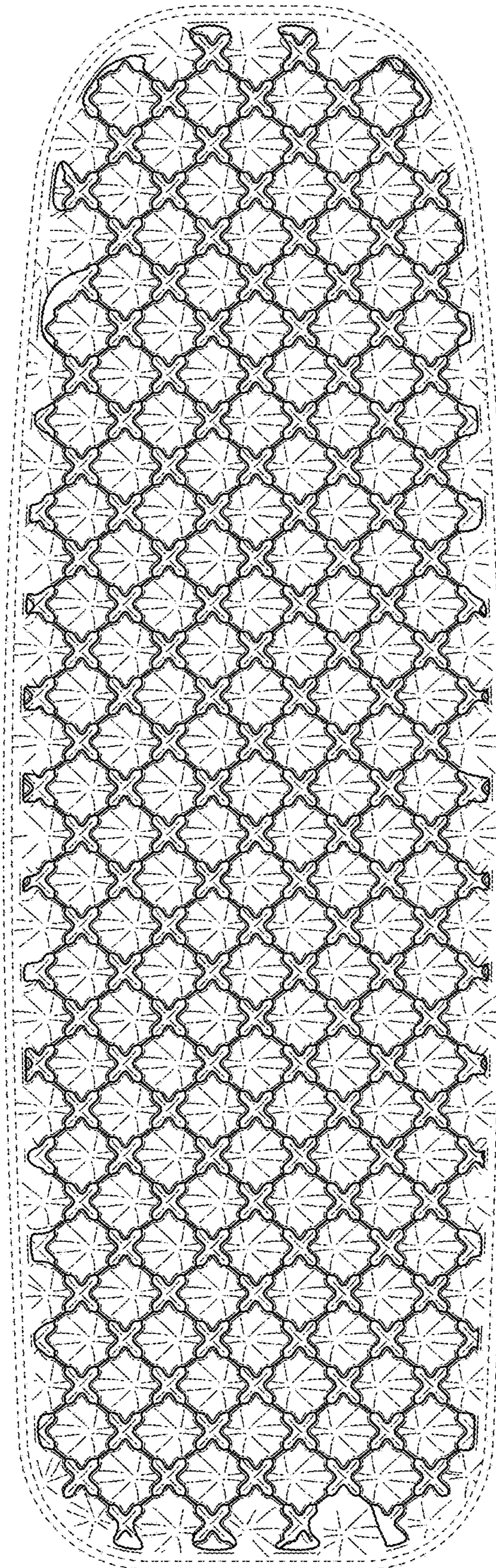

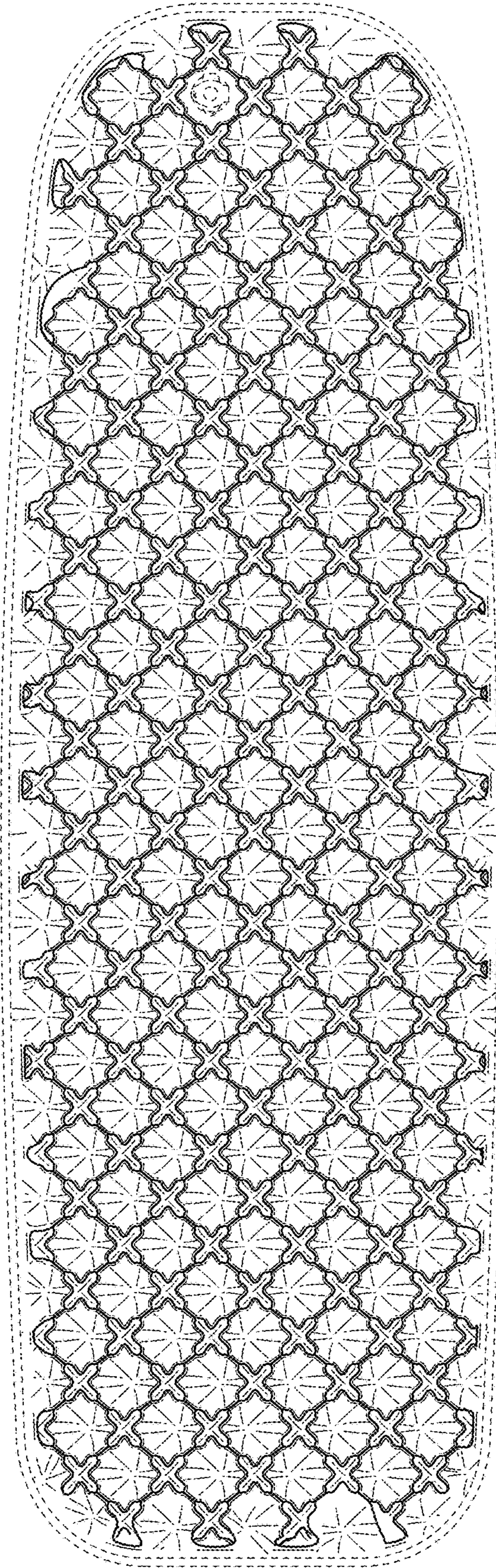
