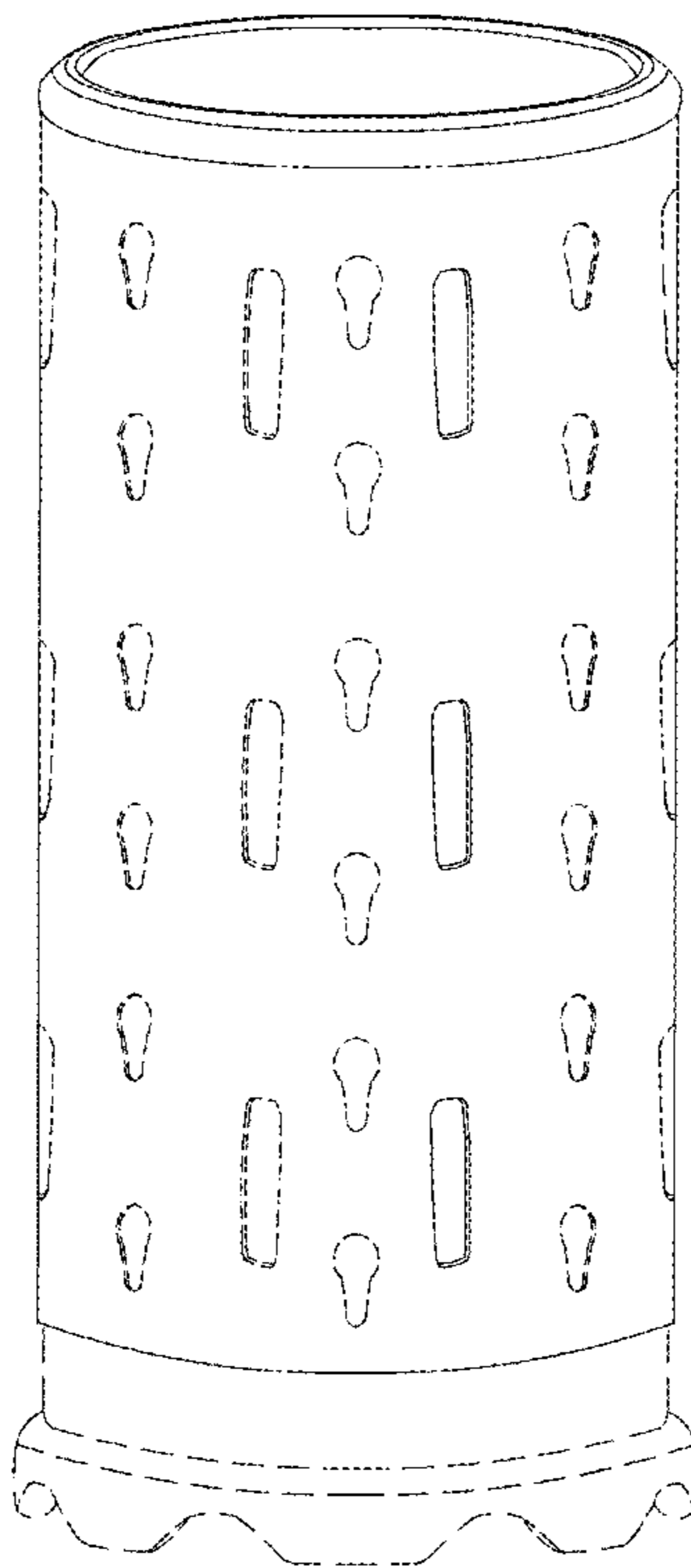
FIG. 1 is a perspective view of a drinking mug of the present invention;

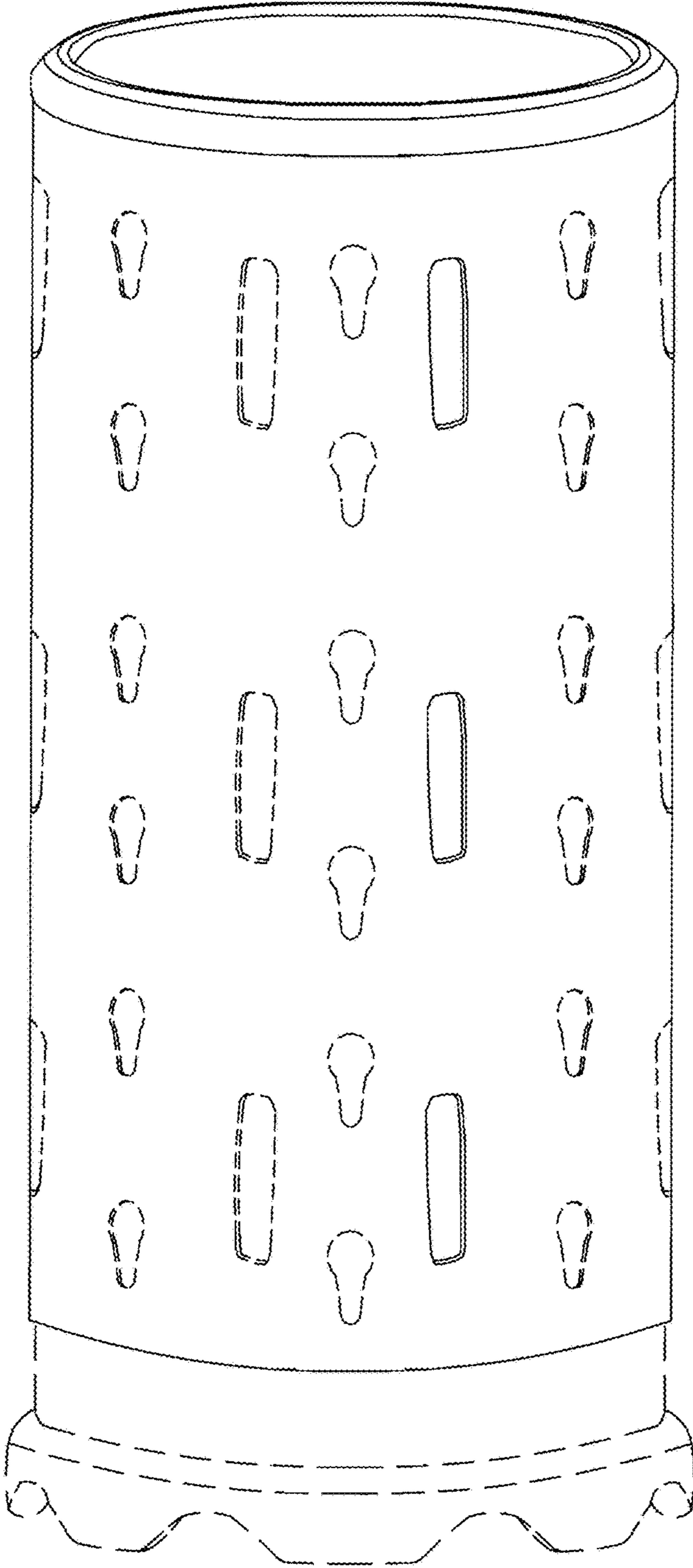

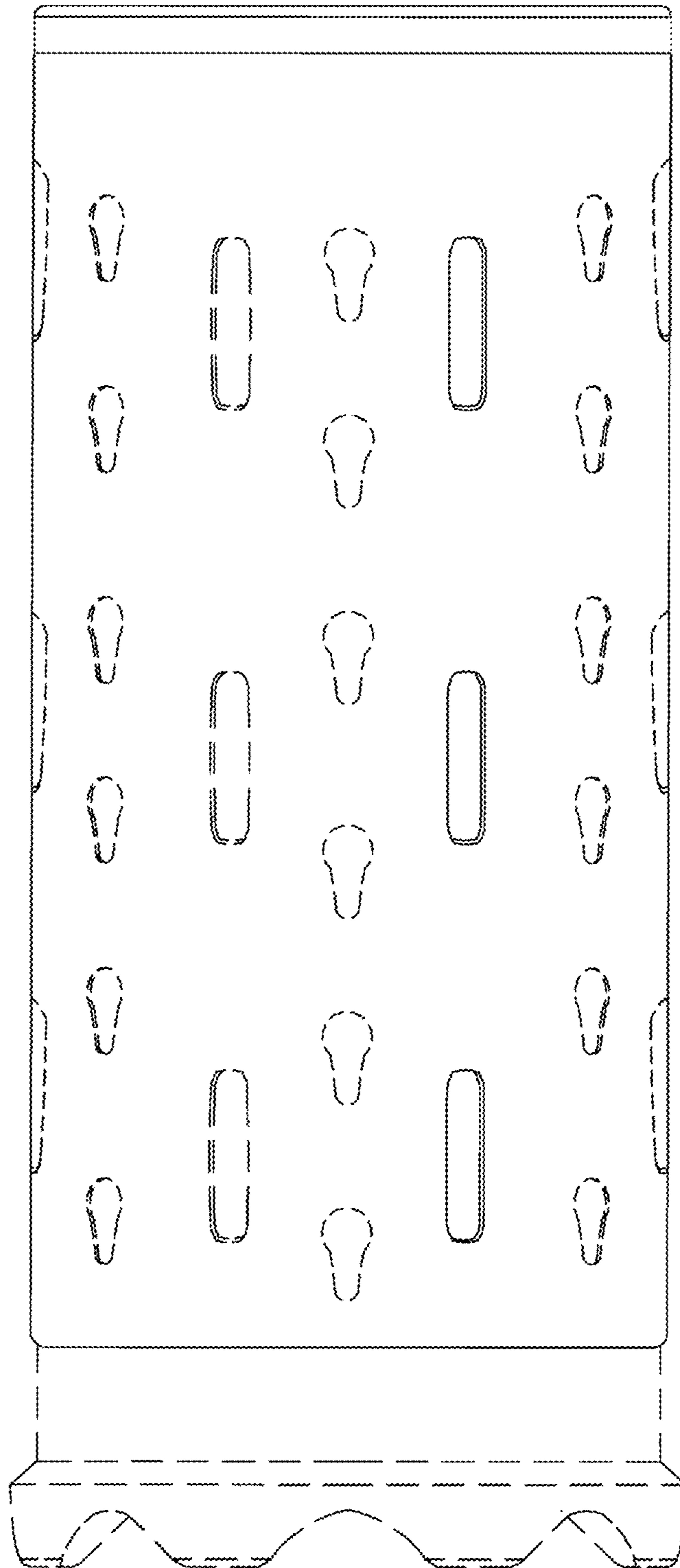

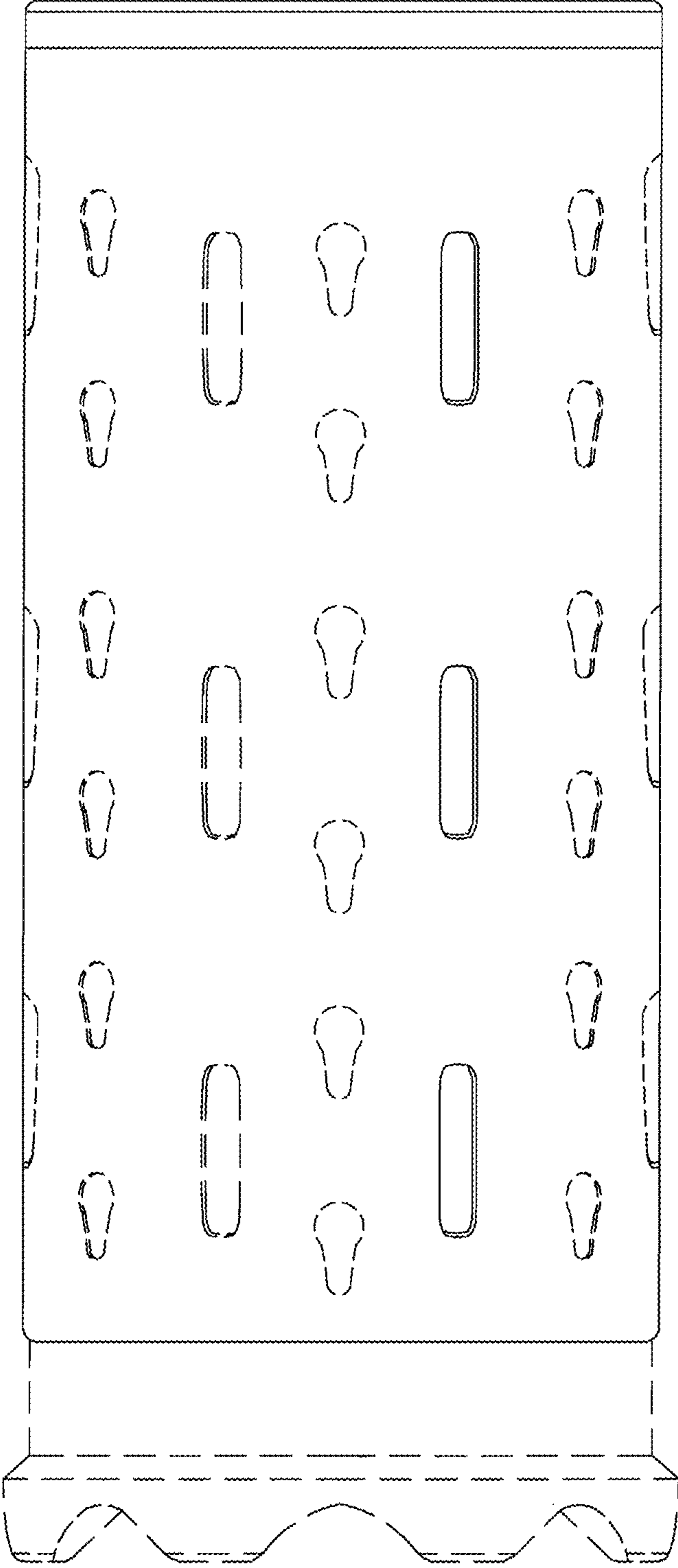

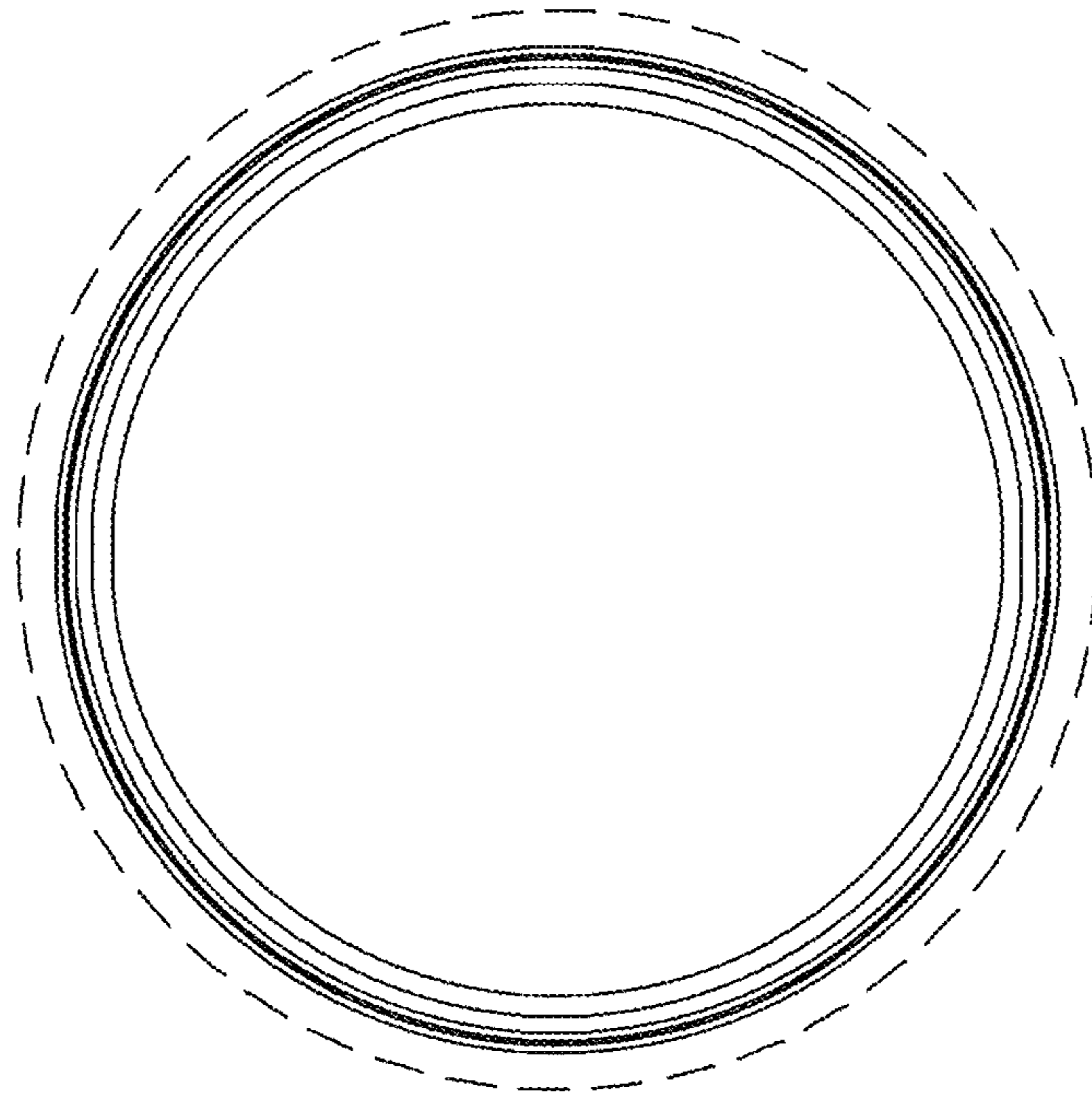

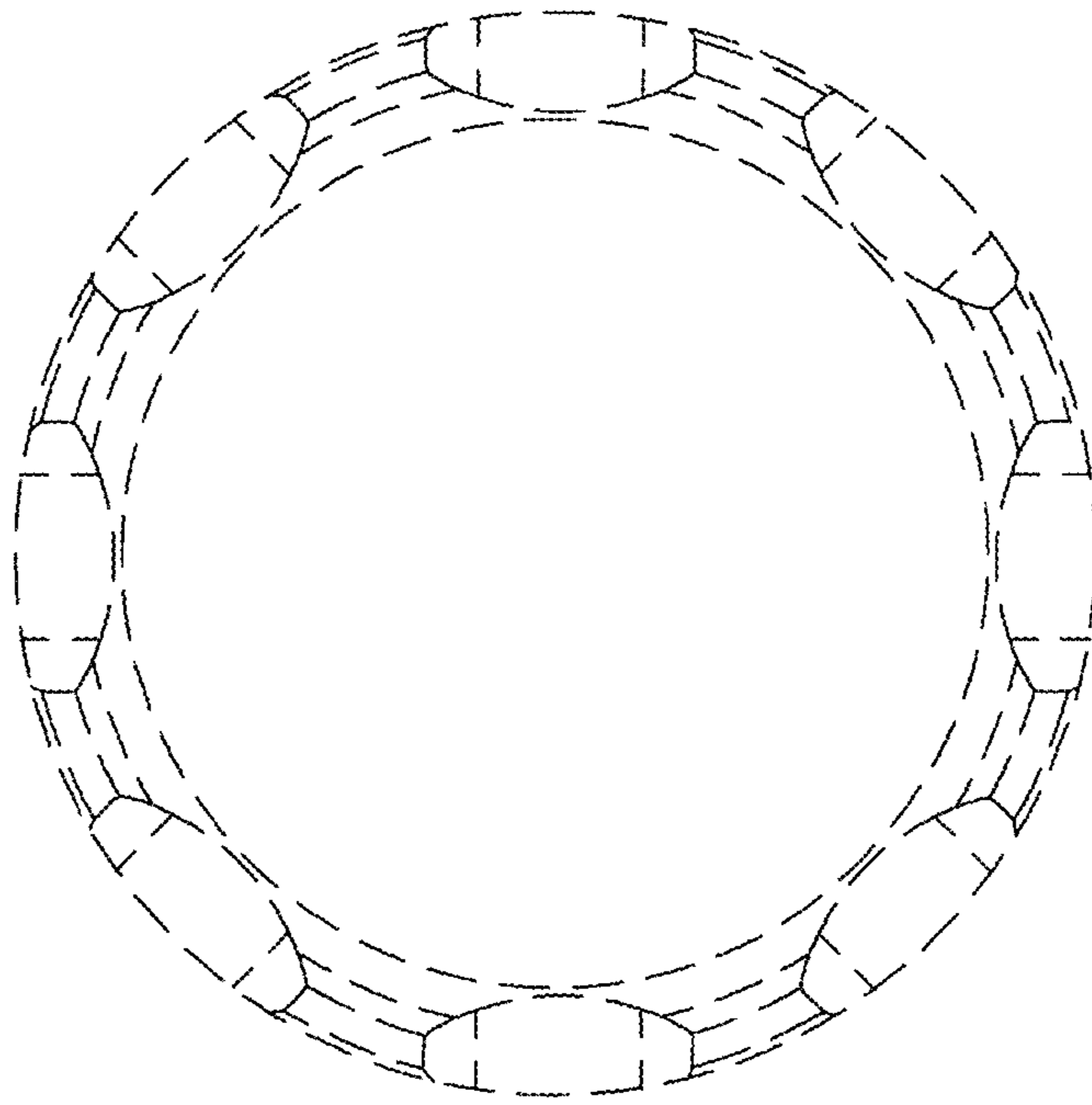

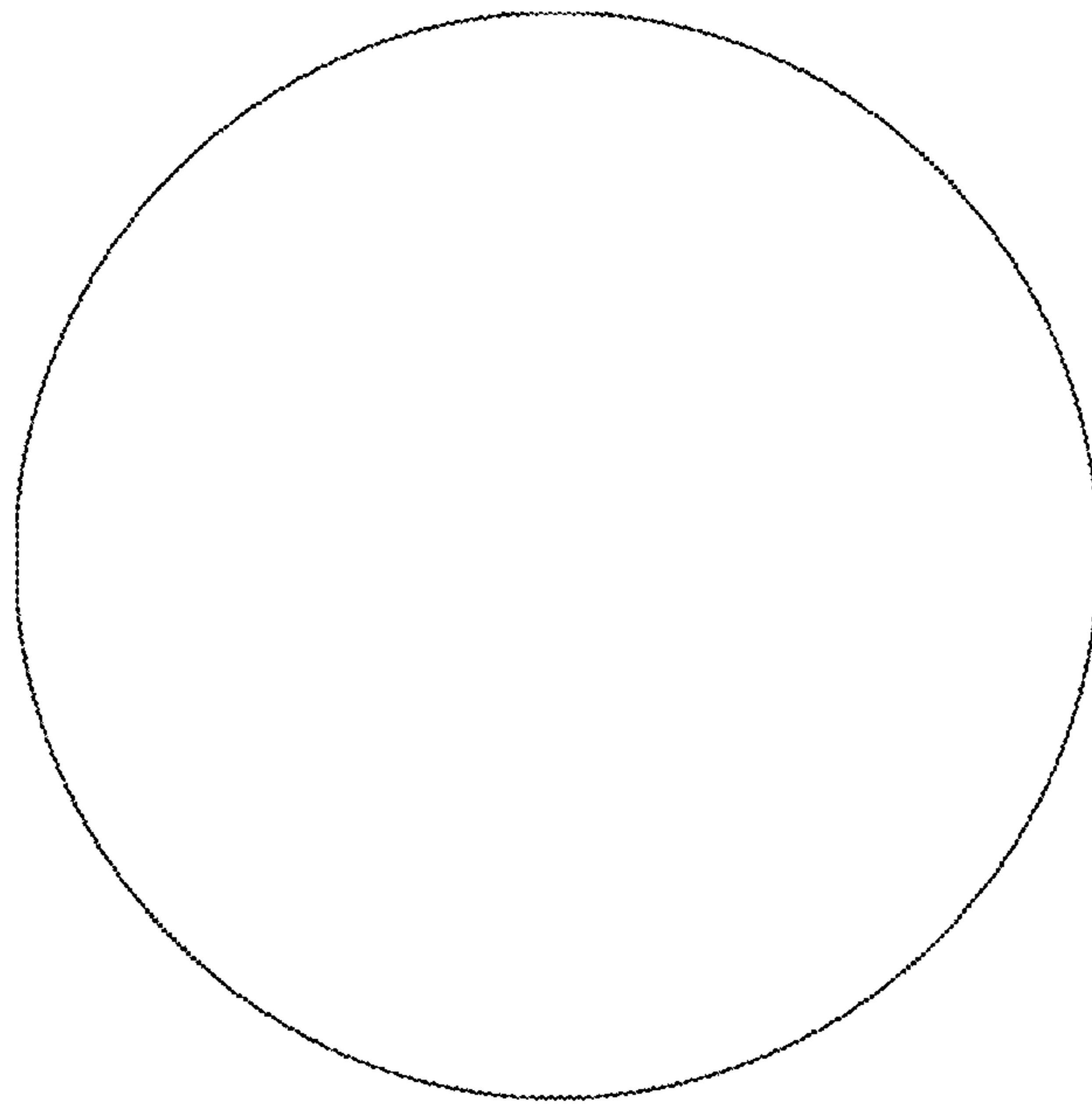

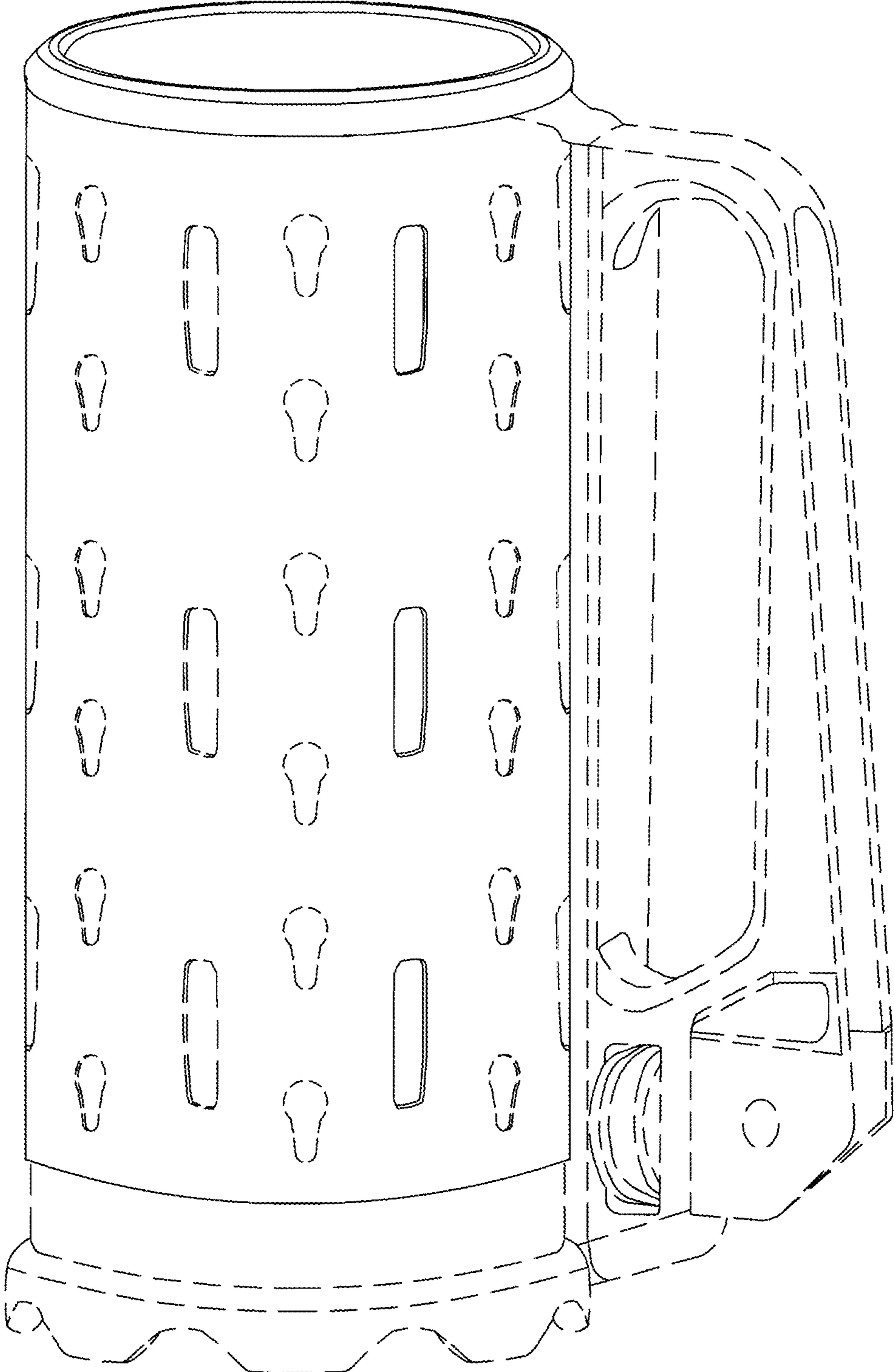
