FIG. 4 is a right side elevational view showing the design for the package of FIG. 1;

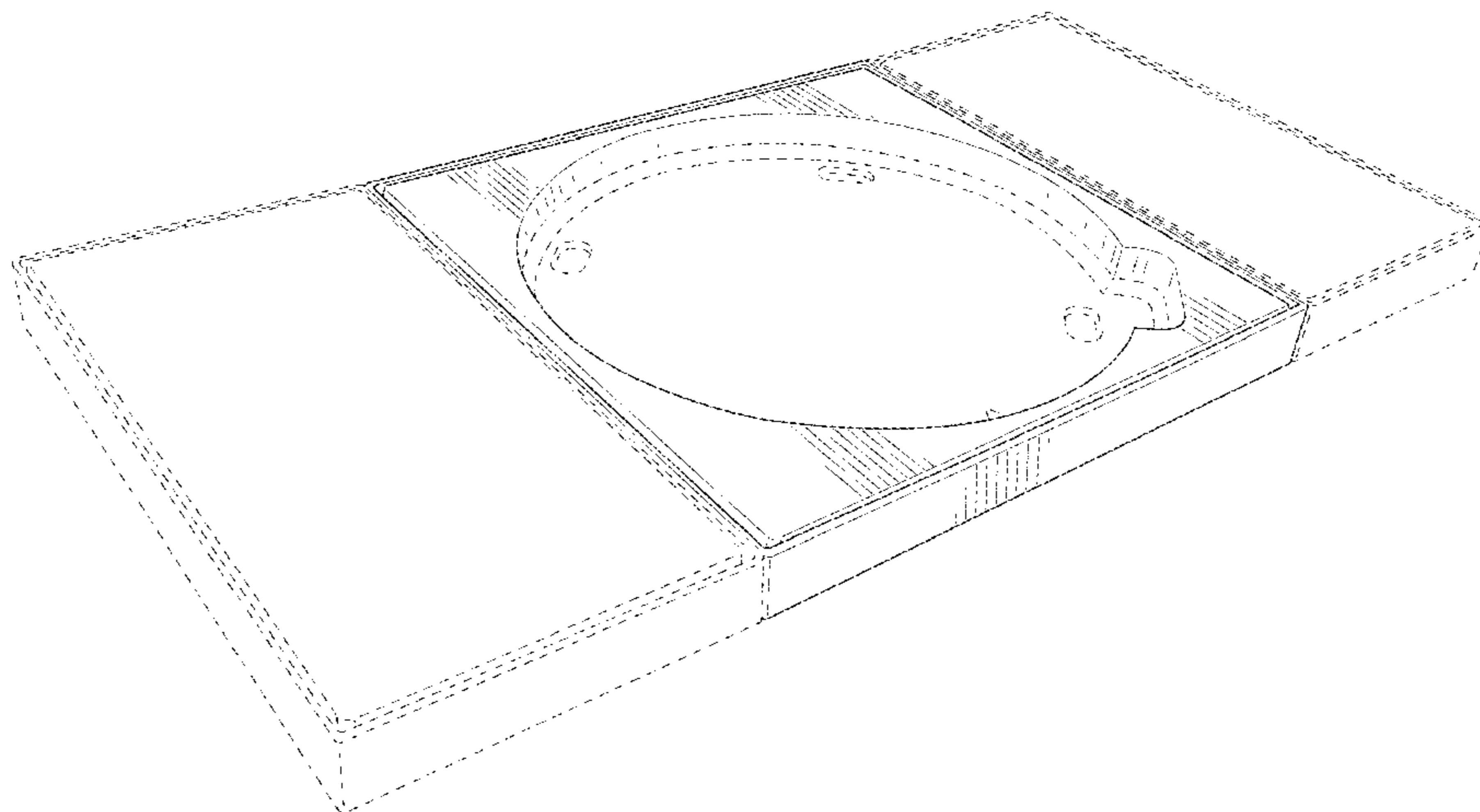
FIG. 5 is a left side elevational view showing the design for the package of FIG. 1;

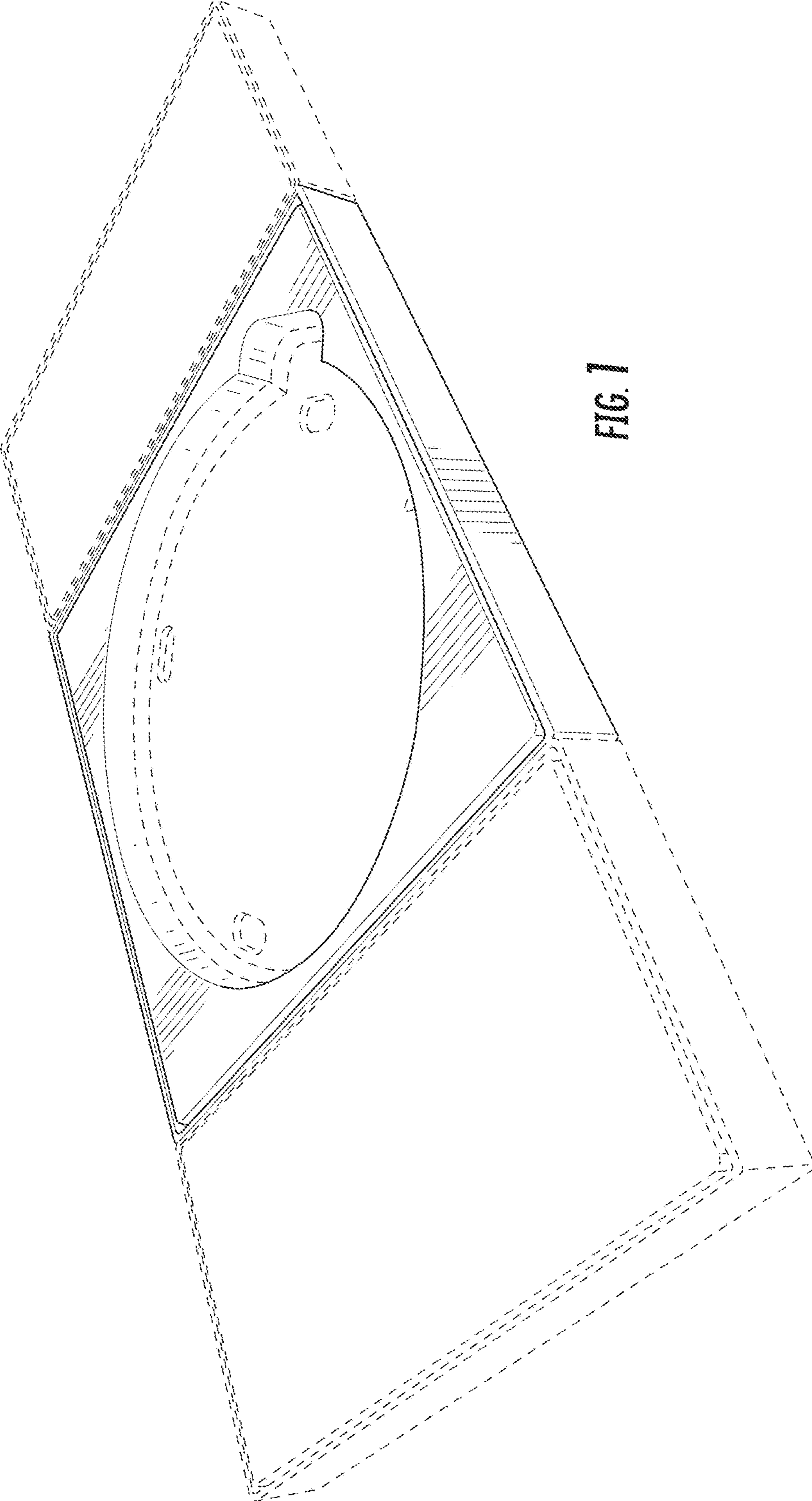

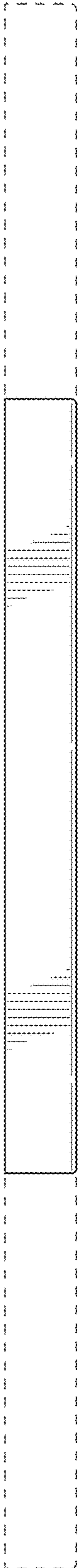

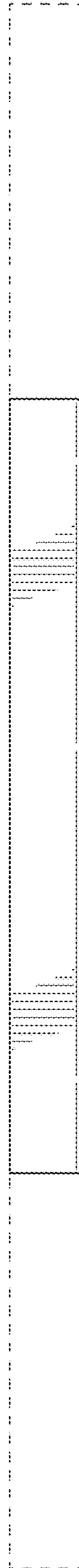

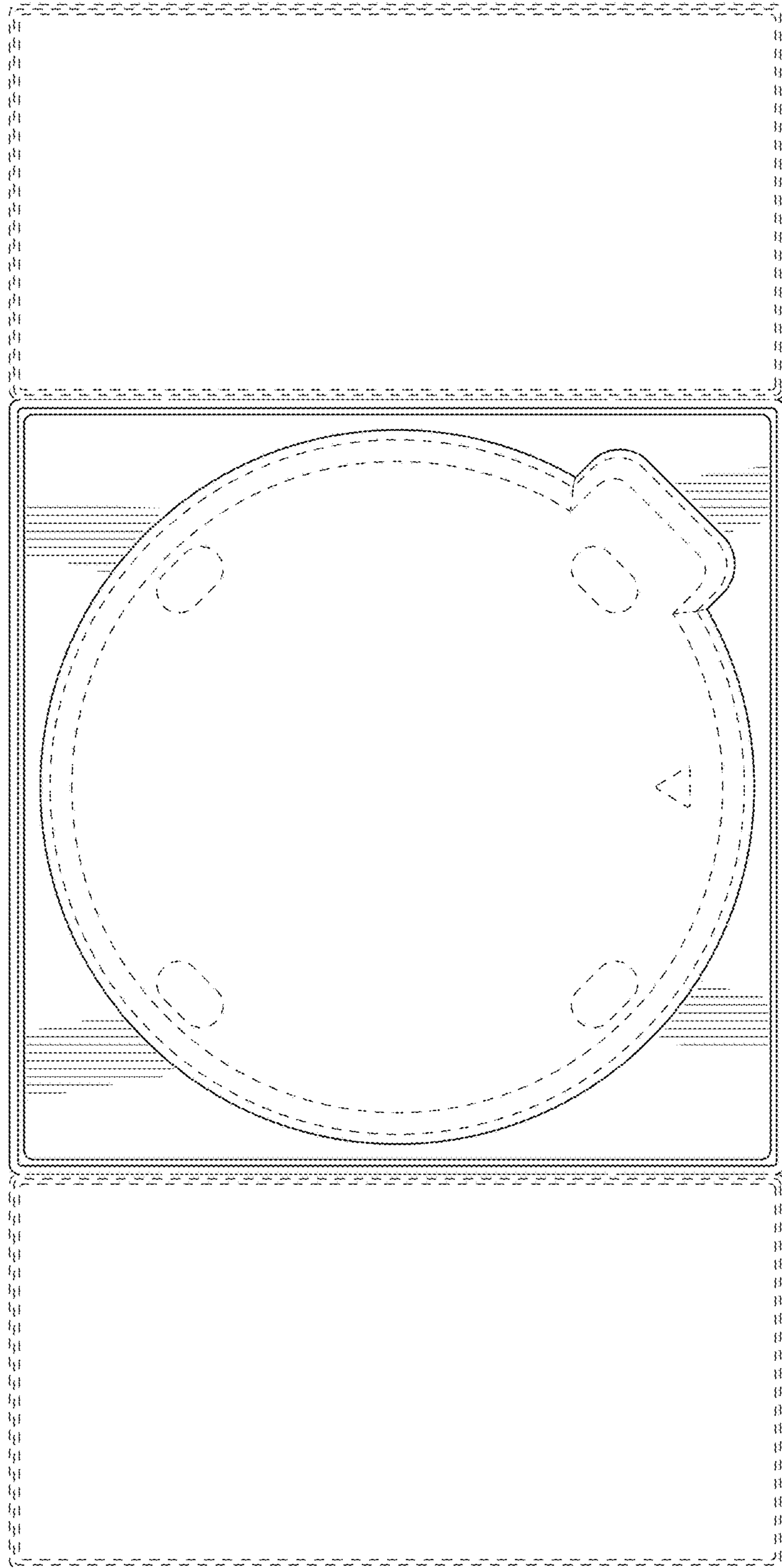

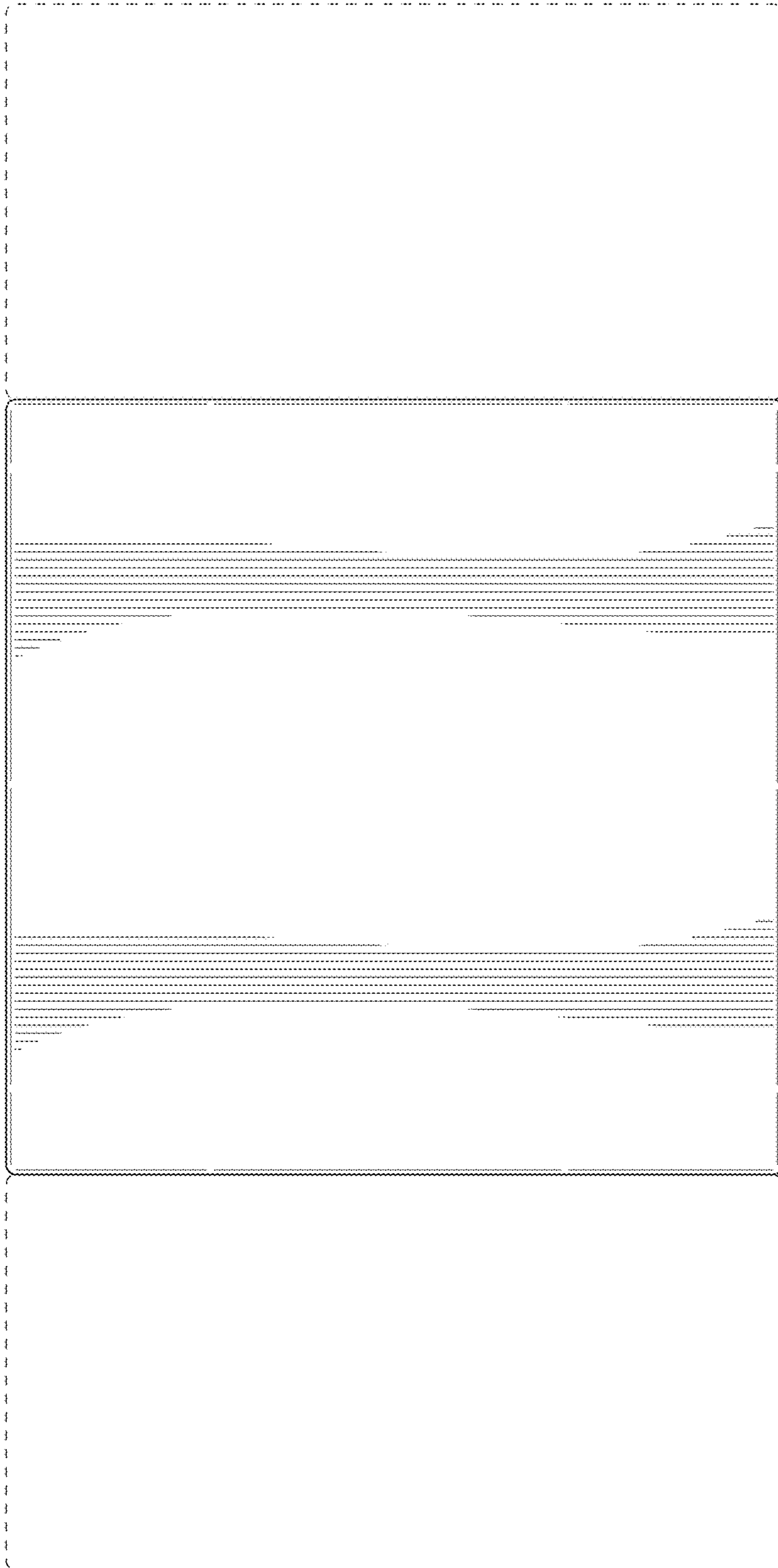
