(57) **CLAIM**

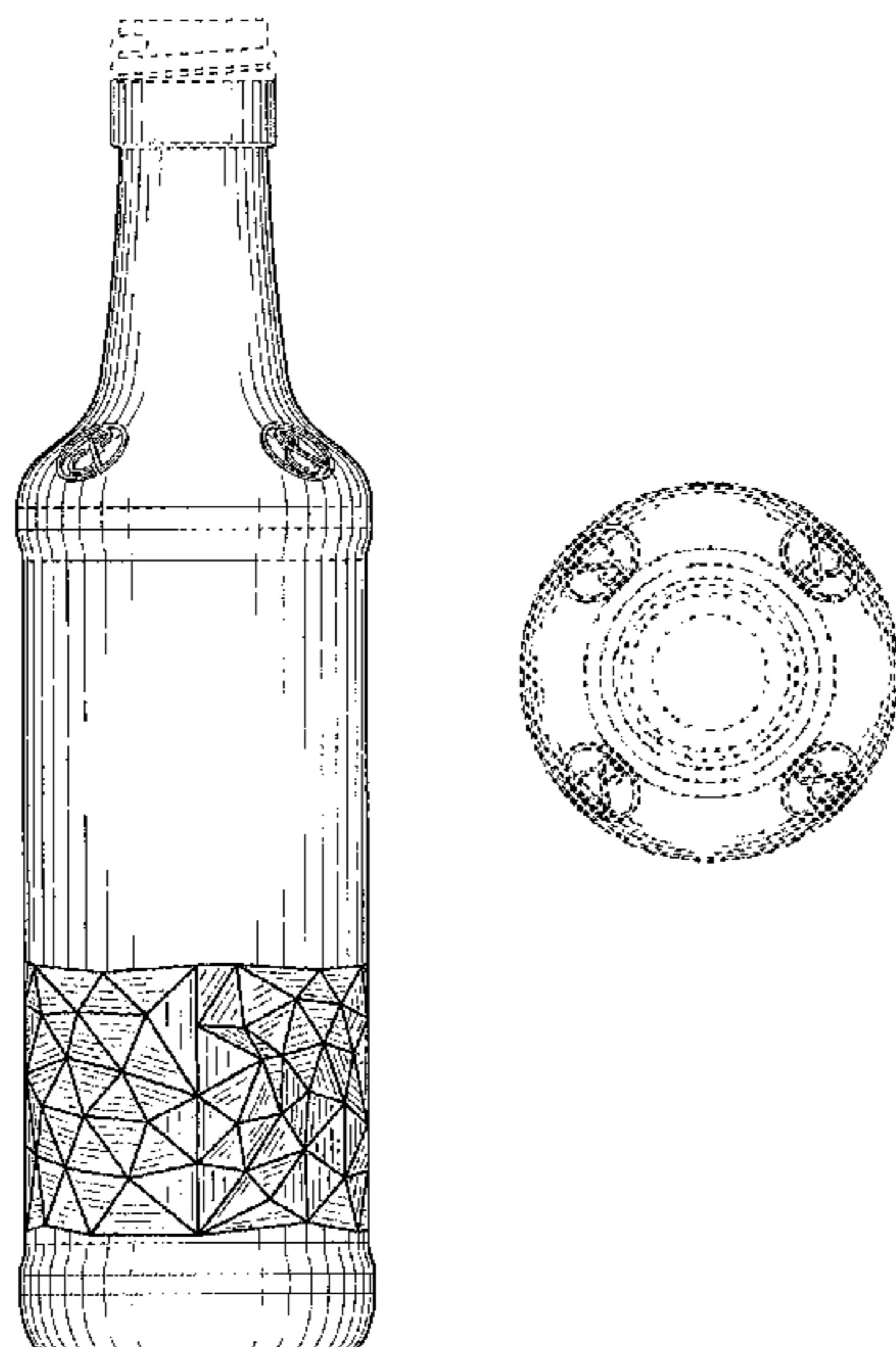
We claim the ornamental design for a faceted bottle, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a faceted bottle showing the new design;  
FIG. 2 is a left side elevation view thereof;  
FIG. 3 is a right side elevation view thereof;  
FIG. 4 is a front elevation view thereof;  
FIG. 5 is a rear elevation view thereof;  
FIG. 6 is a top plan view thereof; and  
FIG. 7 is a bottom plan view thereof.  
FIG. 8 is a cross sectional plan view taken along line 8-8 of FIG. 5;  
FIG. 9 is a cross sectional plan view taken along line 9-9 of FIG. 5;  
FIG. 10 is a cross sectional plan view taken along line 10-10 of FIG. 5;  
FIG. 11 is a cross sectional plan view taken along line 11-11 of FIG. 5; and,  
FIG. 12 is a cross sectional plan view taken along line 12-12 of FIG. 5.

The broken lines in the drawings showing the faceted bottle illustrate the portions of the faceted bottle that form no part of the claimed design.

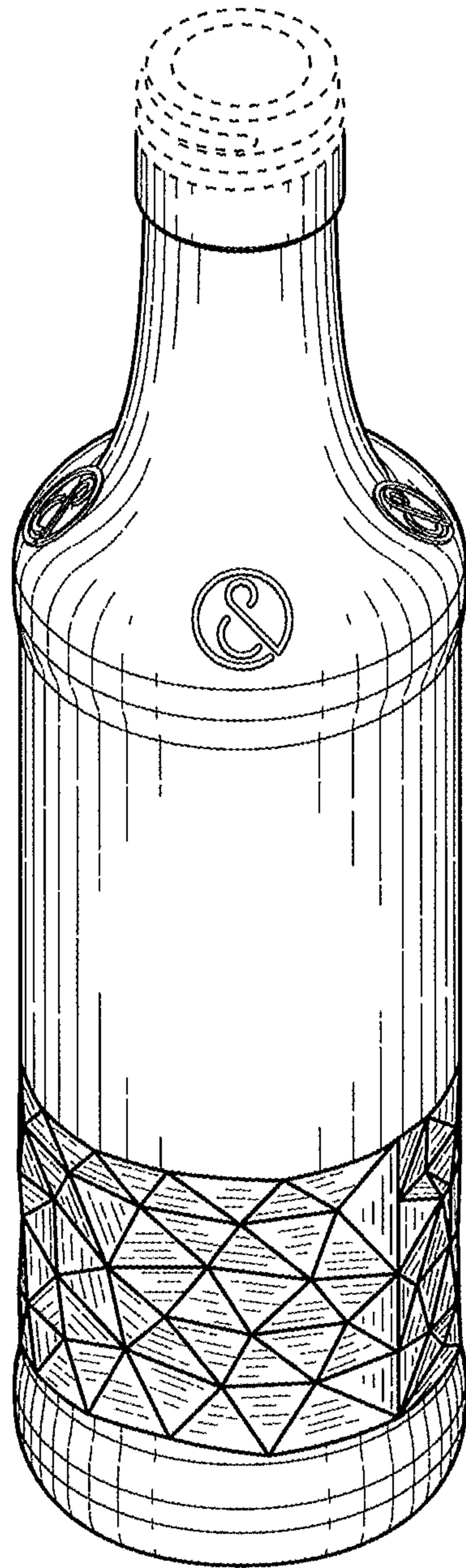

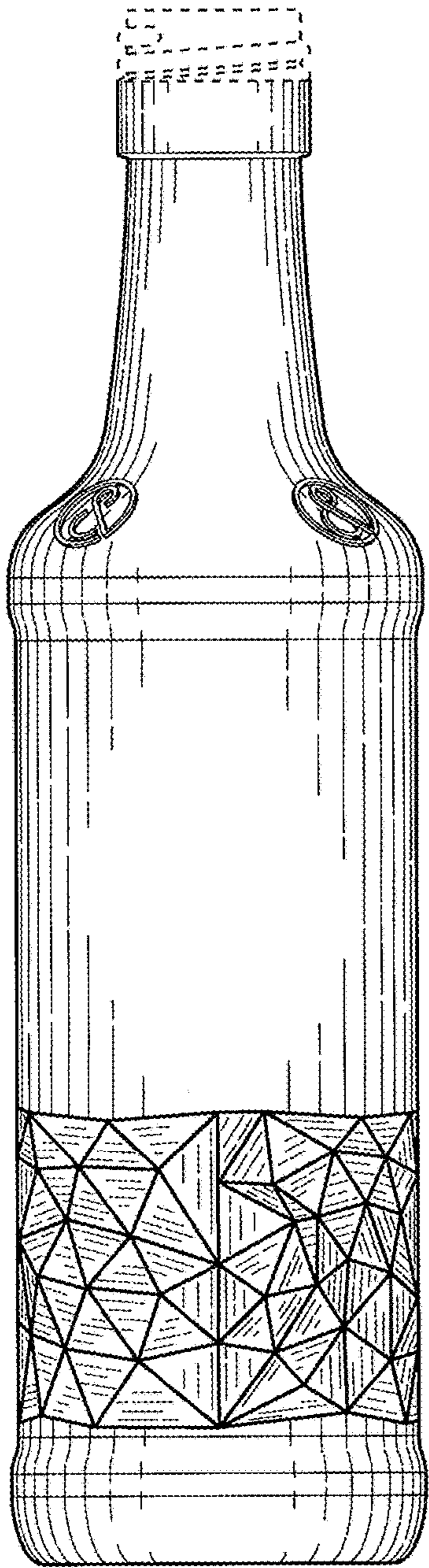

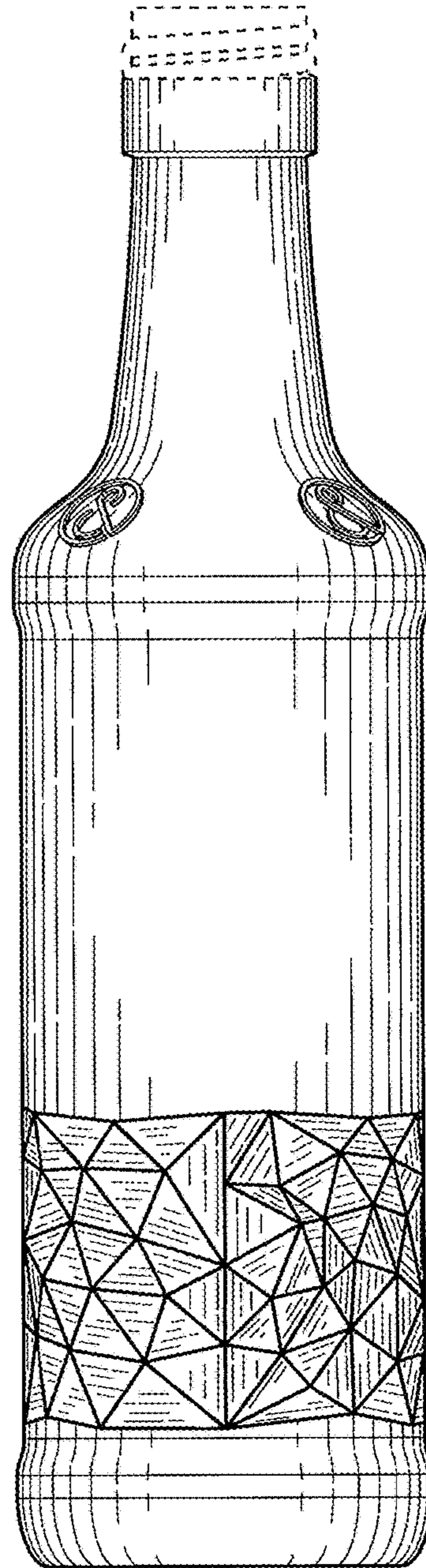

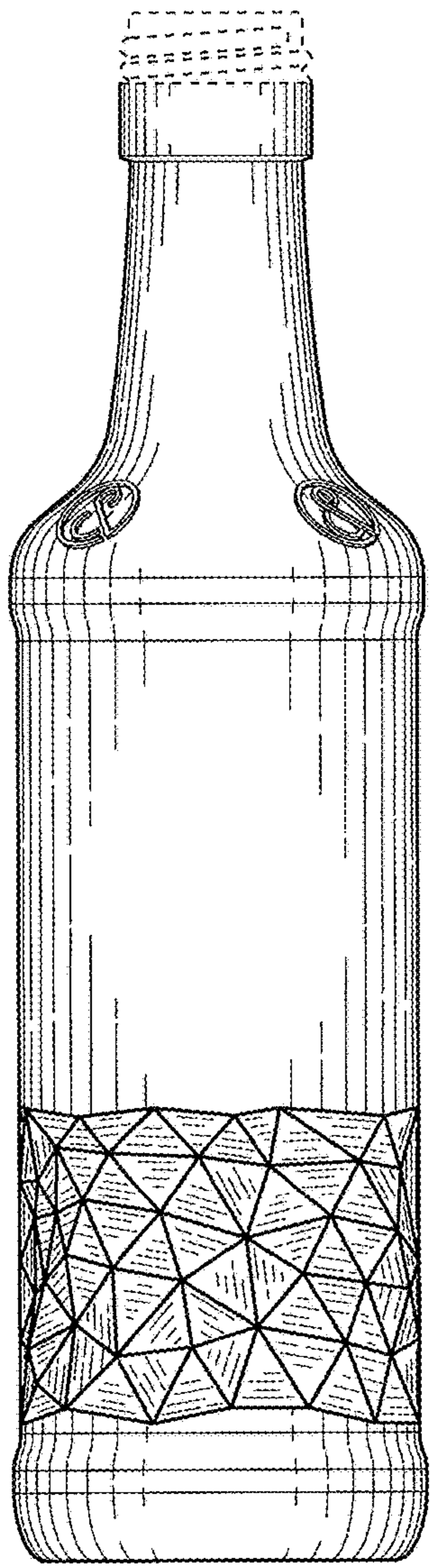

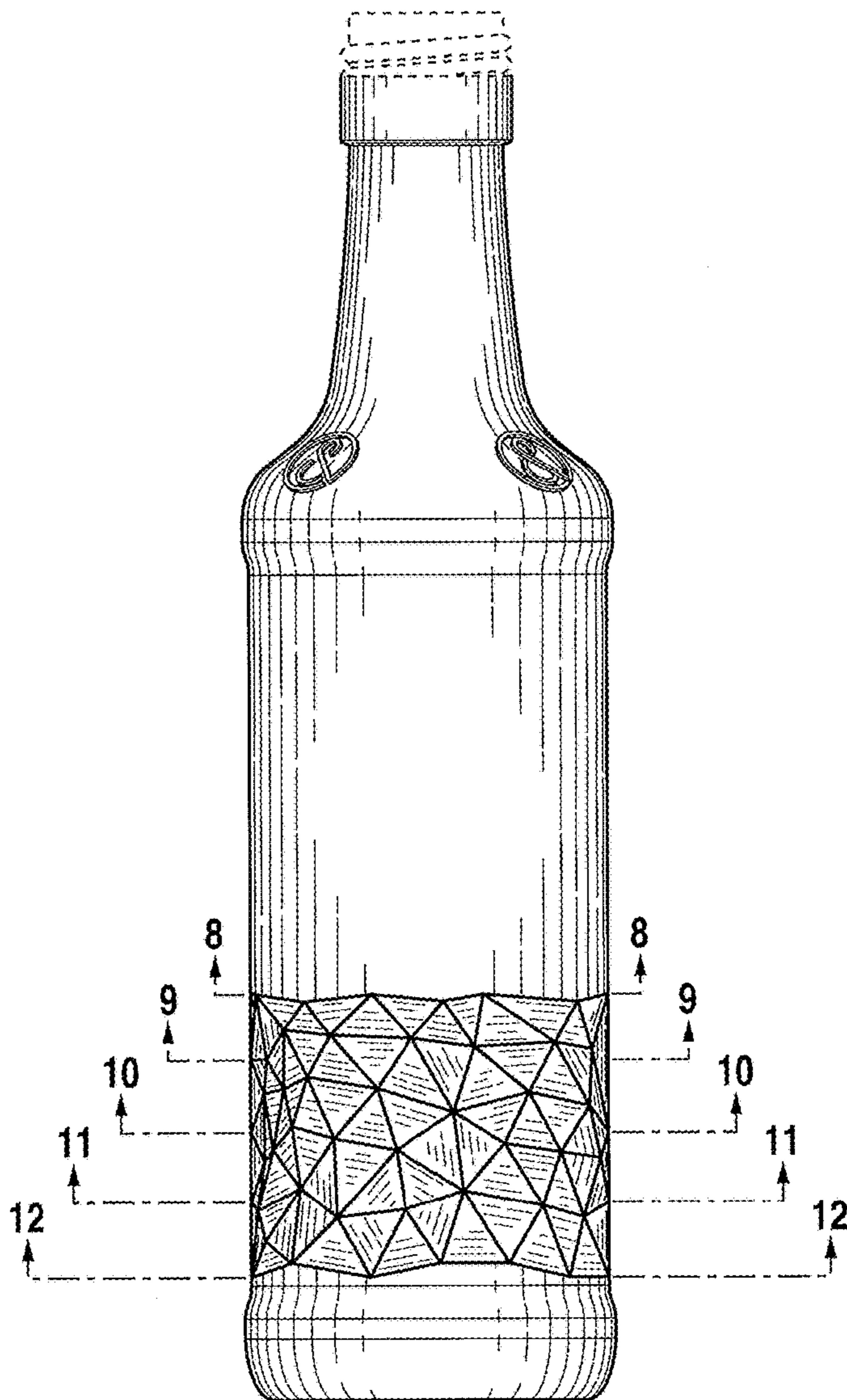

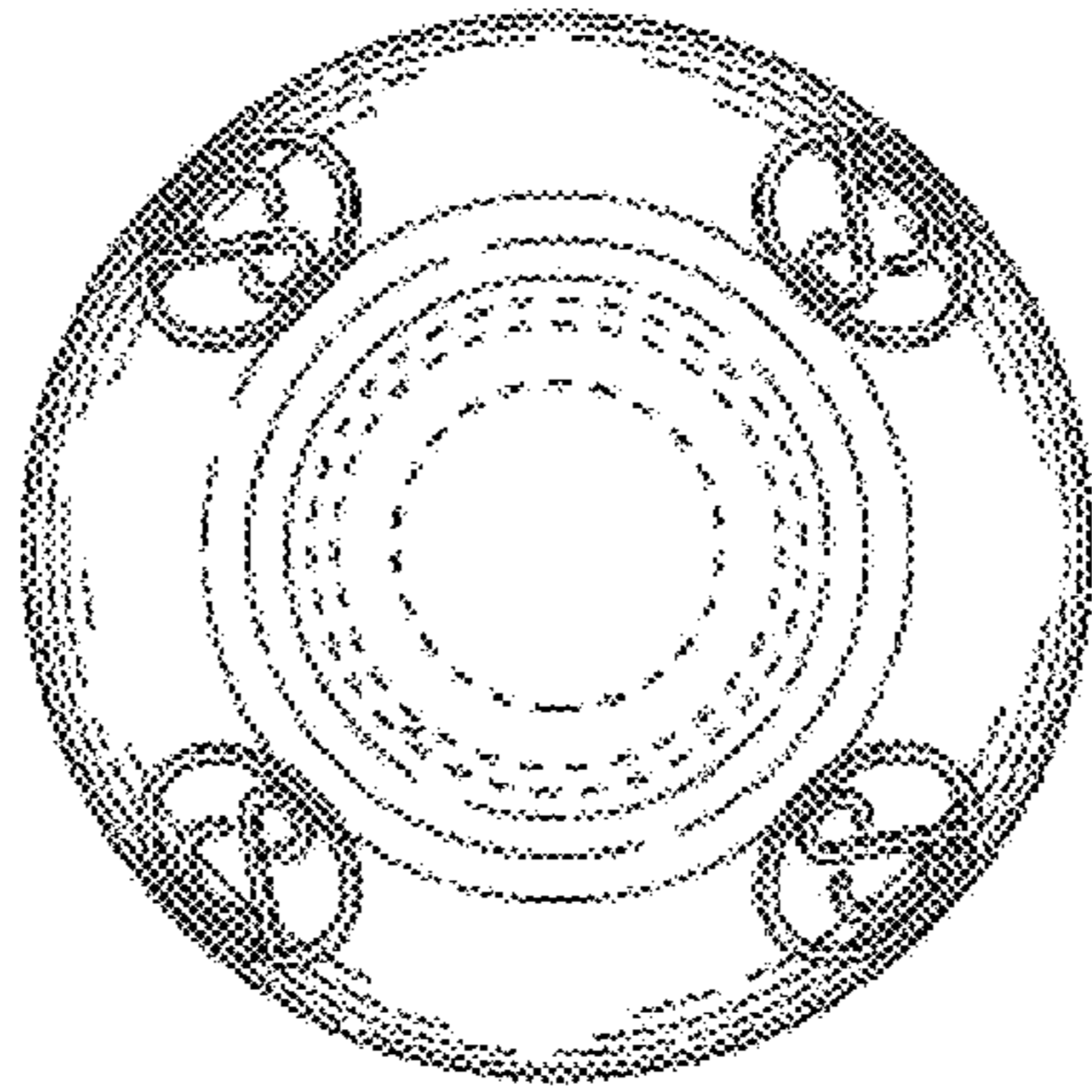

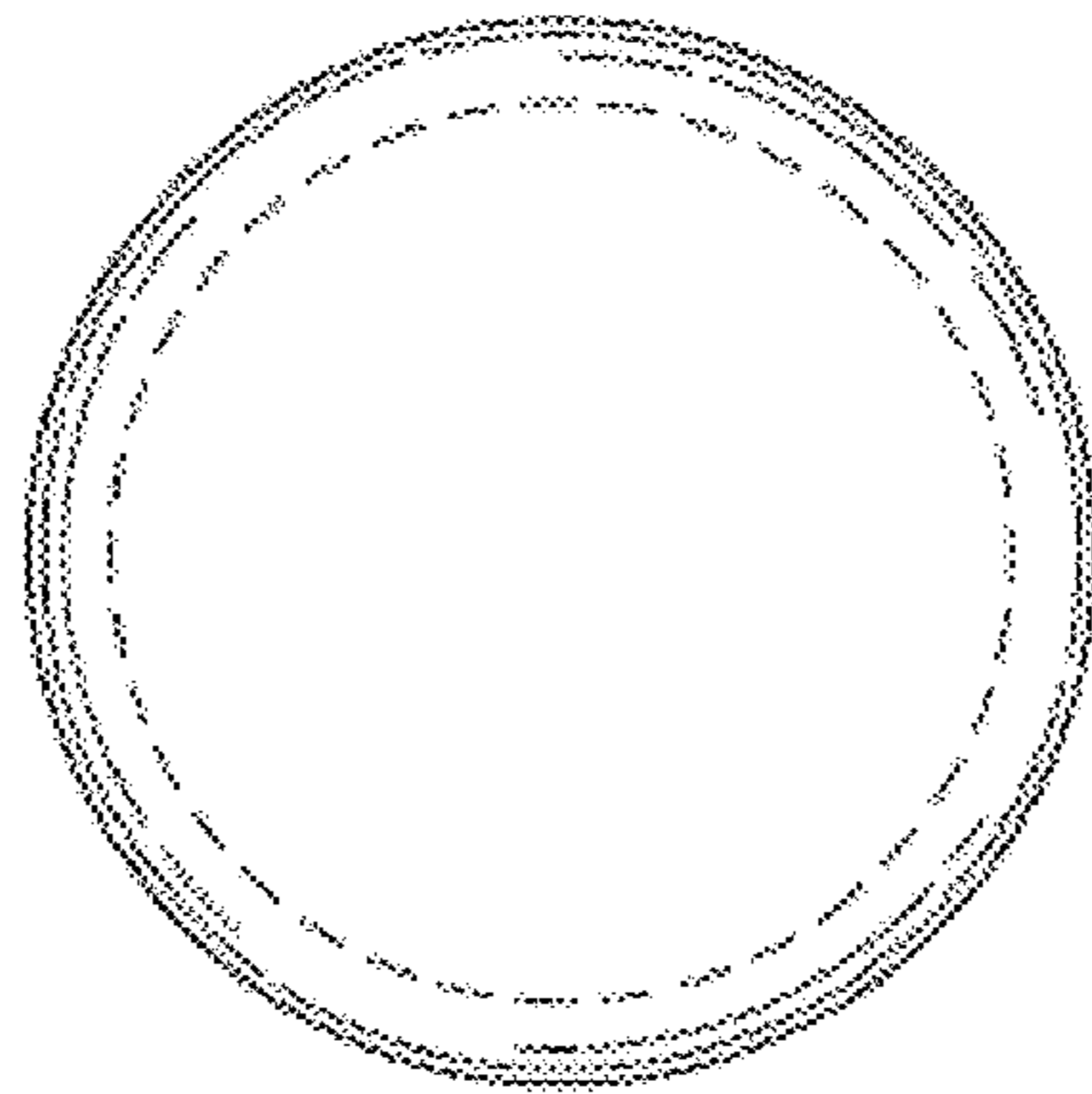

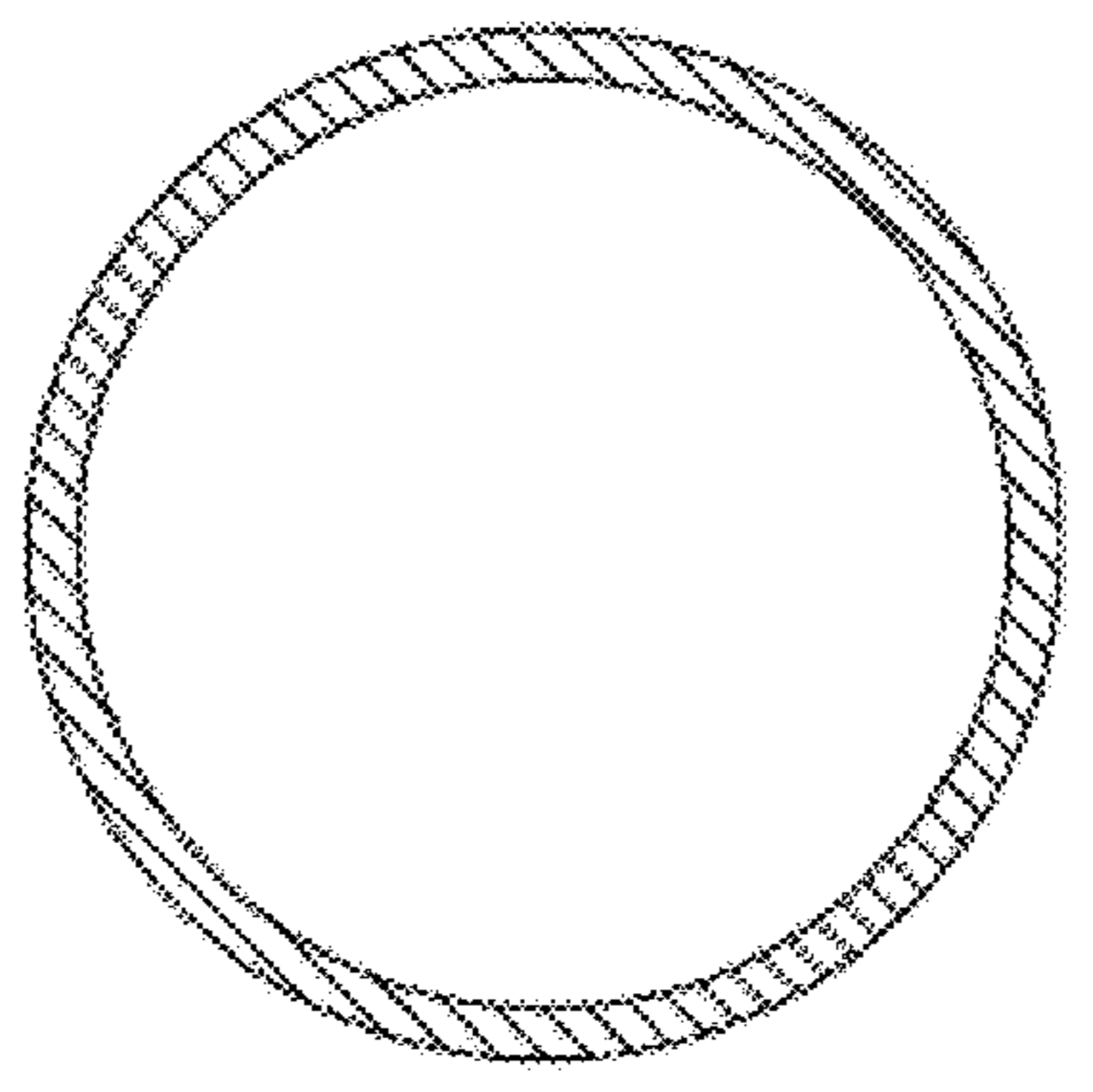

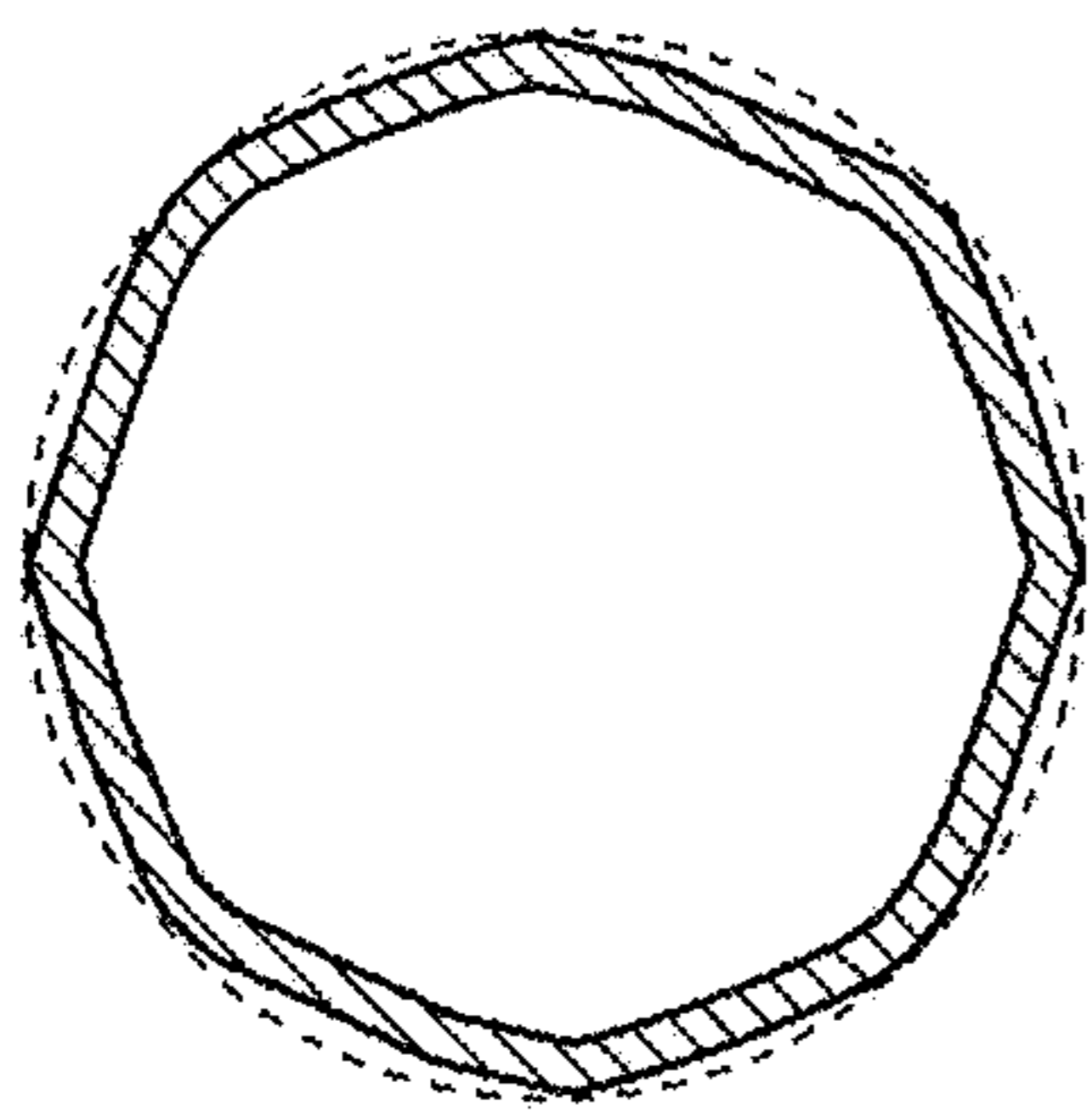

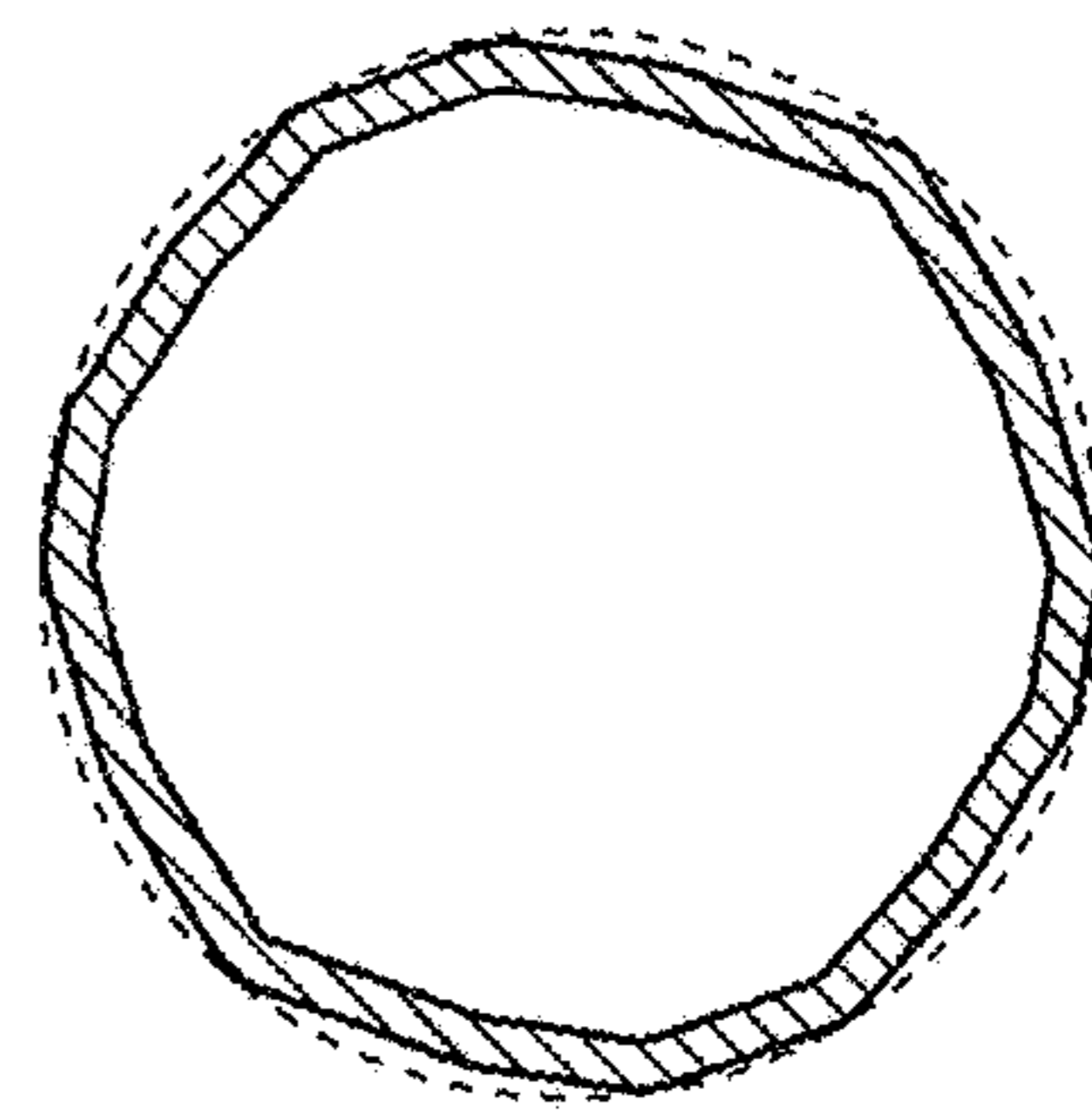

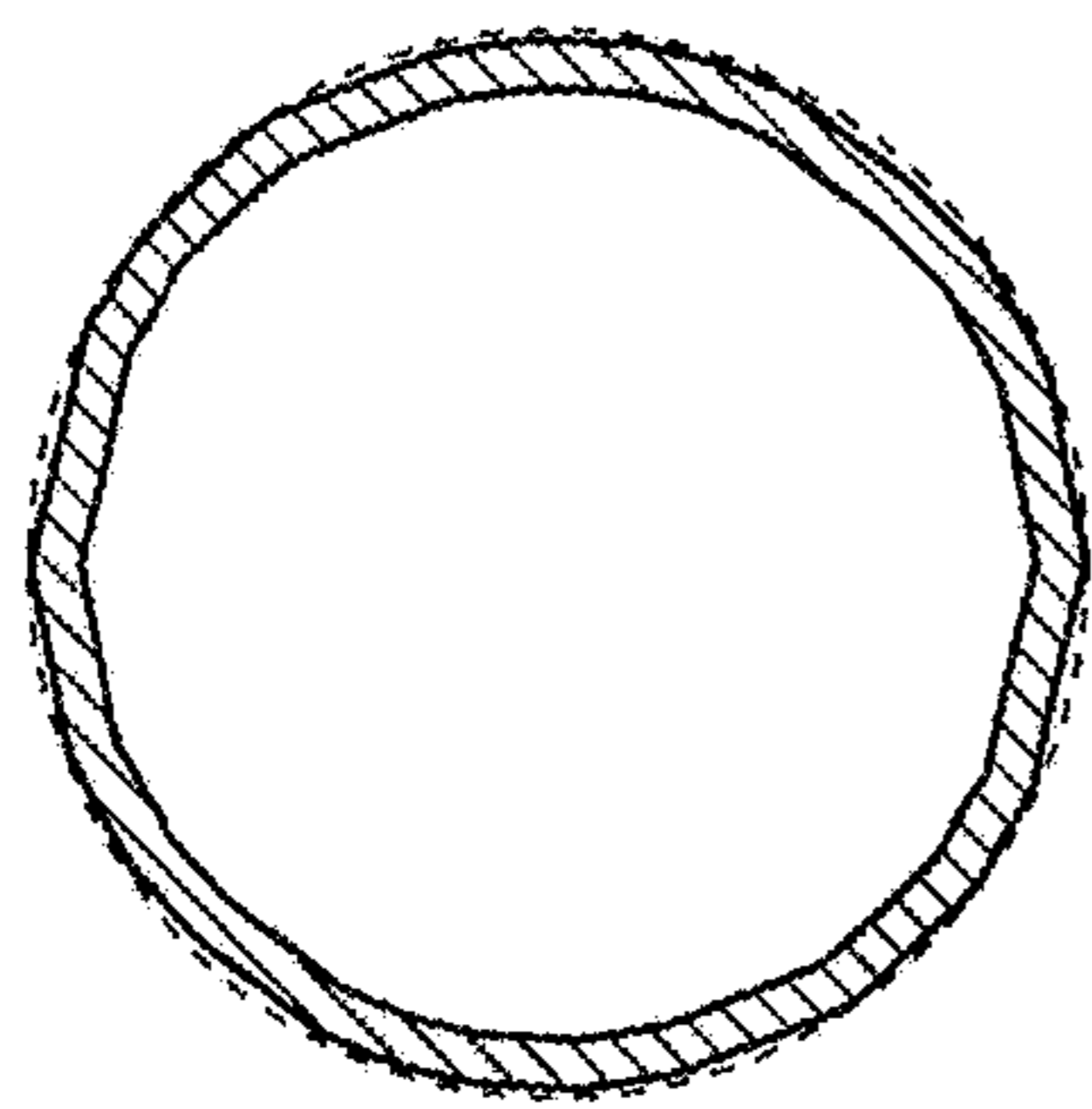

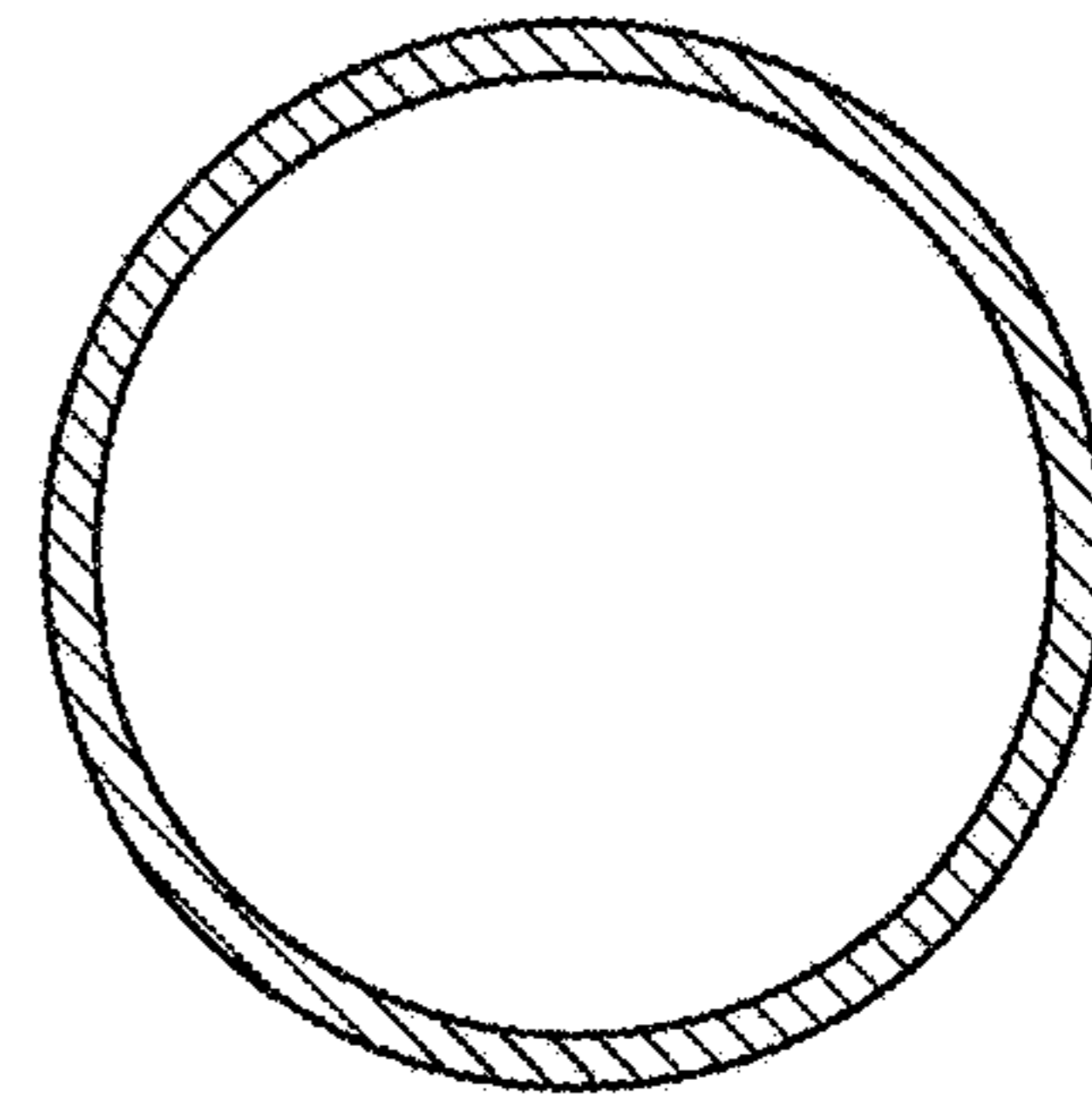
