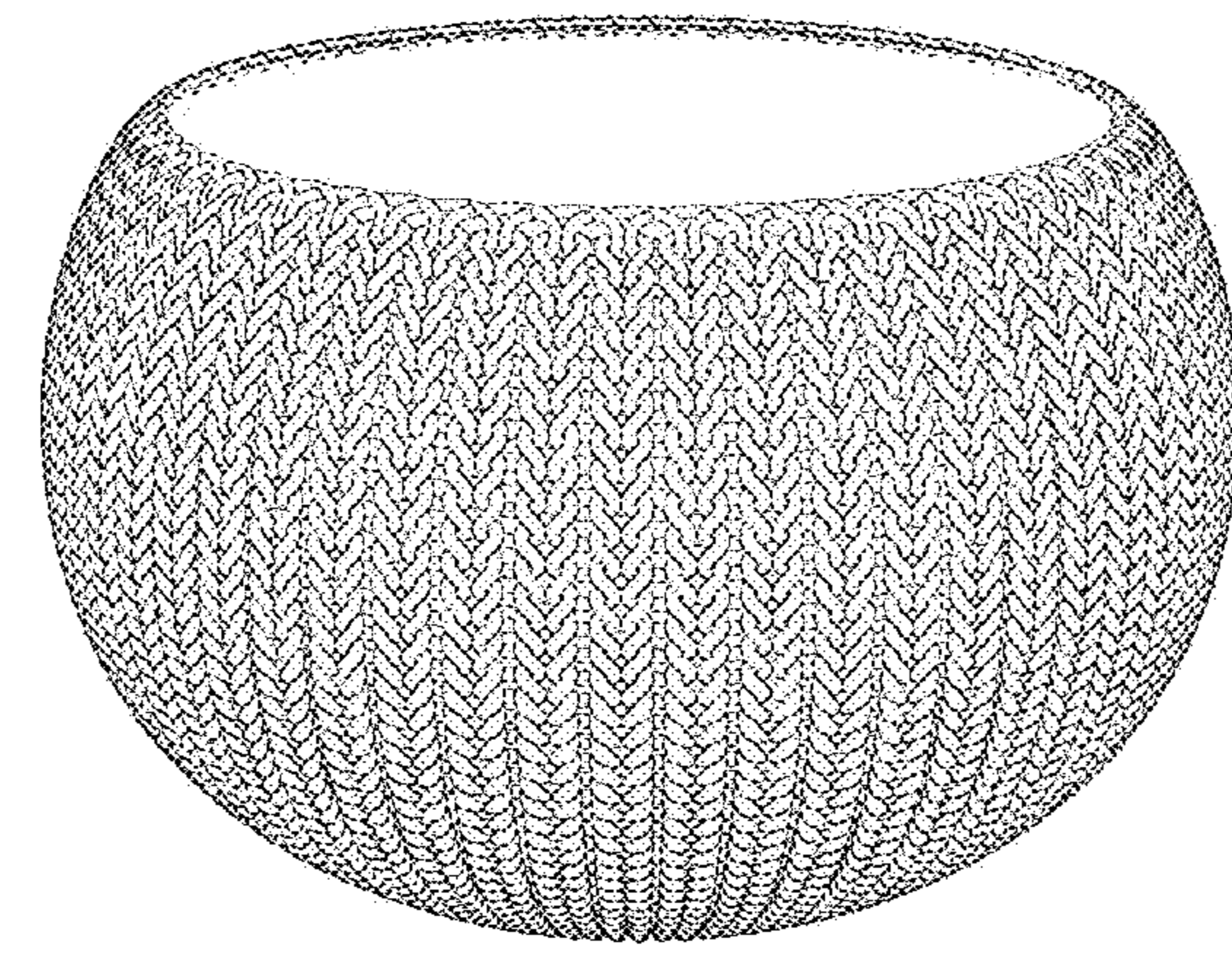
(57) **CLAIM**

The ornamental design for a flowerpot, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a flowerpot;
FIG. 2 is a side view of the flowerpot as seen in FIG. 1, and all other side views are identical;
FIG. 3 is a top plan view of the flowerpot as seen in FIG. 1; and,
FIG. 4 is a bottom plan view of the flowerpot as seen in FIG. 1.
The broken lines that define the bounds of the claimed design form no part thereof. The broken lines shown in the drawings are included to show portions of the flowerpot that form no part of the claimed design.

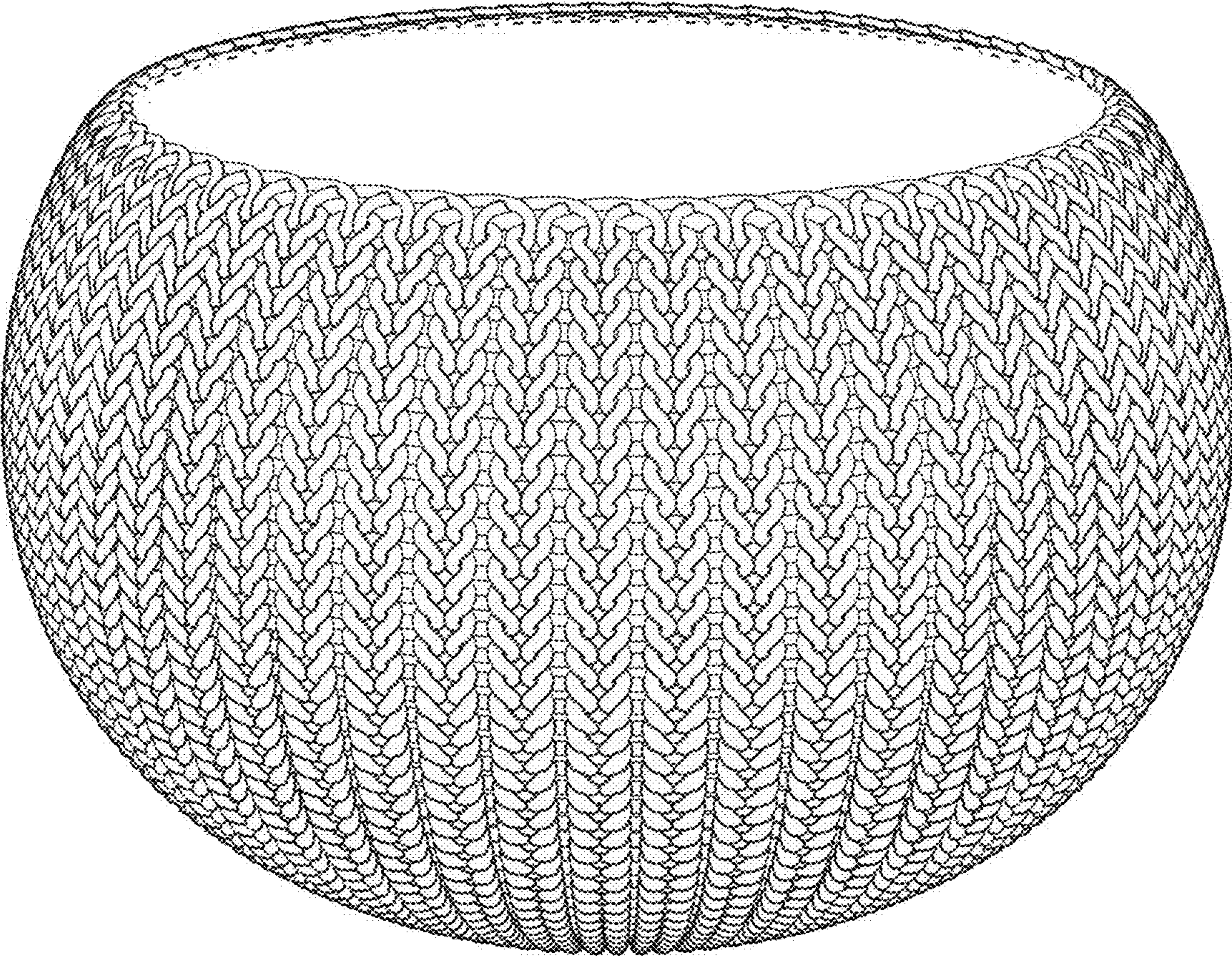

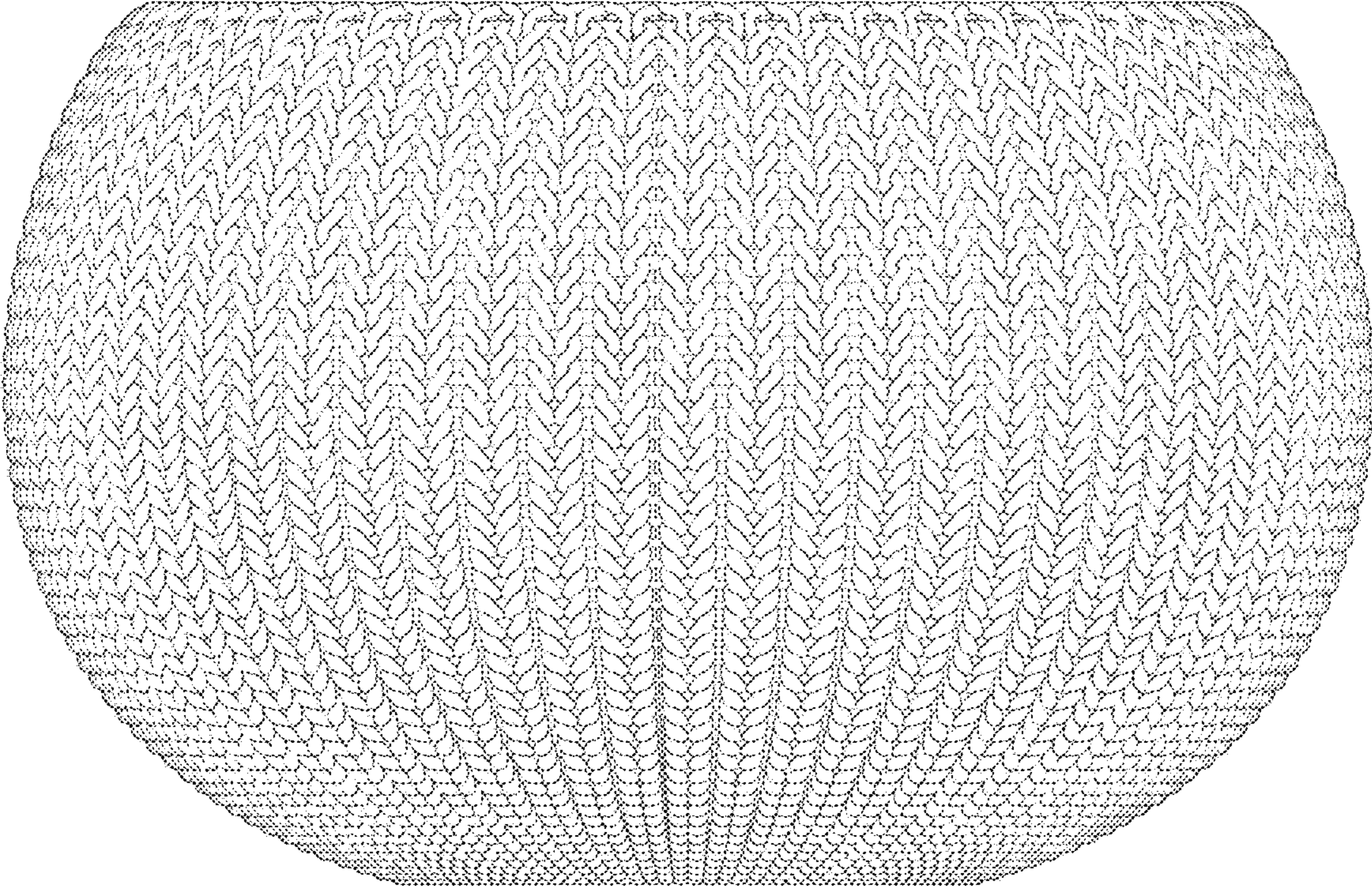

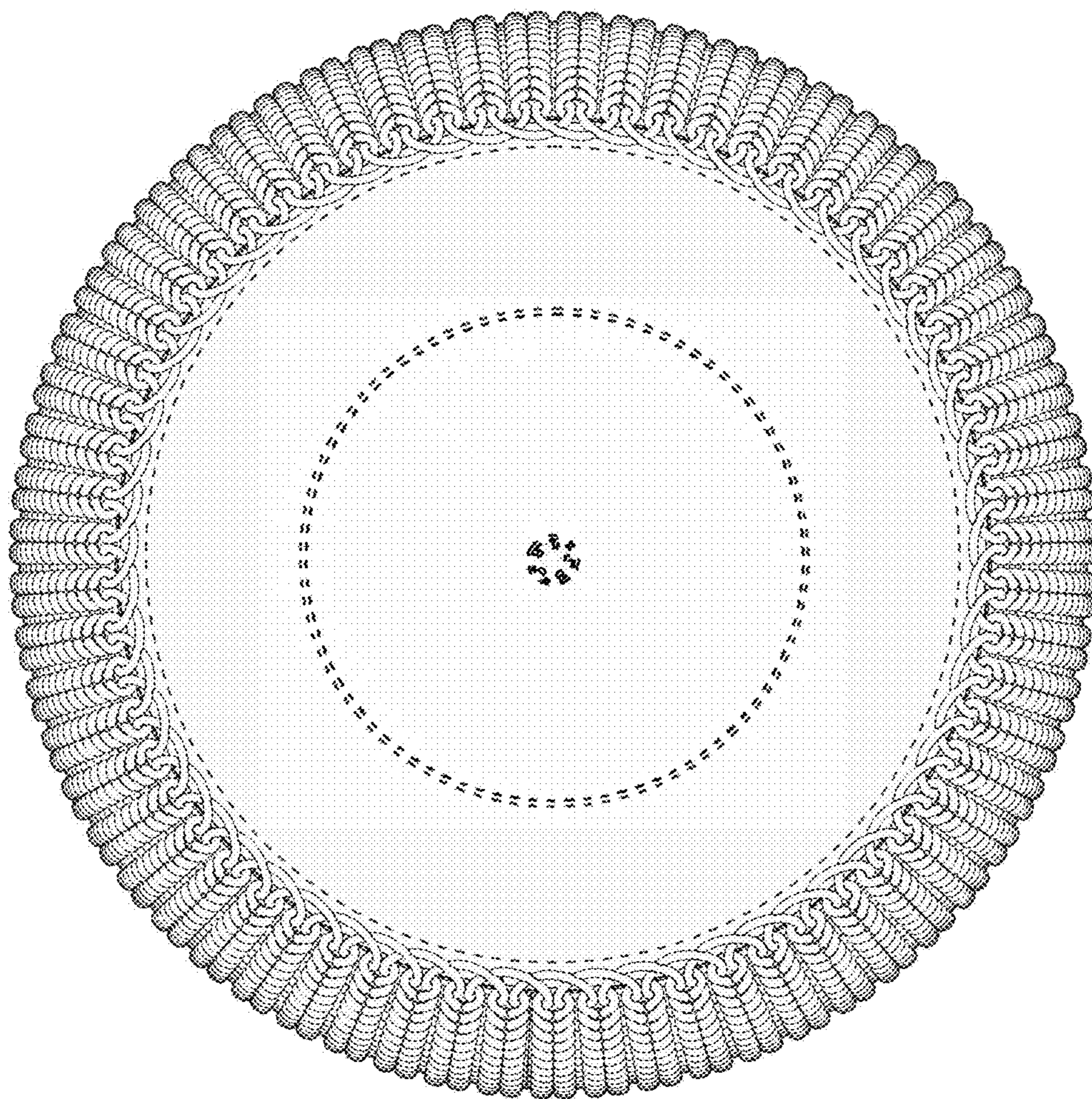

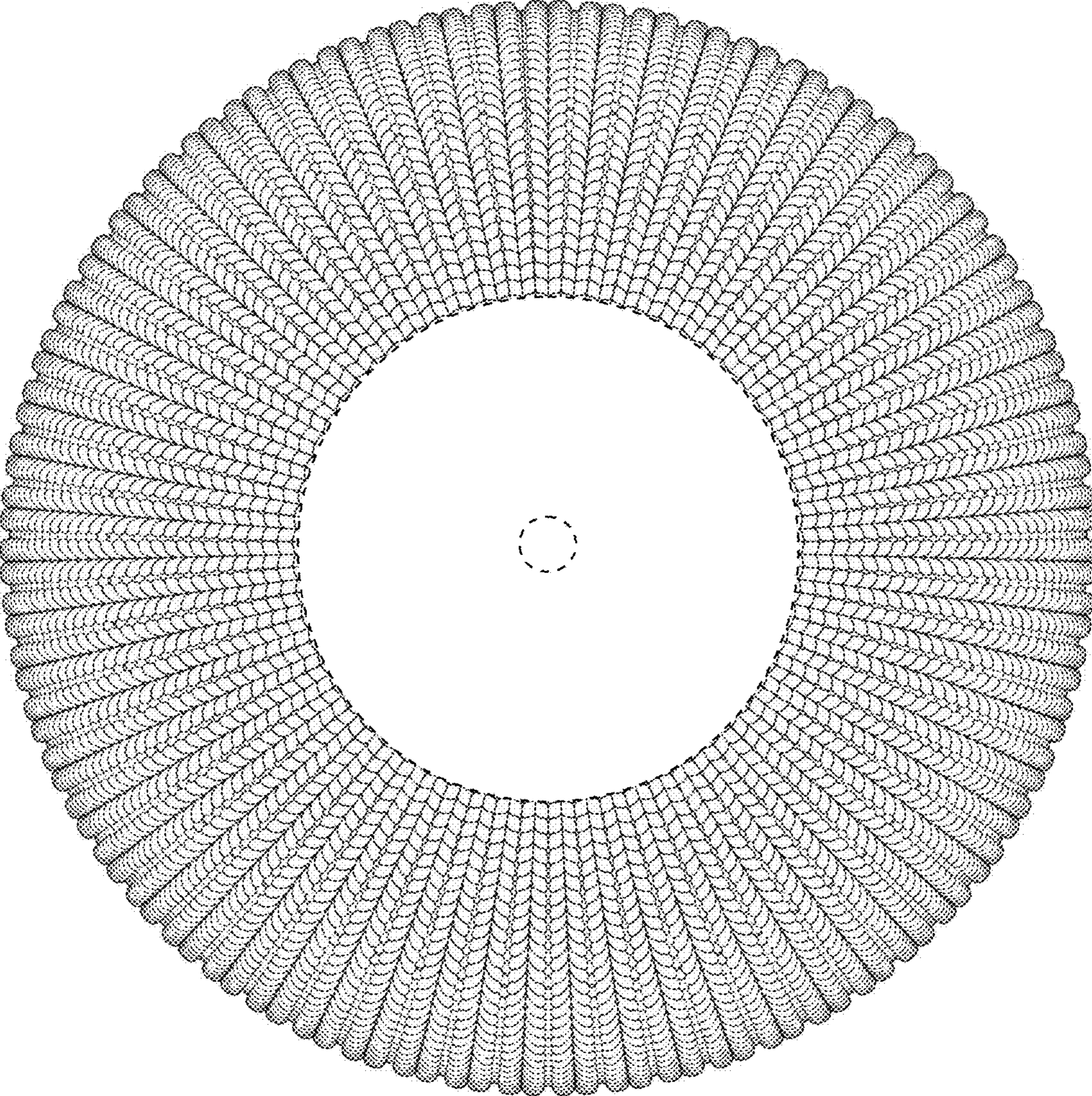
