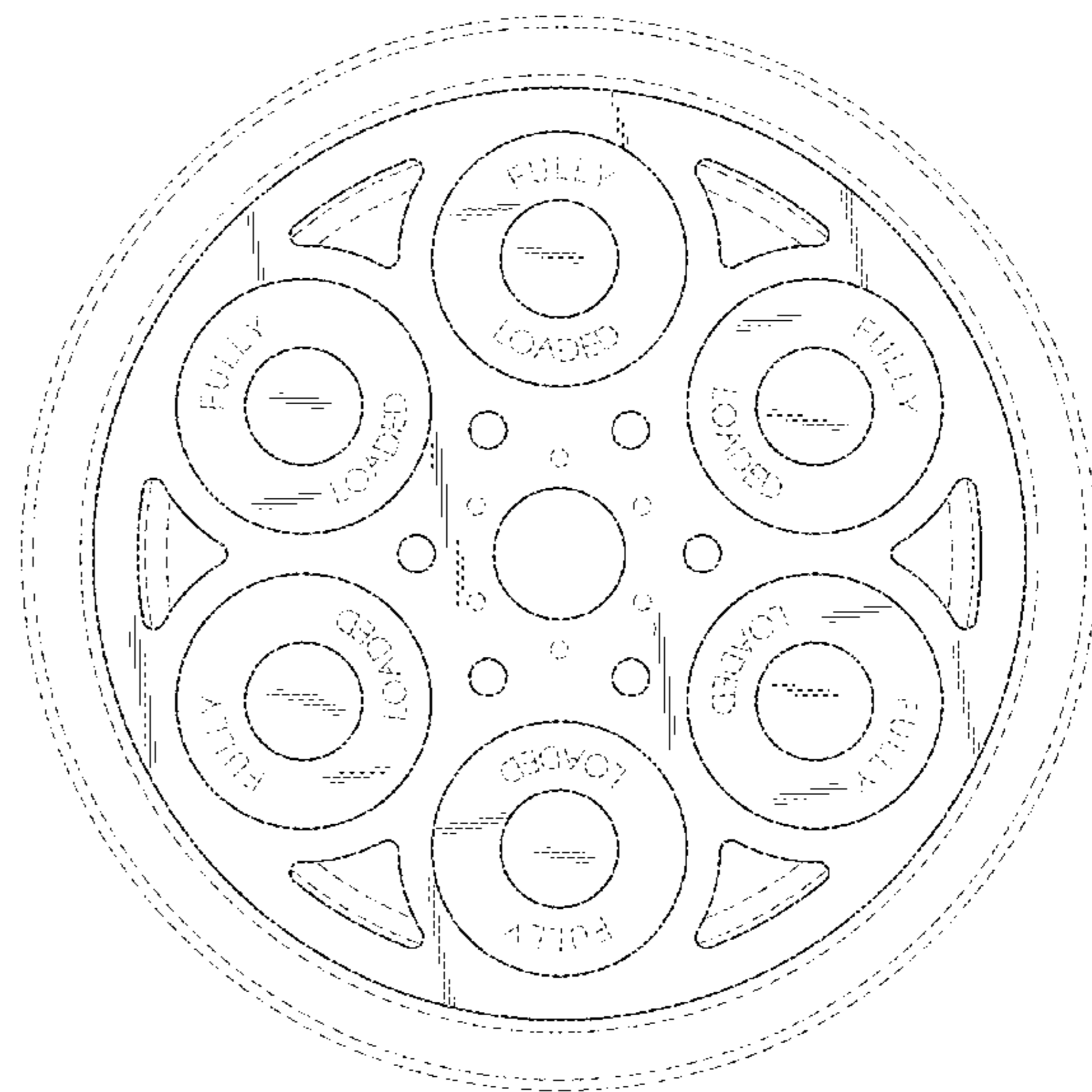
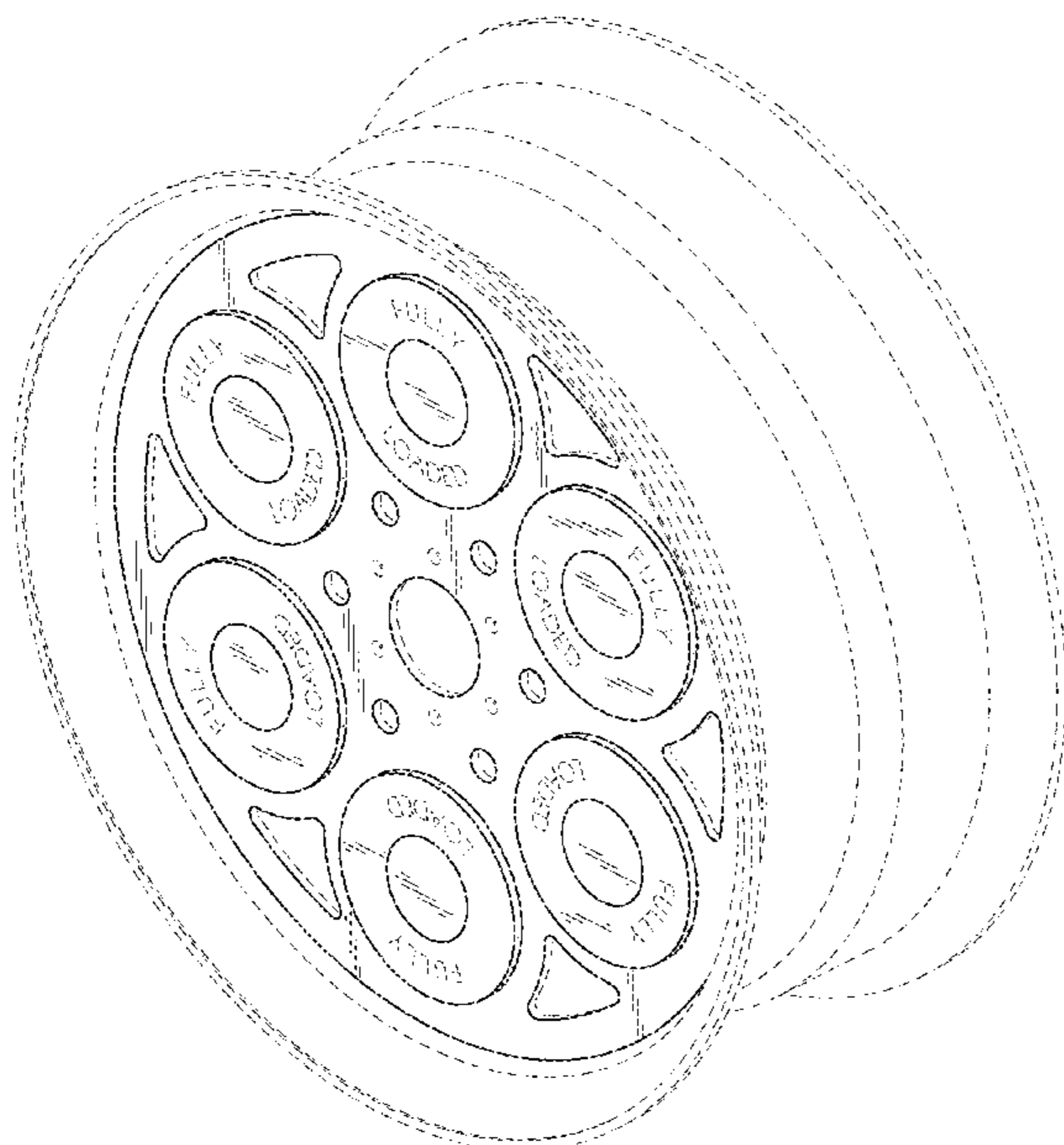
The ornamental design for a vehicle wheel, as shown and

**DESCRIPTION**

FIG. 1 is a front perspective view of the vehicle wheel;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof; and,  
FIG. 4 is a left side elevation view thereof, the right side  
elevation view, top plan view, and bottom plan view being  
a mirror image thereof.

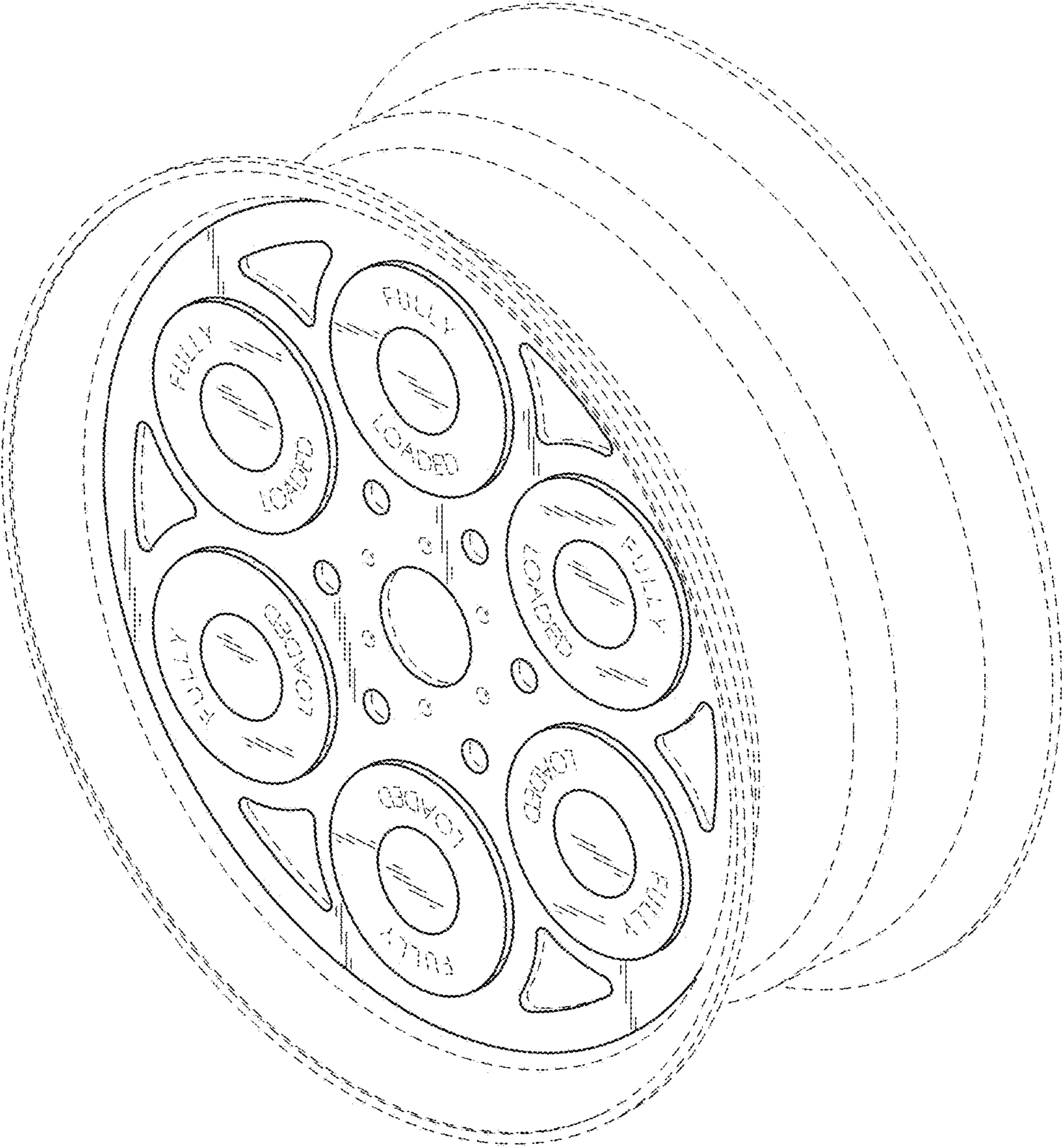

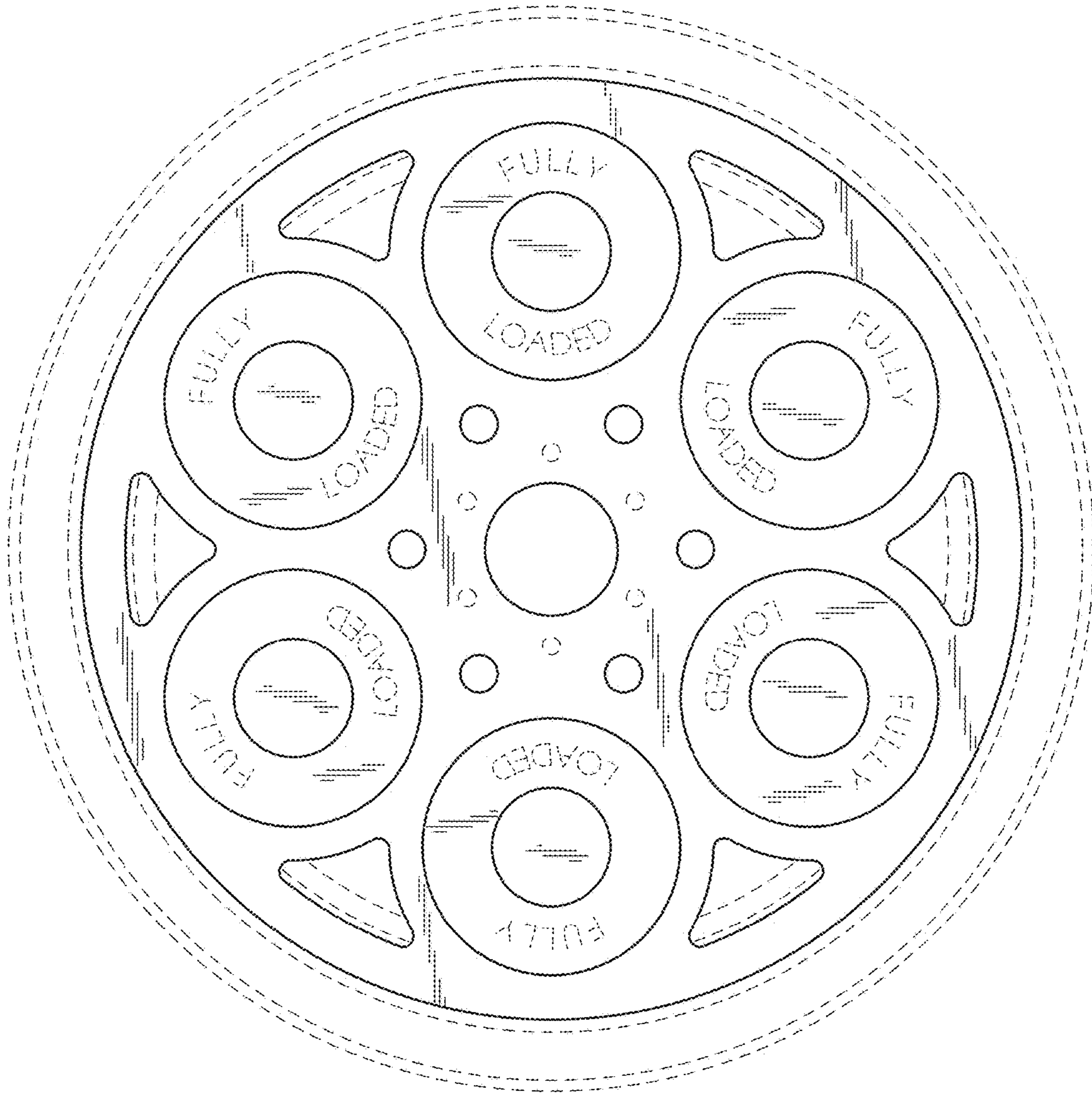

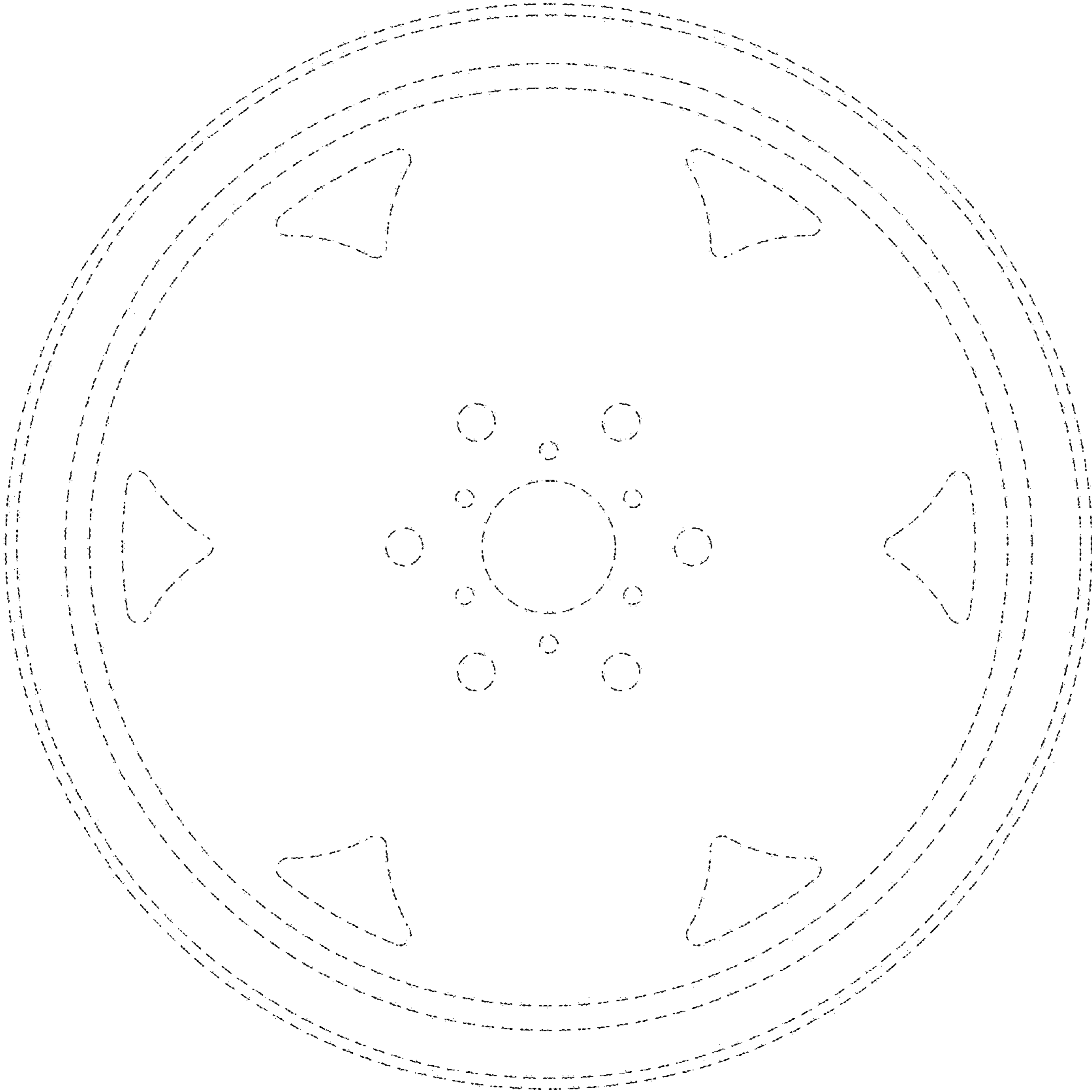

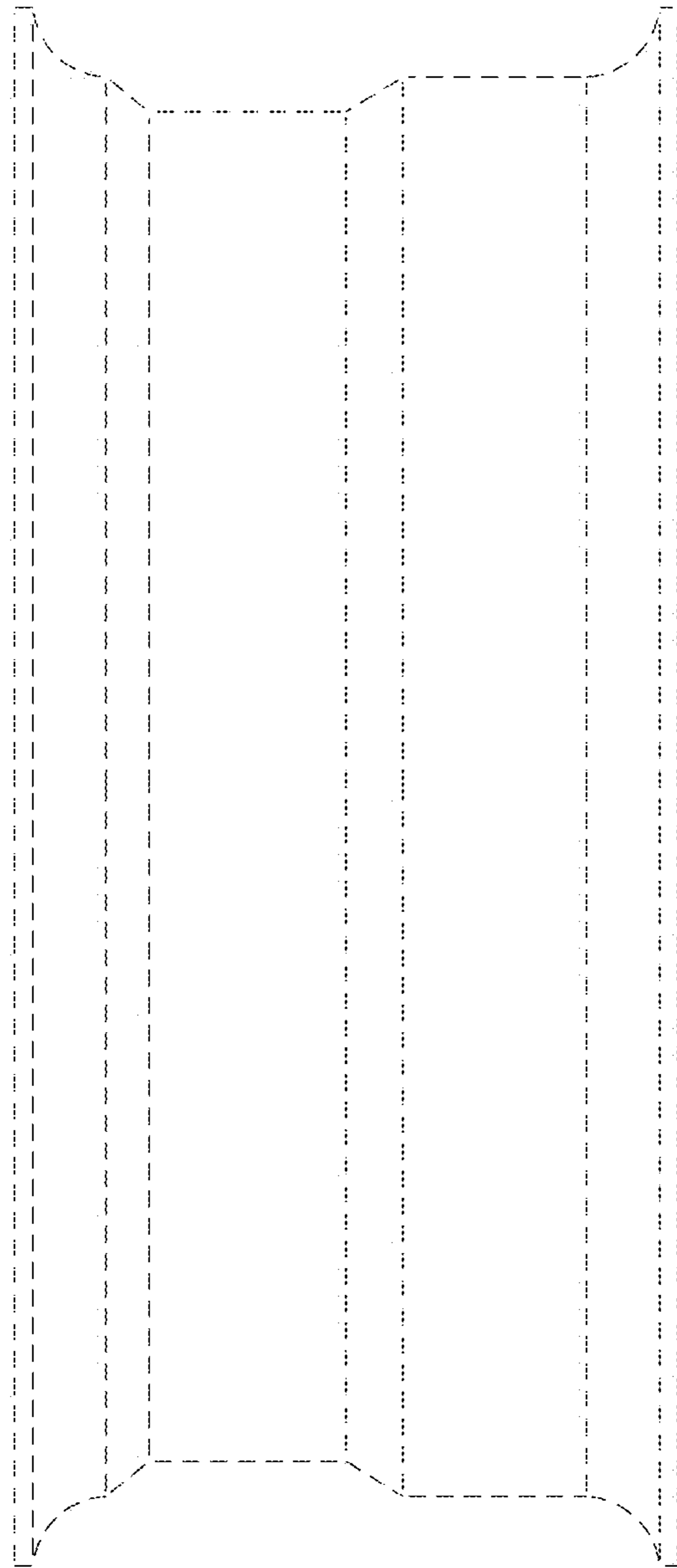
