The ornamental design for an intercommunication system, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of an intercommunication system showing our new design;
FIG. 2 is a back elevational view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a left side elevational view thereof; and,

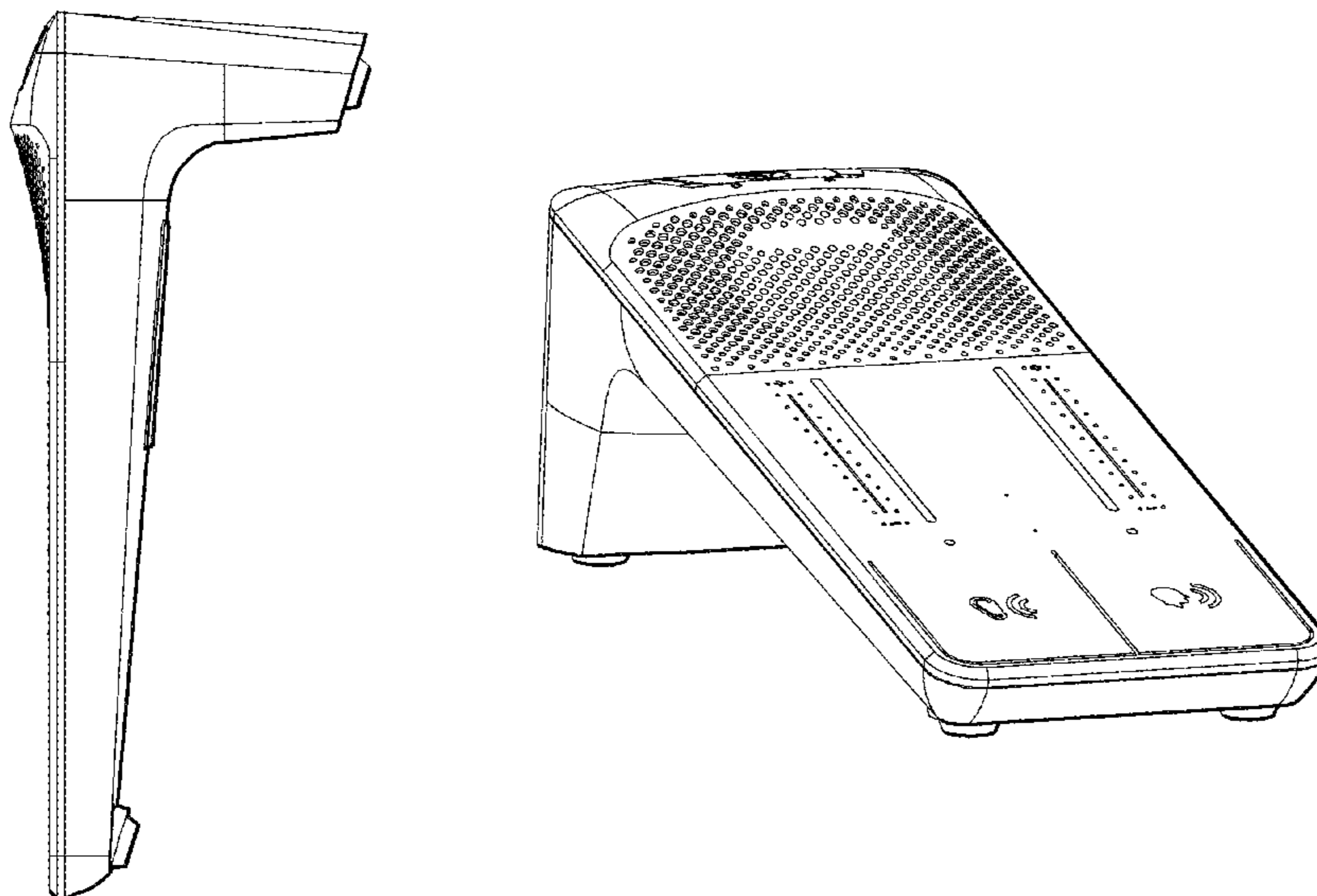

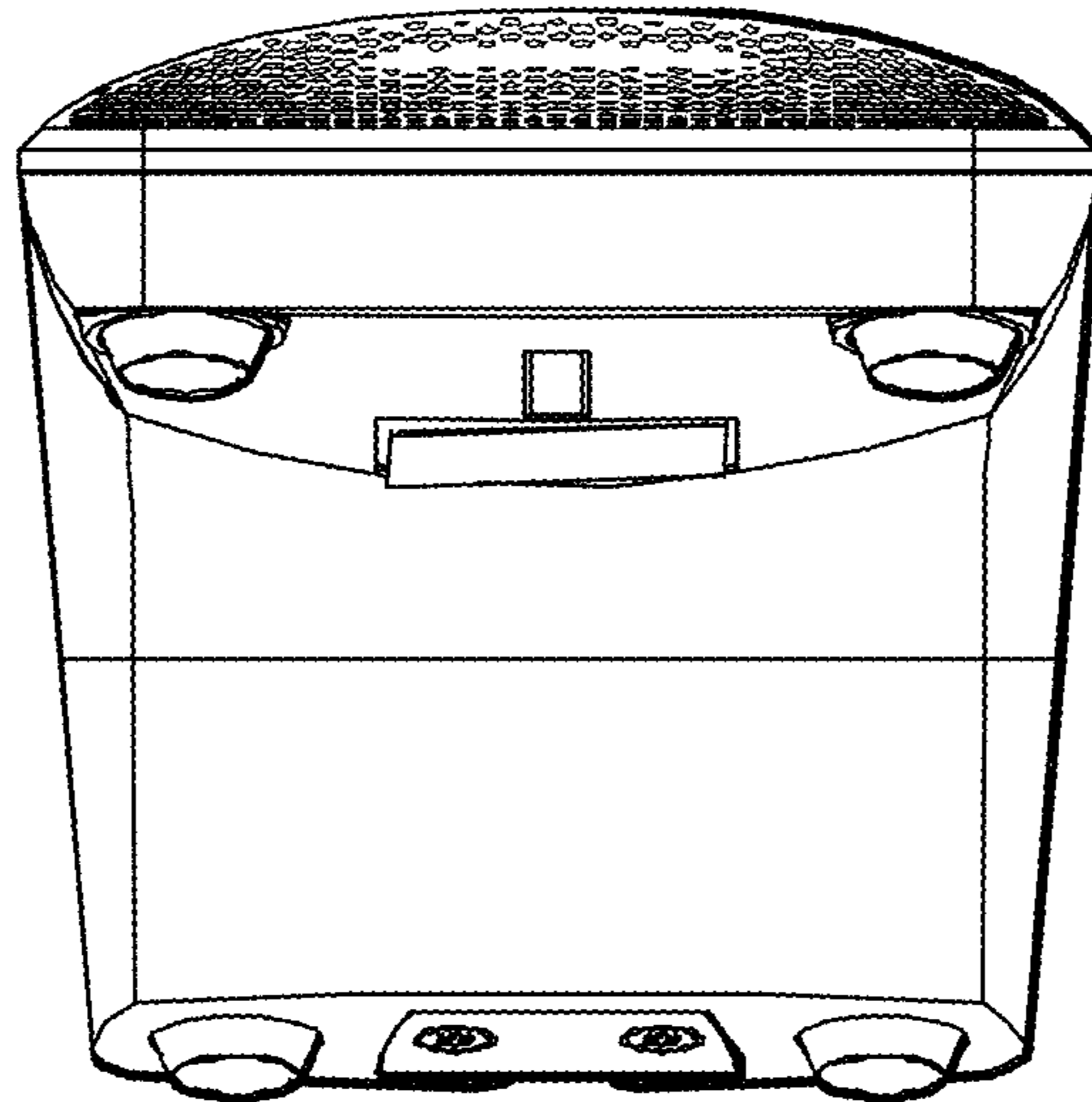

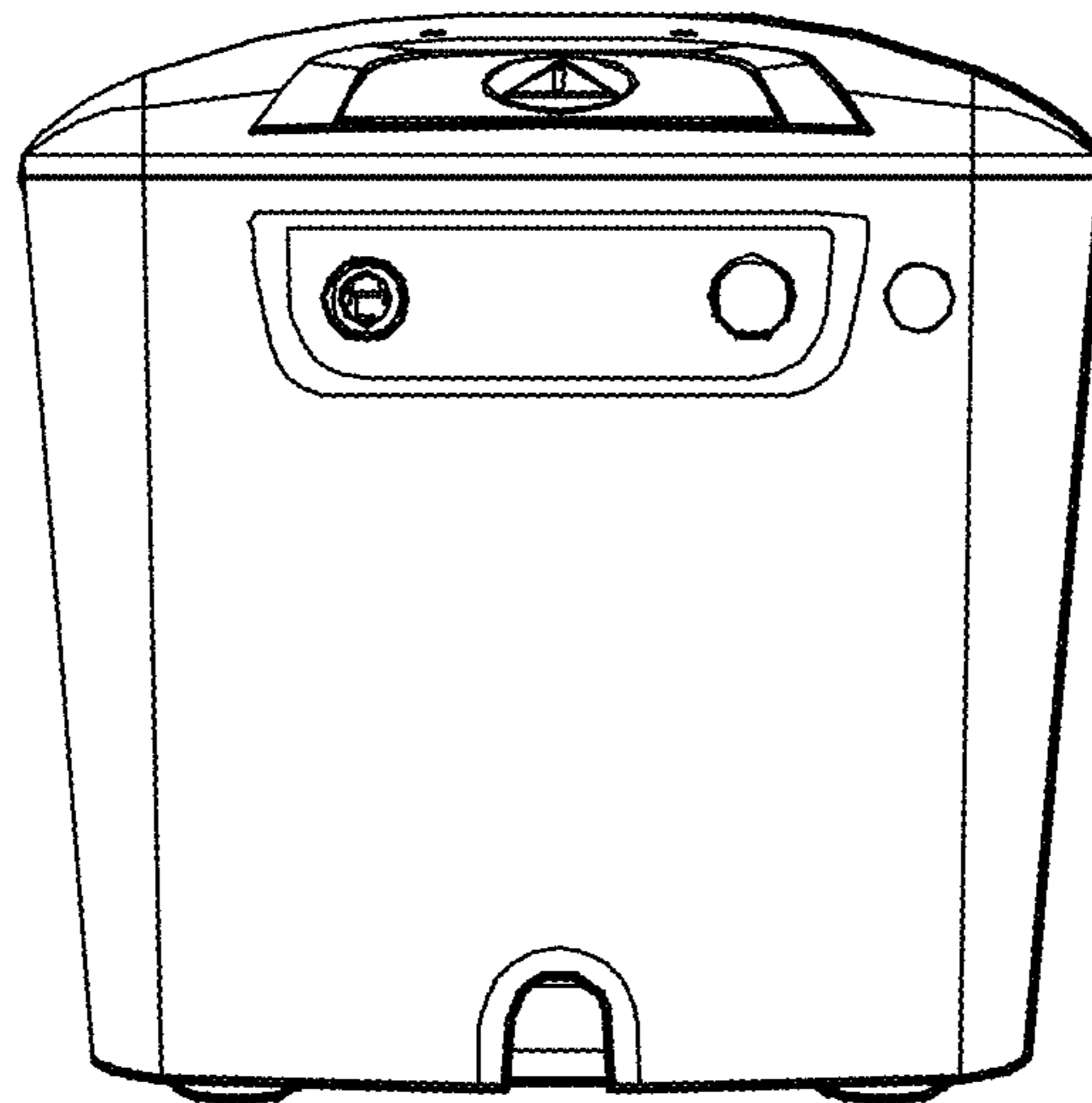

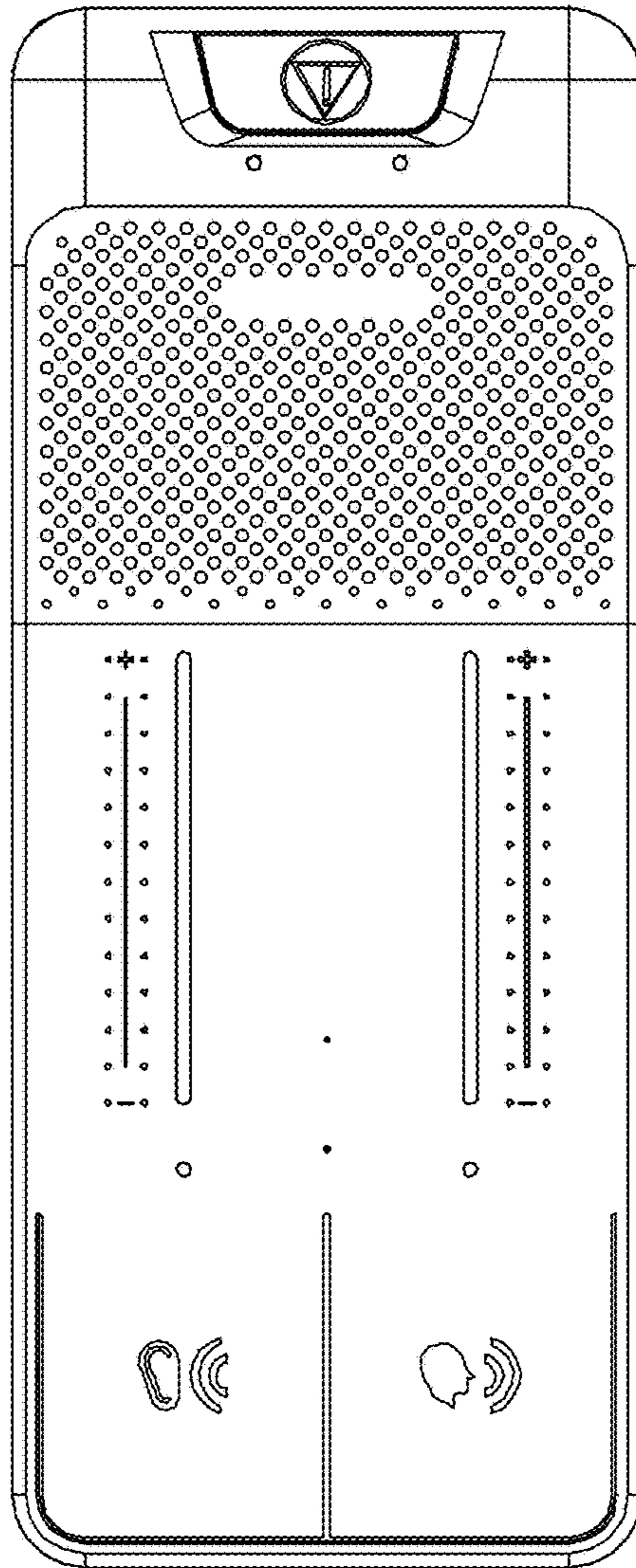

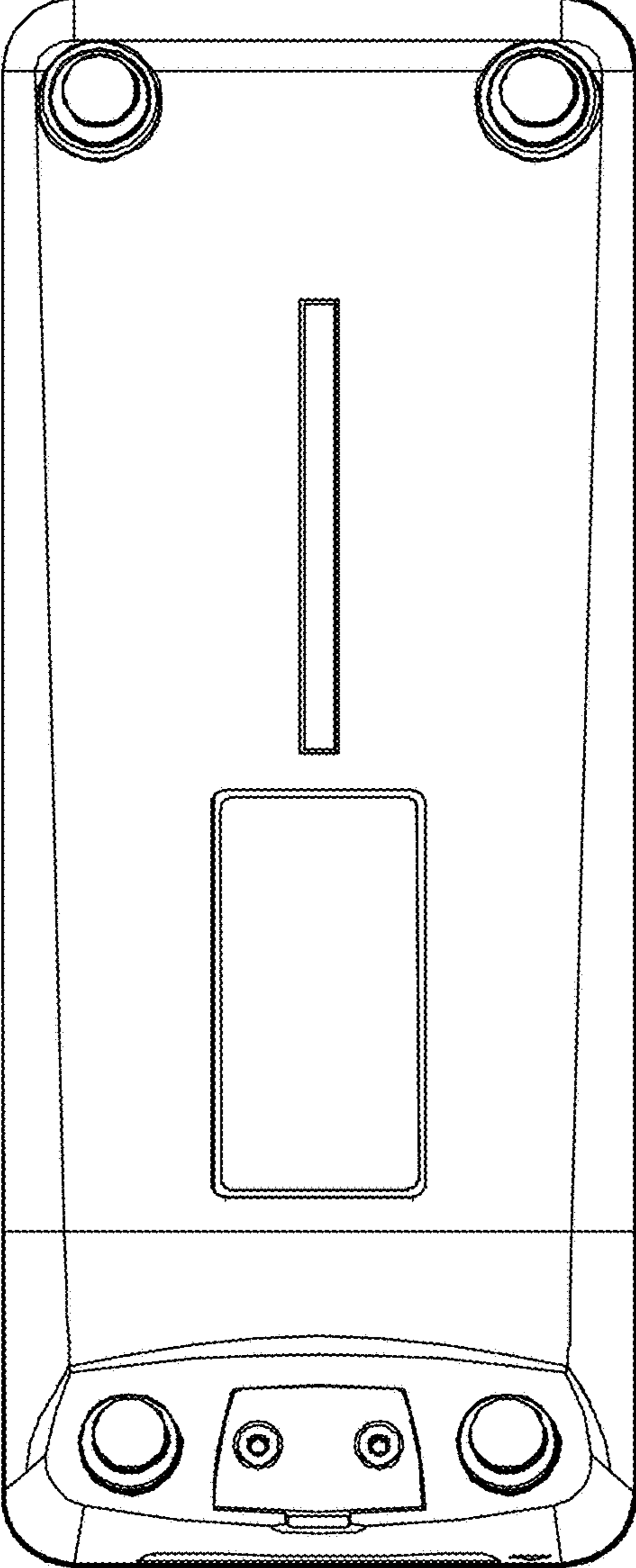

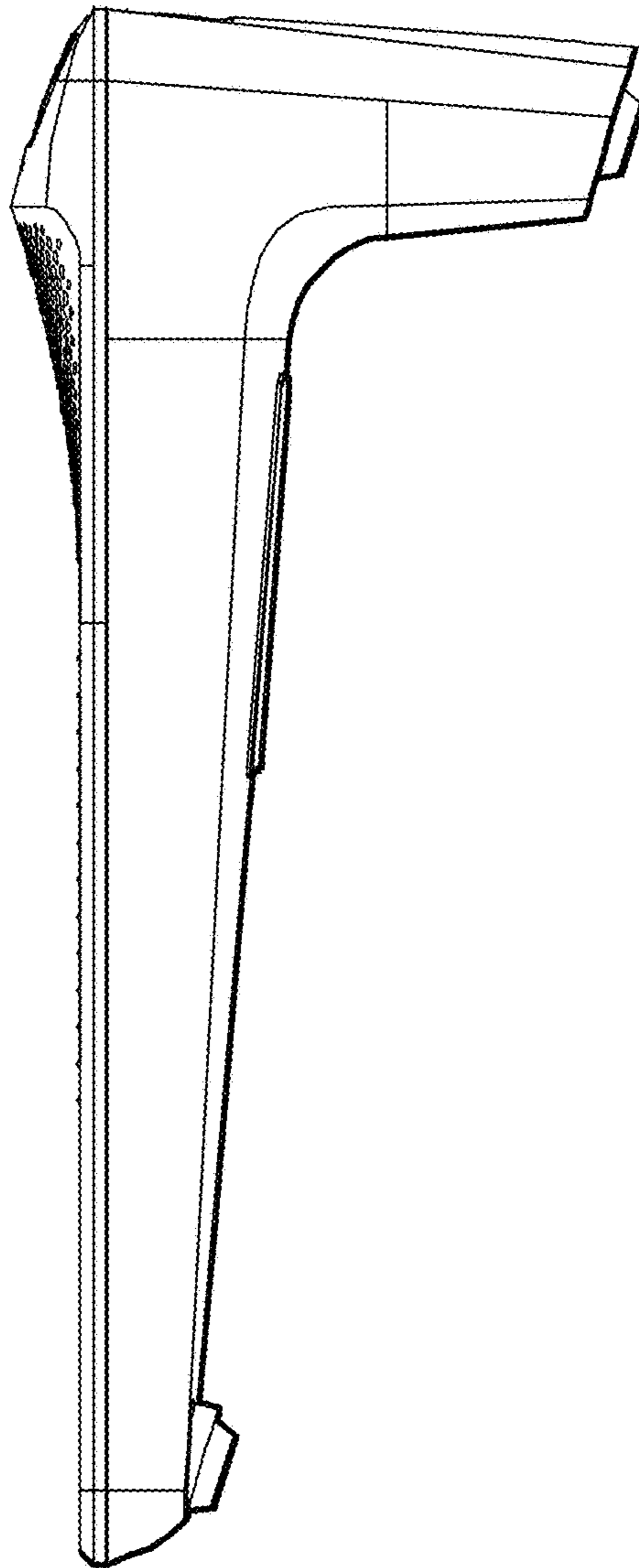

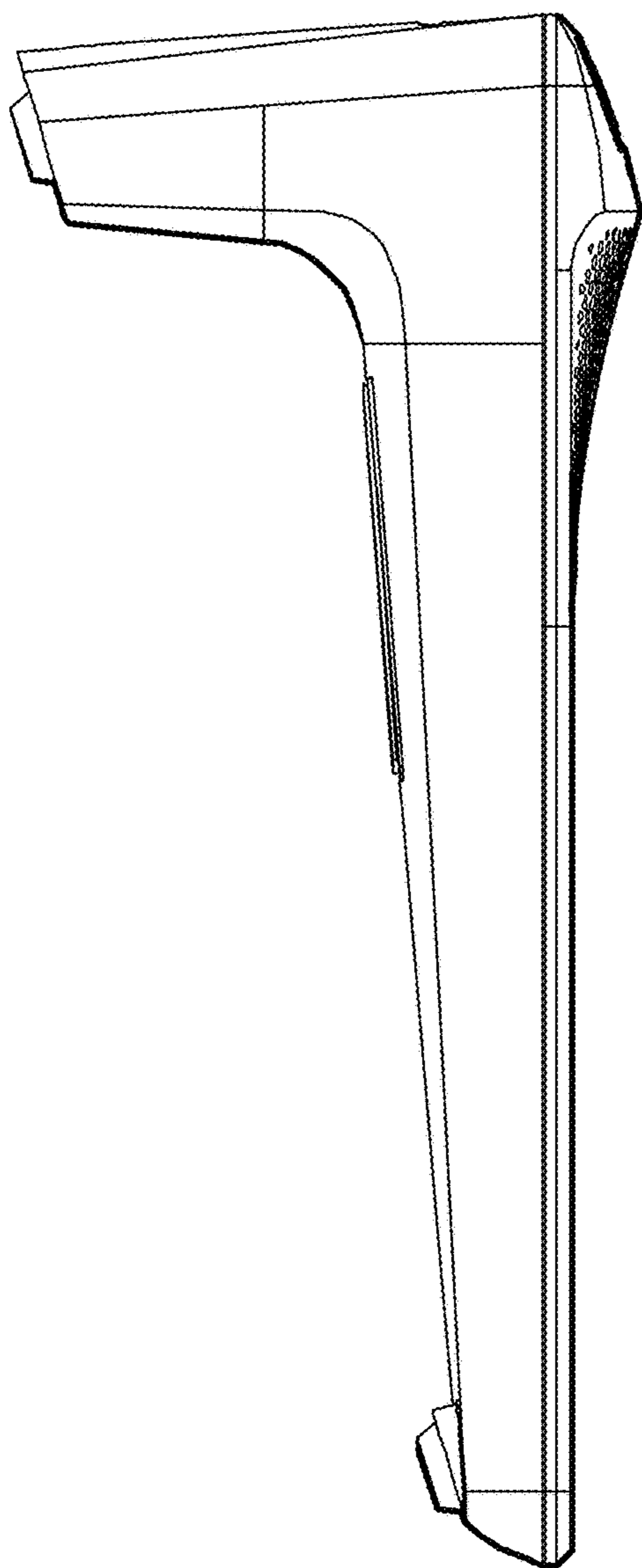
