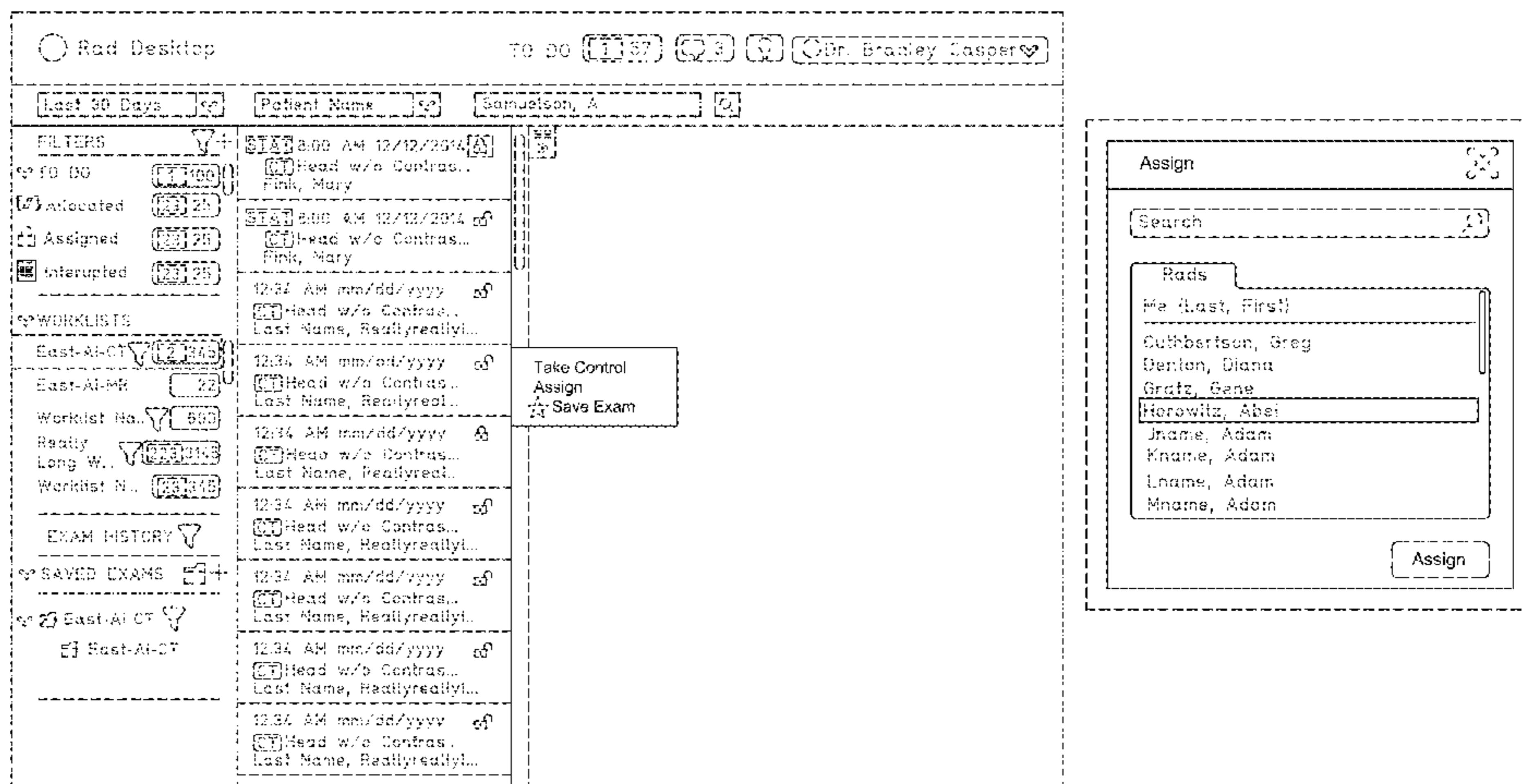
FIG. 1 is a front view of a first image in a sequence of a display screen or portion thereof with transitional graphical user interface; and,

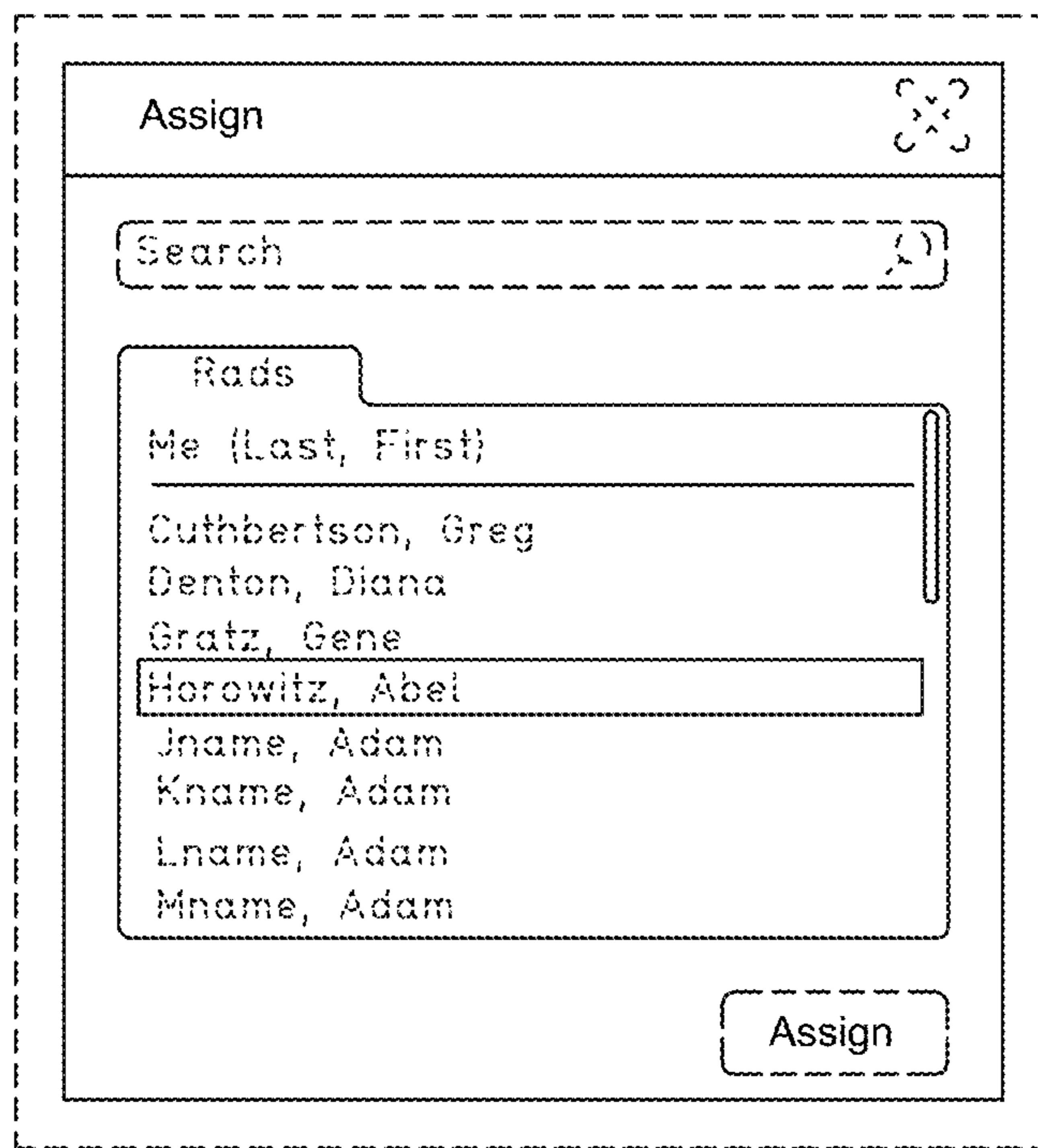
