DESCRIPTION

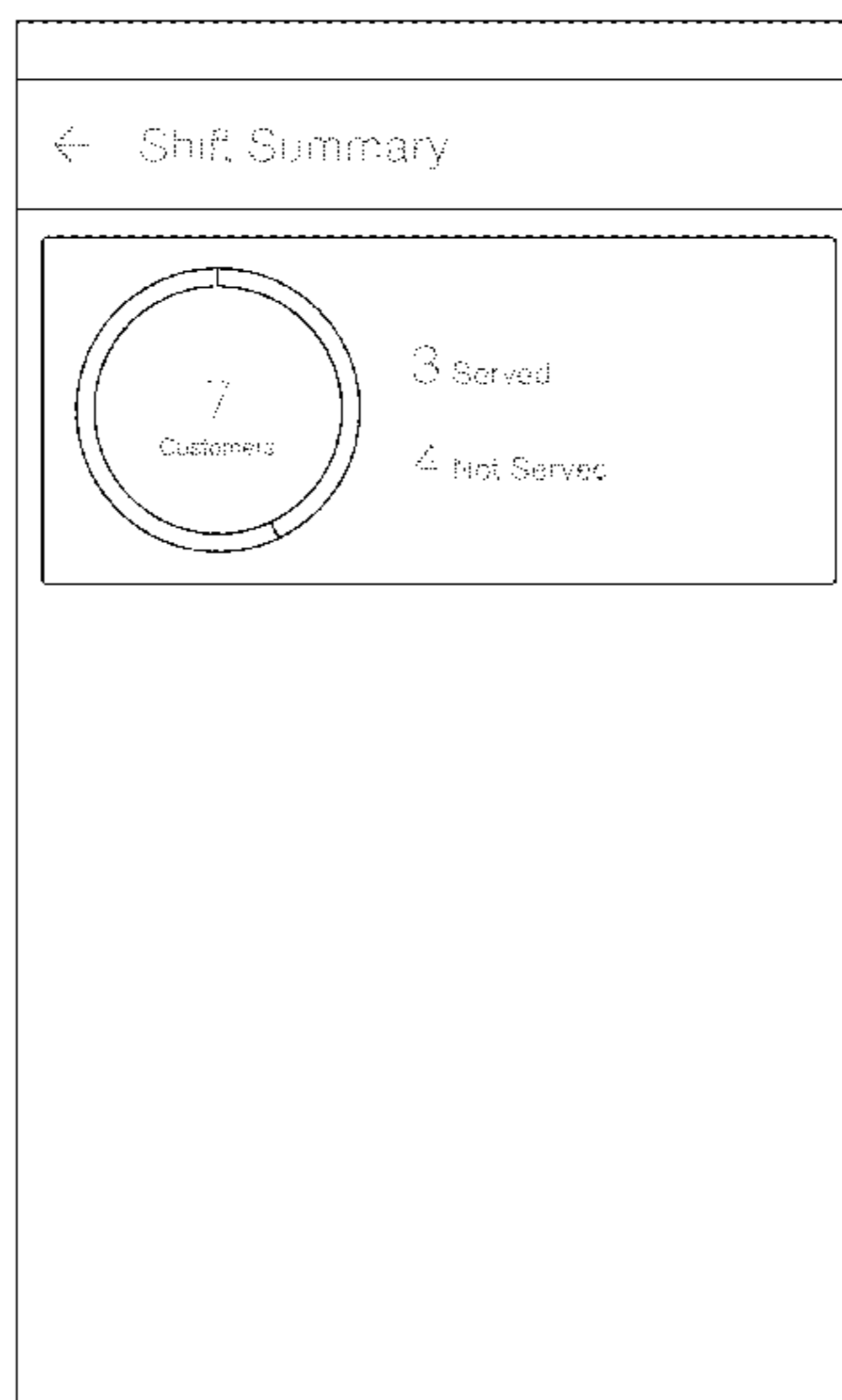

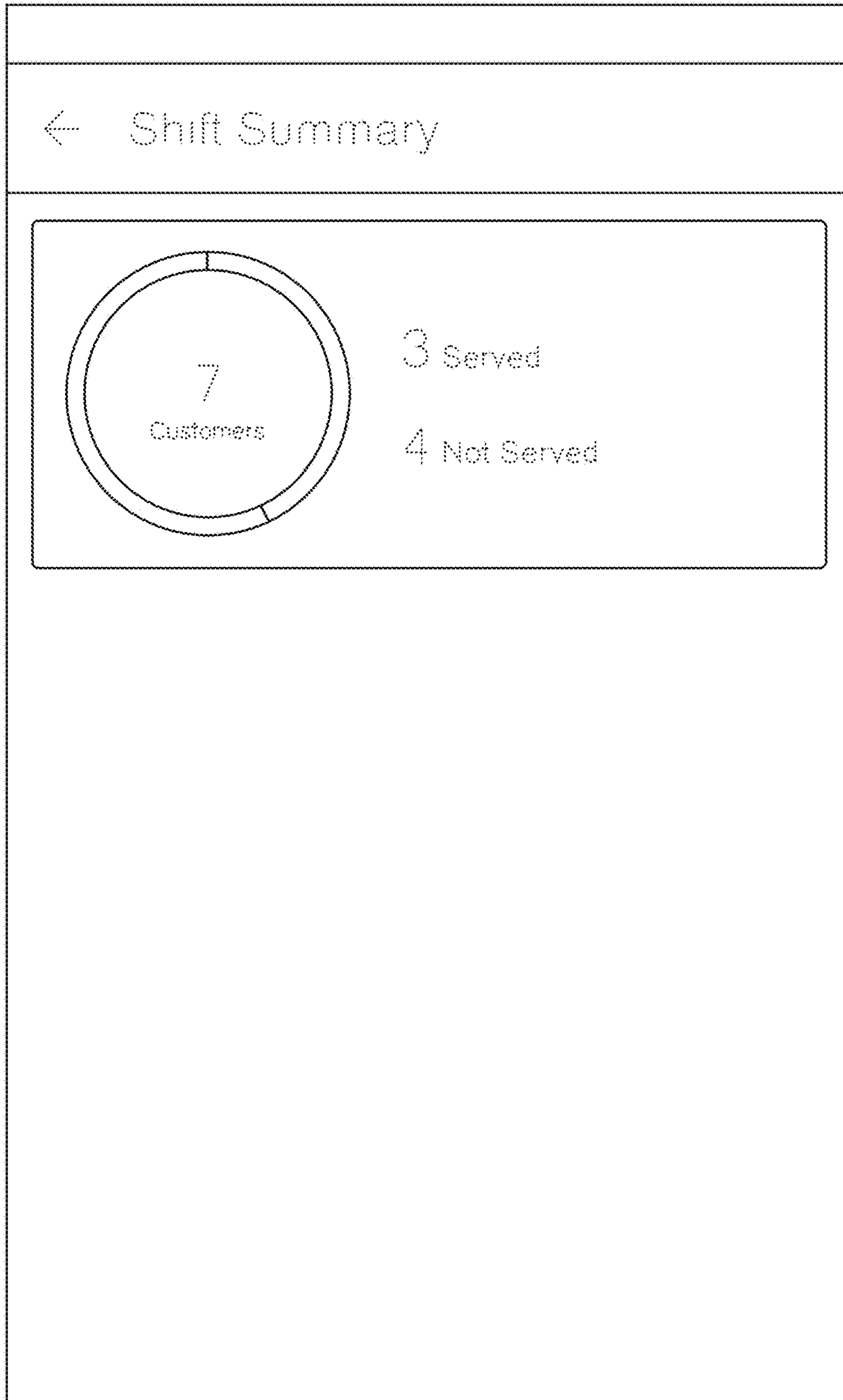

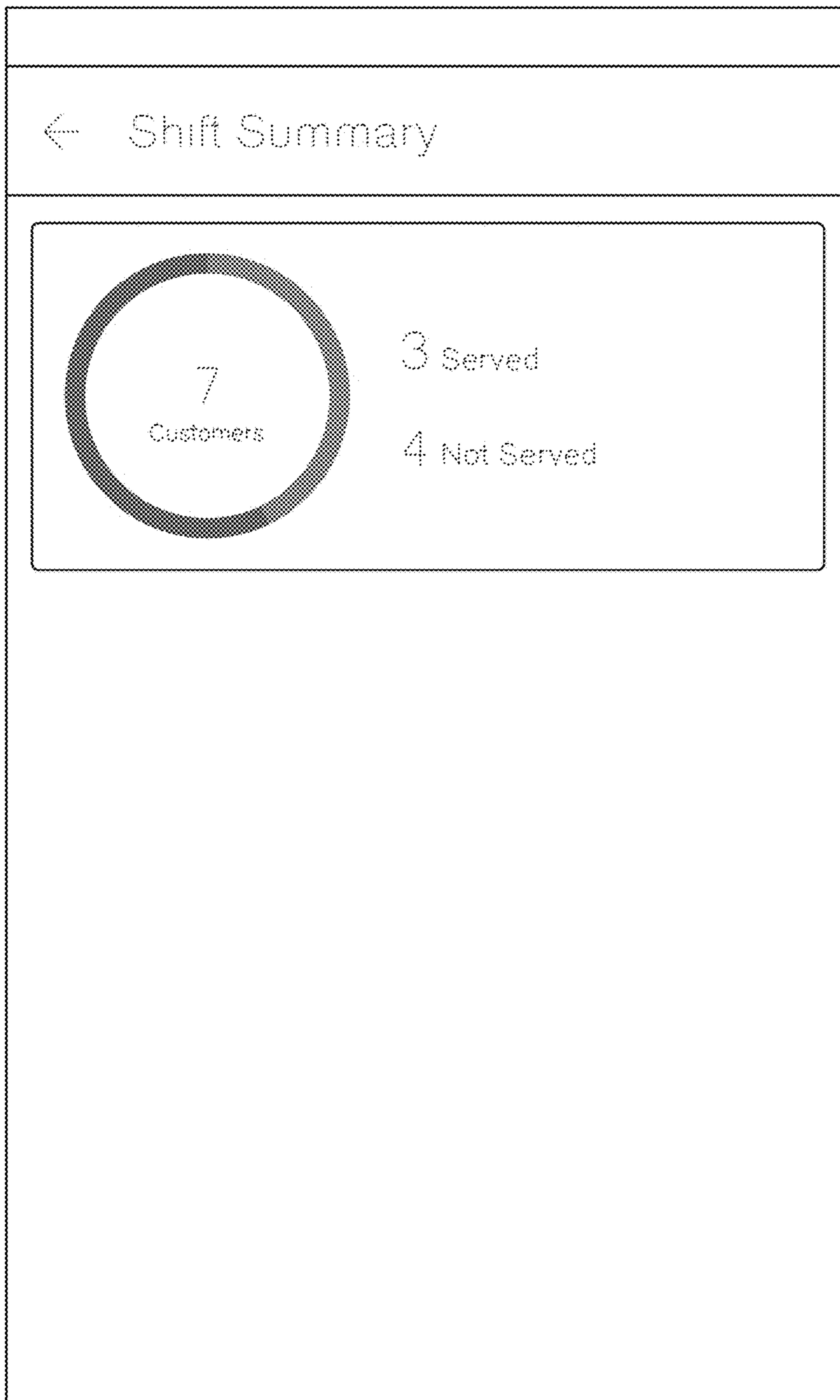
