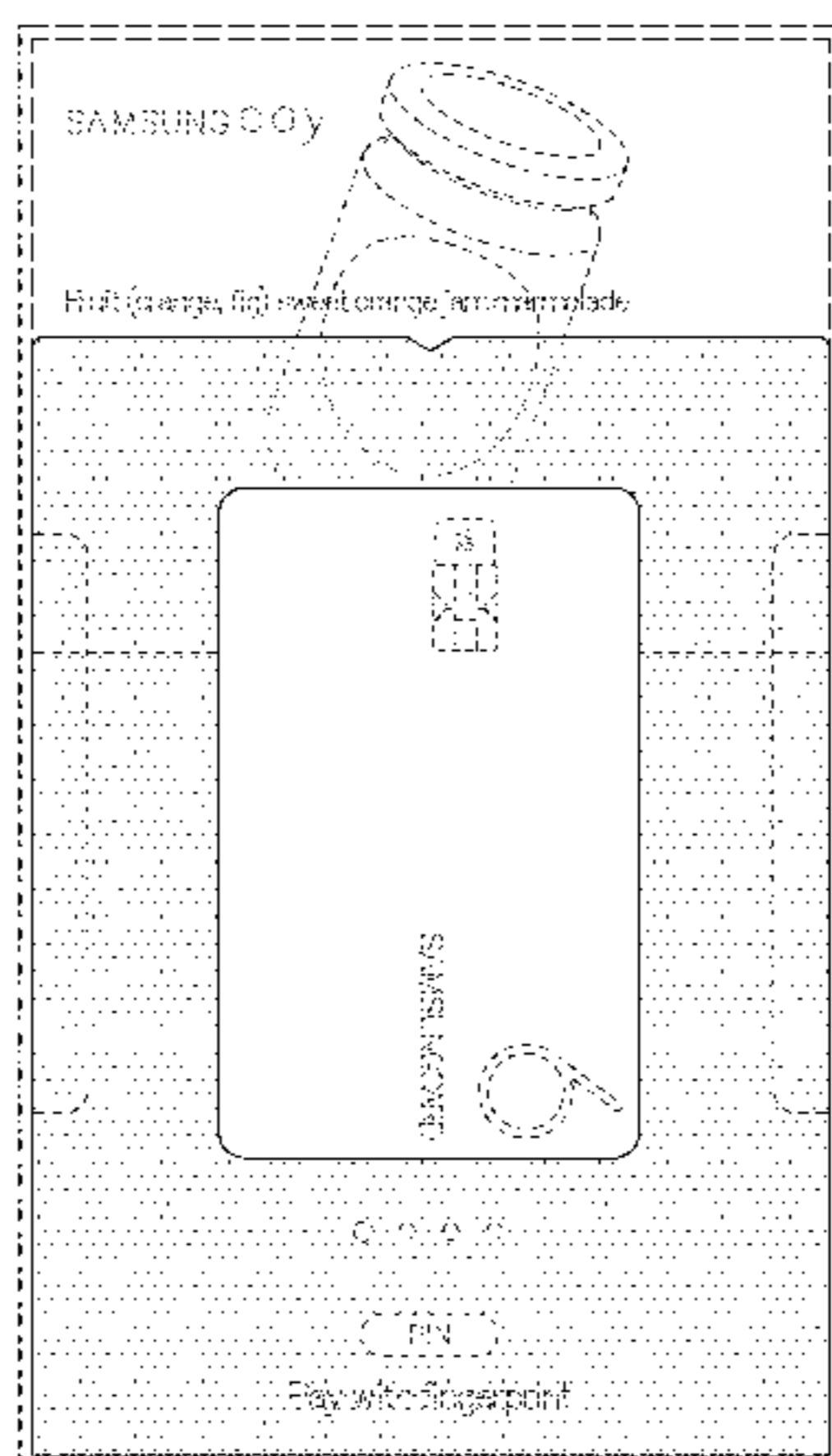
(57) **CLAIM**

The ornamental design for a display screen or portion thereof with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a first embodiment; and, FIG. 2 is a front view of a display screen or portion thereof with graphical user interface showing our new design according to a second embodiment. The outermost broken lines in the drawings illustrate a display screen or portion thereof and form no part of the claimed design. The remaining broken lines in the drawings illustrate portions of the graphical user interface that form no part of the claimed design. The stipple shading in the drawings portrays the illusion of translucent portions of the

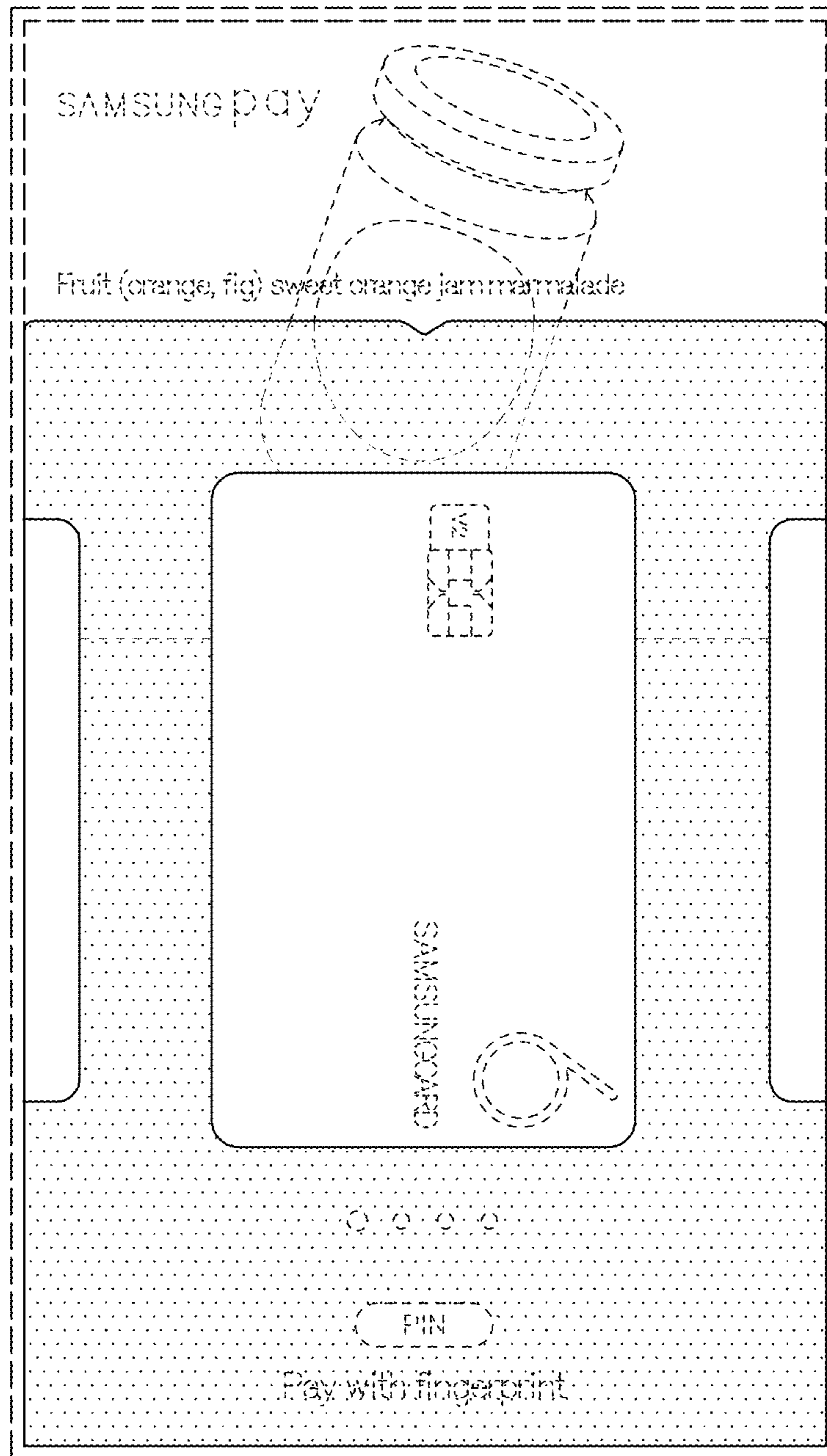
