(57) **CLAIM**

The ornamental design for a display panel of a programmed computer system with a graphical user interface, as shown and described.

**DESCRIPTION**

The FIGURE is a front view of a display panel of a programmed computer system with a graphical user interface.

The outermost broken line illustrates a display screen and forms no part of the claimed design. The remaining broken lines illustrate portions of the graphical user interface and form no part of the claimed design.
