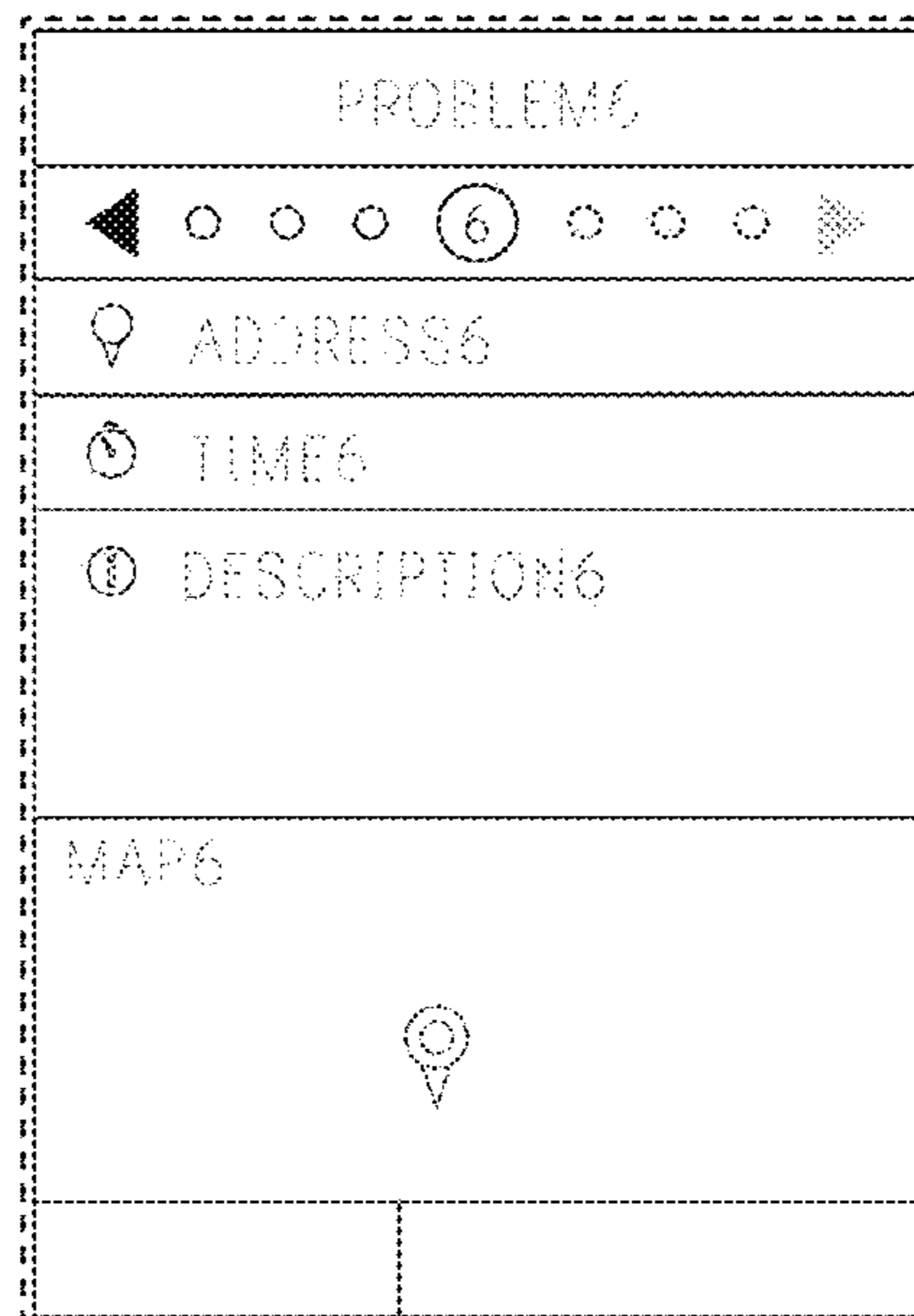
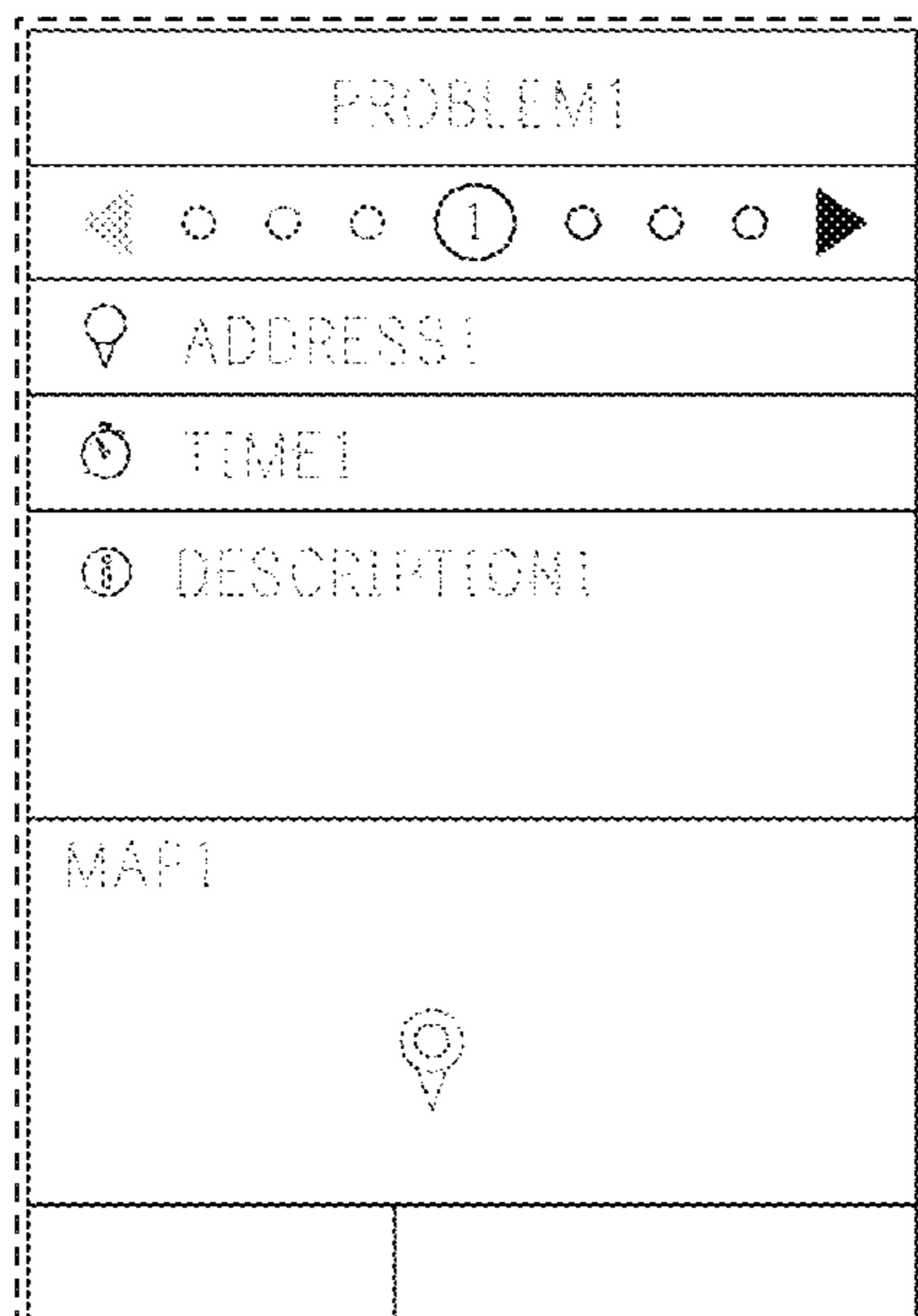
(57) **CLAIM**

The ornamental design for a display screen with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a first image of a display screen with a transitional graphical user interface;
 FIG. 2 is a second image of the display screen shown in FIG. 1;
 FIG. 3 is a third image of the display screen shown in FIG. 1;
 FIG. 4 is a fourth image of the display screen shown in FIG. 1;
 FIG. 5 is a fifth image of the display screen shown in FIG. 1; and,
 FIG. 6 is a sixth image of the display screen shown in FIG. 1.
 The appearance of the transitional graphical user interface sequentially transitions between the images shown in FIGS. 1-6. The broken lines showing of the text and the remainder of the graphical user interface and display screen is for environmental purposes only and forms no part of the claimed design.

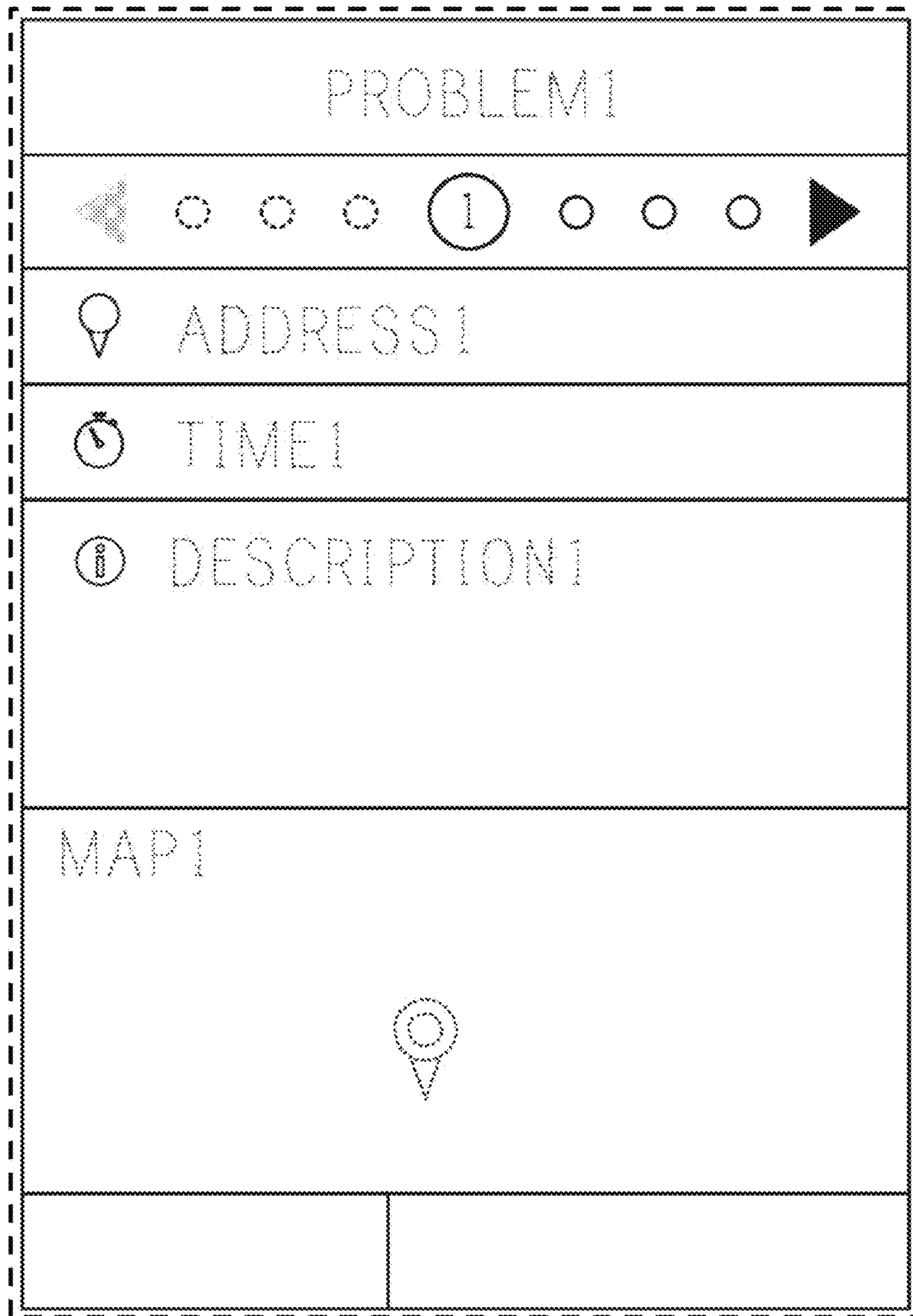

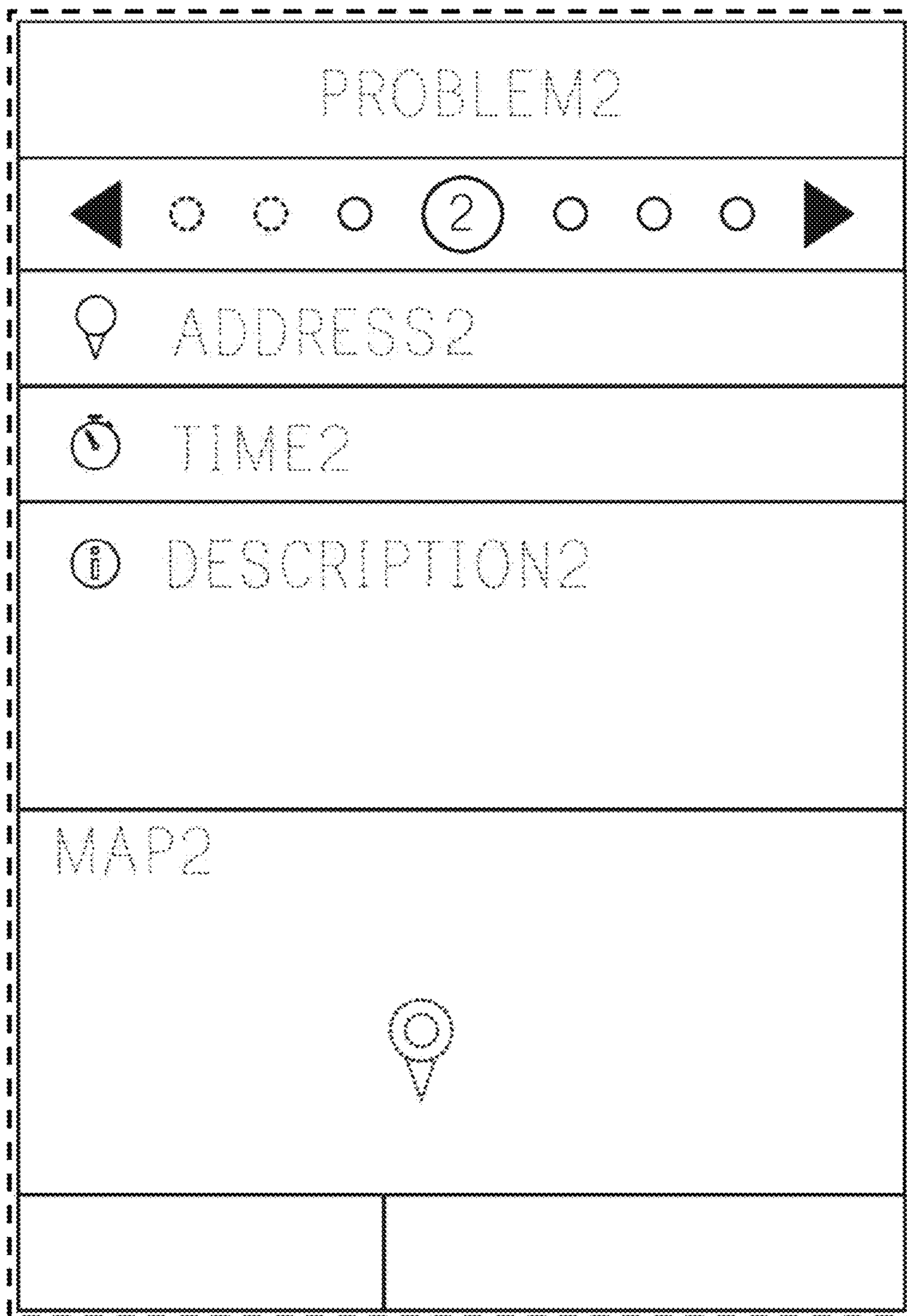

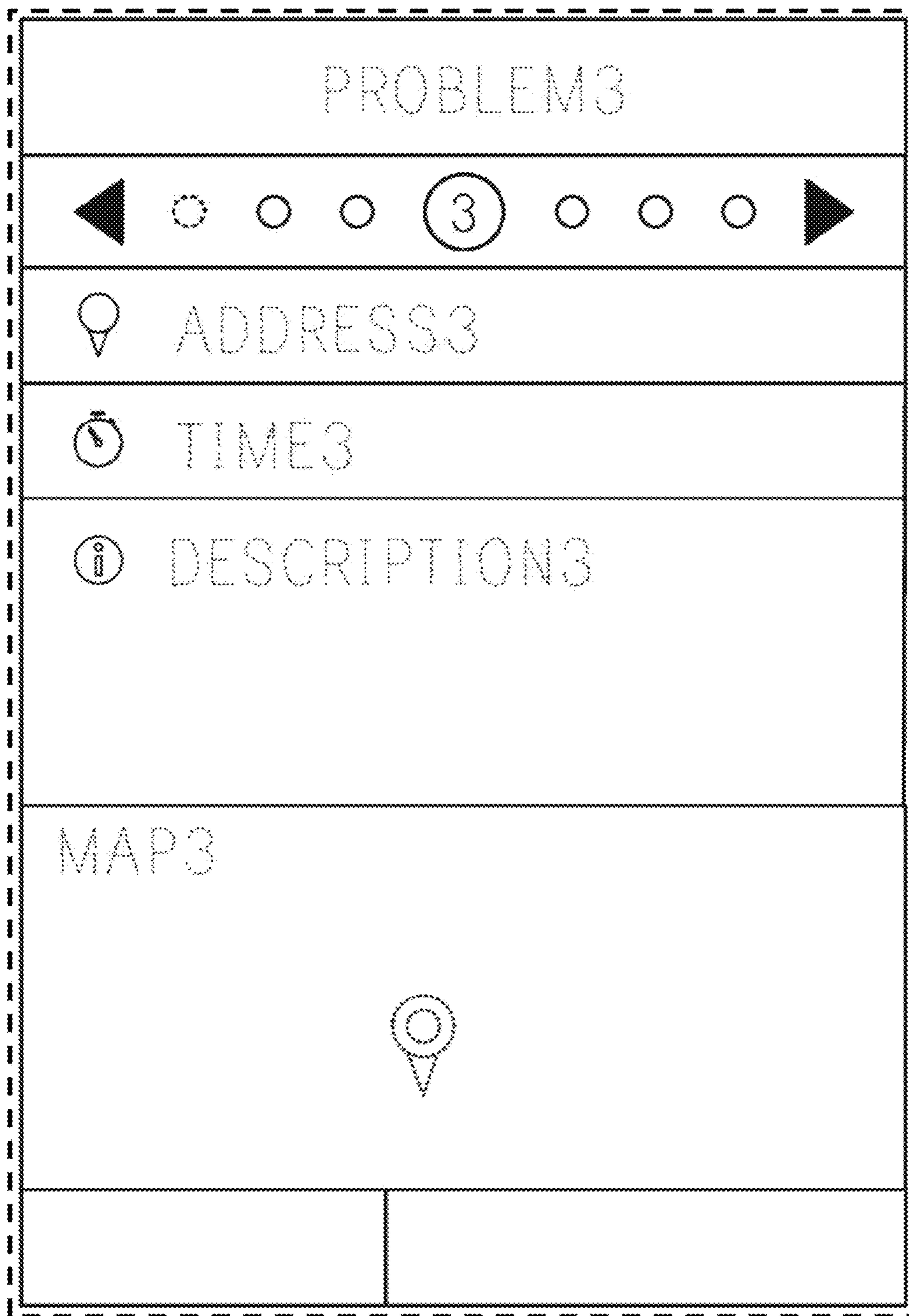

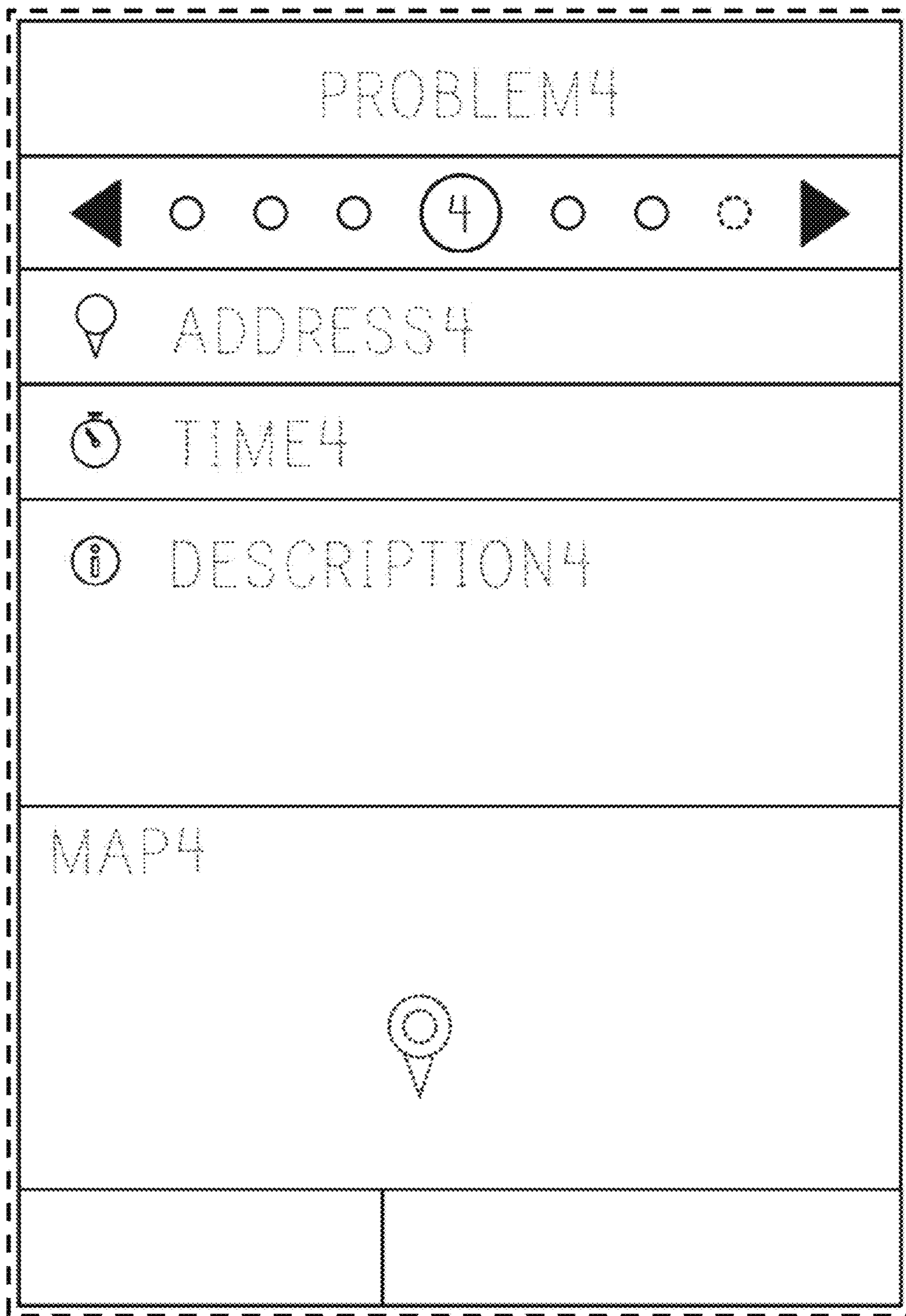

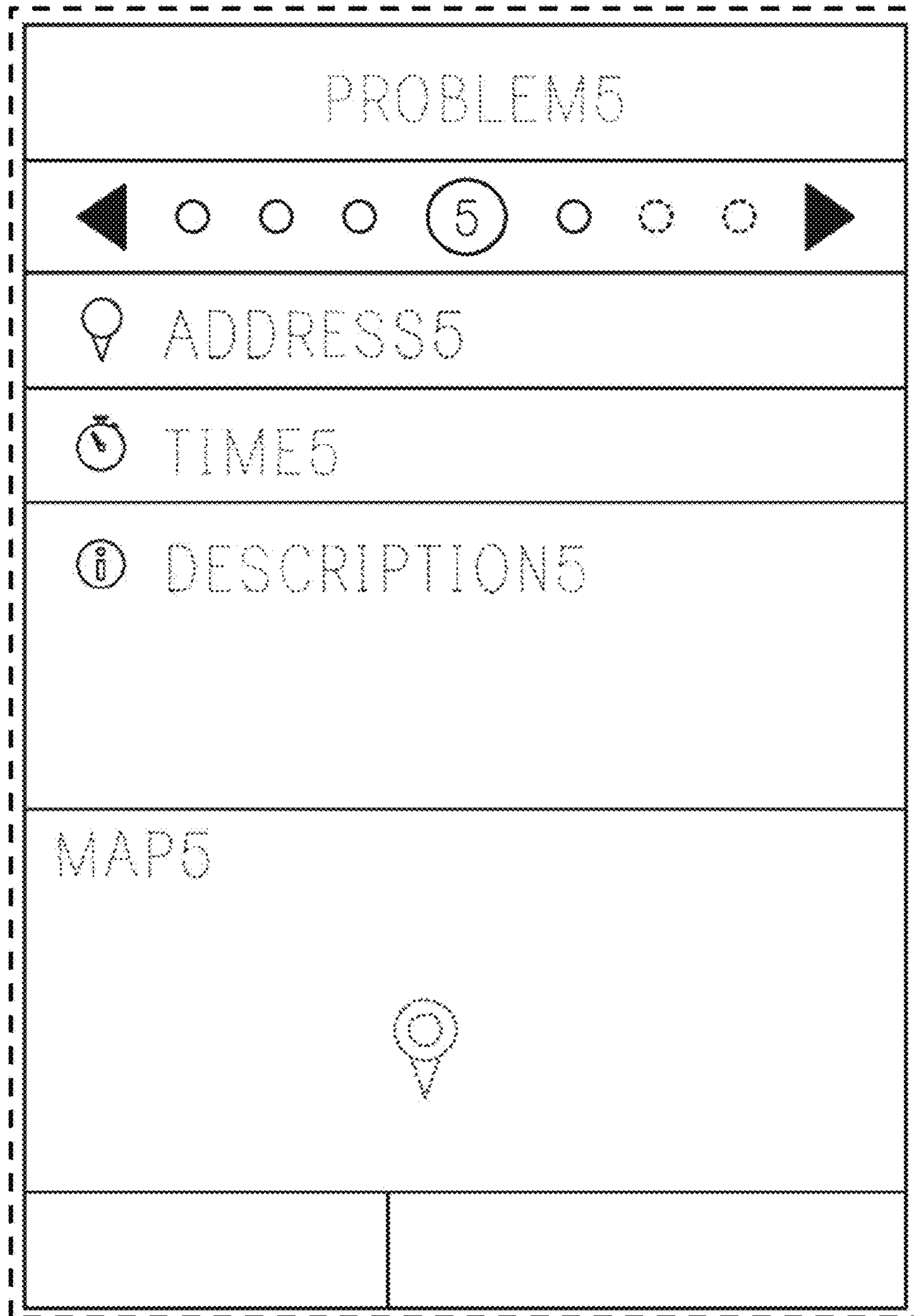

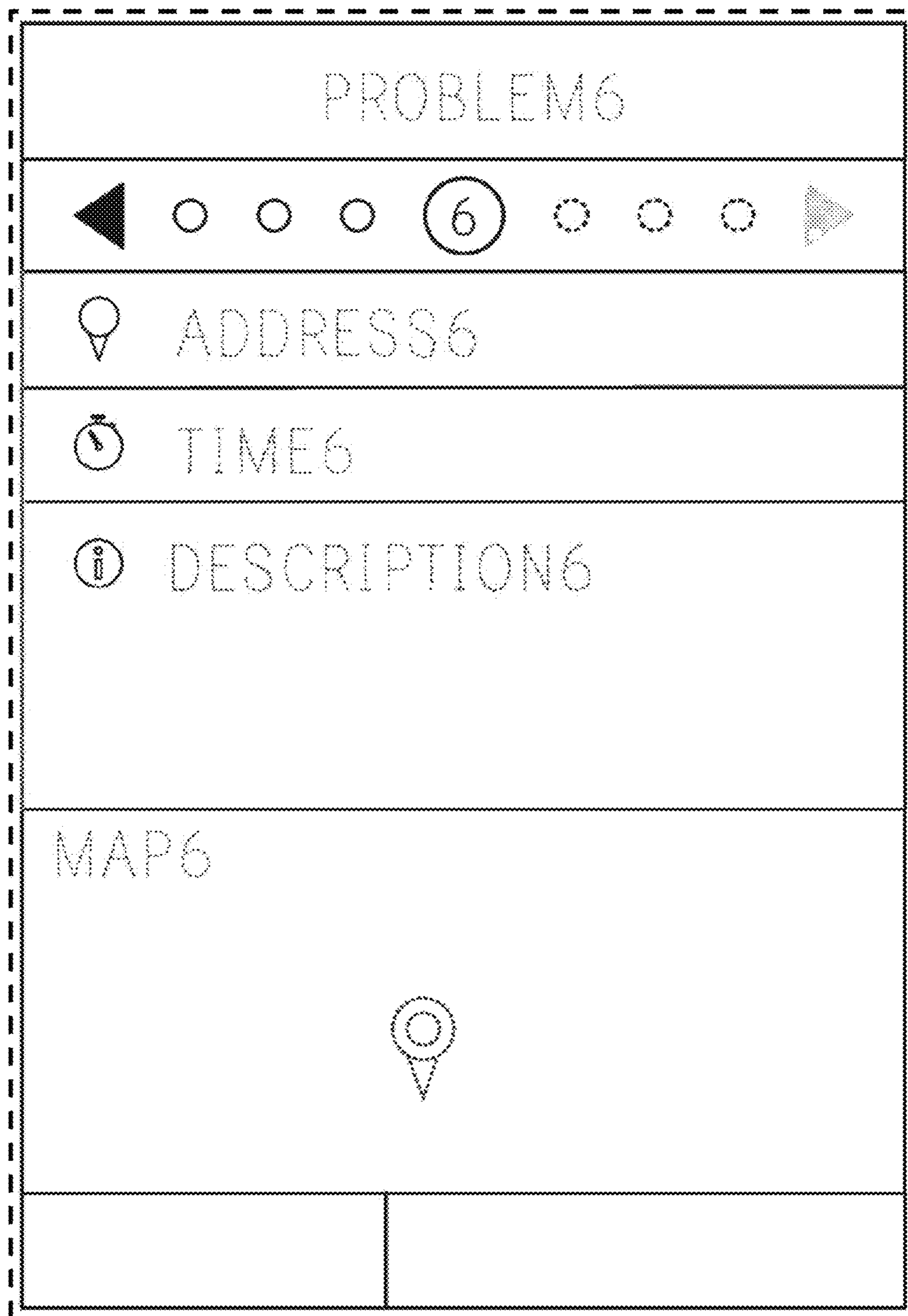
