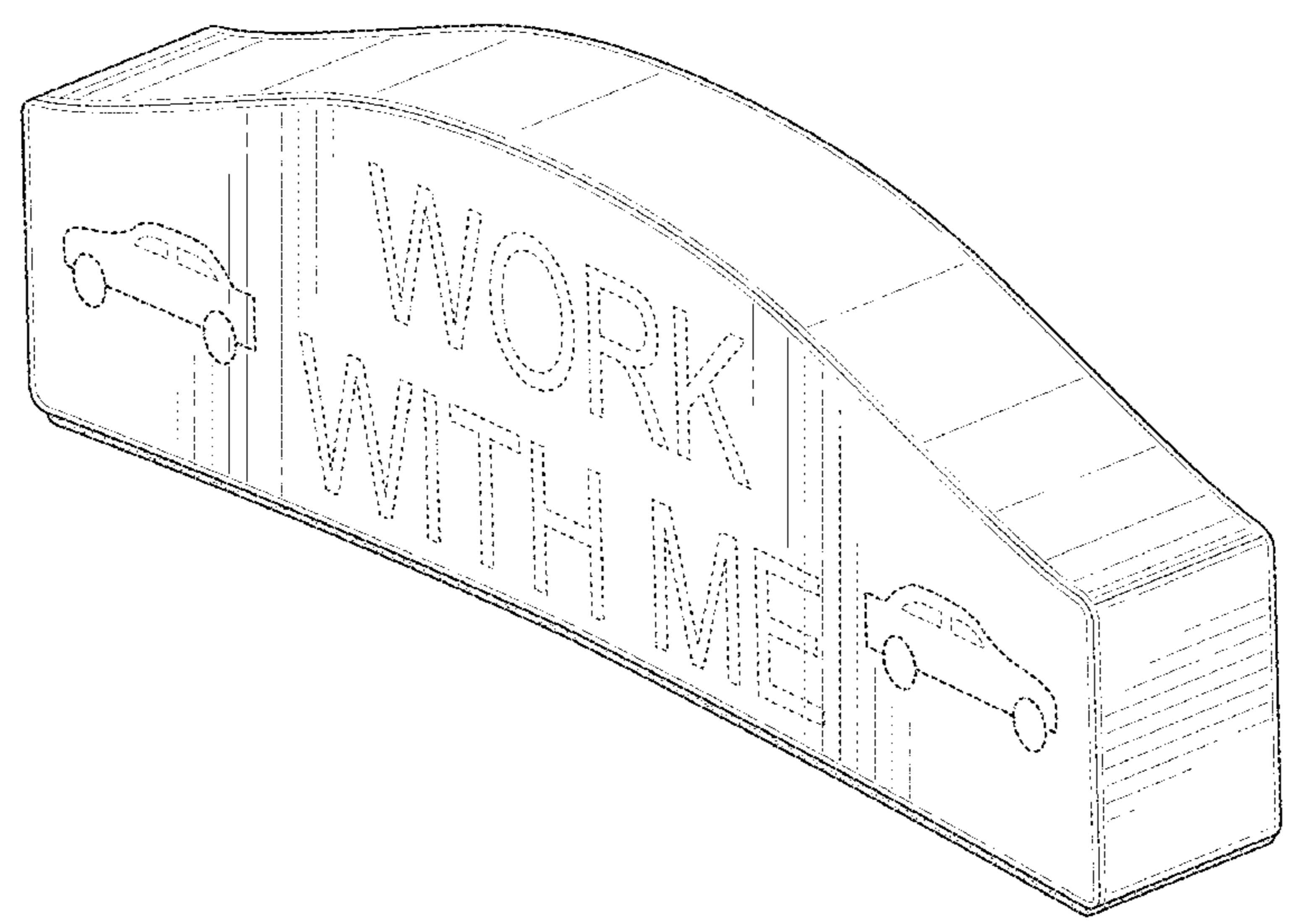
The ornamental design for a magnetic car top sign, as shown and described.

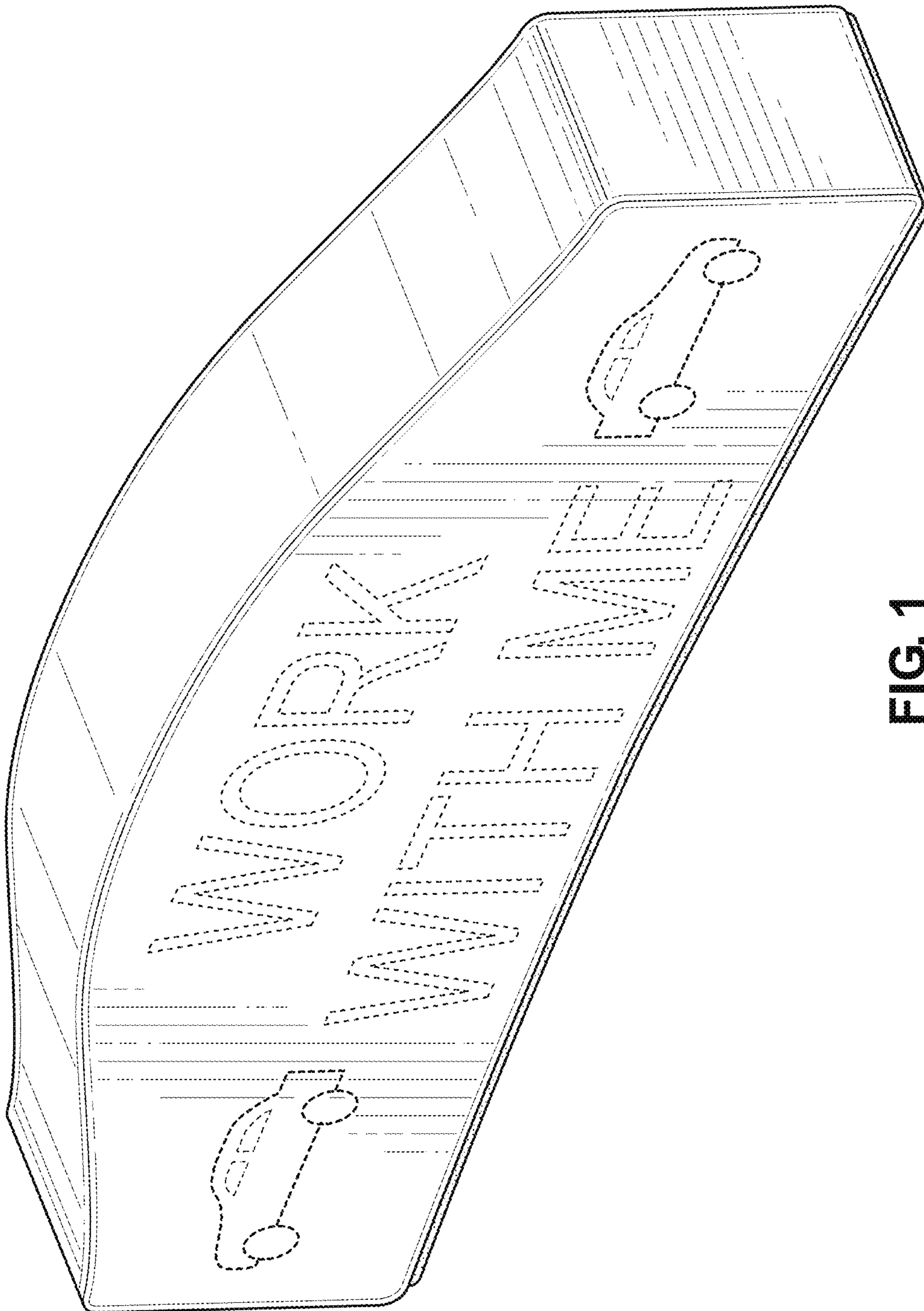

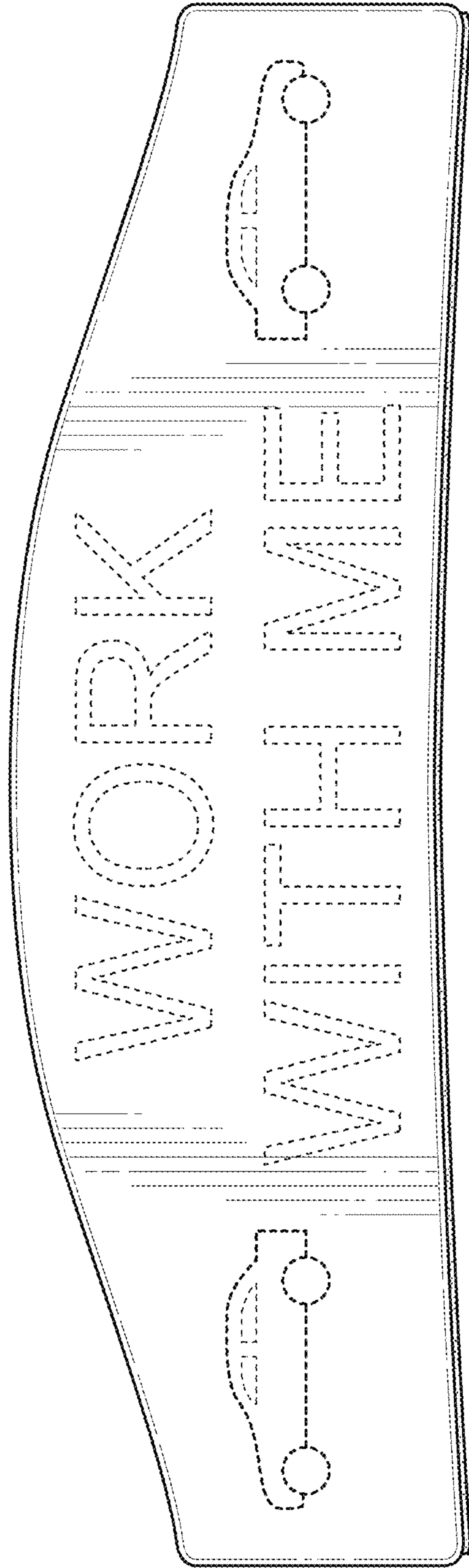

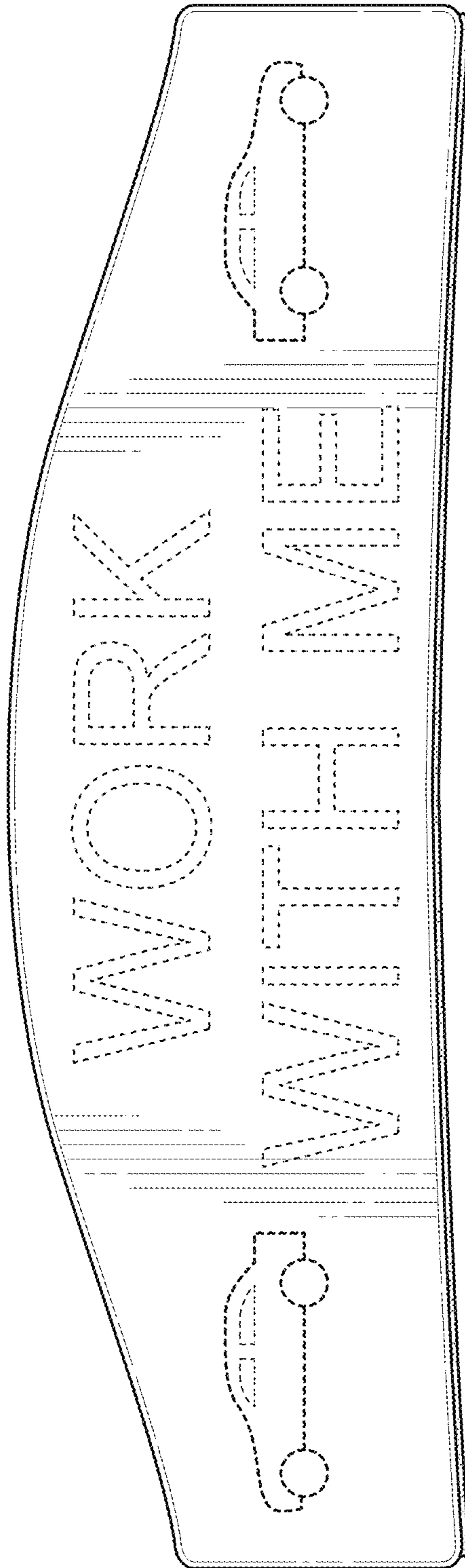
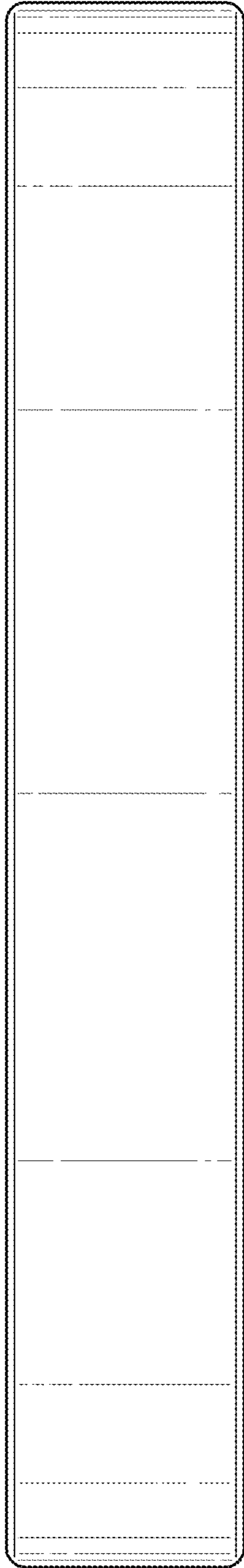
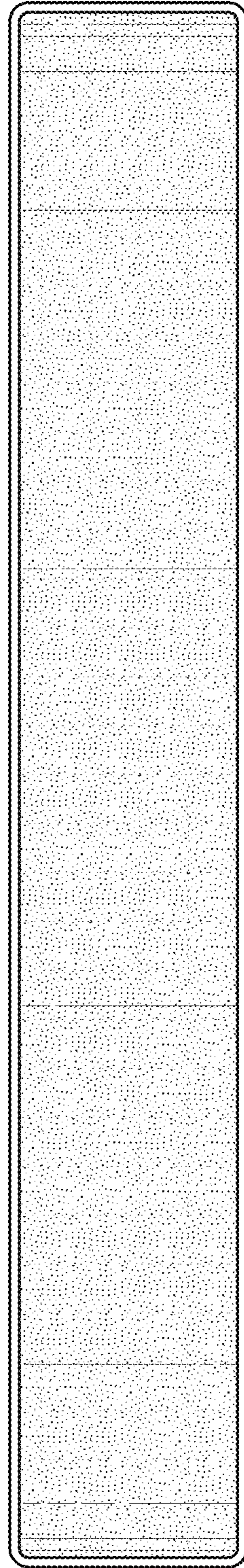

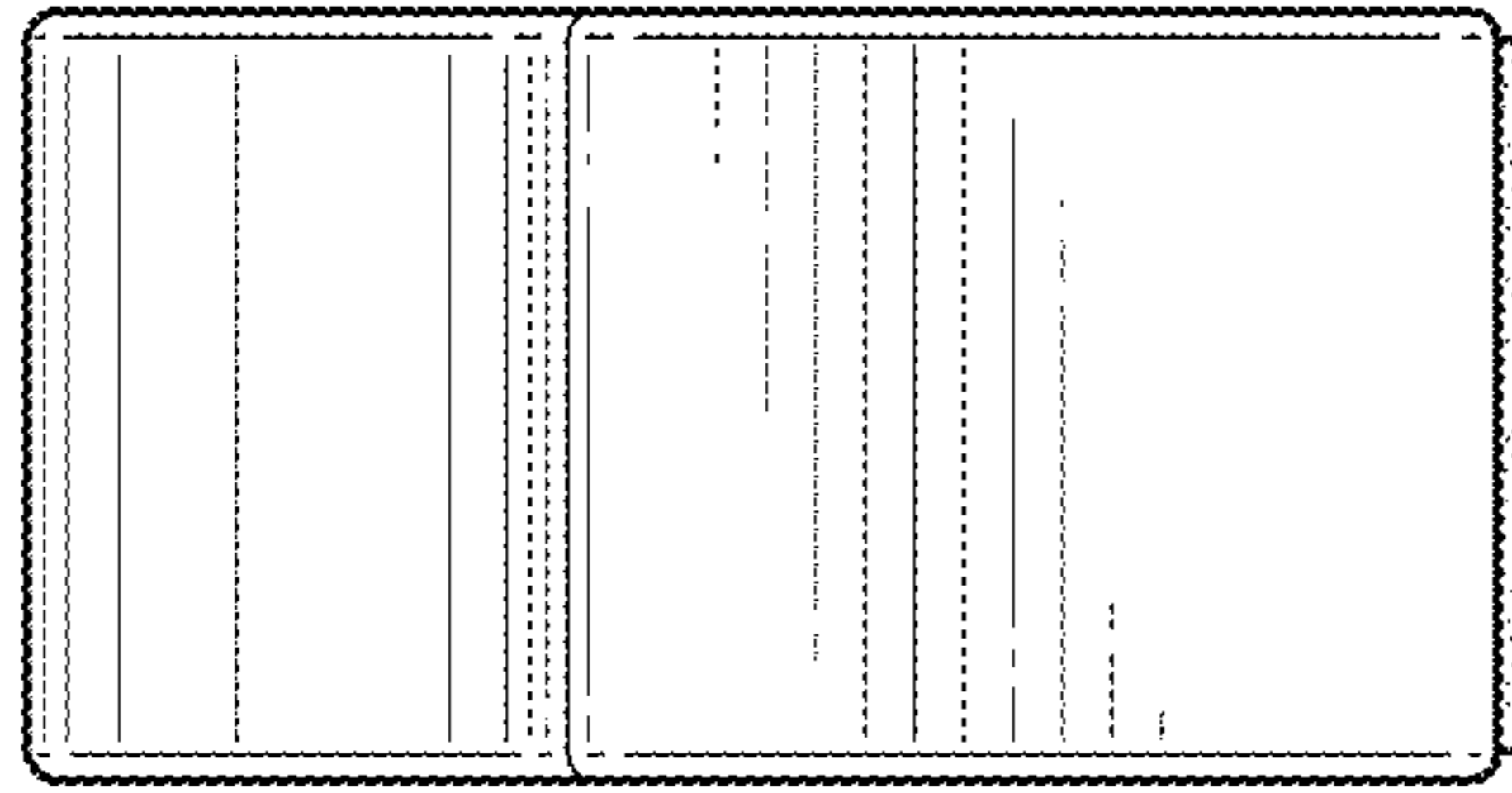

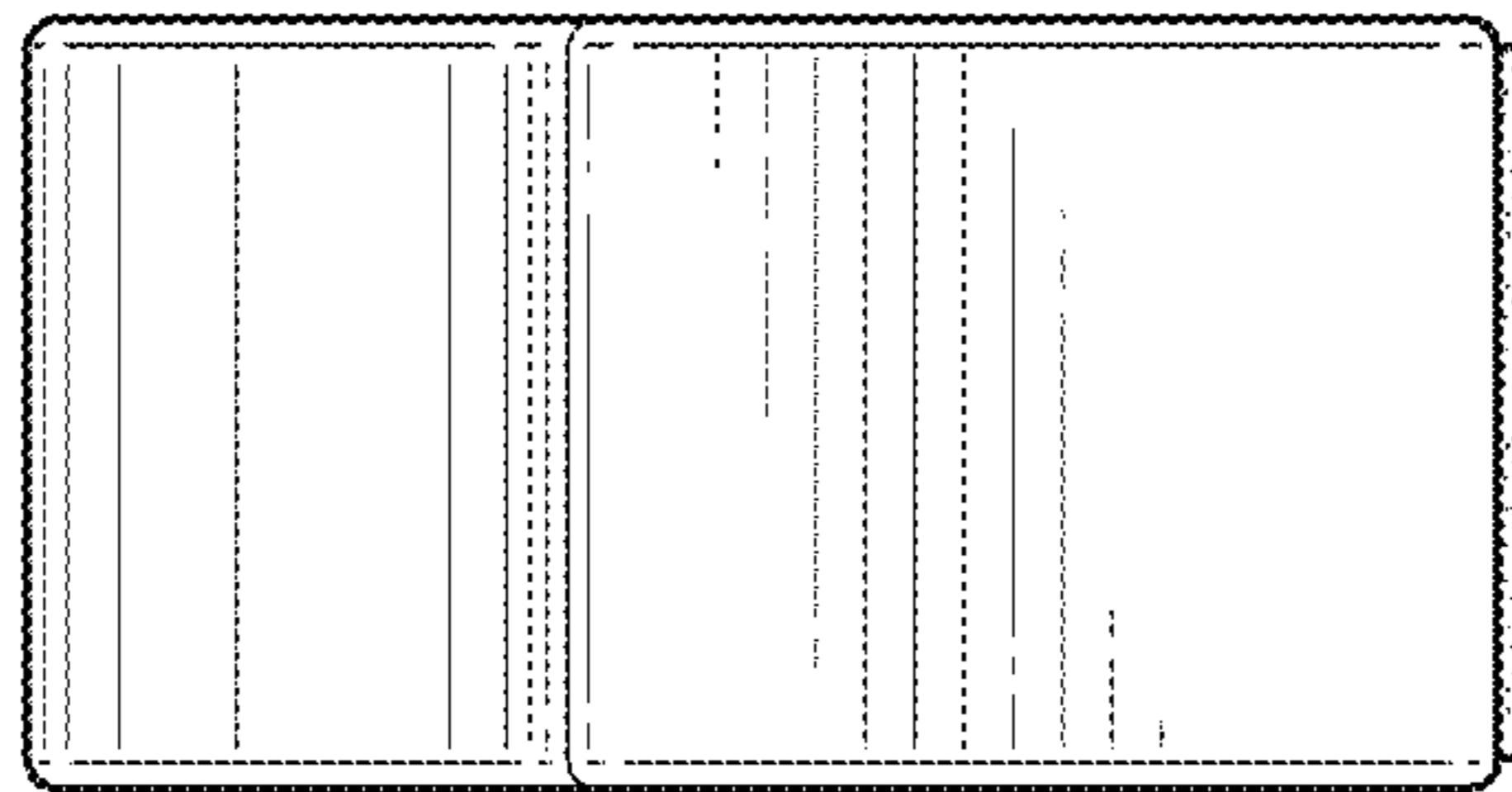
