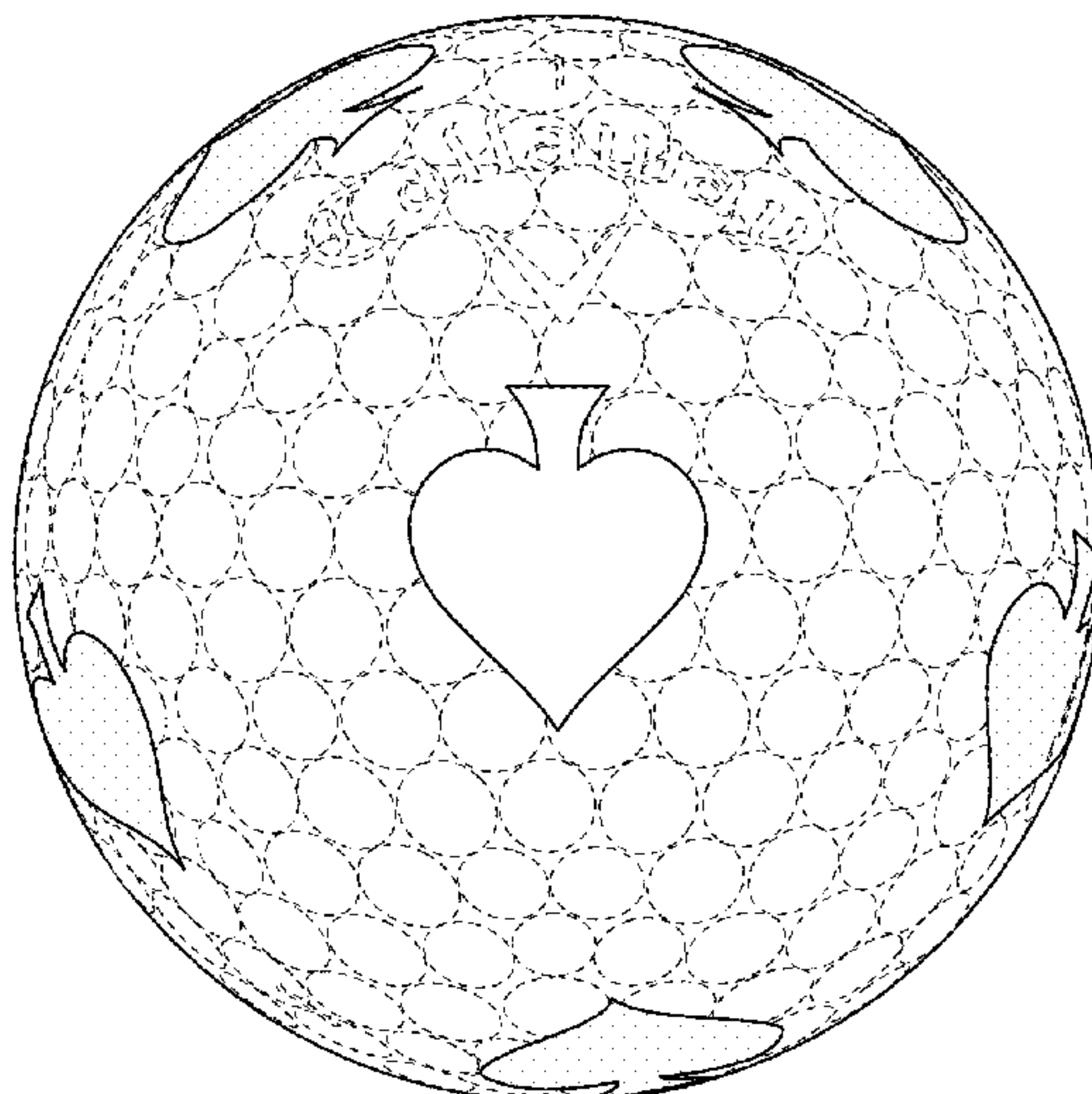
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top plan view of a golf ball showing our new design;
 FIG. 2 is bottom plan view thereof;
 FIG. 3 is a front elevation view thereof;
 FIG. 4 is a rear elevation view thereof;
 FIG. 5 is a side elevation view thereof; and,
 FIG. 6 is another side elevation view thereof.
 The broken lines in the drawings are for the purpose of illustration portion of the golf ball, which form no part of the claimed design. The trademark "Callaway V" logo is a trademark of the Callaway Golf Company.

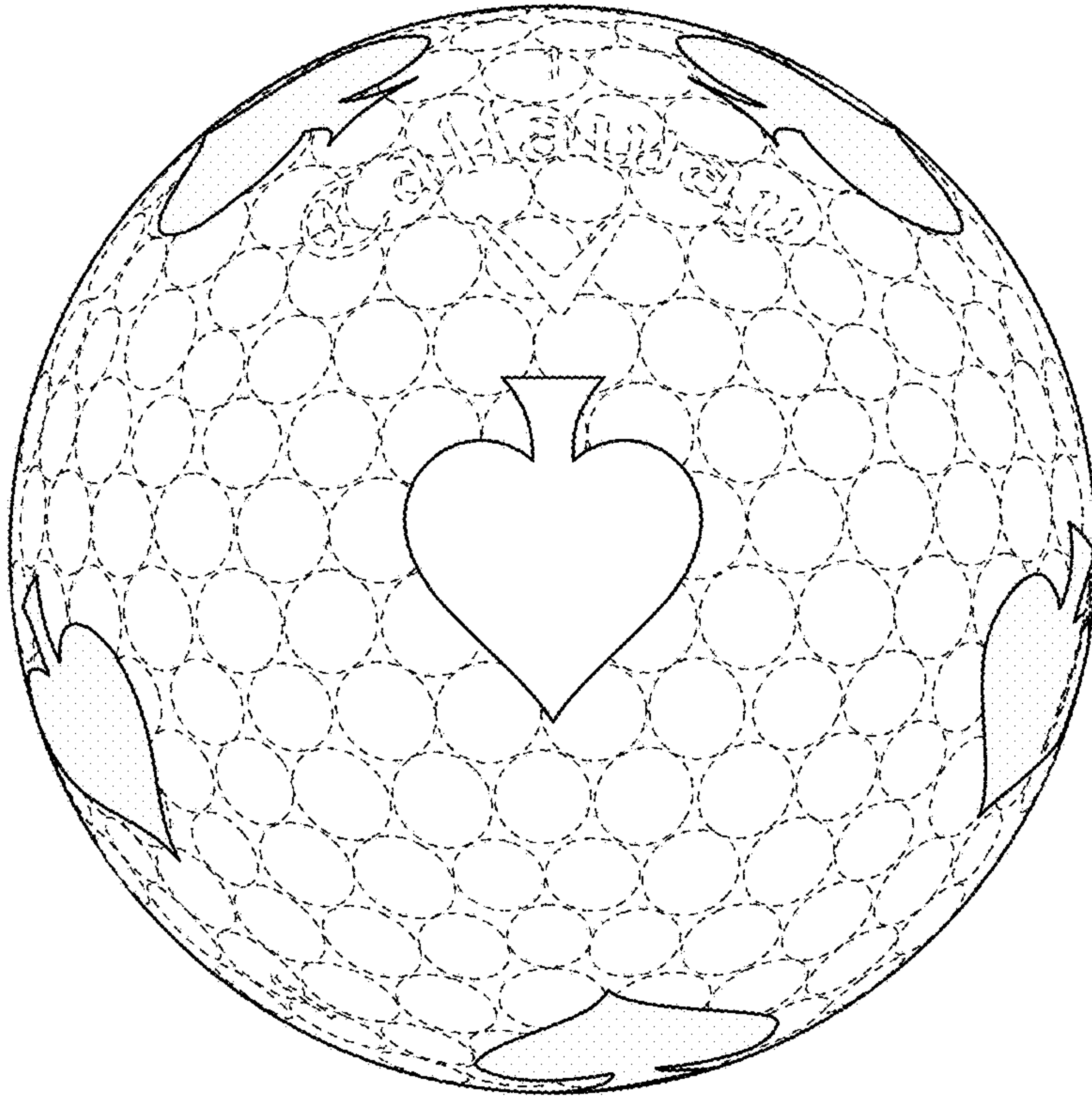

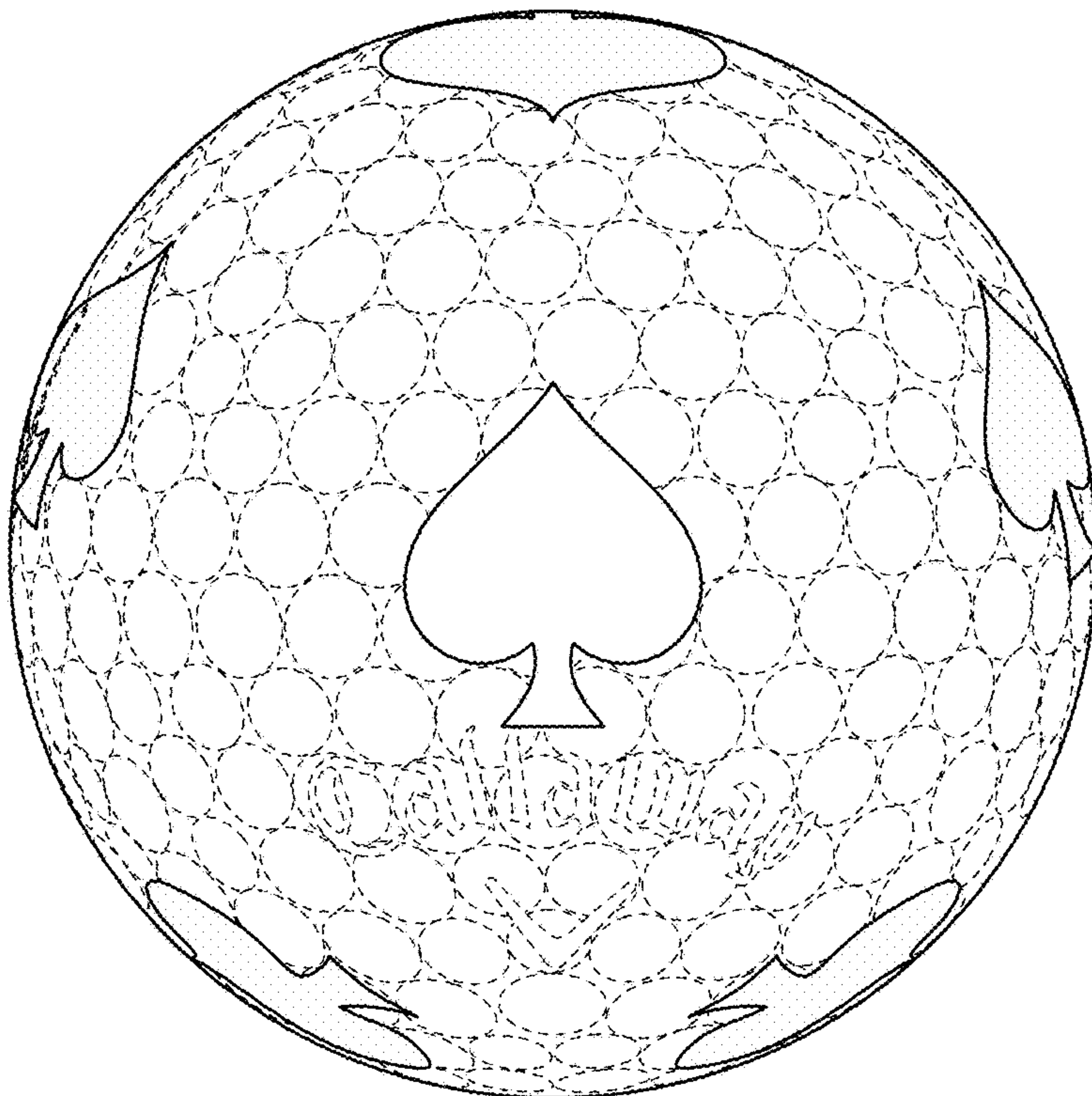

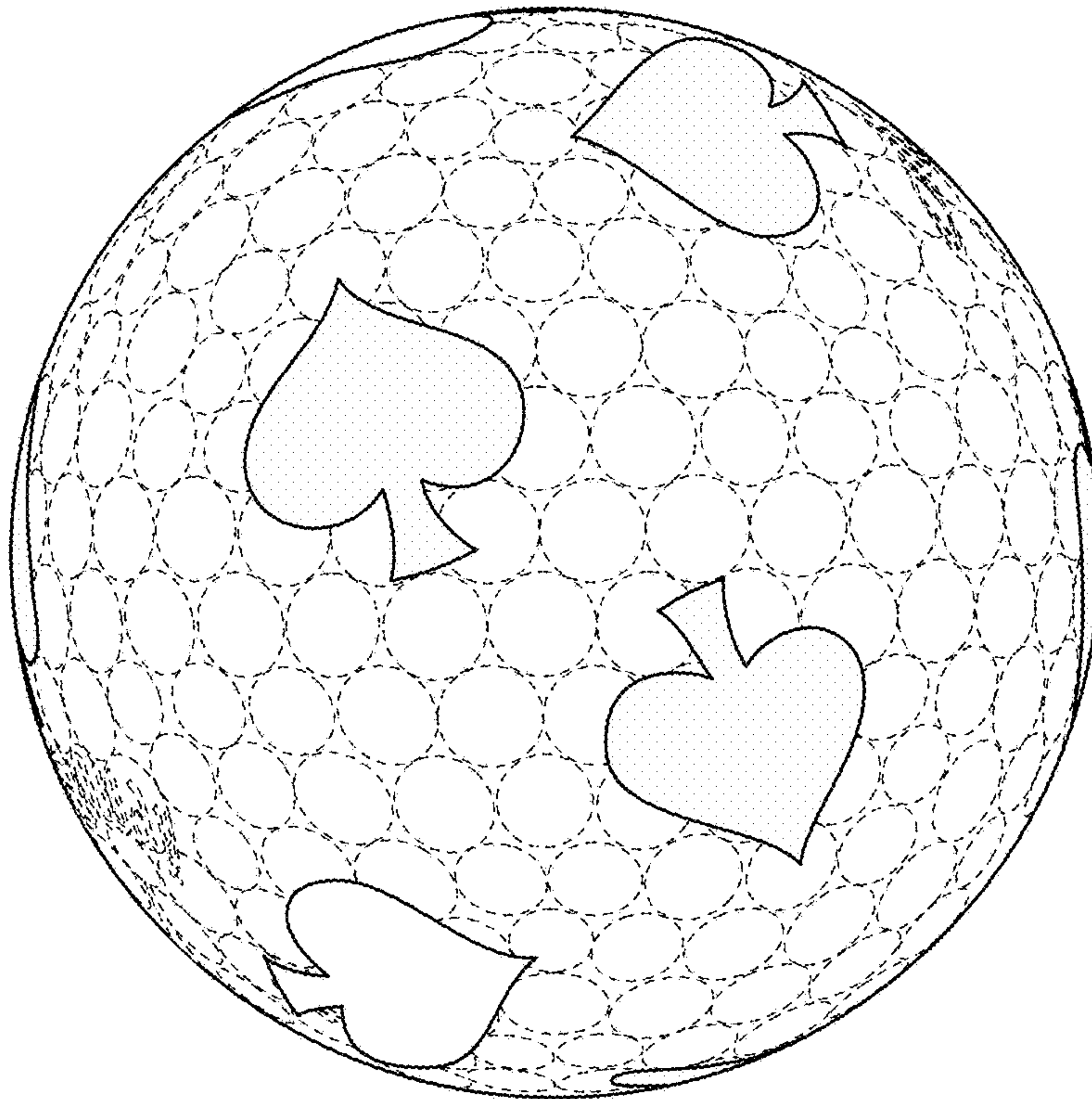

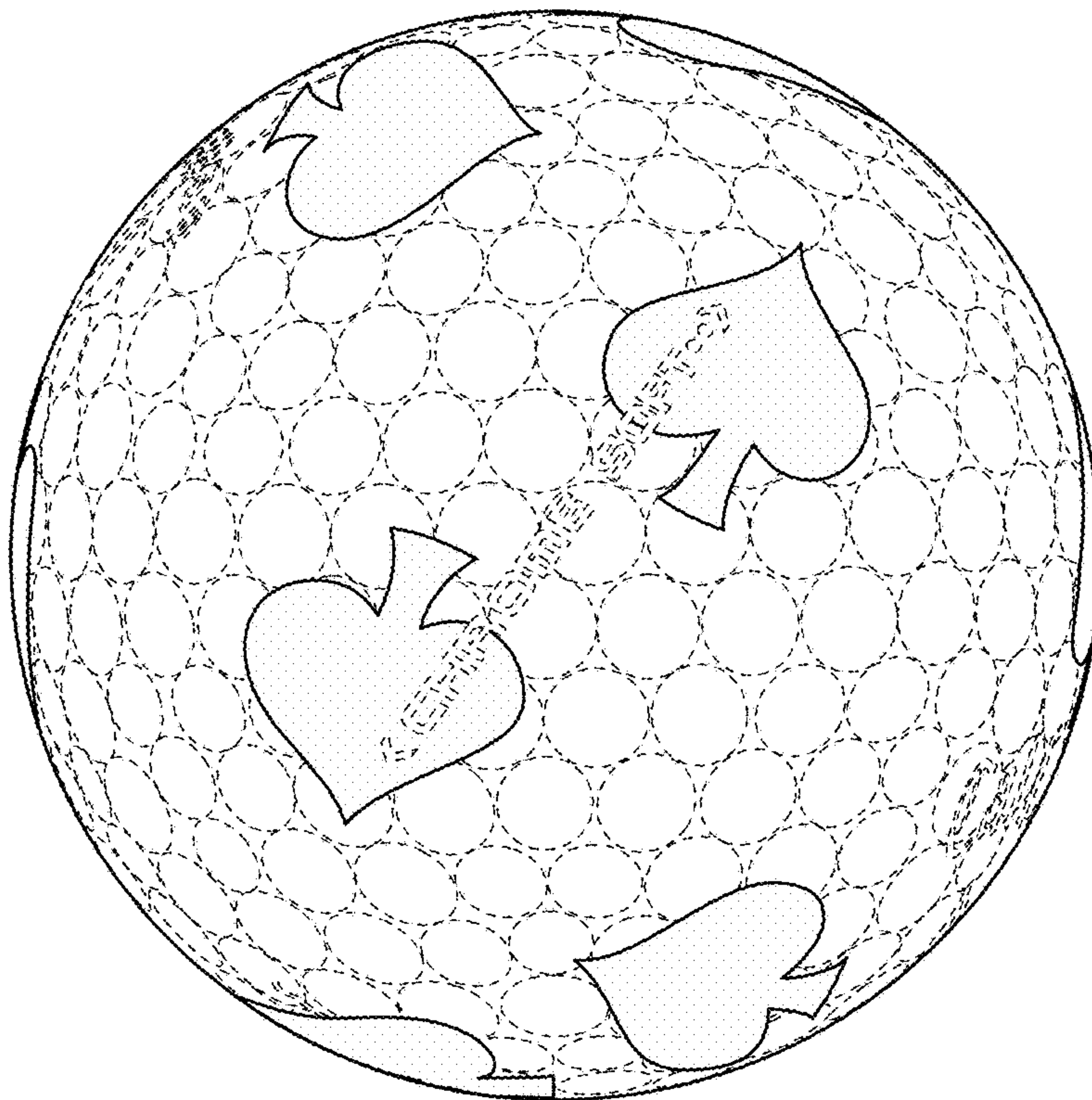

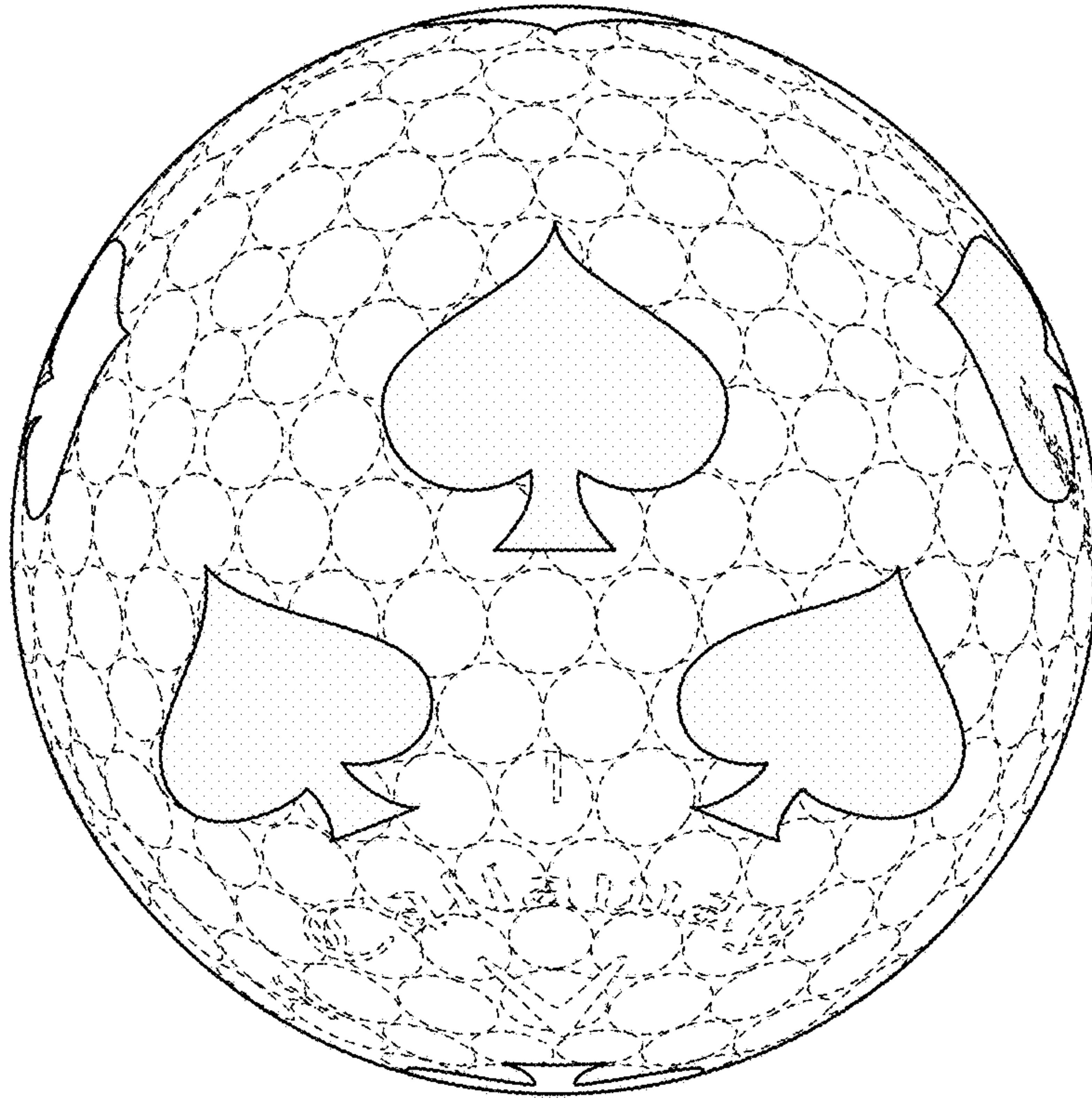

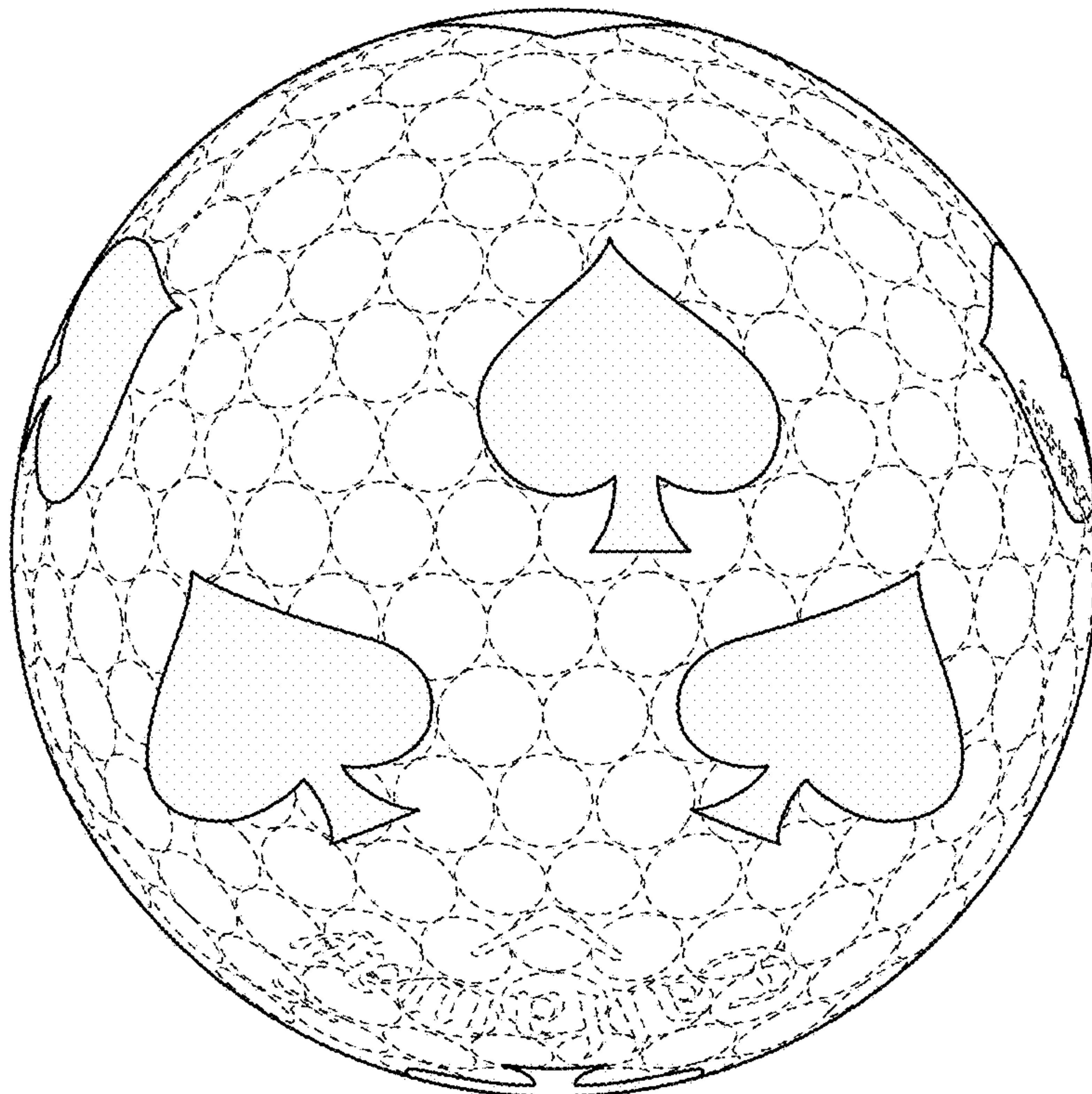
