(57) **CLAIM**

I claim the ornamental design for a racket handle, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a racket handle illustrating the claimed design, wherein the racket handle is attached to the unclaimed racket.

FIG. 2 is another perspective view of the racket handle shown in FIG. 1.

FIG. 3 is a front view of the racket handle shown in FIG. 1.

FIG. 4 is a back view of the racket handle shown in FIG. 1.

FIG. 5 is a left side view of the racket handle shown in FIG. 1.

FIG. 6 is a right side view of the racket handle shown in FIG. 1.

FIG. 7 is a top view of the racket handle shown in FIG. 1.

FIG. 8 is a bottom view of the racket handle shown in FIG. 1.

FIG. 9 is an enlarged perspective view of the racket handle shown in FIG. 1.

FIG. 10 is another enlarged perspective view of the racket handle shown in FIG. 9.

FIG. 11 is an enlarged front view of the racket handle shown in FIG. 9.

FIG. 12 is an enlarged back view of the racket handle shown in FIG. 9.

FIG. 13 is an enlarged left side view of the racket handle shown in FIG. 9.

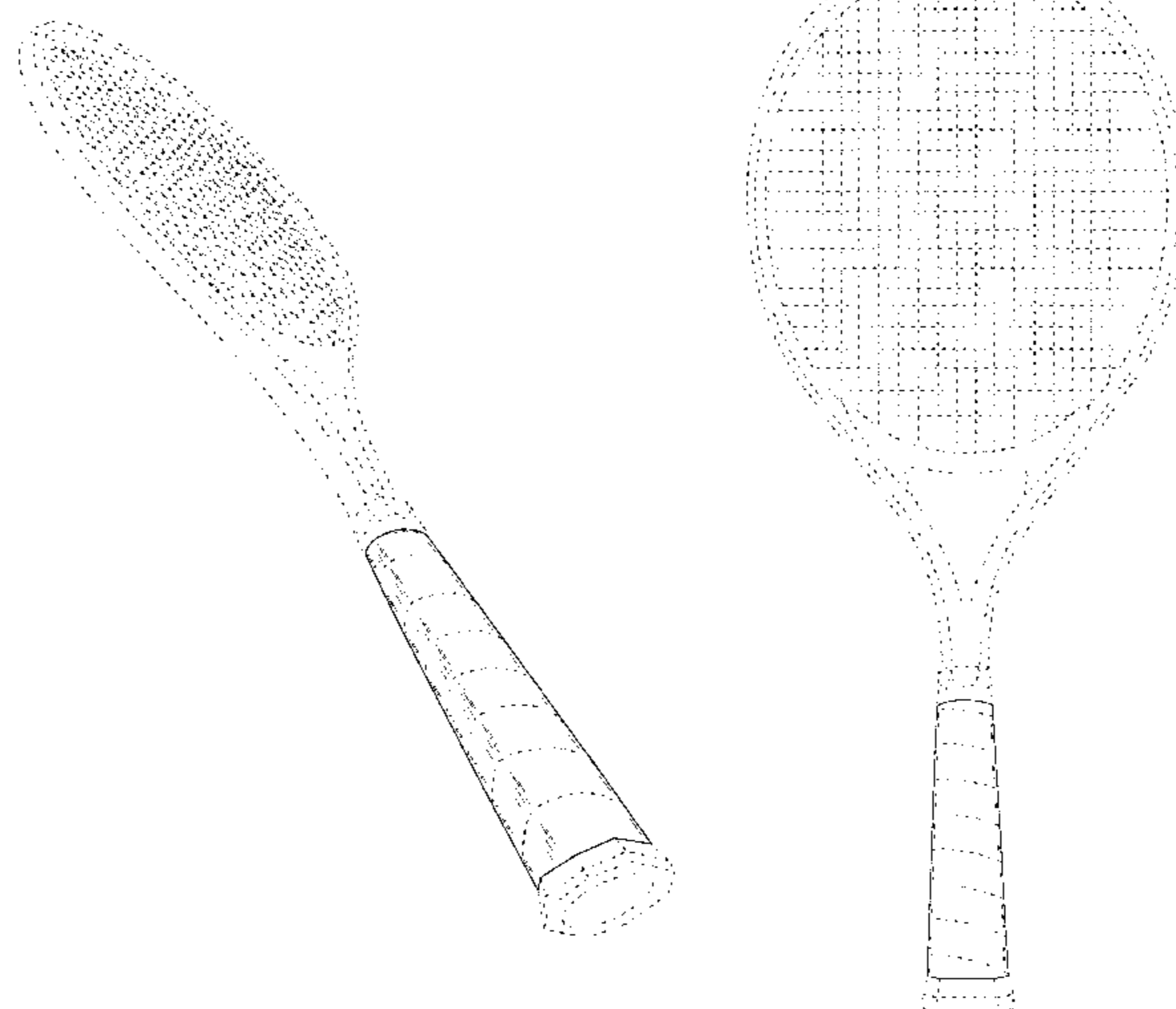
FIG. 14 is an enlarged right side view of the racket handle shown in FIG. 9.

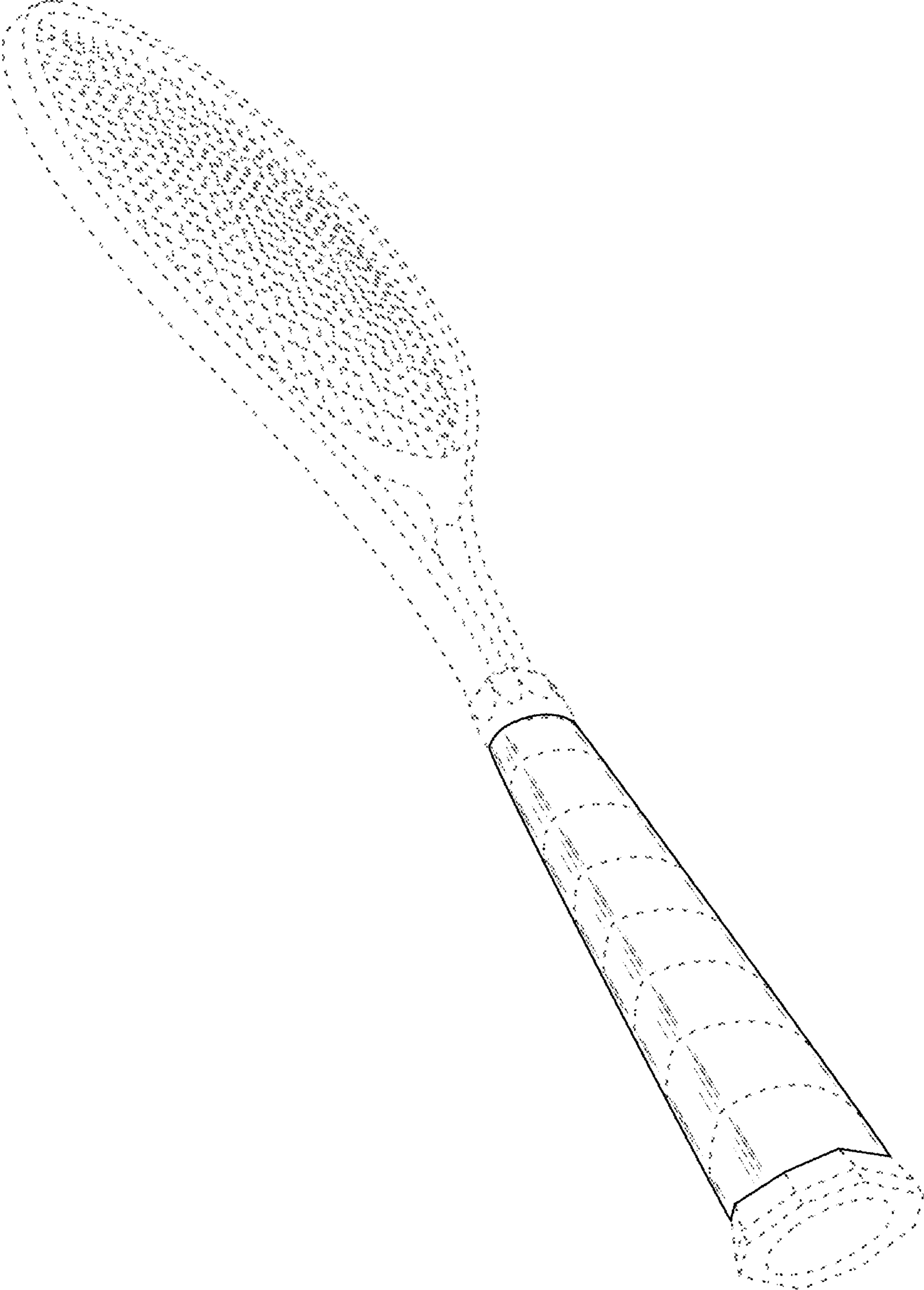

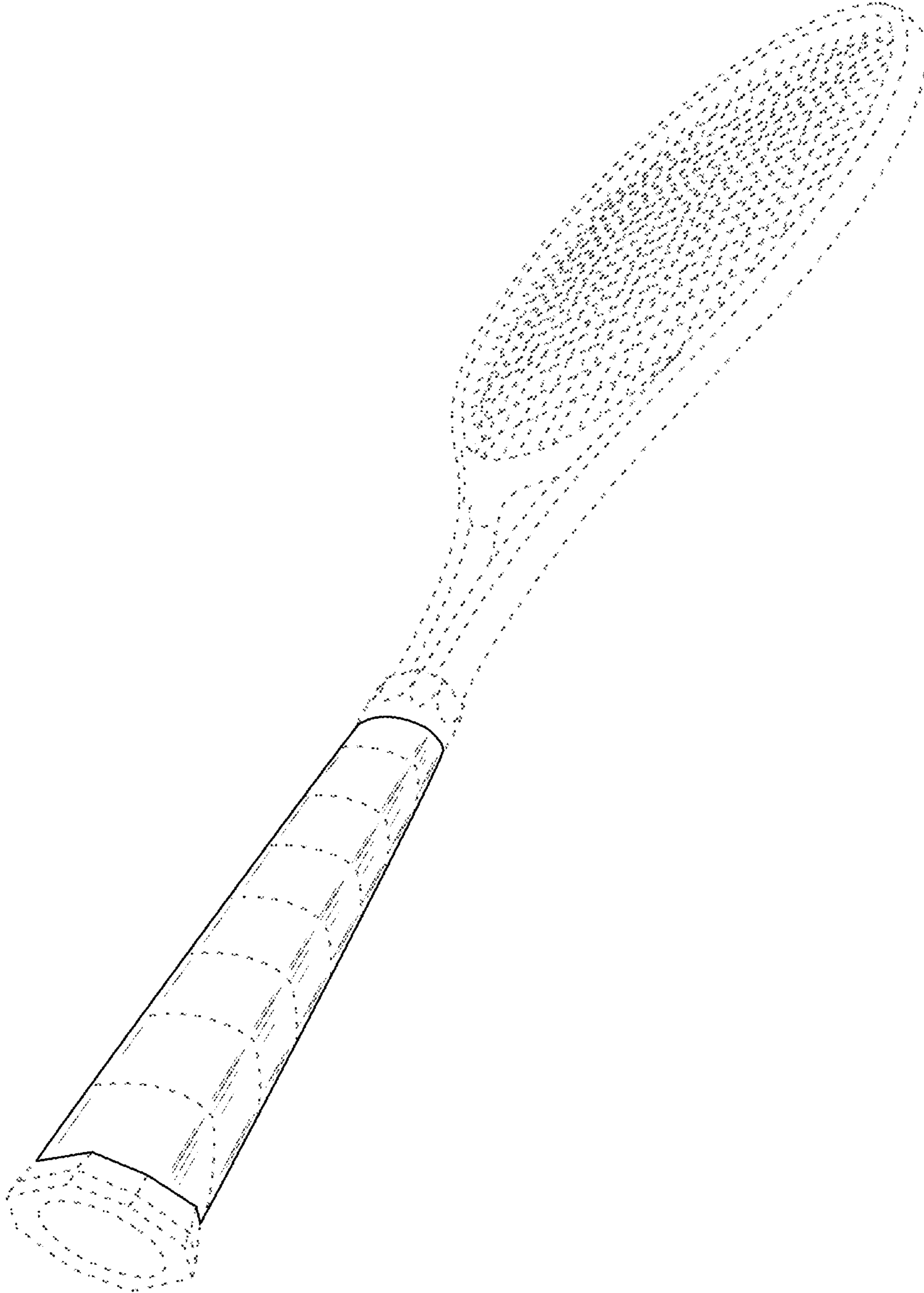

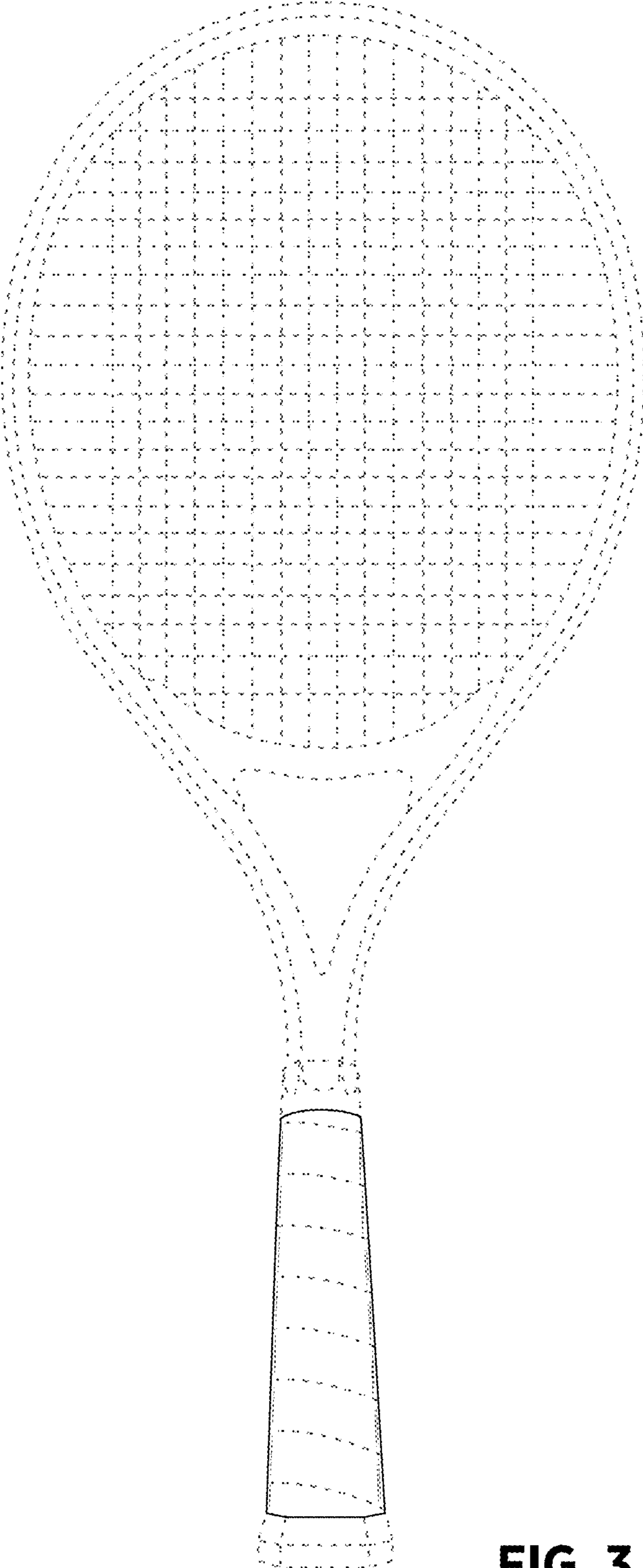

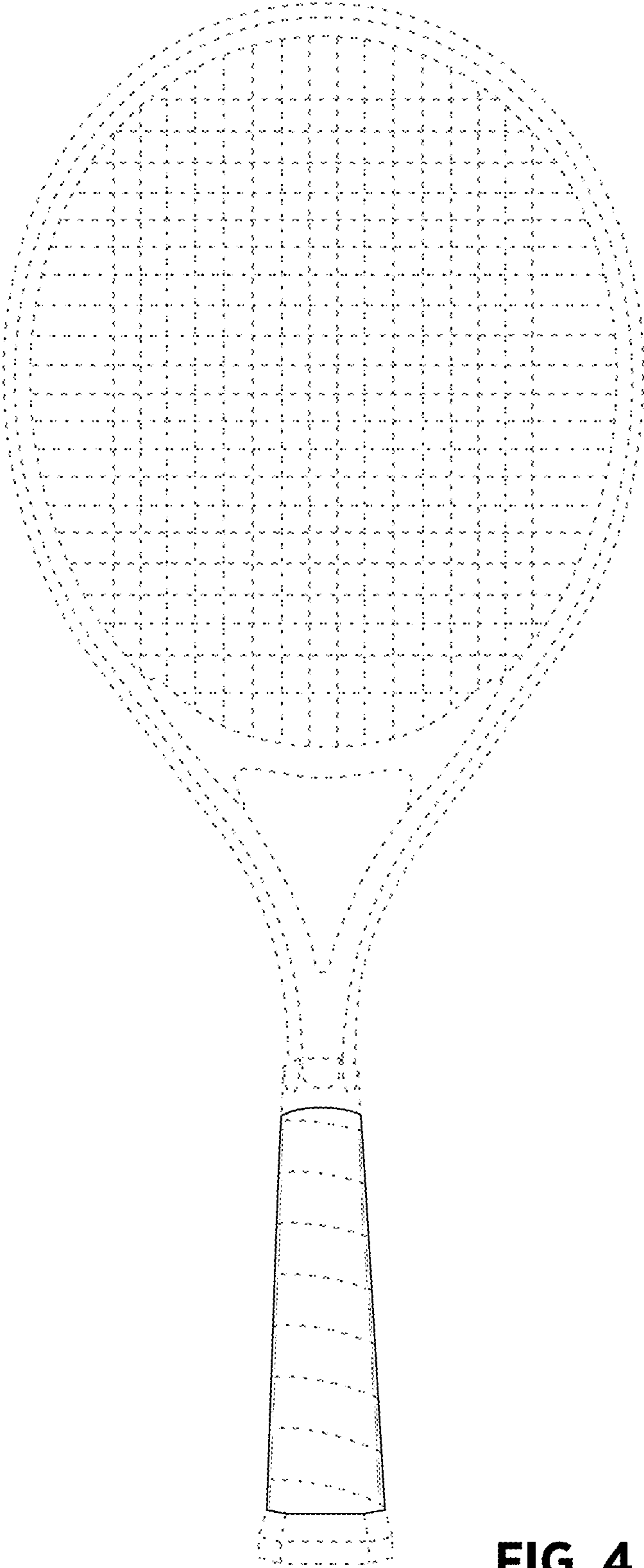

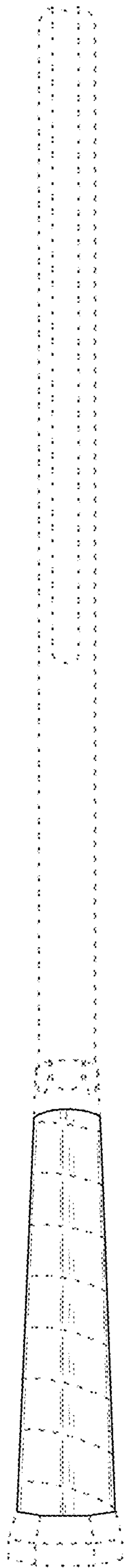

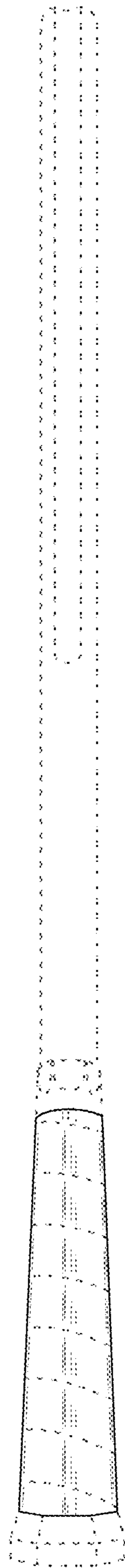

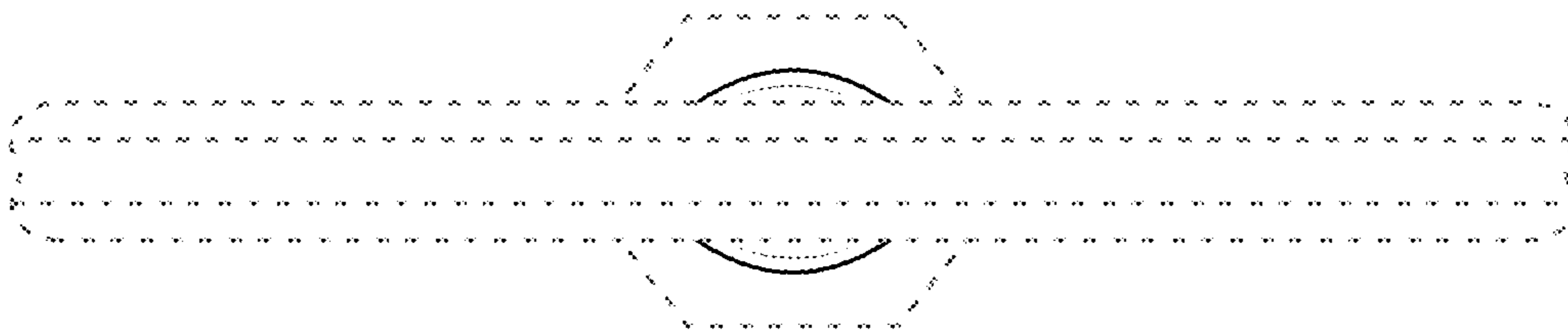

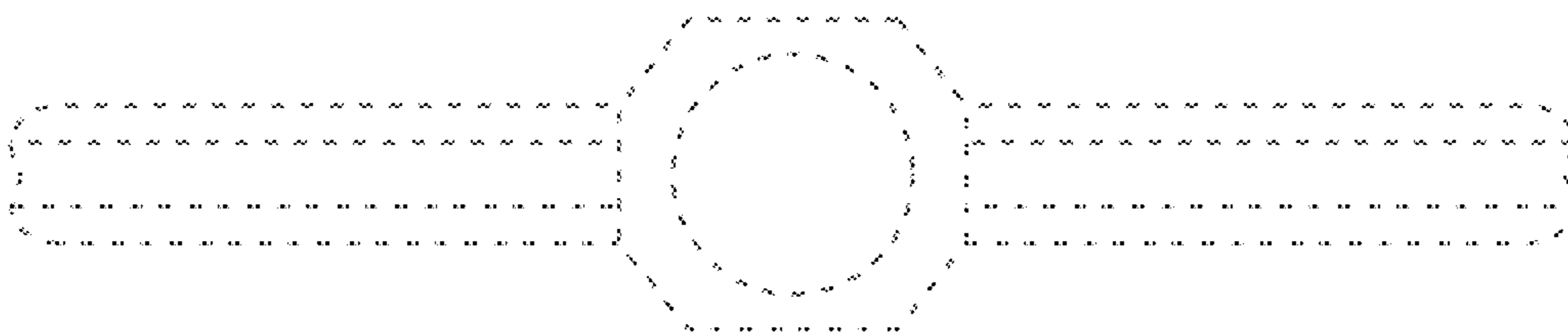

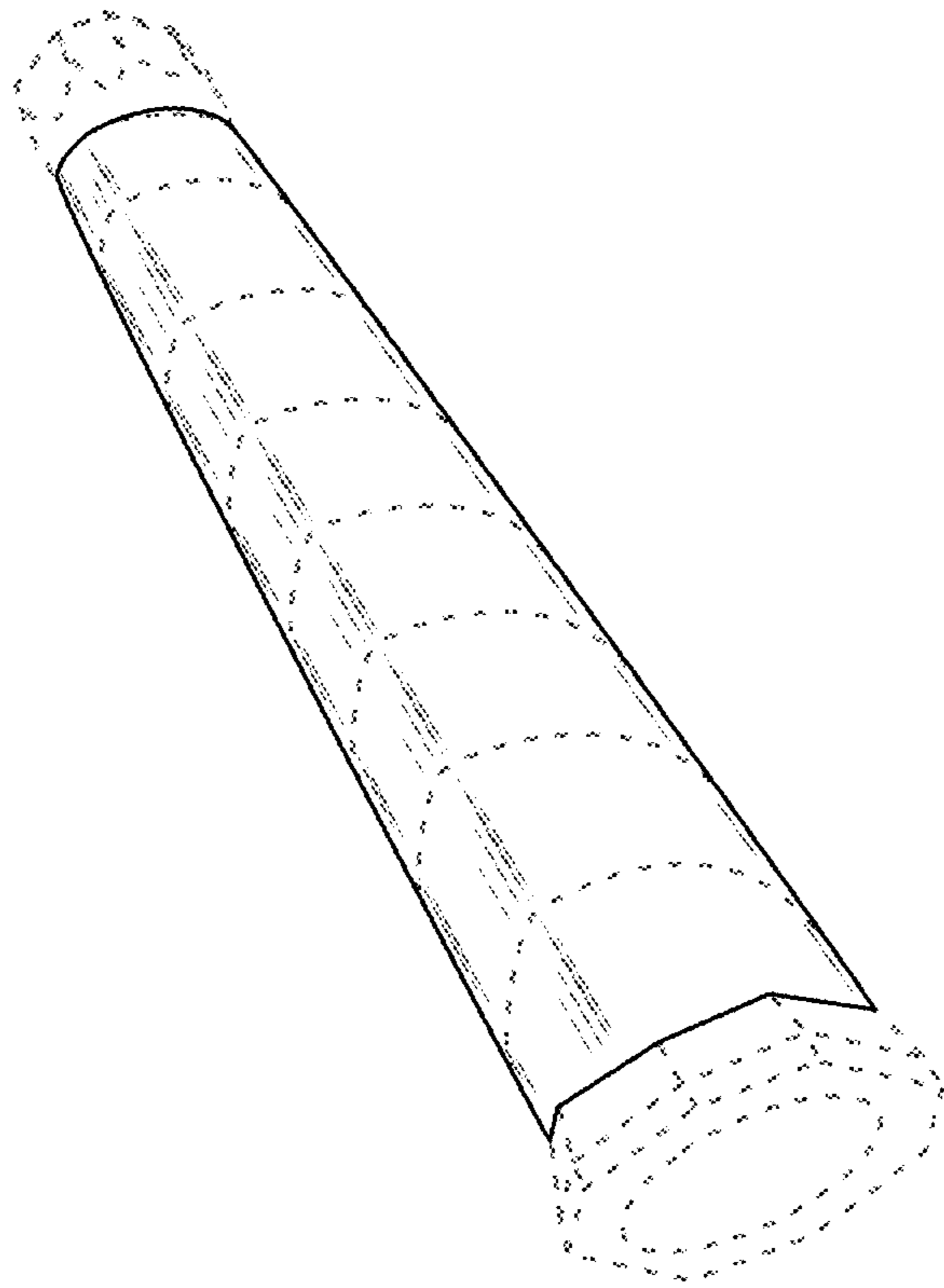

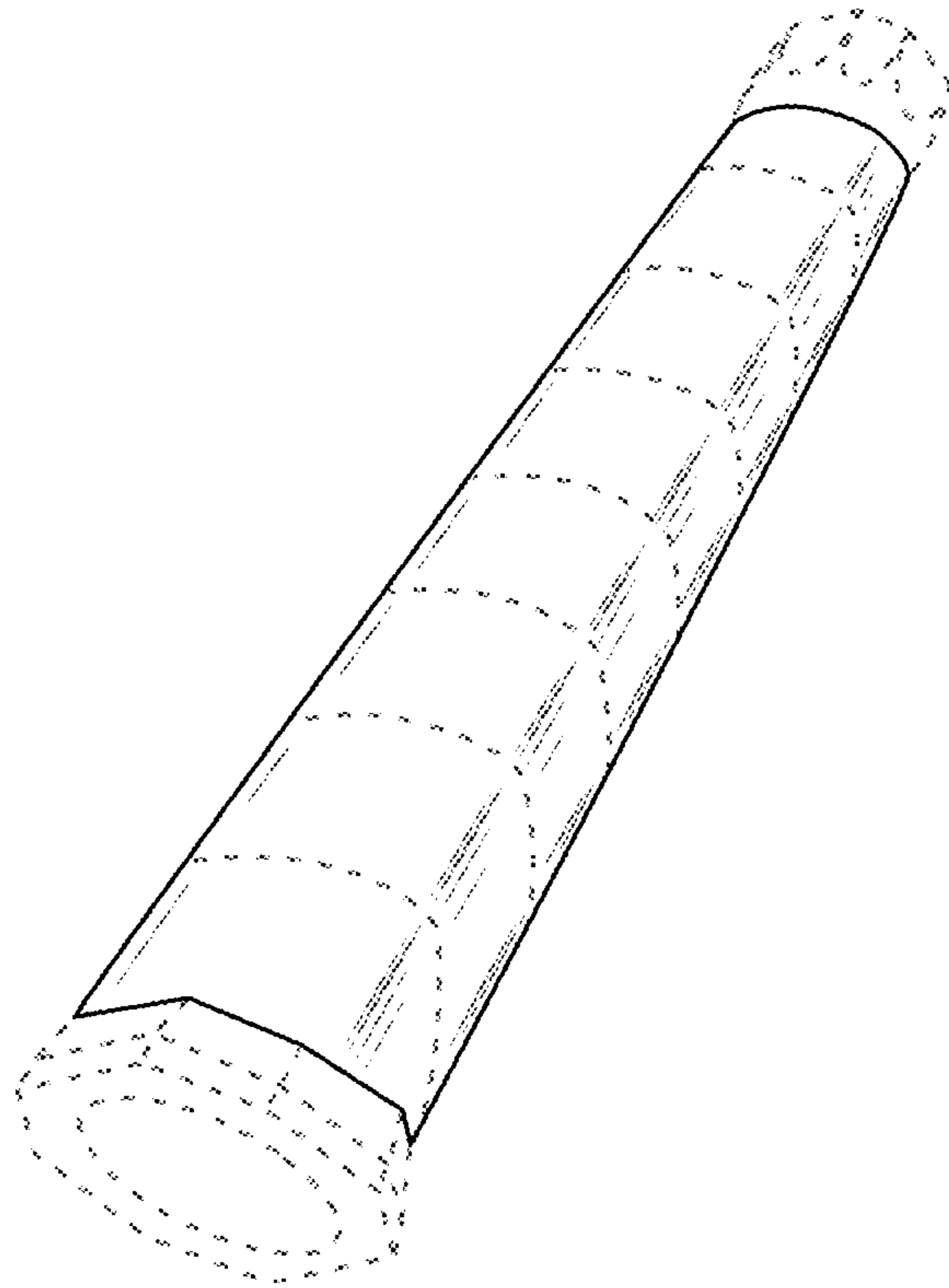

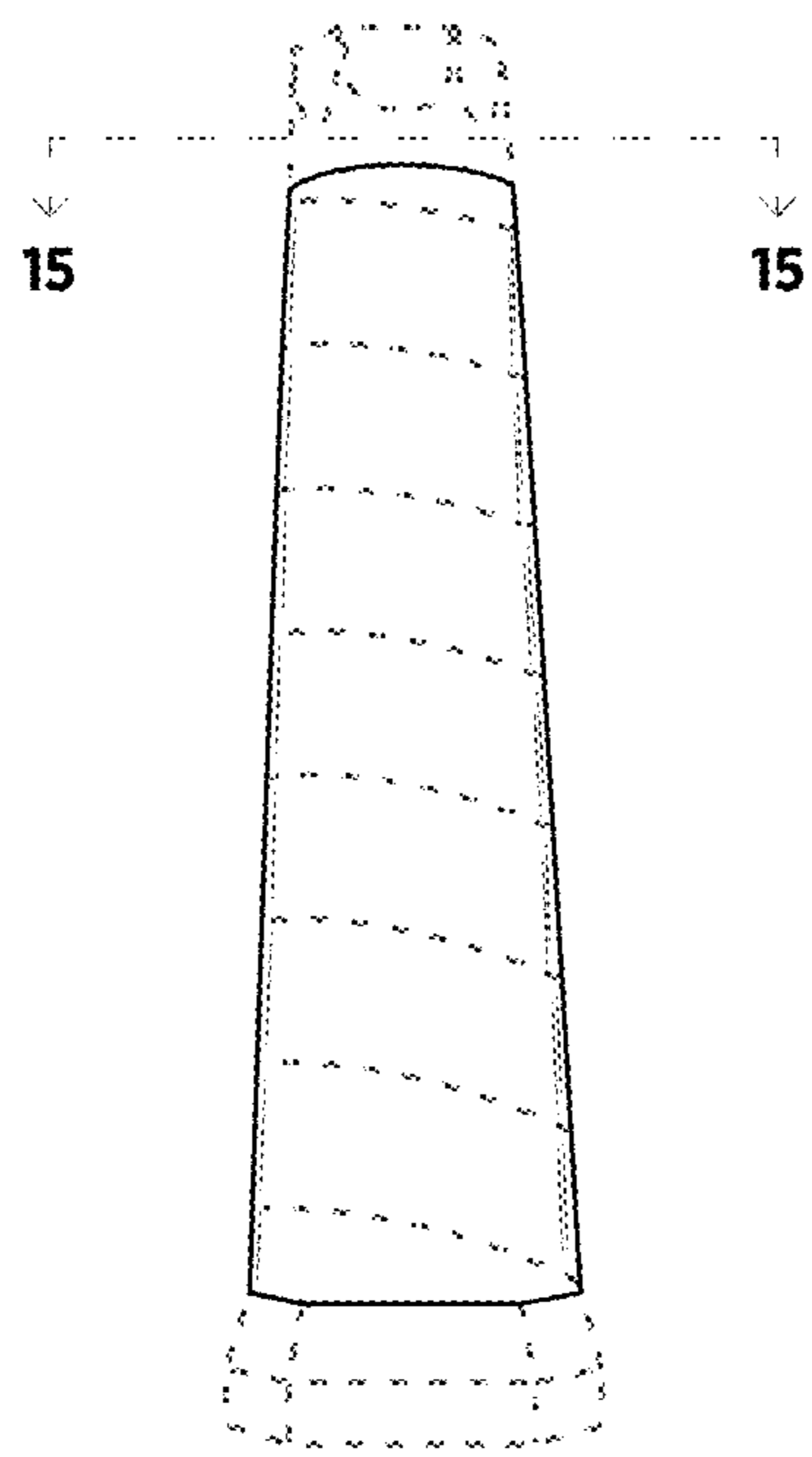

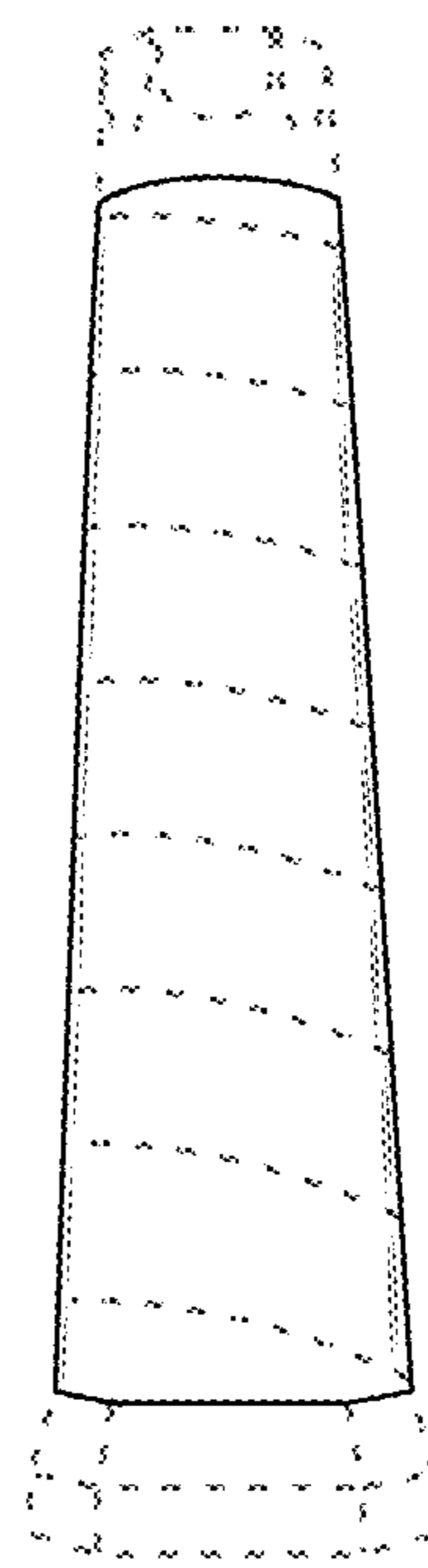

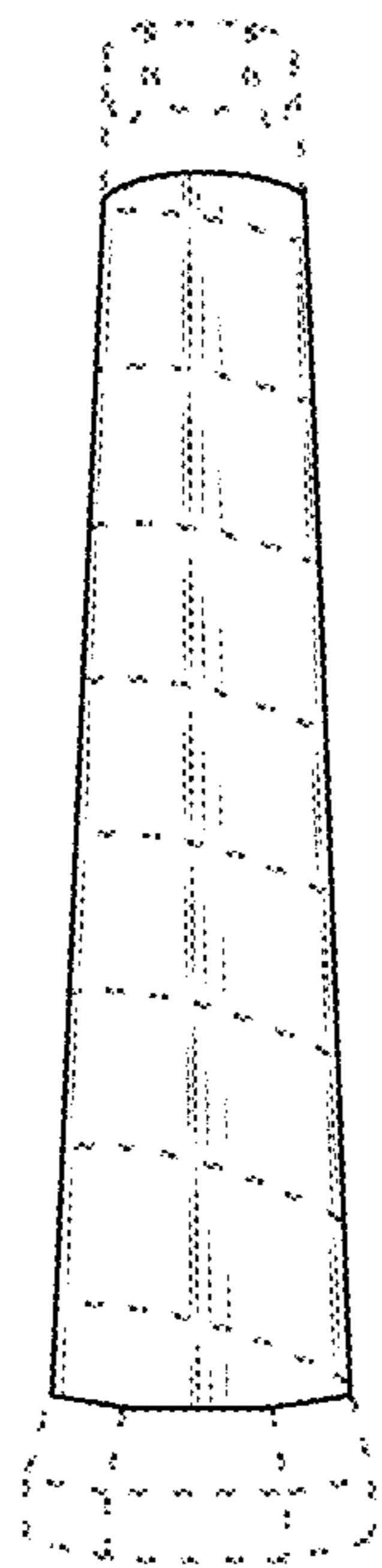

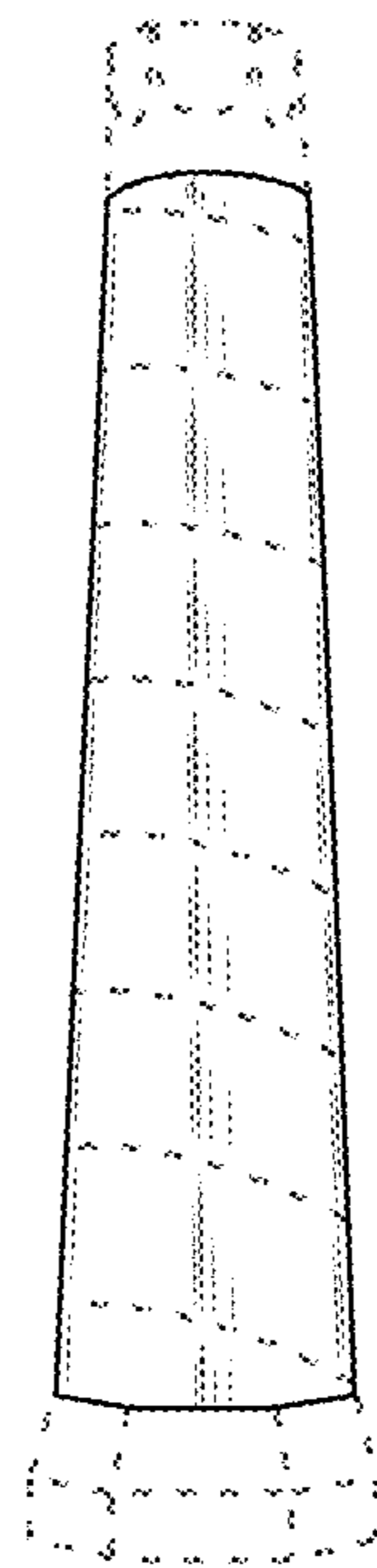

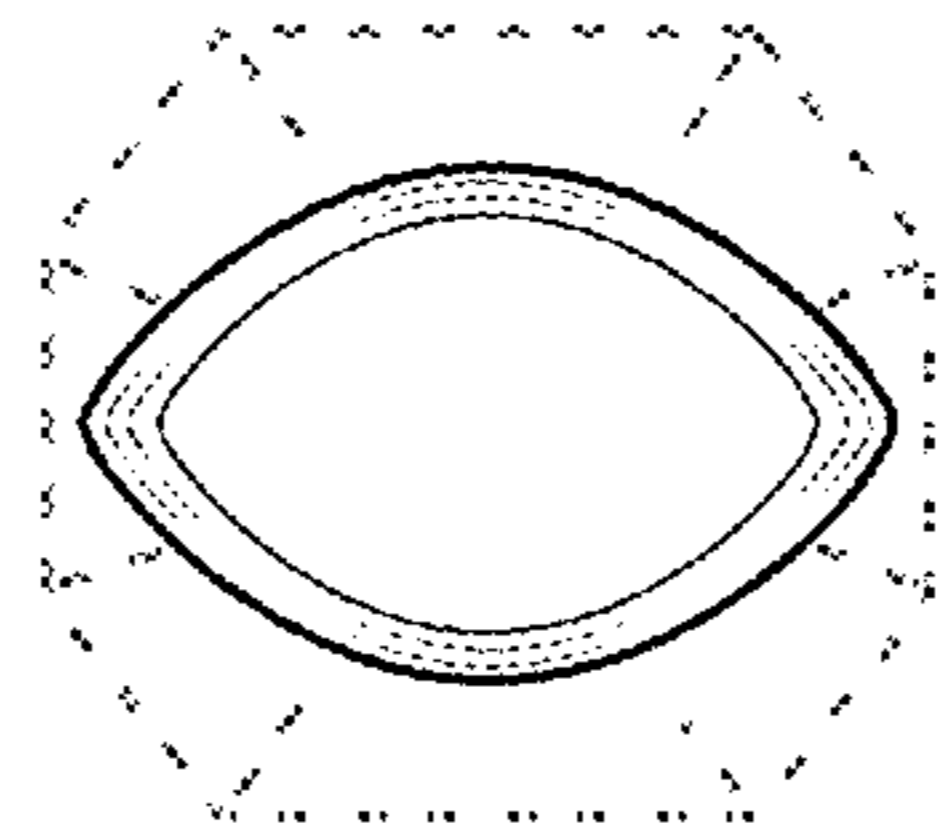

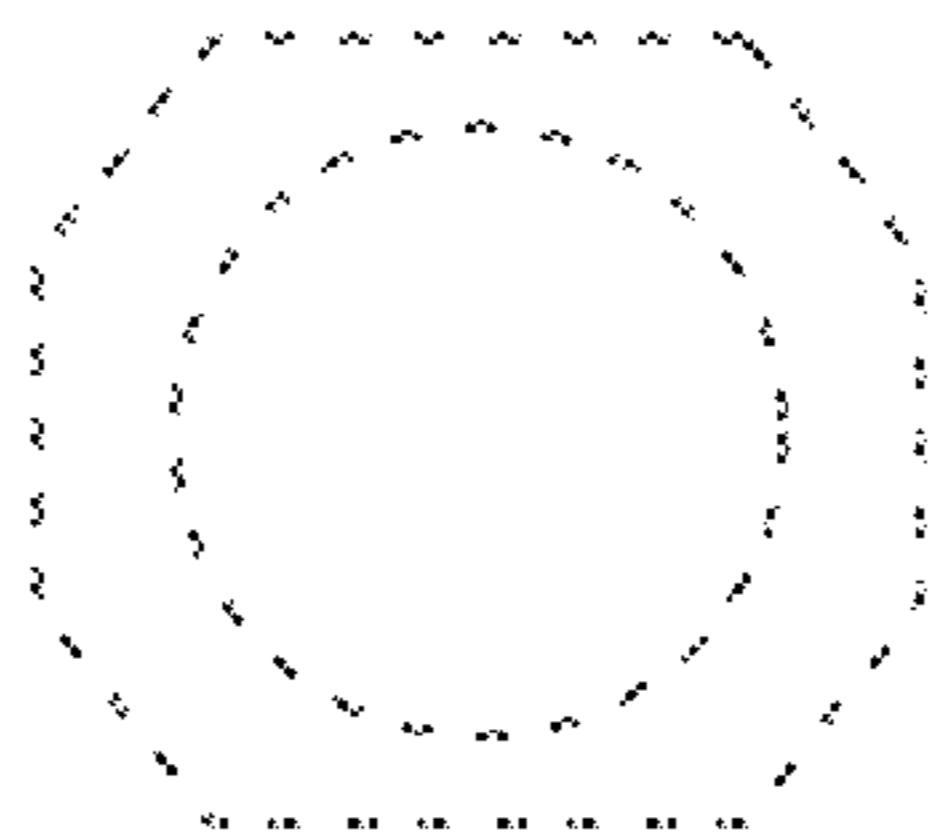
