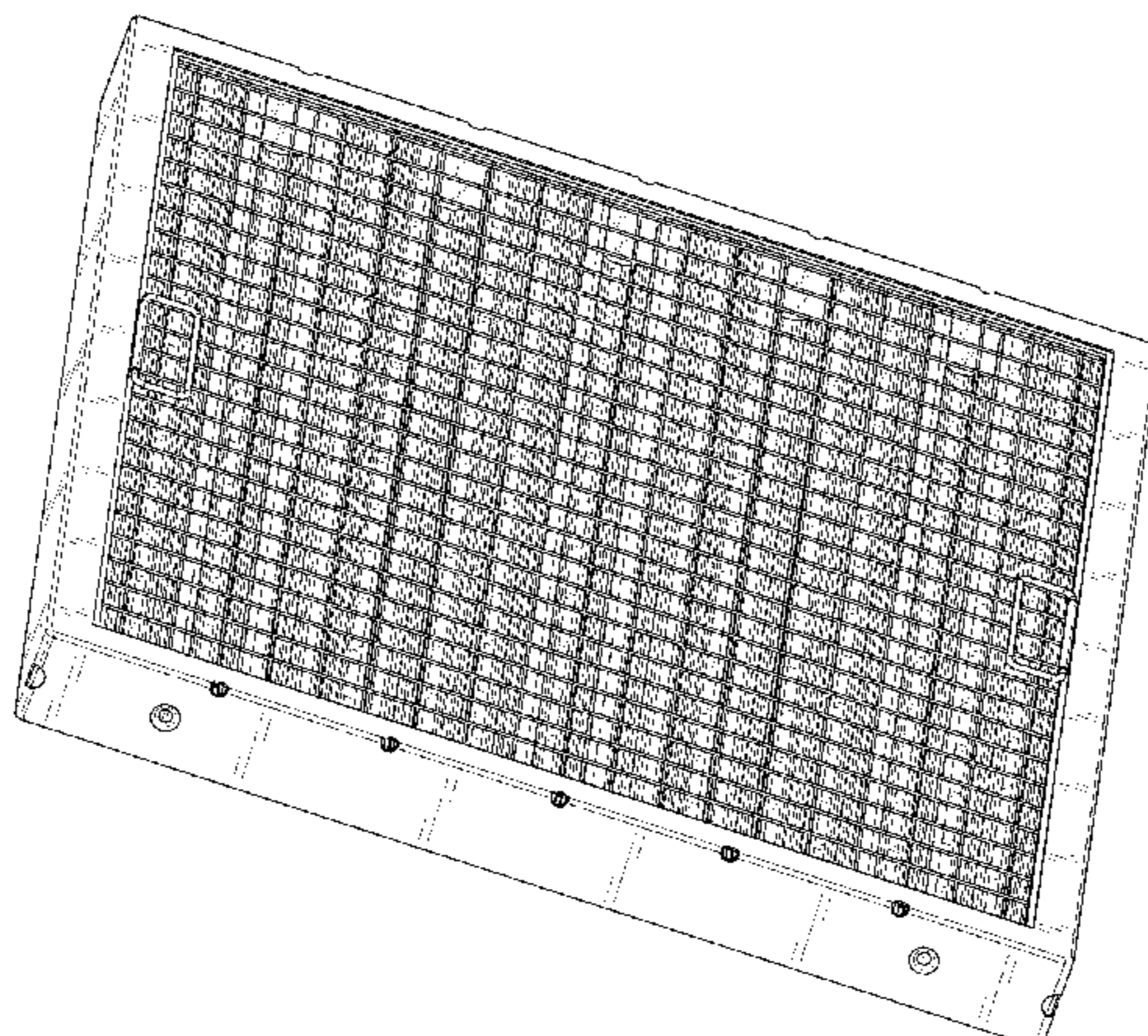

(57) **CLAIM**

The ornamental design for a filter support structure, as shown and described.

FIG. 1 is a front perspective view of a filter support structure showing my new design;

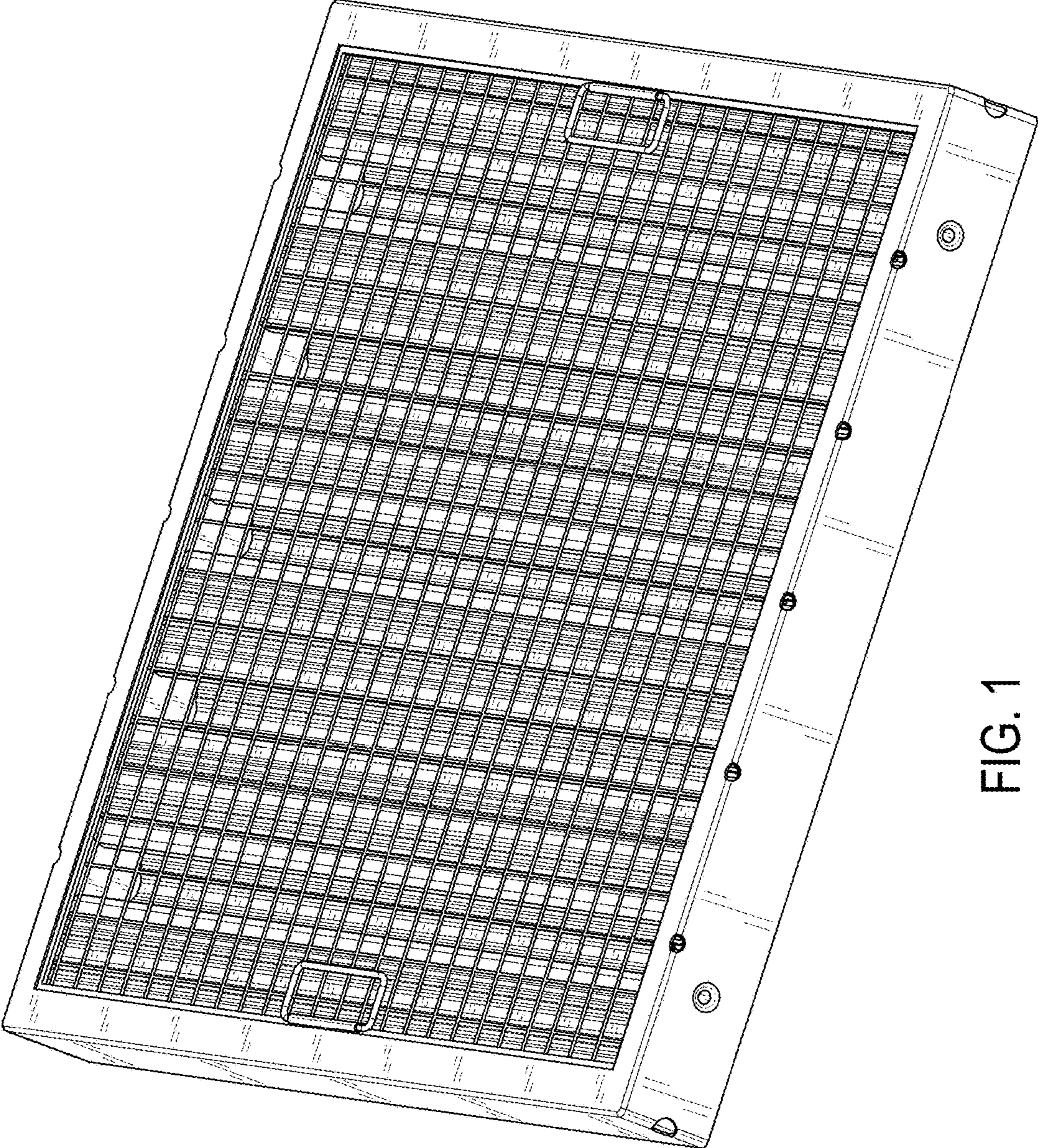

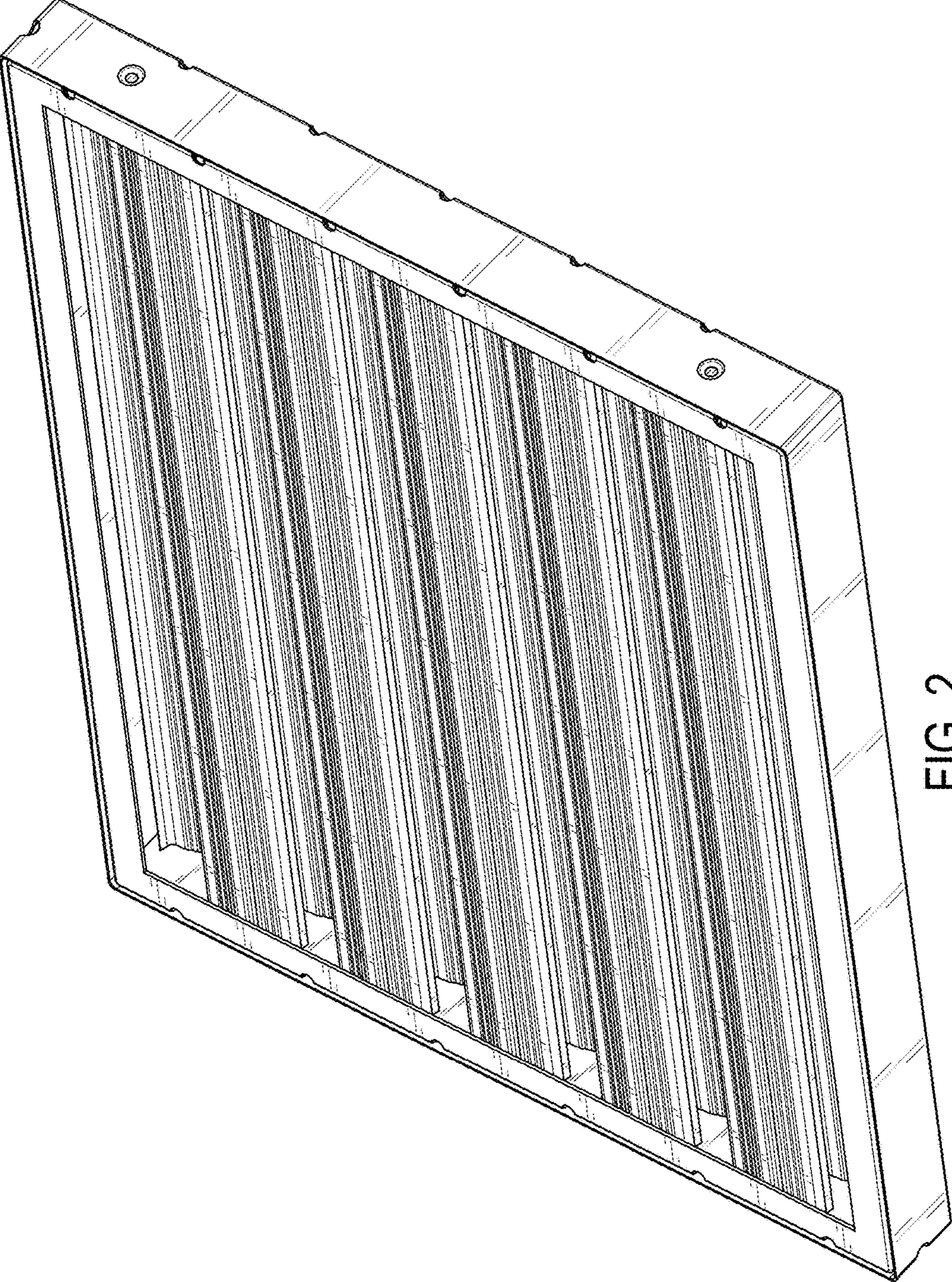

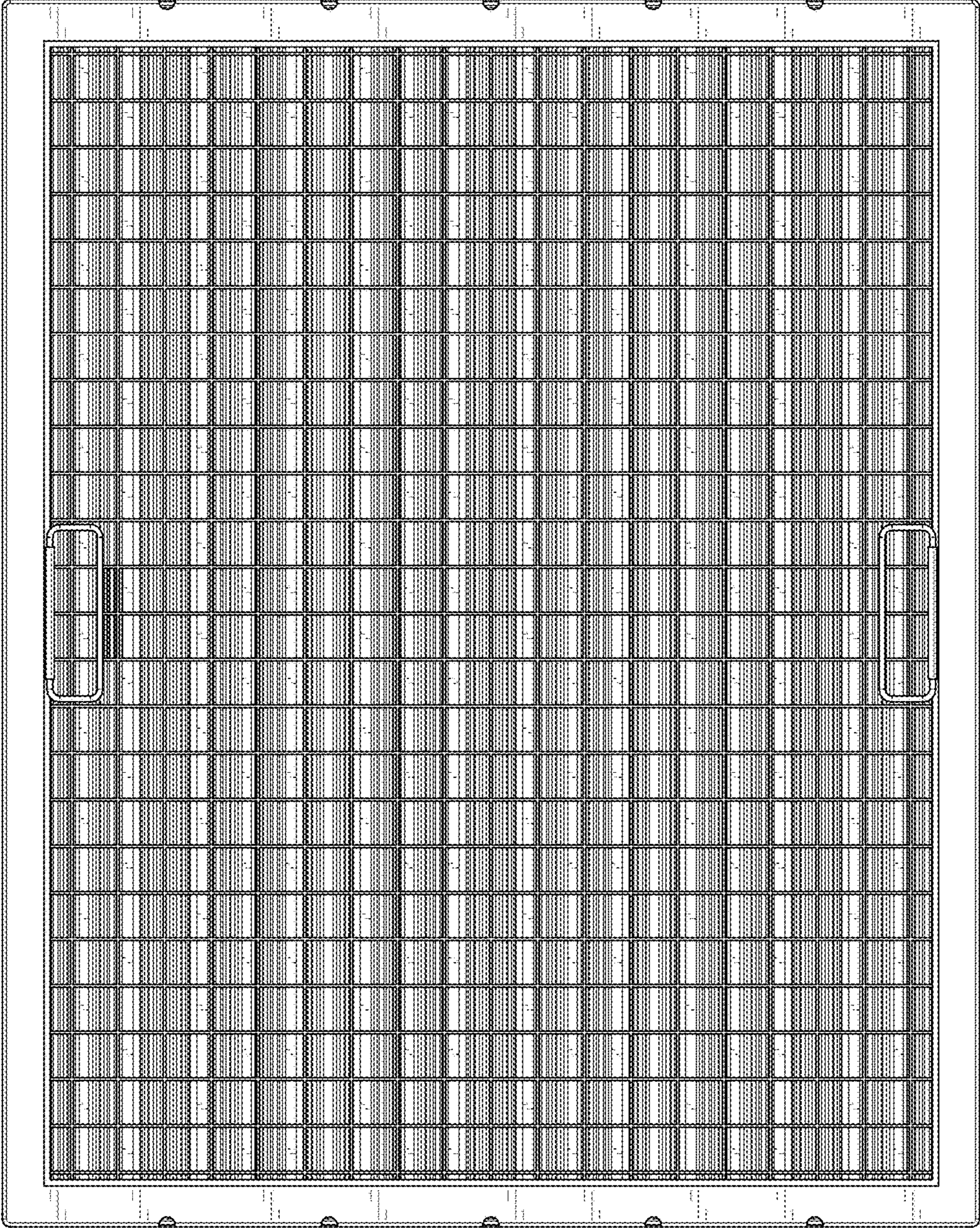

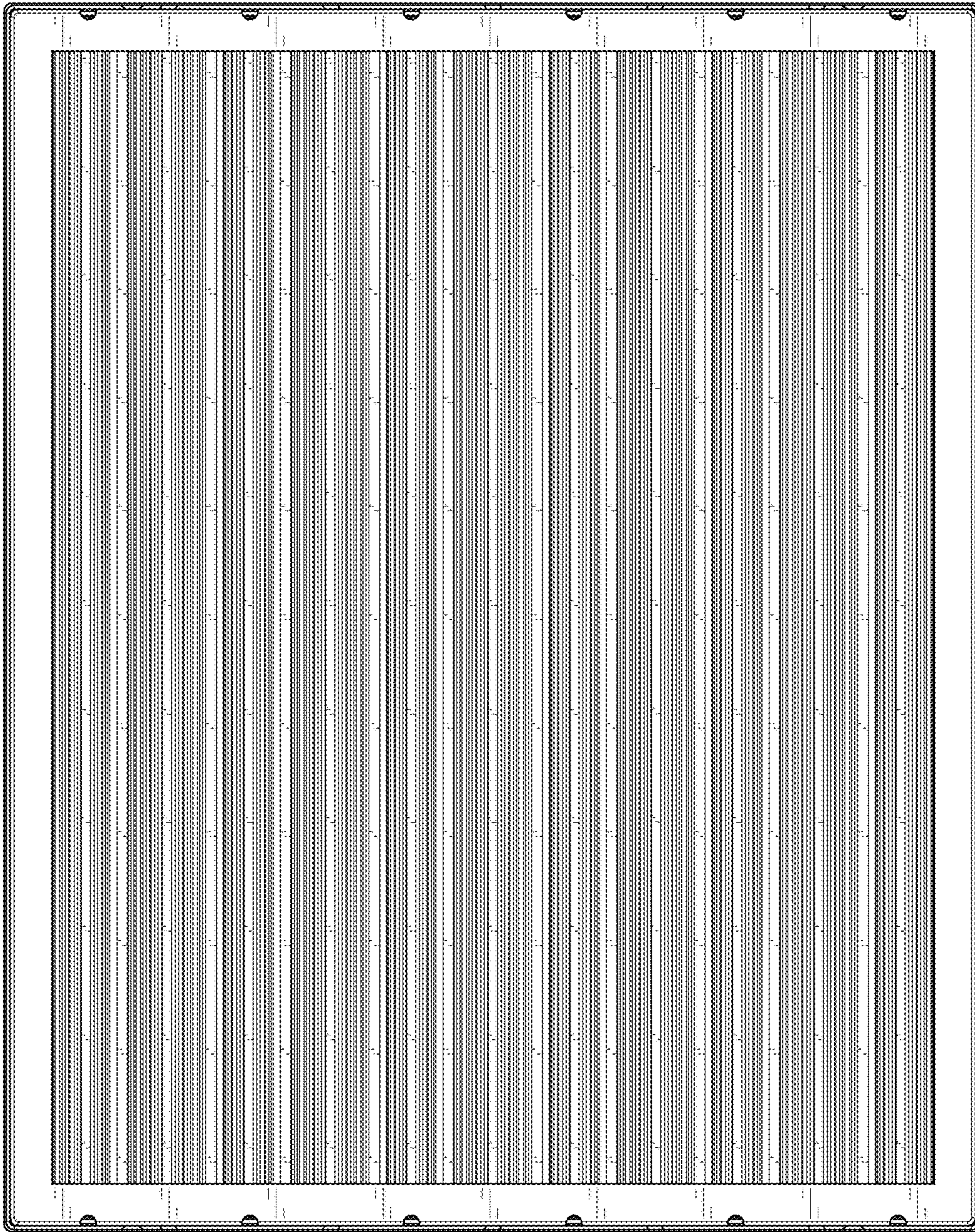

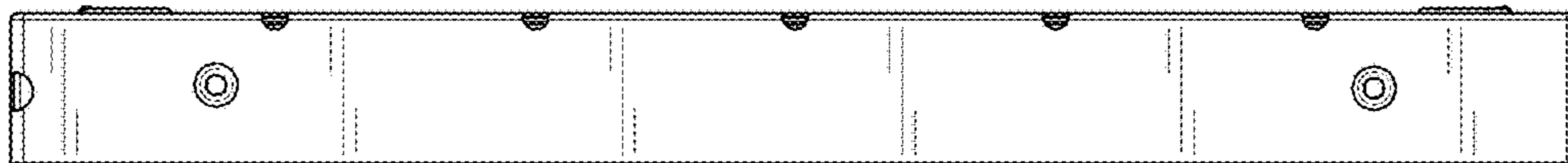

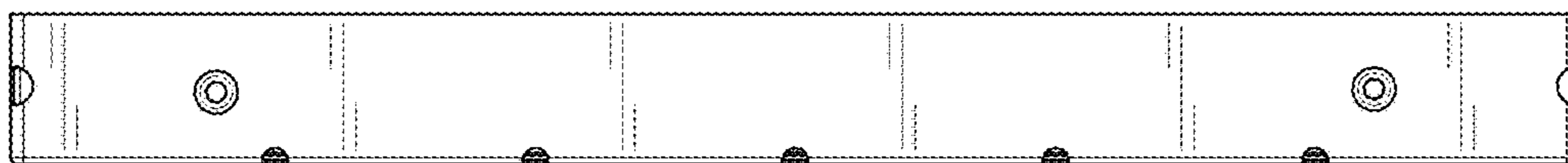

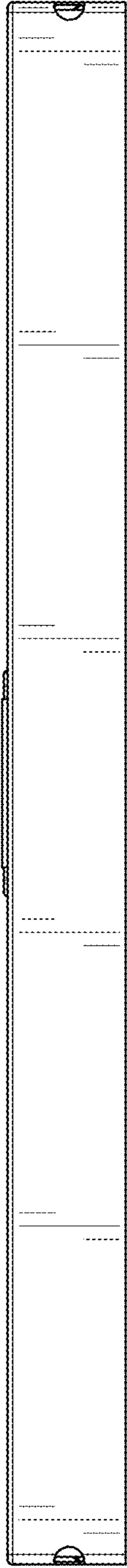

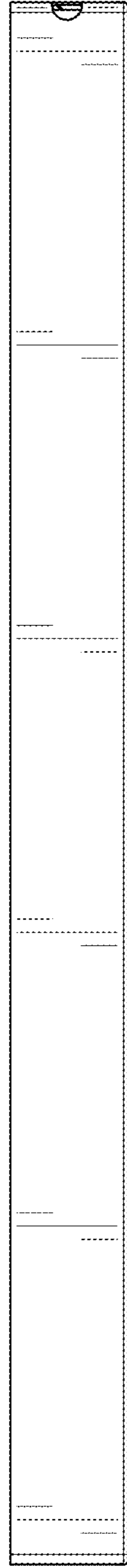

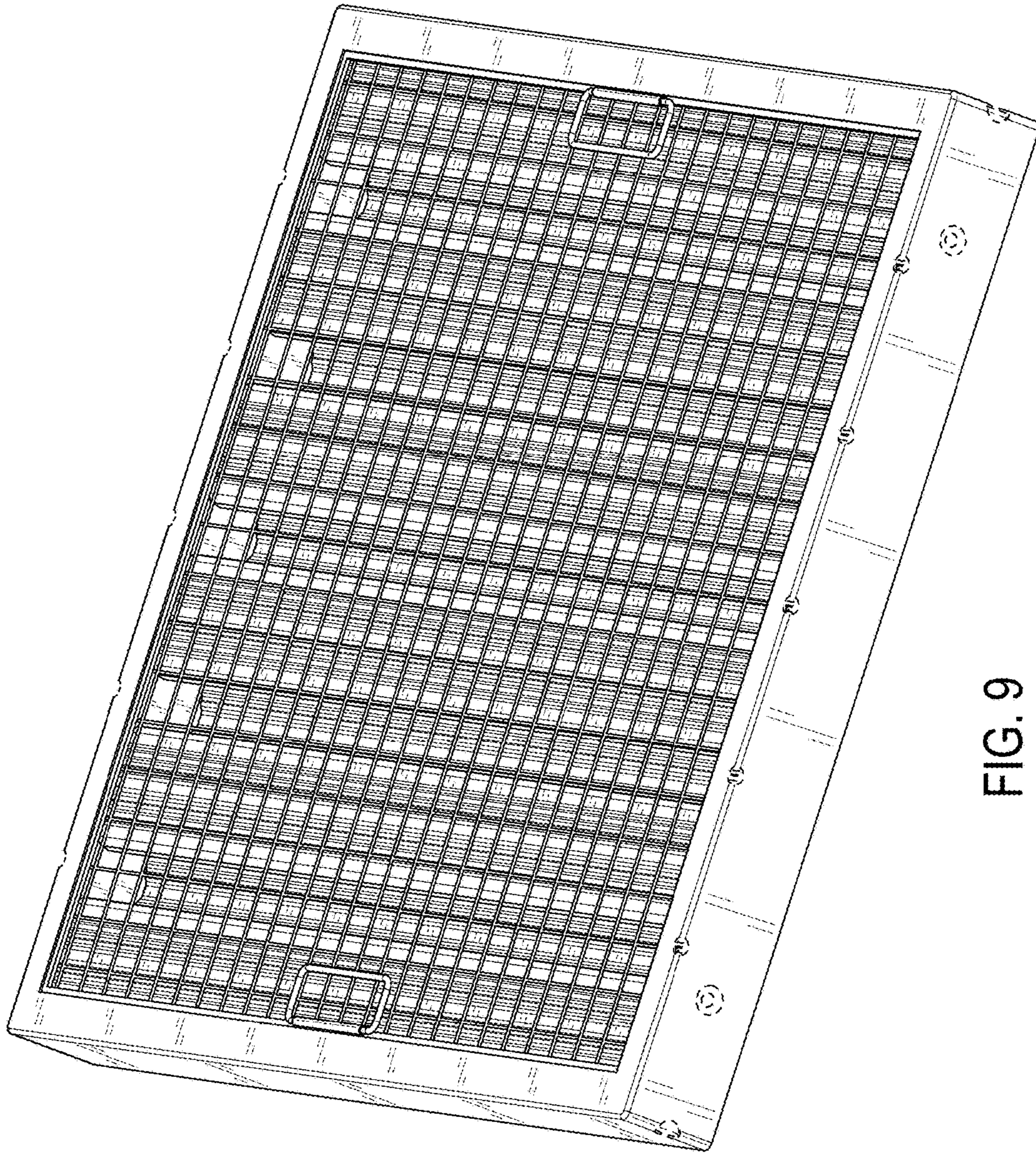

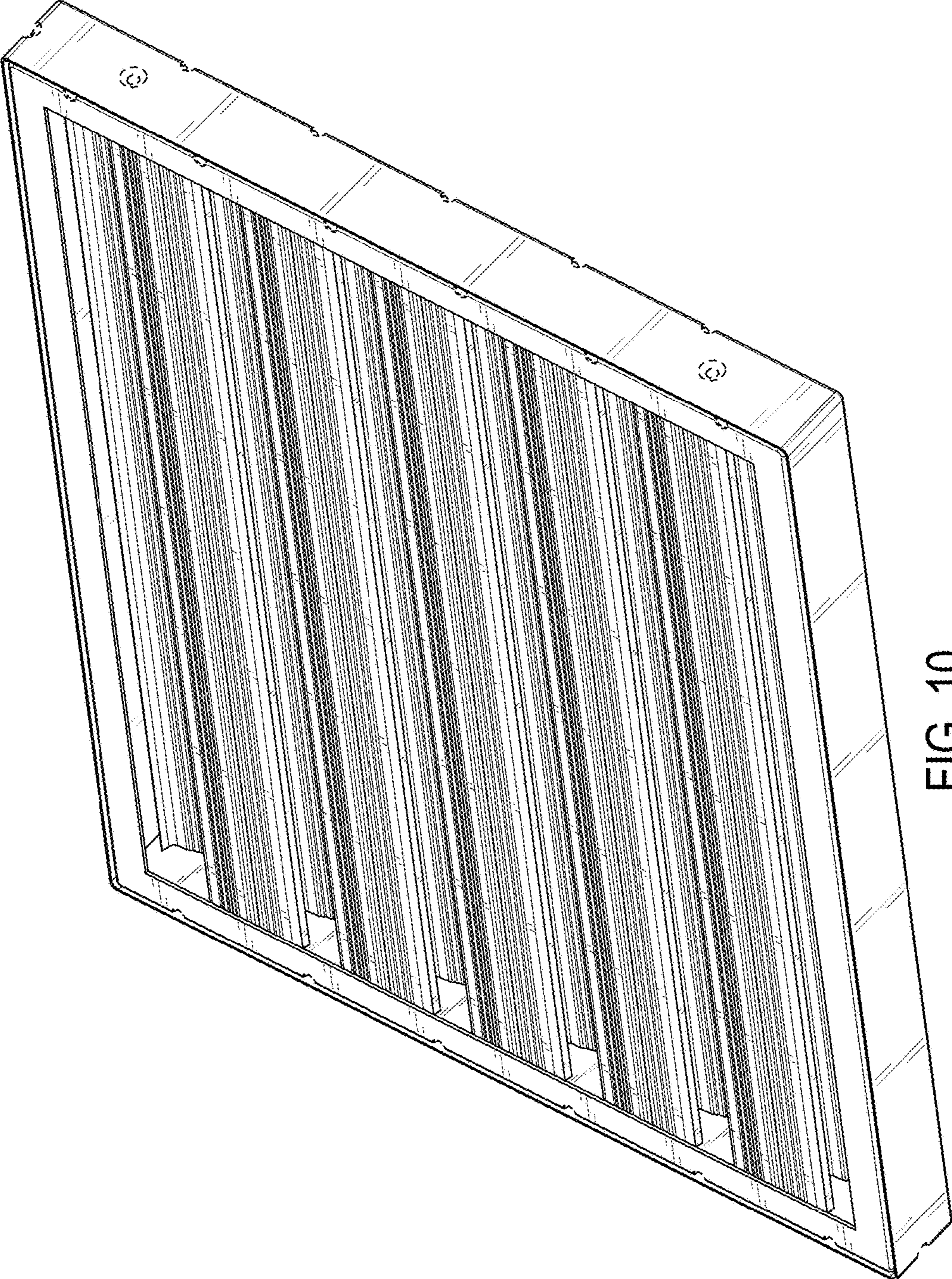

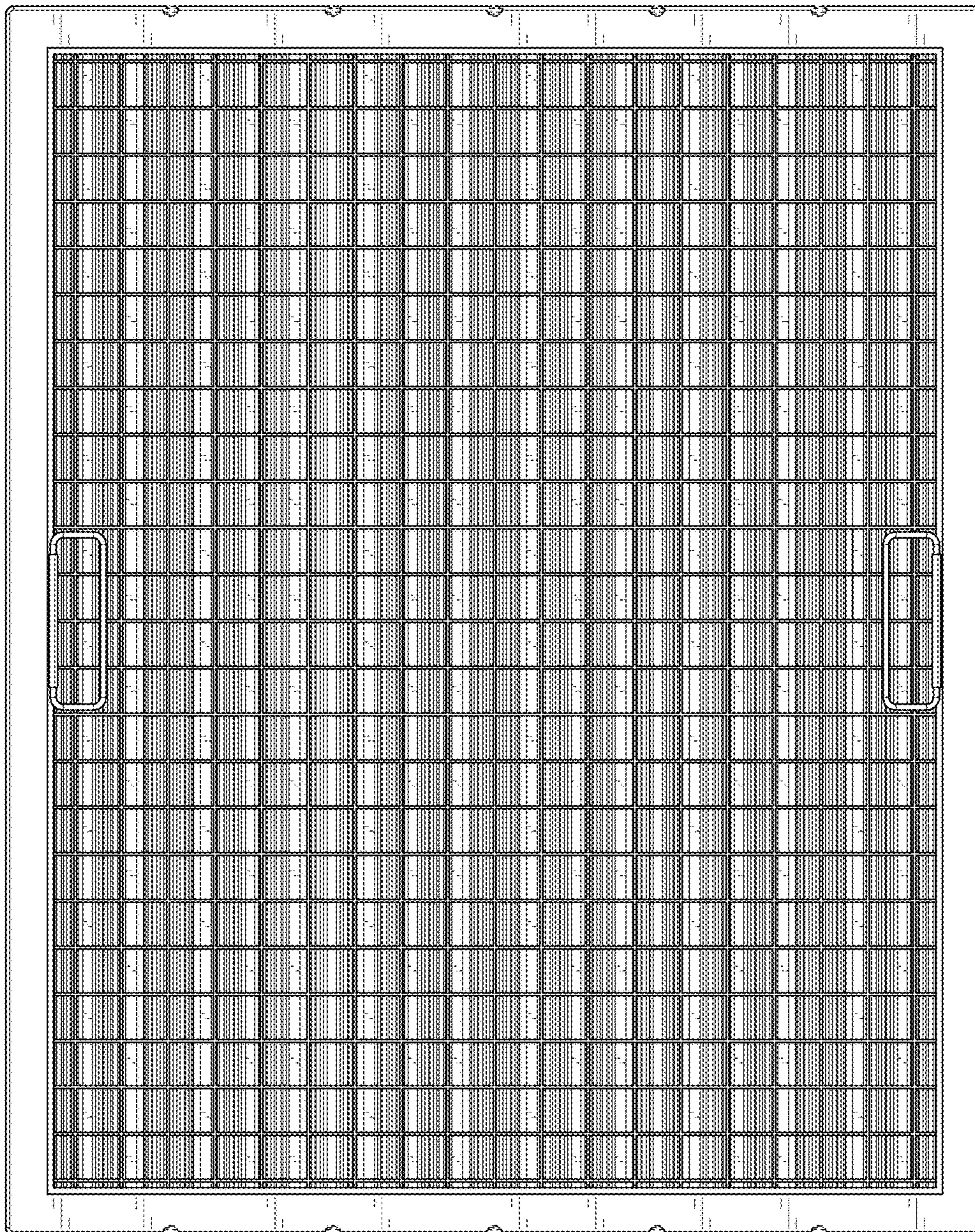

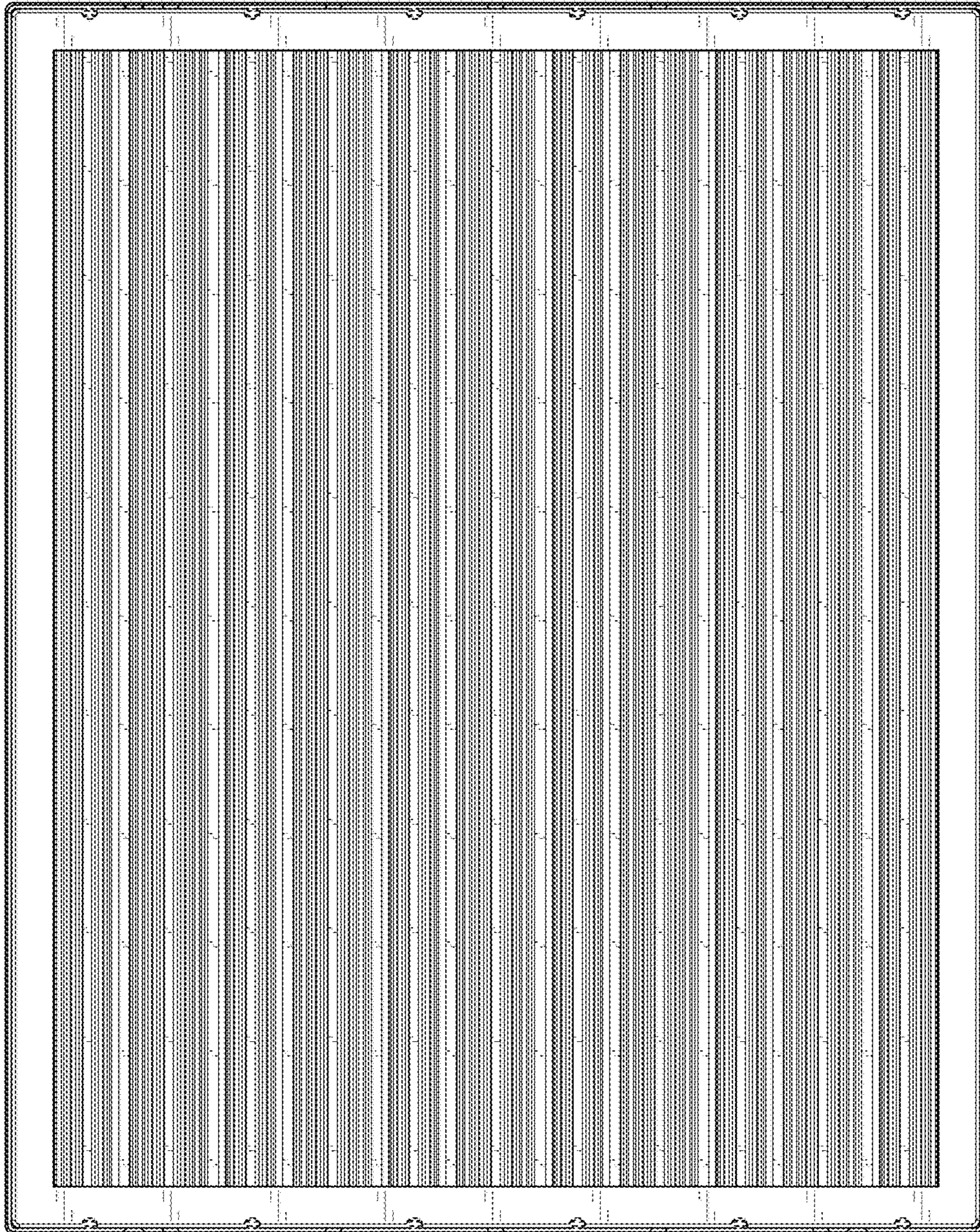

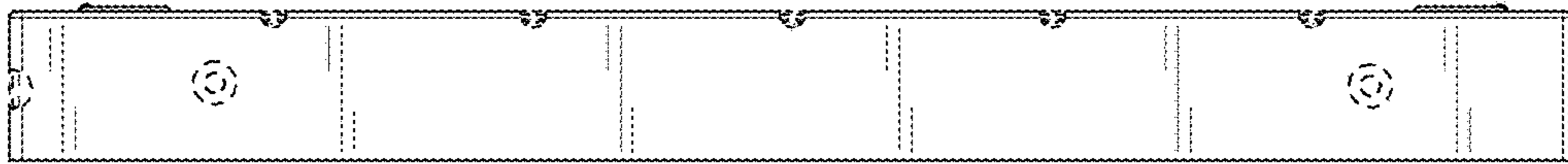

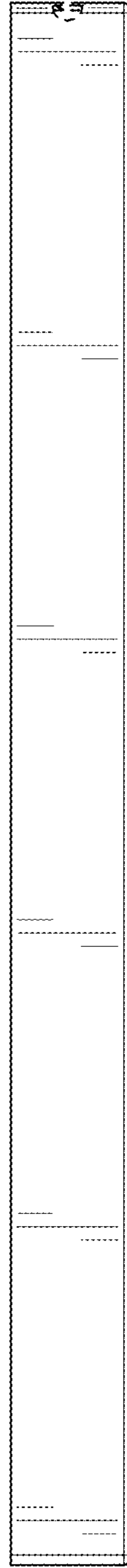
