**DESCRIPTION**

FIG. 1 is a perspective view of a tap according to the present invention.

FIG. 2 is a top plan view of the tap illustrated in FIG. 1.

FIG. 3 is a bottom plan elevation view of the tap illustrated in FIG. 1.

FIG. 4 is a left side elevation view of the tap illustrated in FIG. 1.

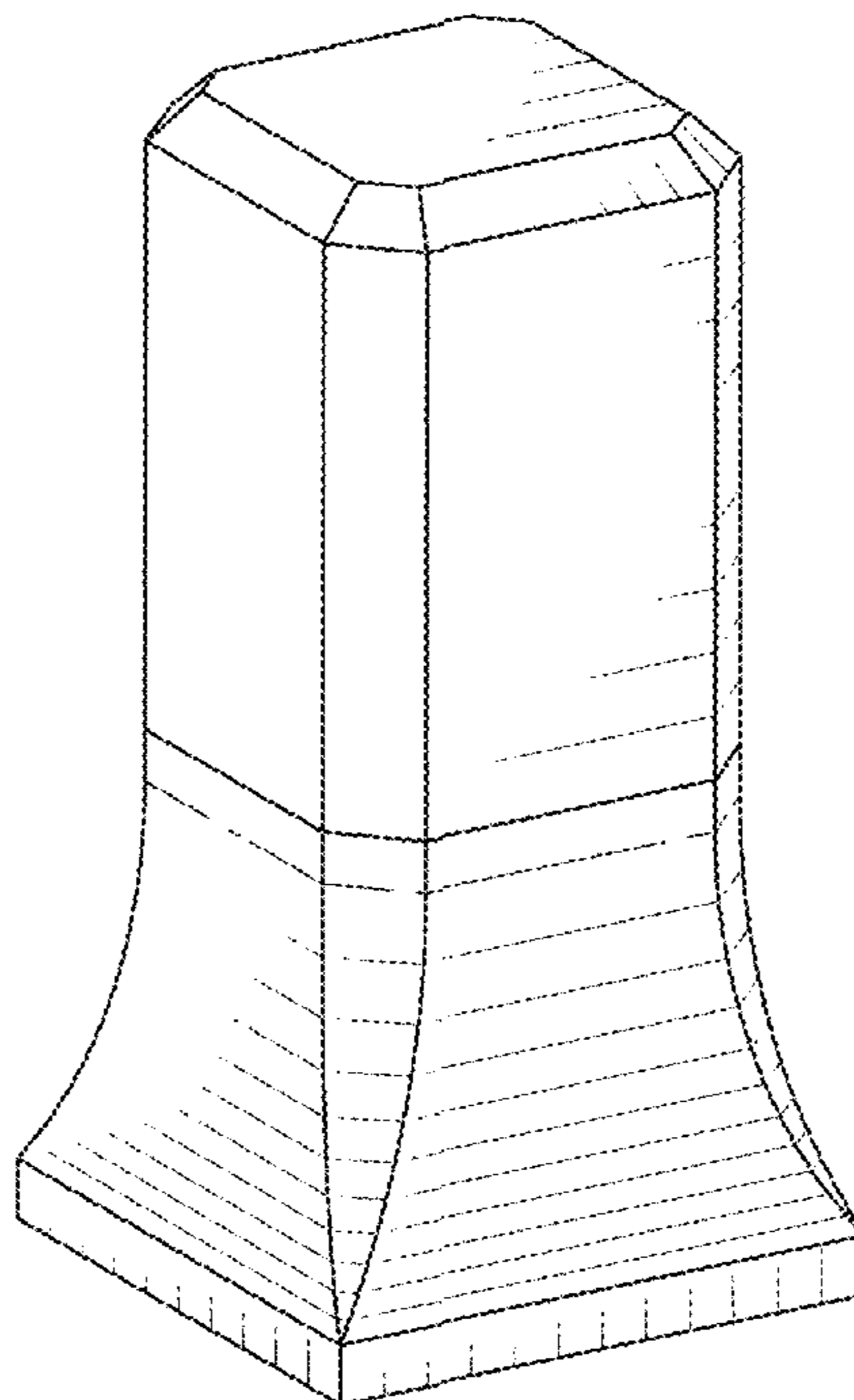
FIG. 5 is a right side elevation view of the tap illustrated in FIG. 1.

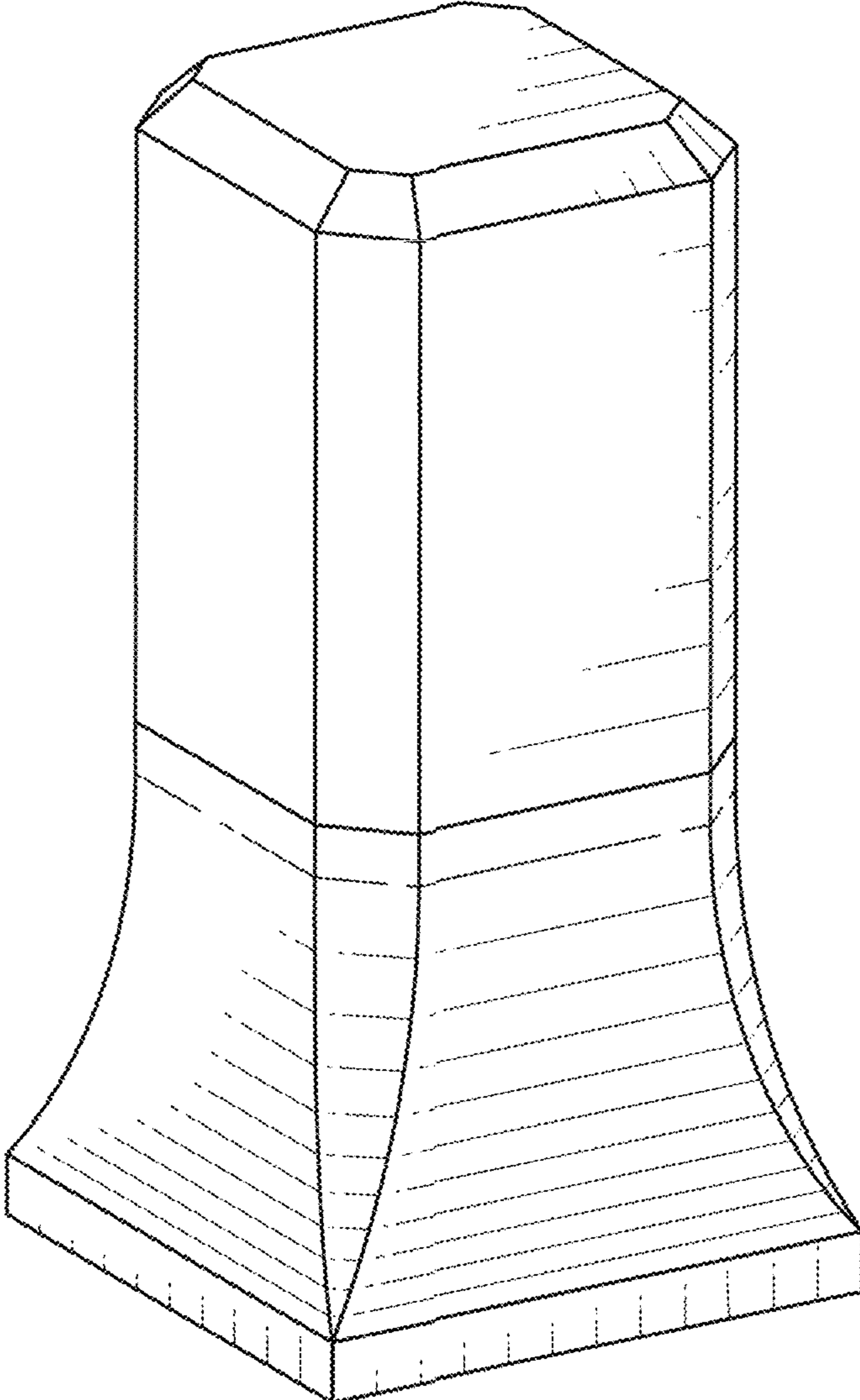

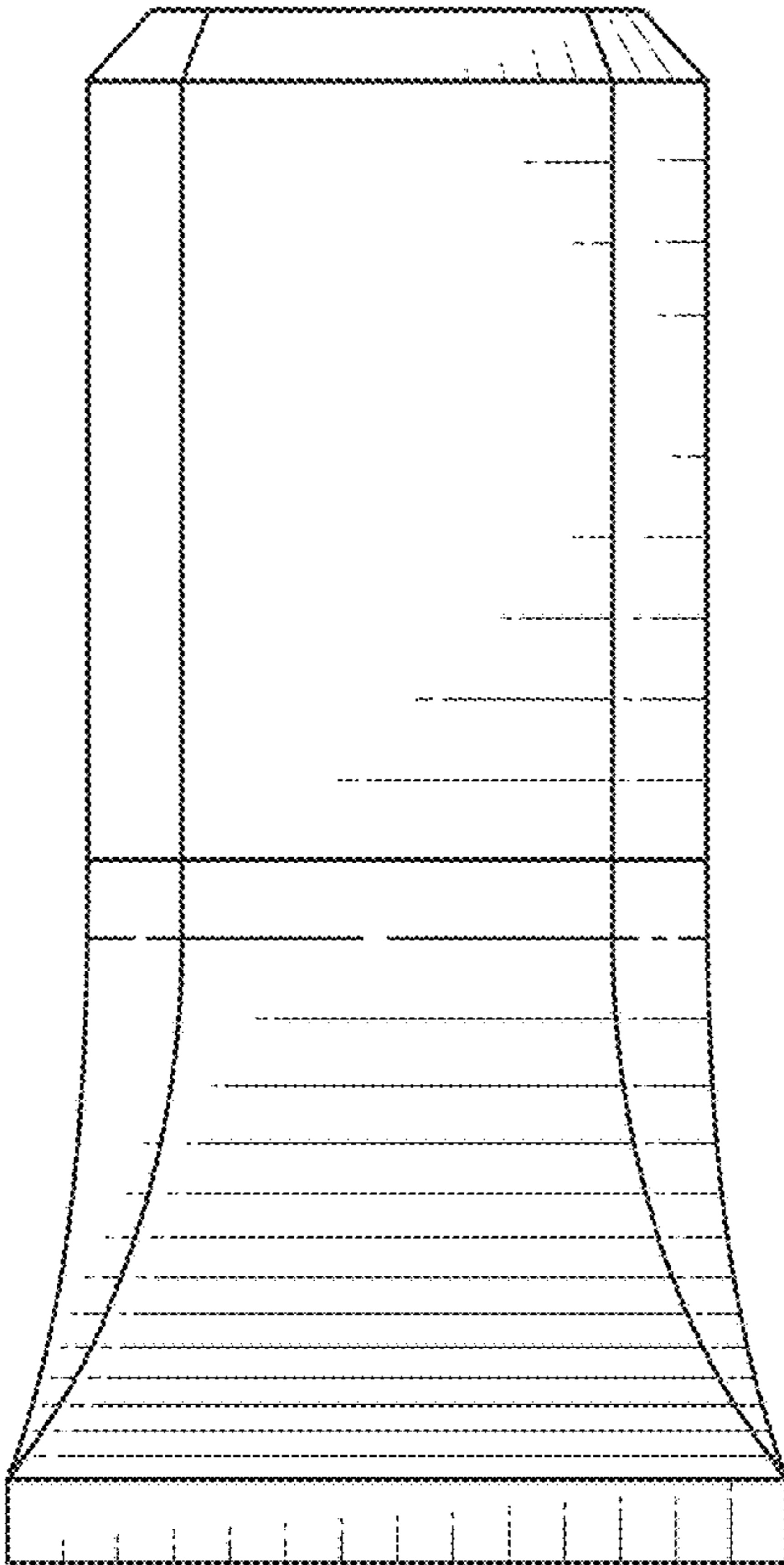

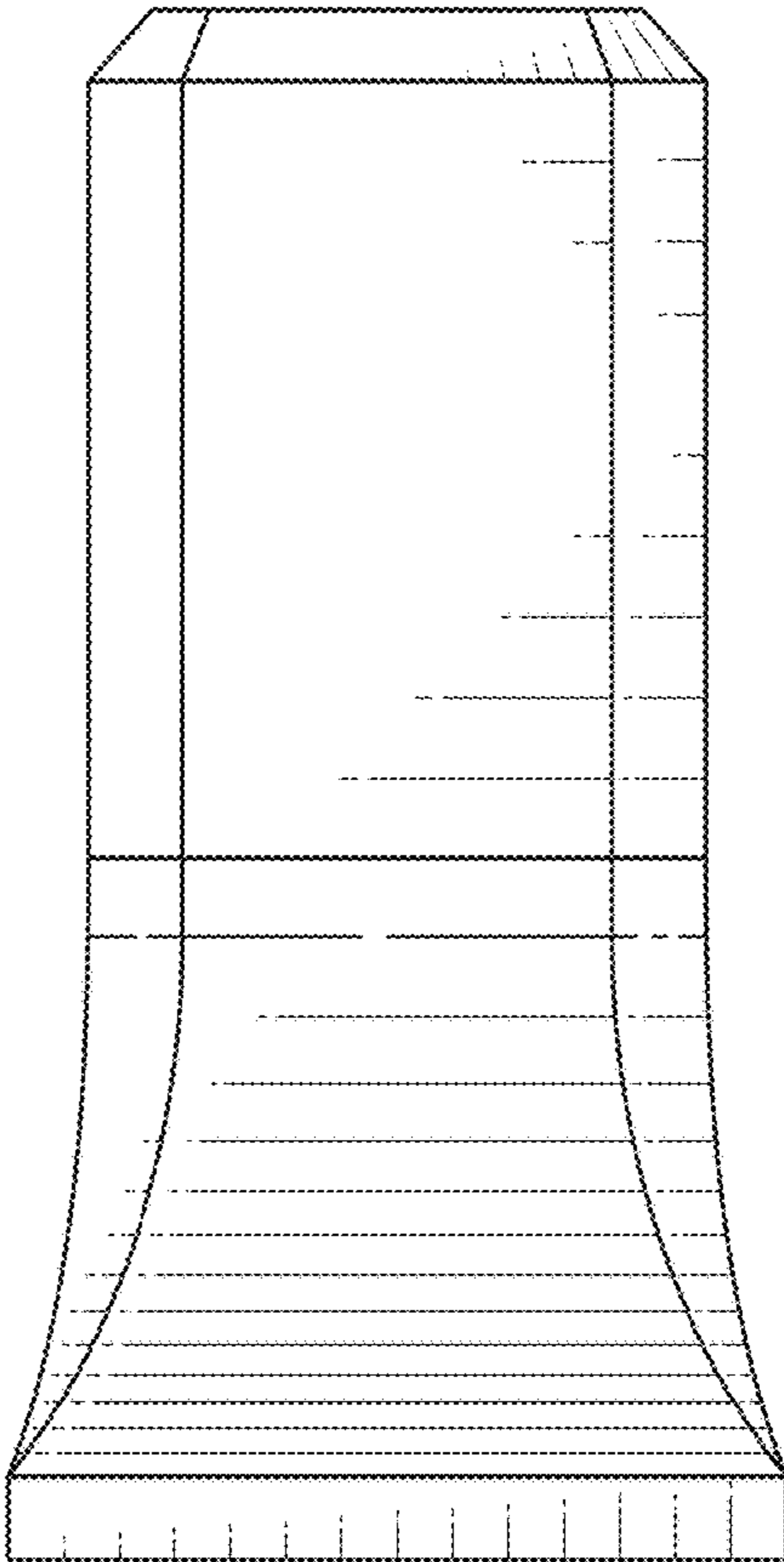

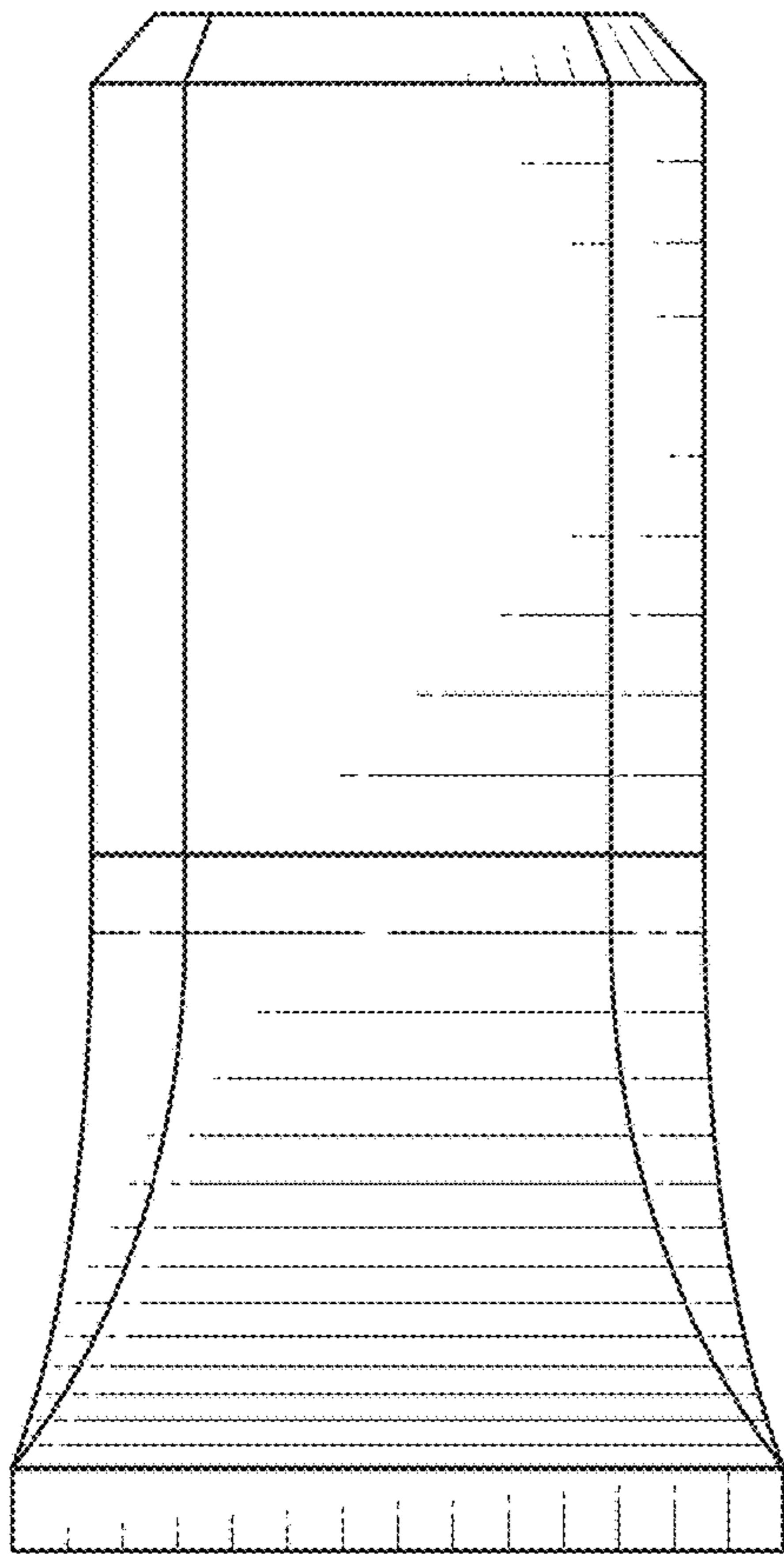

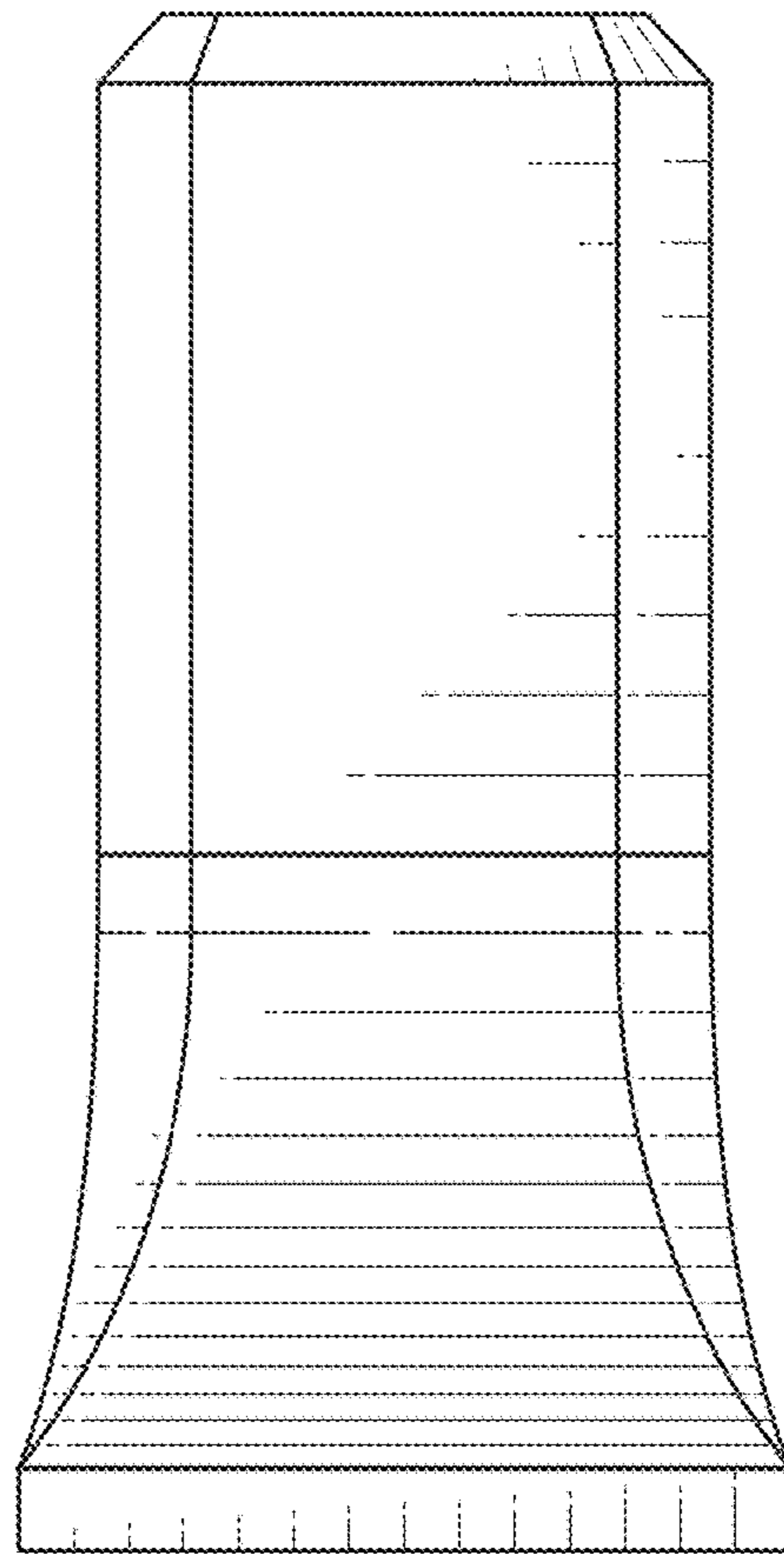

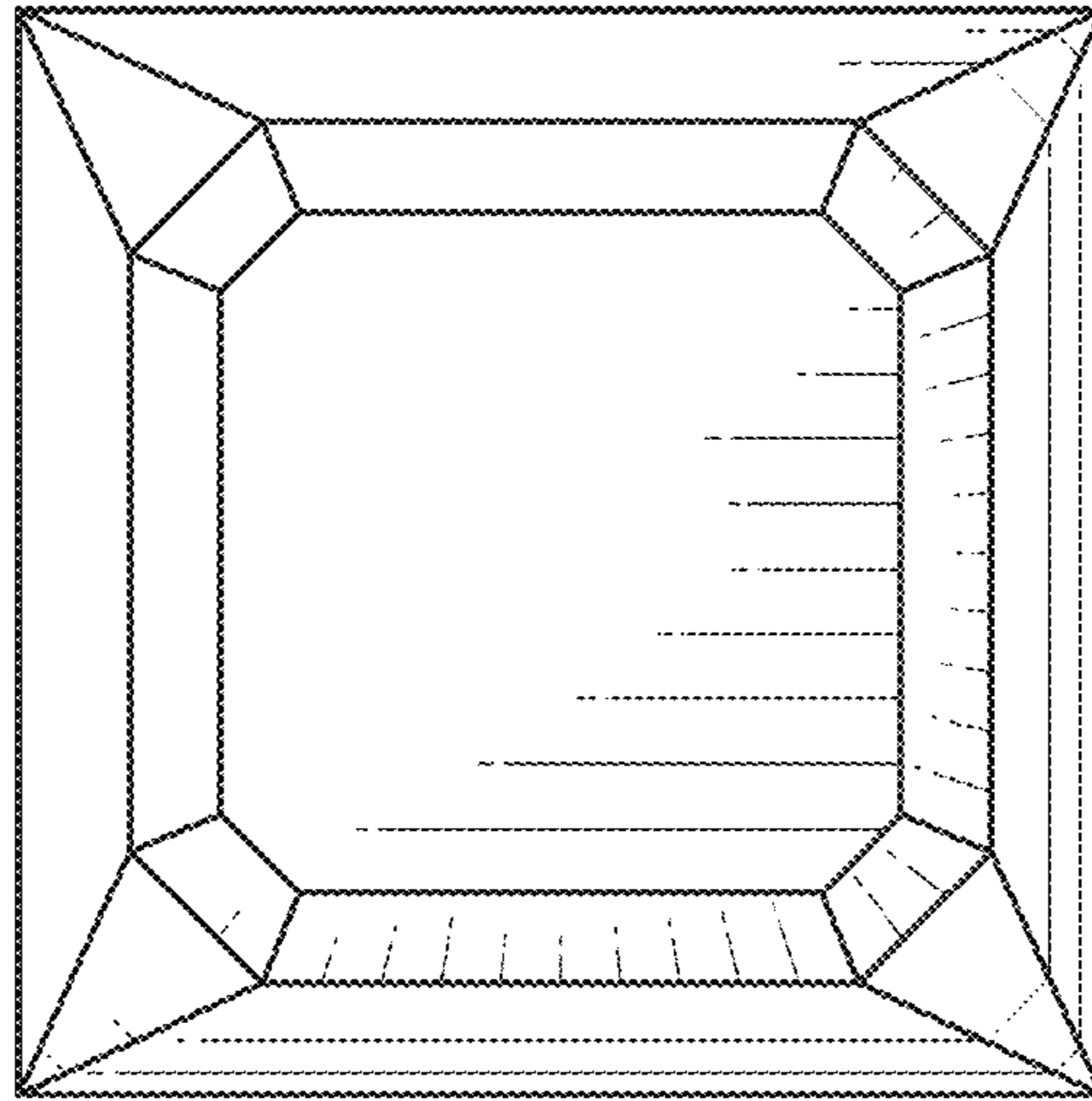

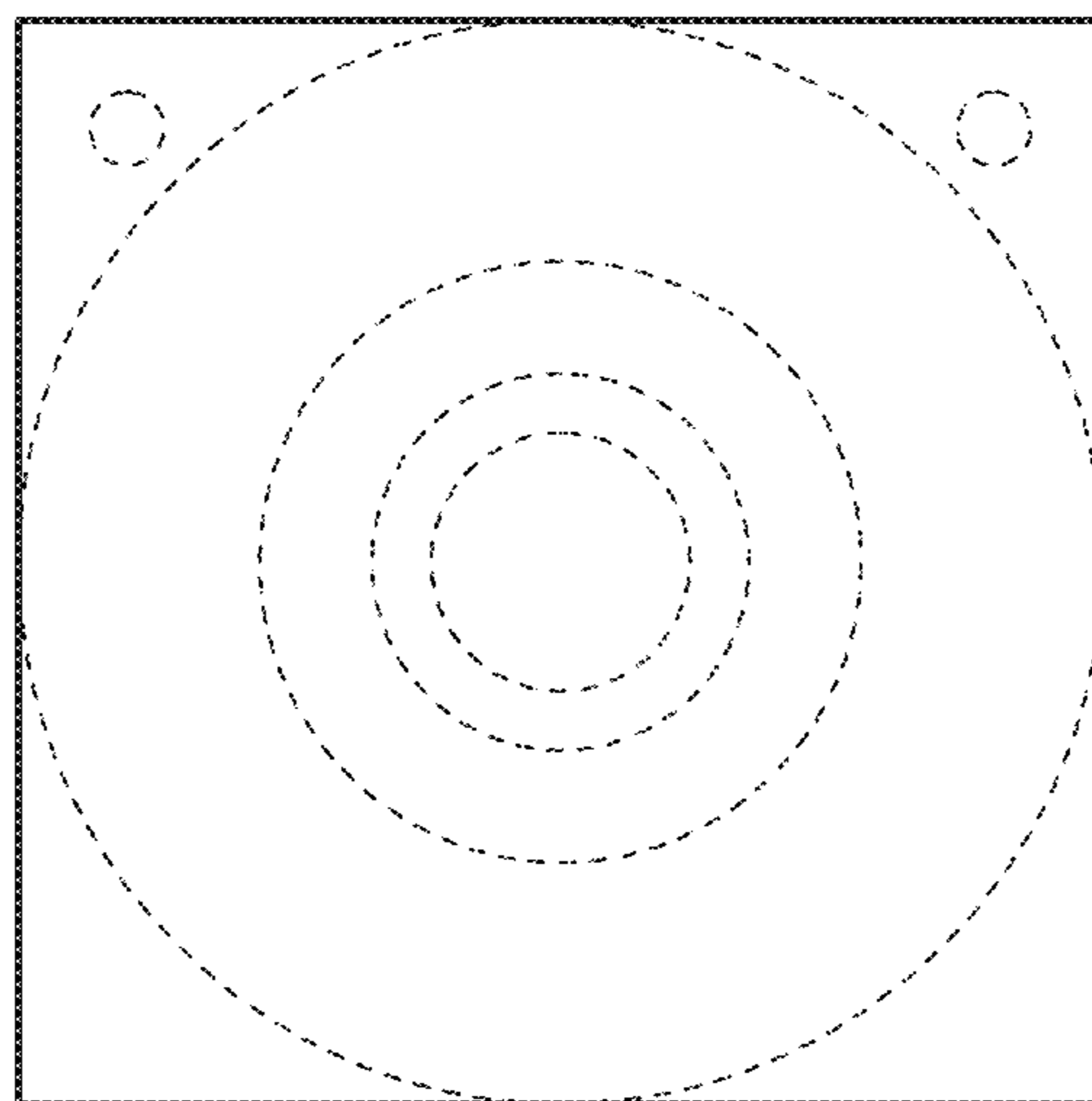
