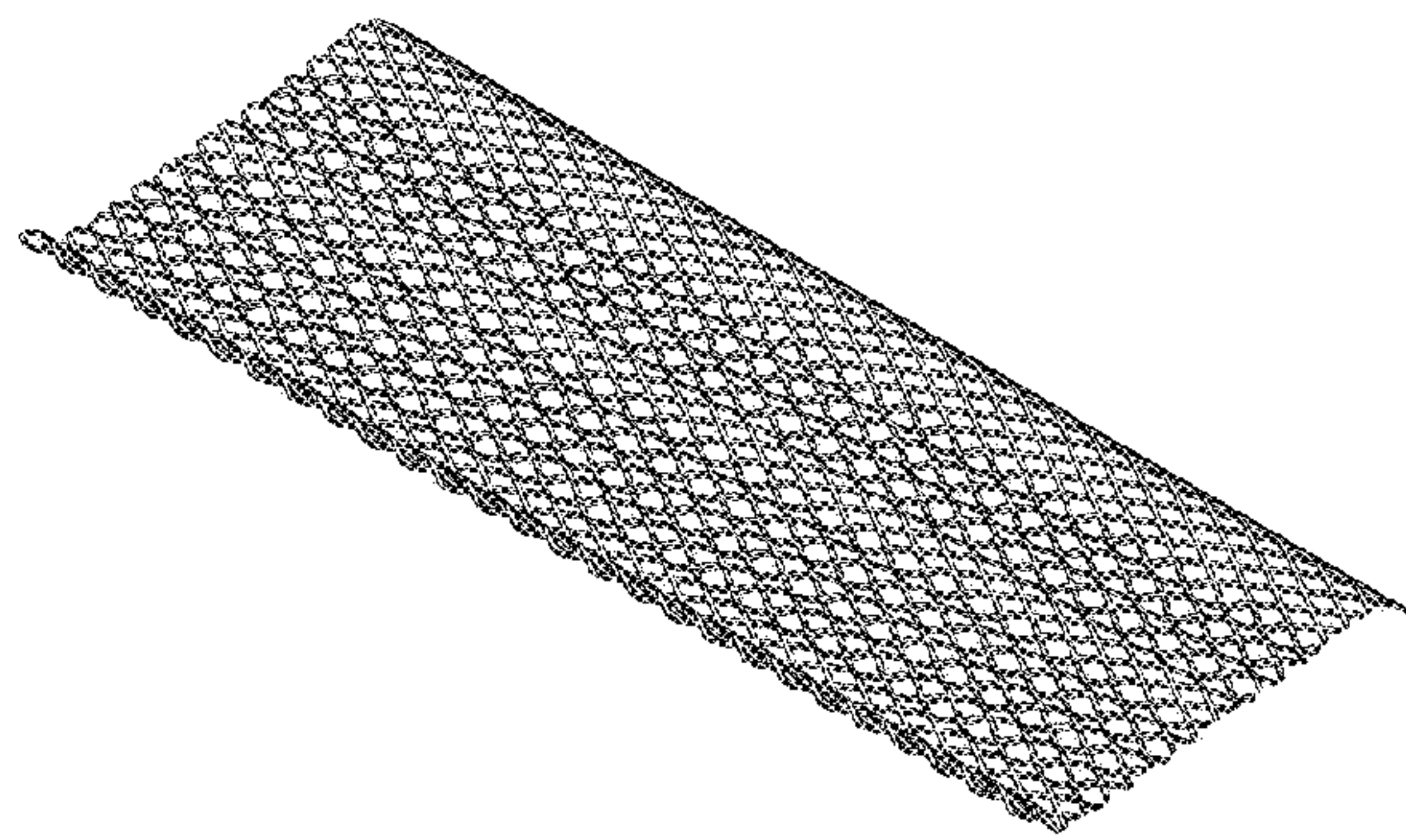
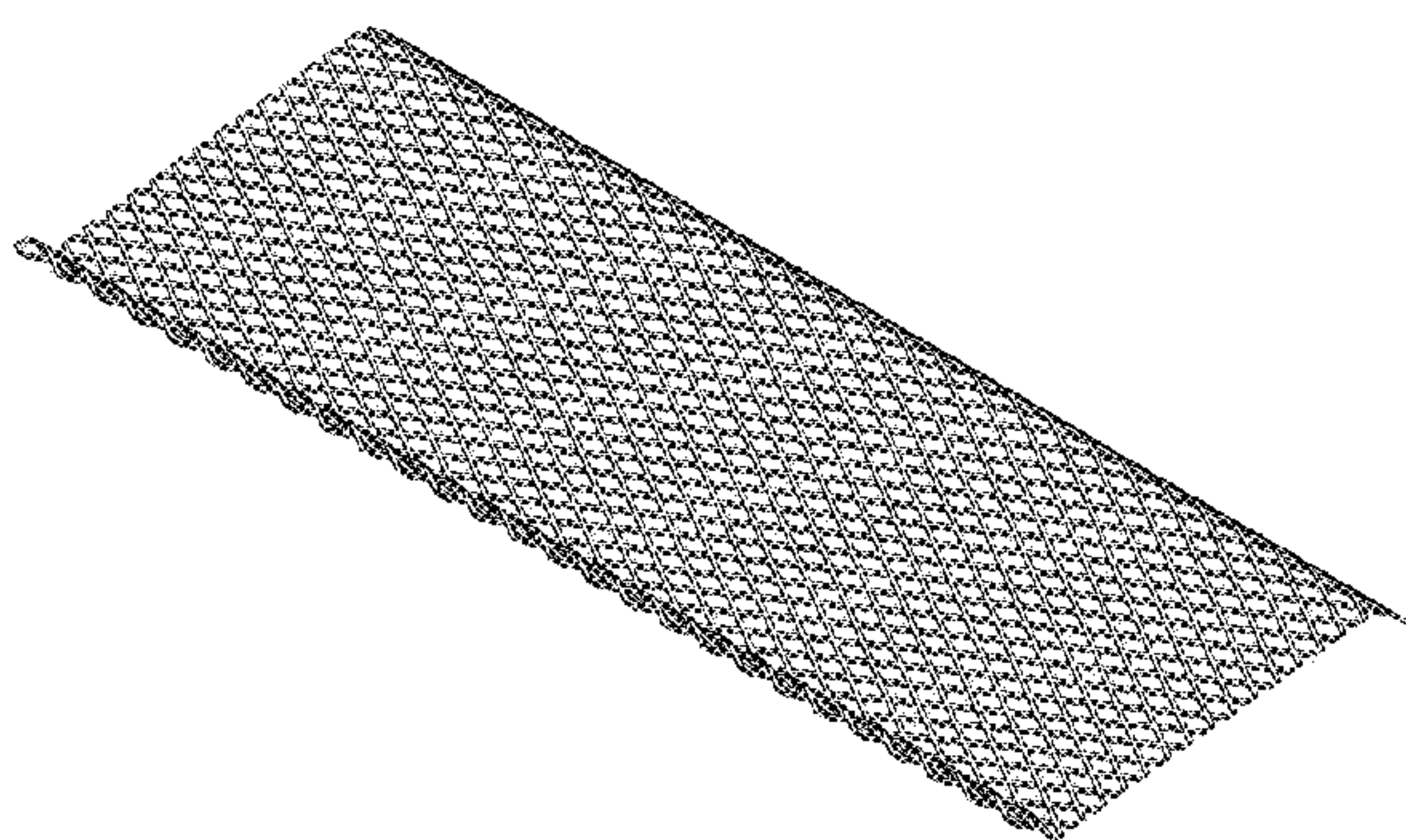
(57) **CLAIM**

I claim the ornamental design for a gutter cover, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a first embodiment of a gutter cover of my design.
FIG. 2 is a front view thereof.
FIG. 3 is a top view thereof.
FIG. 4 is a right end view thereof.
FIG. 5 is a rear view thereof.
FIG. 6 is a bottom view thereof.
FIG. 7 is a left end view thereof.
FIG. 8 is a top front perspective view of a second embodiment of a gutter cover of my design.
FIG. 9 is a right end view of FIG. 8, the left end view being a mirror image of FIG. 9.
FIG. 10 is a top front perspective view of a third embodiment of a gutter cover of my design.
FIG. 11 is a right end view of FIG. 10, the left end view being a mirror image of FIG. 11.
FIG. 12 is a top front perspective view of a fourth embodiment of a gutter cover of my design; and,
FIG. 13 is a right end view of FIG. 12, the left end view being a mirror image of FIG. 13.

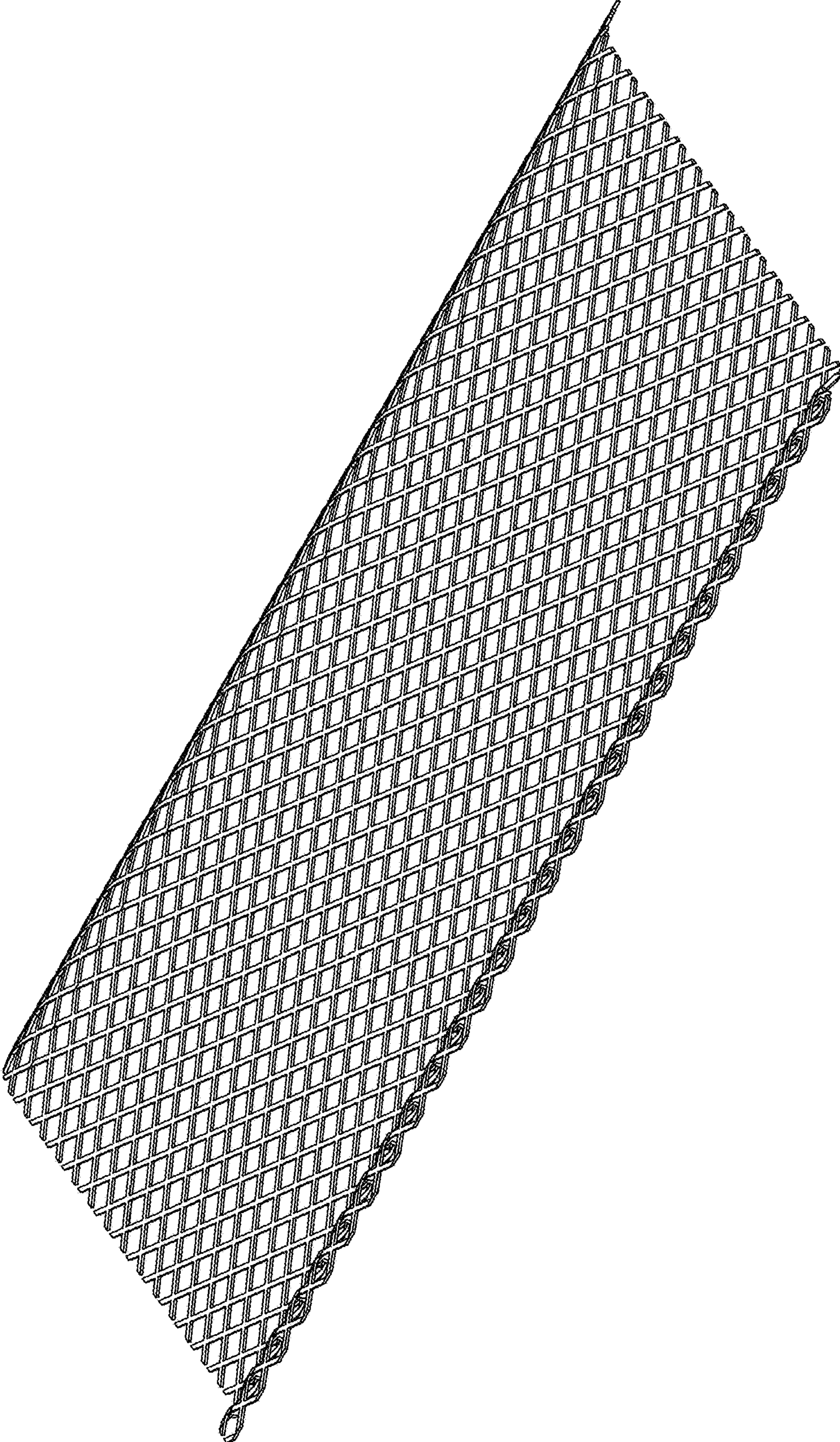

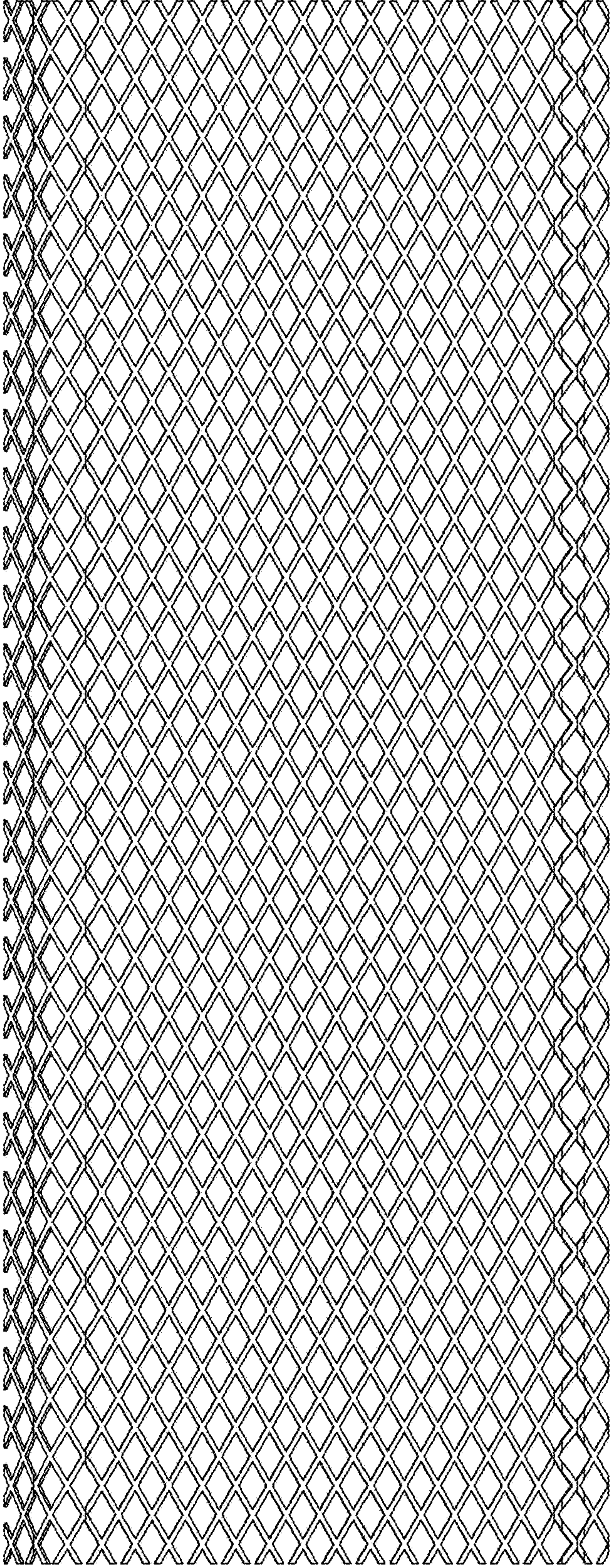

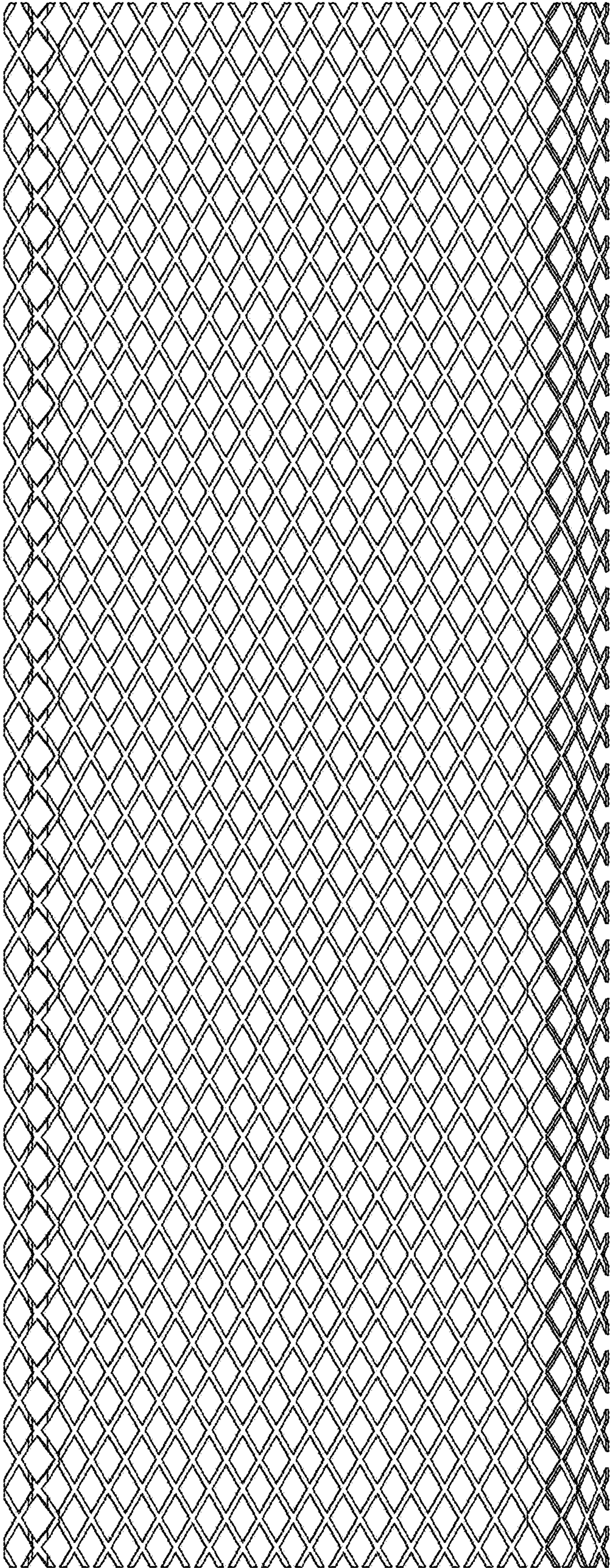

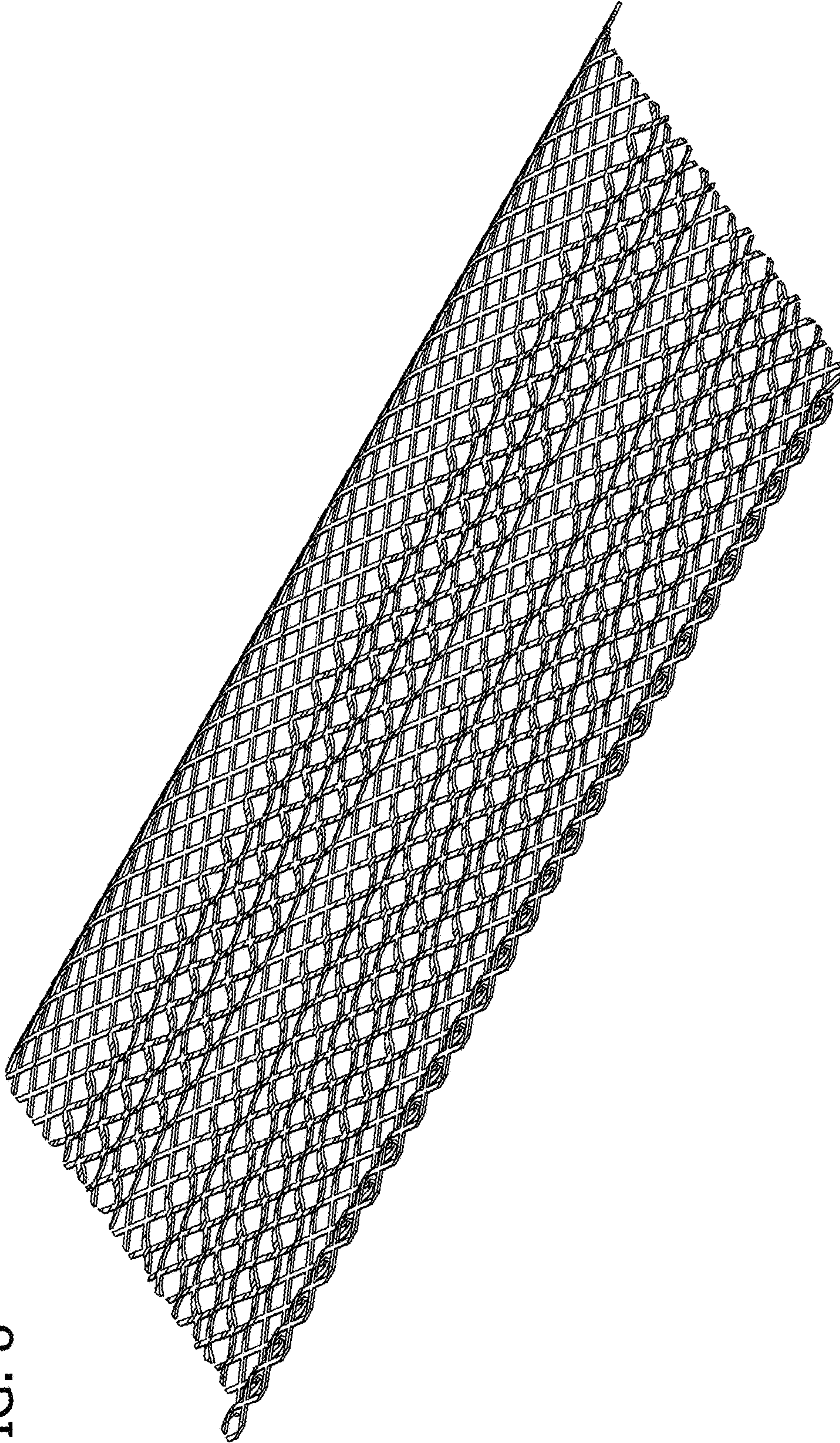

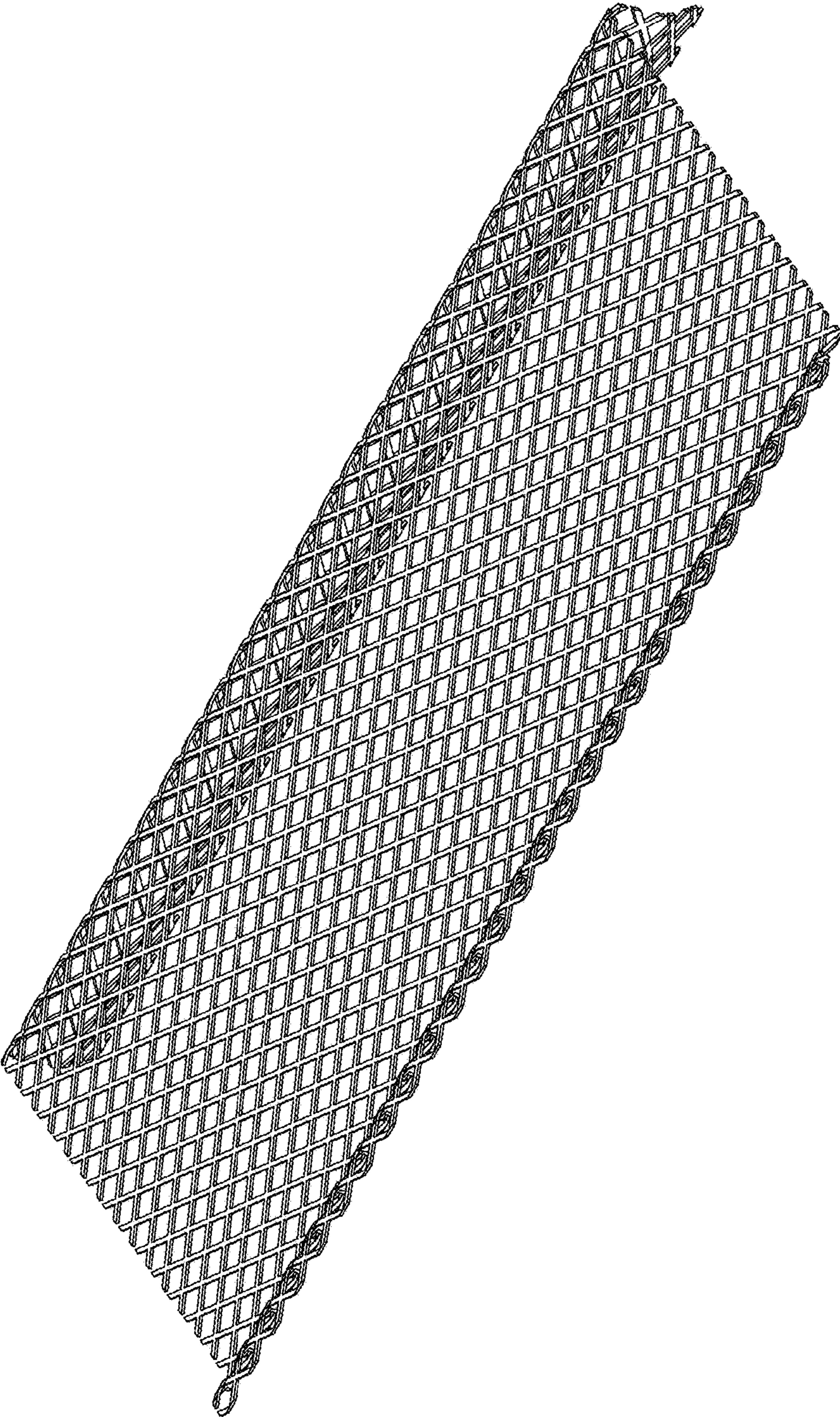
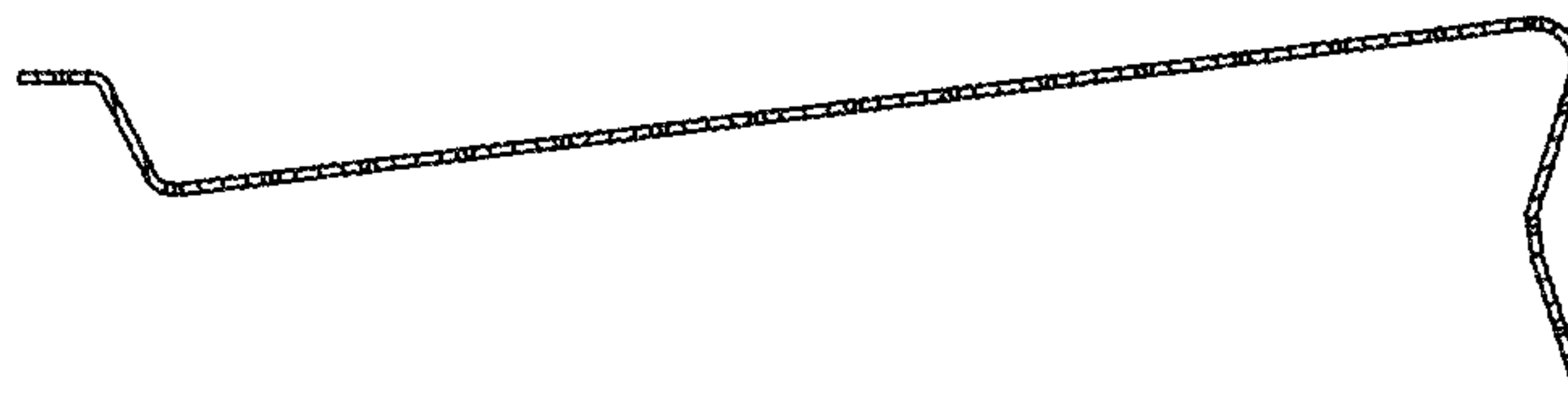

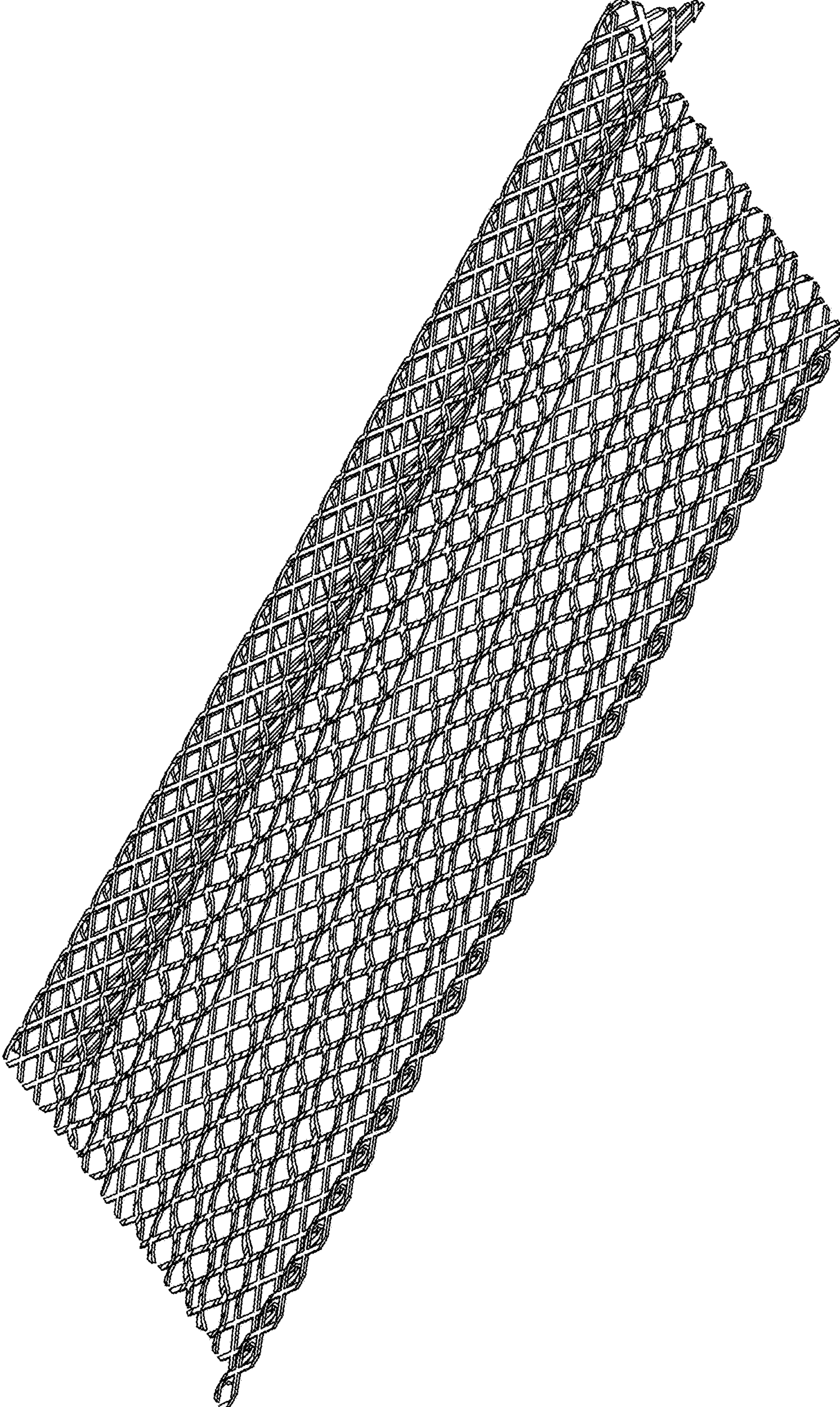
