(57) **CLAIM**

We claim the ornamental design for a roof and wall panel, as shown and described.

DESCRIPTION

FIG. 1 is a left end elevation view of a roof and wall panel showing our new design.

FIG. 2 is a right end elevation view of the roof and wall panel.

FIG. 3 is a front left perspective view of the roof and wall panel.

FIG. 4 is a rear left perspective view of the roof and wall panel.

FIG. 5 is a top plan view of the roof and wall panel.

FIG. 6 is a front elevation view of the roof and wall panel.

FIG. 7 is a rear elevation view of the roof and wall panel.

FIG. 8 is an enlarged detail of circumscribed area "8" in FIG. 1.

FIG. 9 is an enlarged detail of circumscribed area "9" in FIG. 1.

FIG. 10 is a left end elevation view of a roof and wall panel showing an alternative embodiment of our new design.

FIG. 11 is a right end elevation view of the roof and wall panel shown in FIG. 10.

FIG. 12 is a front left perspective view of the roof and wall panel shown in FIG. 10.

FIG. 13 is a rear left perspective view of the roof and wall panel shown in FIG. 10.

FIG. 14 is a top plan view of the roof and wall panel shown in FIG. 10.

FIG. 15 is a rear elevation view of the roof and wall panel shown in FIG. 10.

FIG. 16 is a front elevation view of the roof and wall panel shown in FIG. 10.

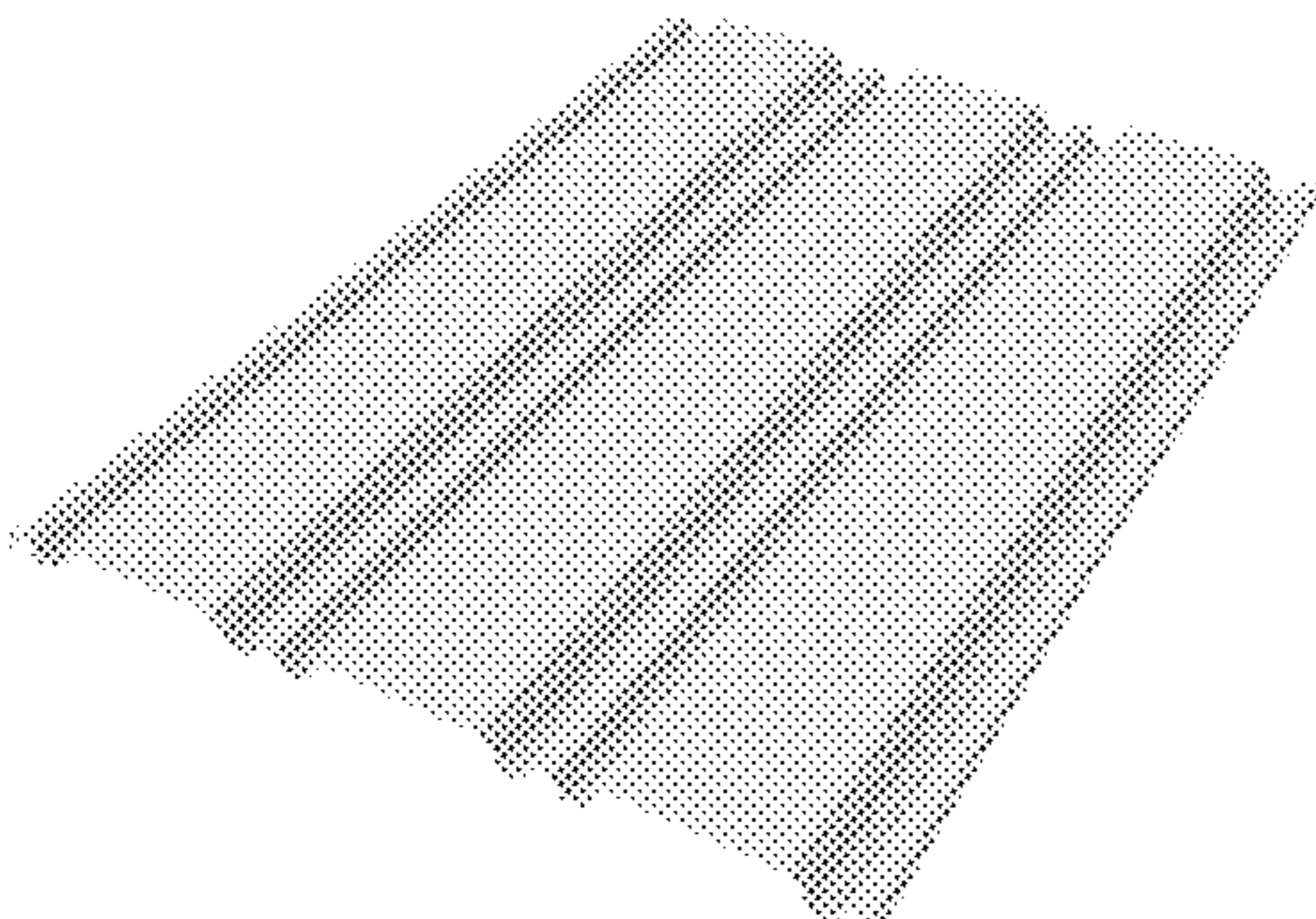


FIG. 18 is an enlarged detail of circumscribed area "18" in FIG. 10.

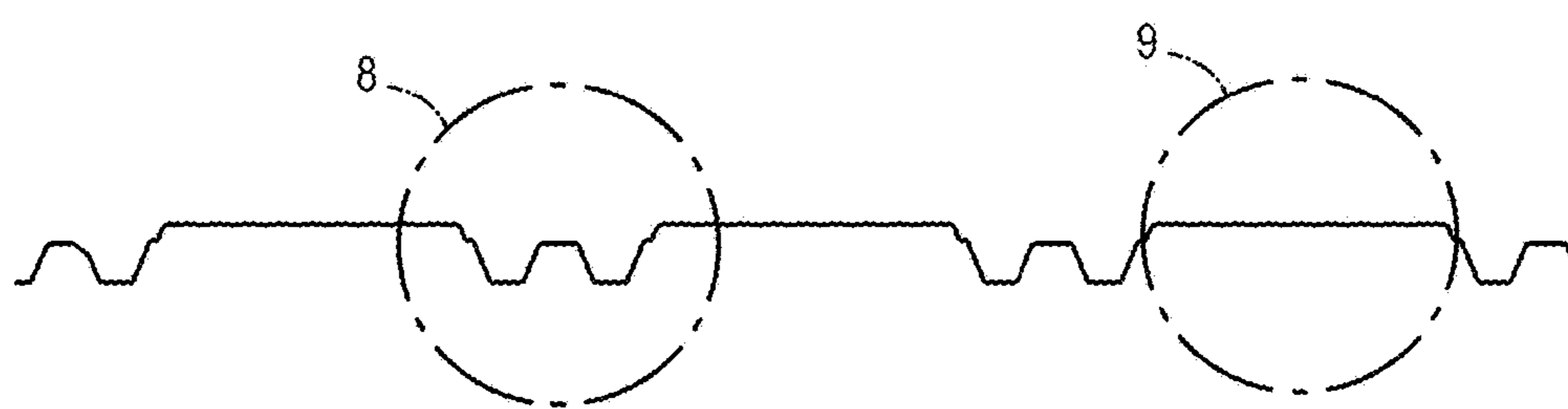

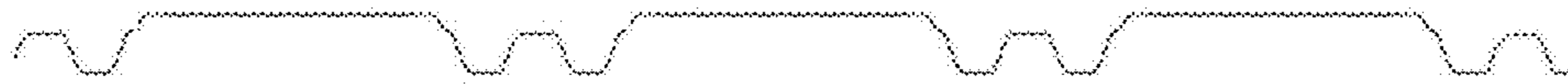

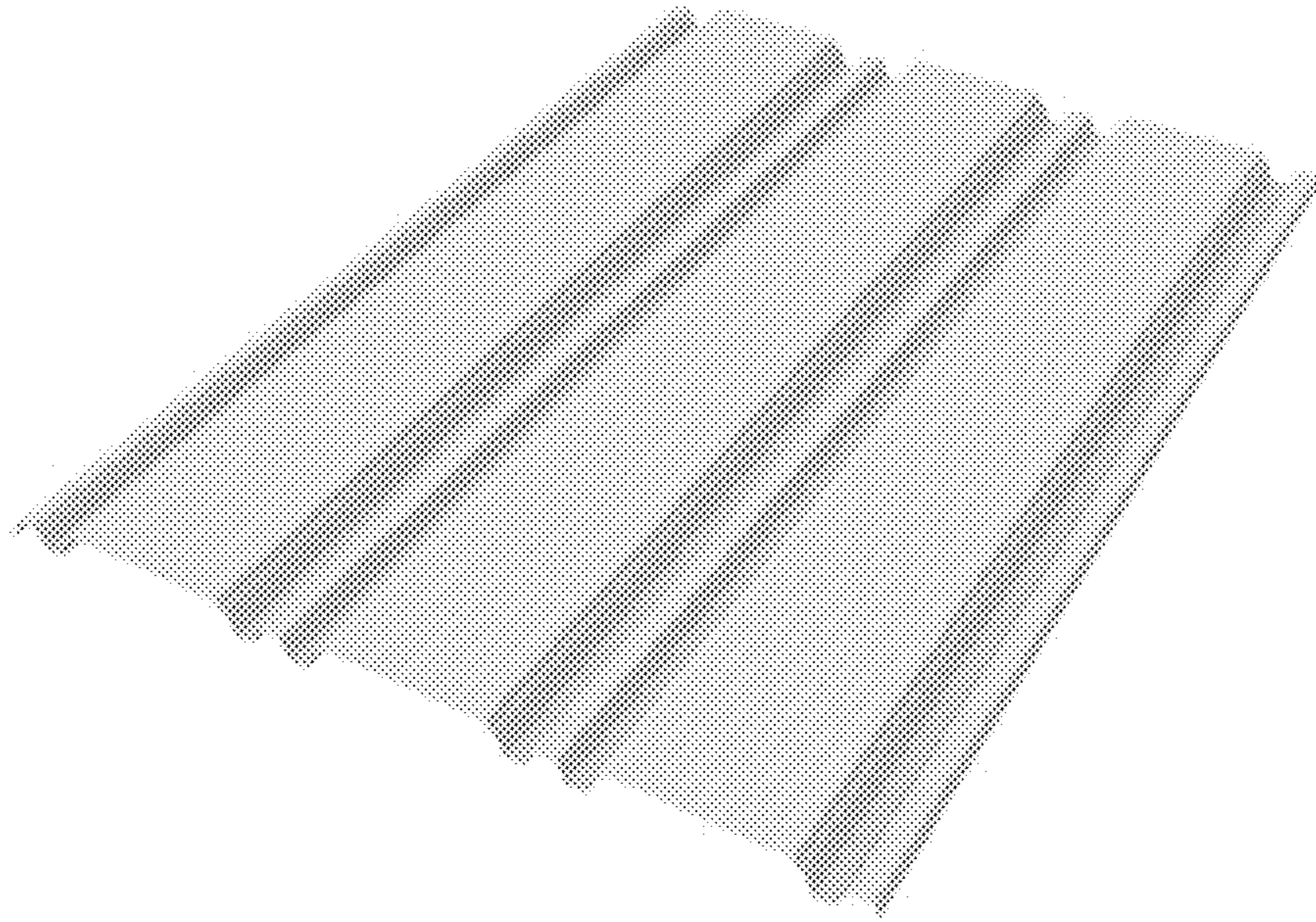

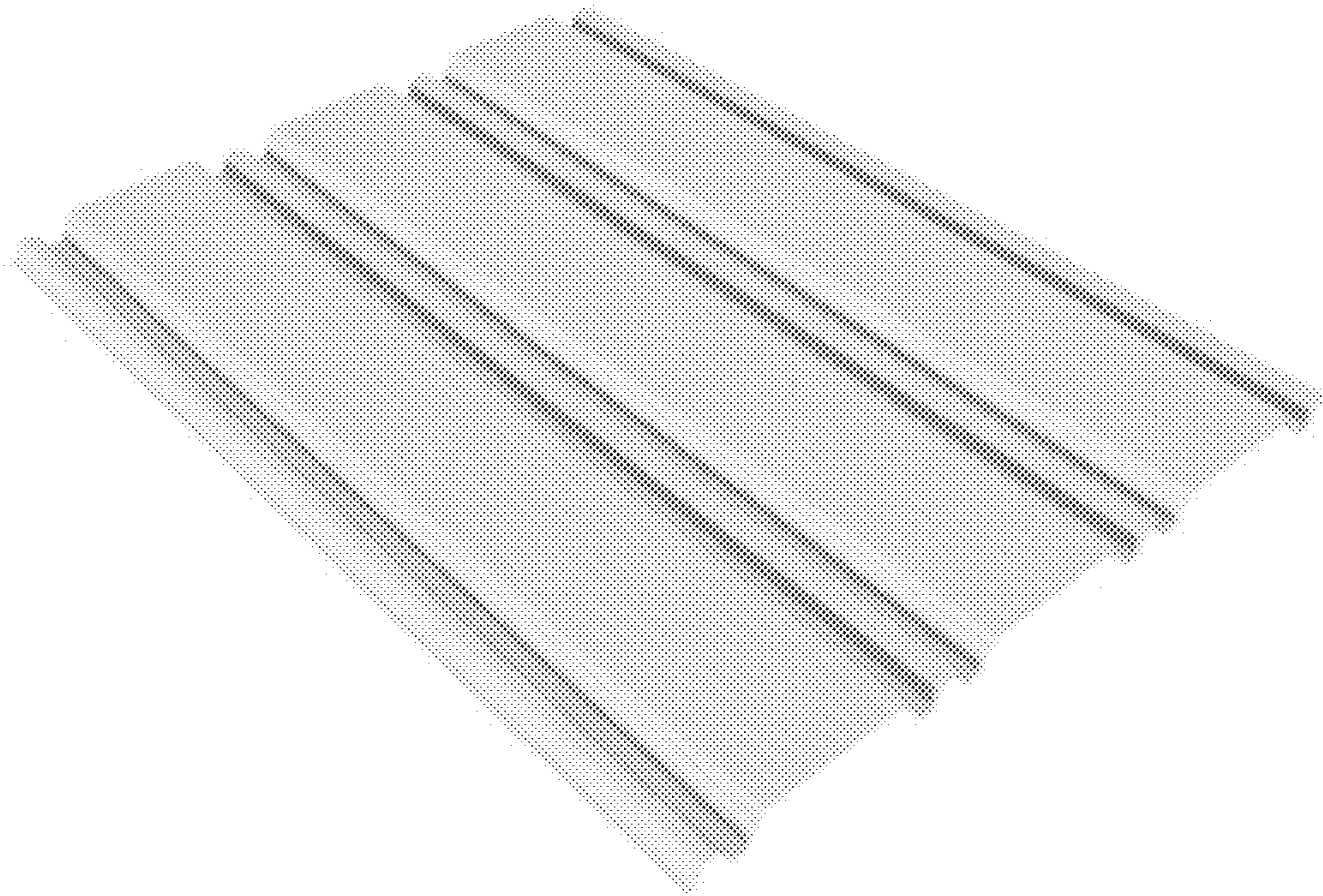

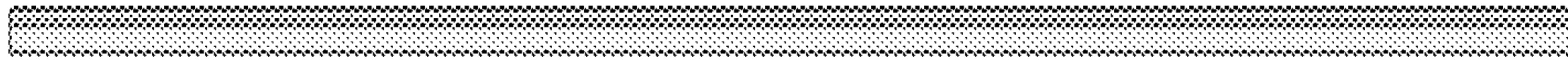

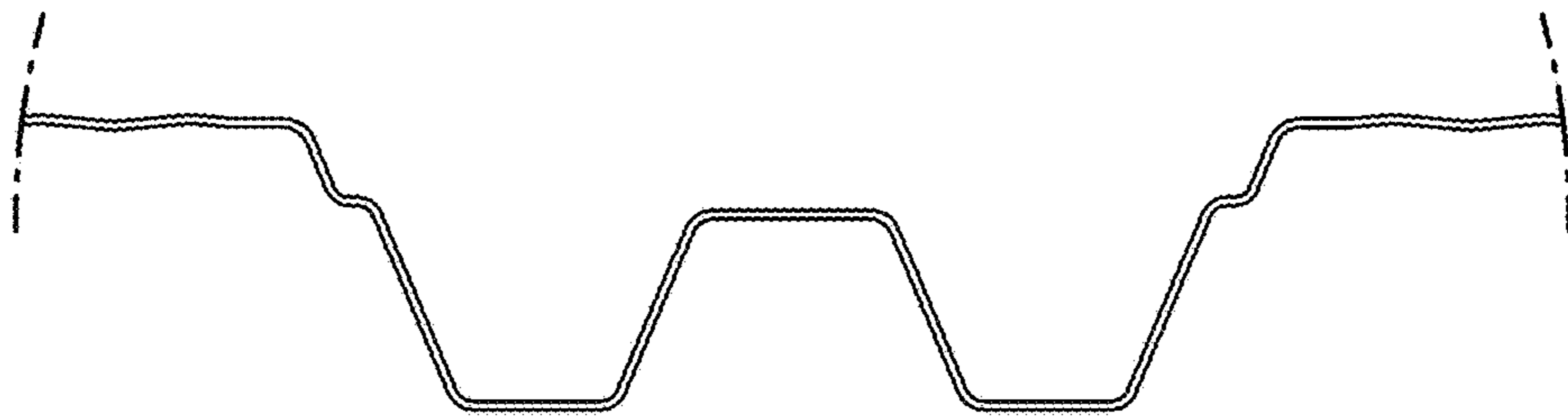

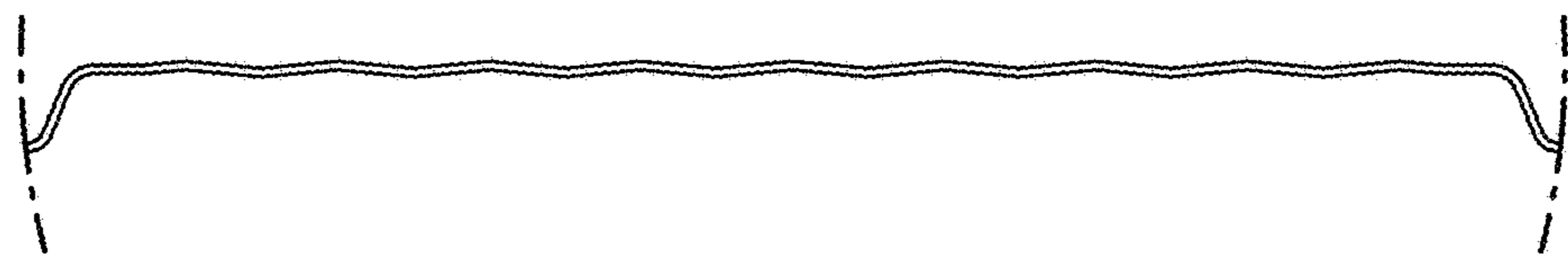

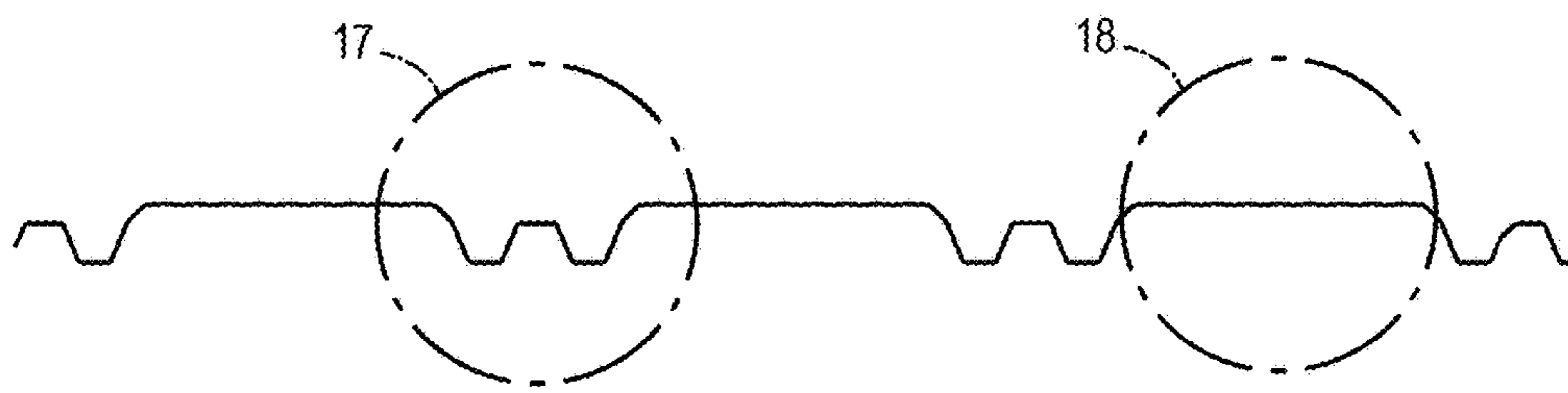

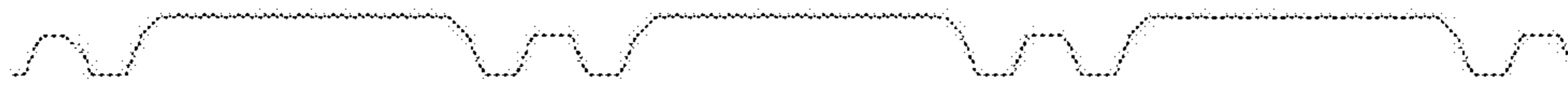

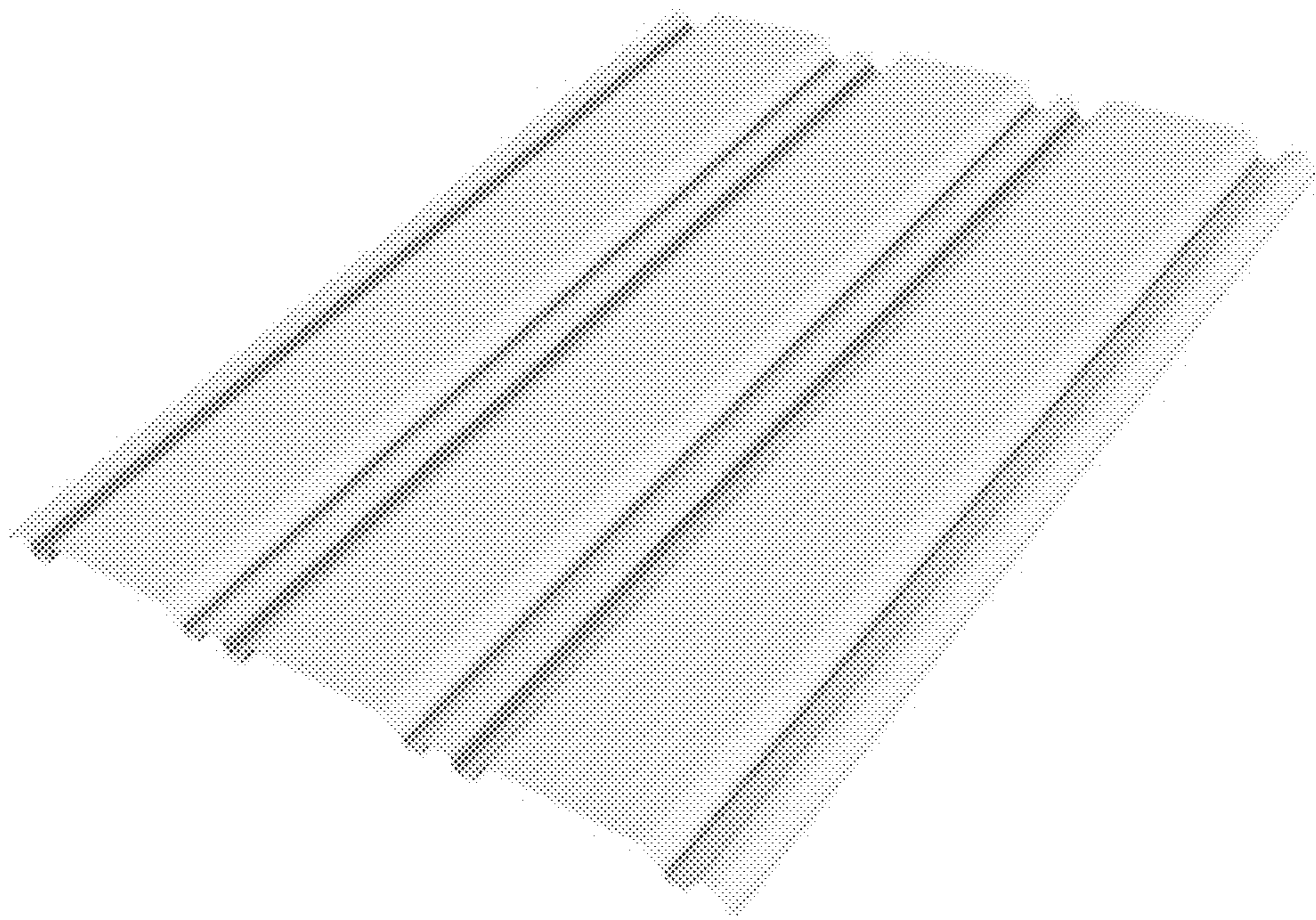

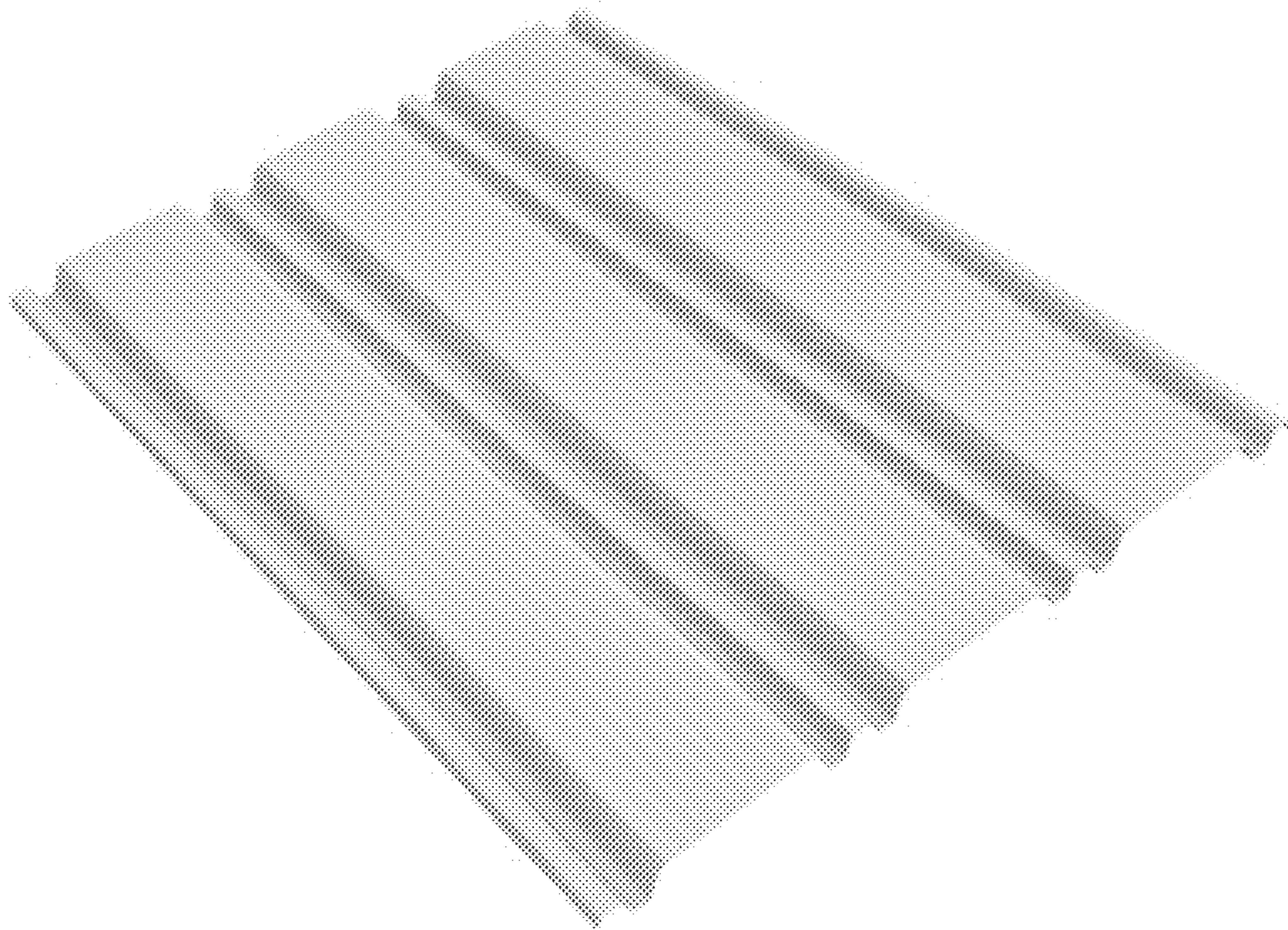

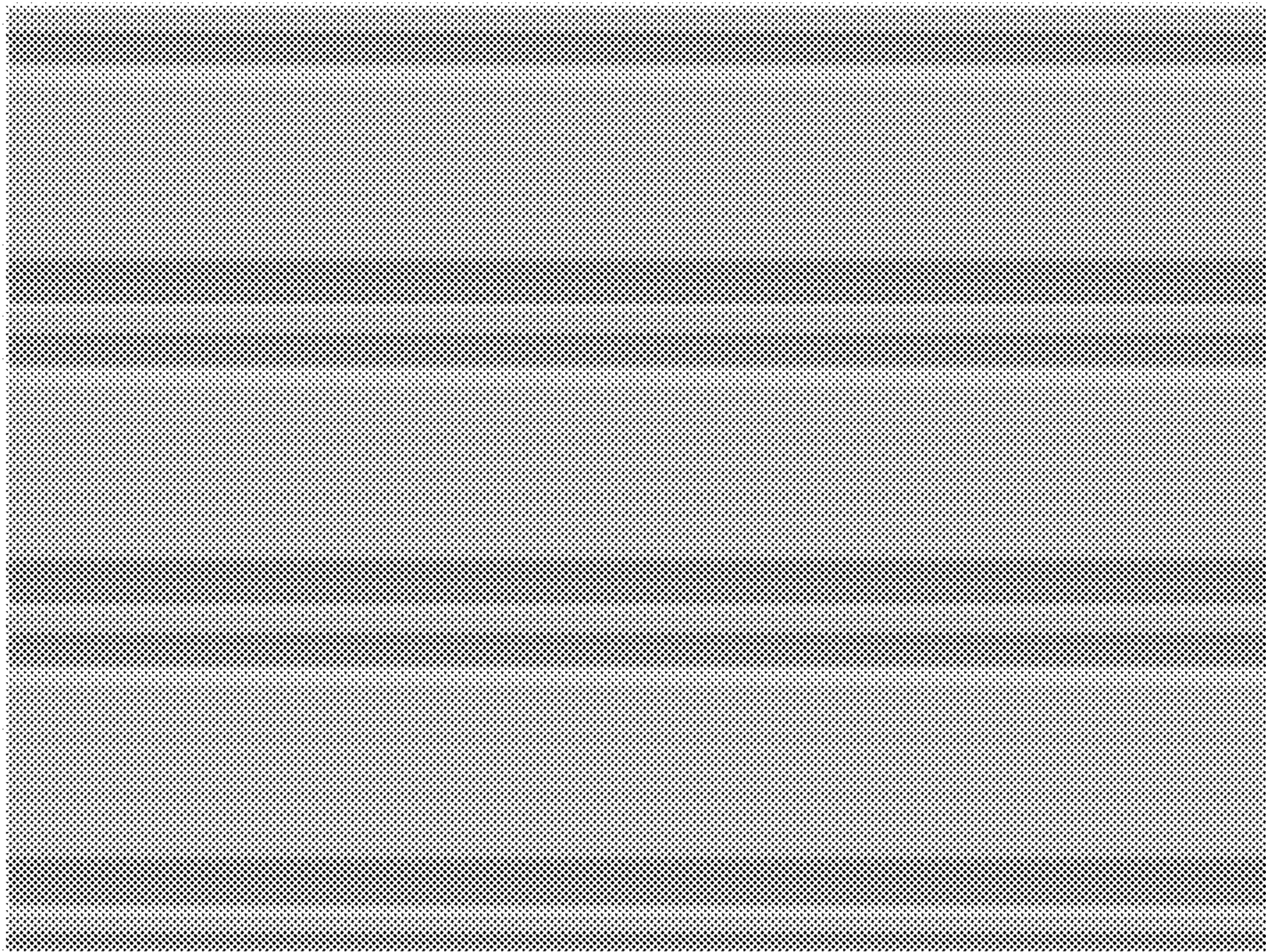

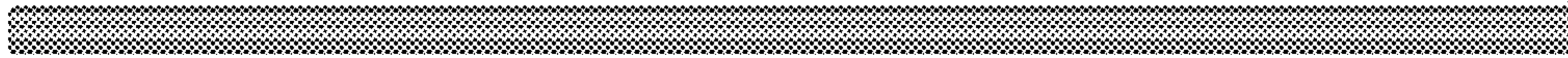

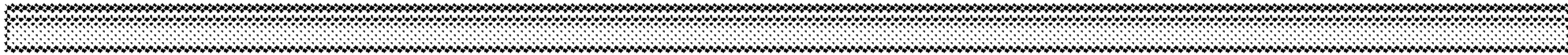

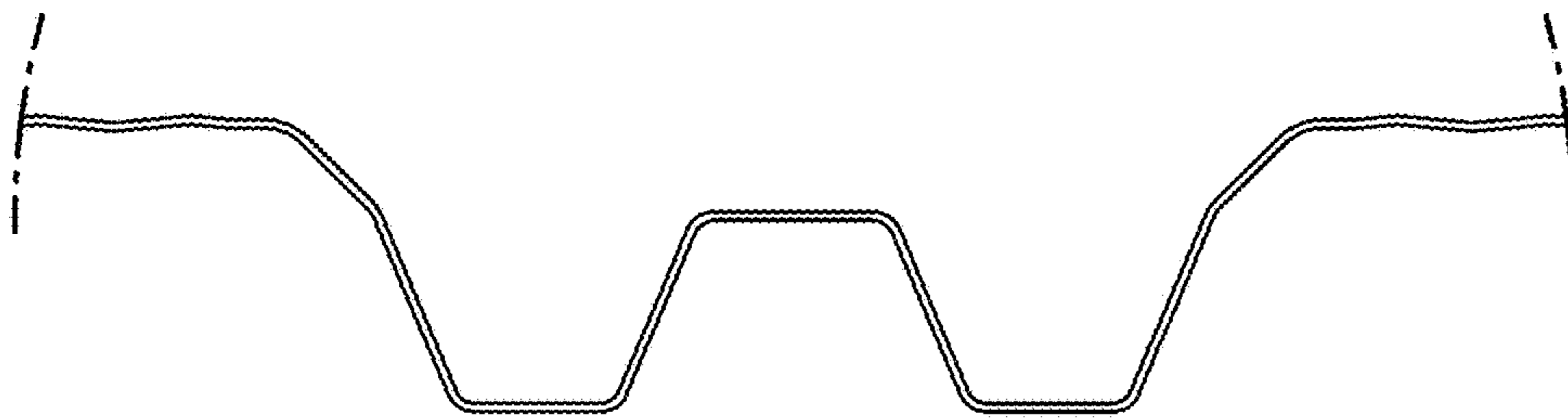

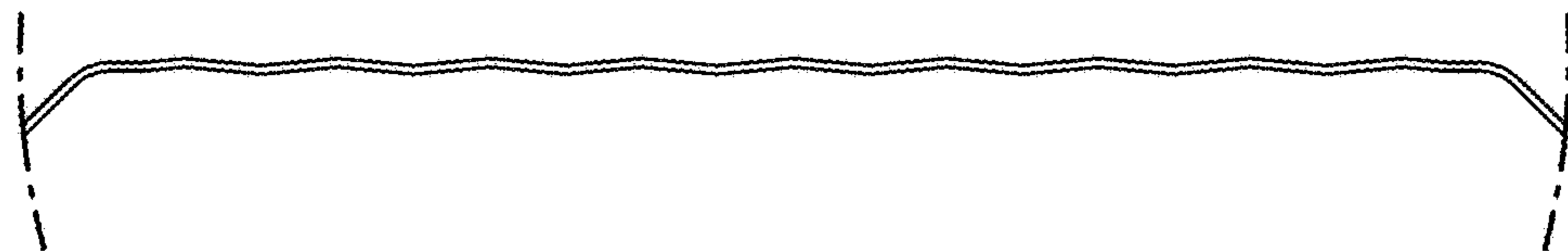
