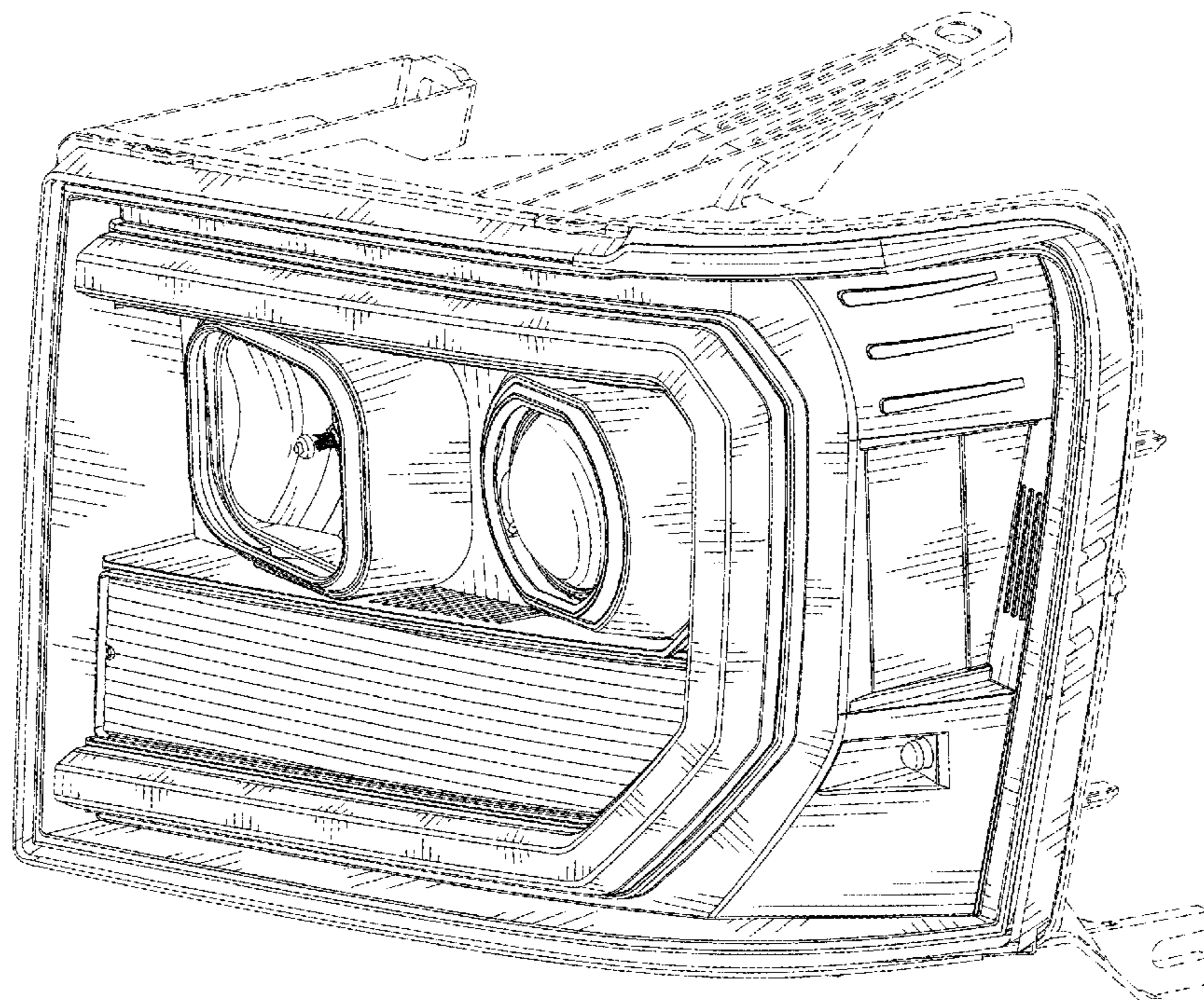
FIG. 1 is a top and right perspective view of a vehicle

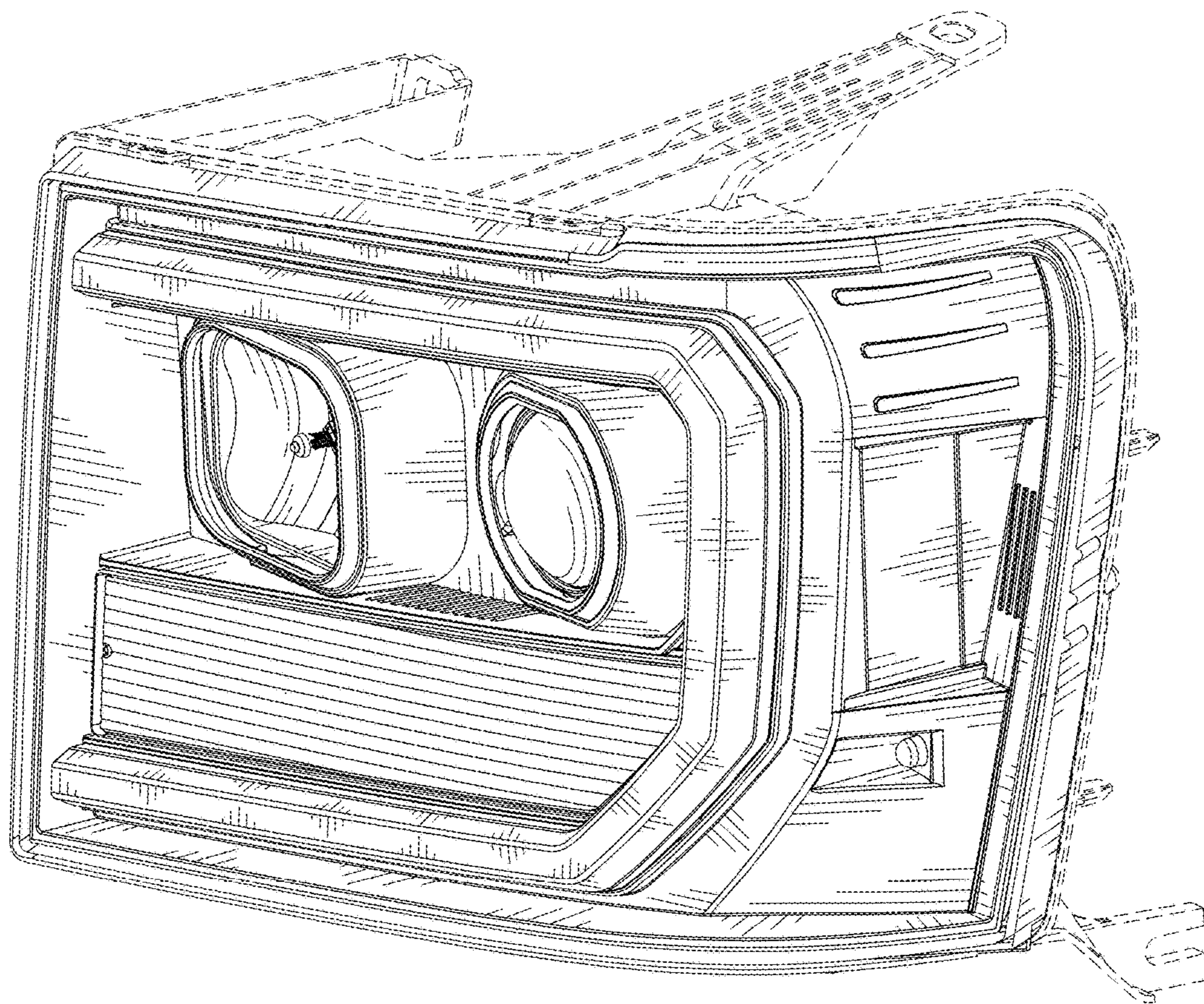

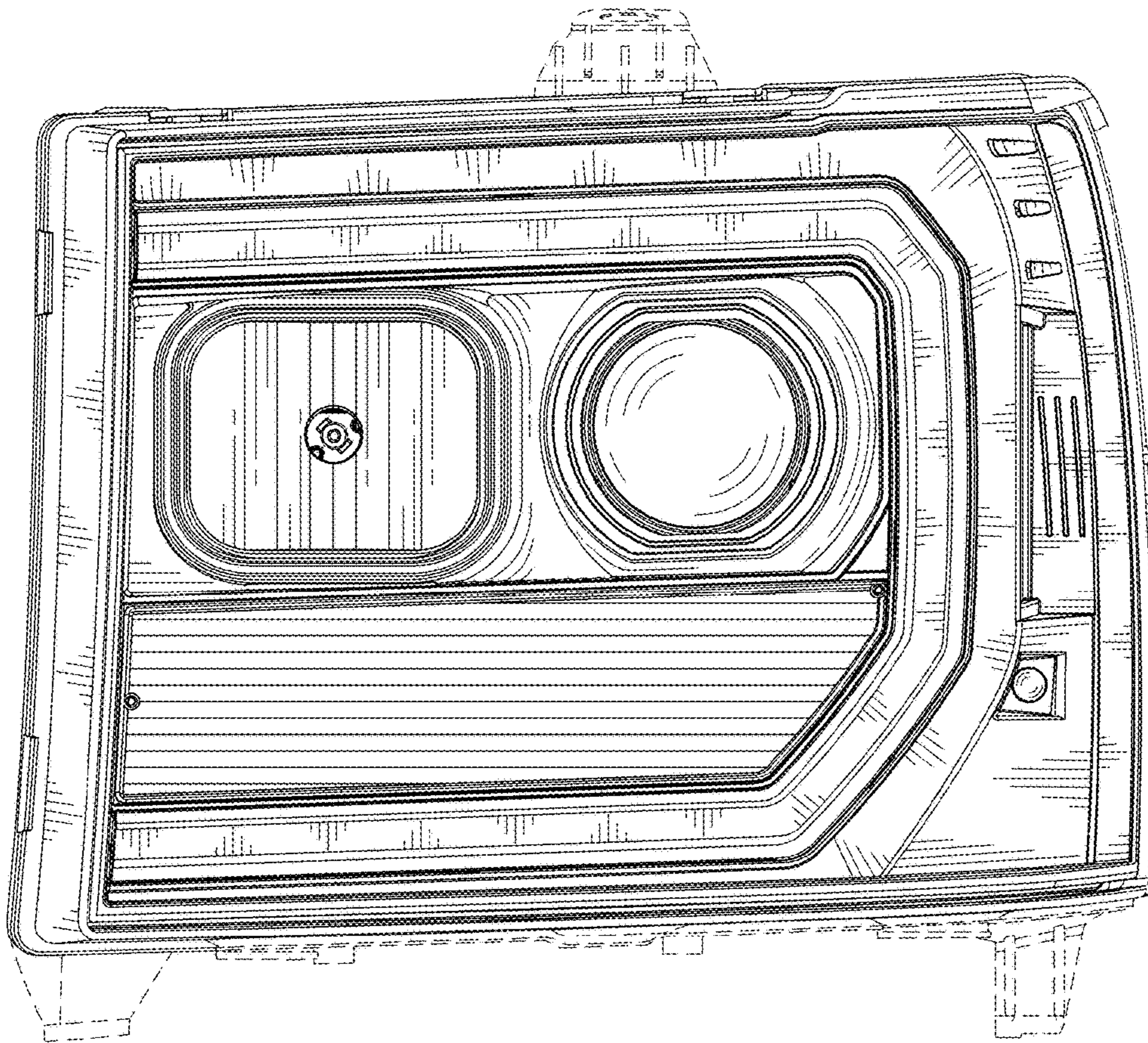

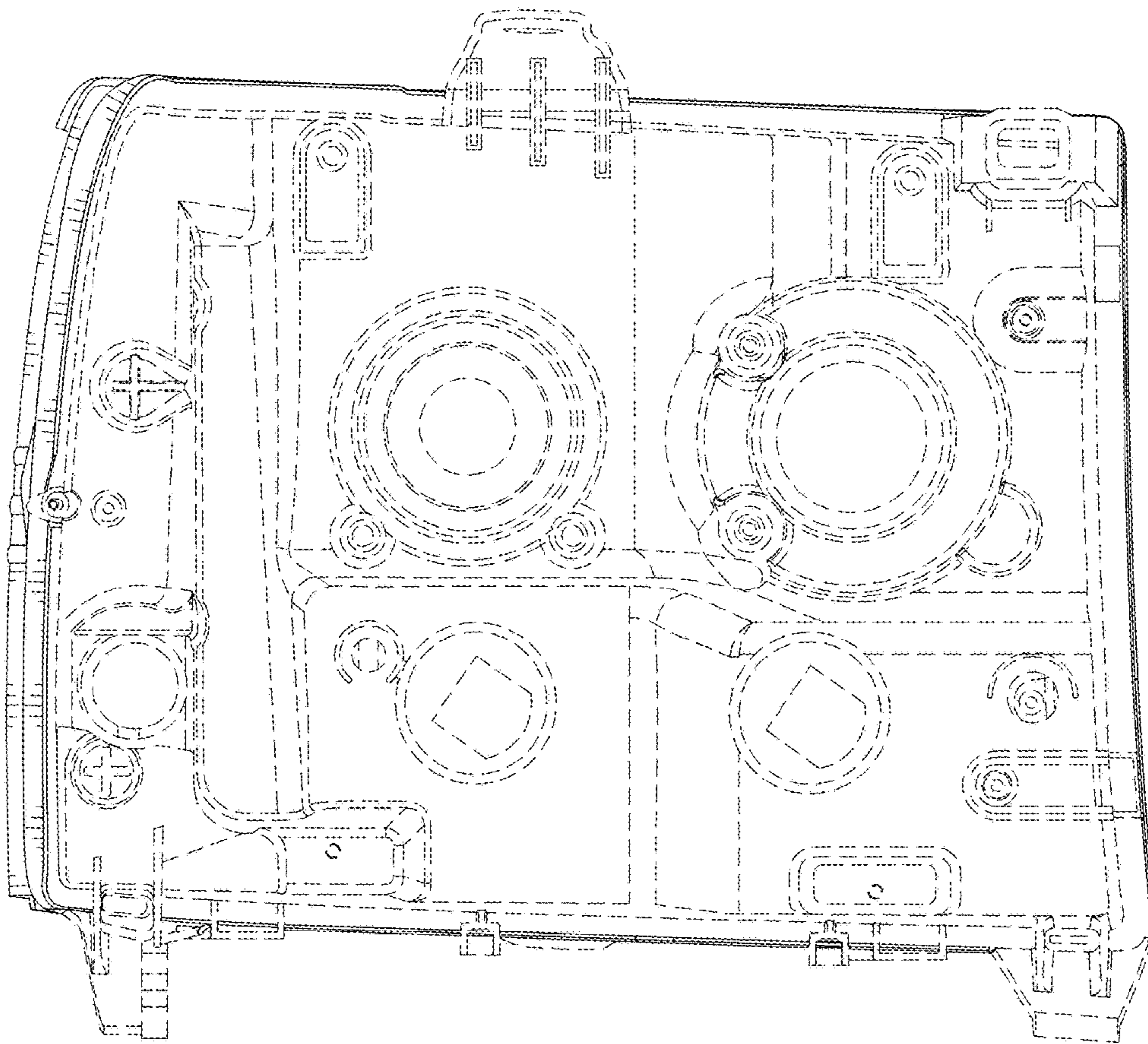

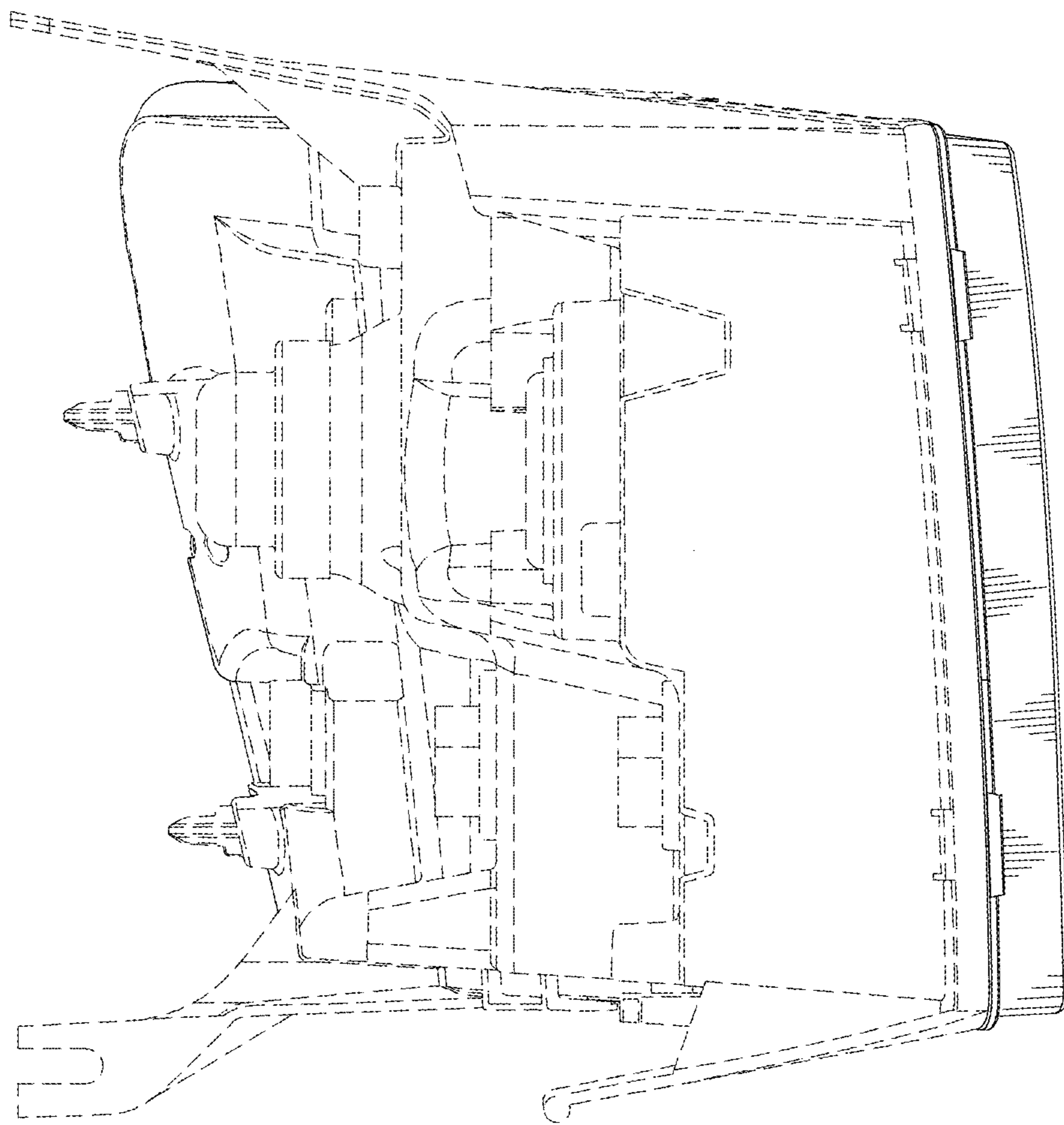

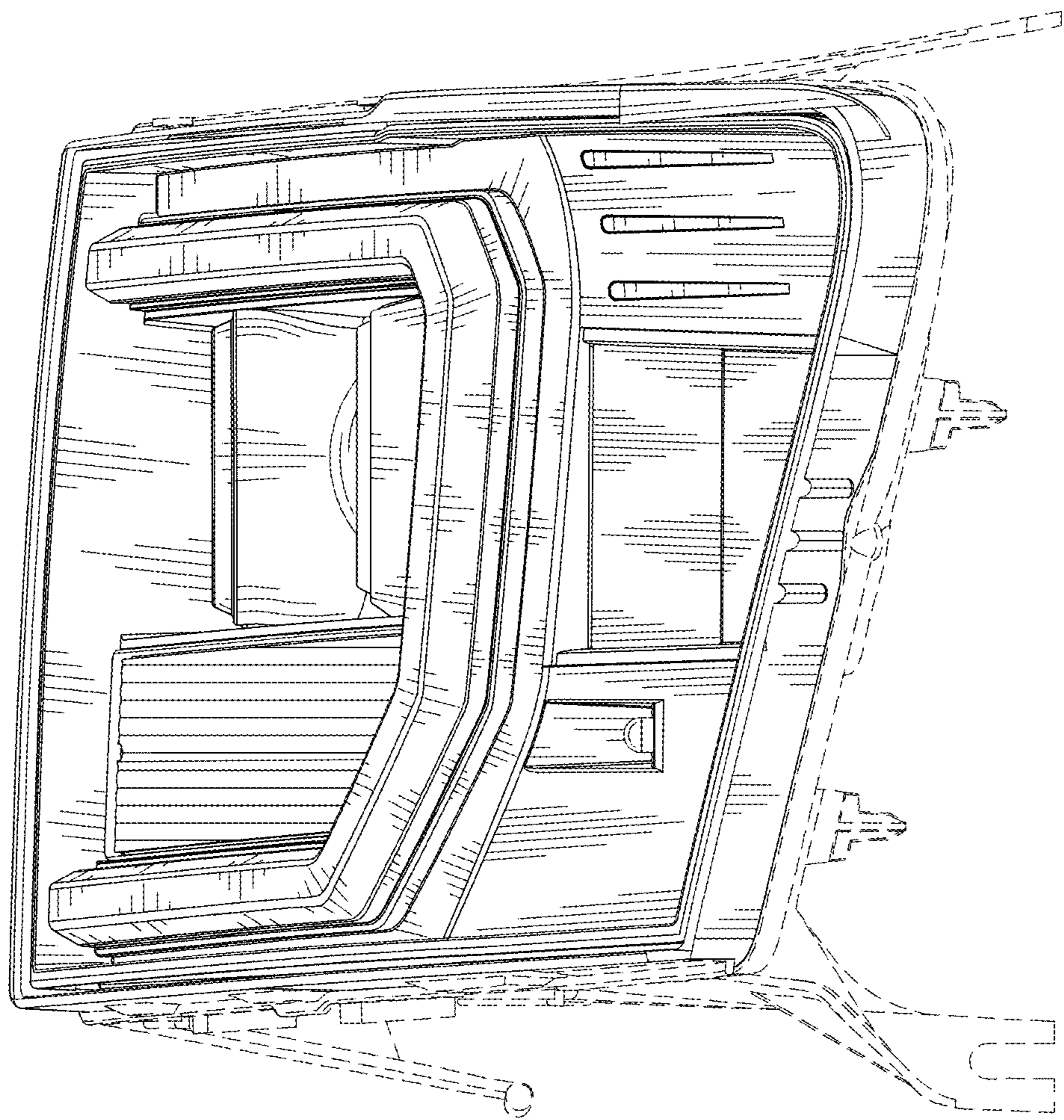

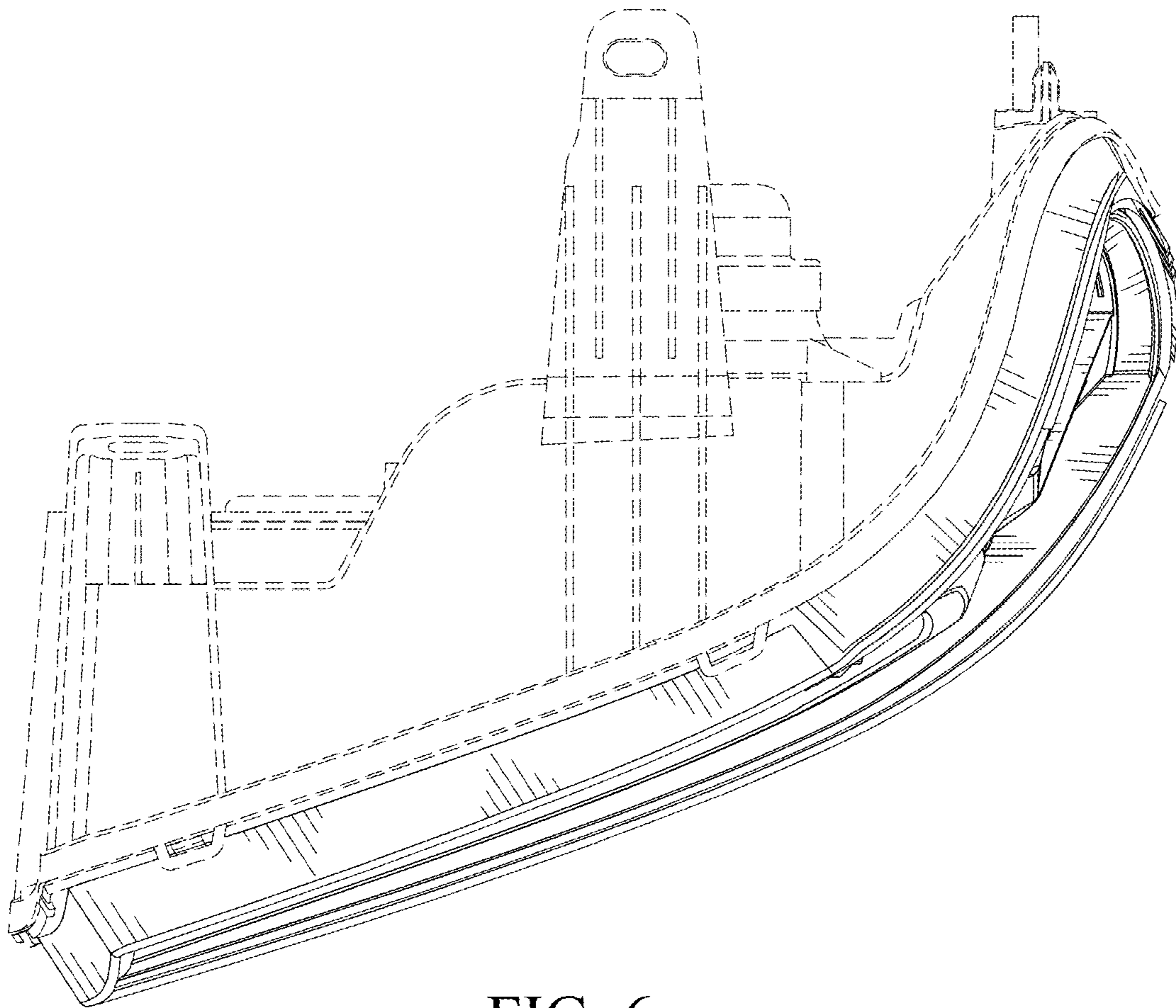

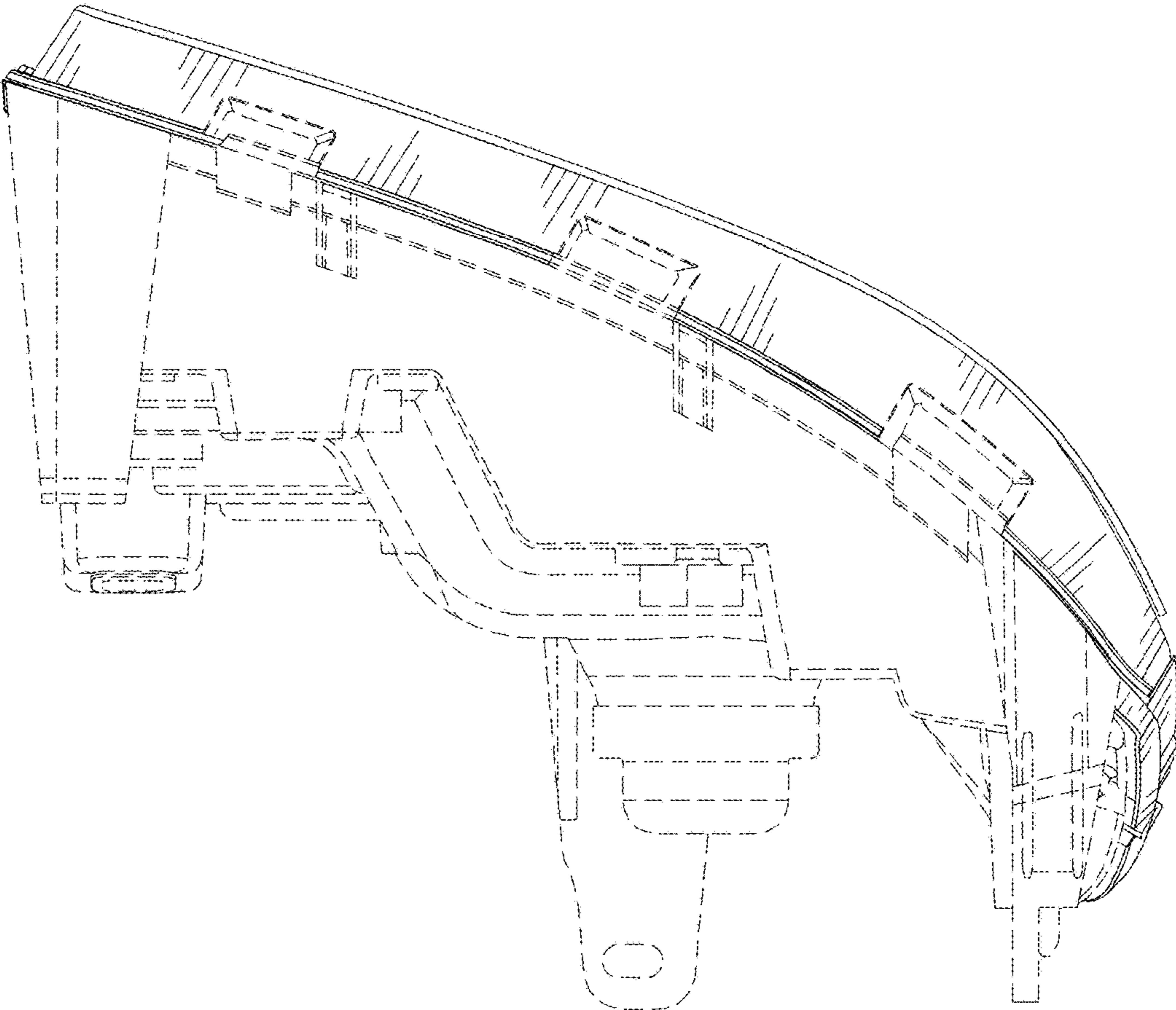

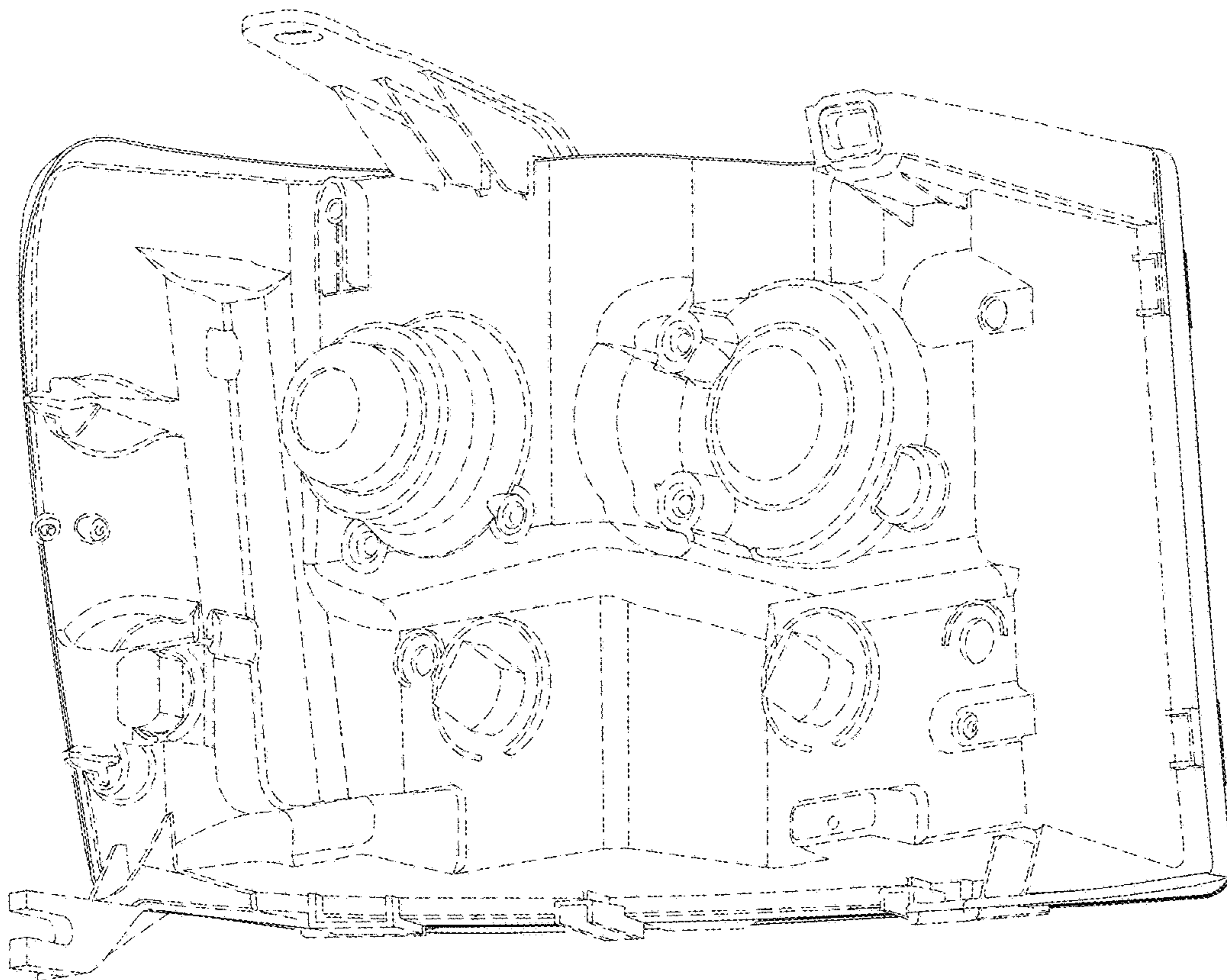
