(57) **CLAIM**

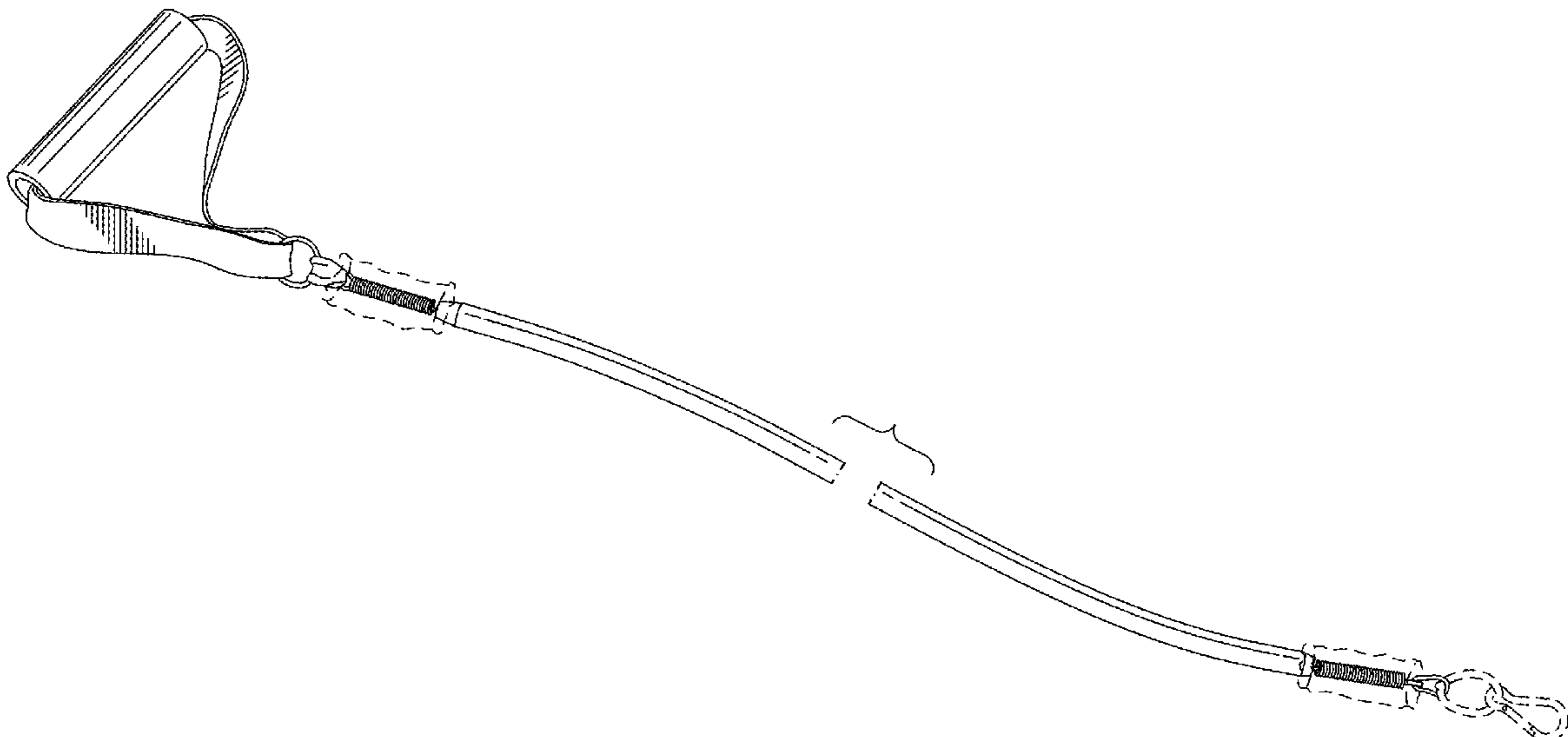
The ornamental design of a leash with dual springs, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an embodiment of a leash with dual springs, illustrating the novel design.

 FIG. 4 illustrates the top view thereof.
 FIG. 5 illustrates the bottom view thereof.
 FIG. 6 illustrates the front view thereof; and,

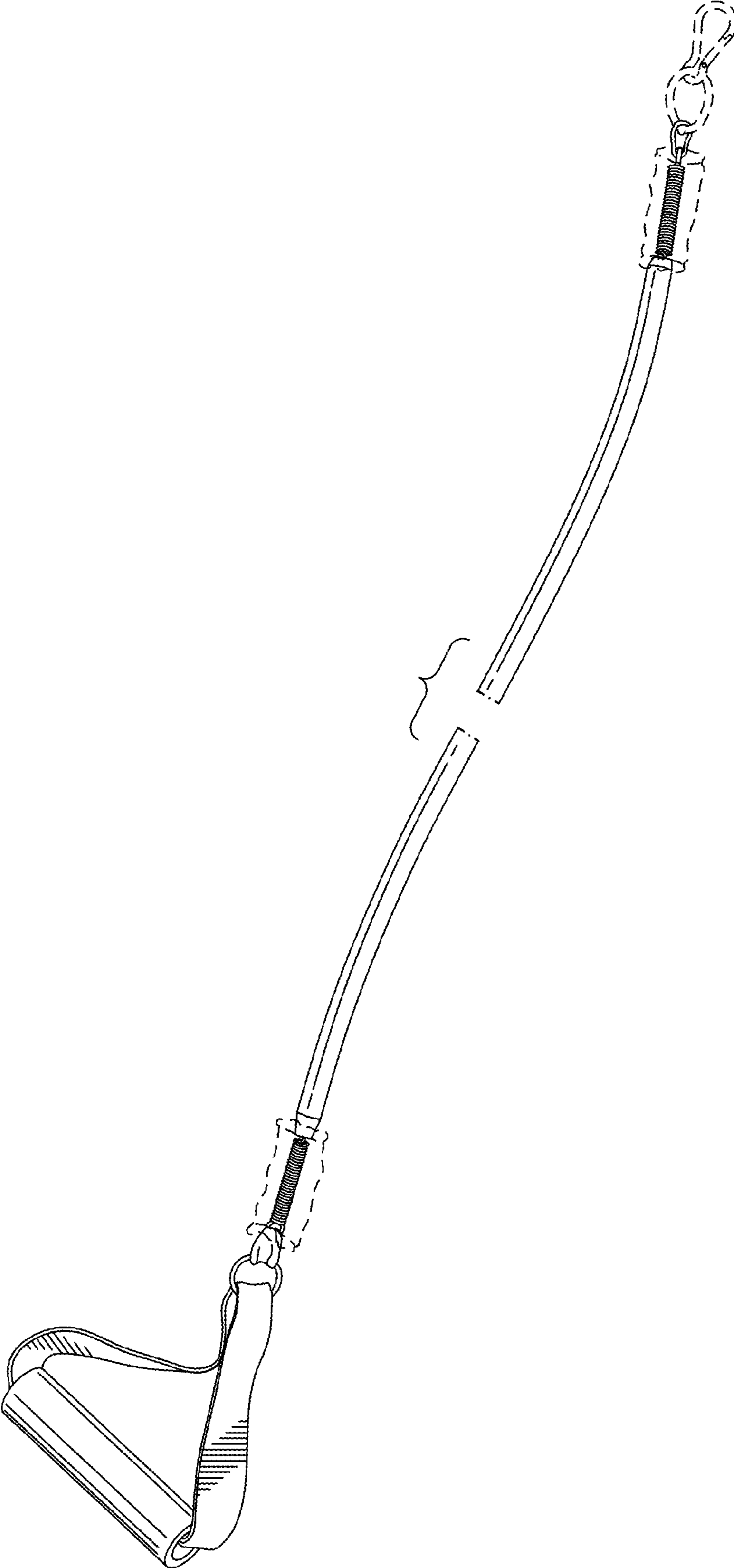

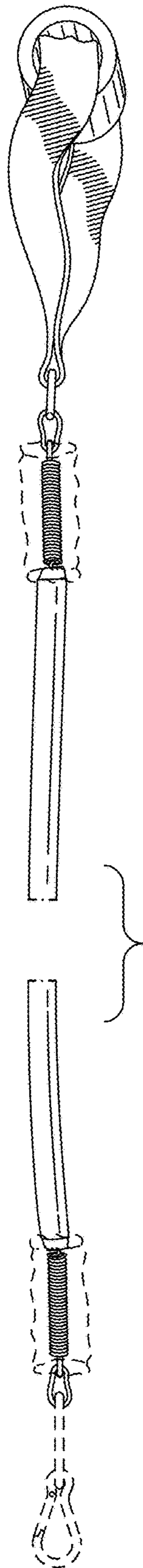

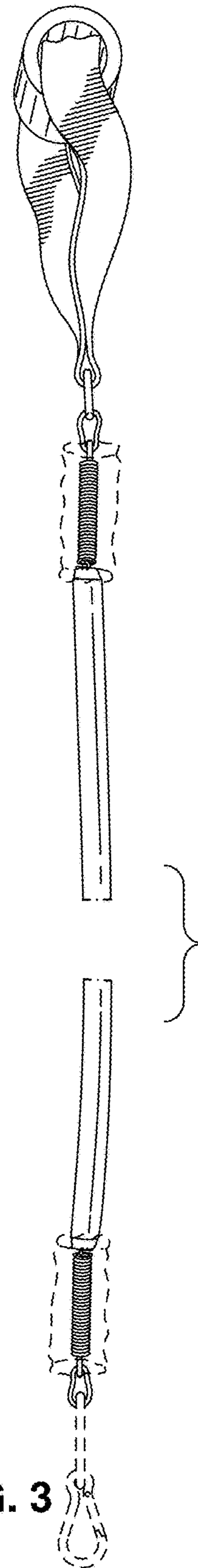

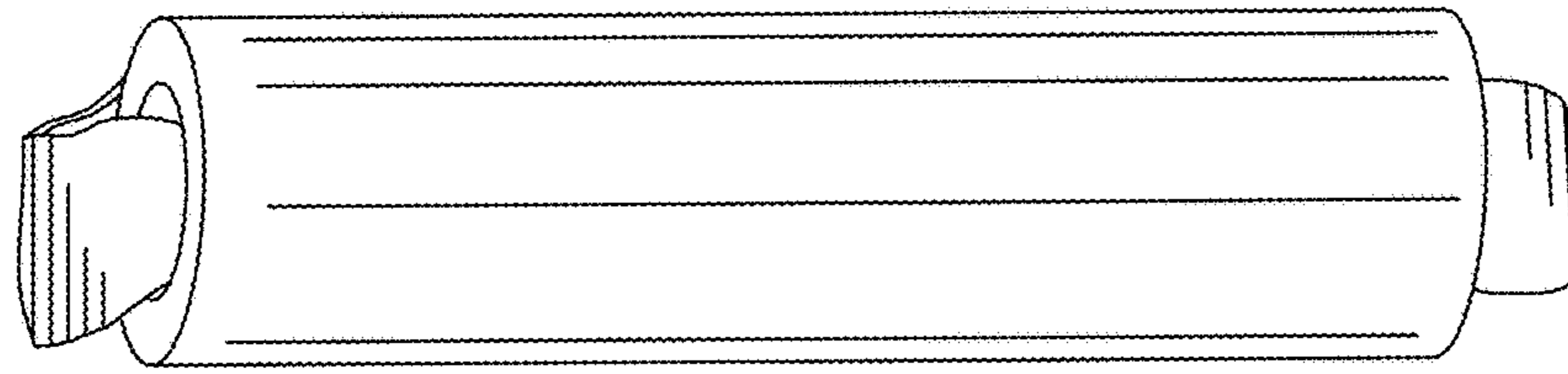

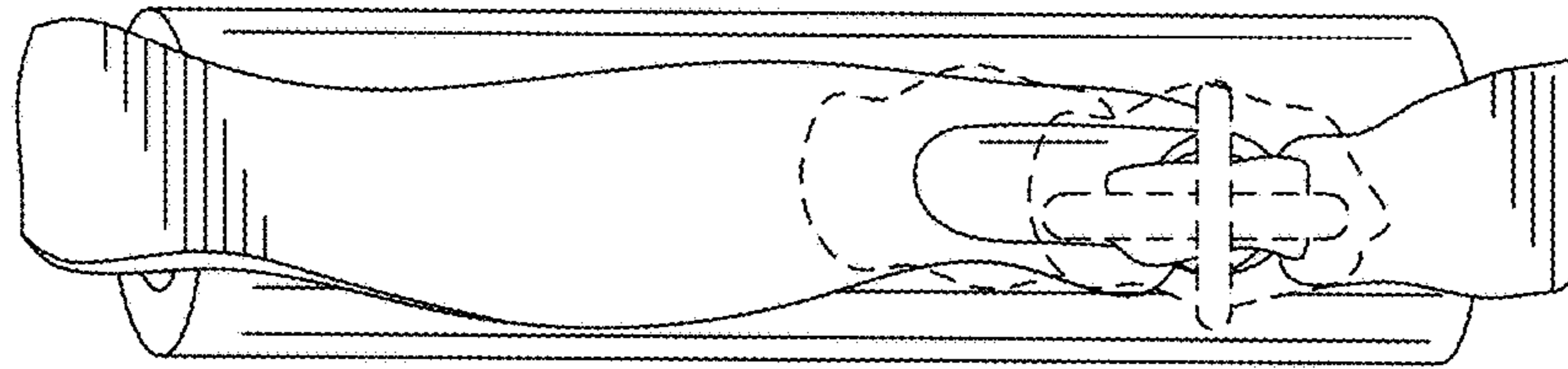
