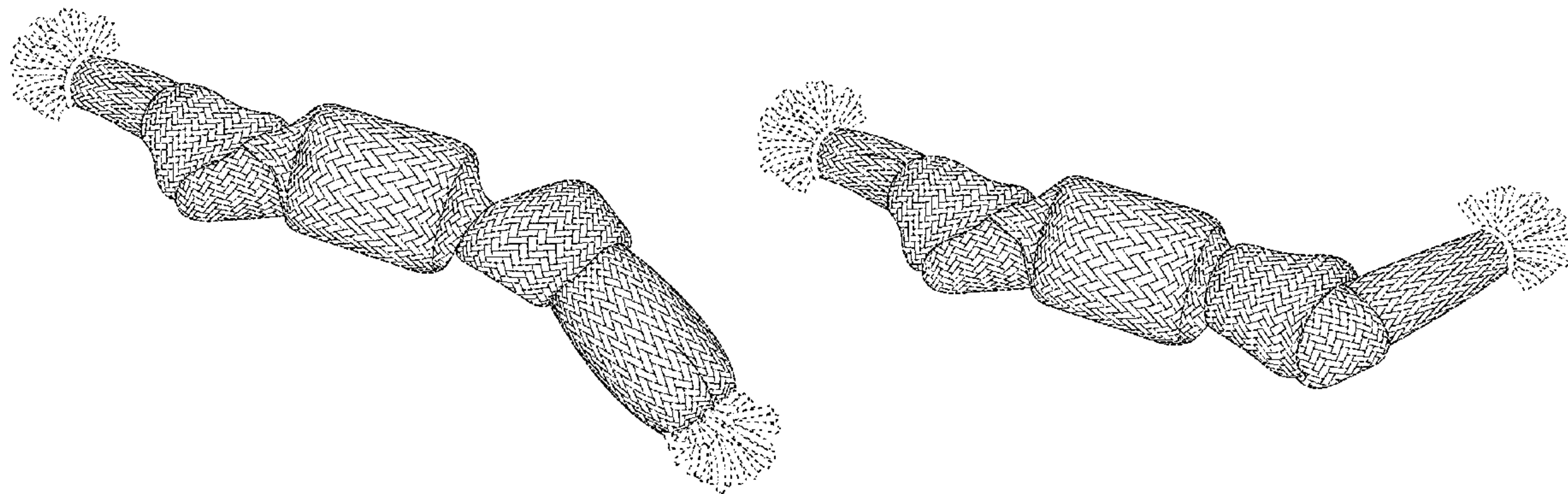
(57) **CLAIM**

The ornamental design for a rope pet toy with cylinder  
inside, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a rope pet toy with cylinder  
inside embodying my new design;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a left side elevation view thereof;  
FIG. 5 is a right side elevation view thereof;  
FIG. 6 is a top plan view thereof;  
FIG. 7 is a bottom plan view thereof;  
FIG. 8 is a perspective view of a second embodiment of a  
rope pet toy with cylinder inside similar to FIG. 1 now with  
one side knot rotated 180 degrees;  
FIG. 9 is a front elevation view of FIG. 8;  
FIG. 10 is a rear elevation view of FIG. 8;  
FIG. 11 is a left side elevation view of FIG. 8;  
FIG. 12 is a right side elevation view of FIG. 8;  
FIG. 13 is a top plan view of FIG. 8; and,  
FIG. 14 is a bottom plan view of FIG. 8.

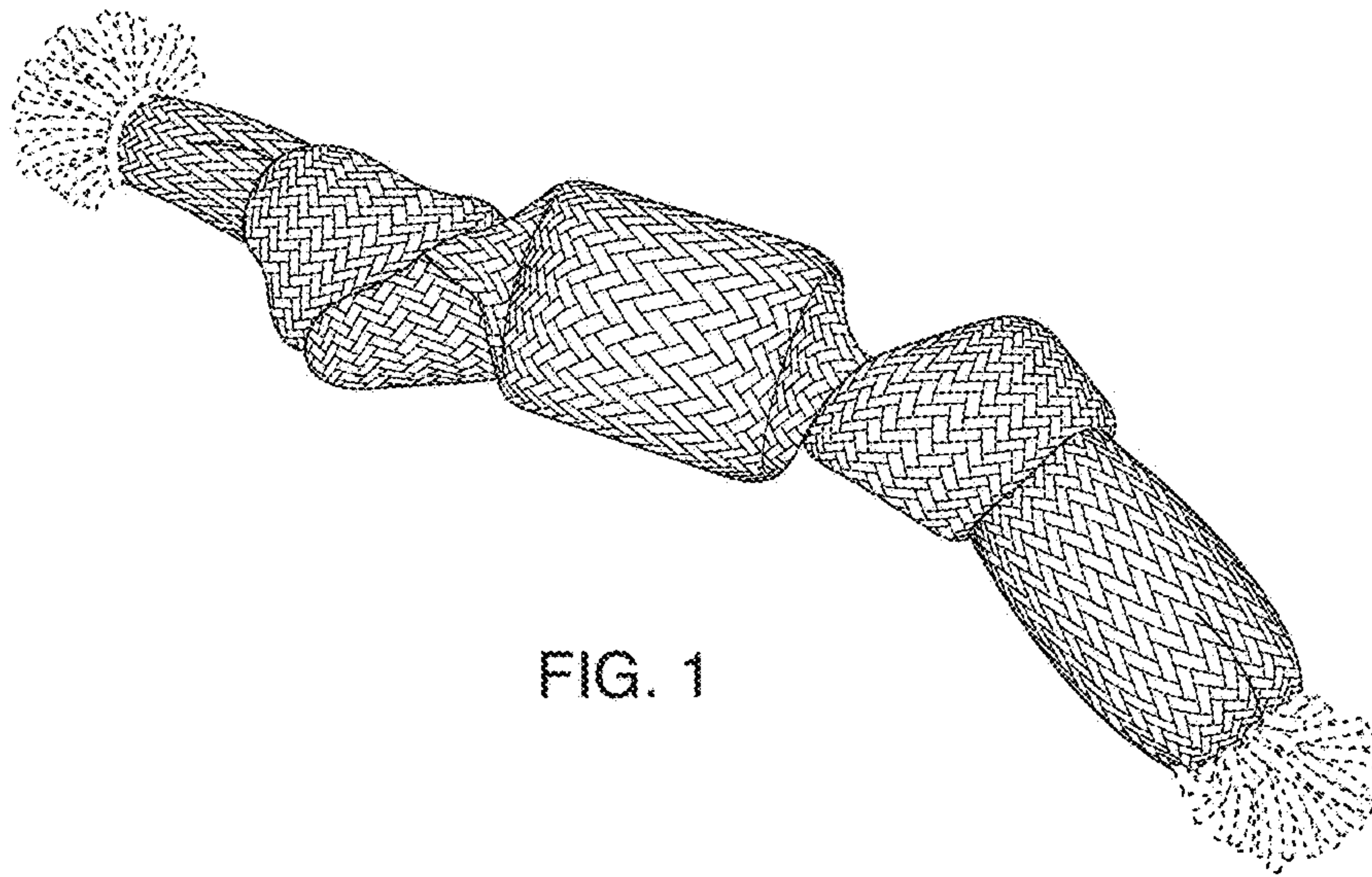

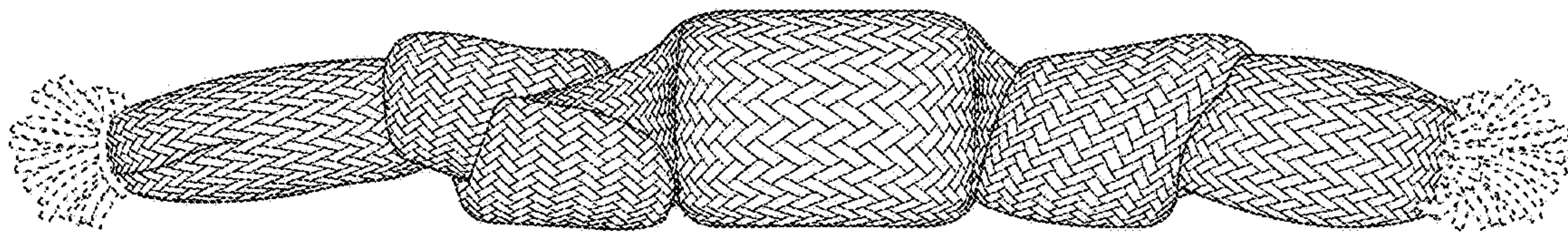

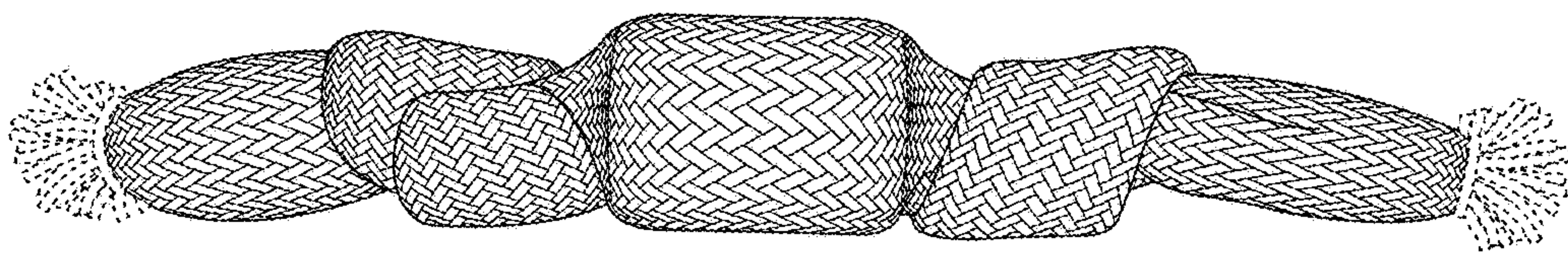

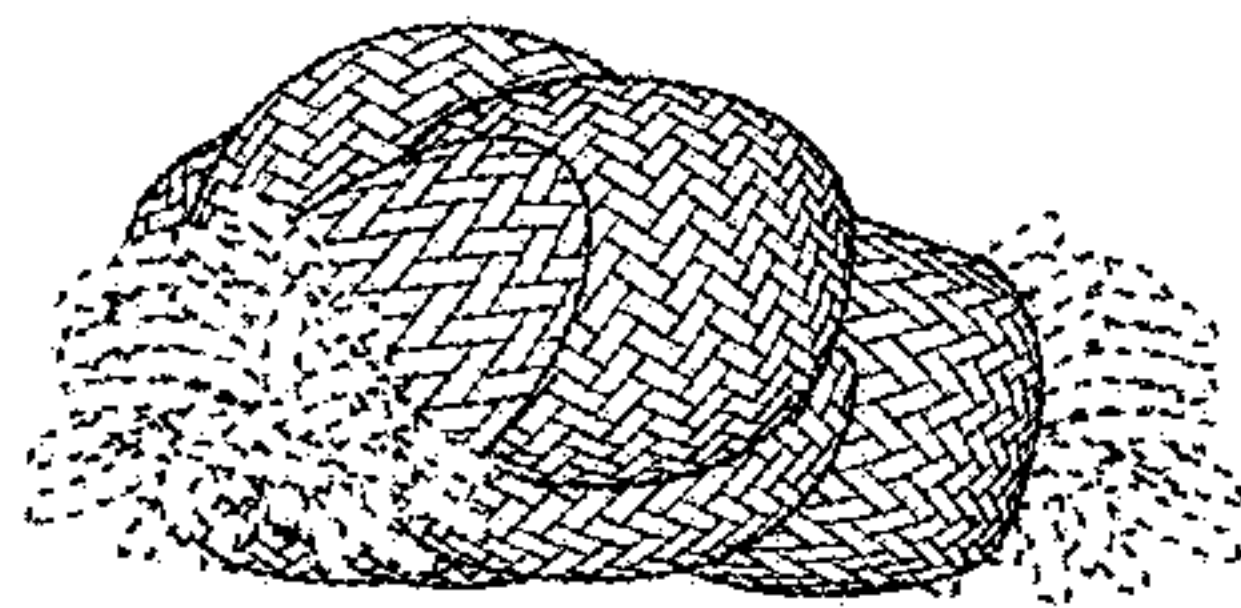

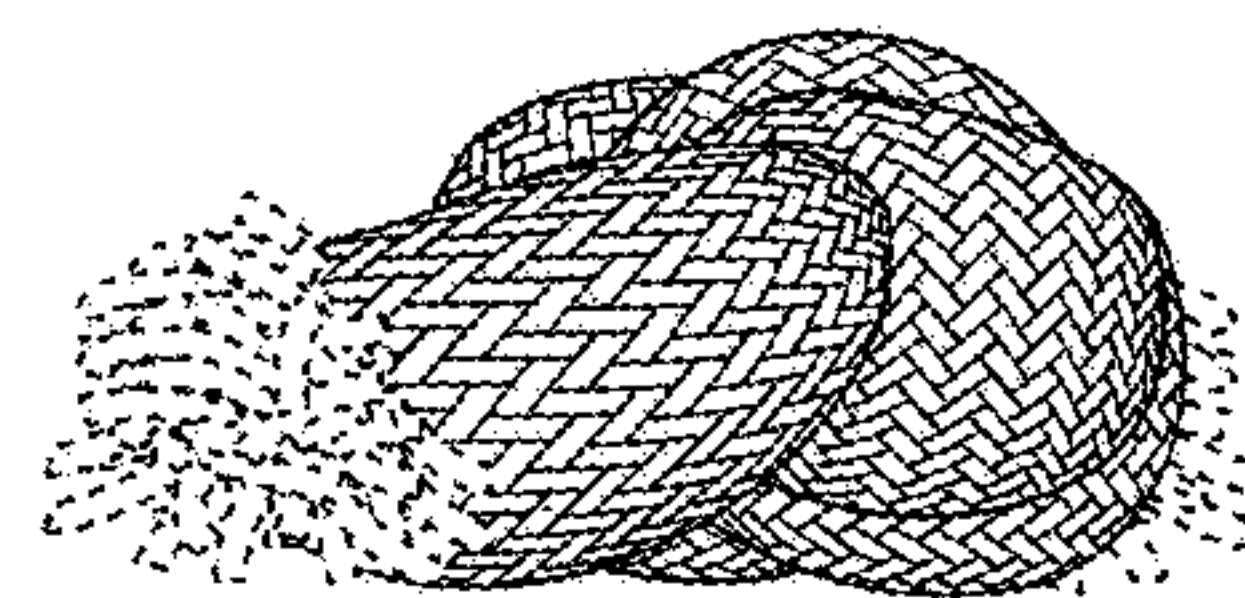

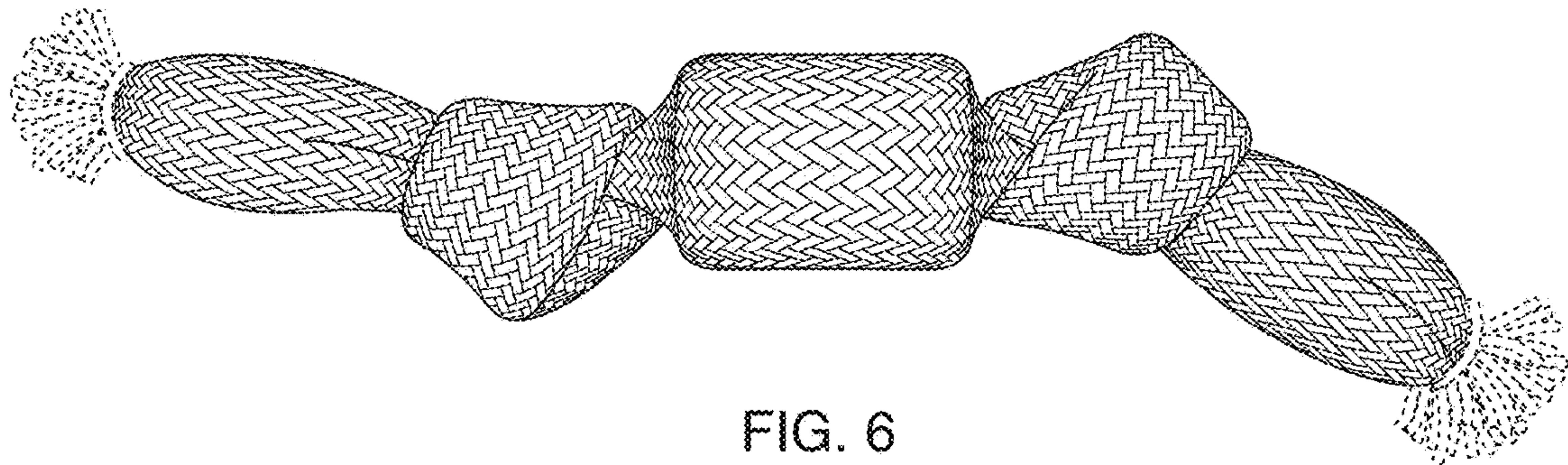

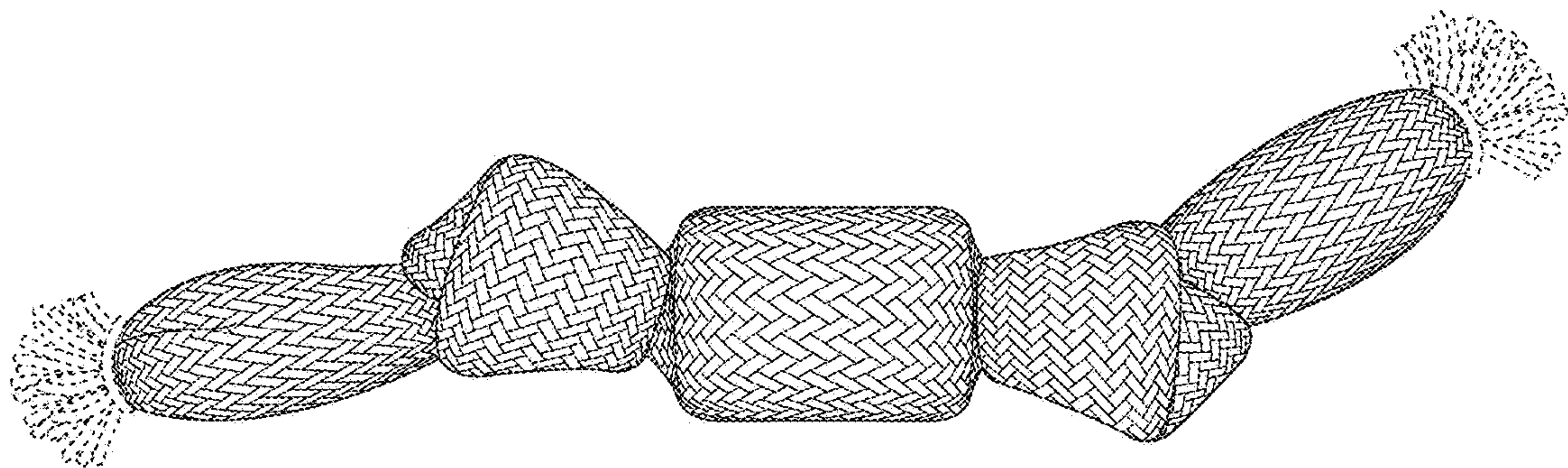

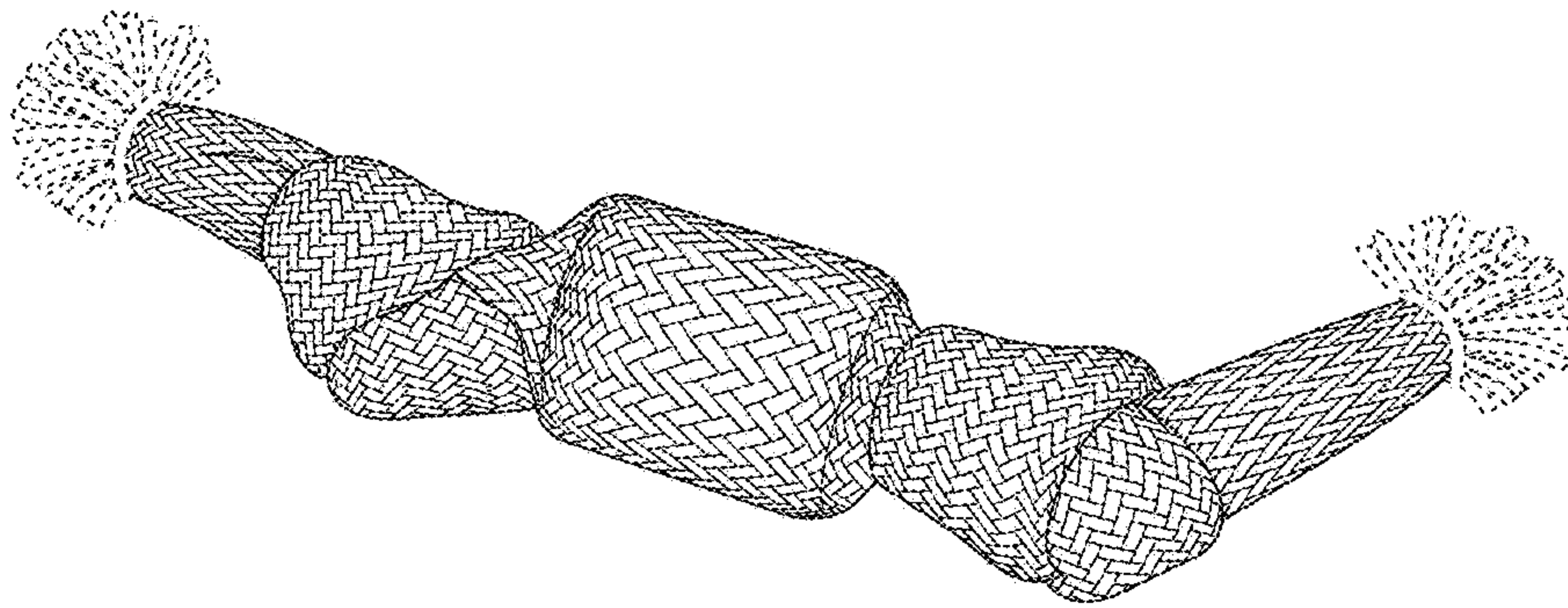

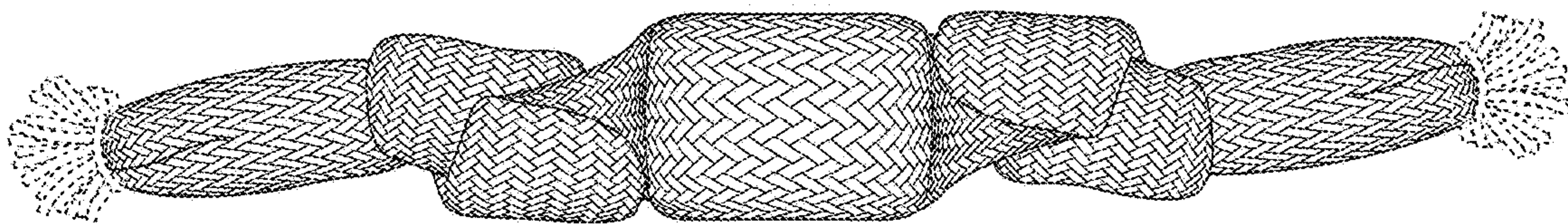

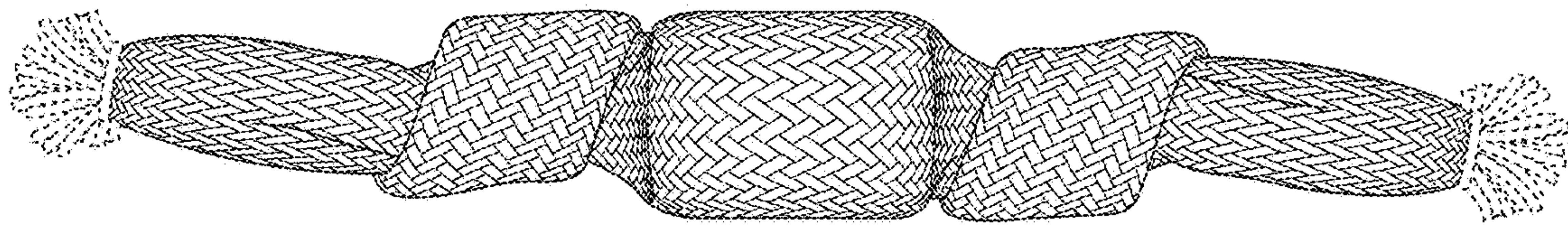

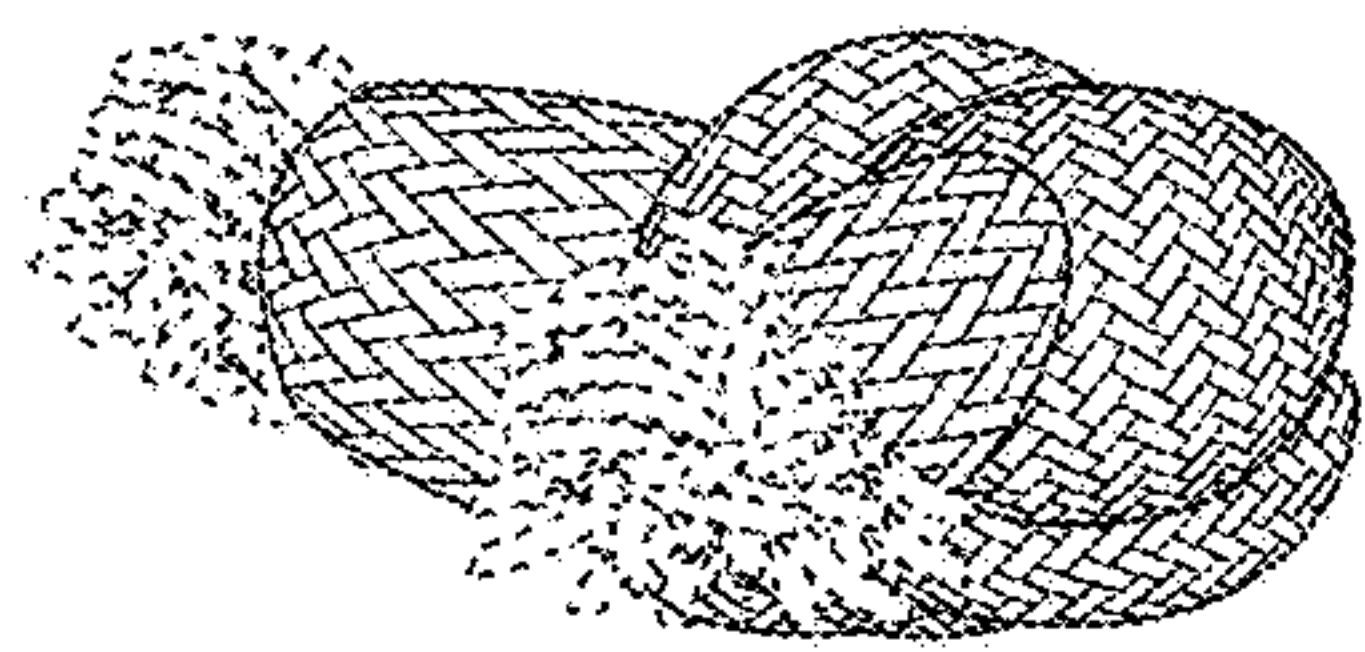

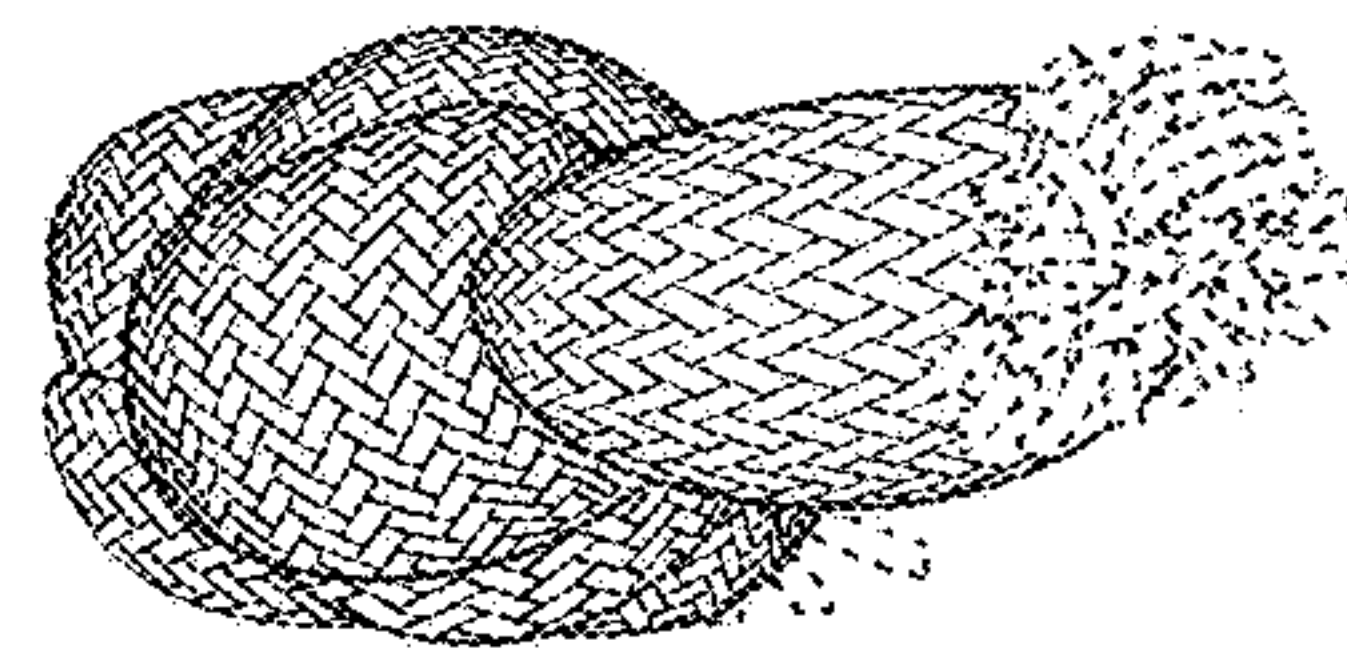

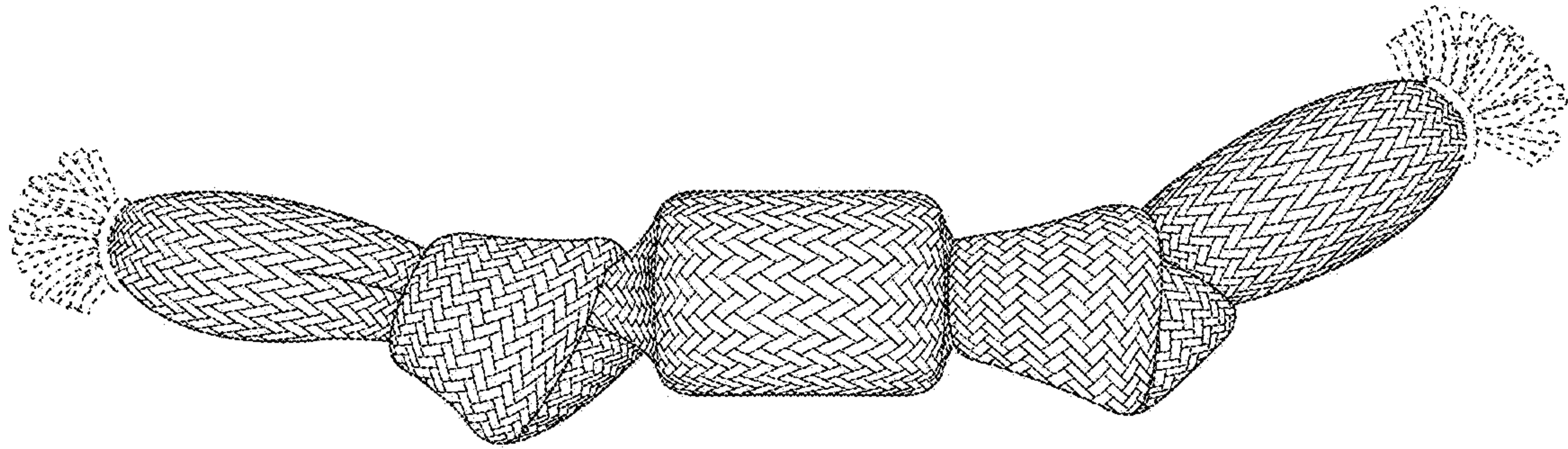

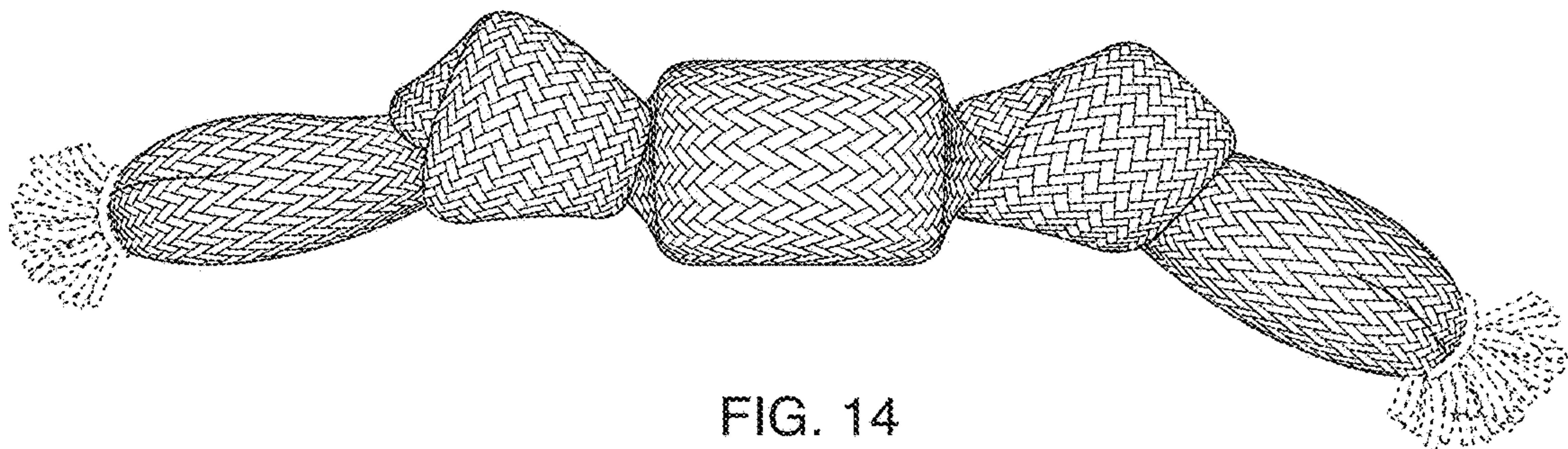
