FIG. 3 is a rear view;

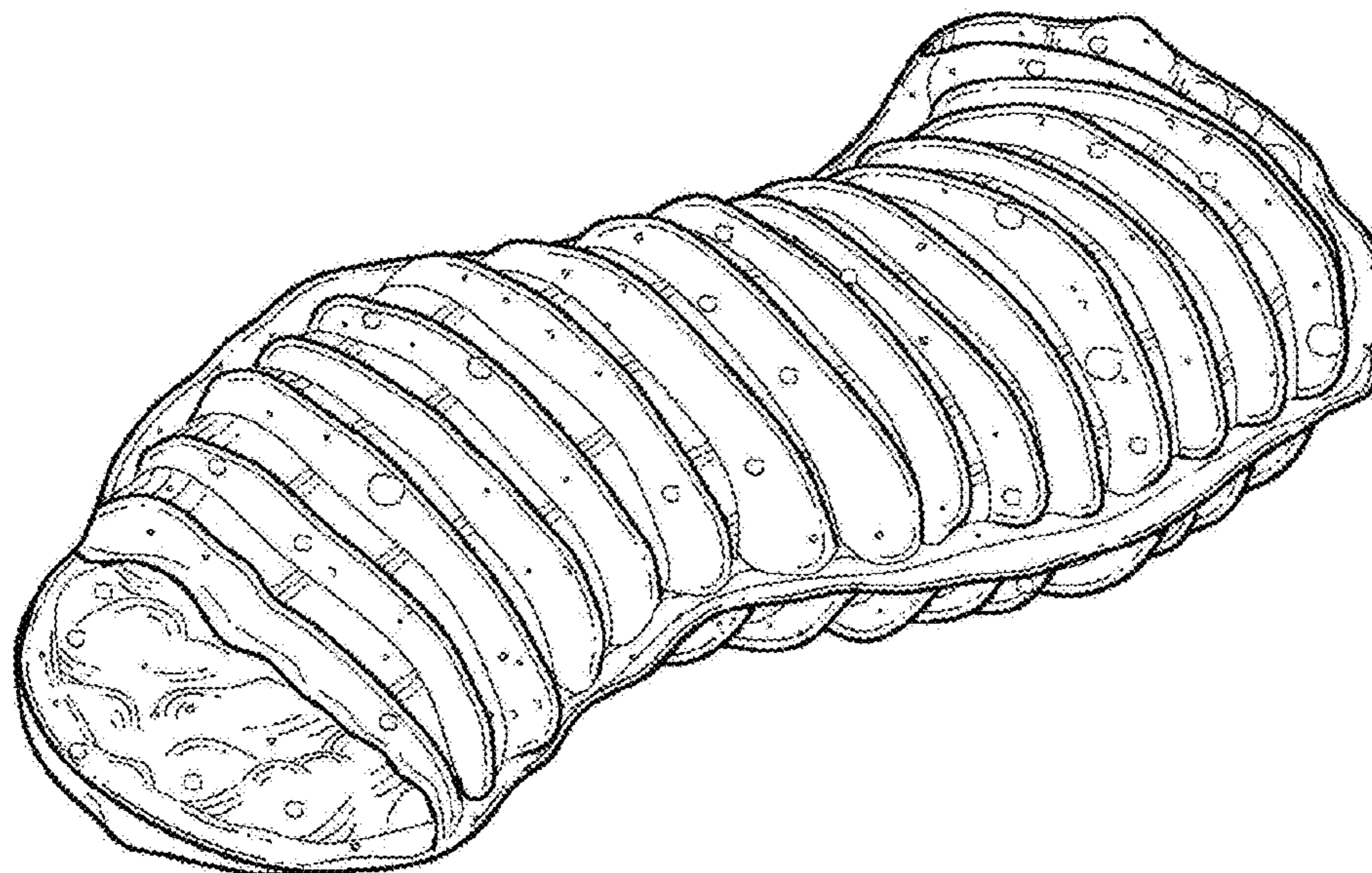
FIG. 4 is a left side view;

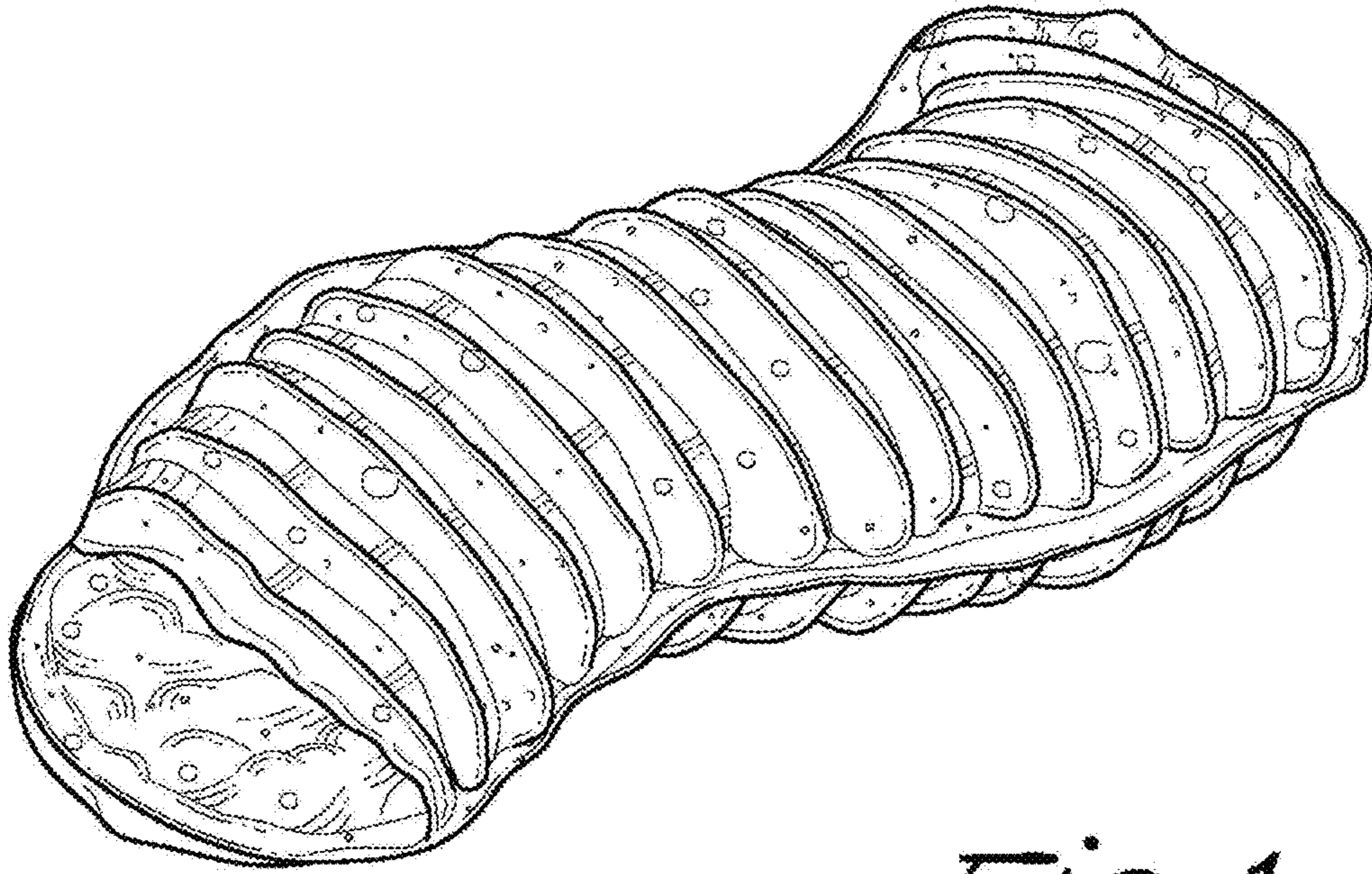

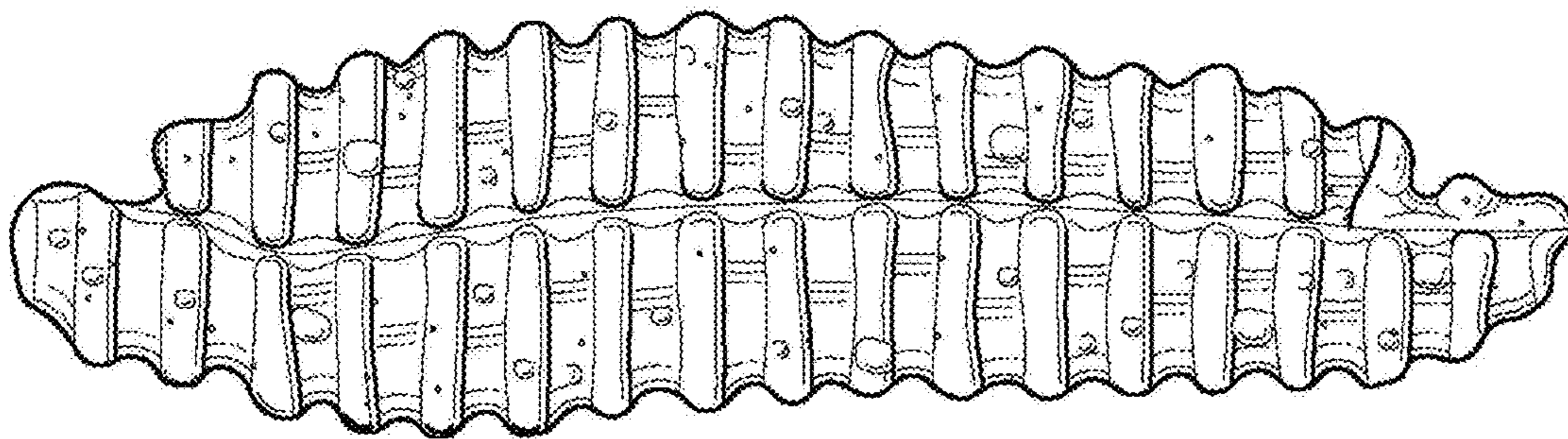

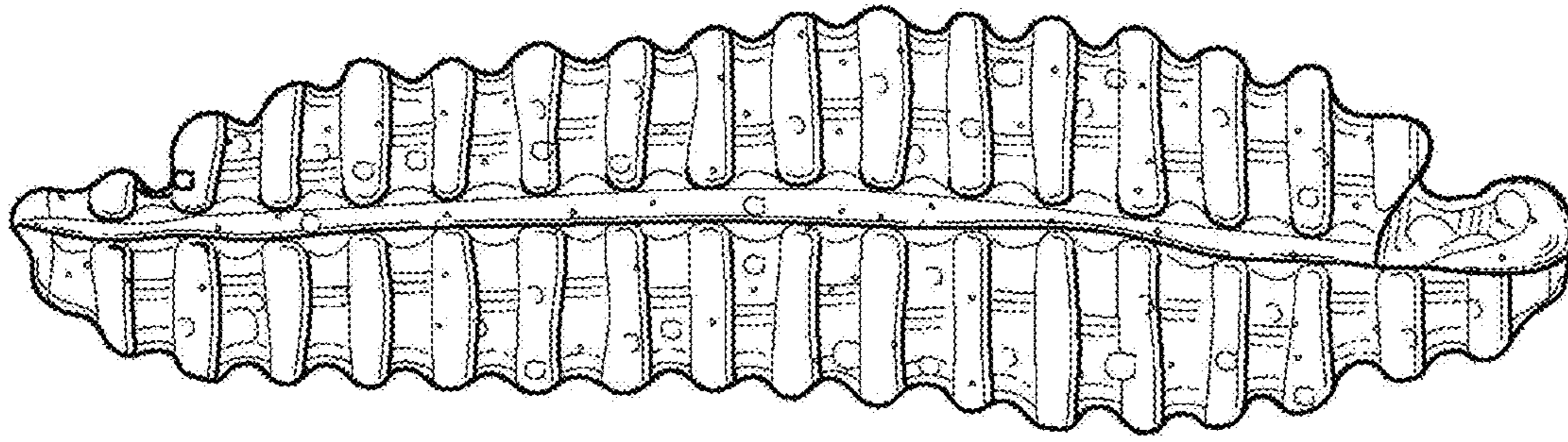

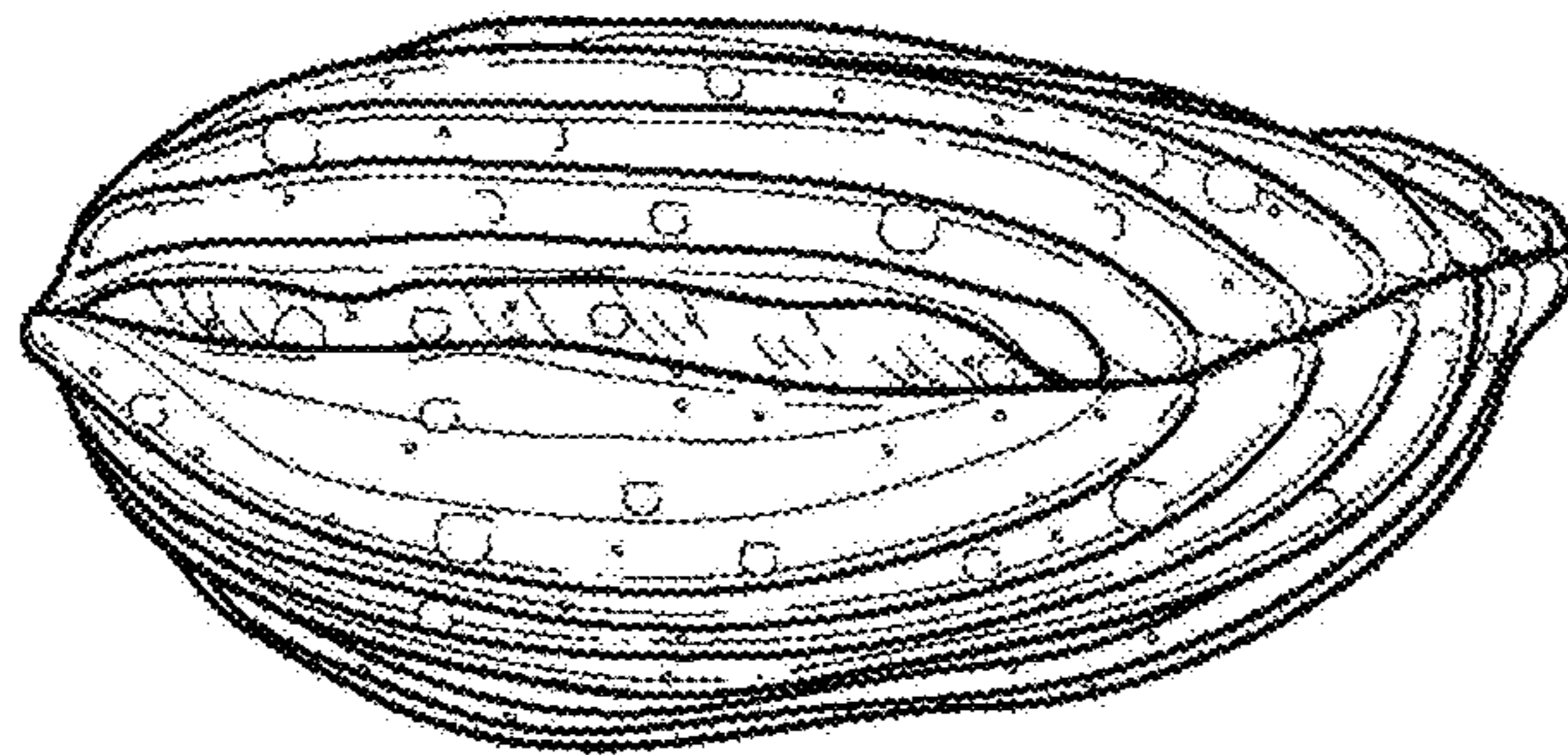

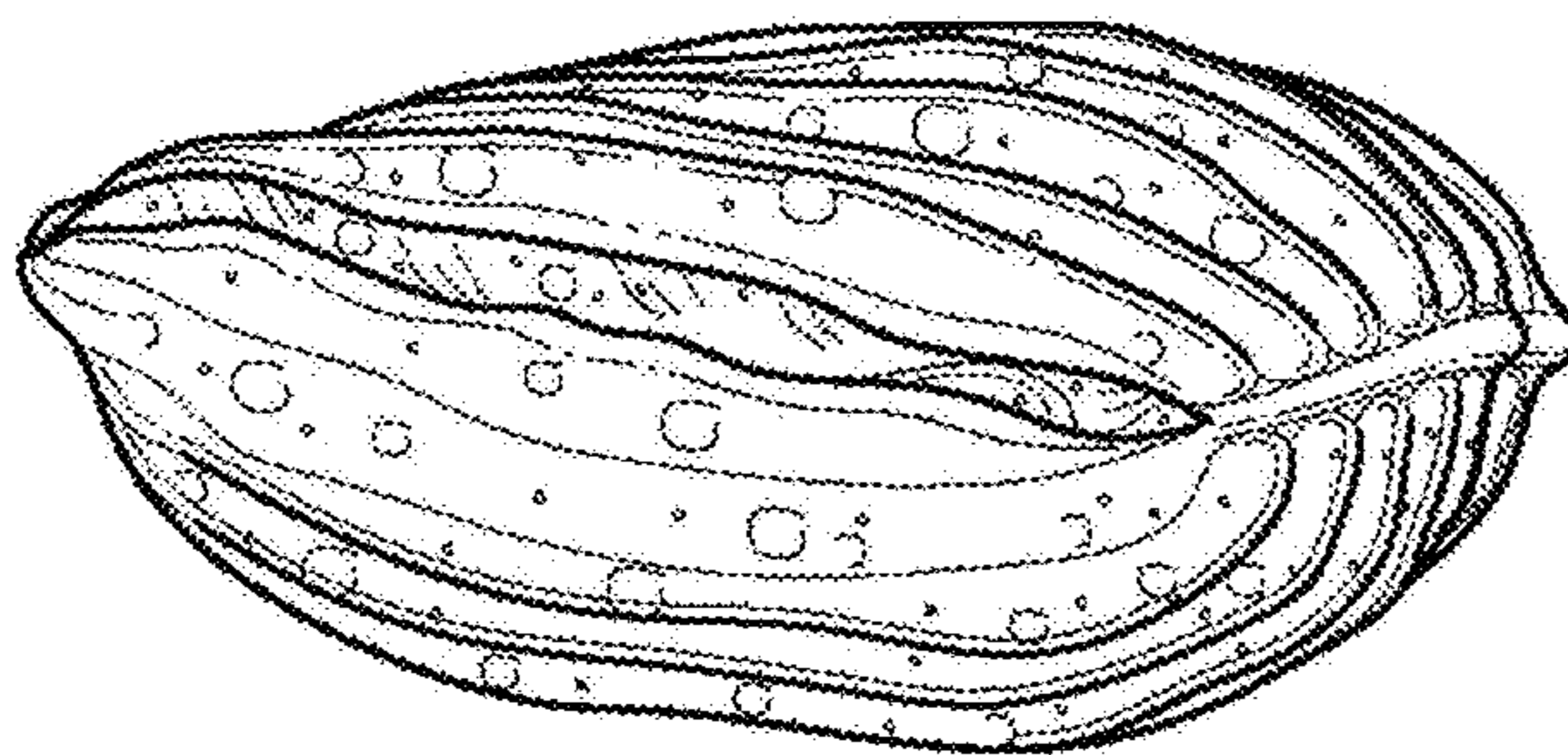

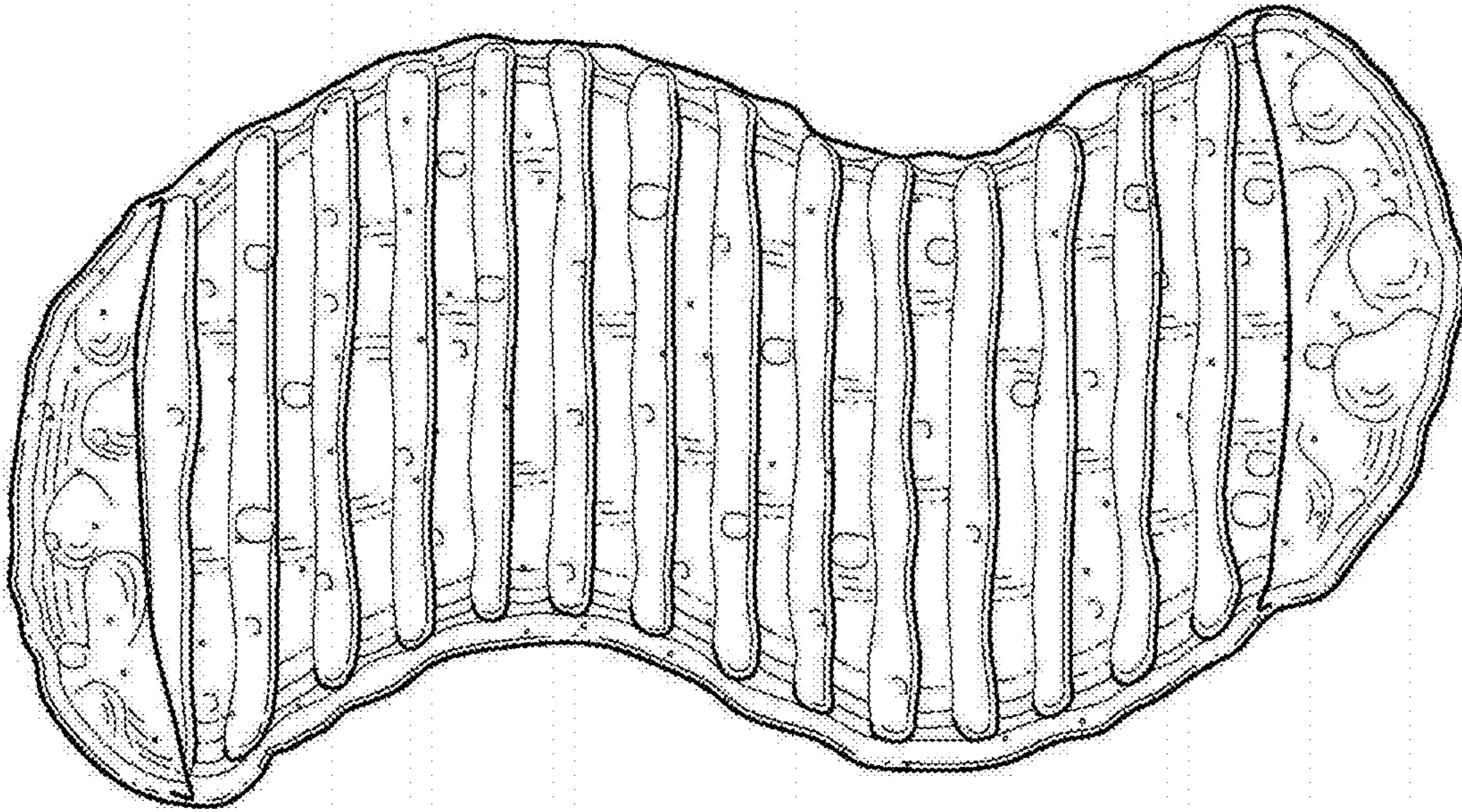

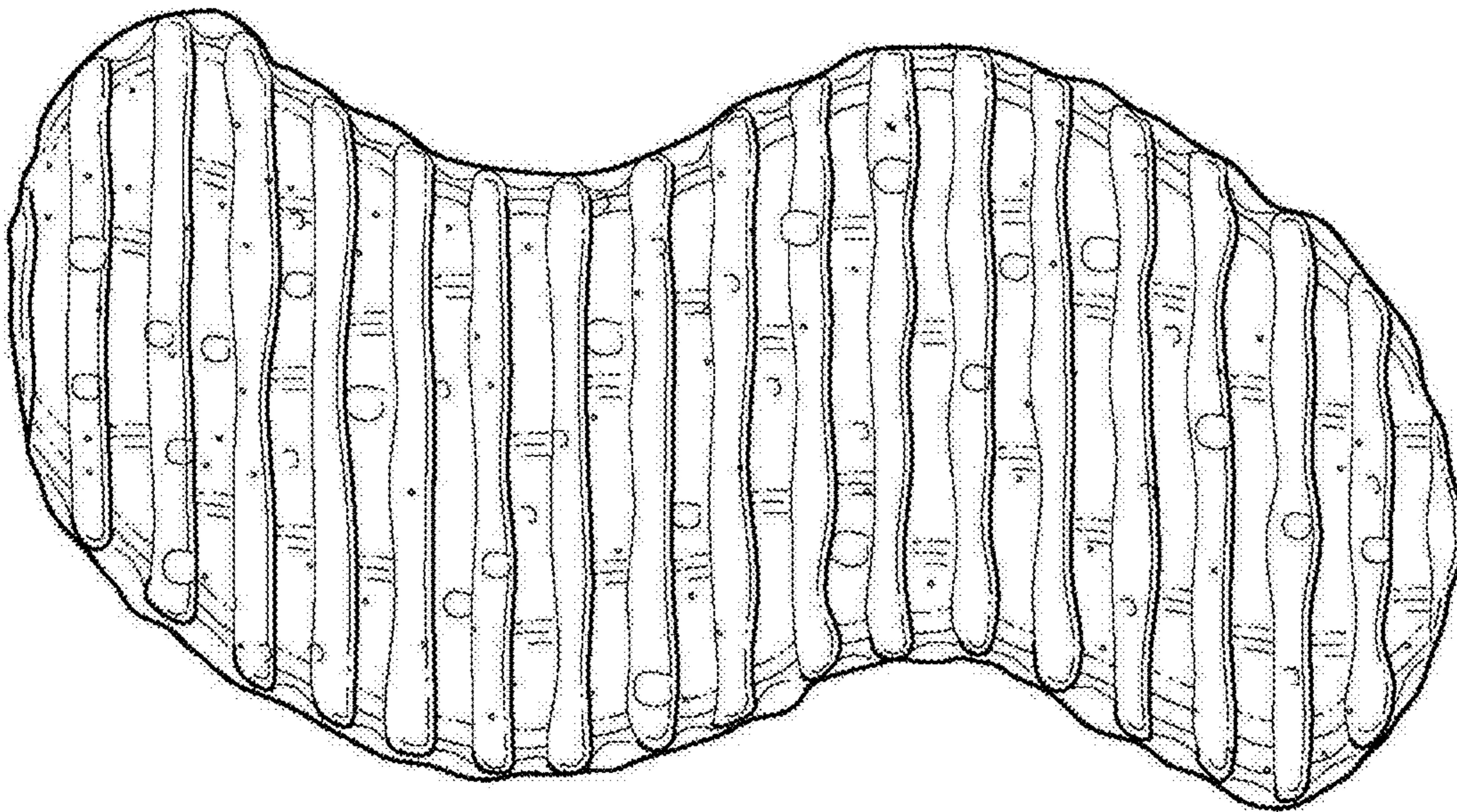
