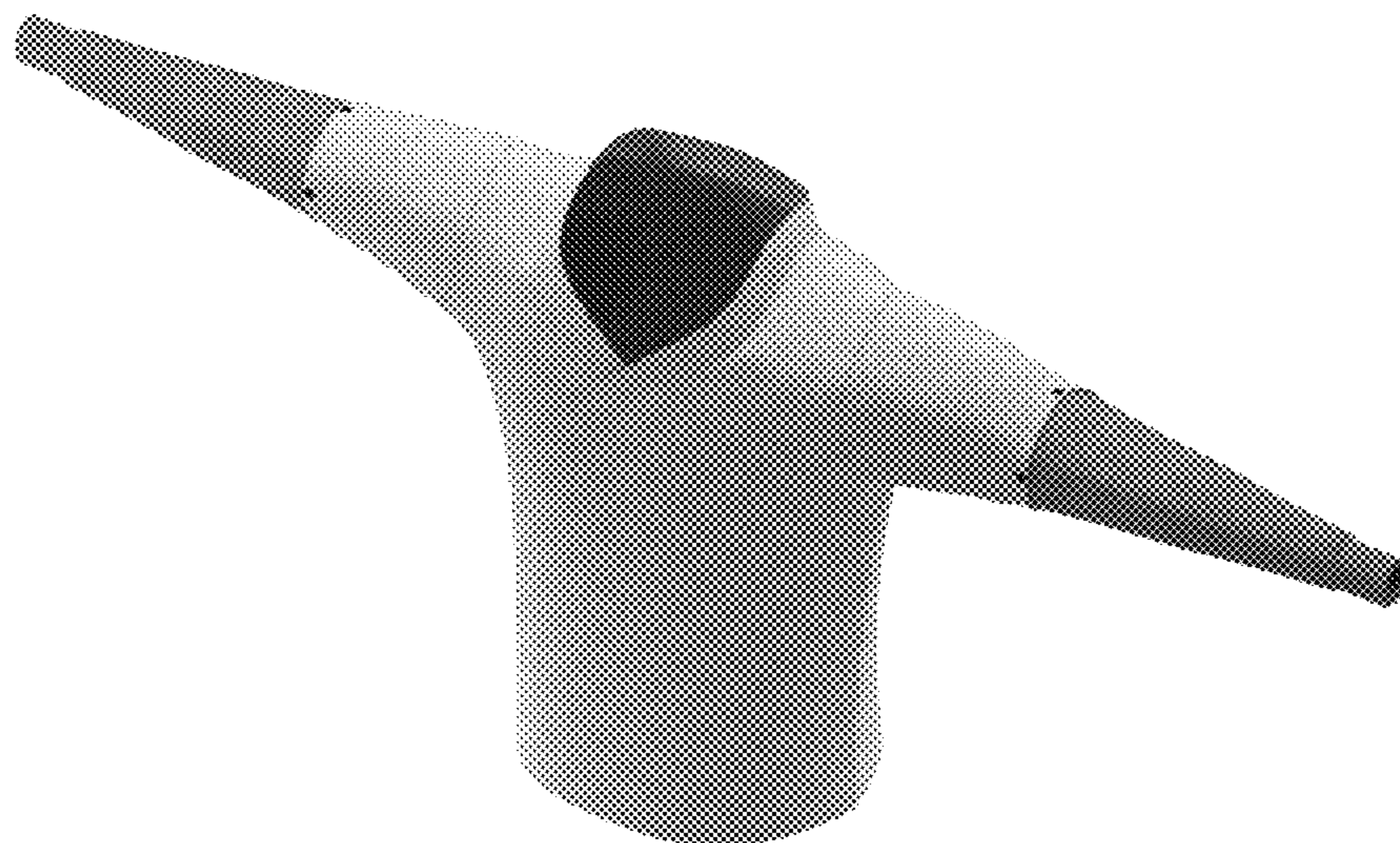
(57) **CLAIM**

The ornamental design for scrubs with removable sleeves, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of scrubs with removable sleeves, wherein a pair of sleeves is attached to a t-shirt body;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof; and
FIG. 8 is a detail view thereof, showing the pair of sleeves being attached to the t-shirt body by a plurality of snaps.
FIG. 9 is a perspective view of scrubs with removable sleeves, wherein the pair of sleeves is detached from the t-shirt body;
FIG. 10 is a front elevational view thereof;
FIG. 11 is a rear elevational view thereof;
FIG. 12 is a left side elevational view thereof;
FIG. 13 is a right side elevational view thereof;
FIG. 14 is a top plan view thereof;
FIG. 15 is a bottom plan view thereof; and,
FIG. 16 is a detail view thereof, showing the pair of sleeves being detached from the t-shirt body.

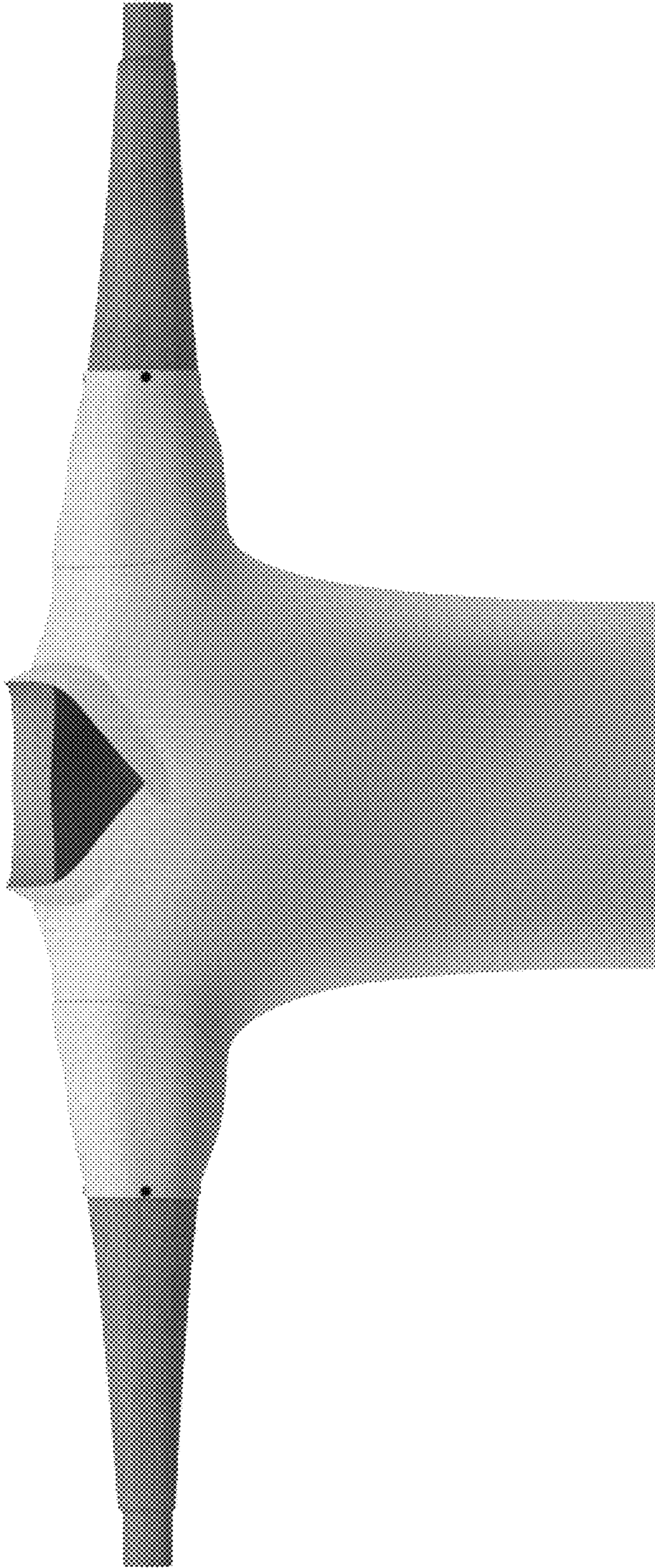

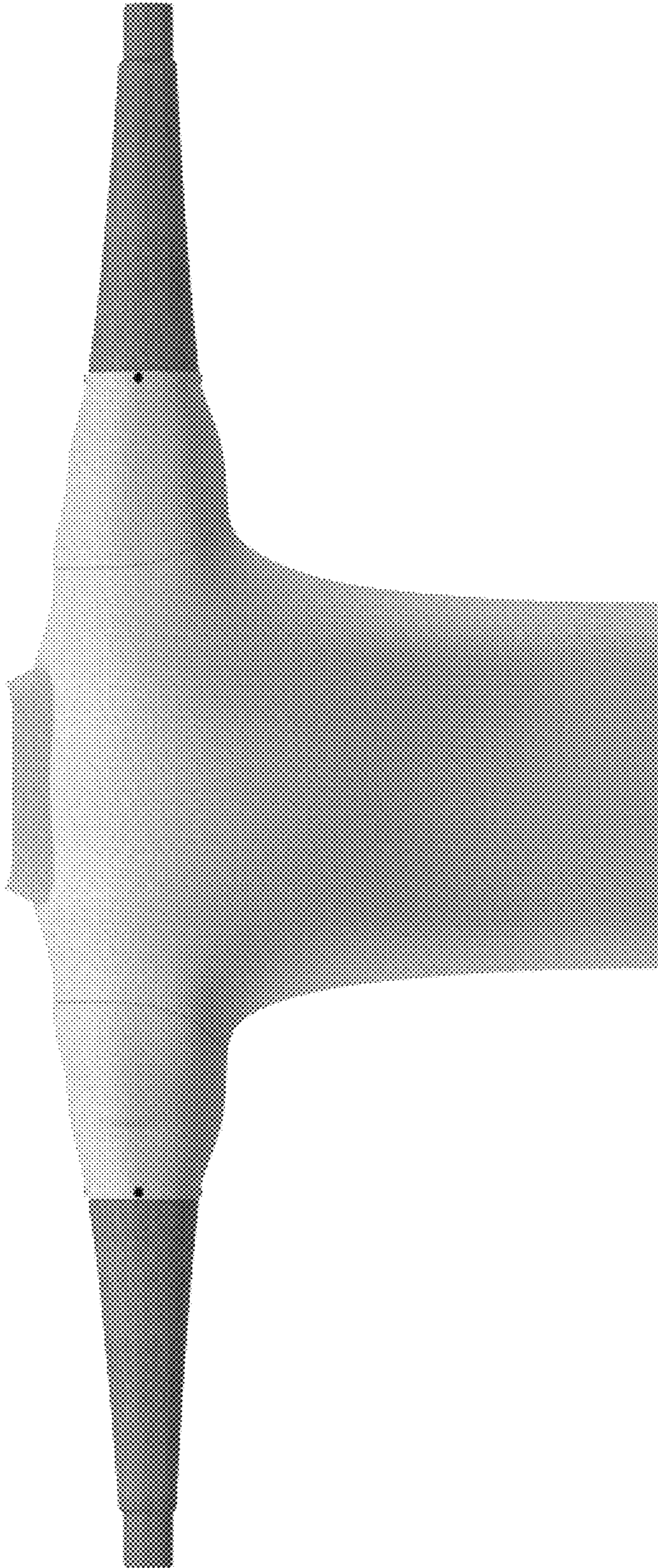

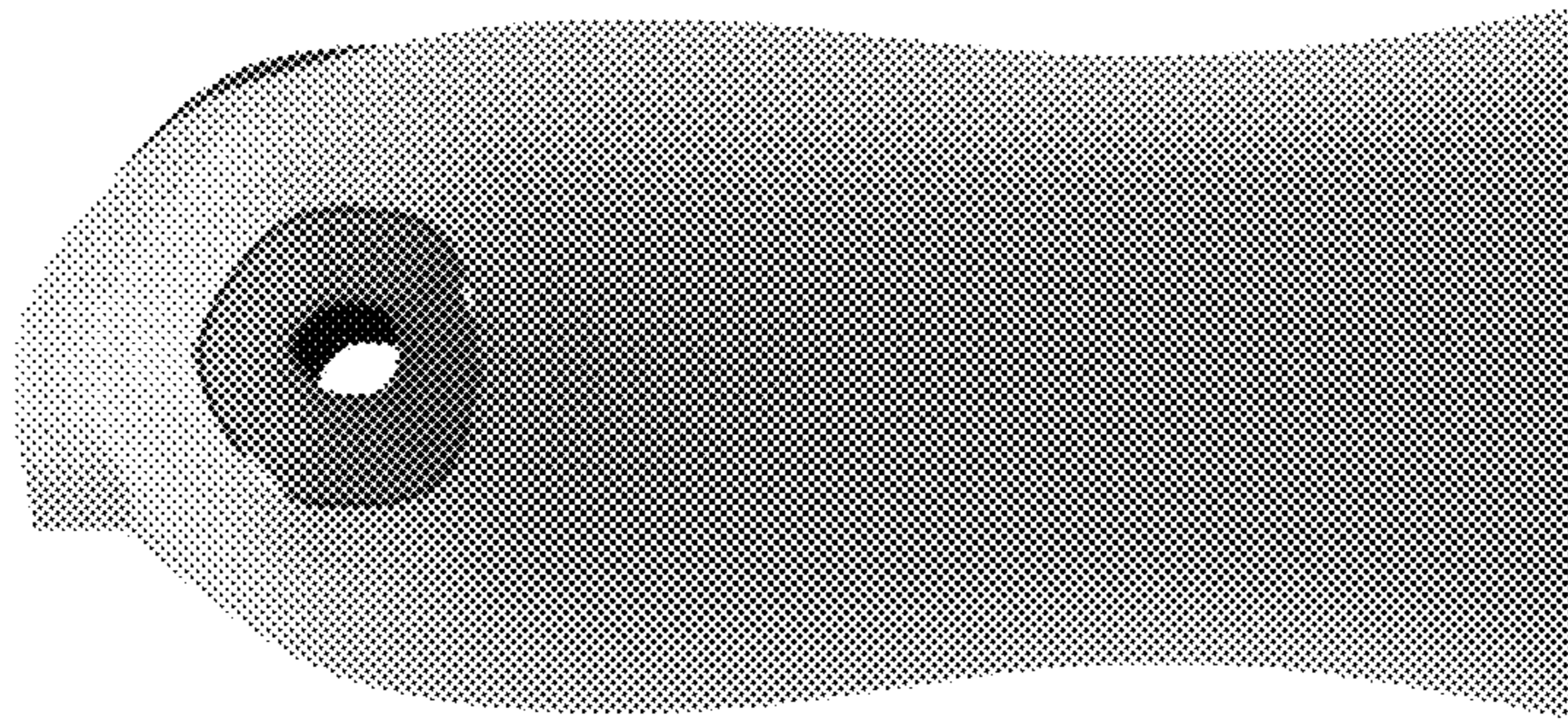

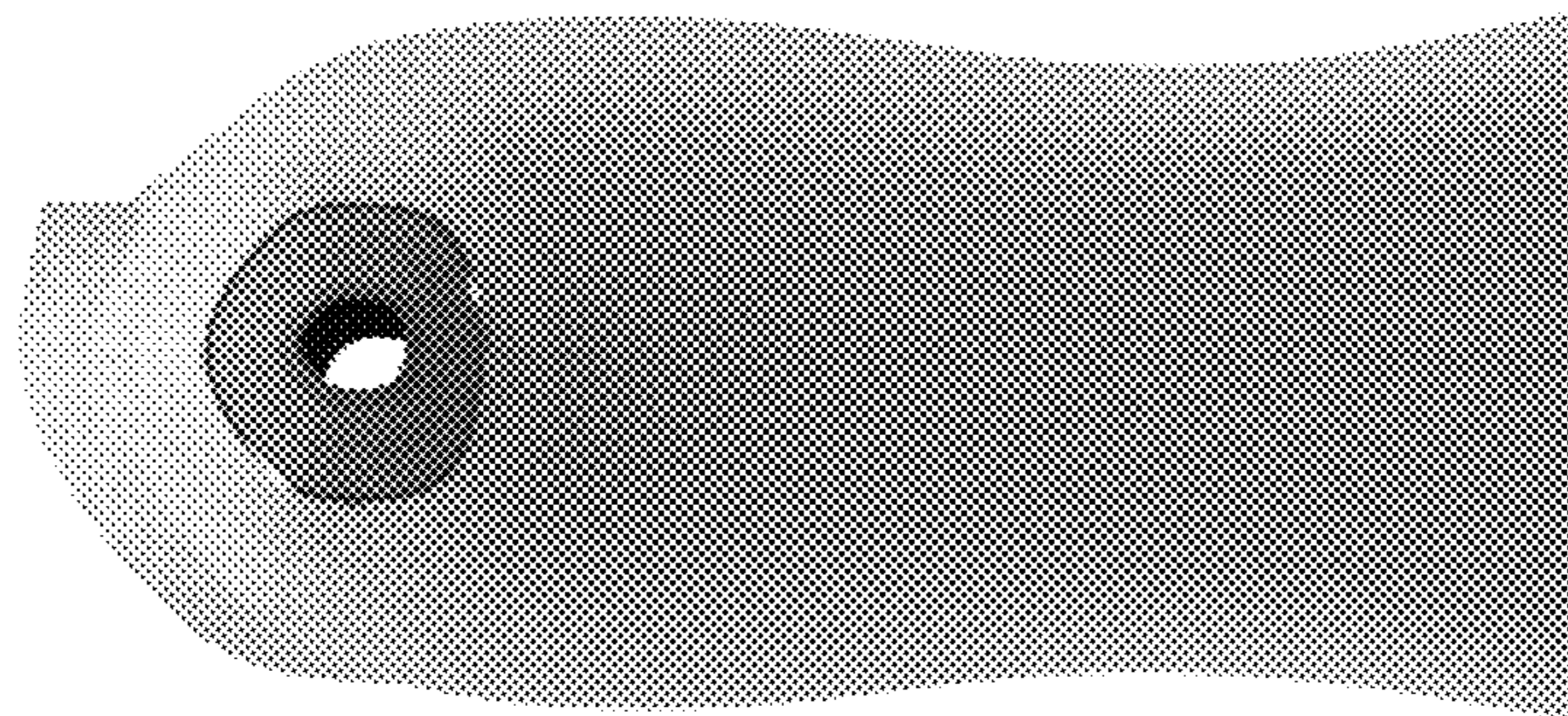

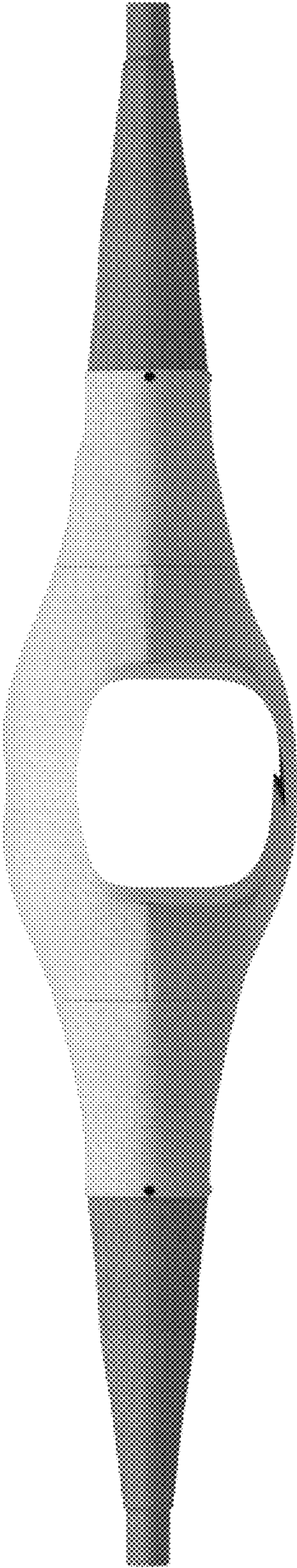

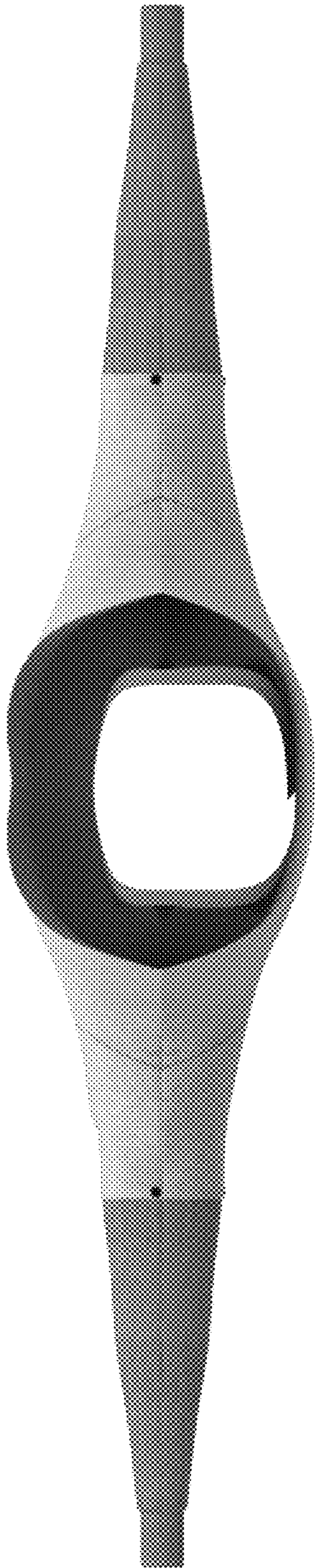

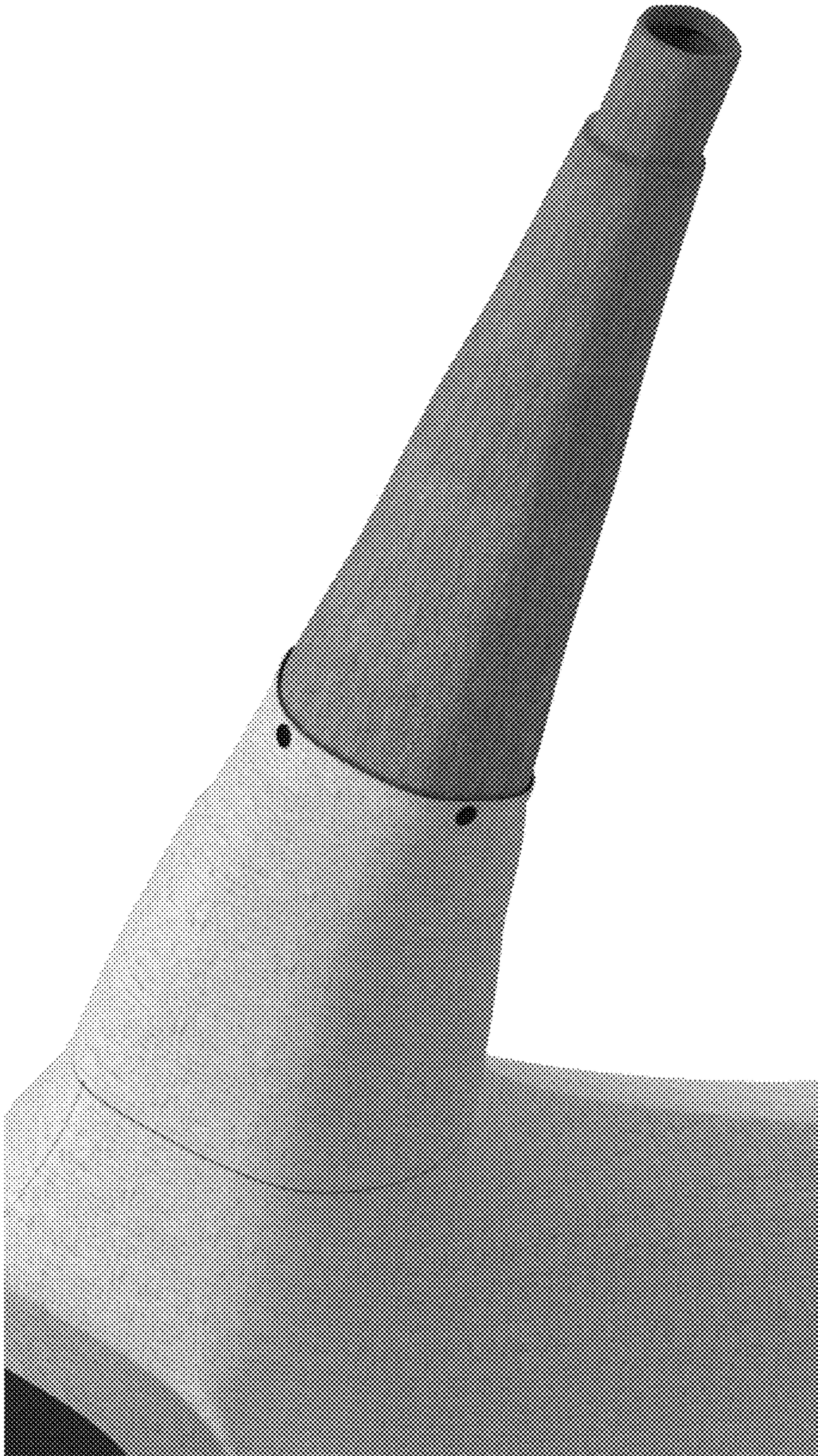

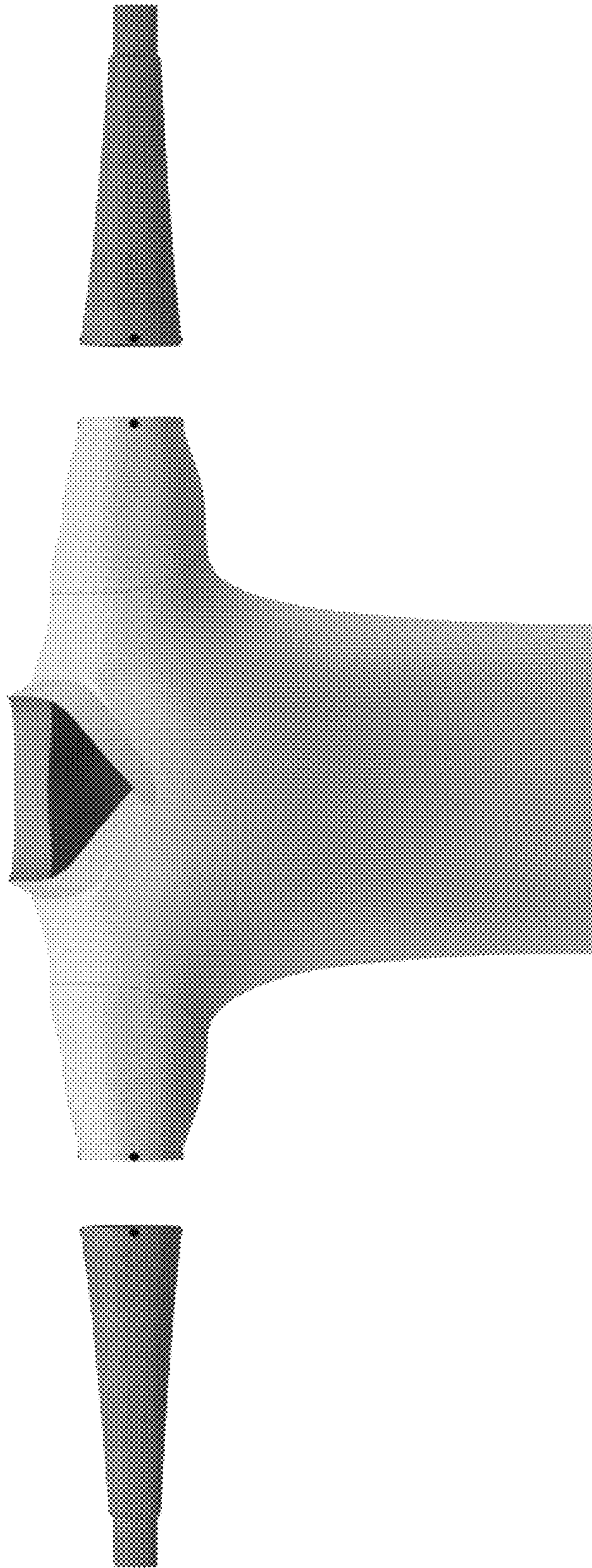

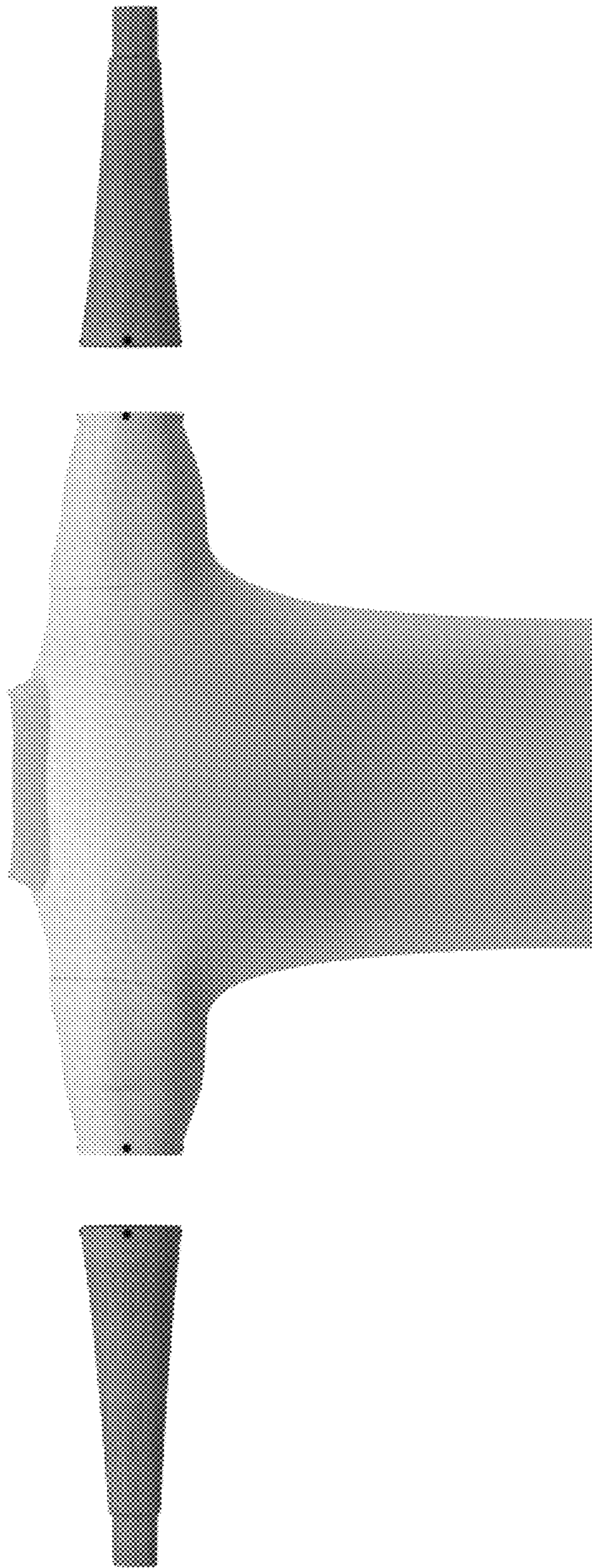

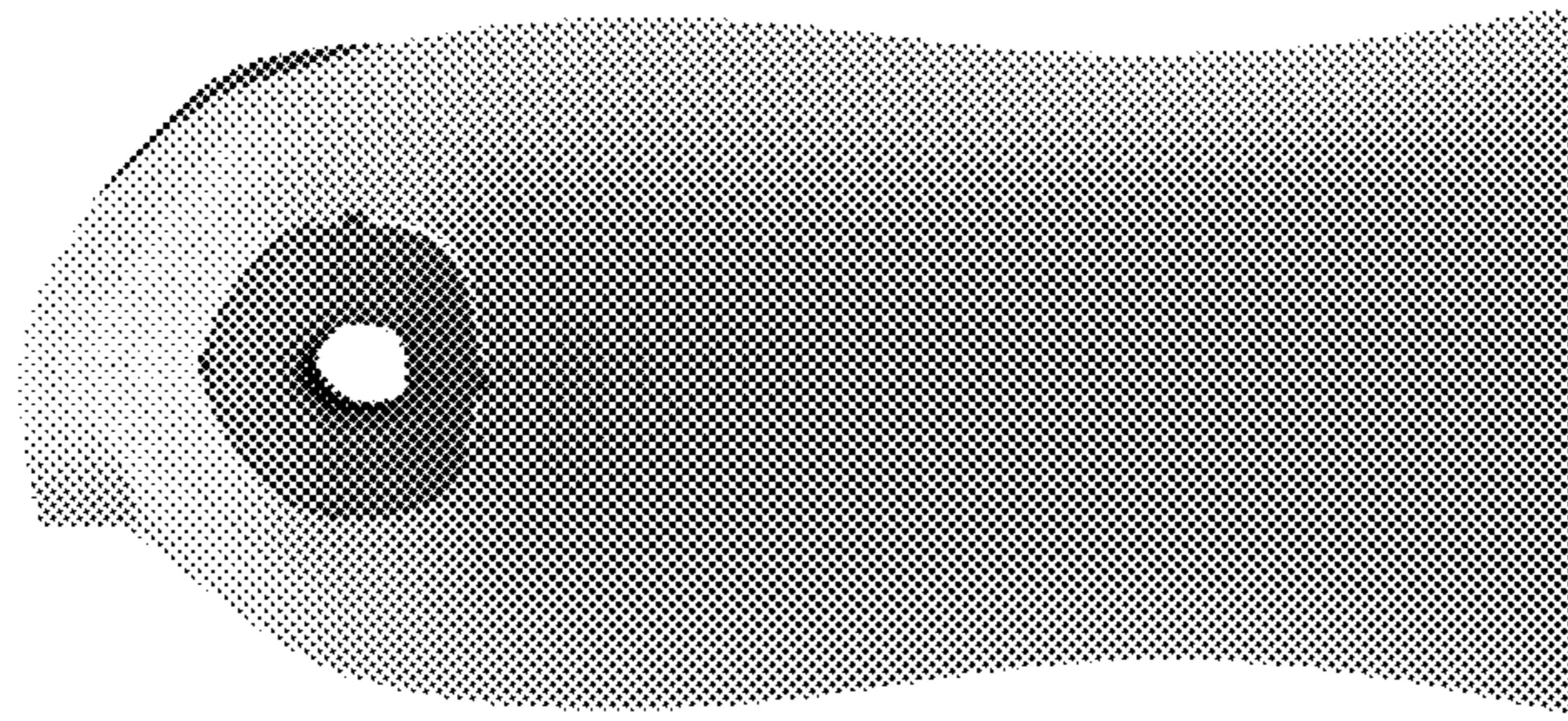

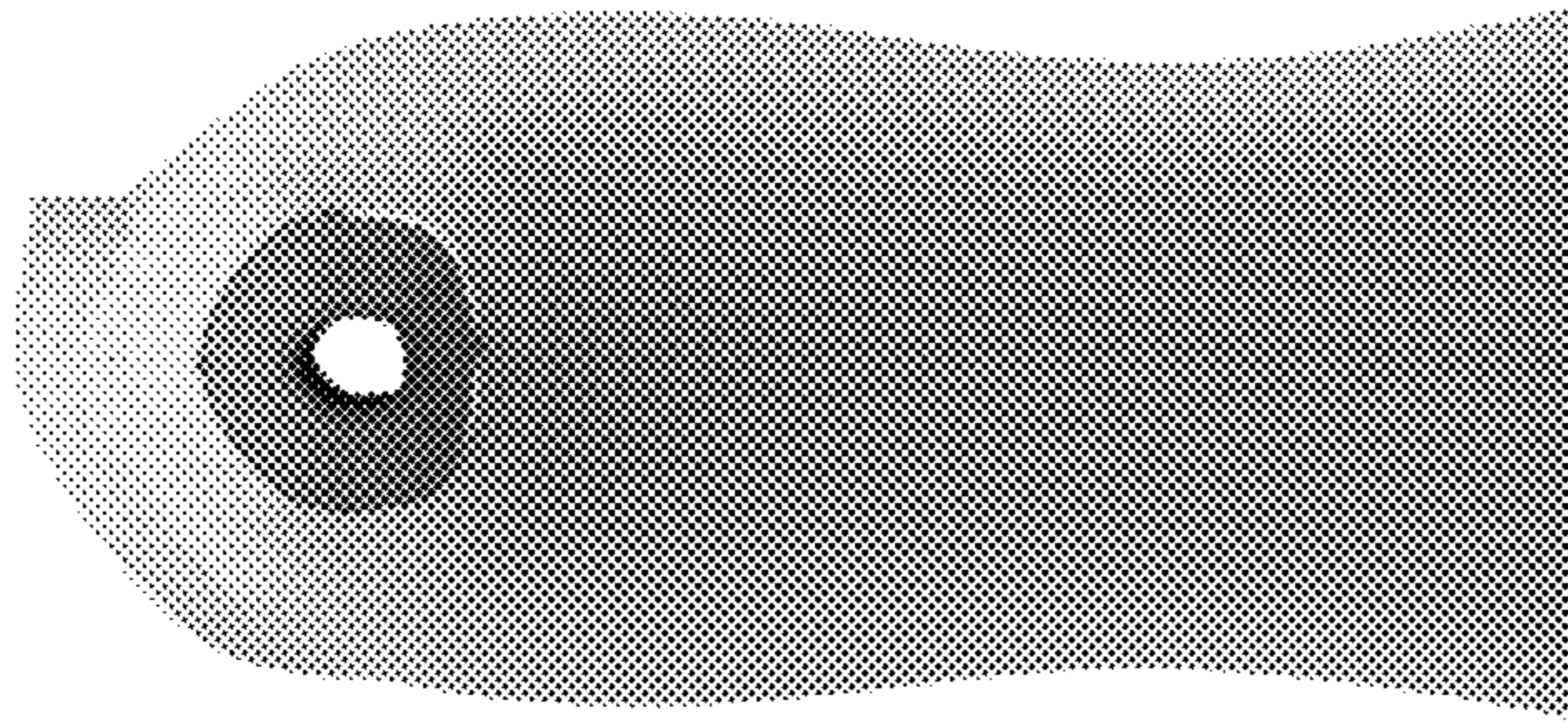

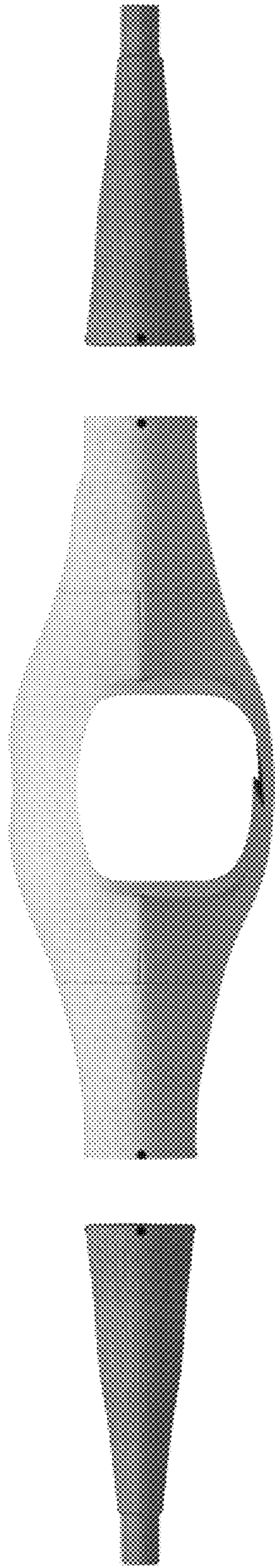

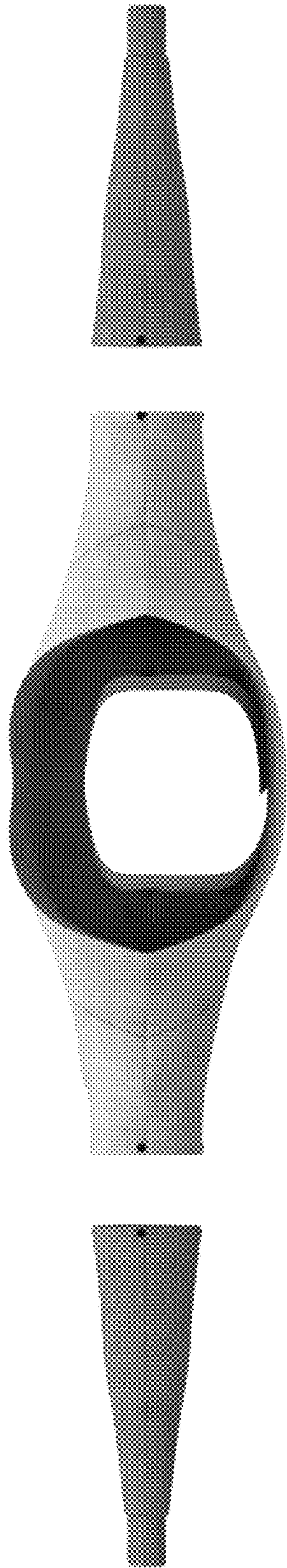

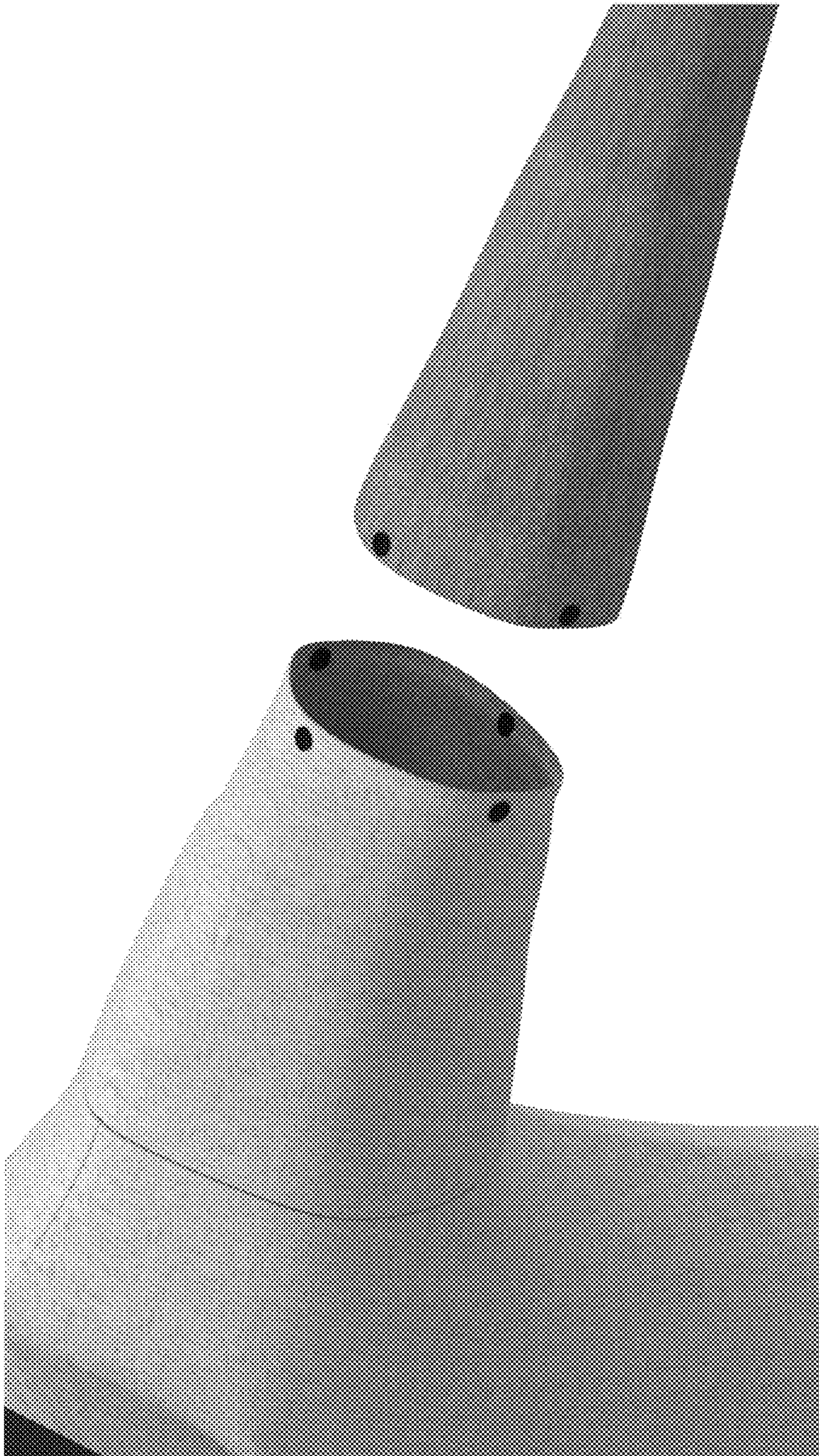
