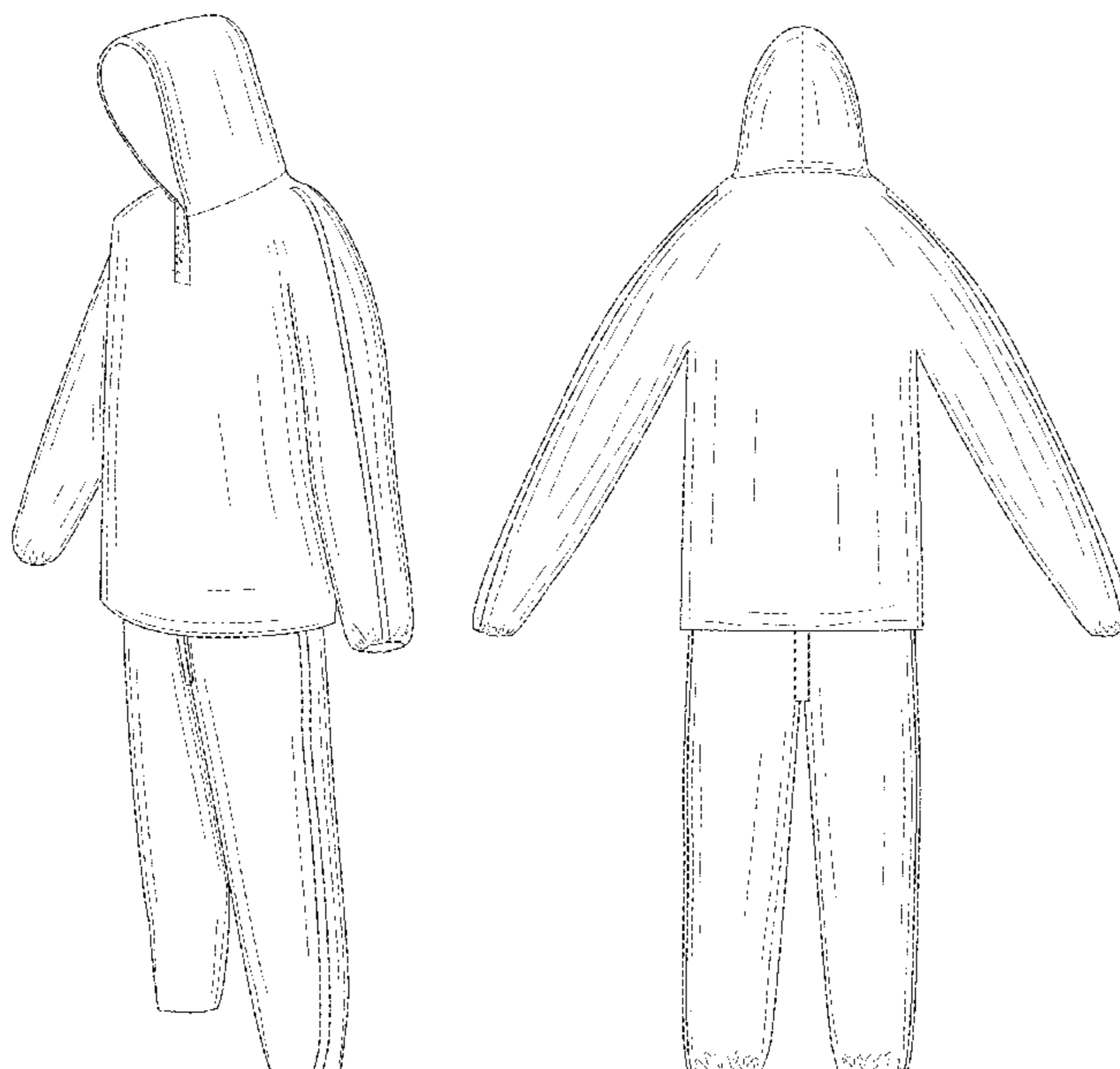
The ornamental design for a two piece hooded garment, as shown and described.

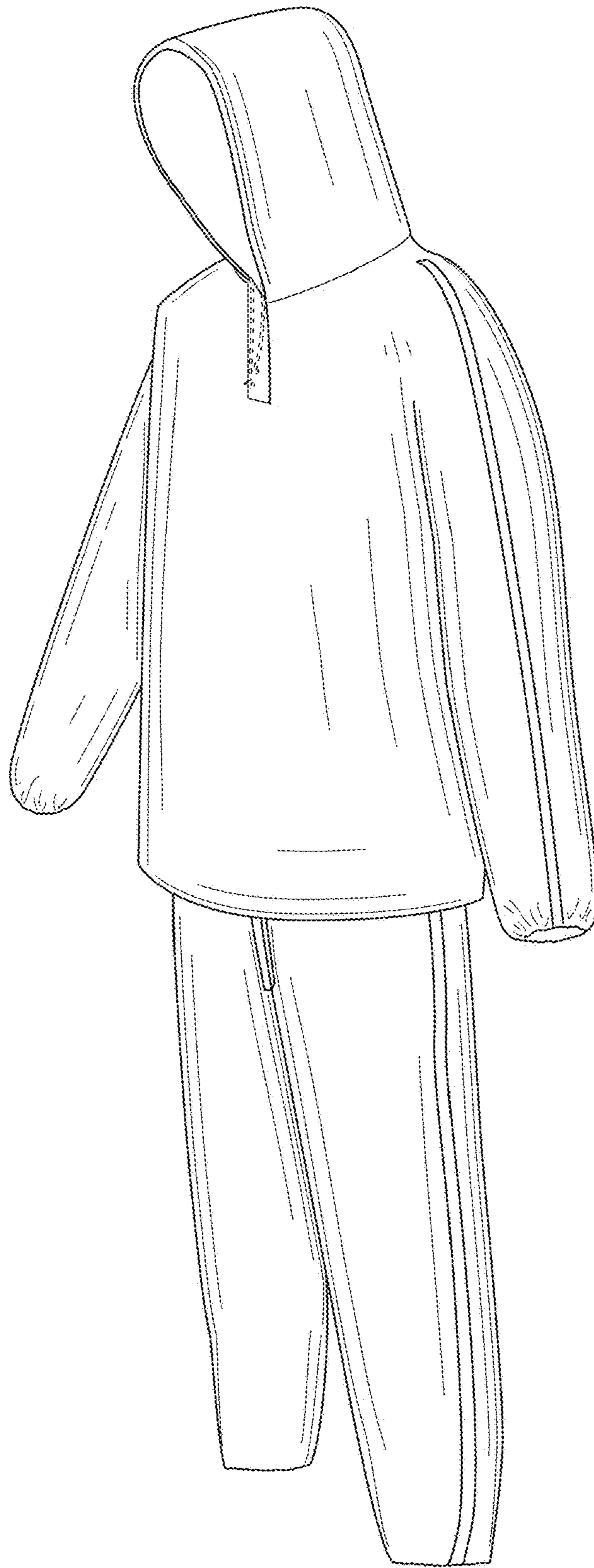

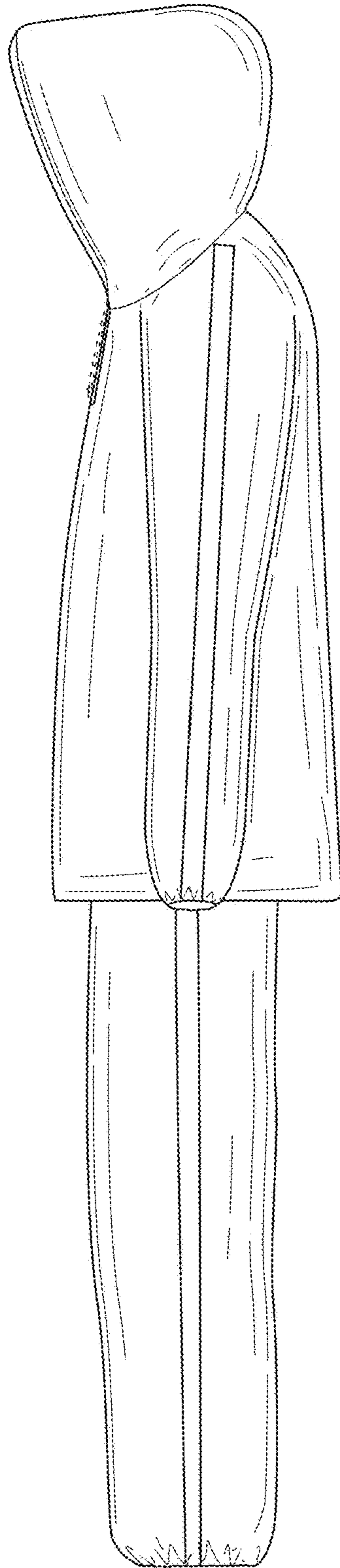

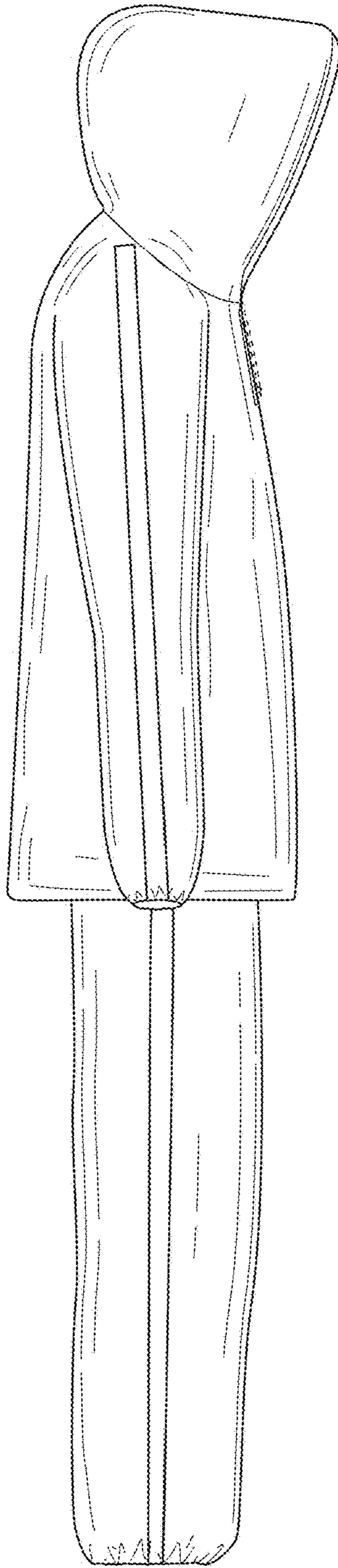

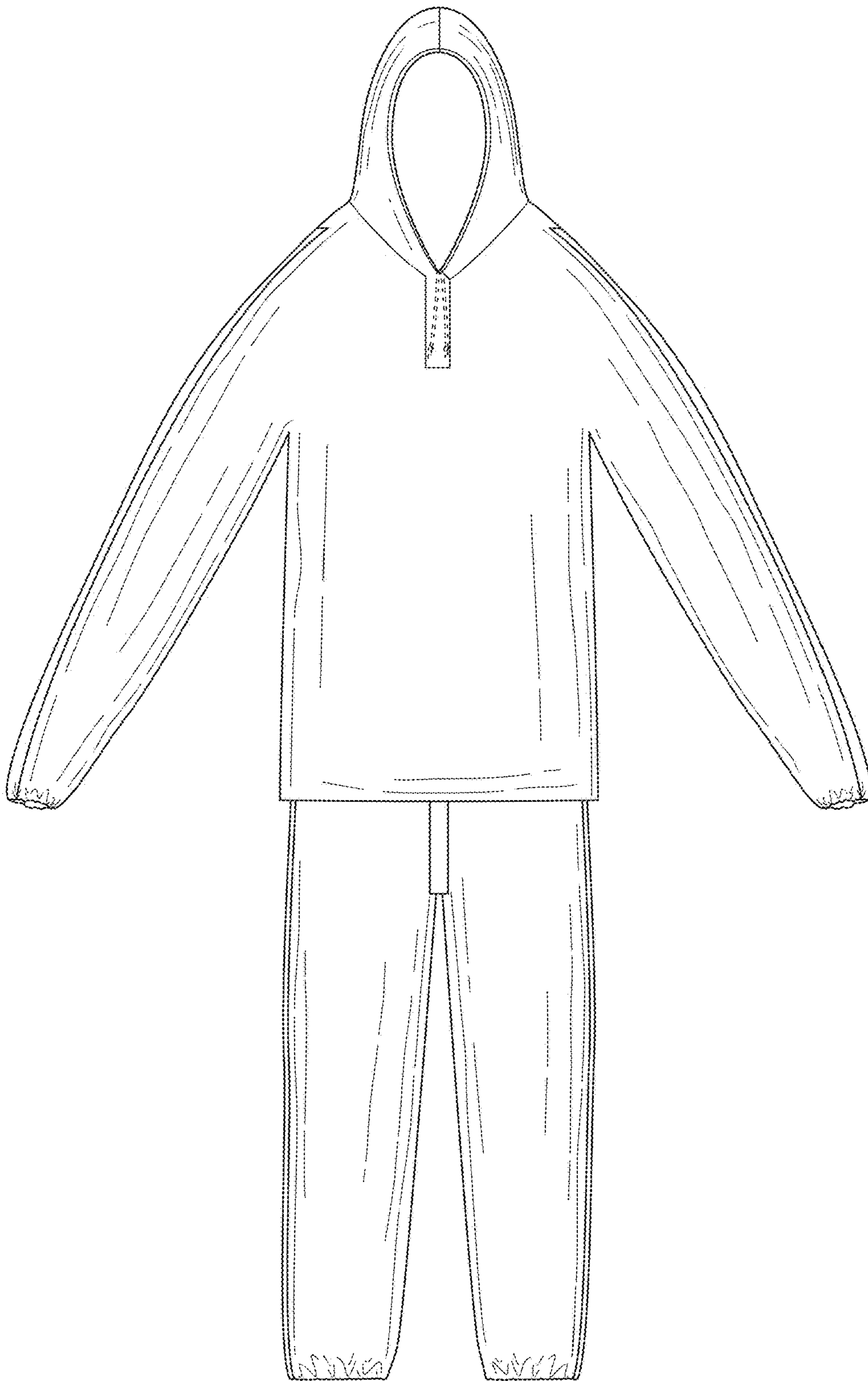

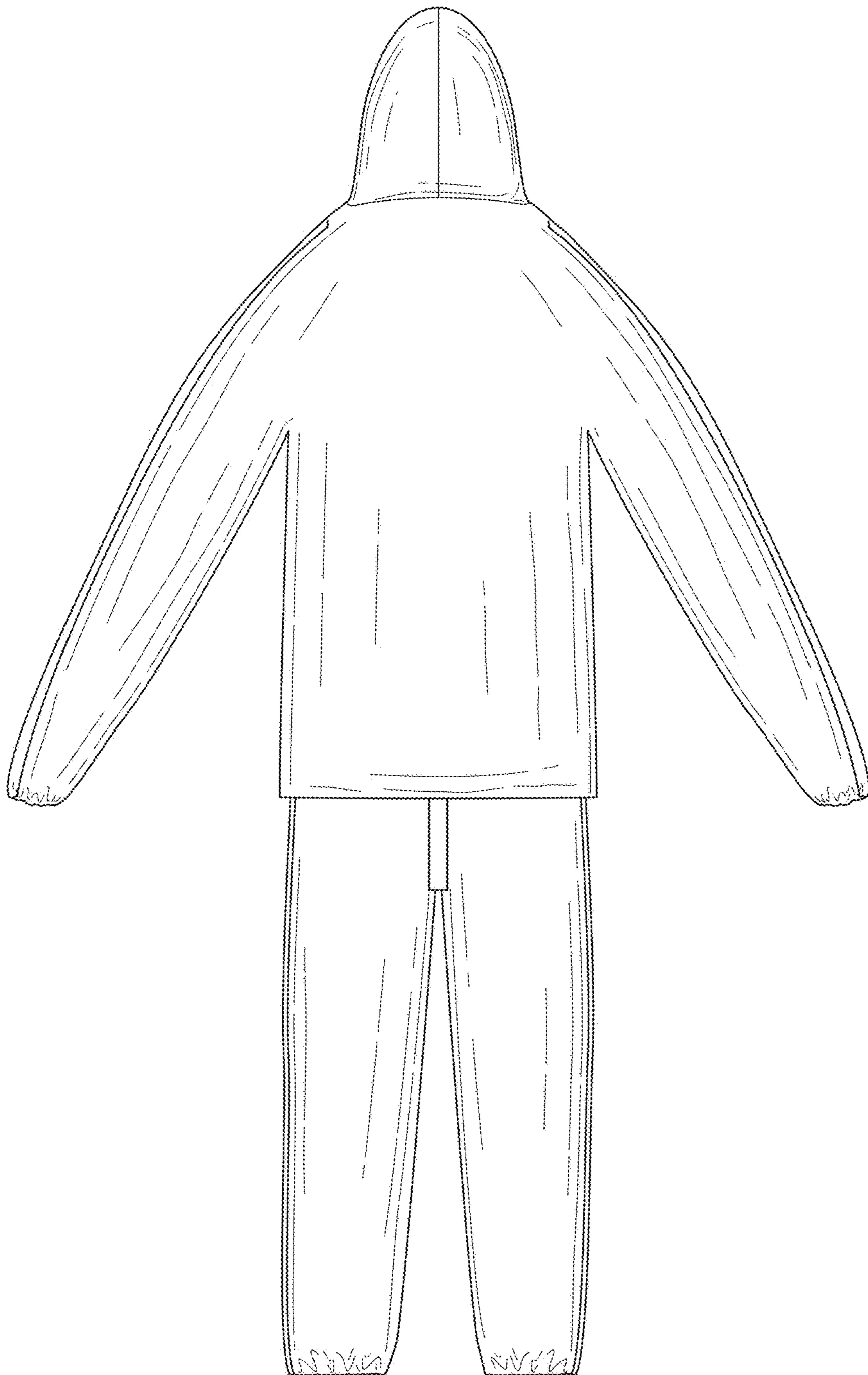

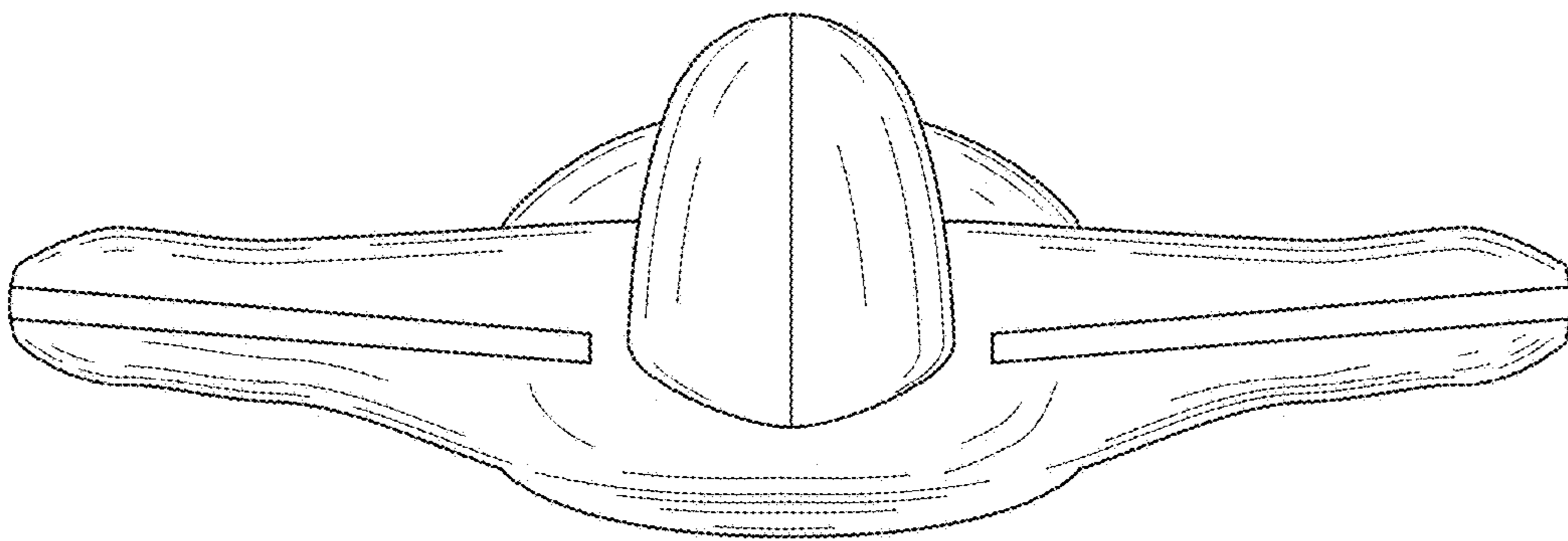

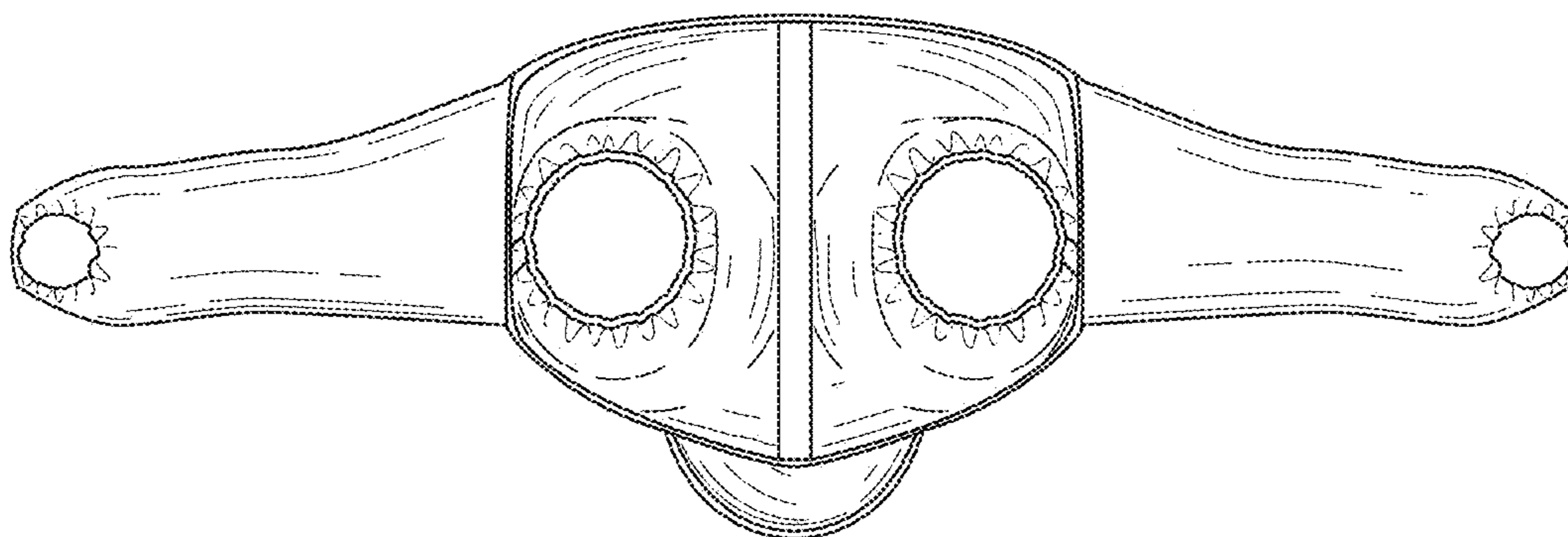
