**CLAIM**

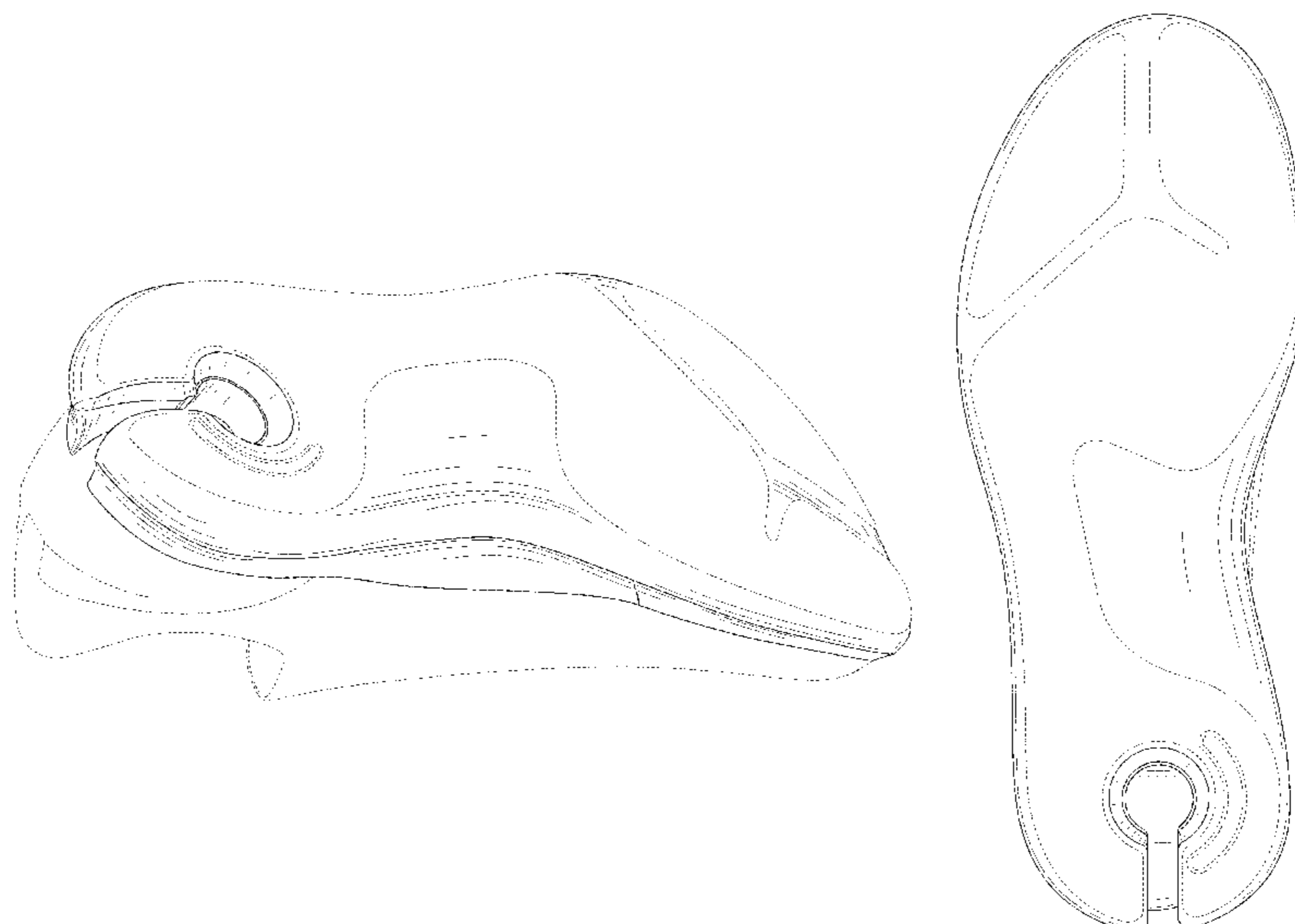
The ornamental design for a shoe sole, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a shoe sole showing my new design;  
FIG. 2 is a bottom view thereof;  
FIG. 3 is a left view thereof;  
FIG. 4 is a right side view thereof;  
FIG. 5 is a front side view thereof; and,  
FIG. 6 is a back view thereof.

The broken line illustration of environmental structure in the drawings is not part of the claimed design. The shoe sole illustrated is a first embodiment showing a right-footed form of the shoe sole. A second embodiment of the shoe sole is for the left-footed form of the shoe sole, which is a mirror image of the right-footed form, is not illustrated.

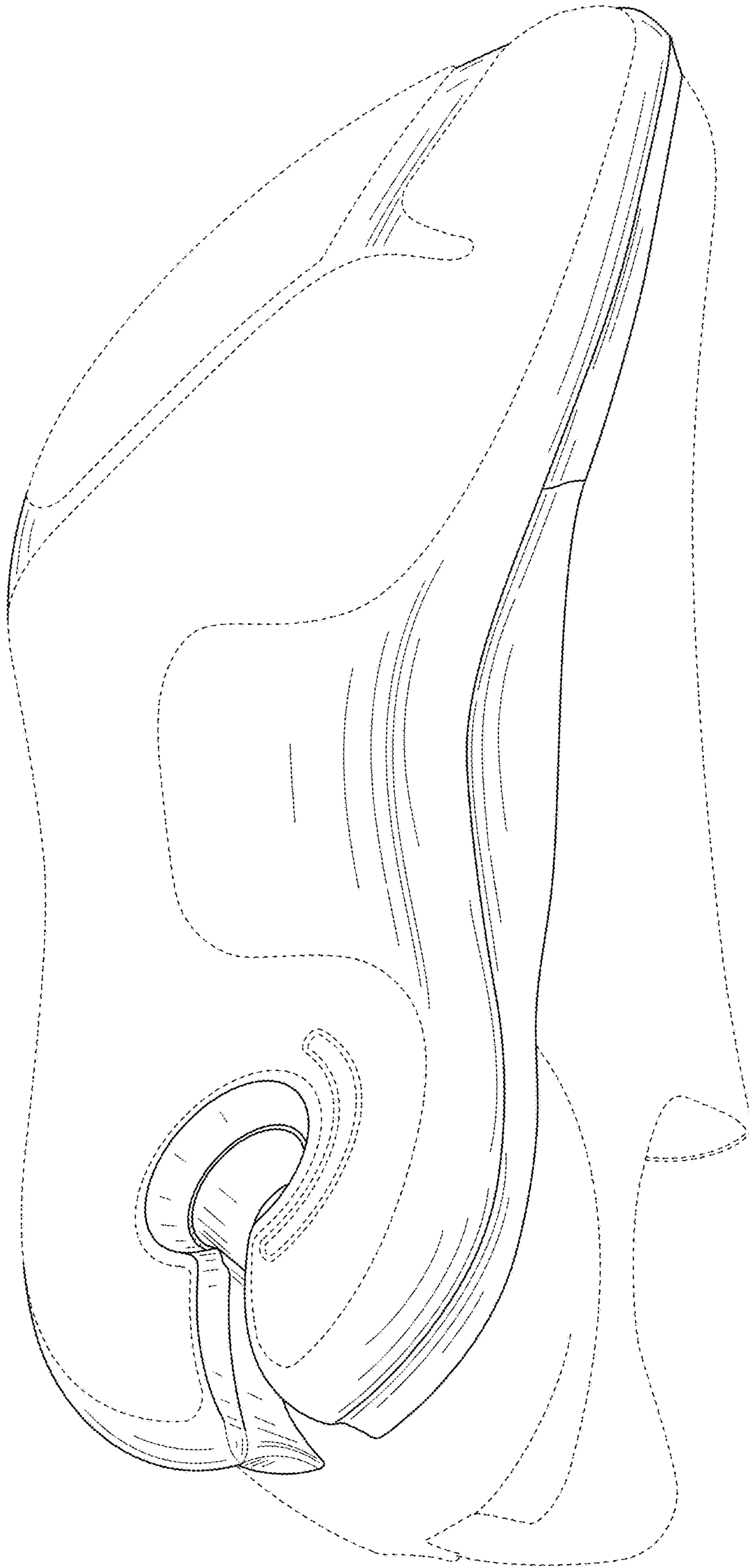
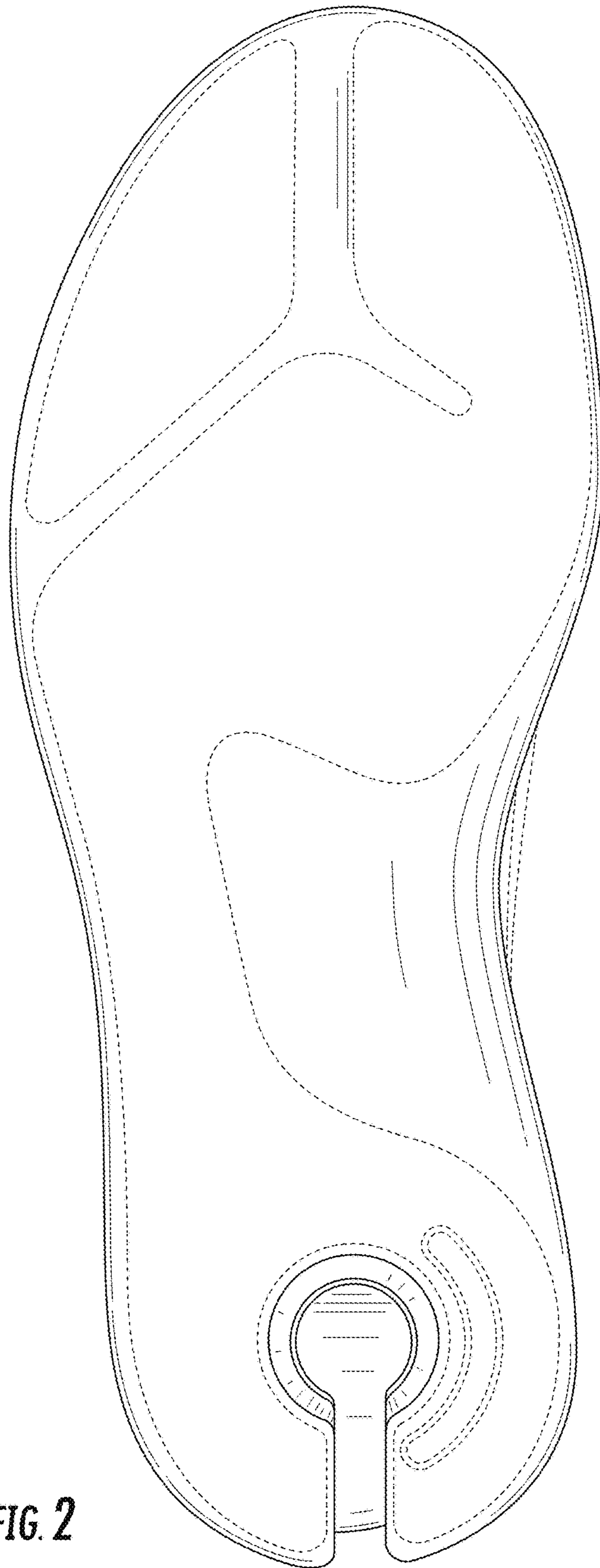

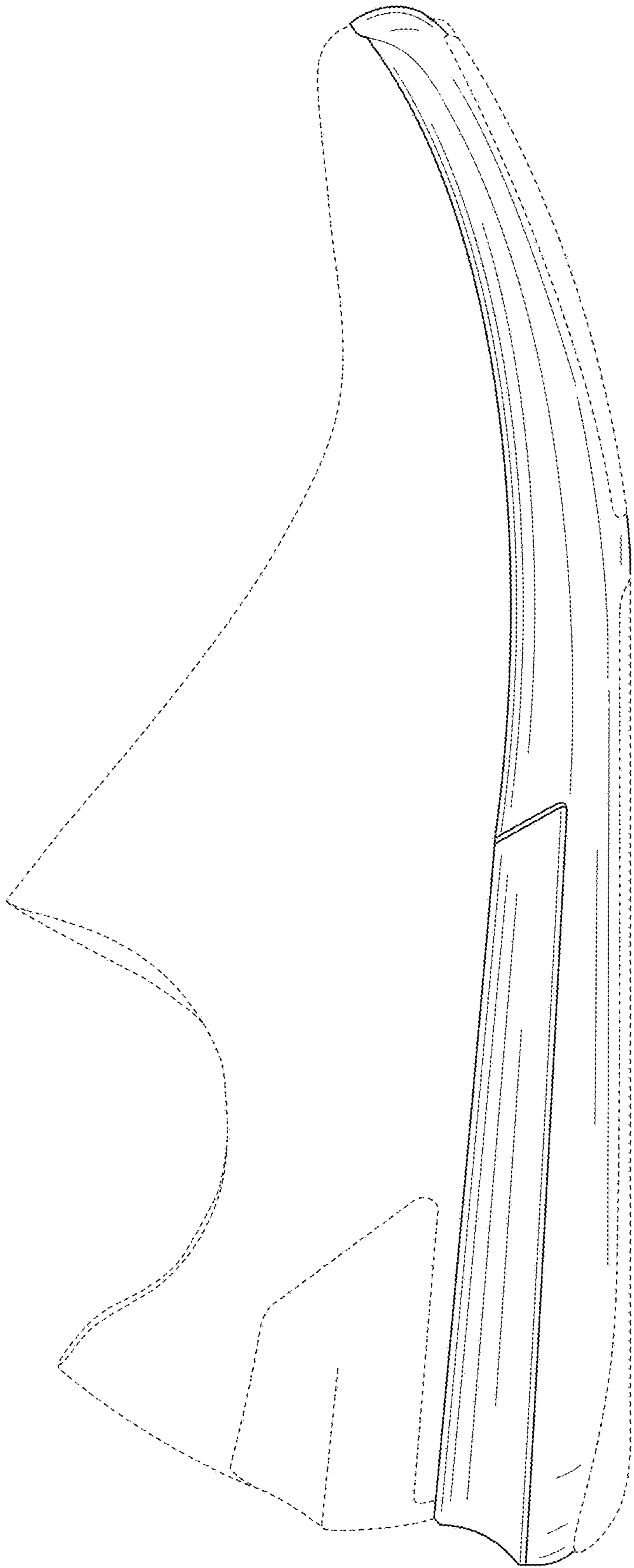

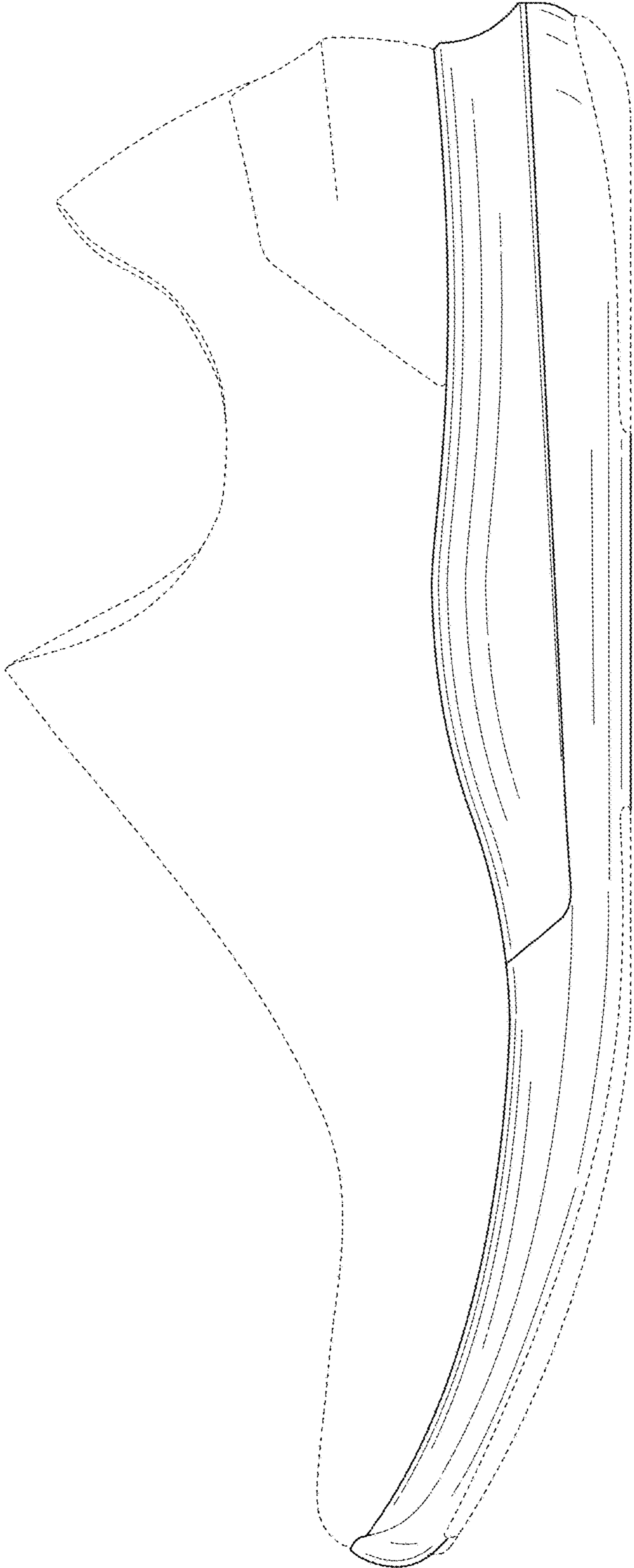

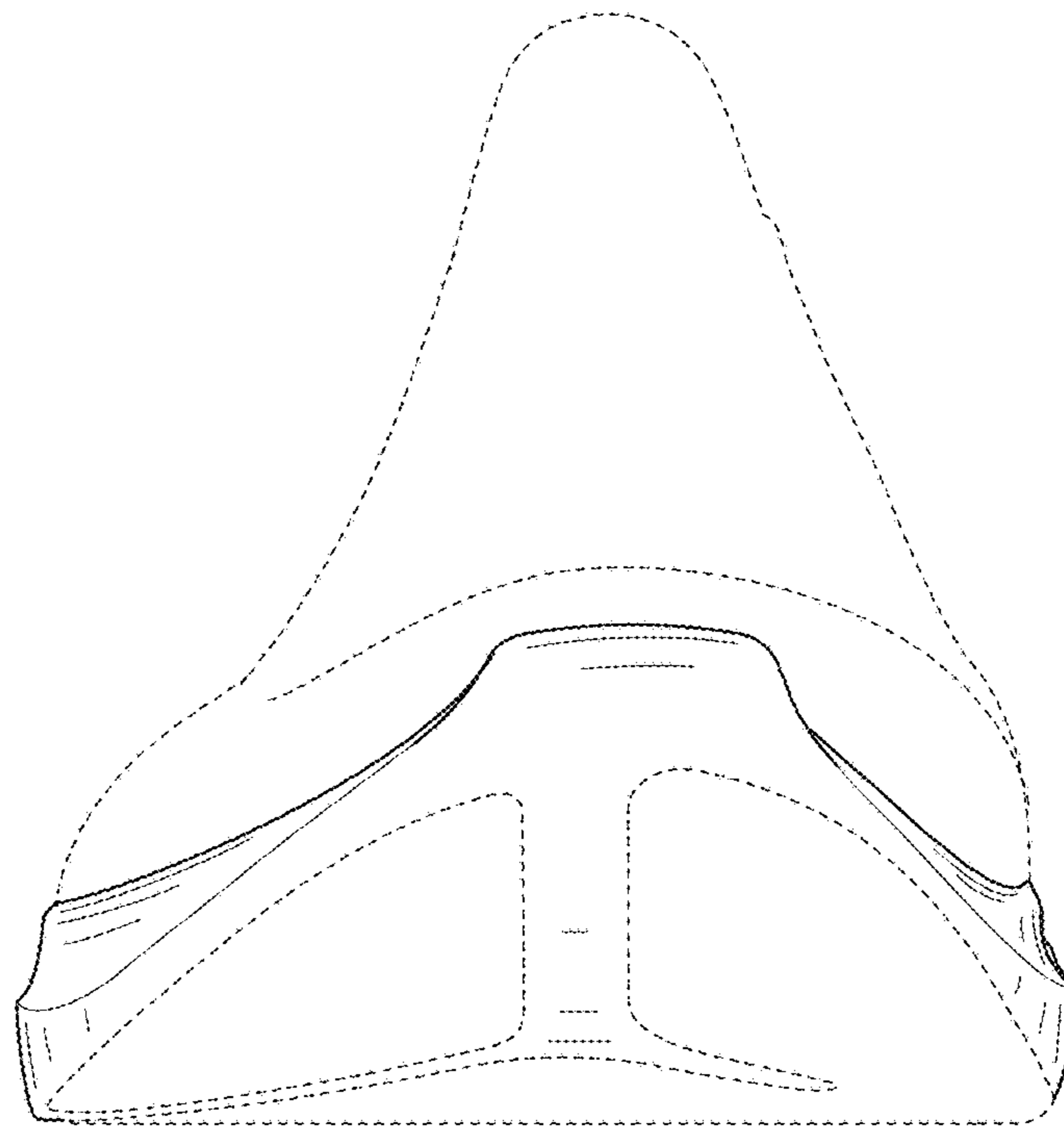

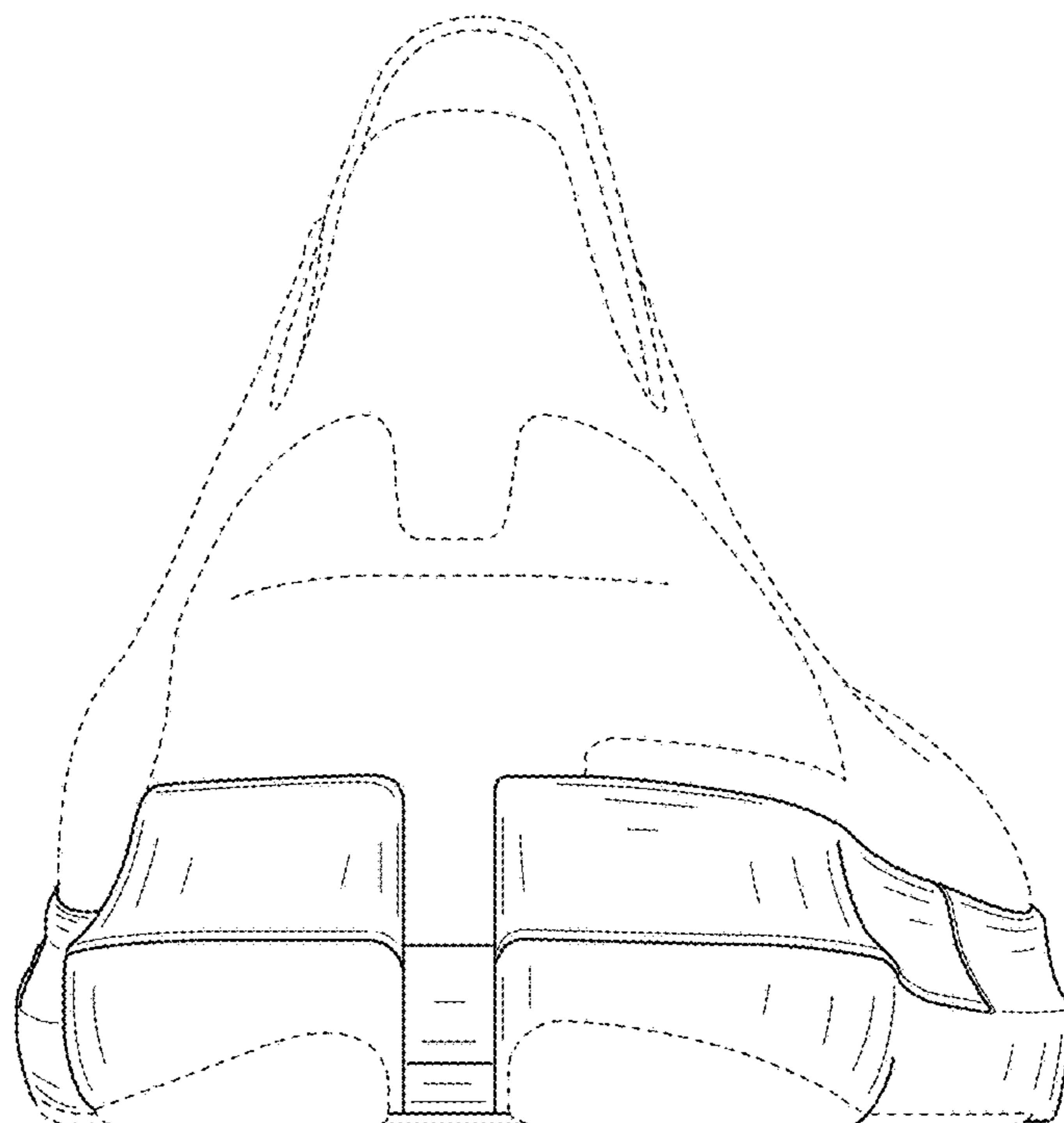
