(57) **CLAIM**

An ornamental design for an “over the shoulder harness/sling,” as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a first embodiment of the over the shoulder harness/sling;  
FIG. 2 is a front elevation view thereof;  
FIG. 3 is a rear elevation view thereof;  
FIG. 4 is a right side view thereof;

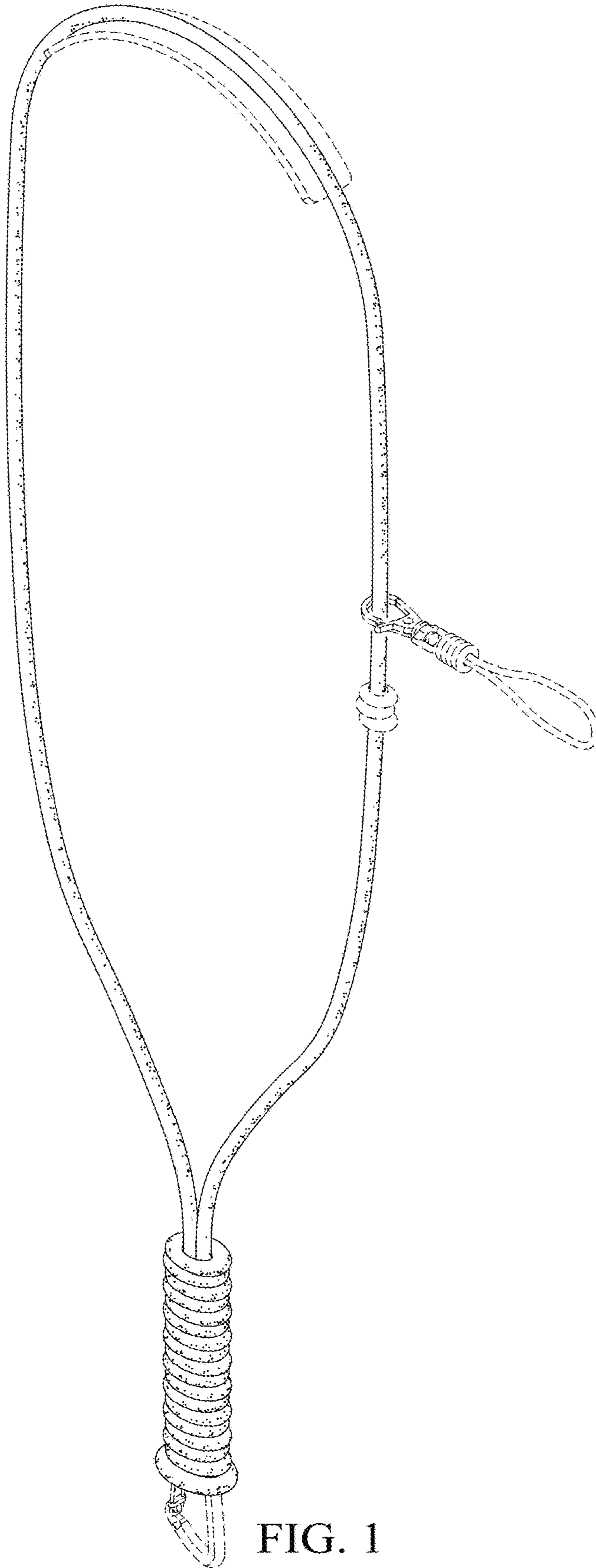

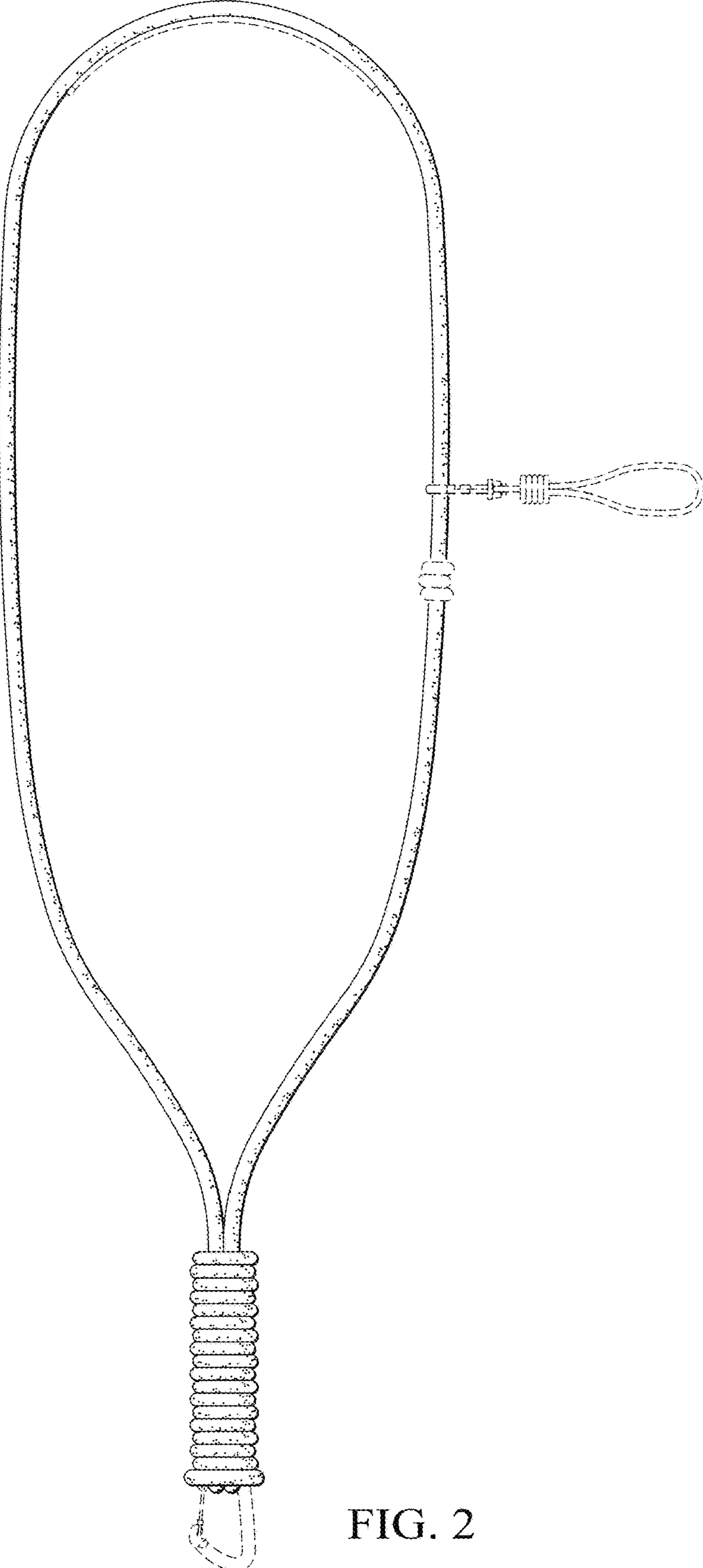

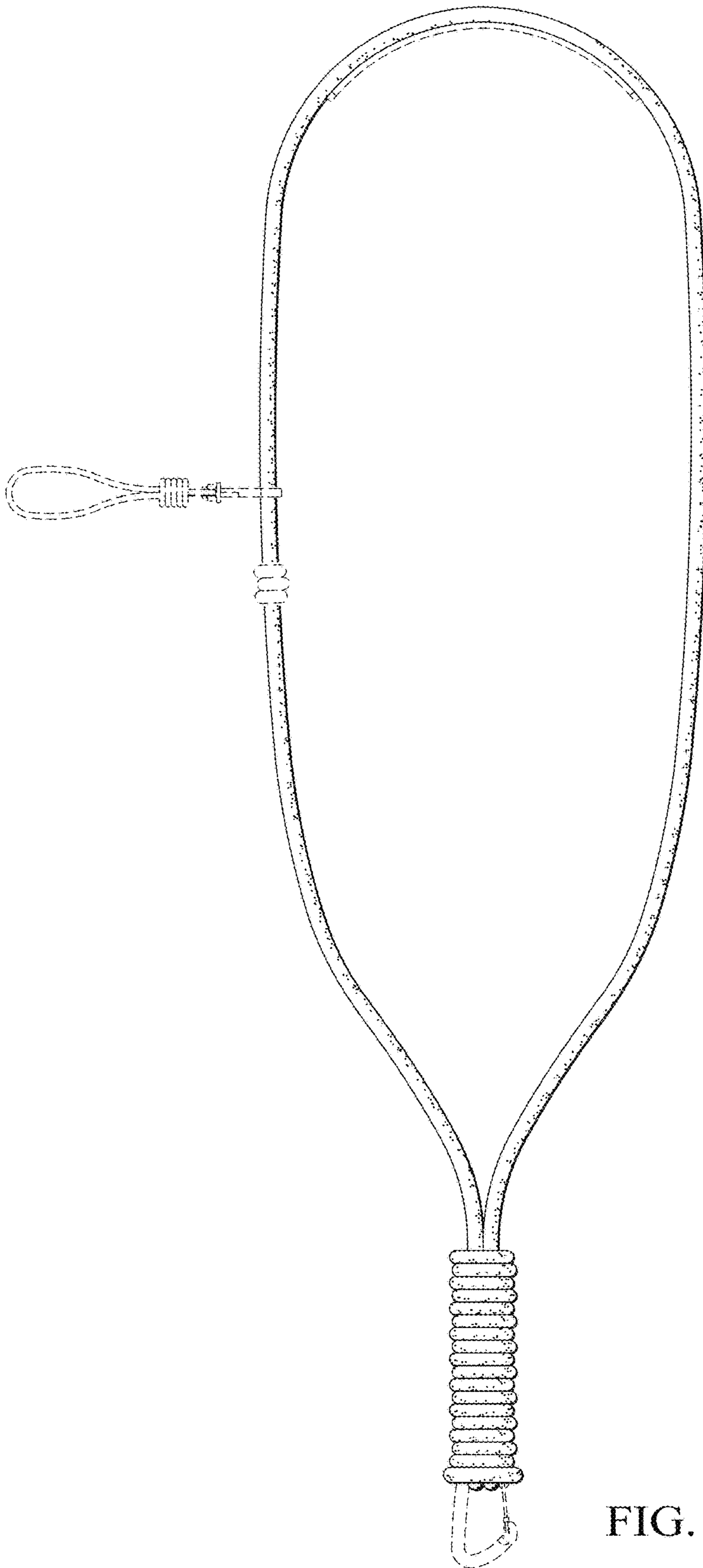

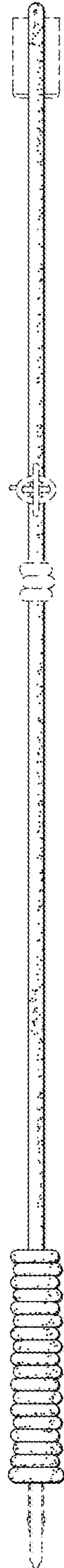

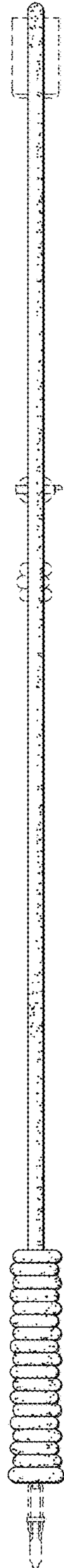

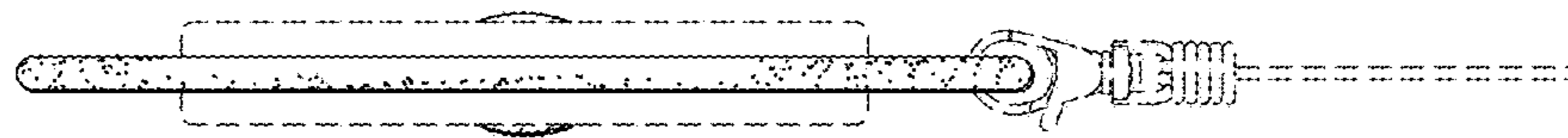

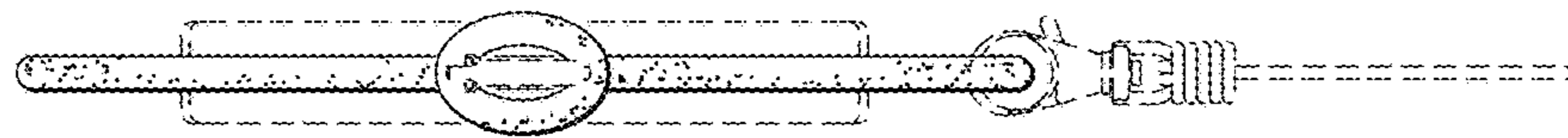

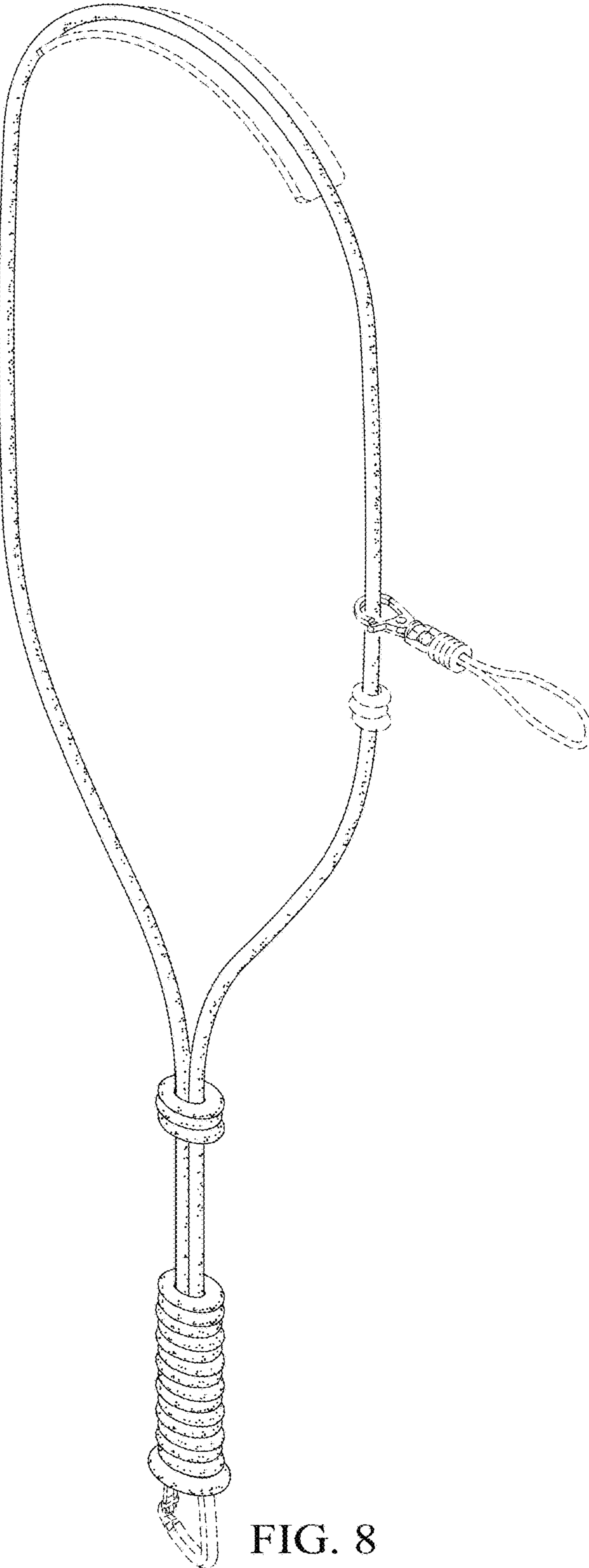

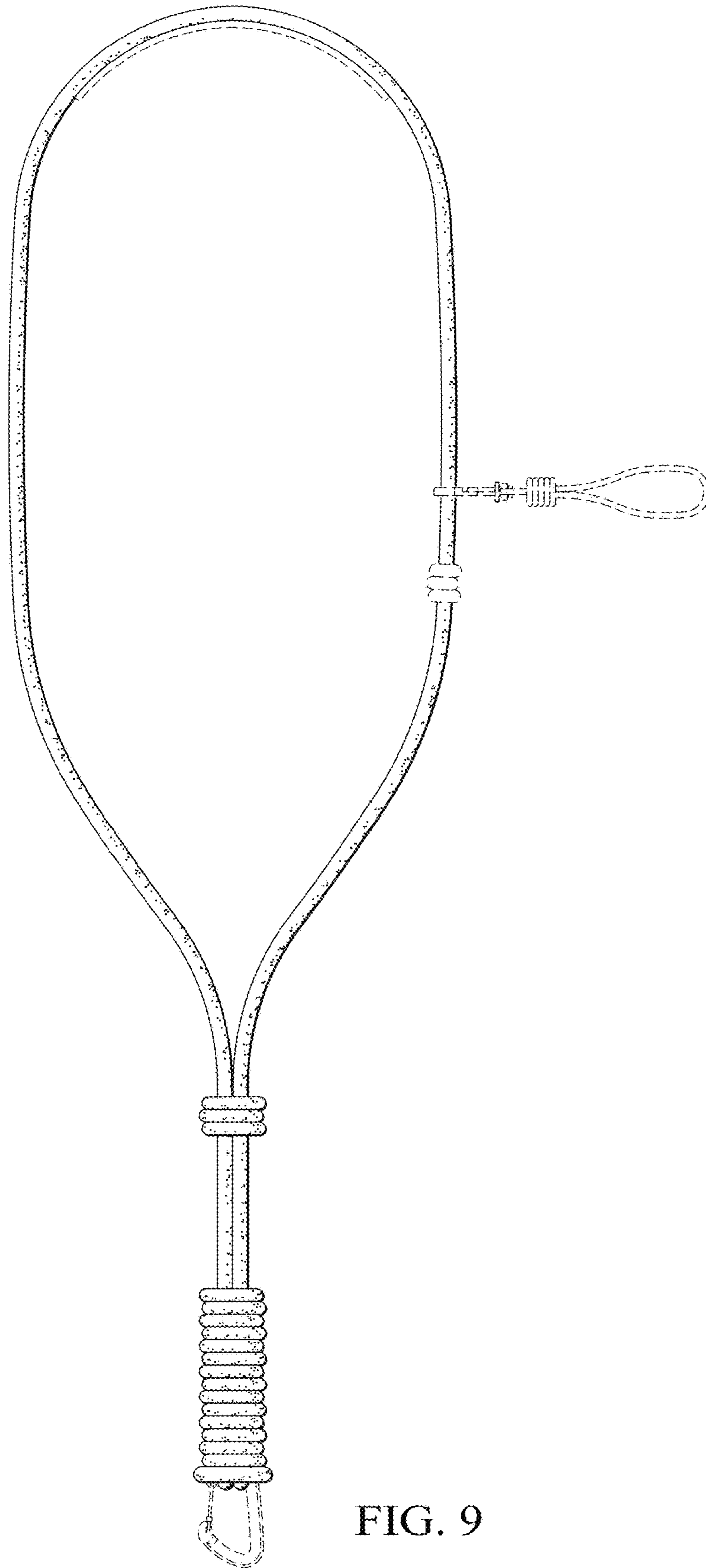

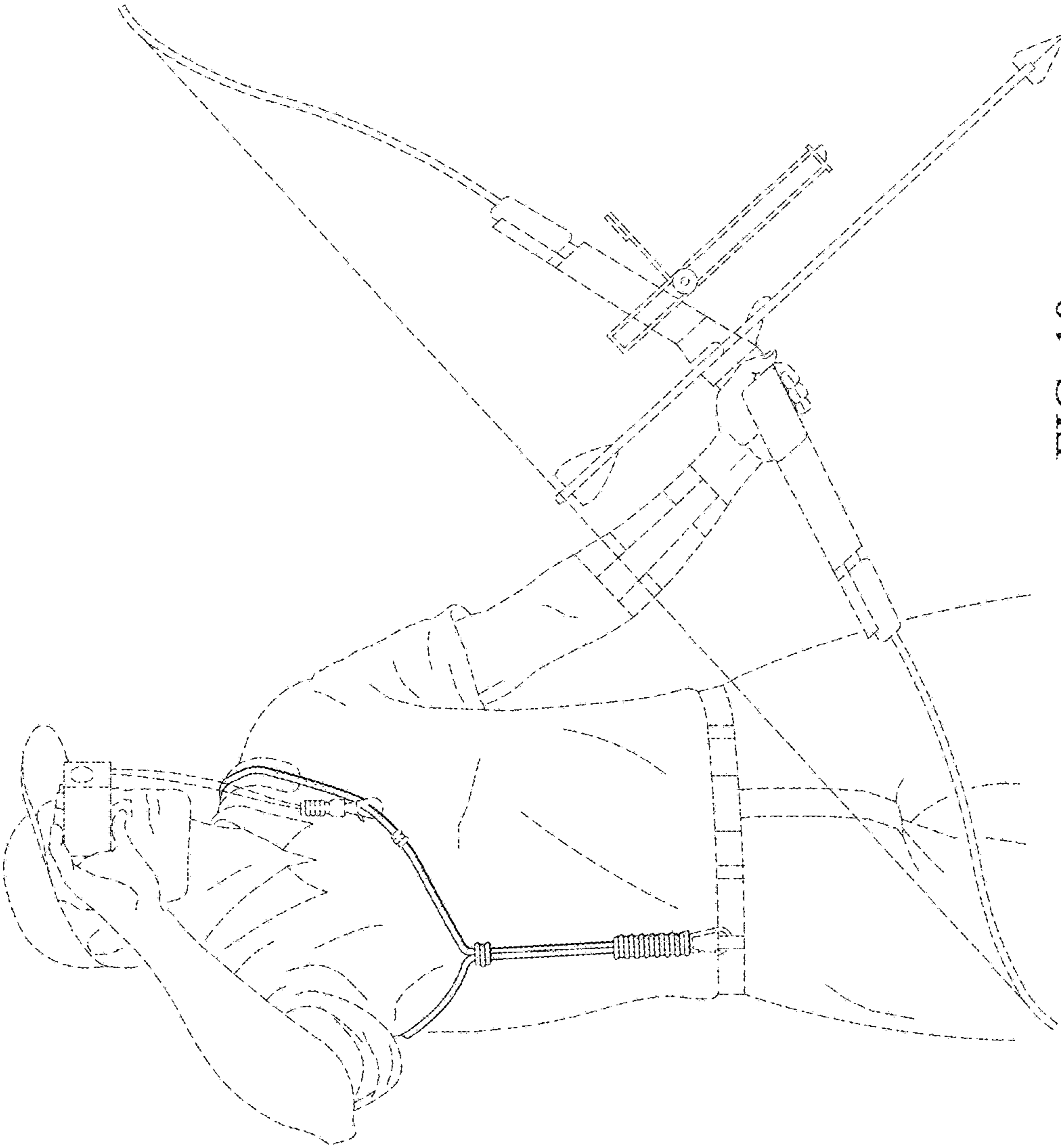

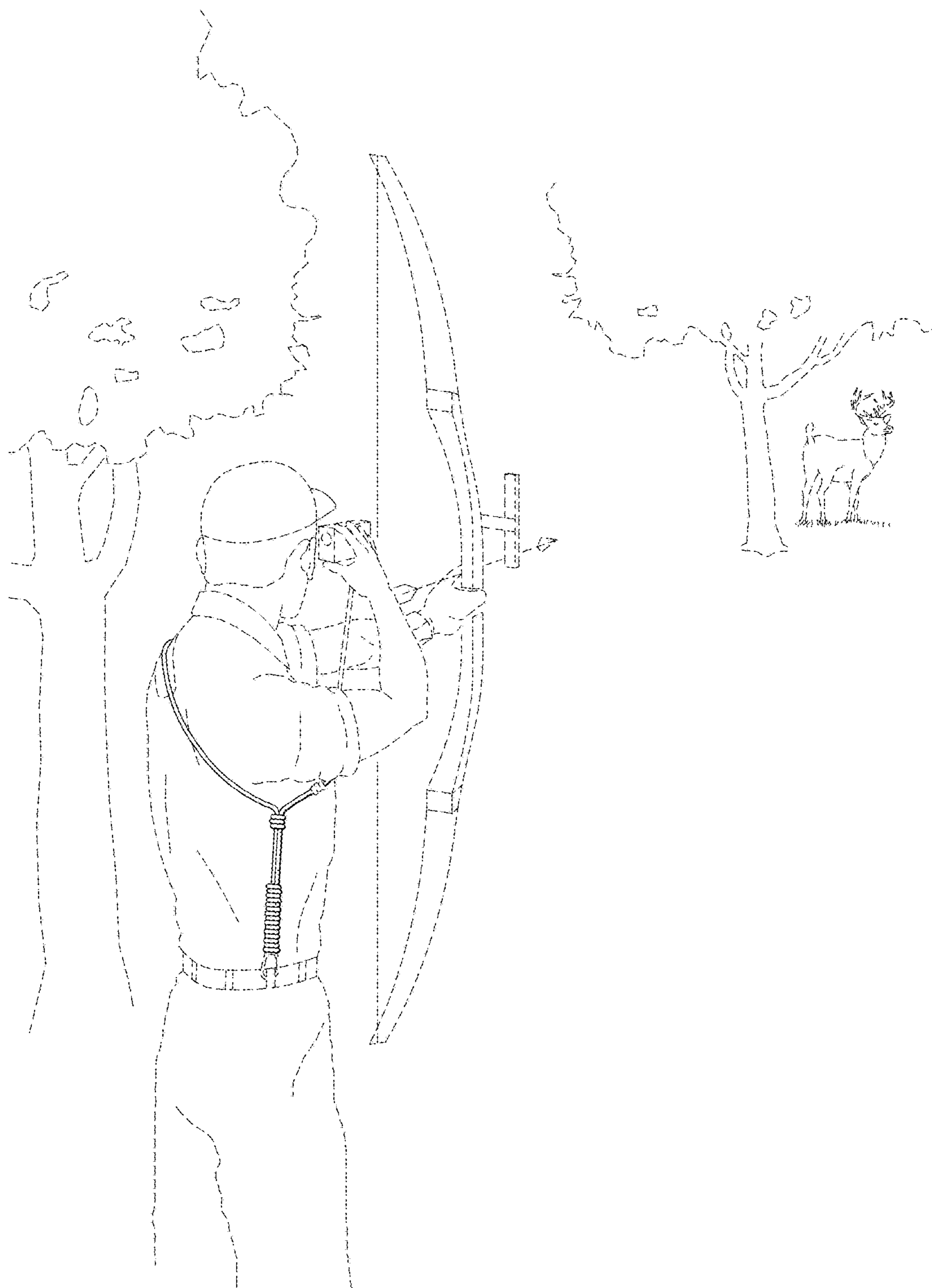
