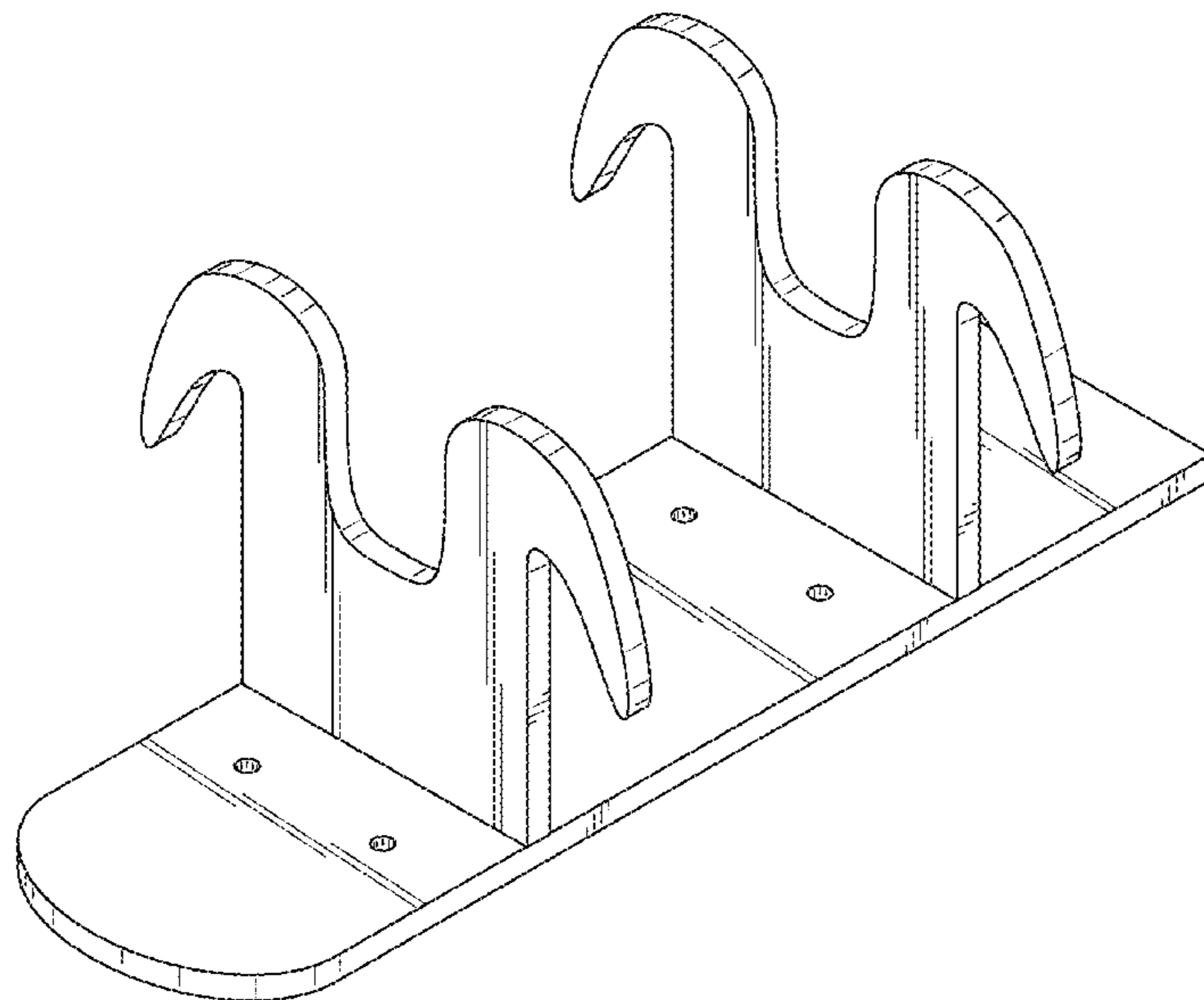
(57) **CLAIM**

The ornamental design for a weapon rack for a tree stand, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top front right view of a weapon rack for a tree stand, showing my new design;
FIG. 2 is a perspective top rear left view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a rear elevation view thereof;
FIG. 5 is a left elevation view thereof;
FIG. 6 is a right elevation view thereof;

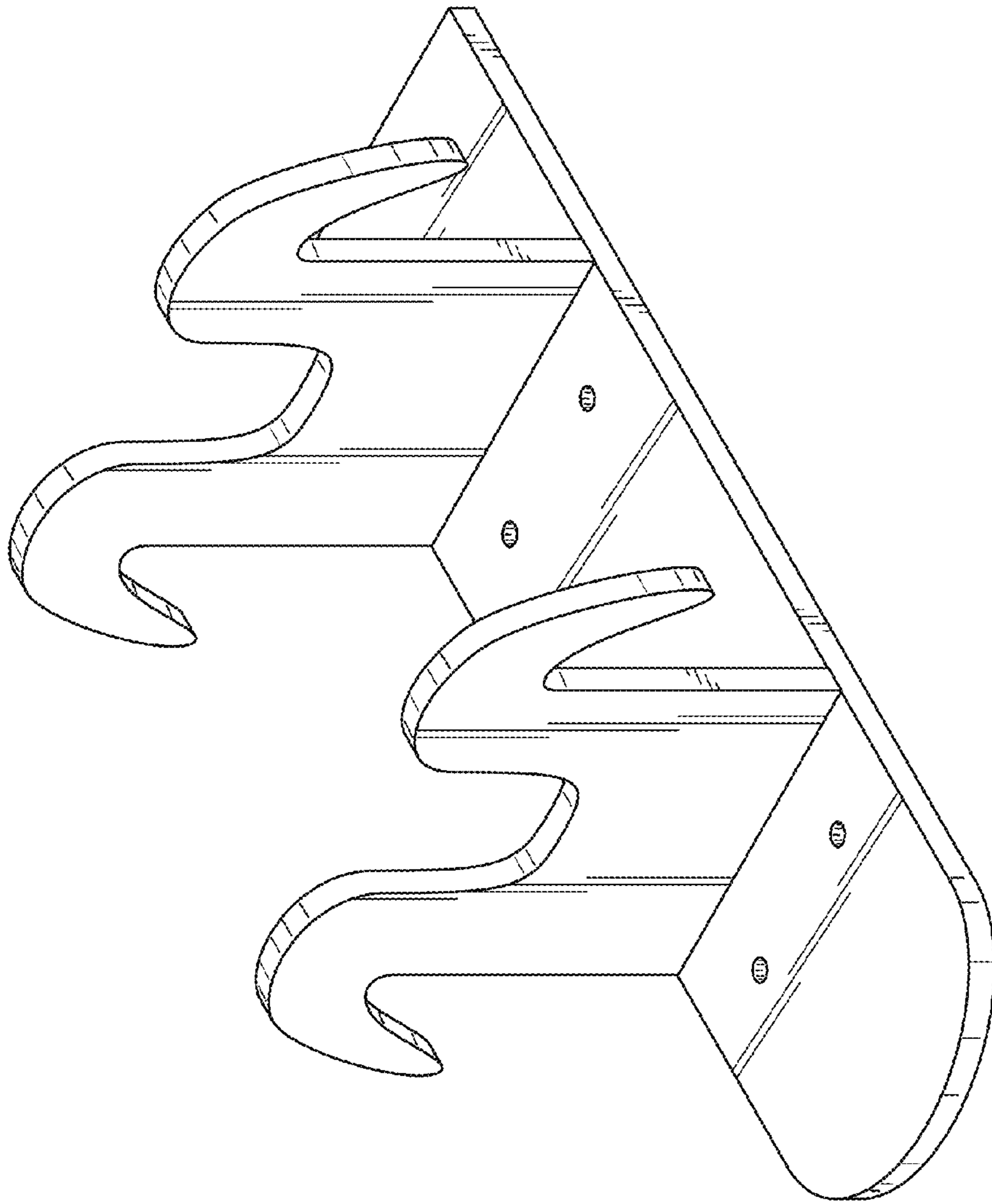

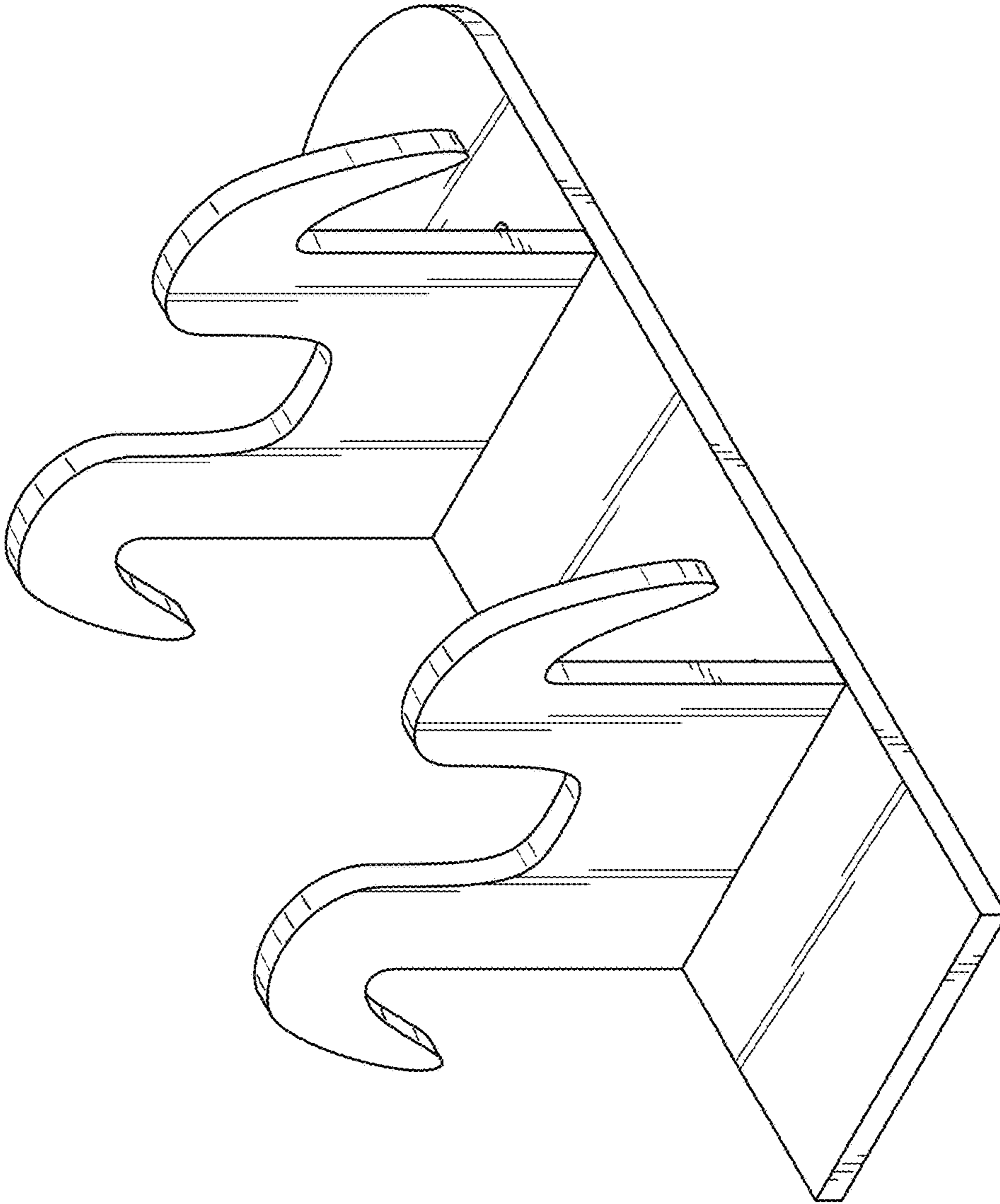

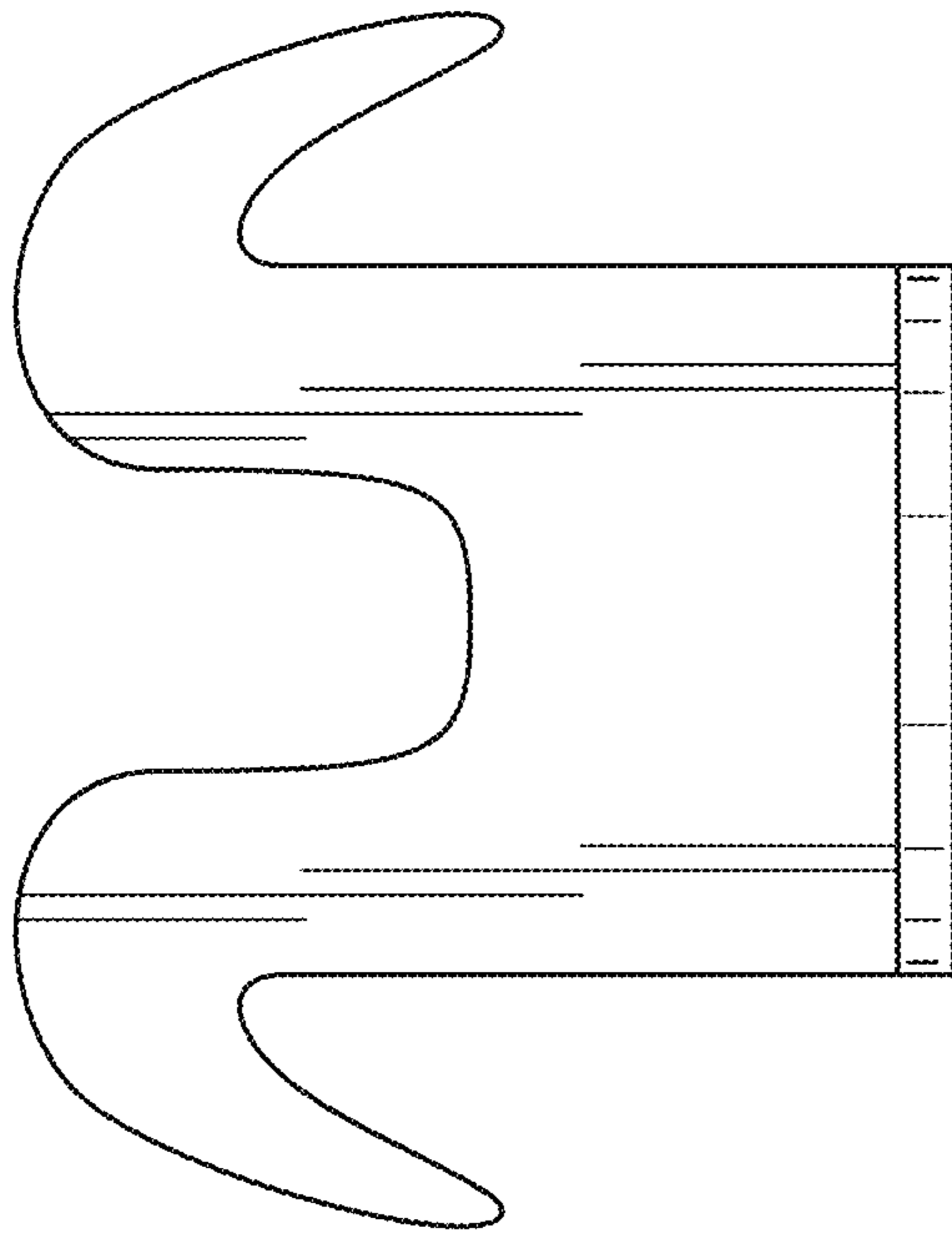

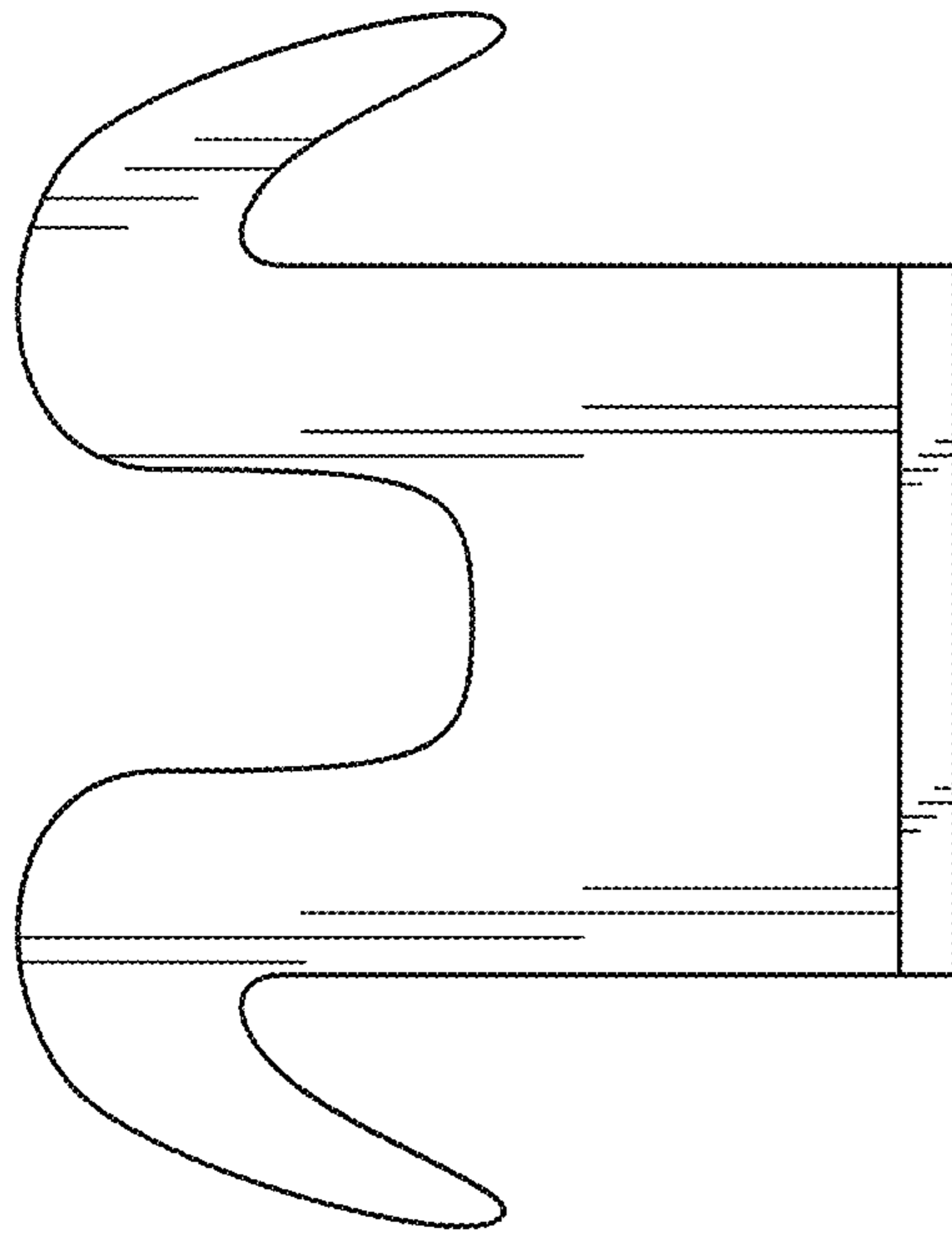

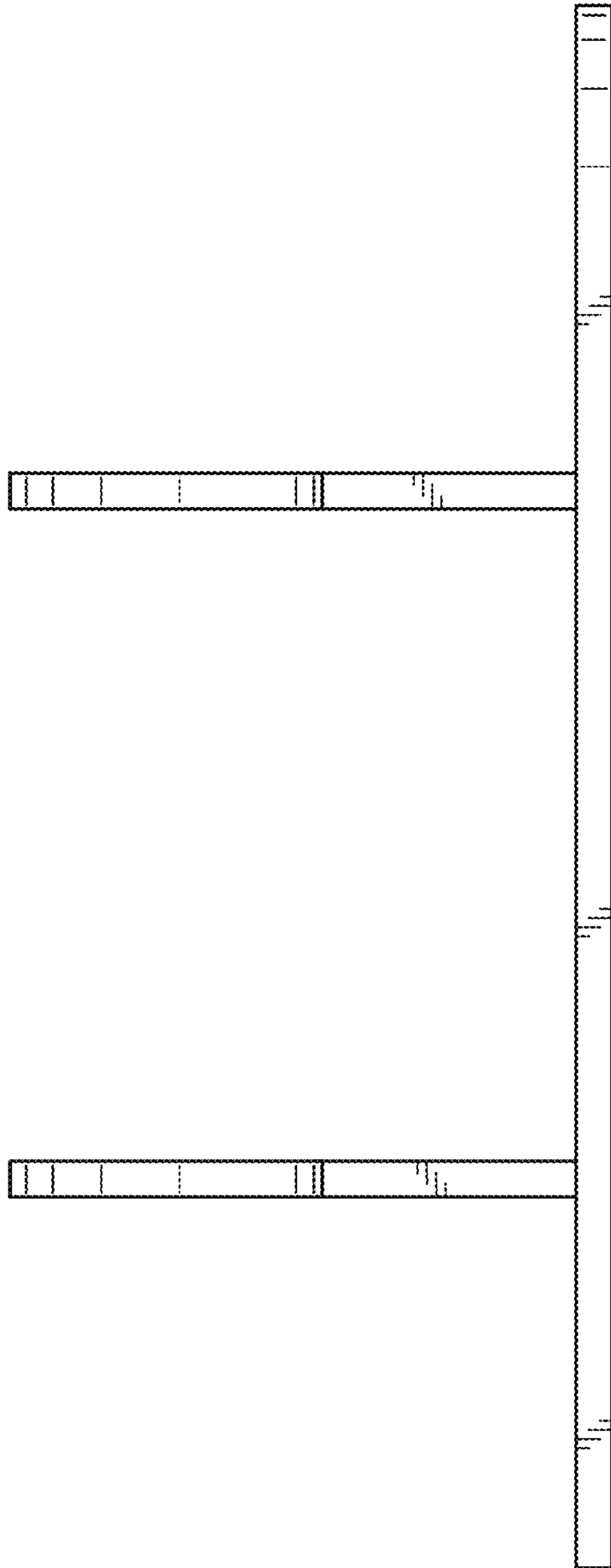

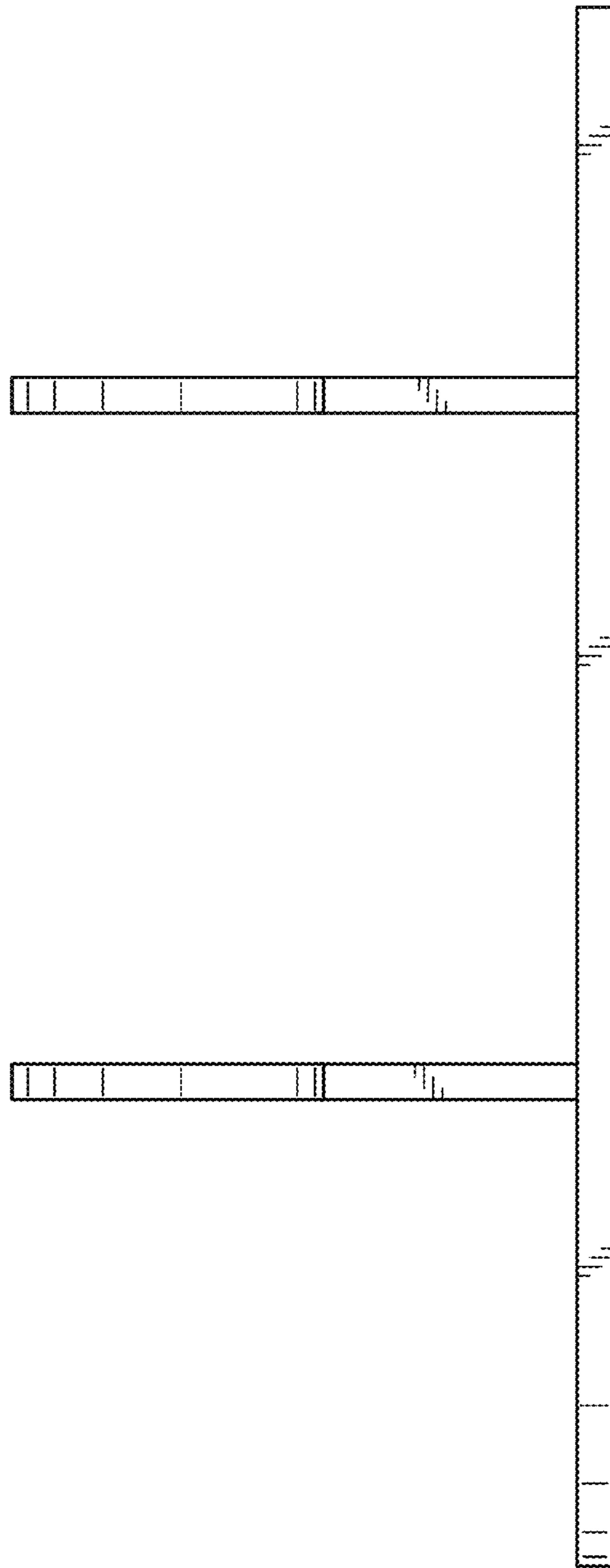

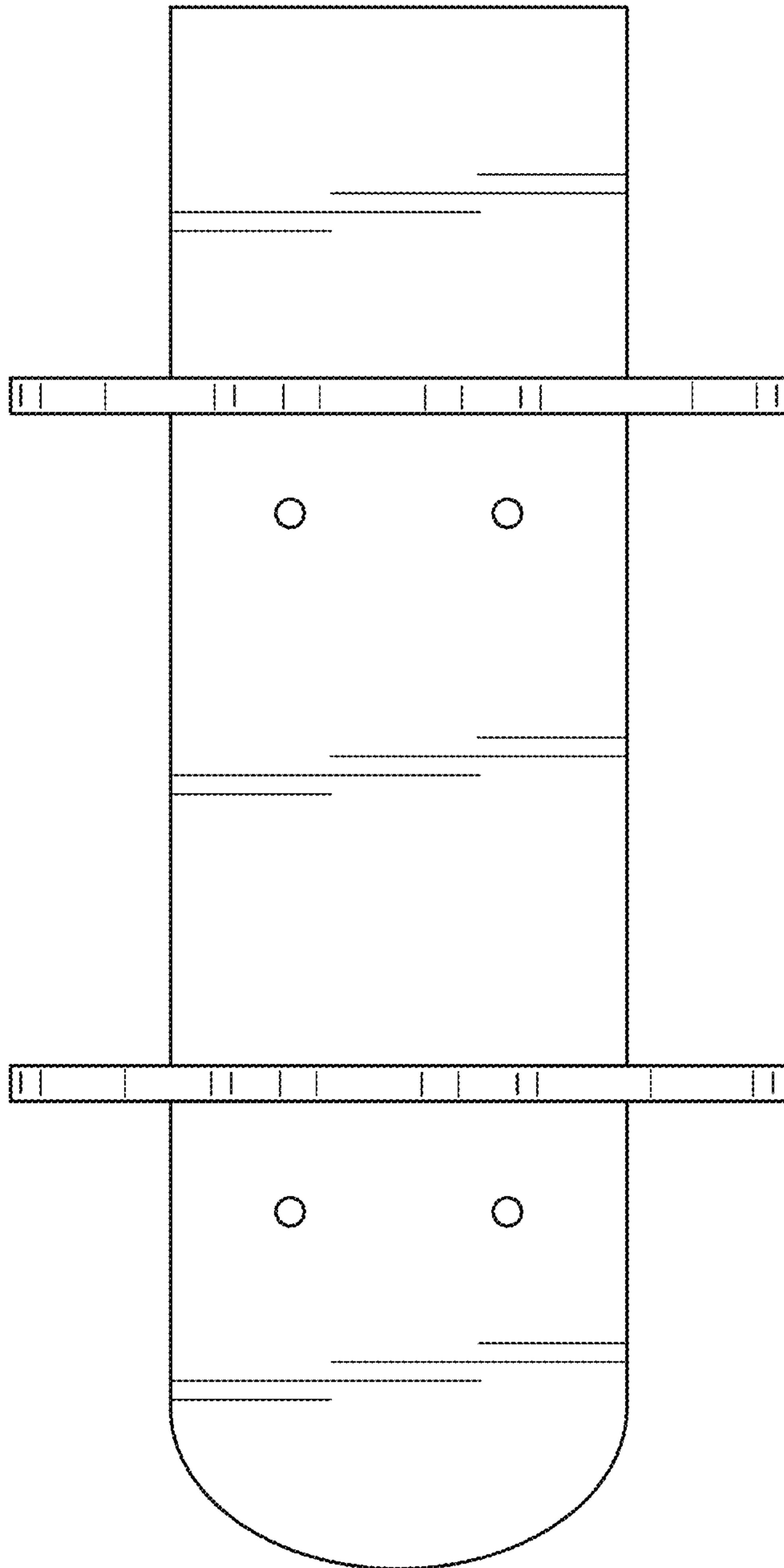

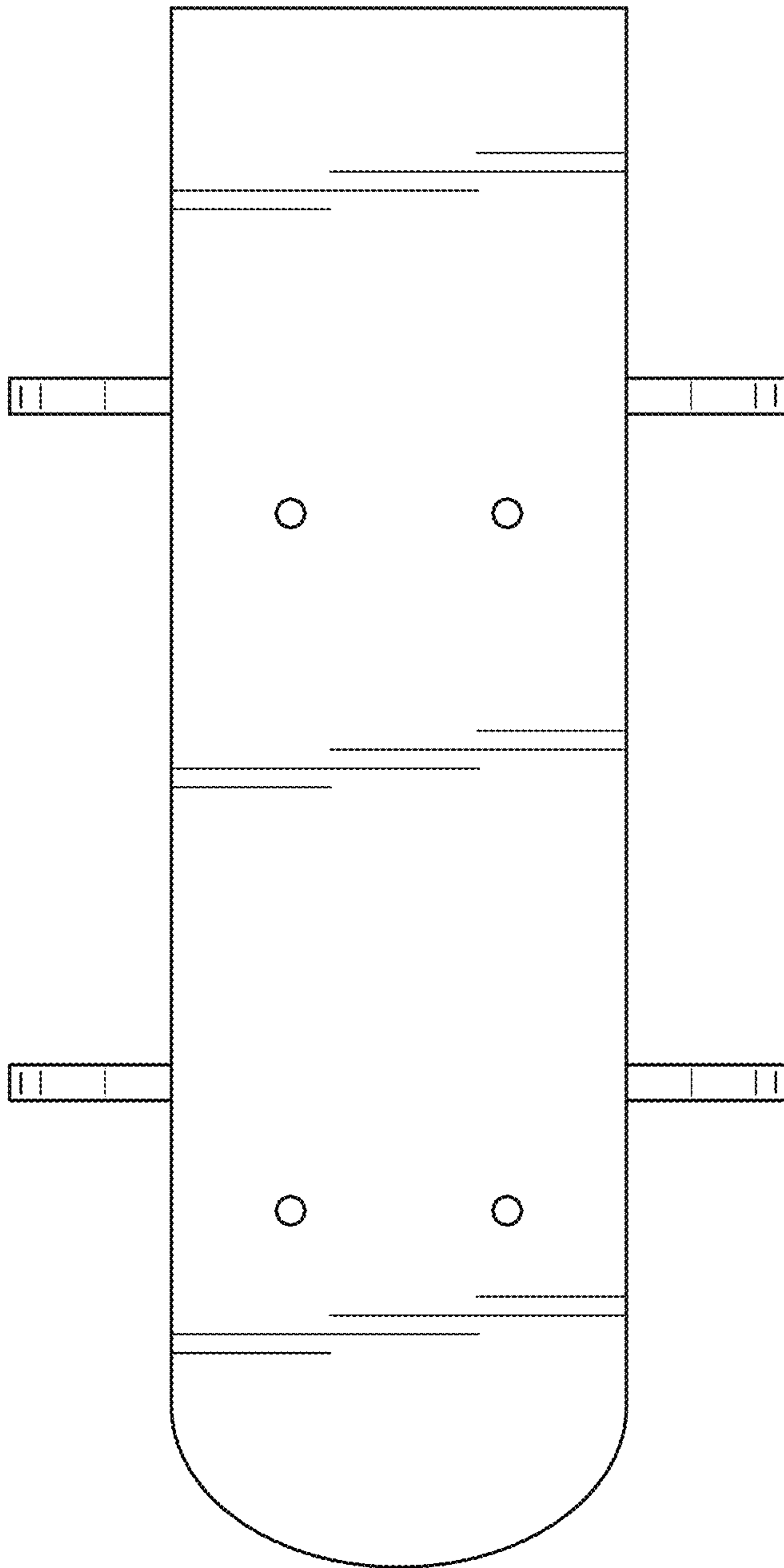
