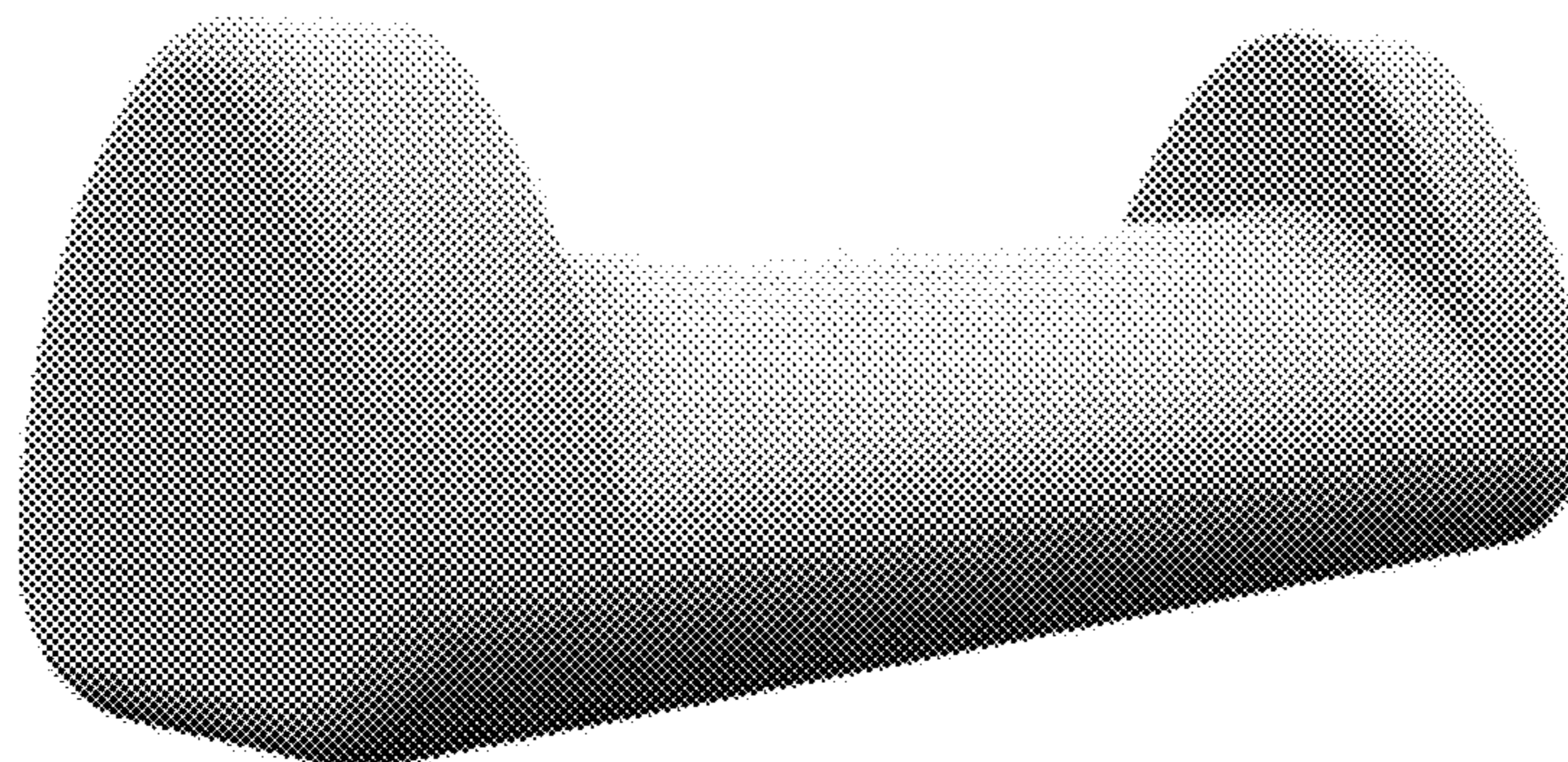
(57) **CLAIM**

I claim the ornamental design for the pillow, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a pillow, showing my new design.
FIG. 2 is a bottom view of the pillow.
FIG. 3 is a left side view of the pillow.
FIG. 4 is a right side view of the pillow.
FIG. 5 is a rear isometric view of the pillow.
FIG. 6 is a front isometric view of the pillow.
FIG. 7 is a top view of the pillow; and,
FIG. 8 is a rear view of the pillow.
The various shades of gray as well as the shadows and reflections represent surface contour and not any particular color or texture.

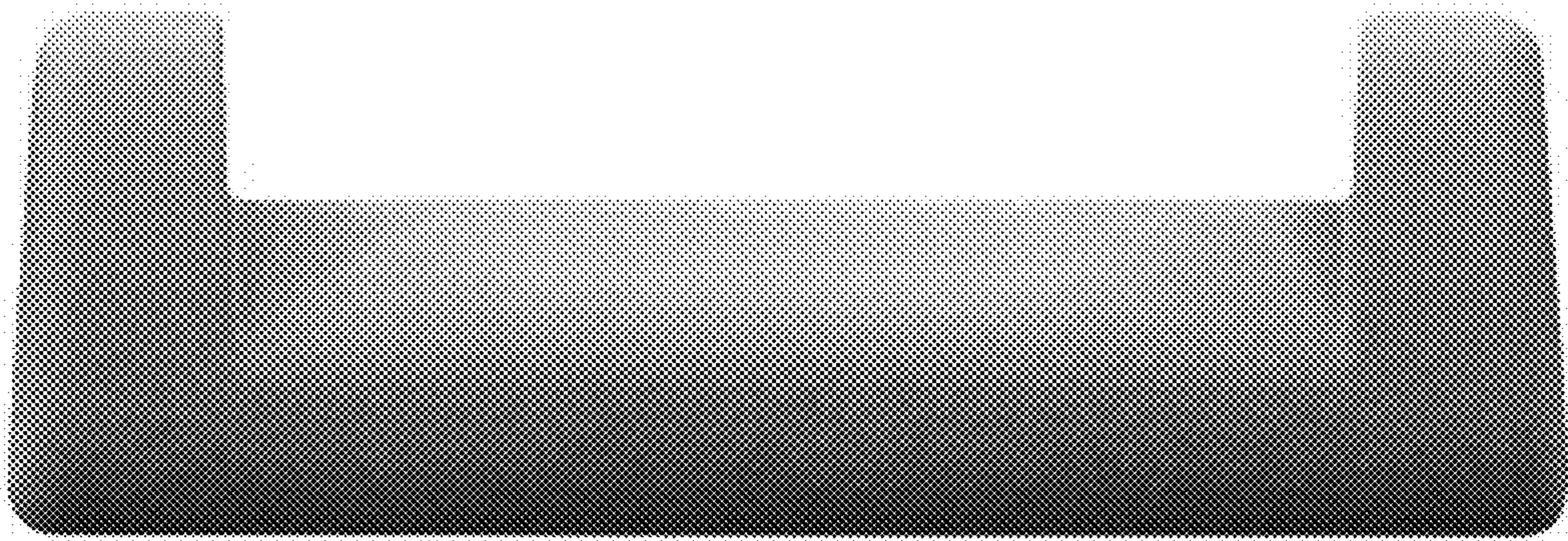

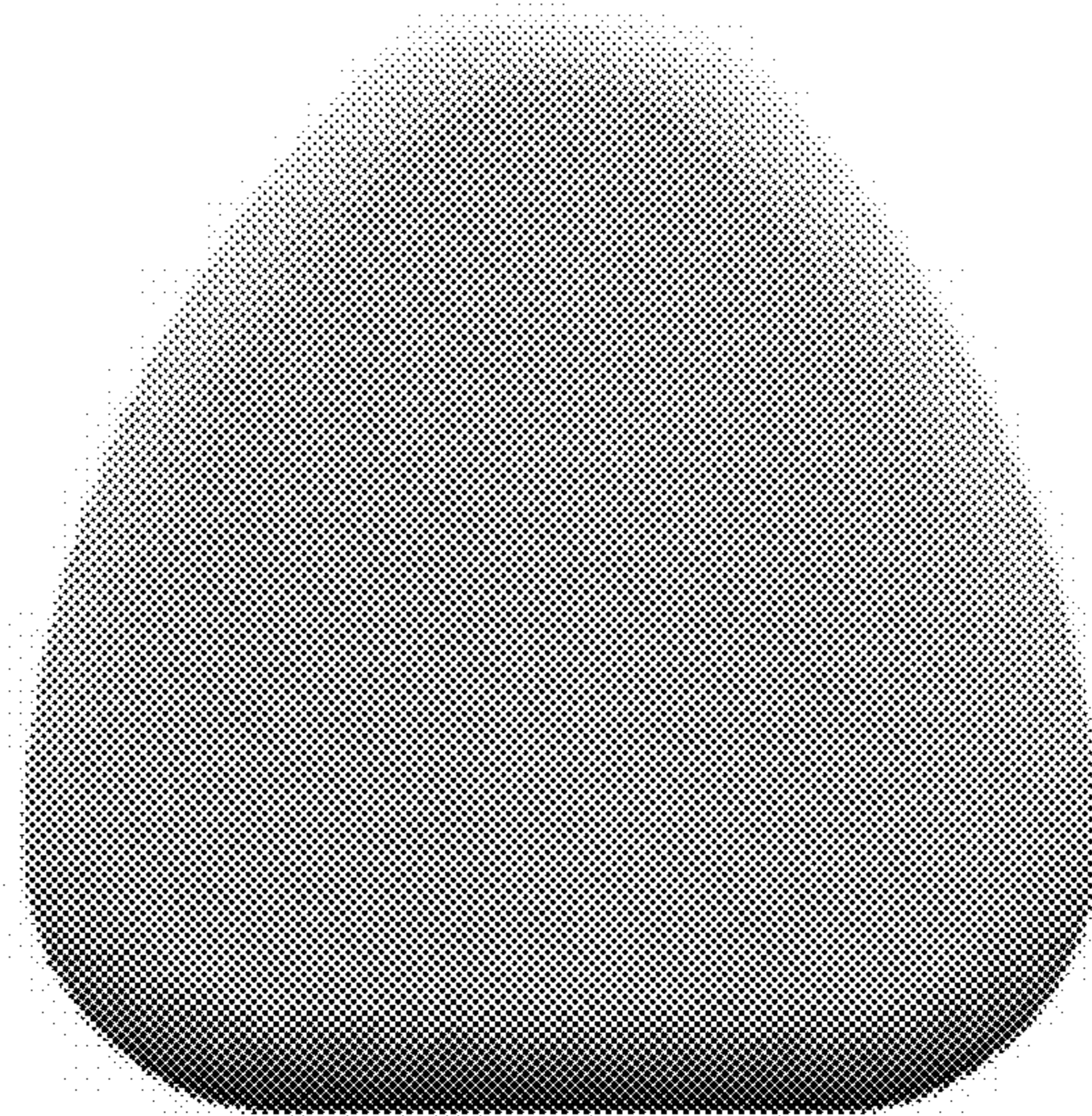

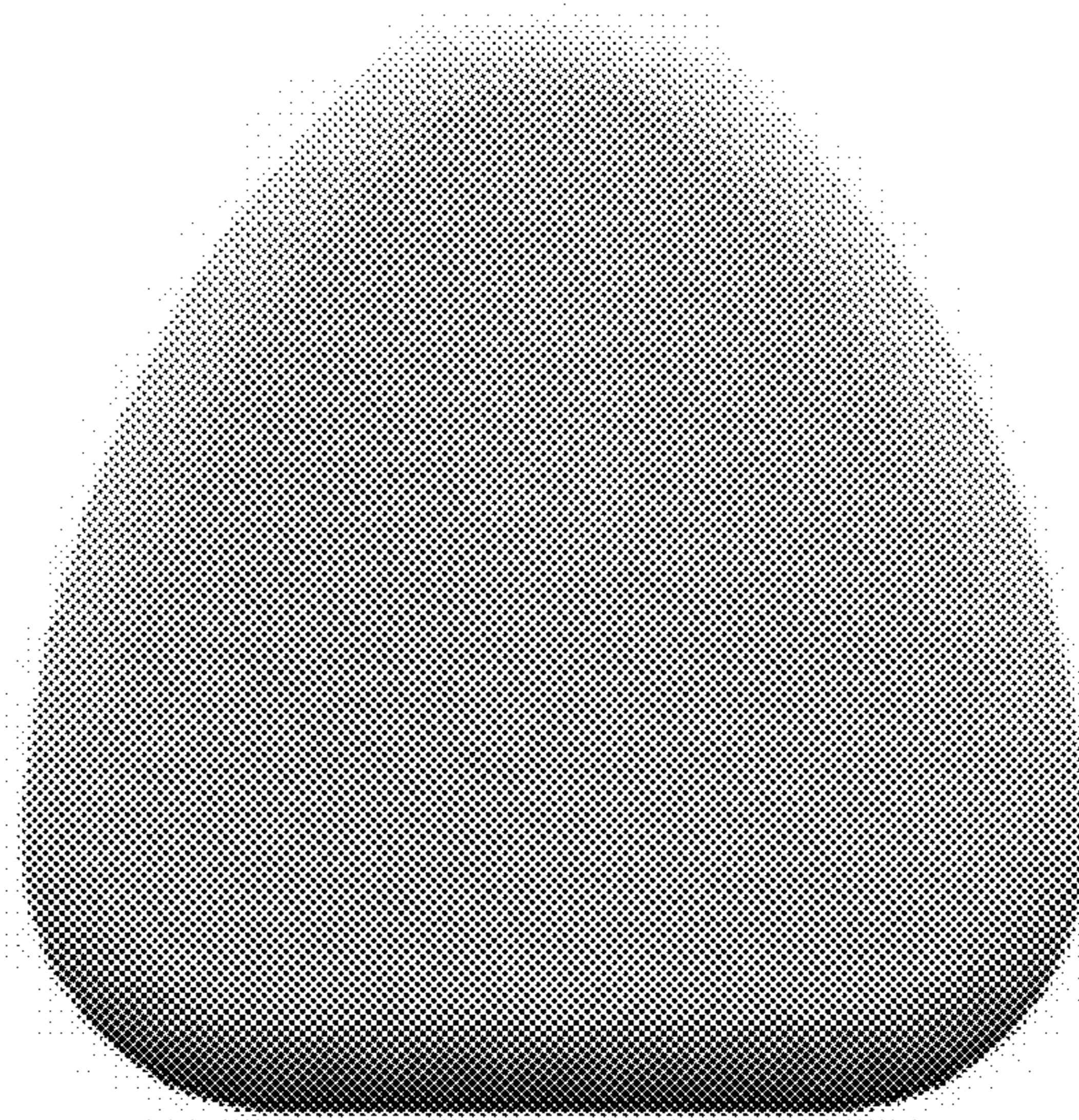

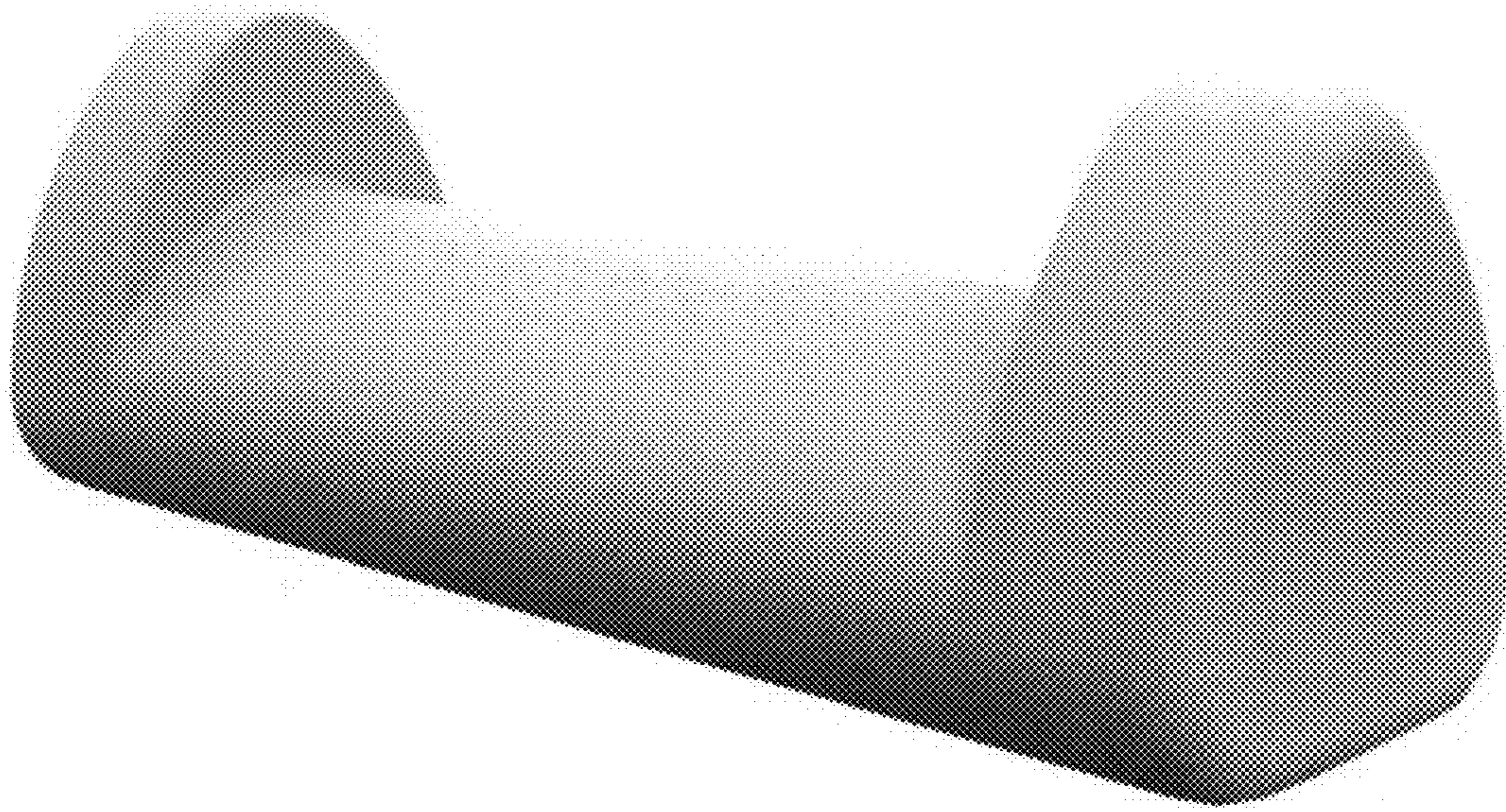

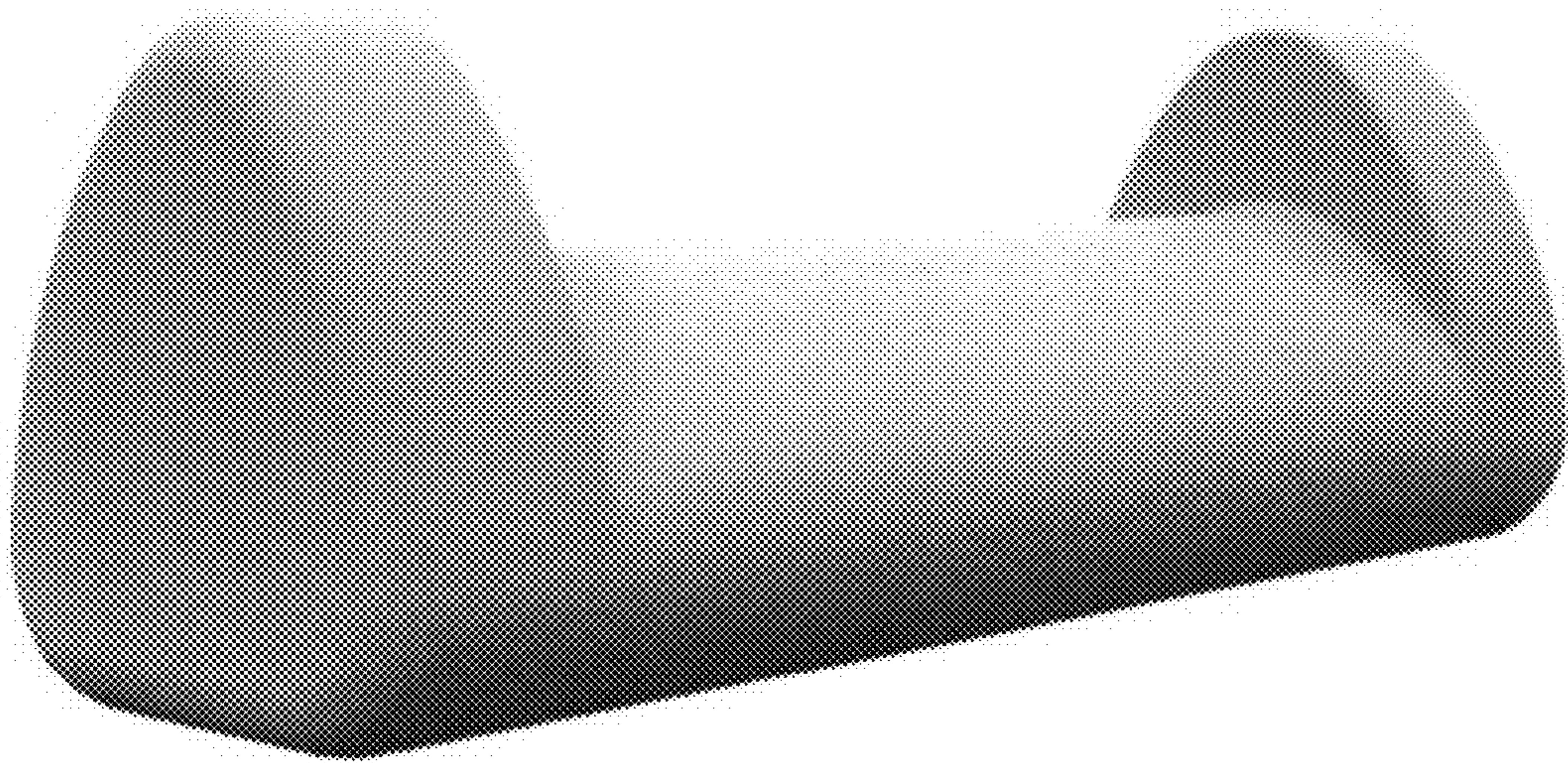

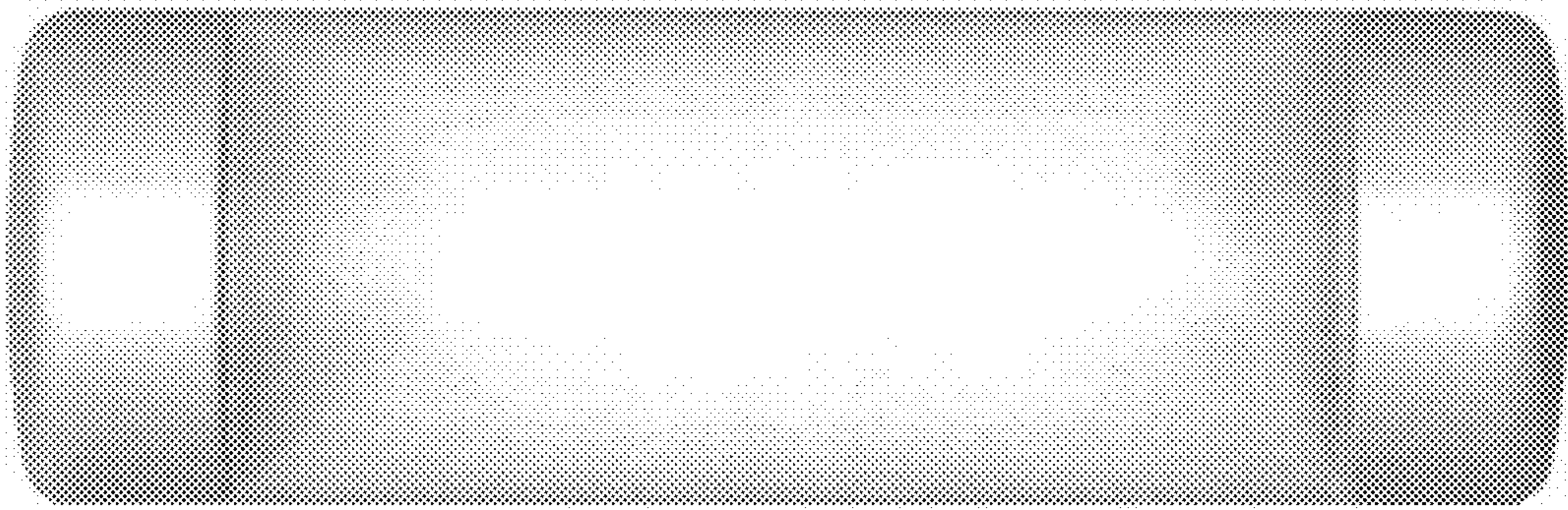

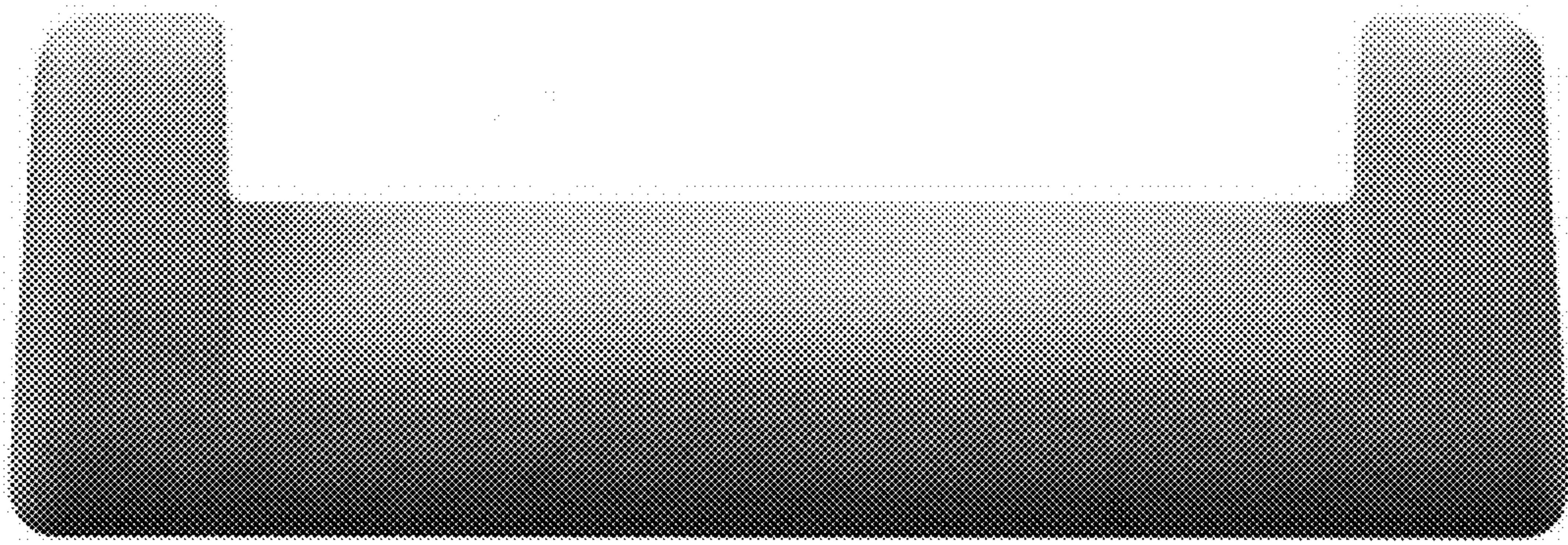
