DESCRIPTION

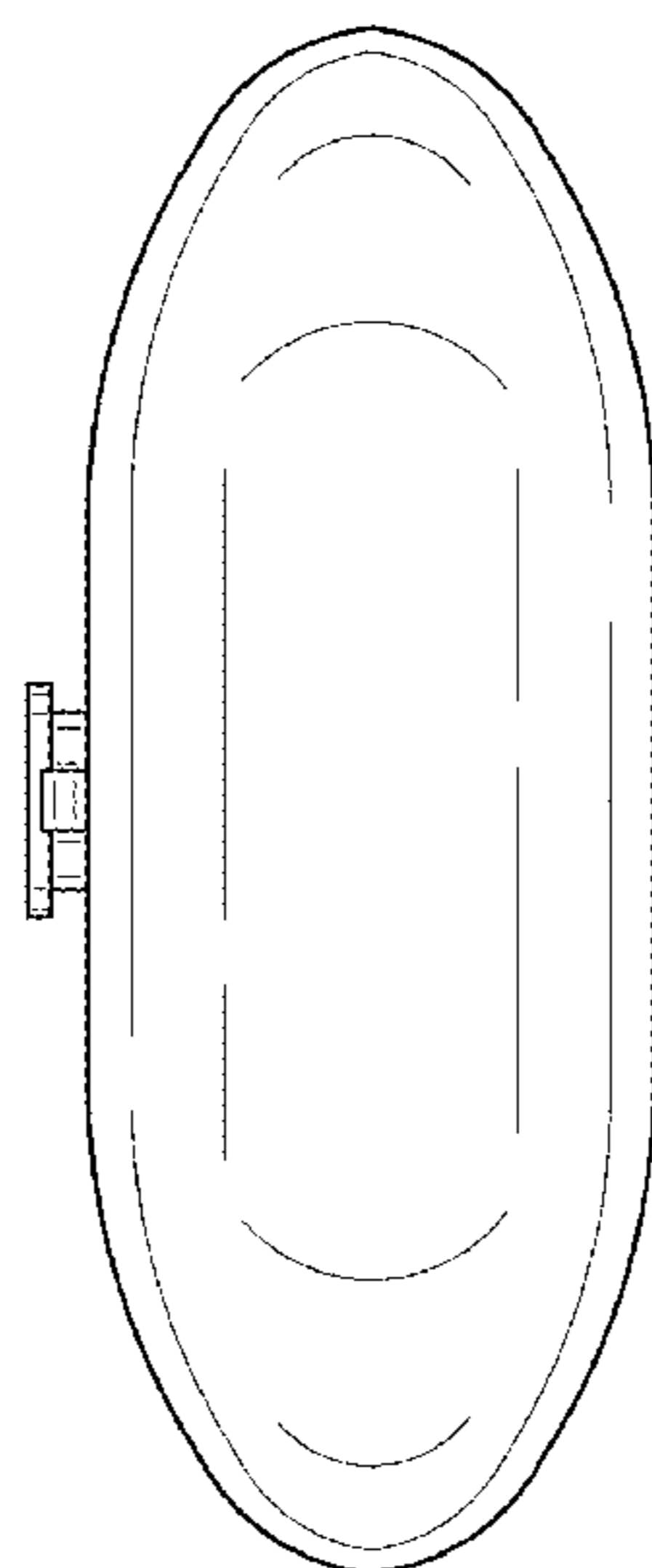
FIG. 1 is a front view of a inflatable pillow showing my new design;

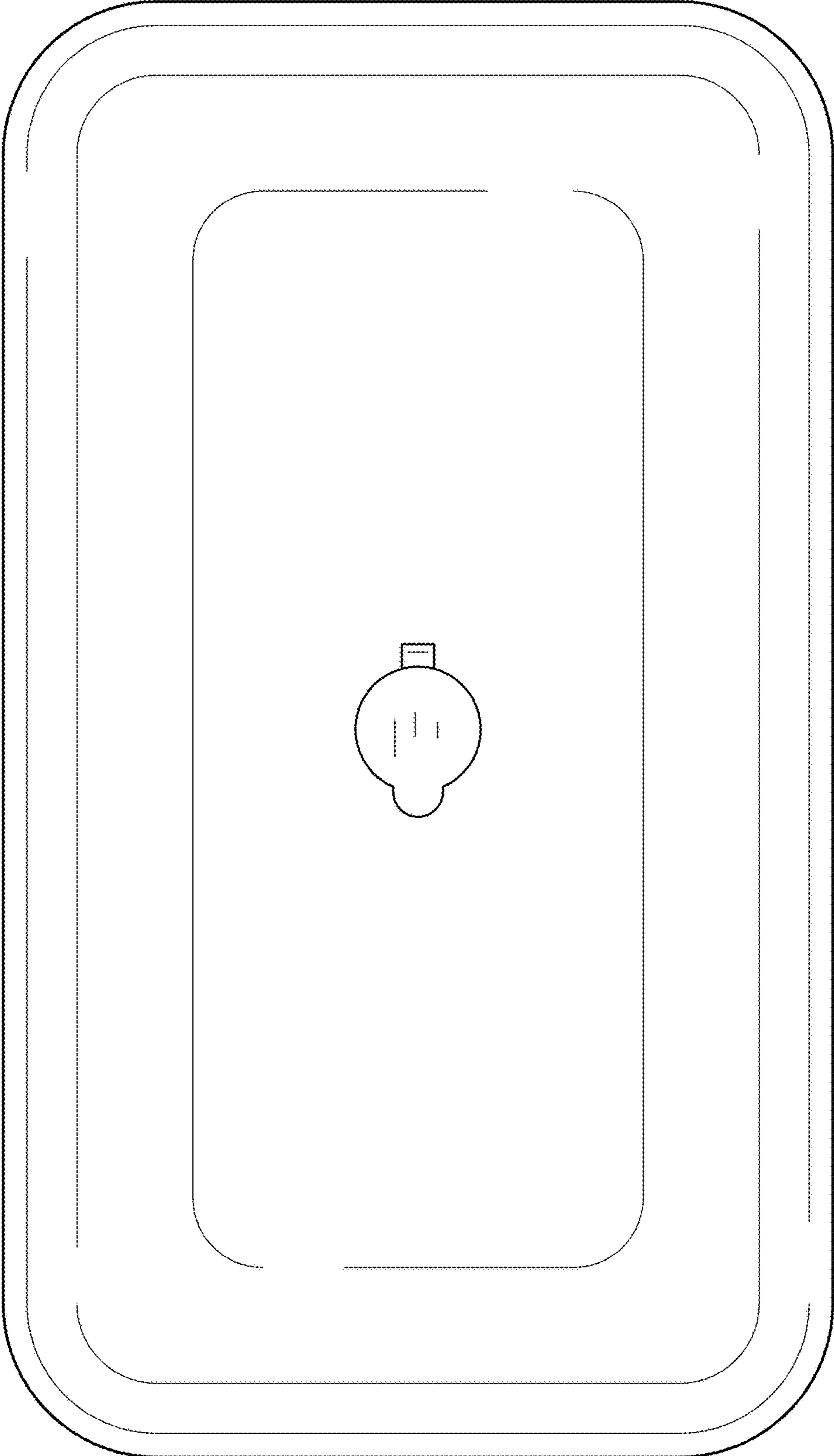

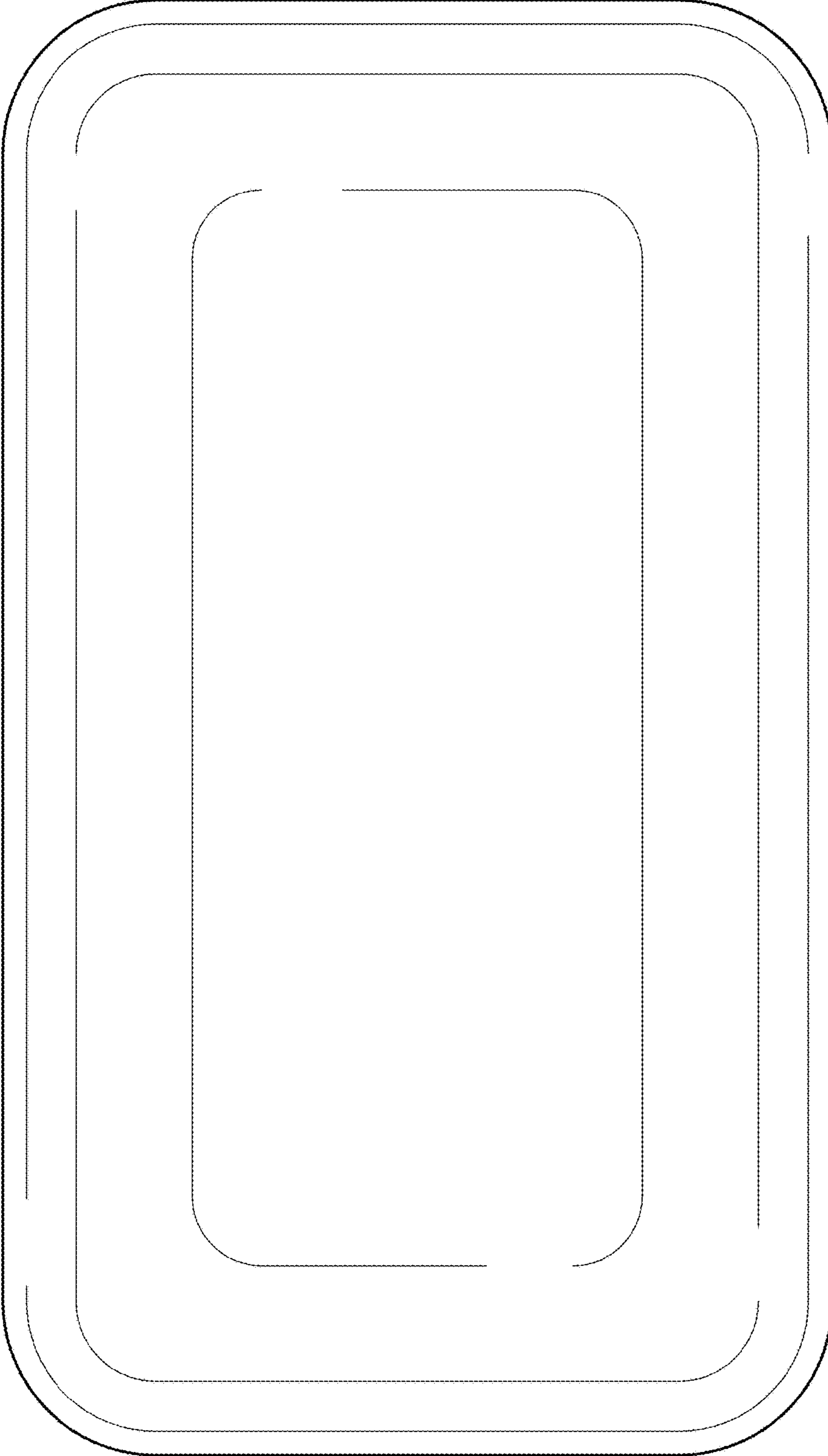

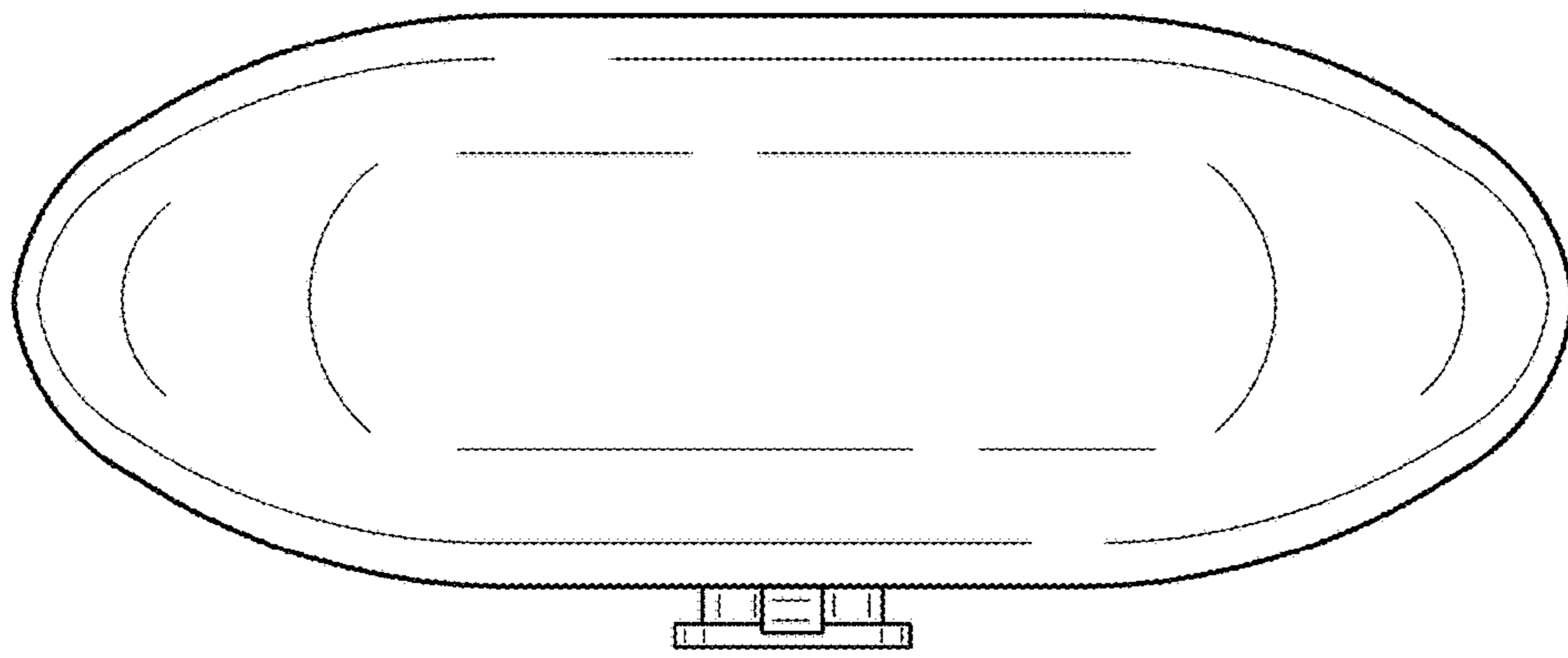

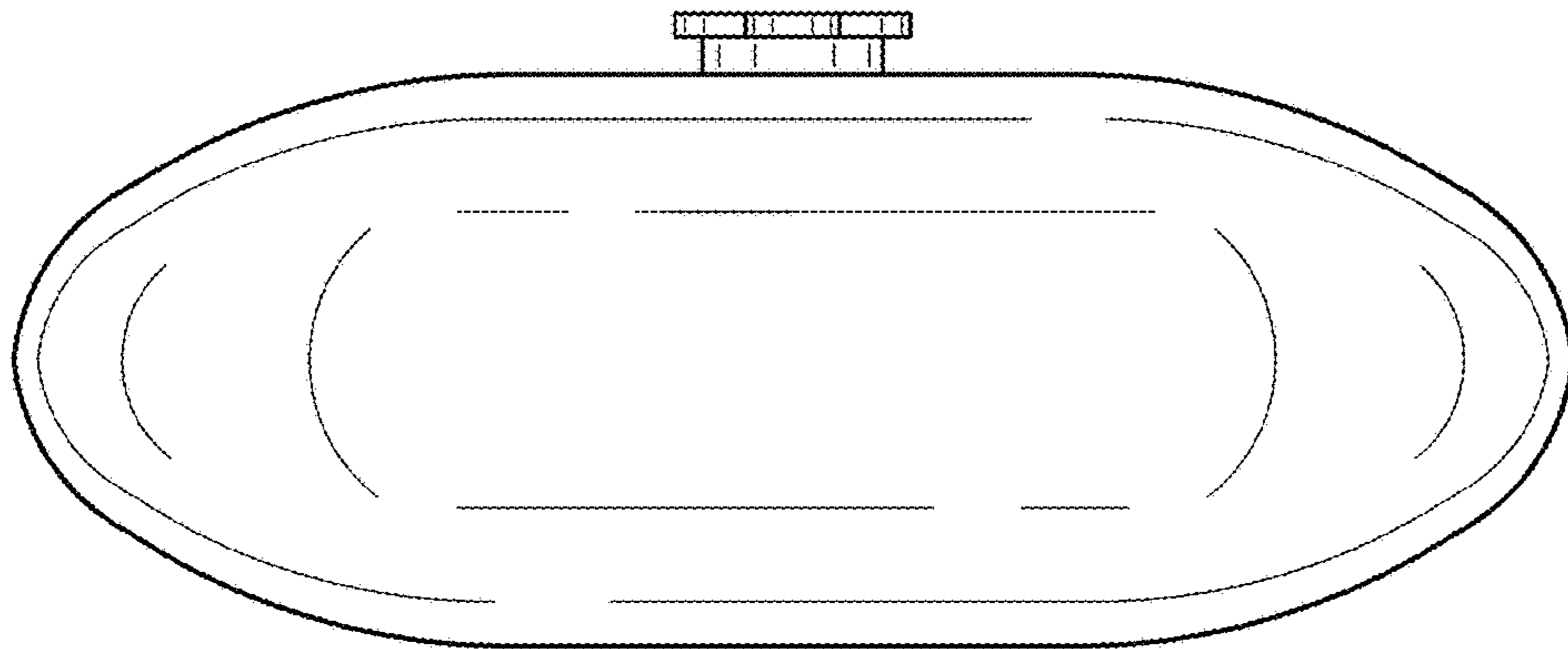

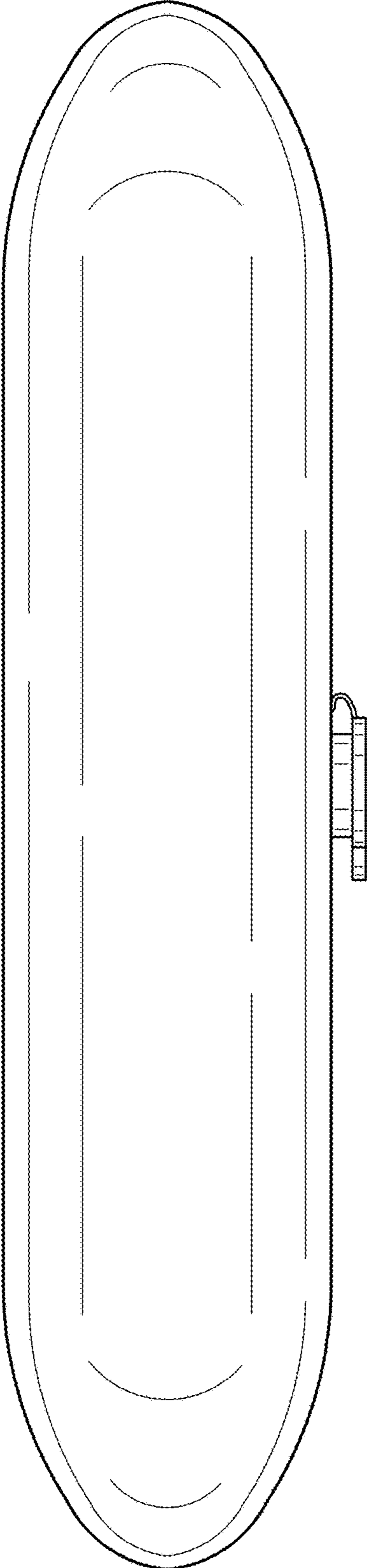
