FIG. 1 is a front perspective view of a first embodiment of a bottle, showing my design;

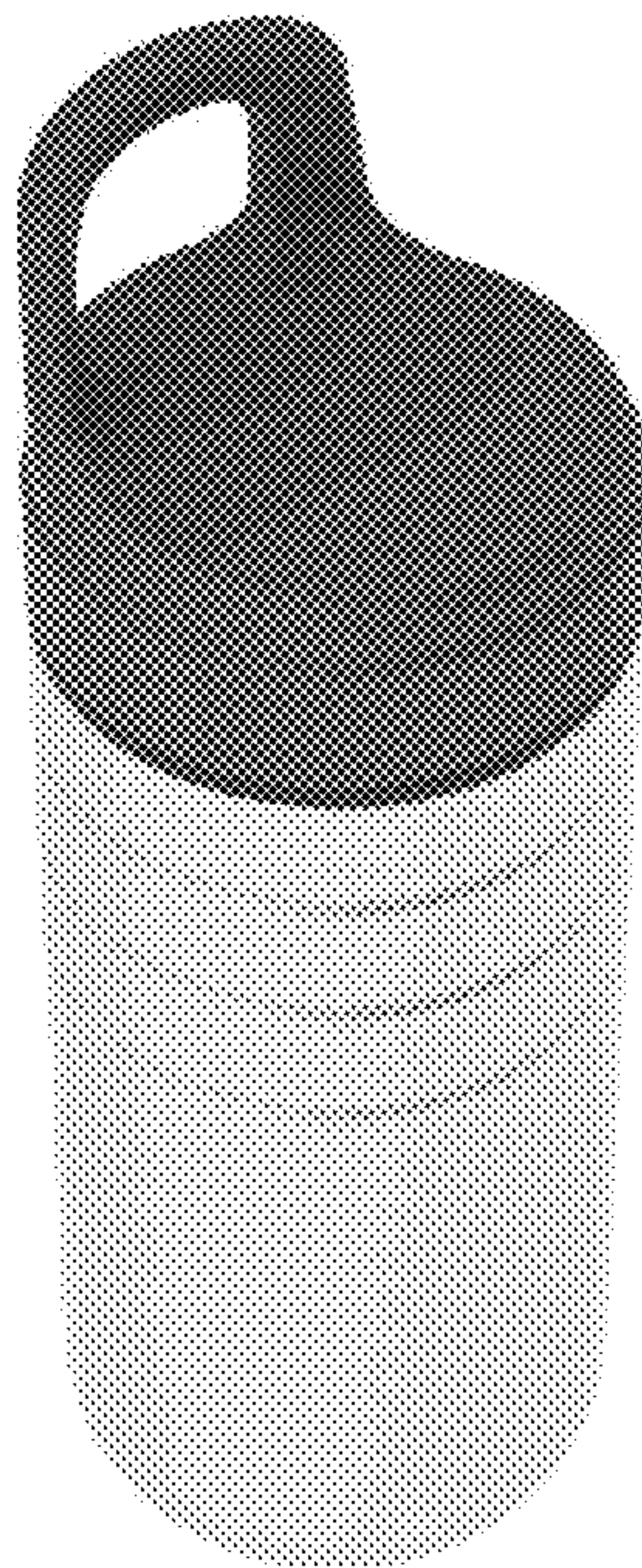
FIG. 2 is a rear perspective view thereof;

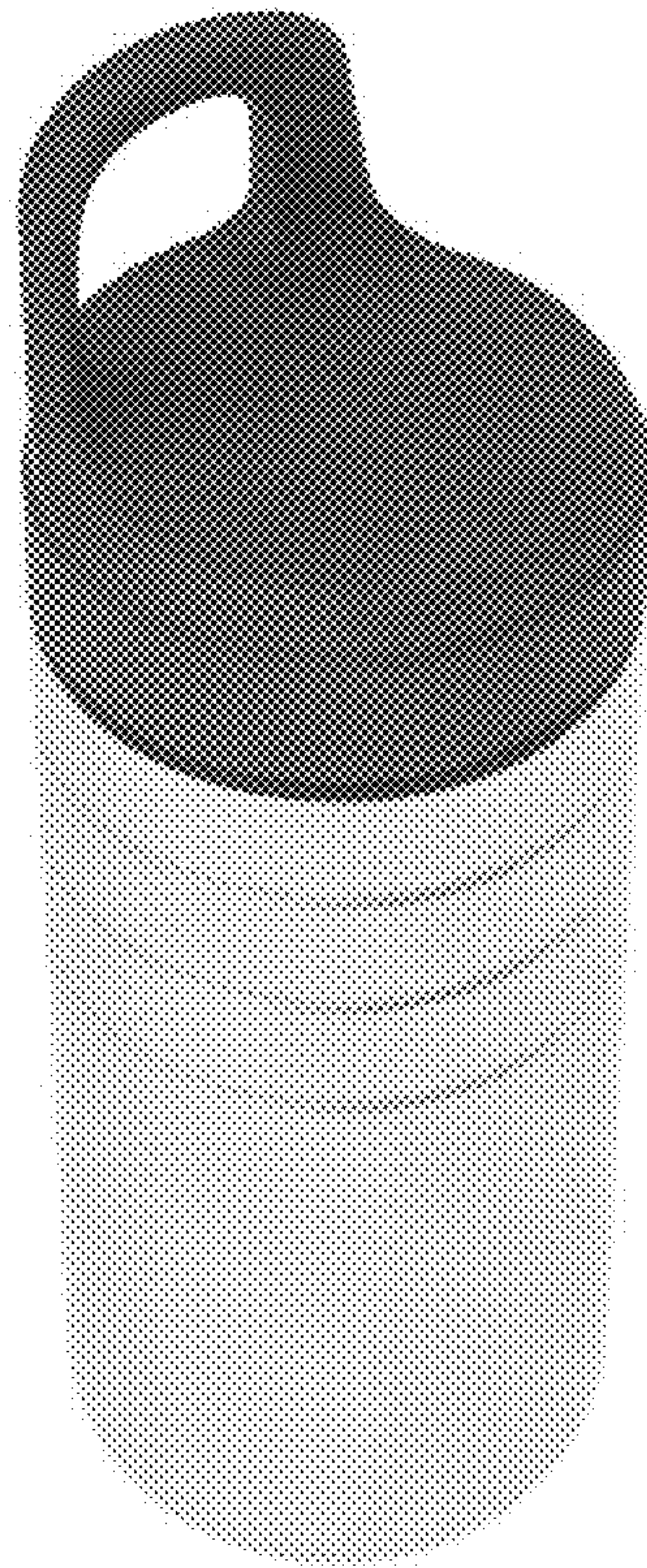

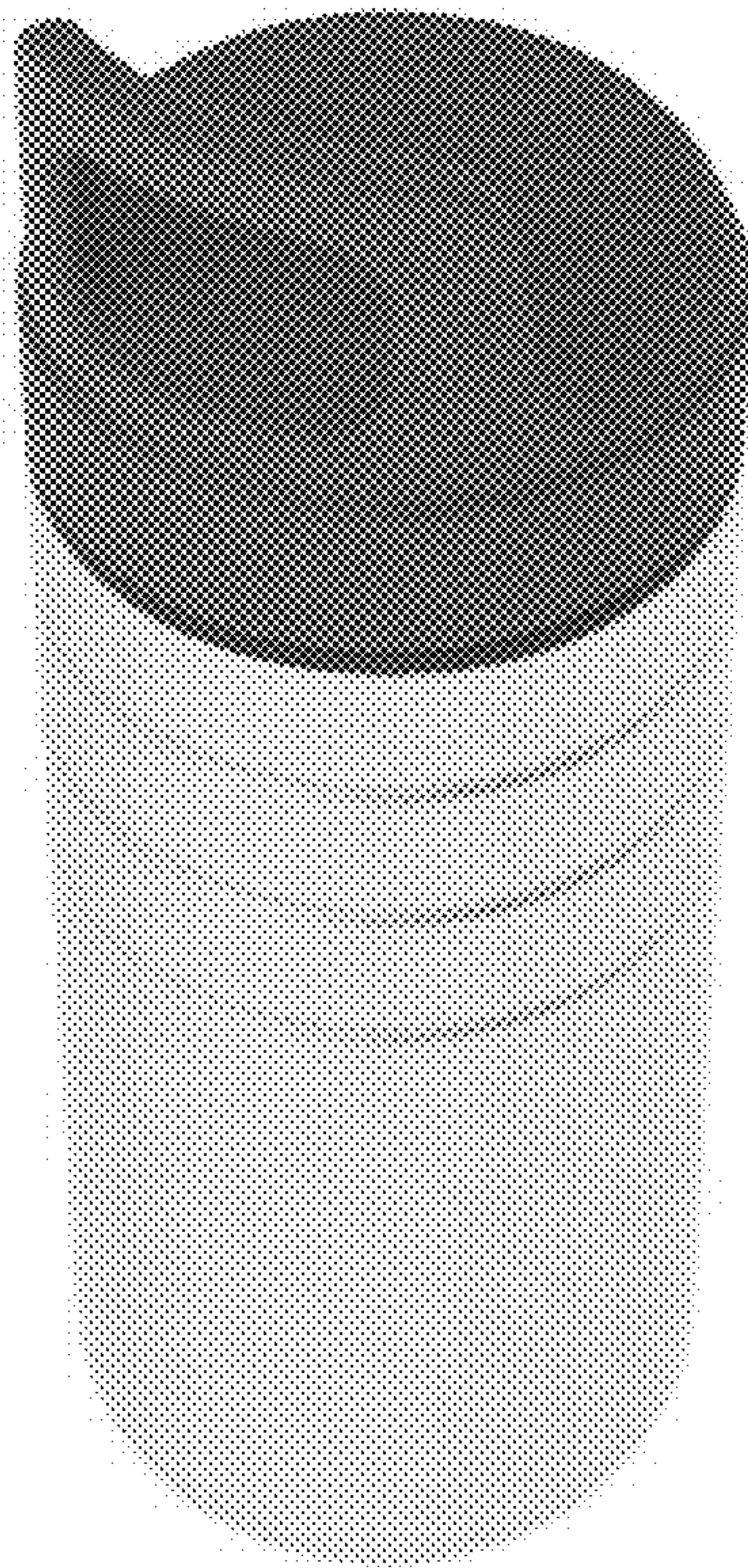

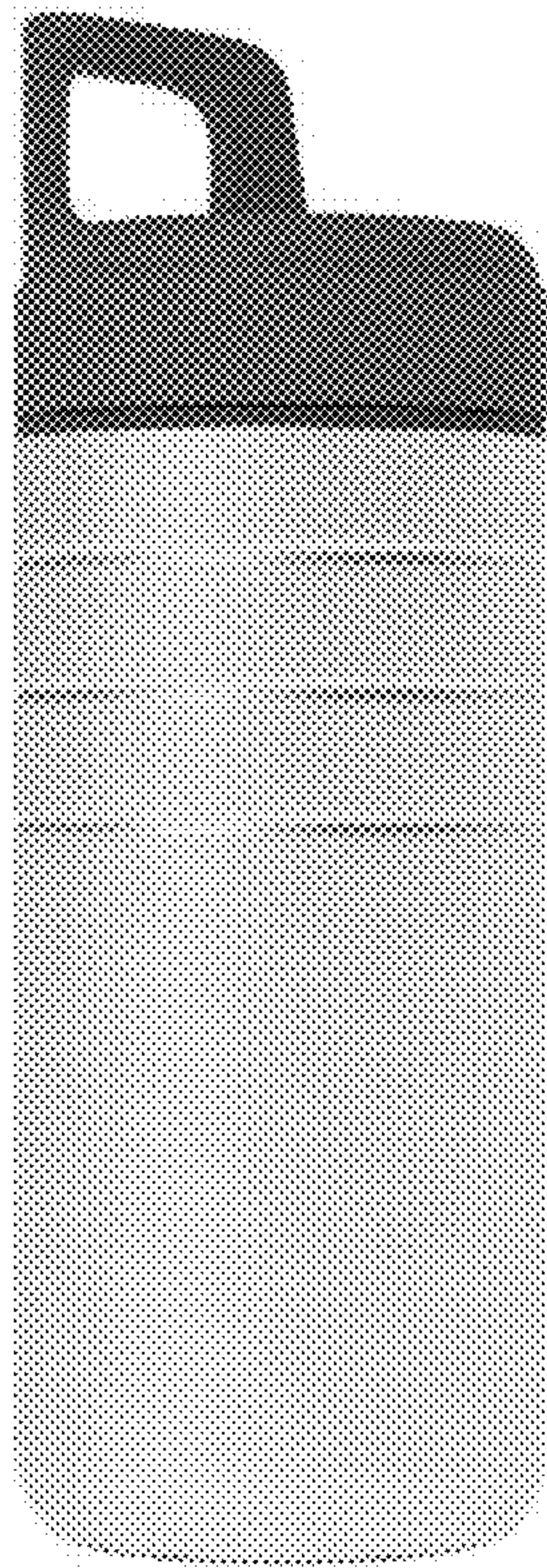

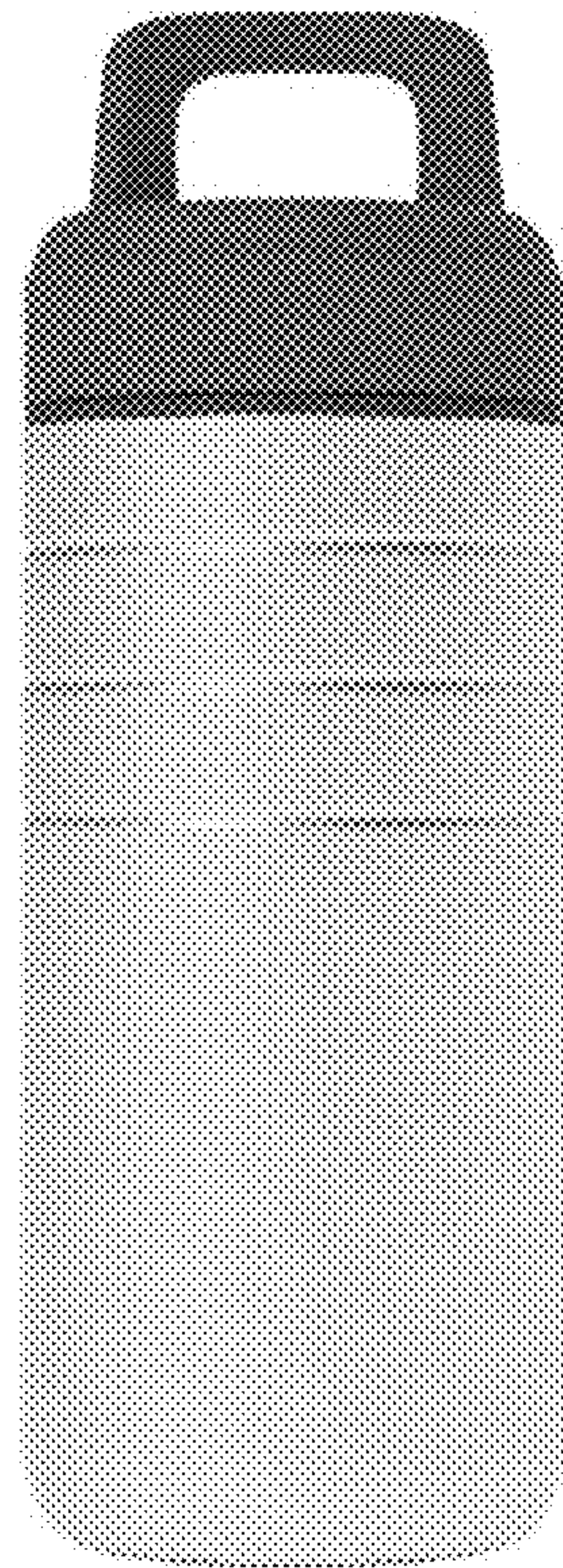
