DESCRIPTION

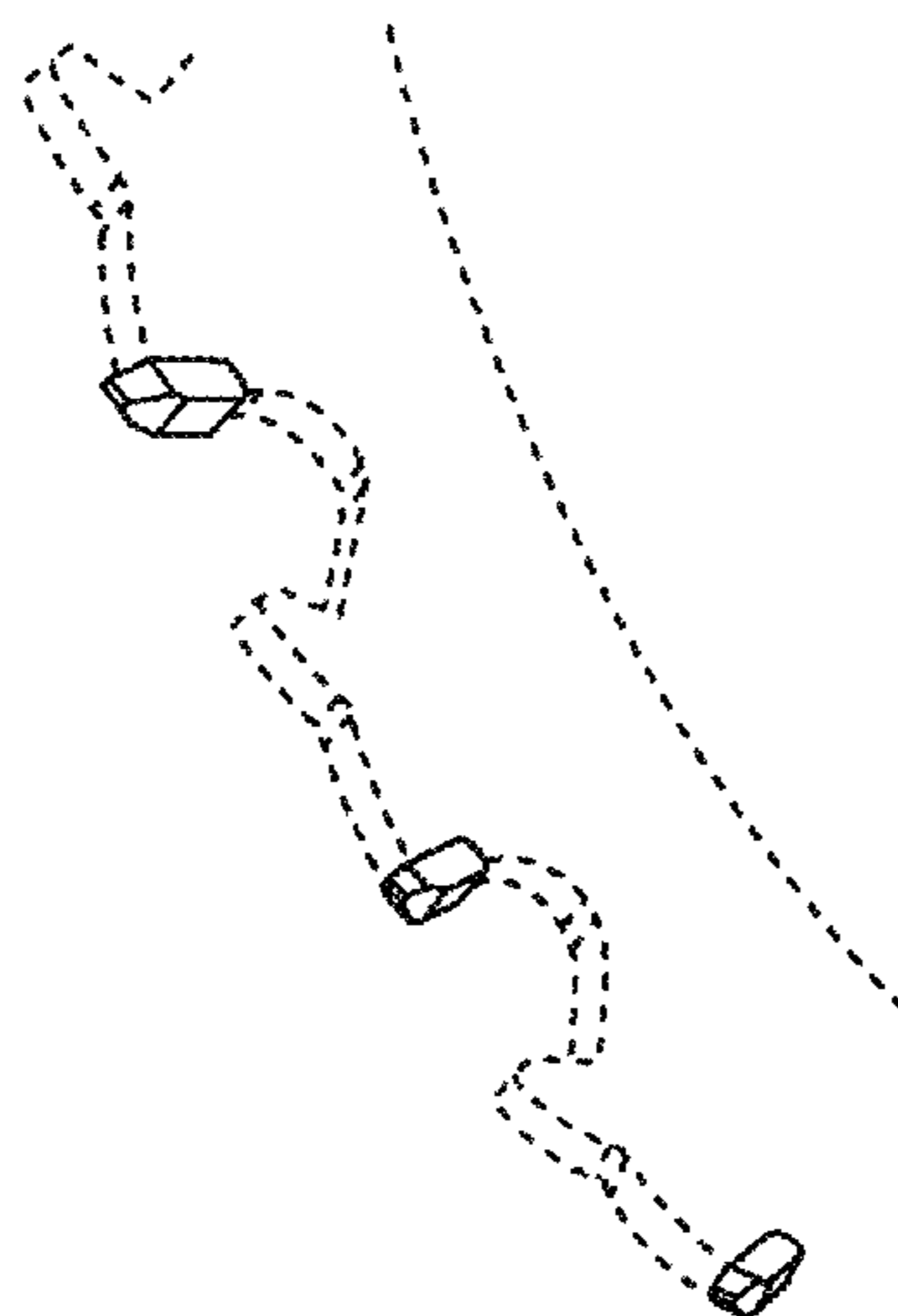
FIG. 1 is a perspective view of a tip geometry showing my new design;

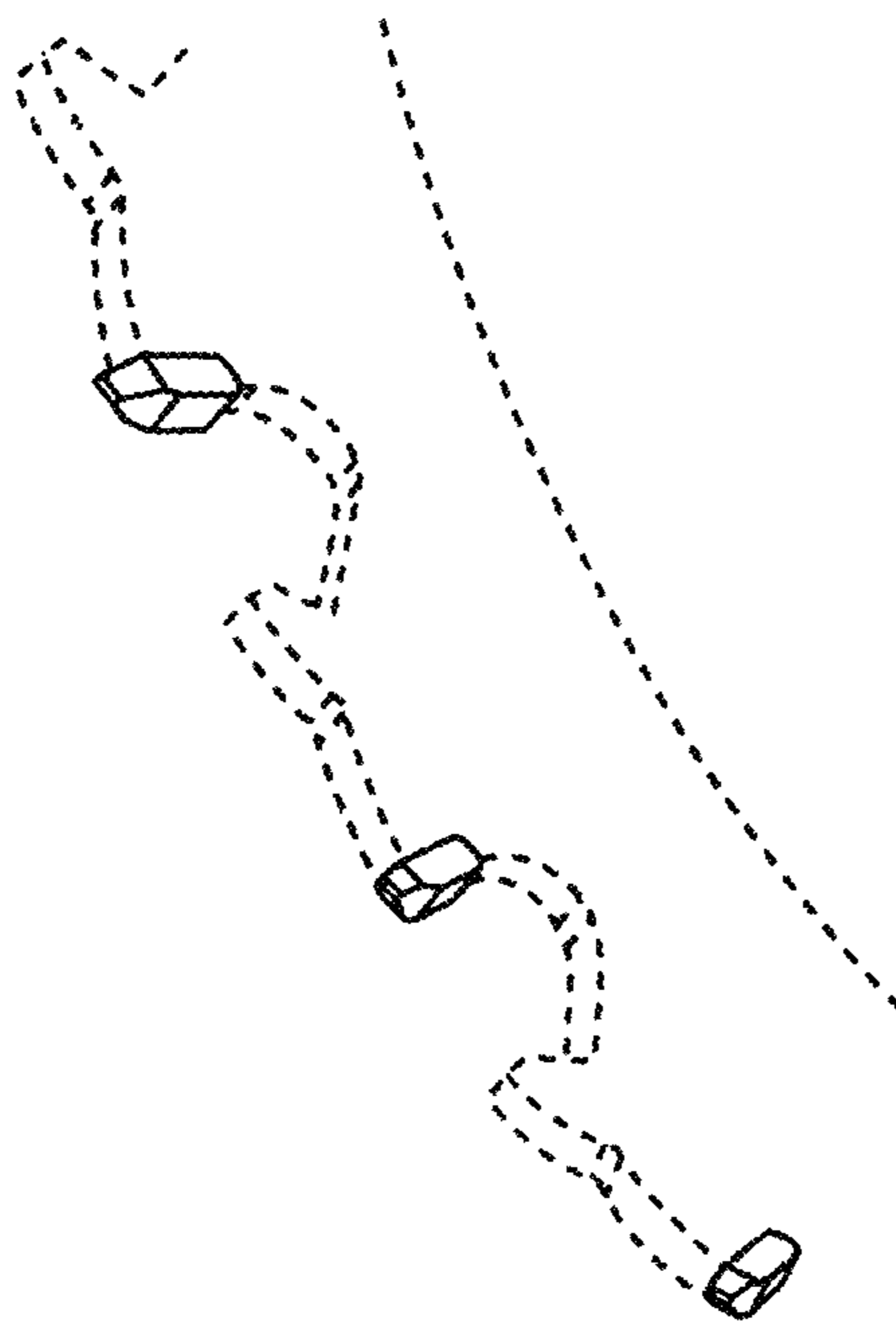

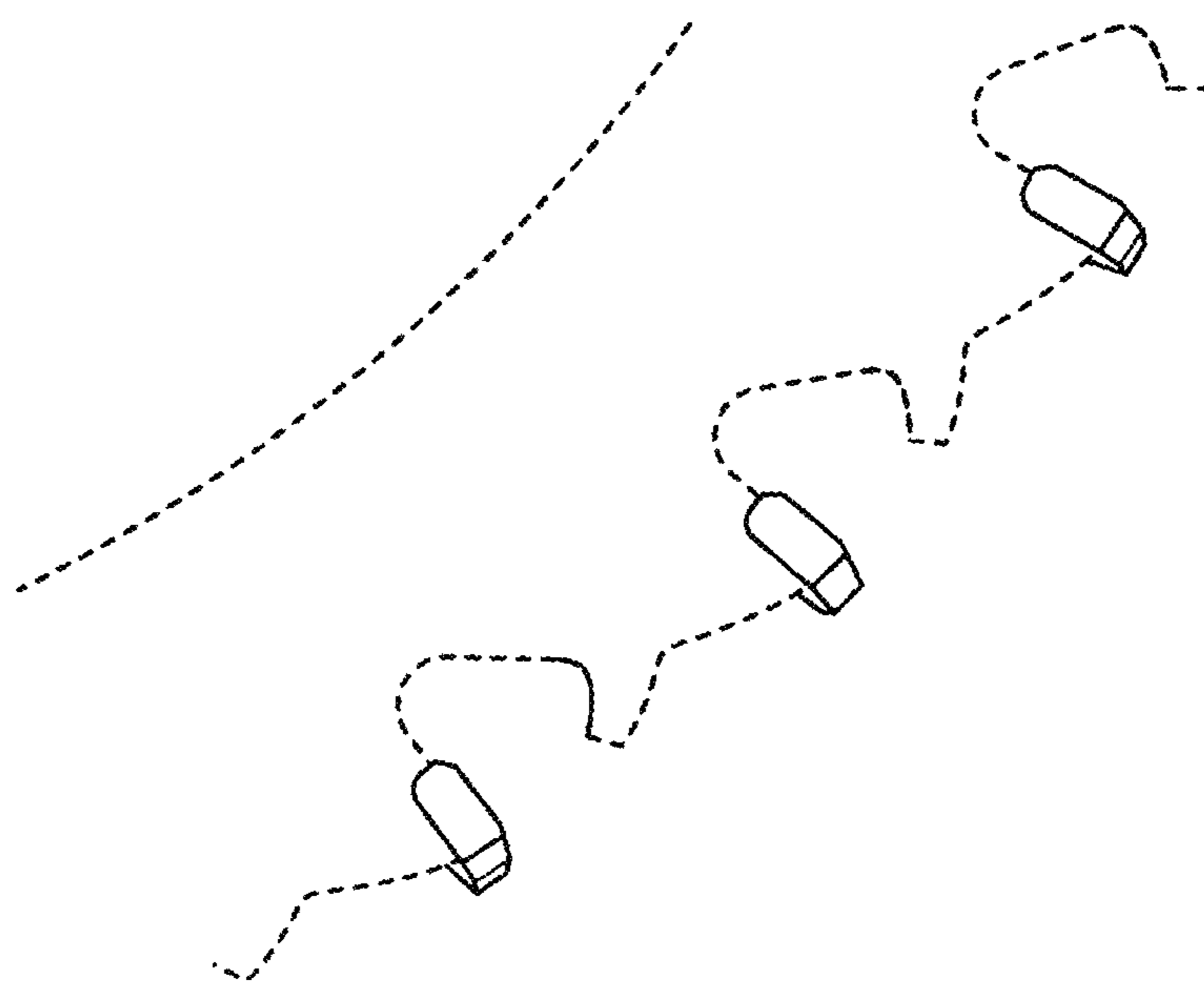

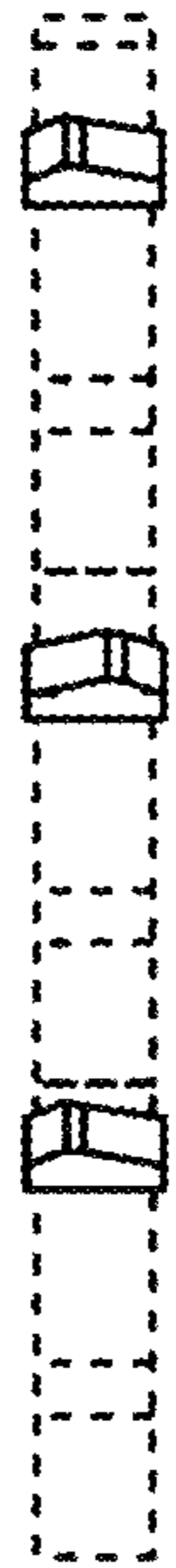

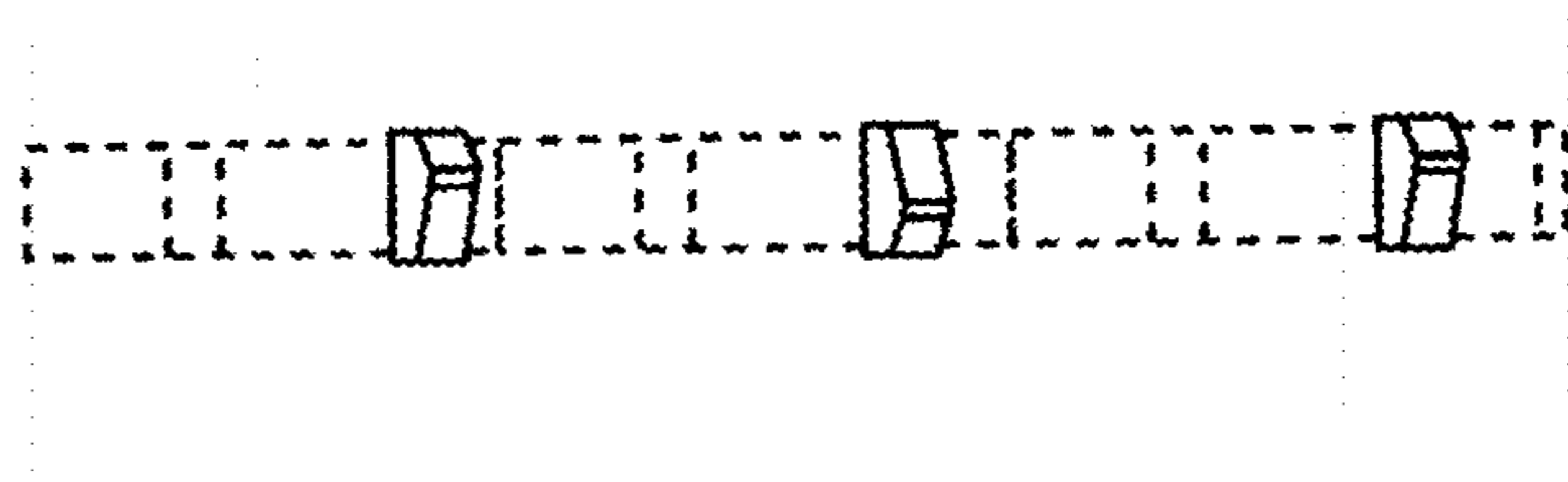
