DESCRIPTION

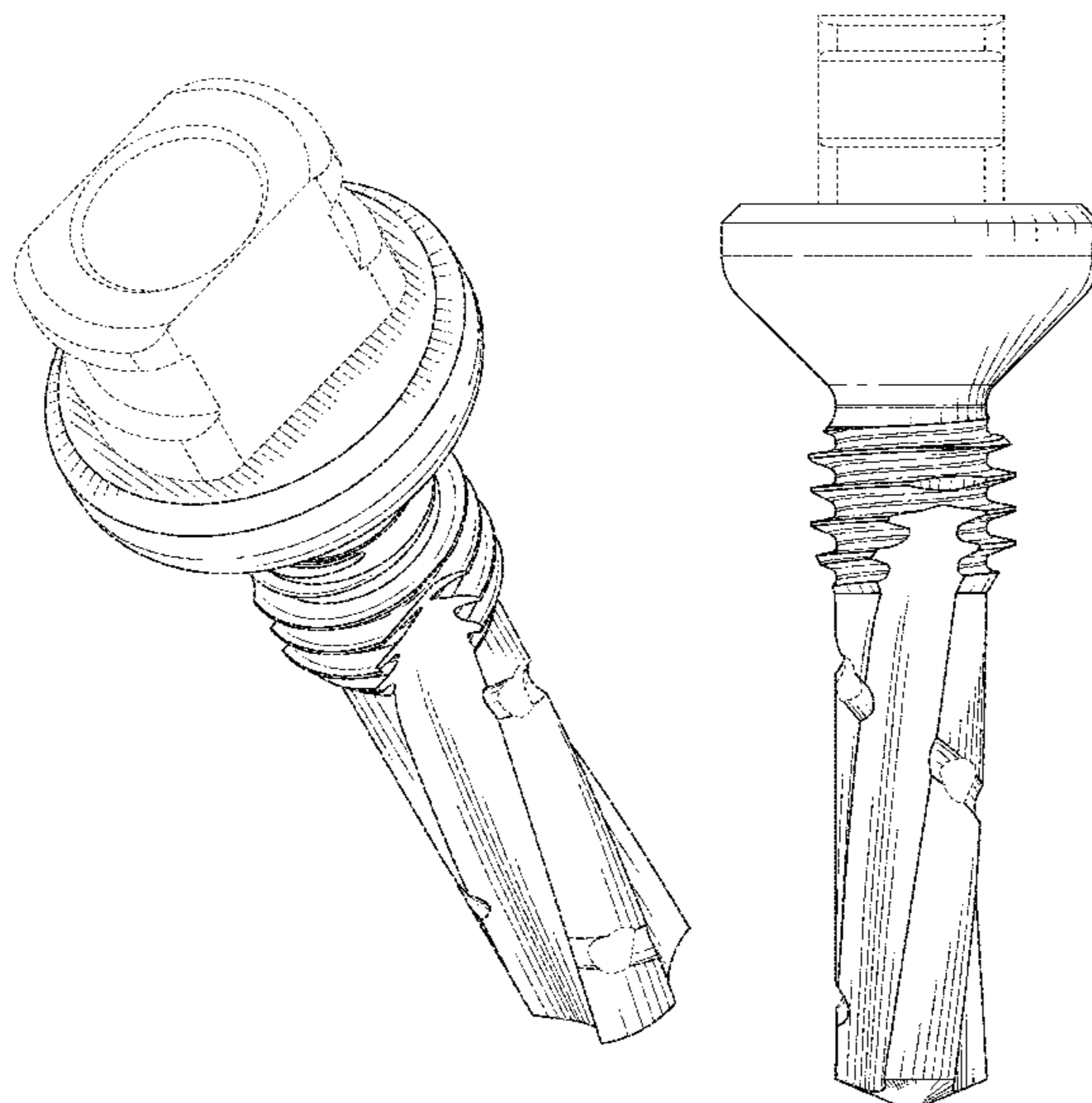

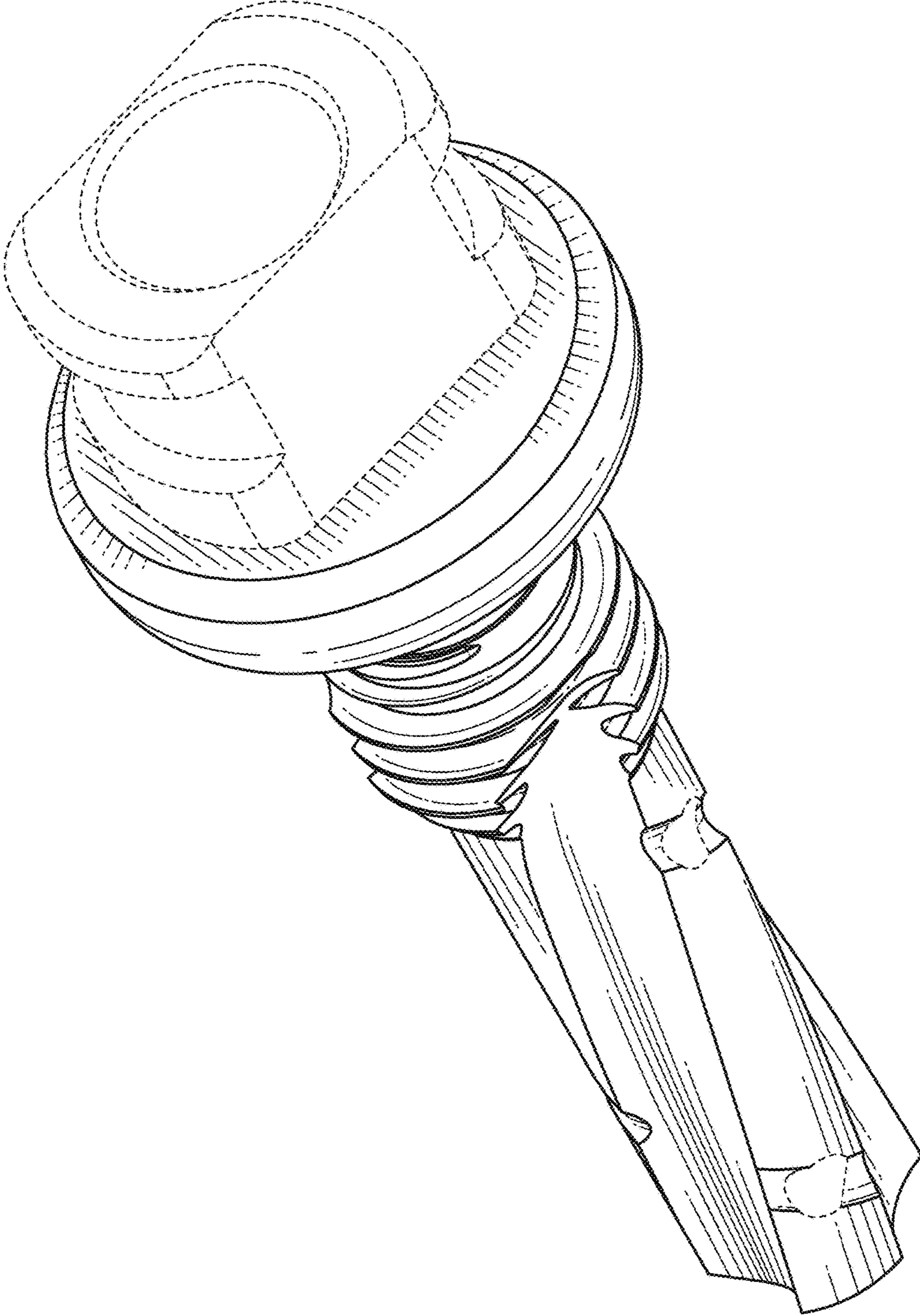

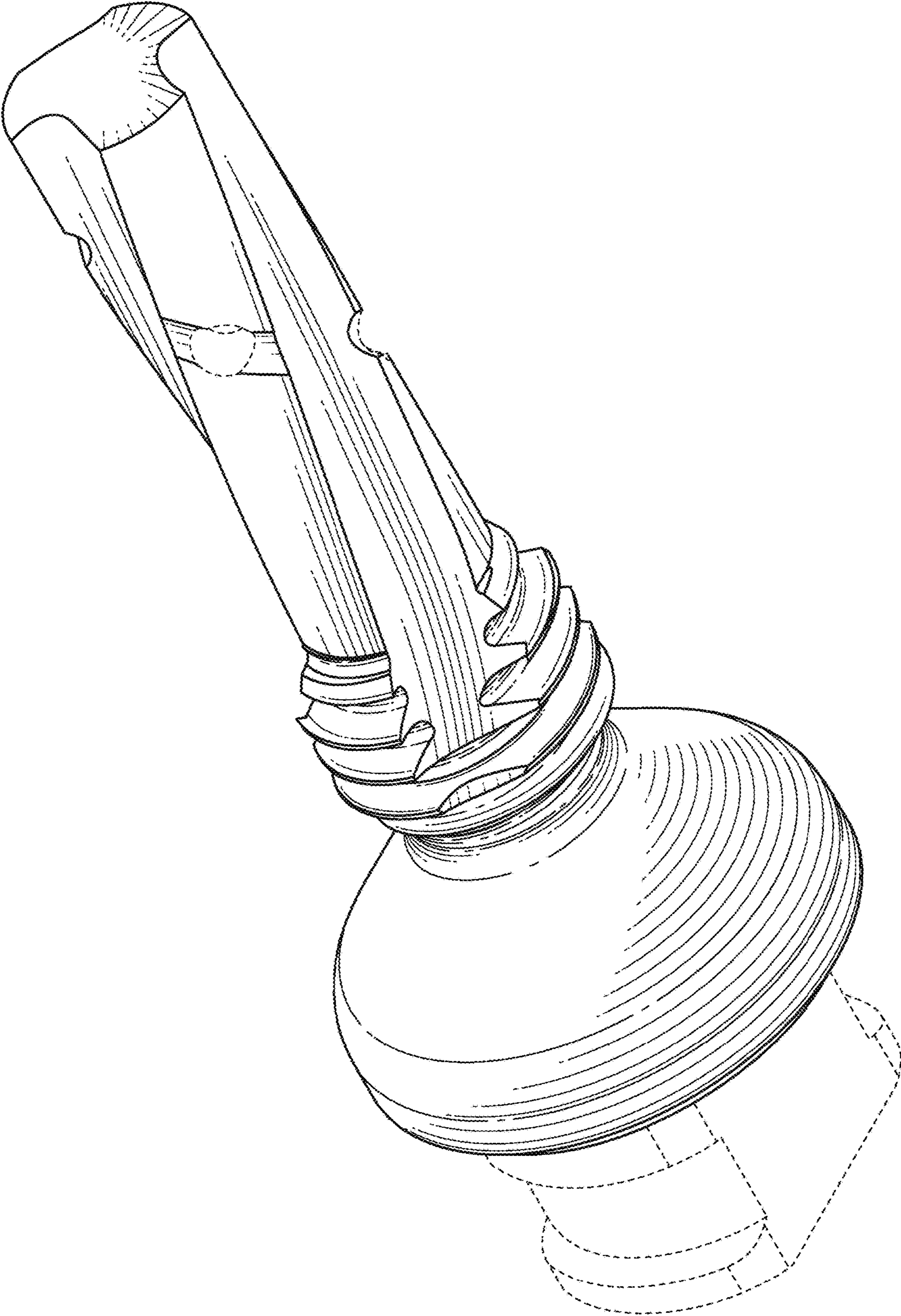

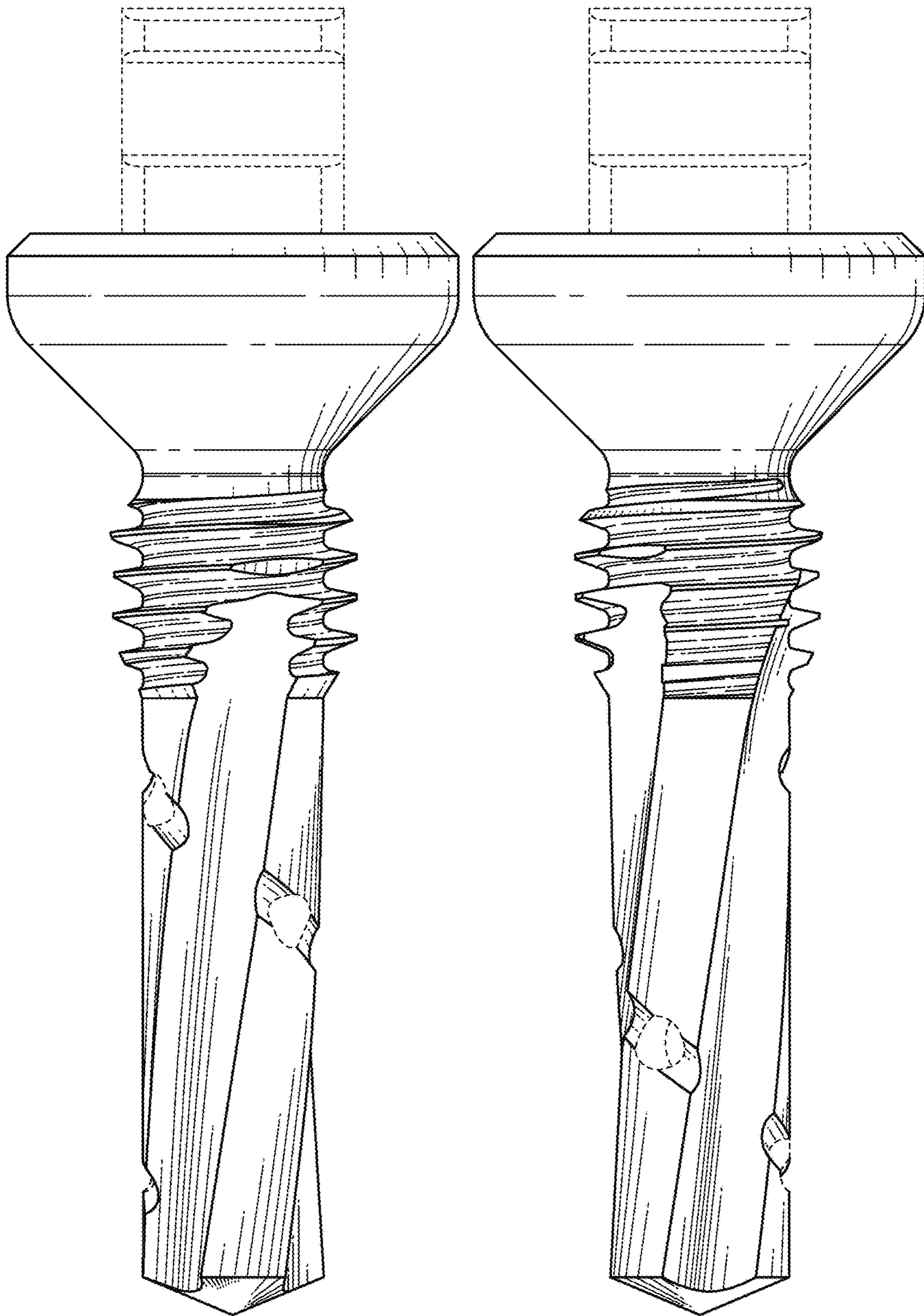

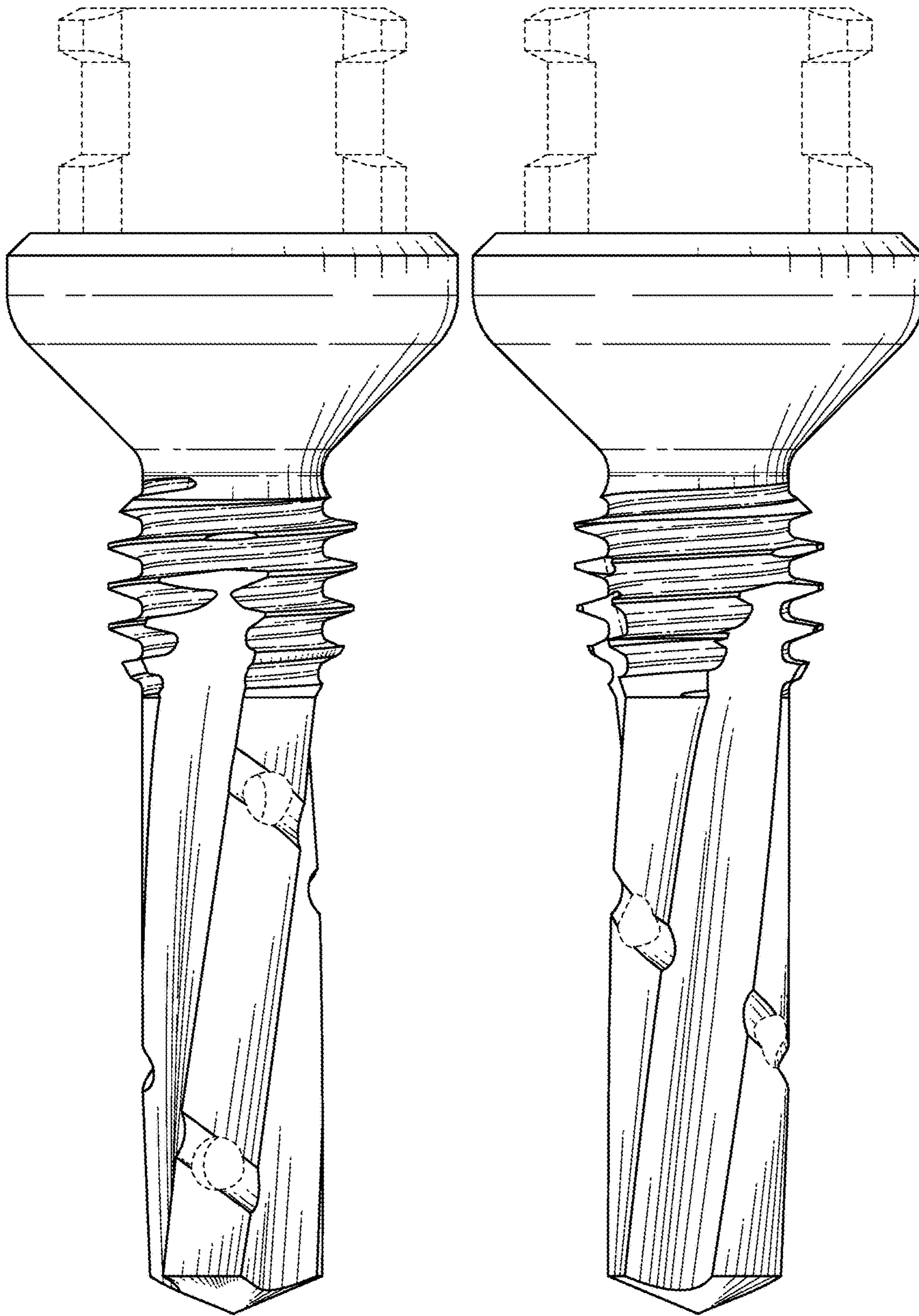

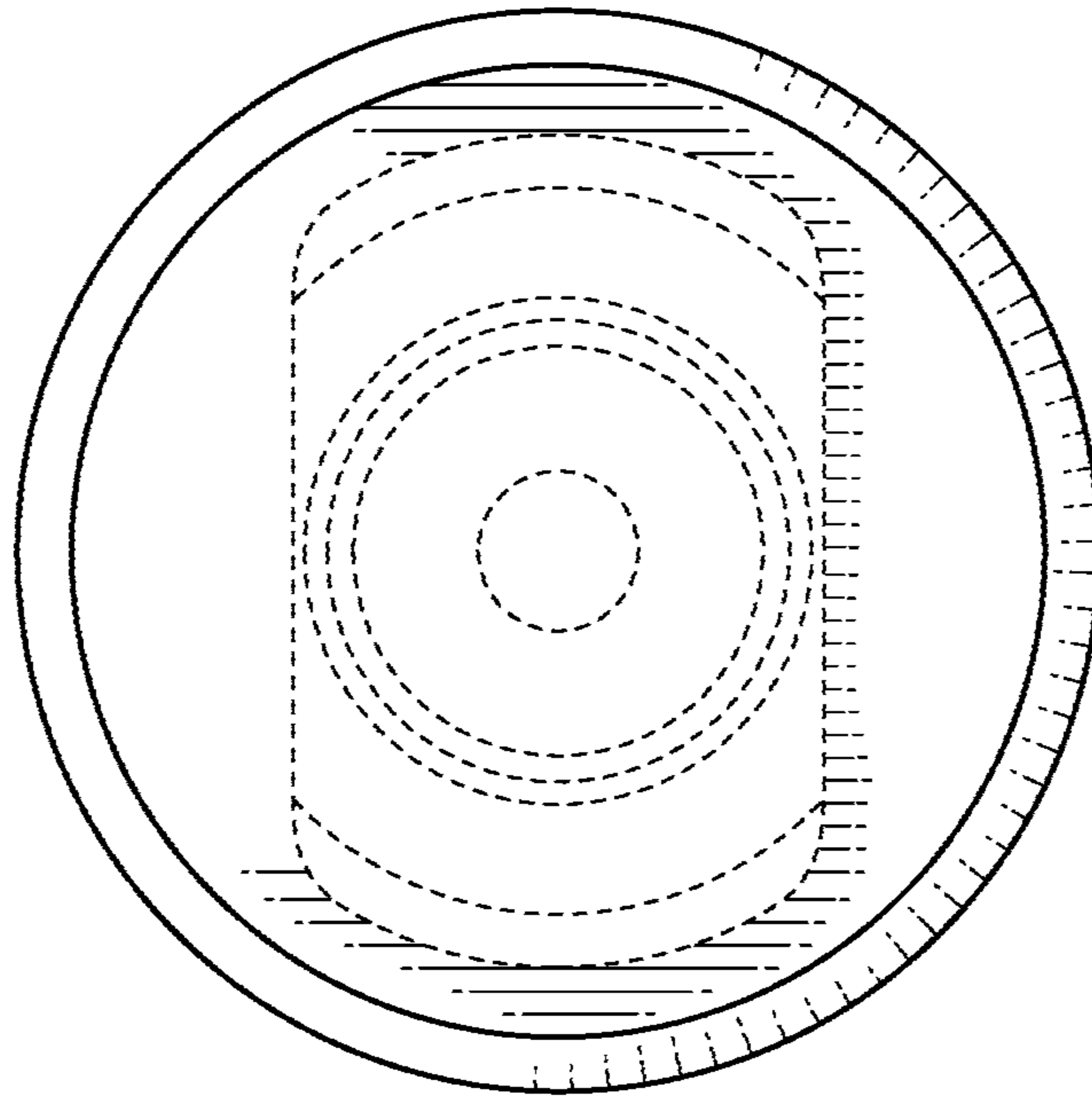

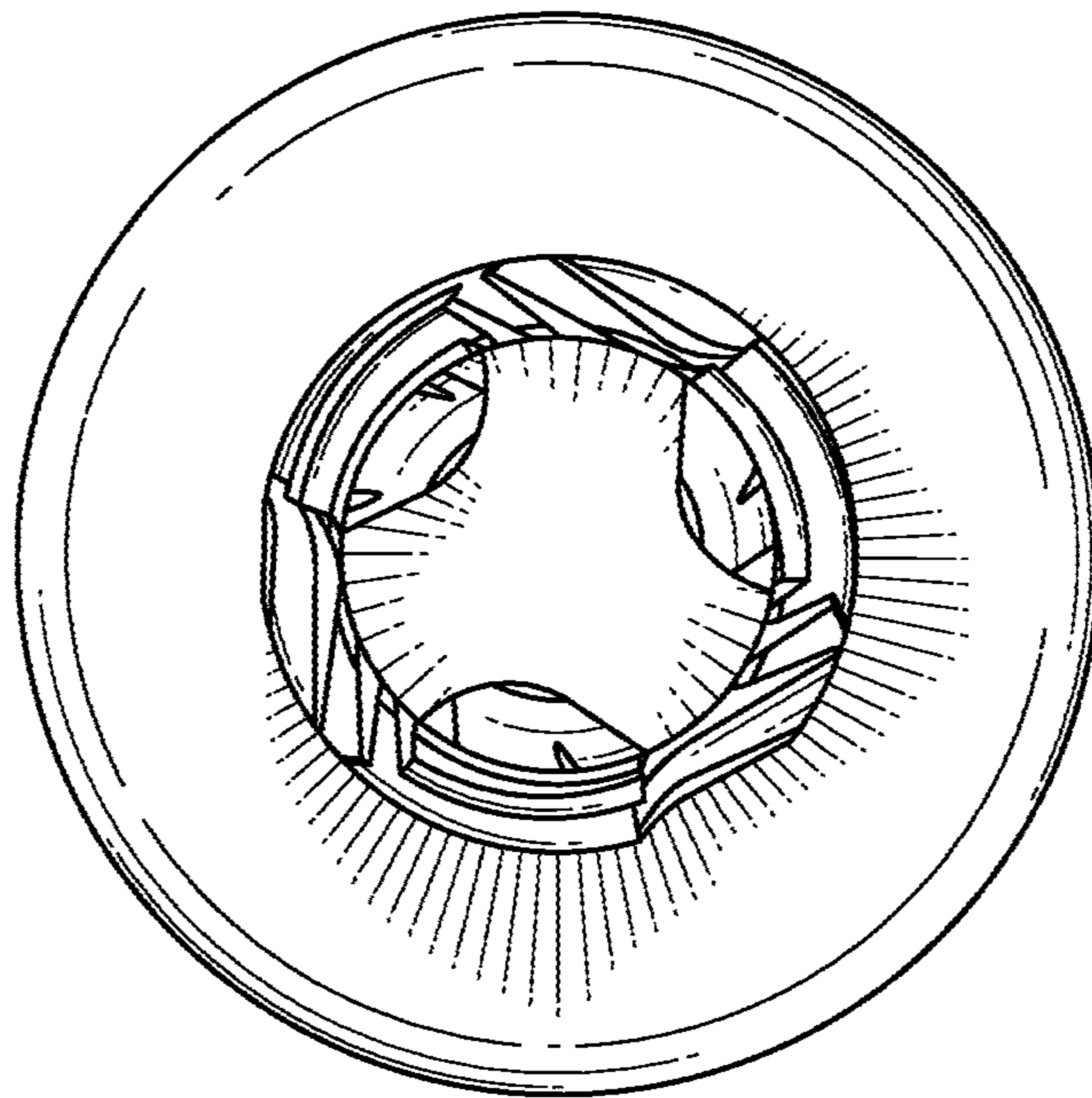
