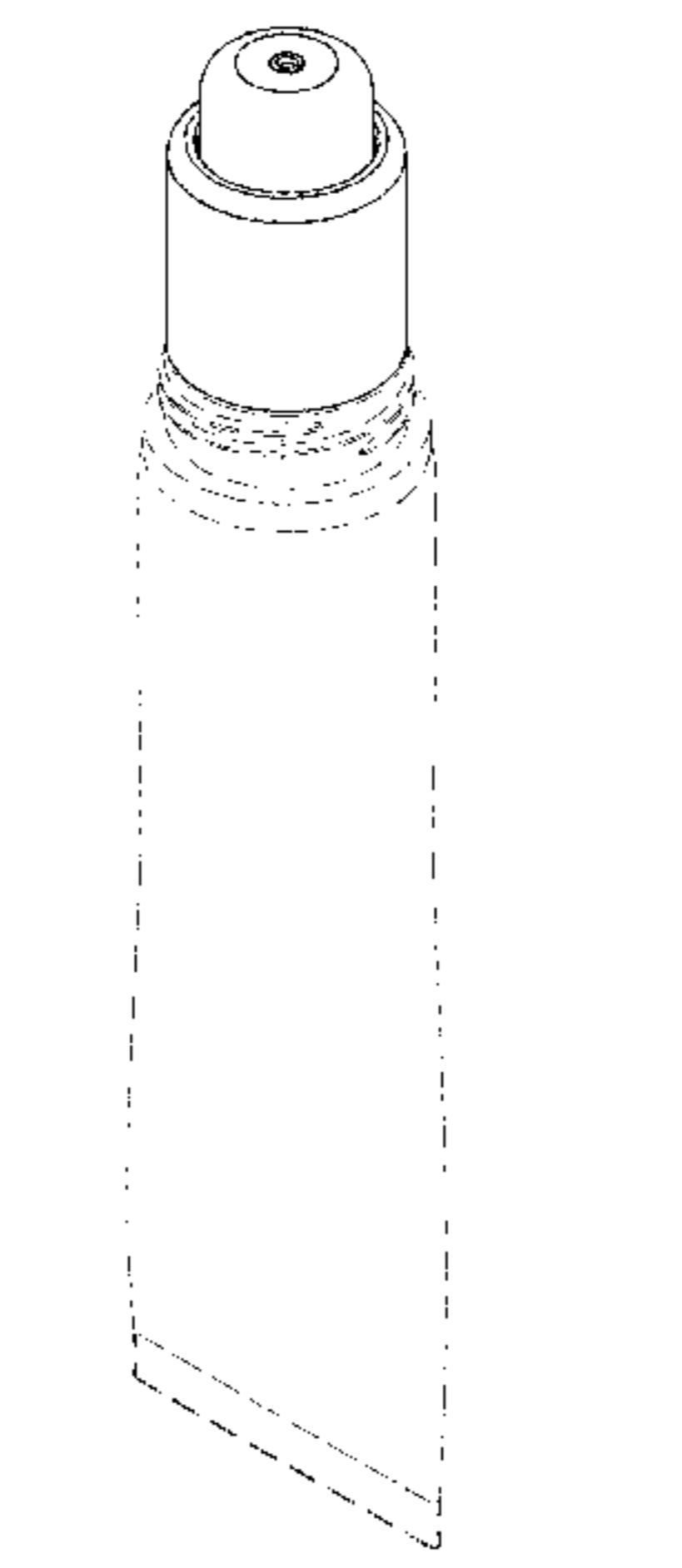
(57) **CLAIM**

The broken lines in the drawings depict portions of the cosmetic tube container that form no part of the claimed design.

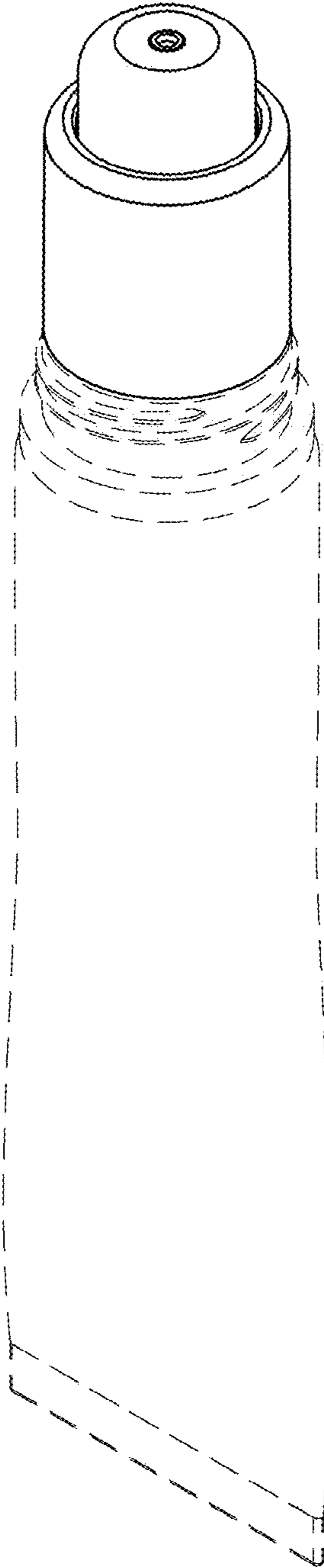

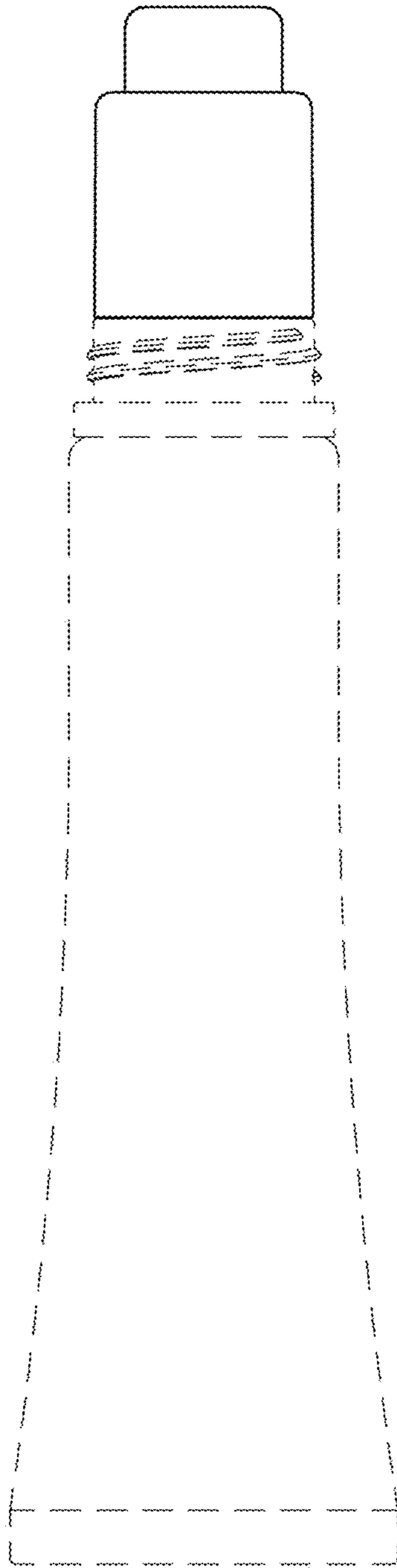

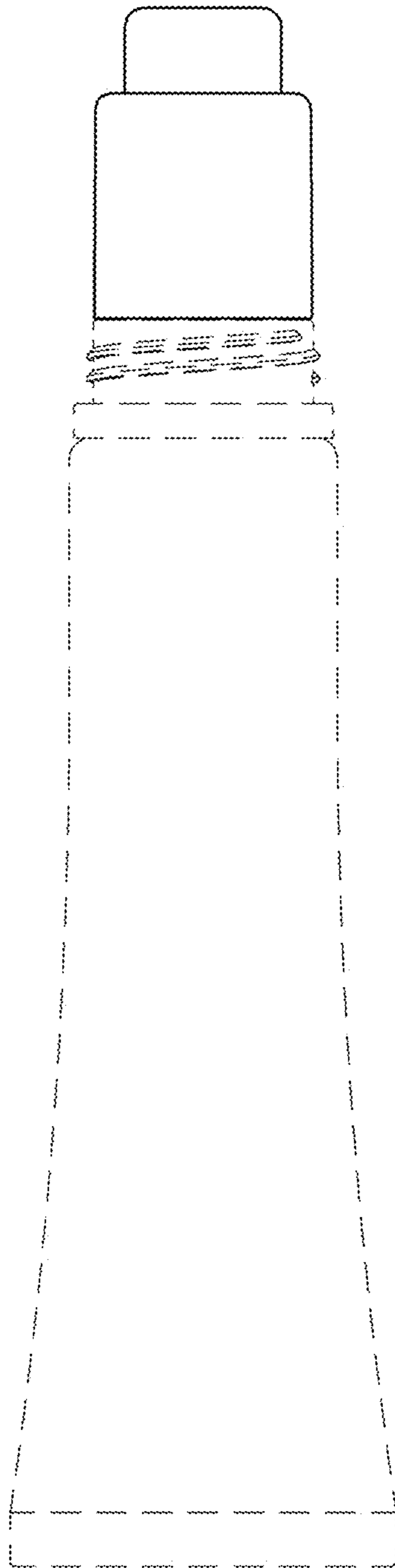

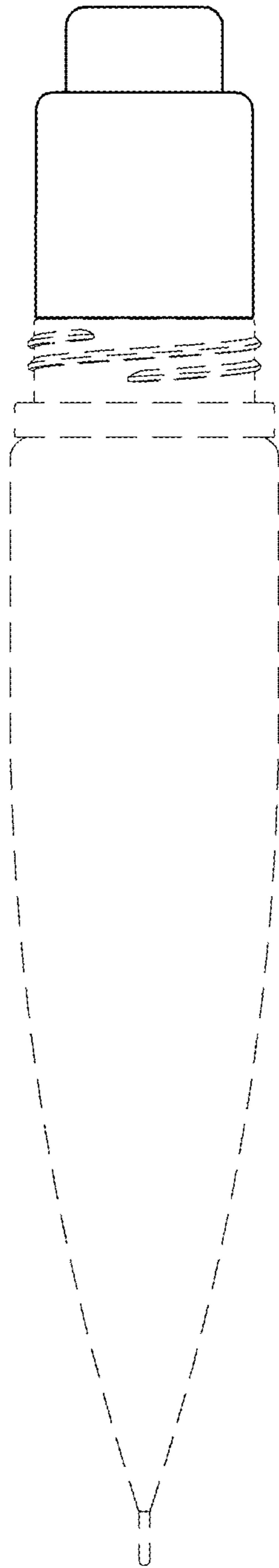

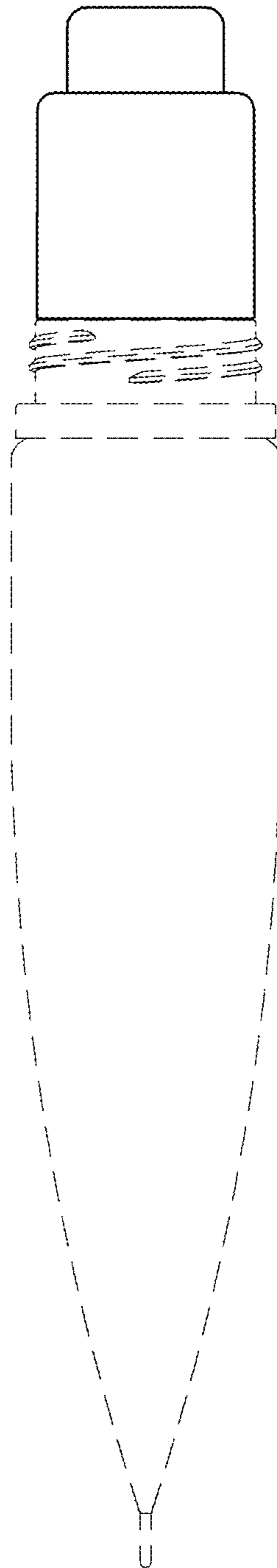

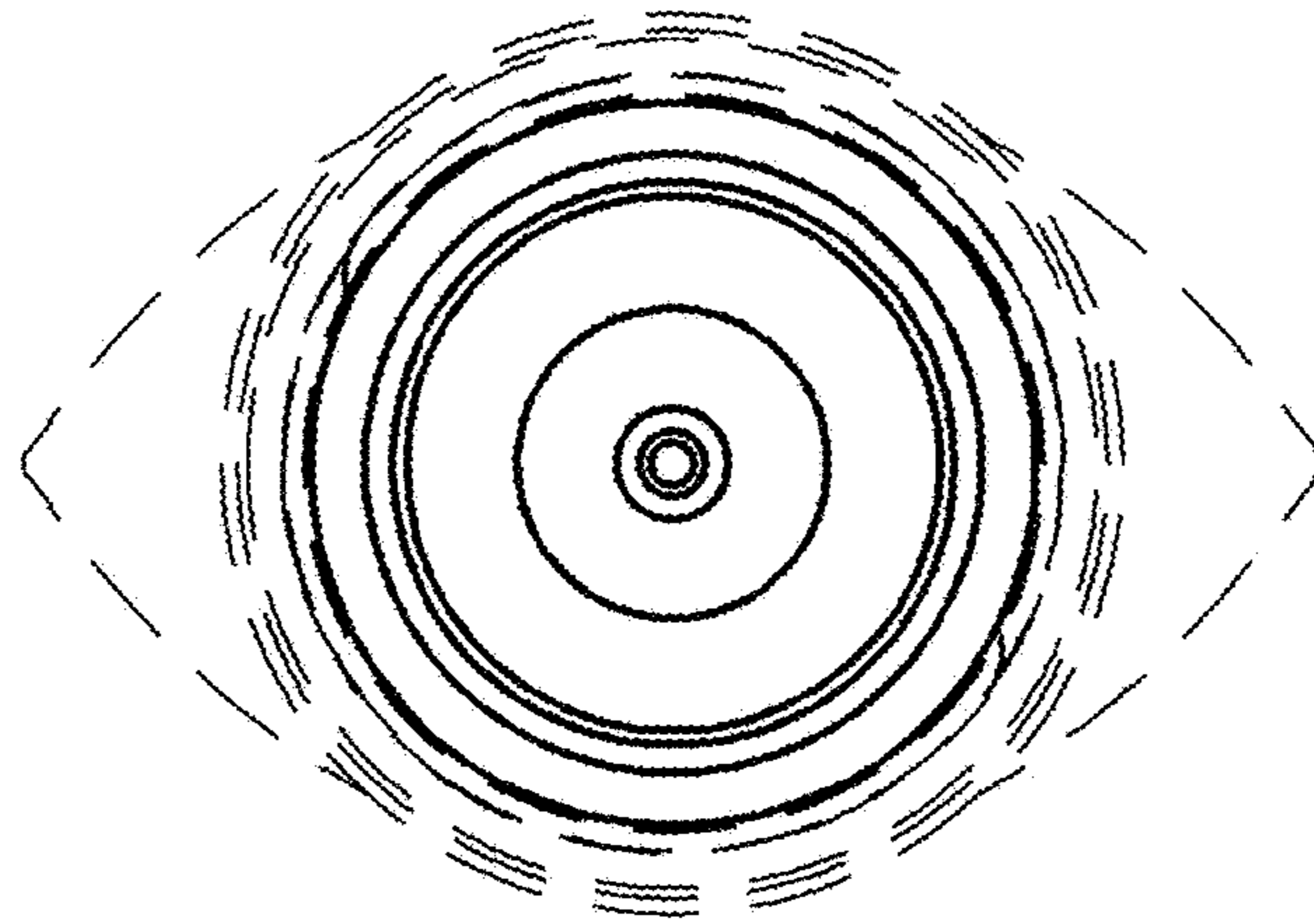

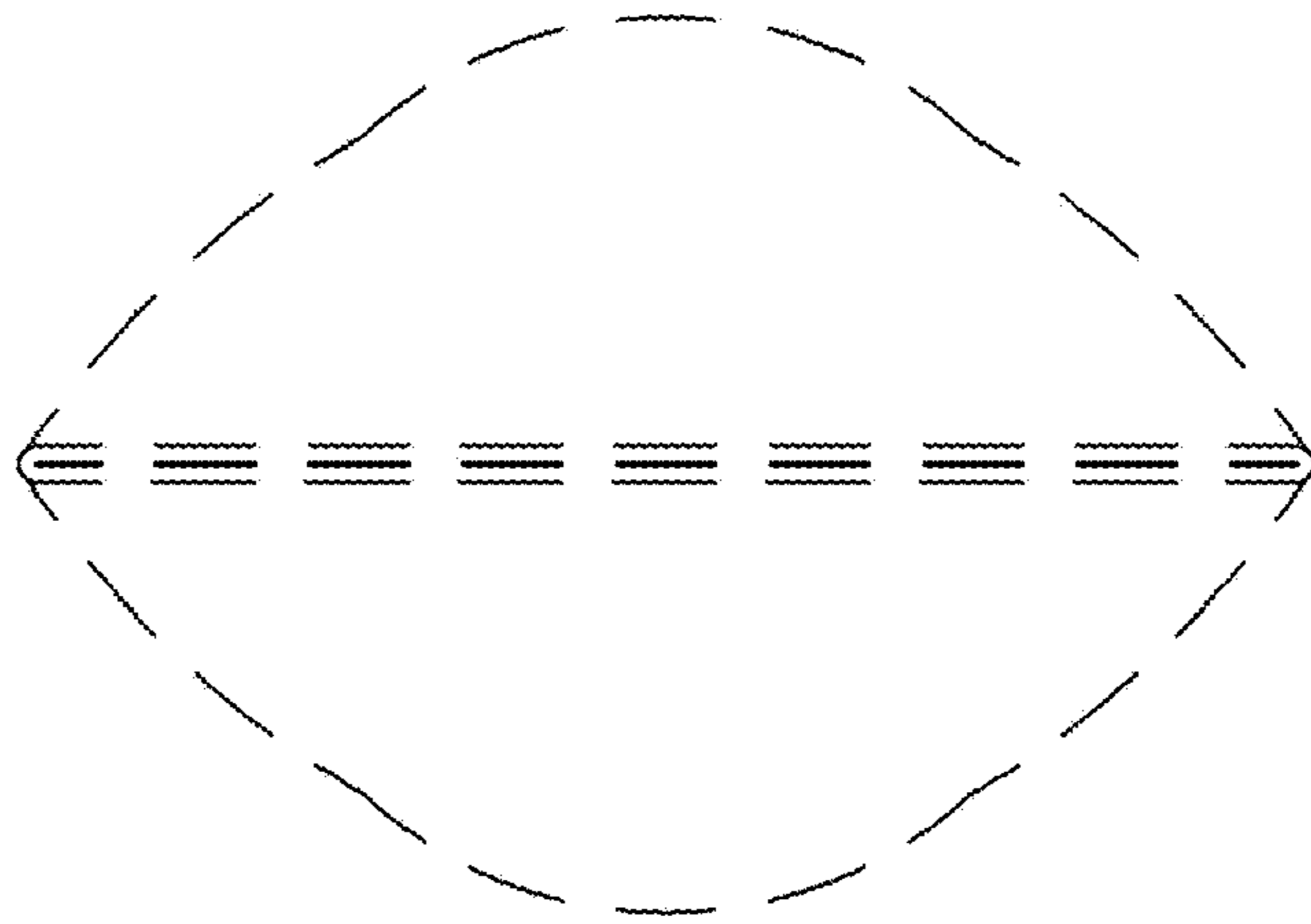
